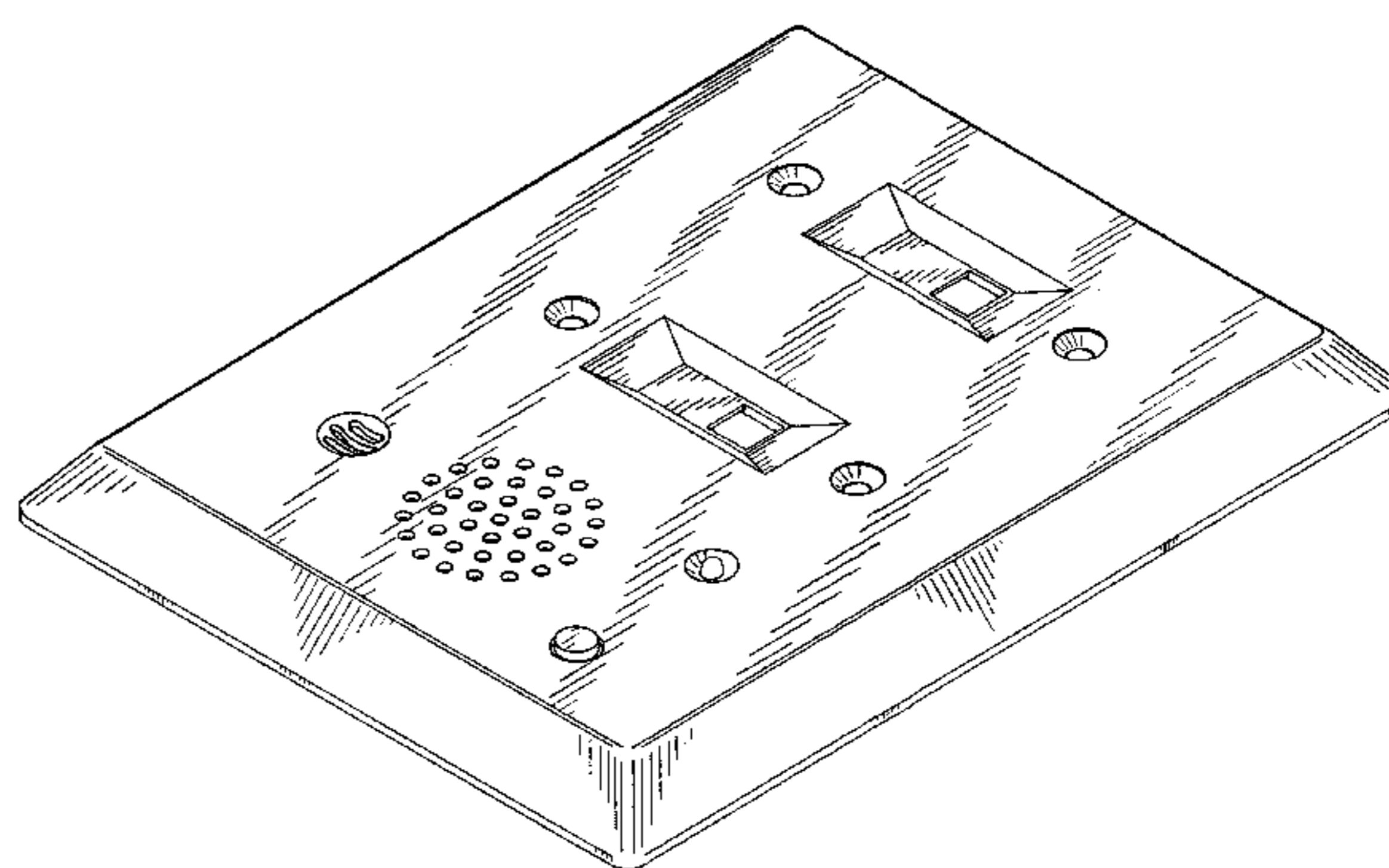
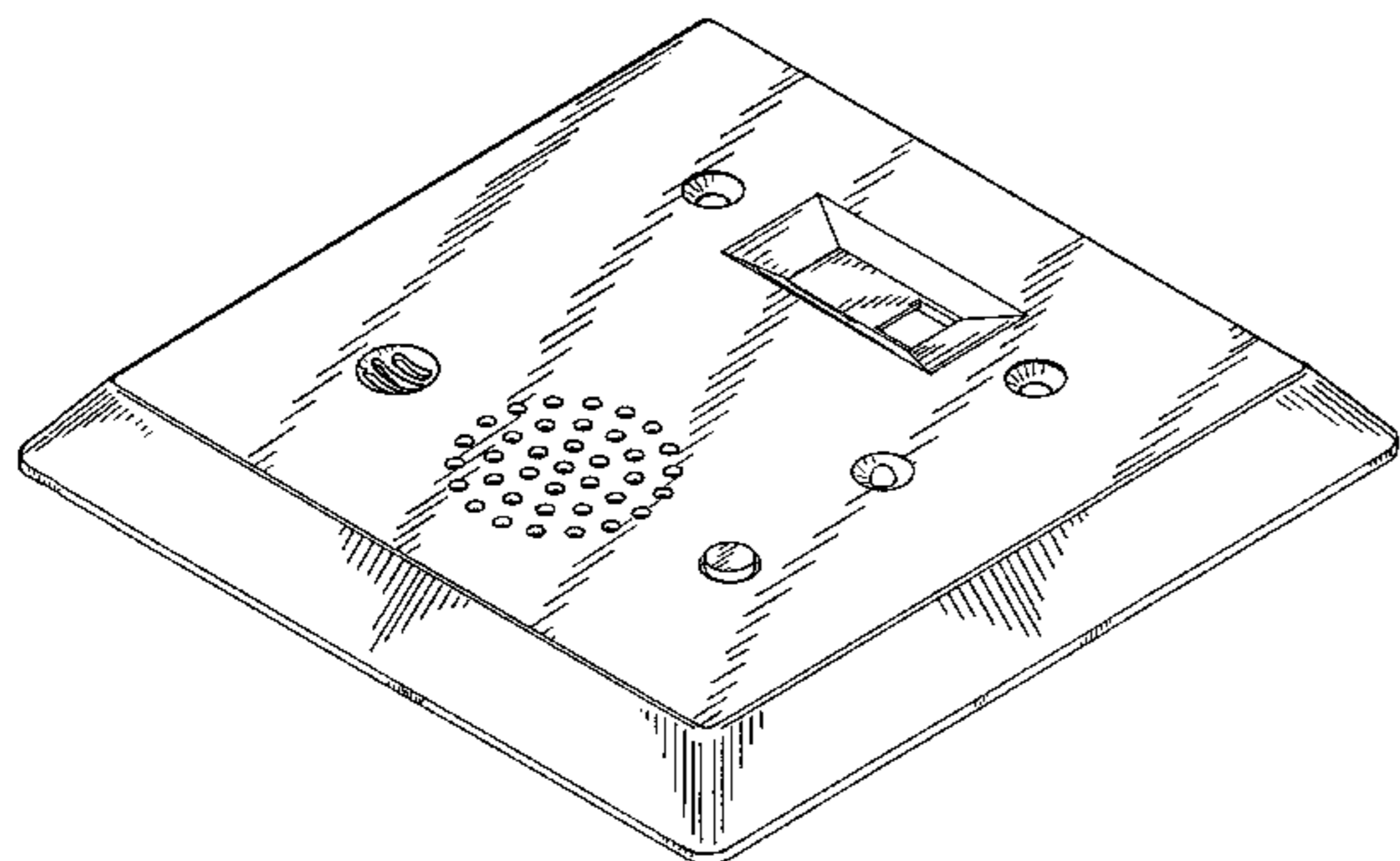
FIG. 15 is an isometric front view of the alternate embodiment of FIGS. 9 and 10; and,

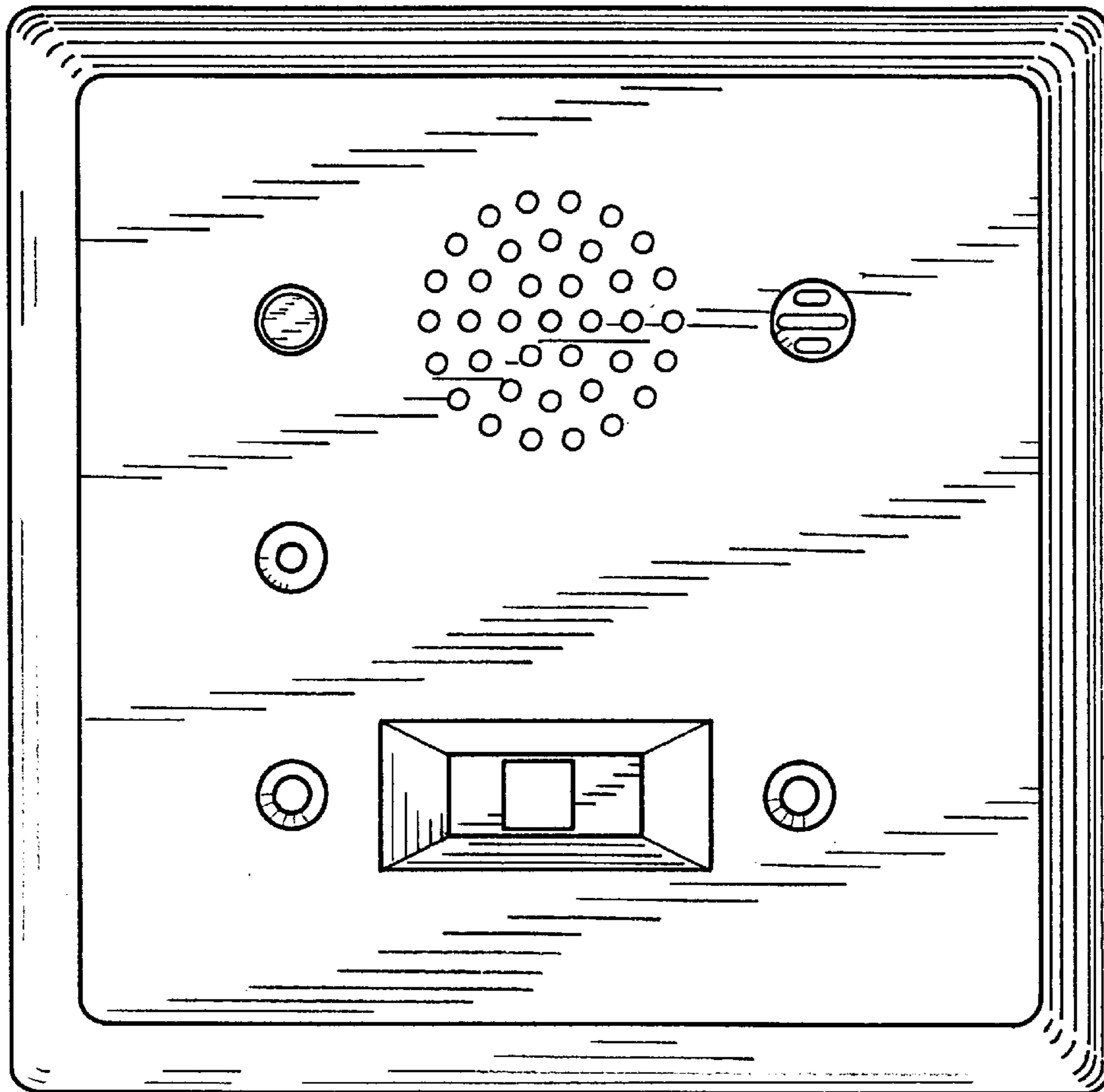

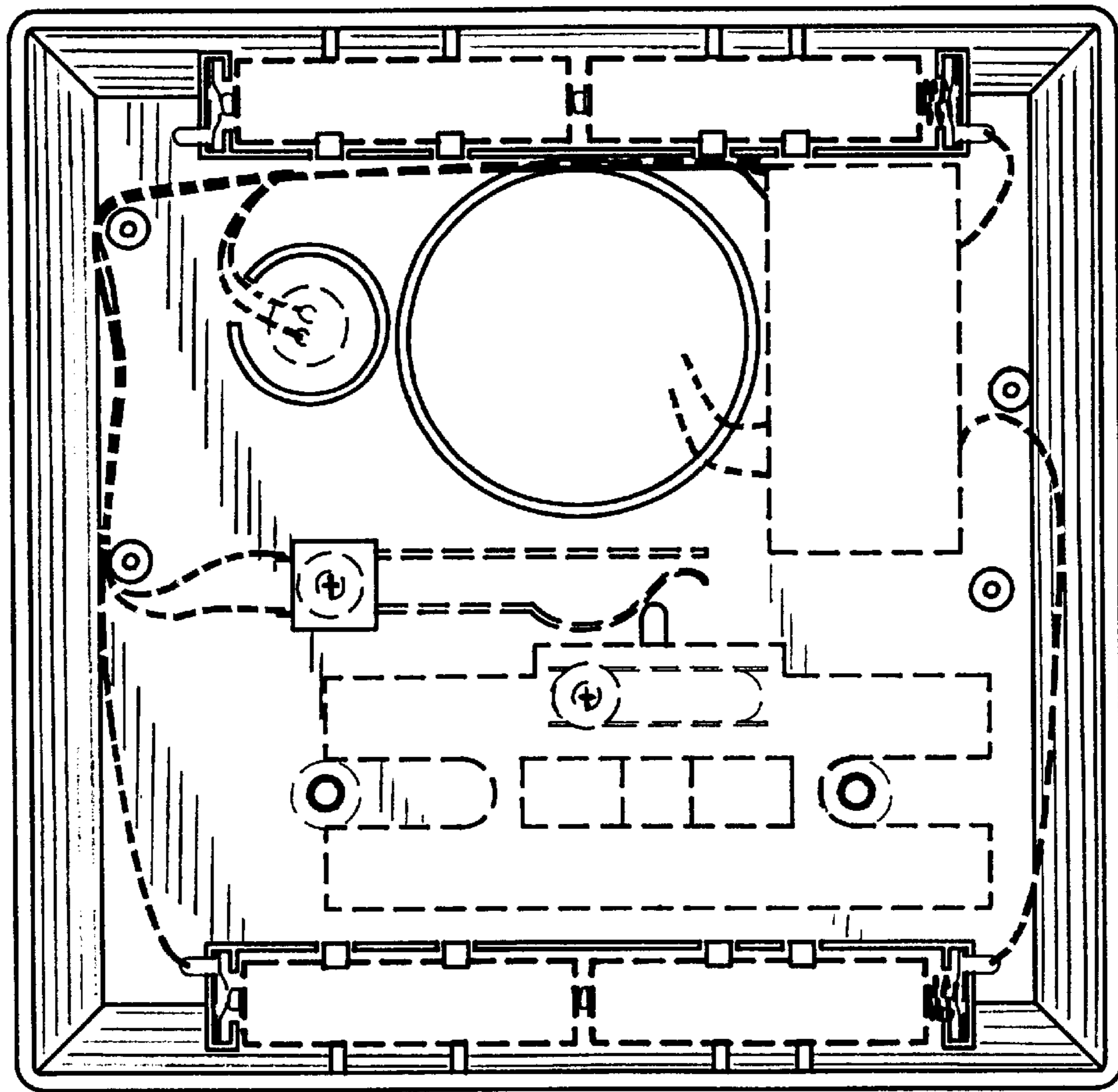

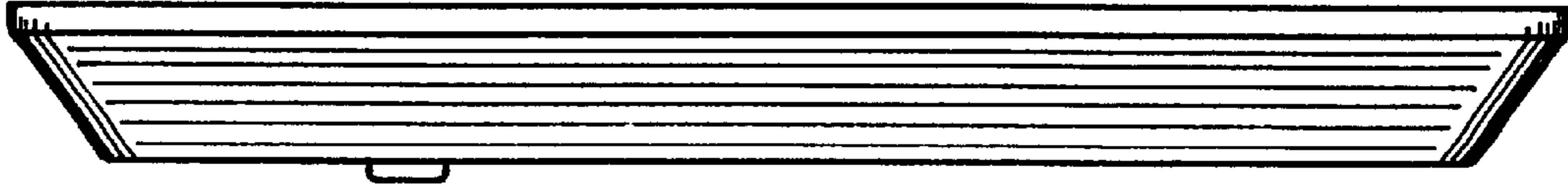

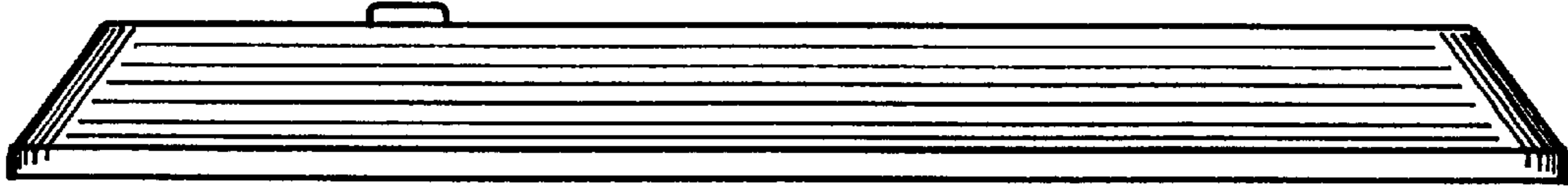

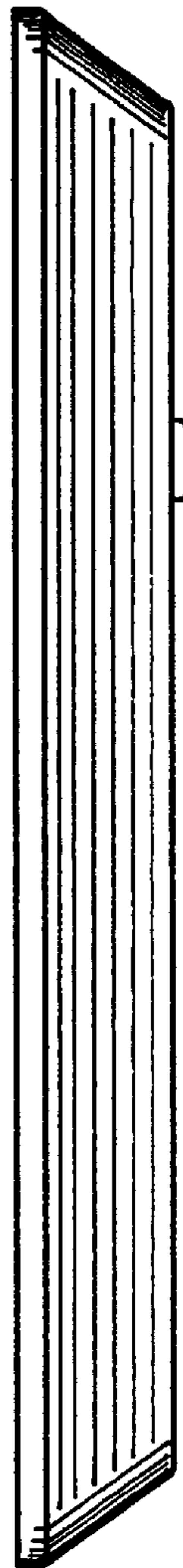

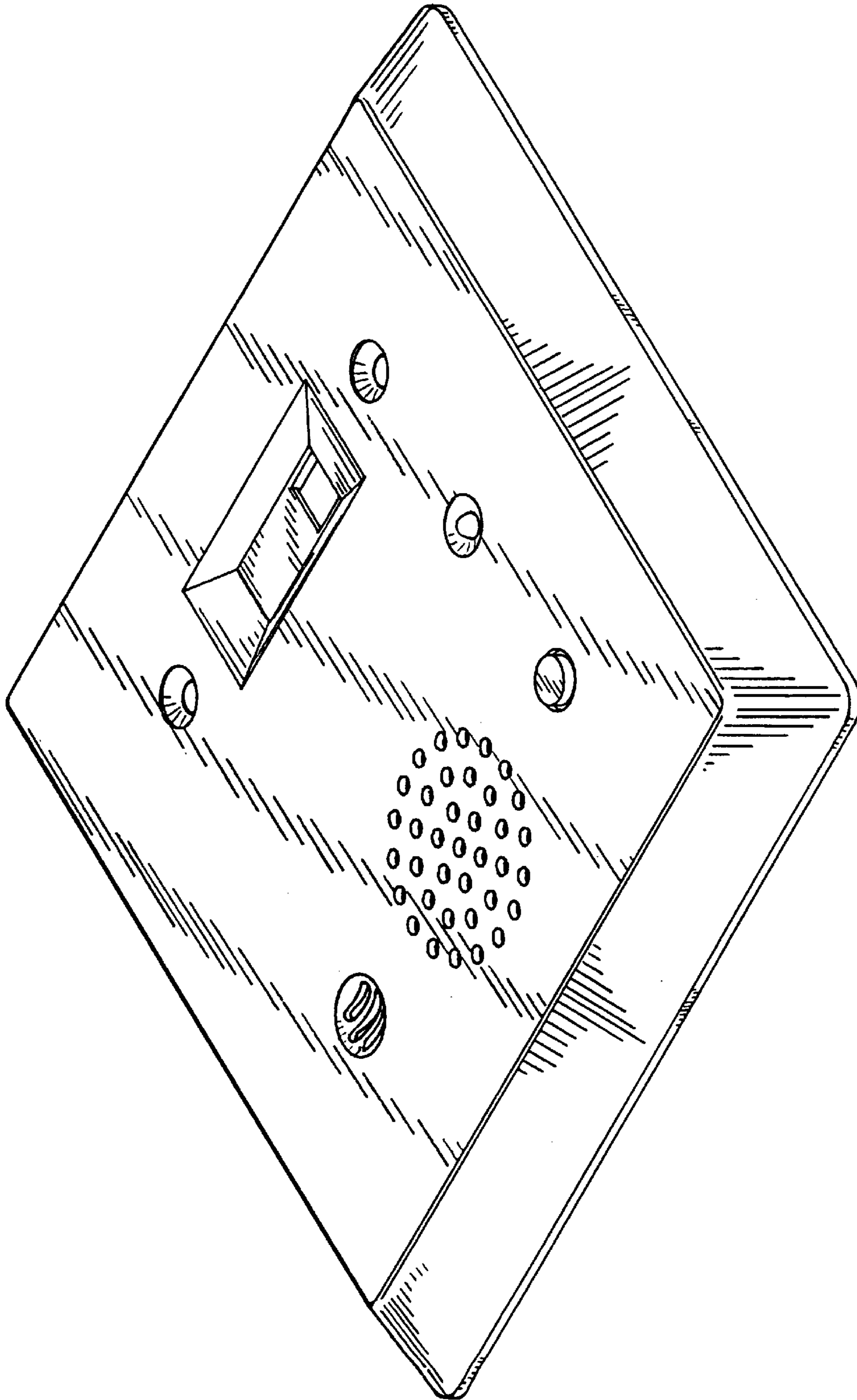

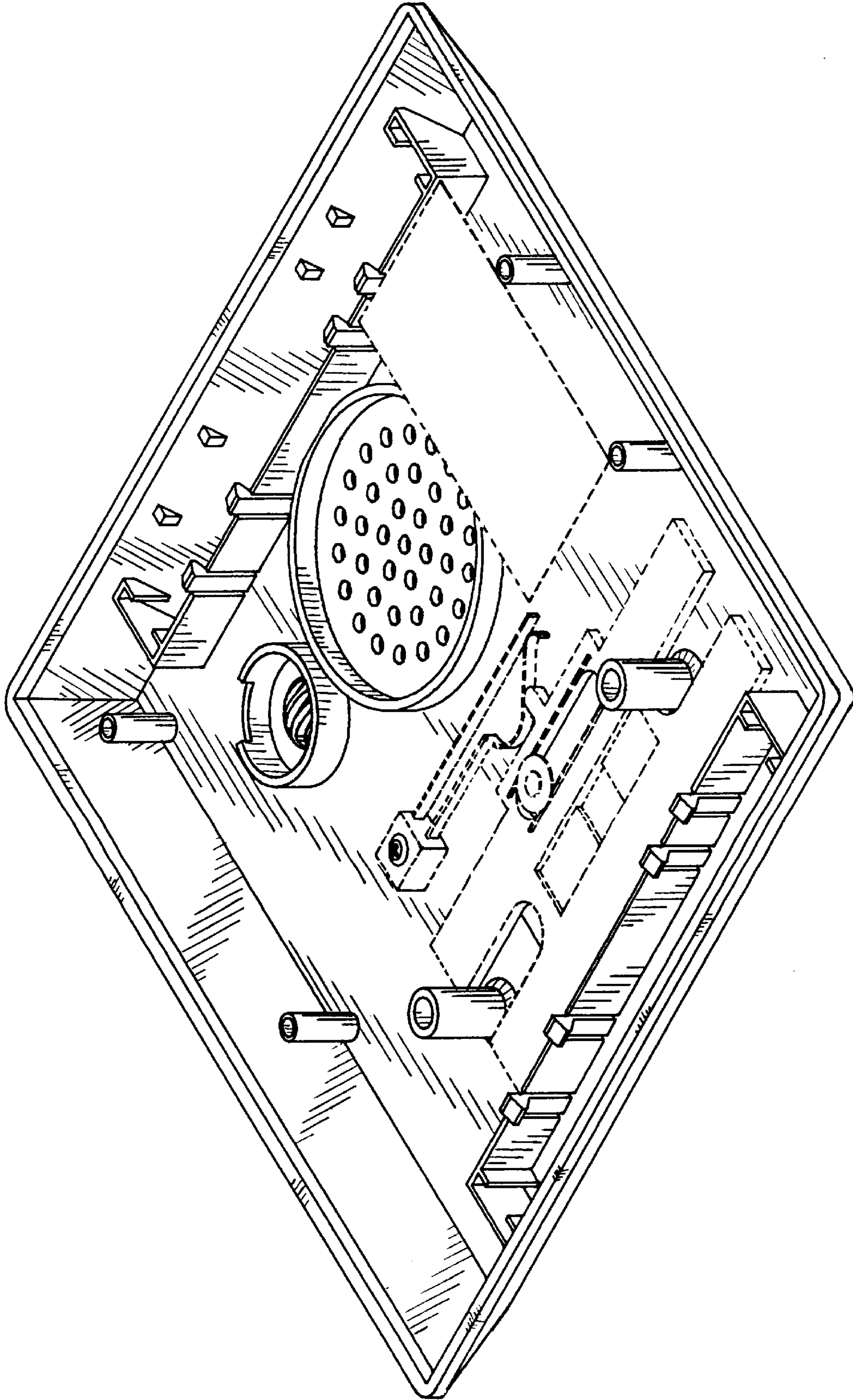

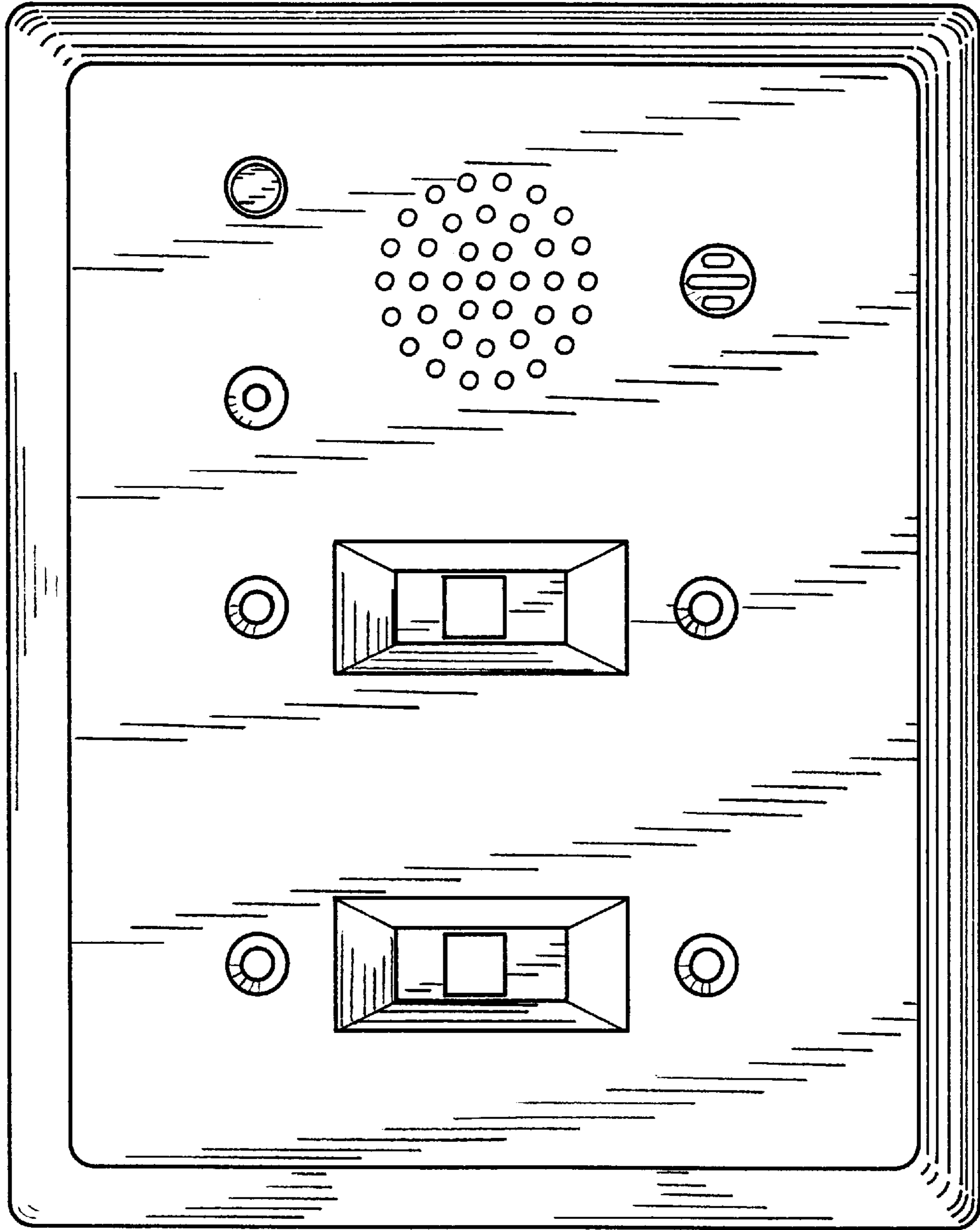

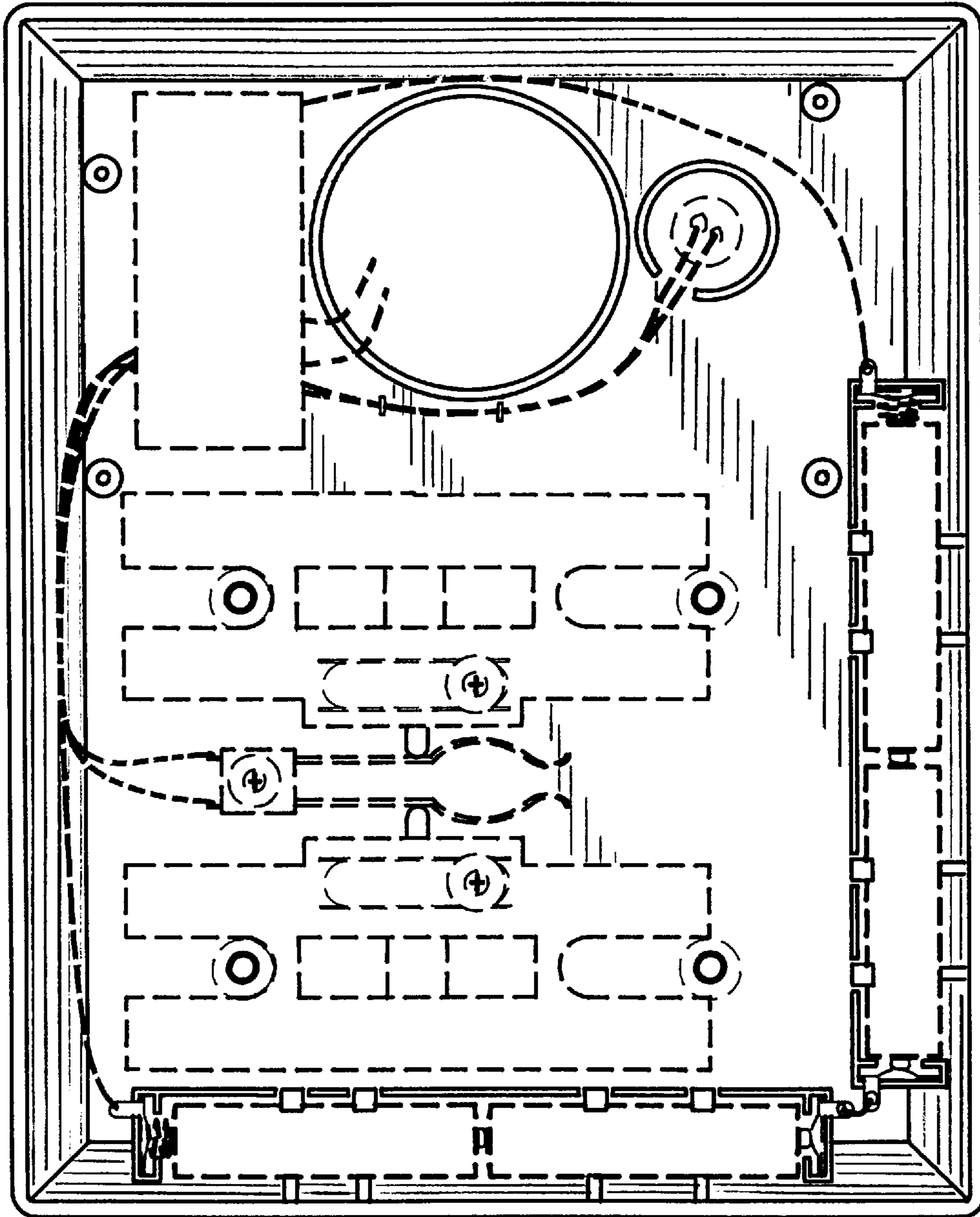

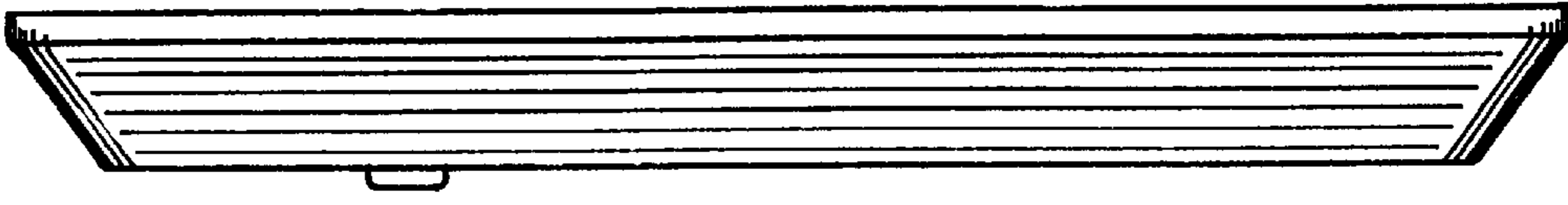

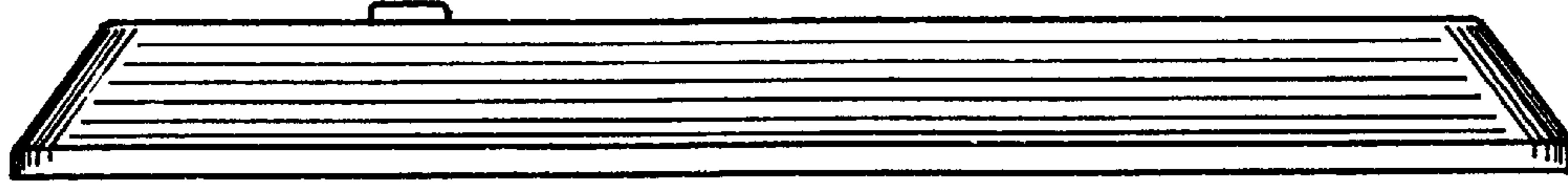

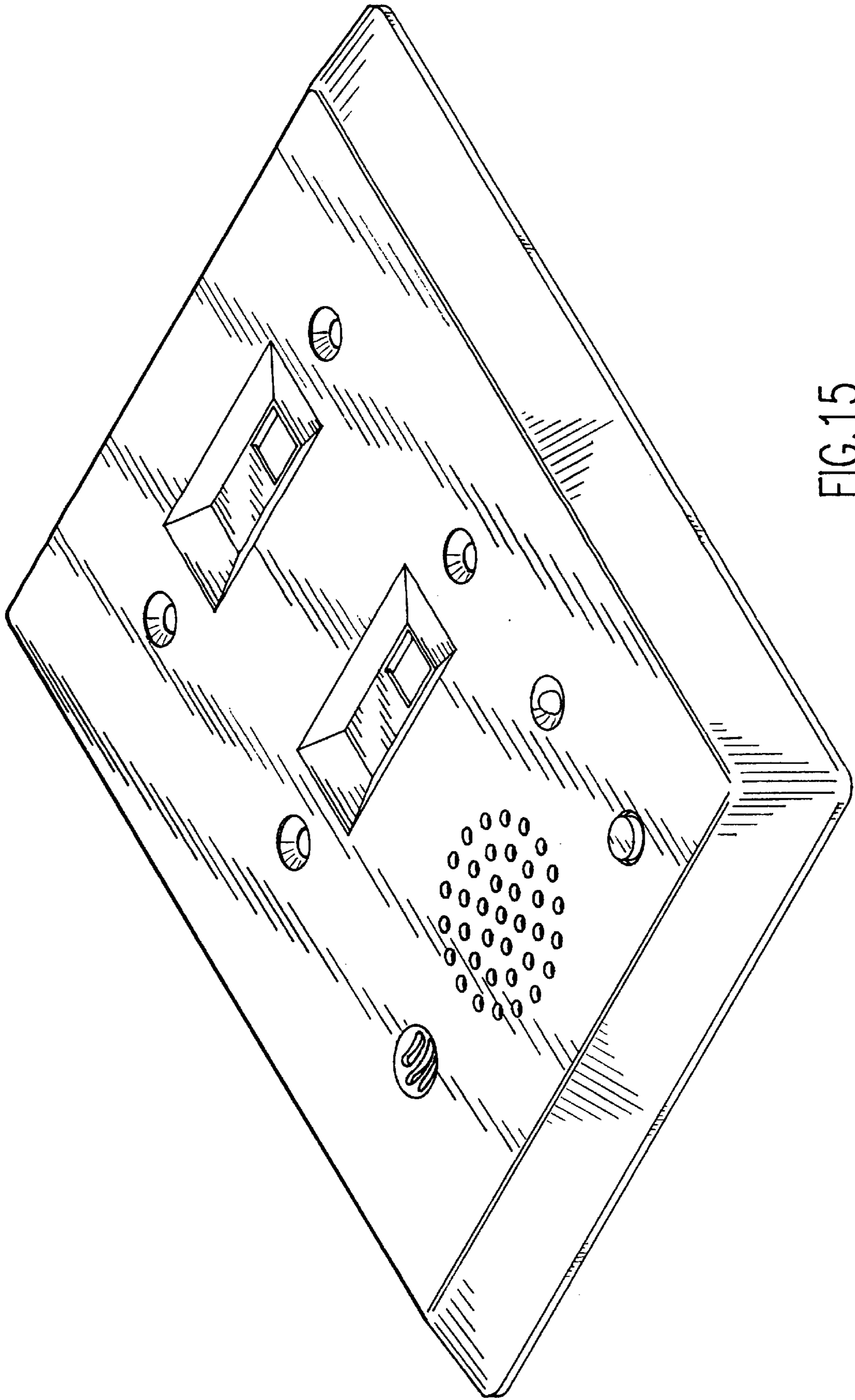

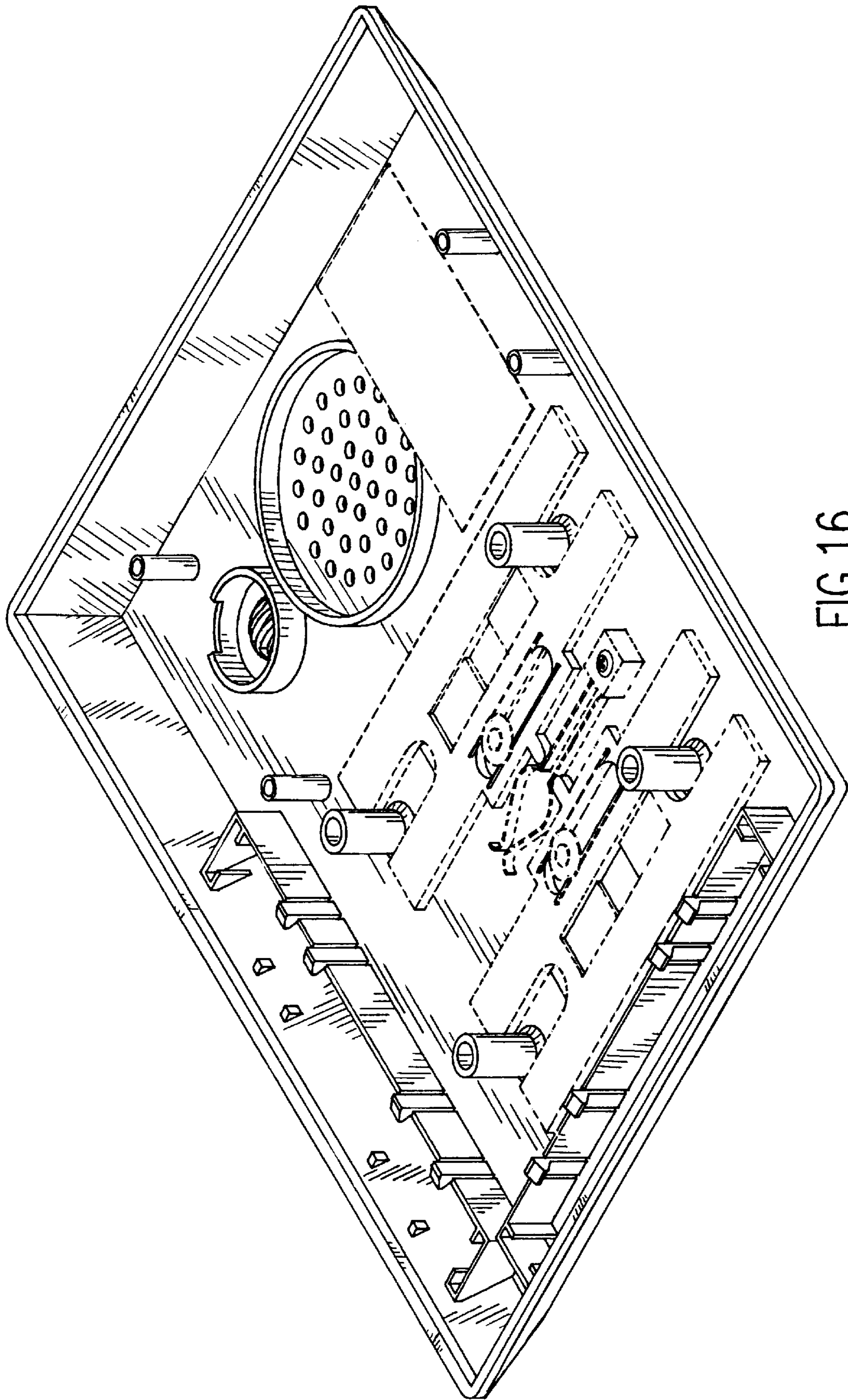
