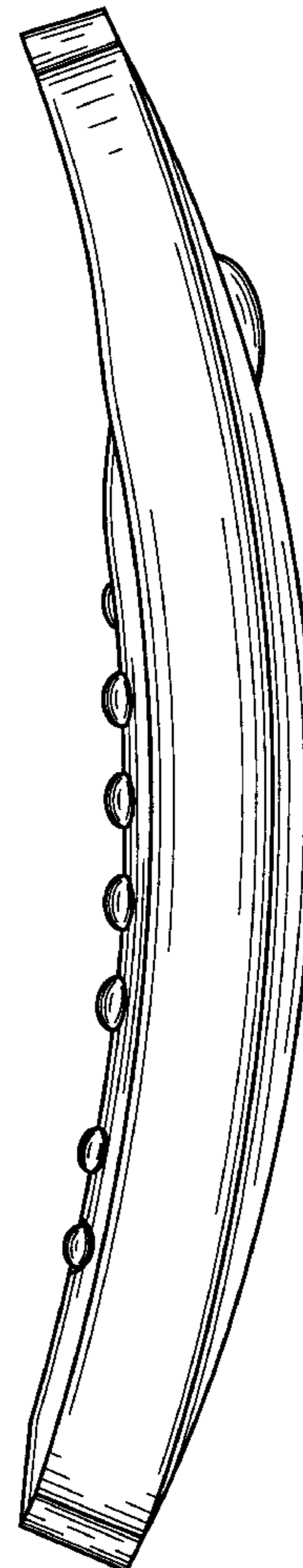
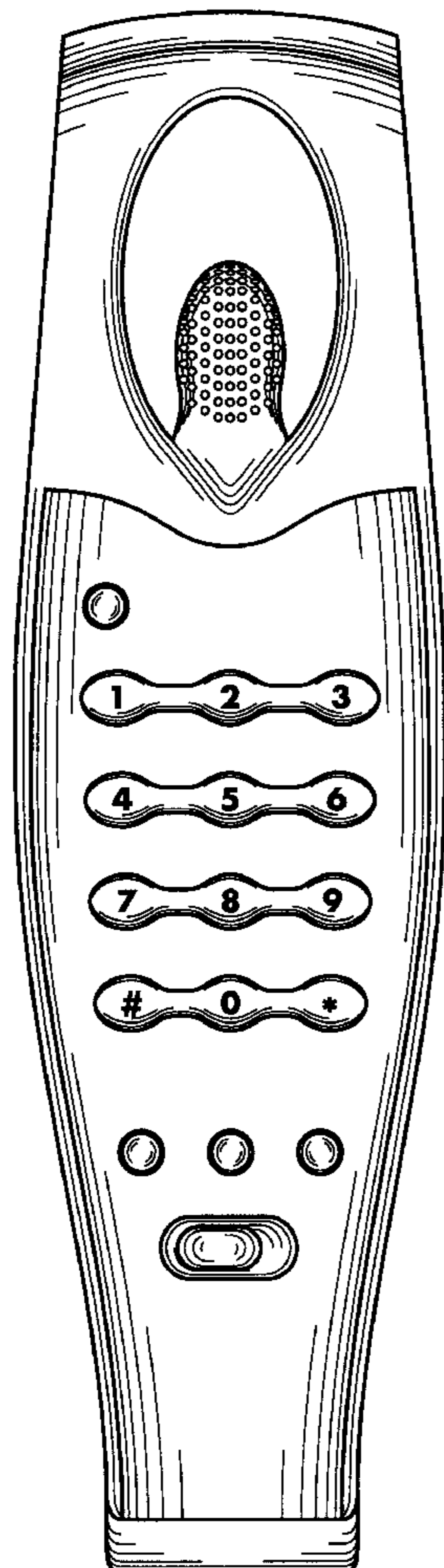
[57] **CLAIM**

The ornamental design for a telephone handset, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a telephone handset, showing my new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a right-side elevational view thereof, the left-side being a mirror image thereof;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.

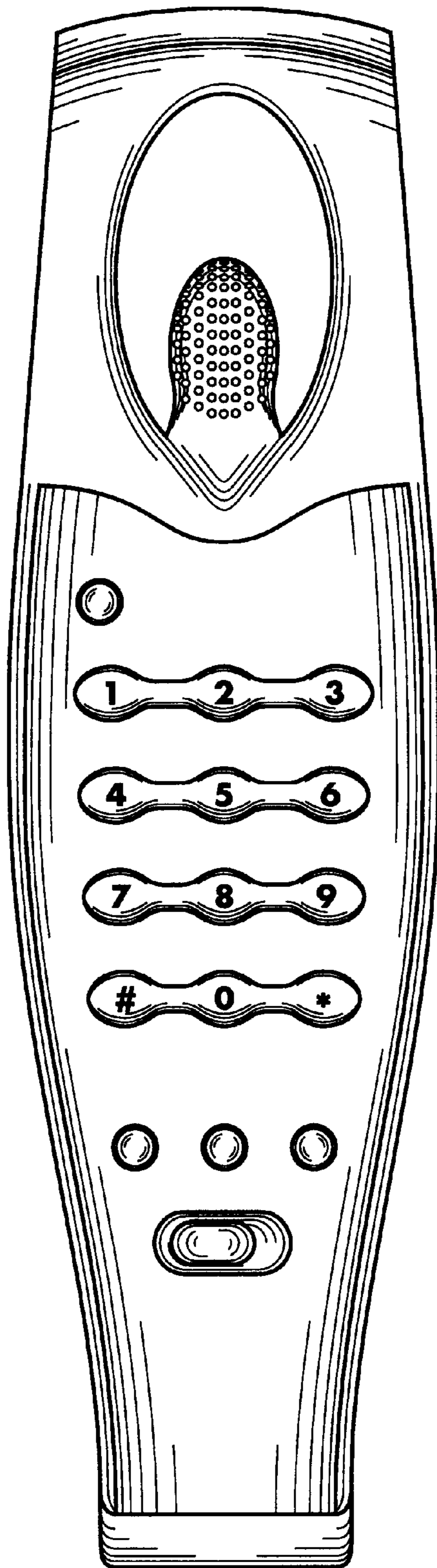

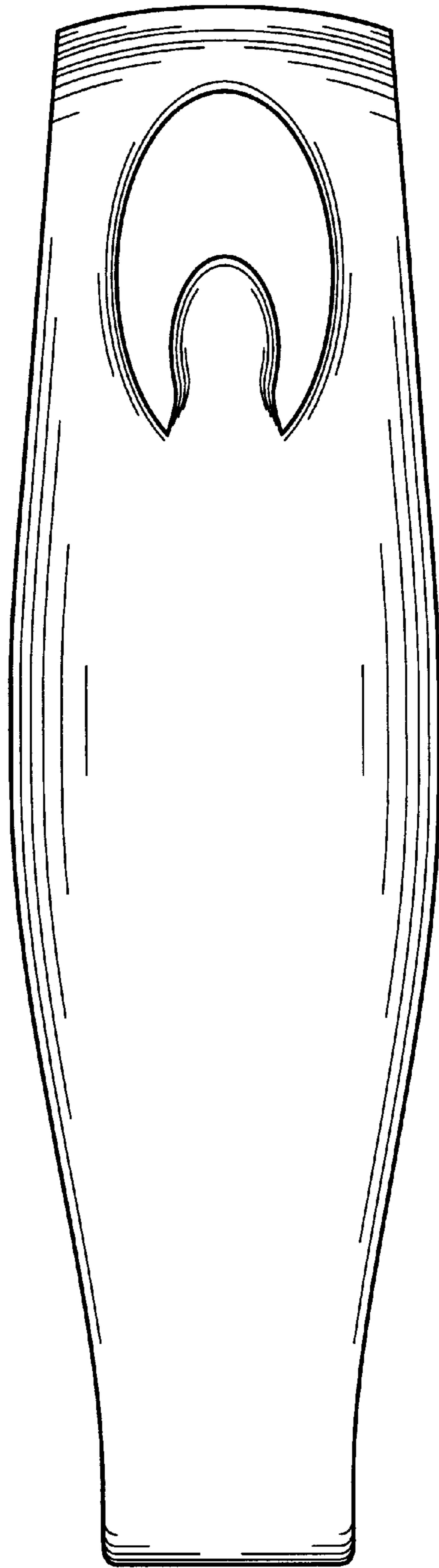

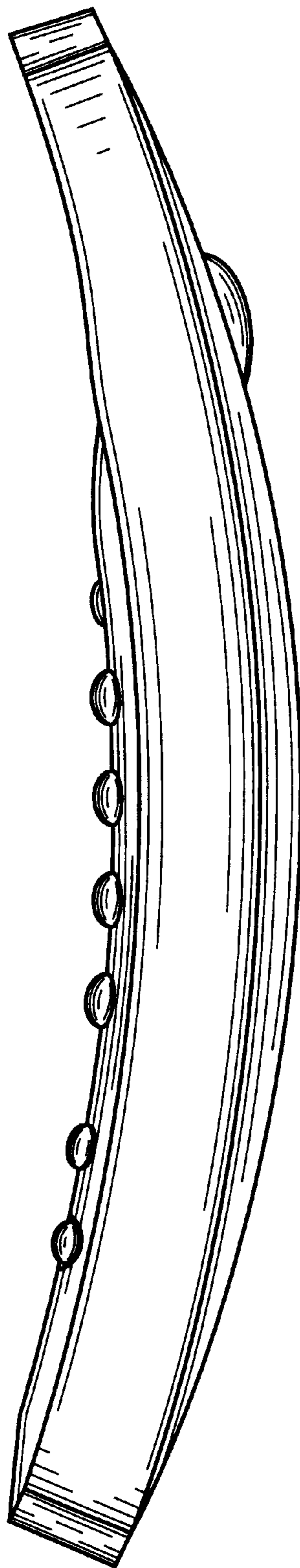

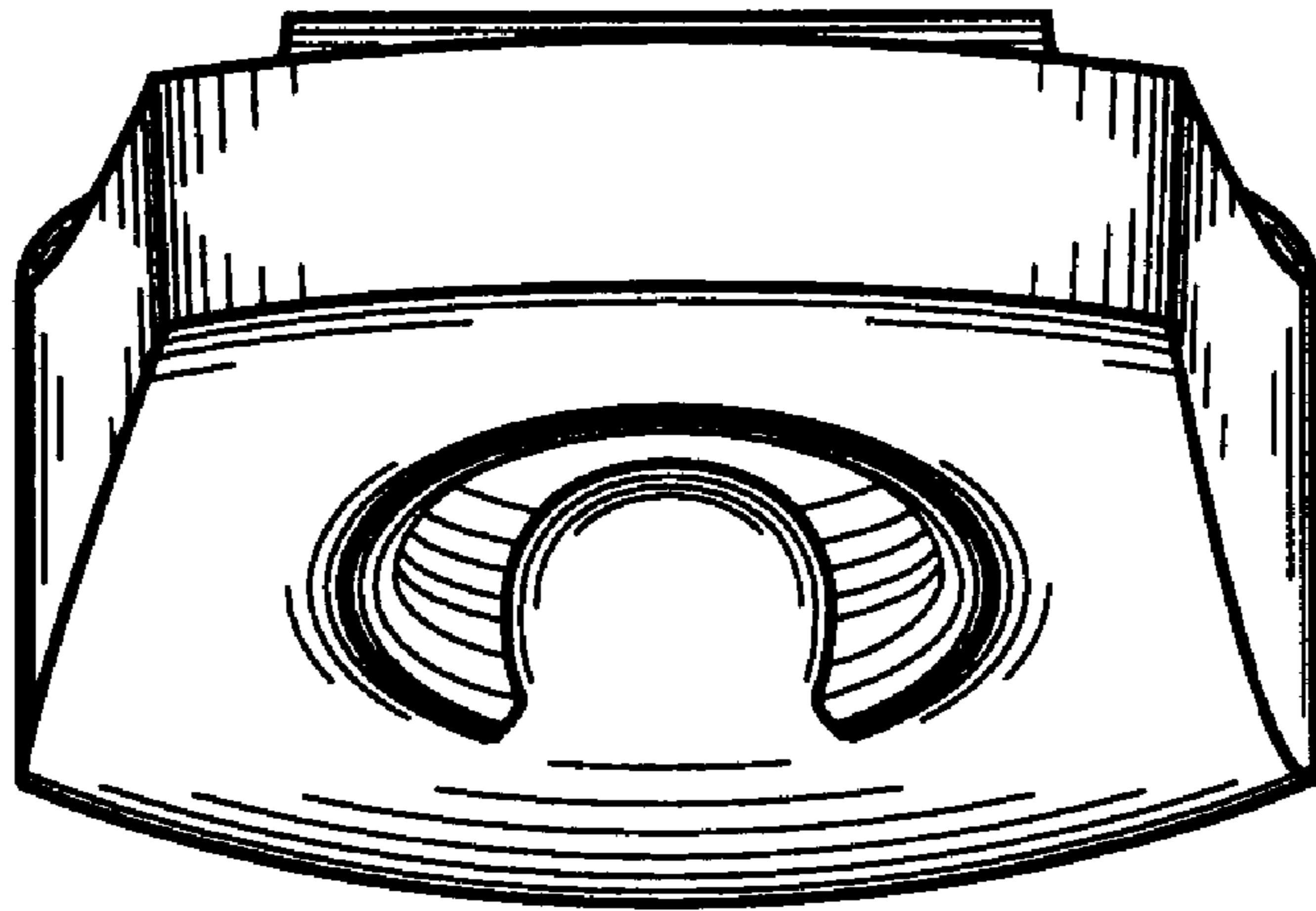

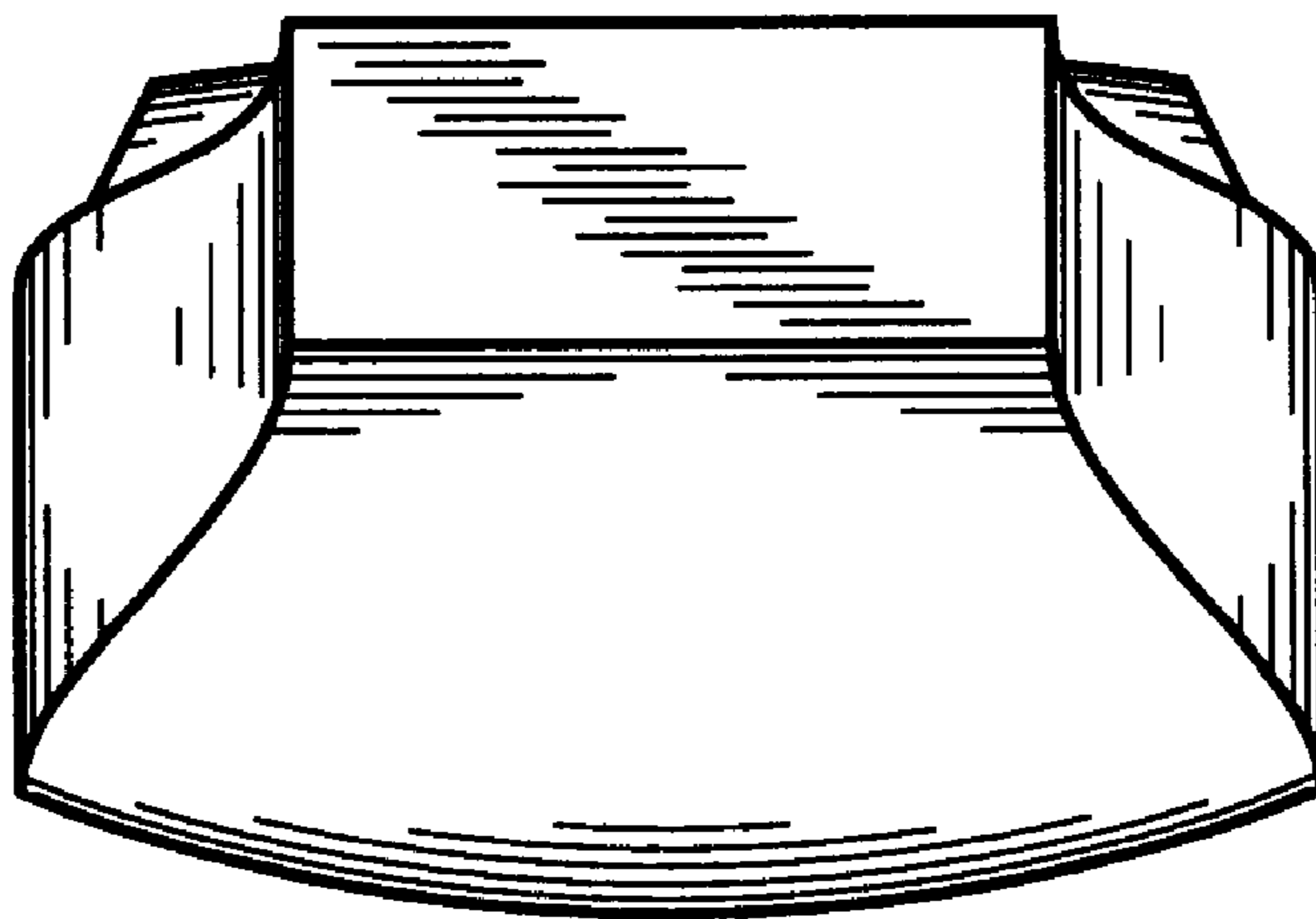
