[57] **CLAIM**

The ornamental design for a clip for attaching lures to a fishing line, substantially as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of clip for attaching lures to a fishing line showing my new design;  
FIG. 2 is a side elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a side elevational view thereof, taken from the side opposite that shown in FIGS. 1 and 2;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is an end elevational view of the smaller end thereof; and,  
FIG. 7 is an end elevational view thereof, taken from the end opposite that shown in FIG. 6.

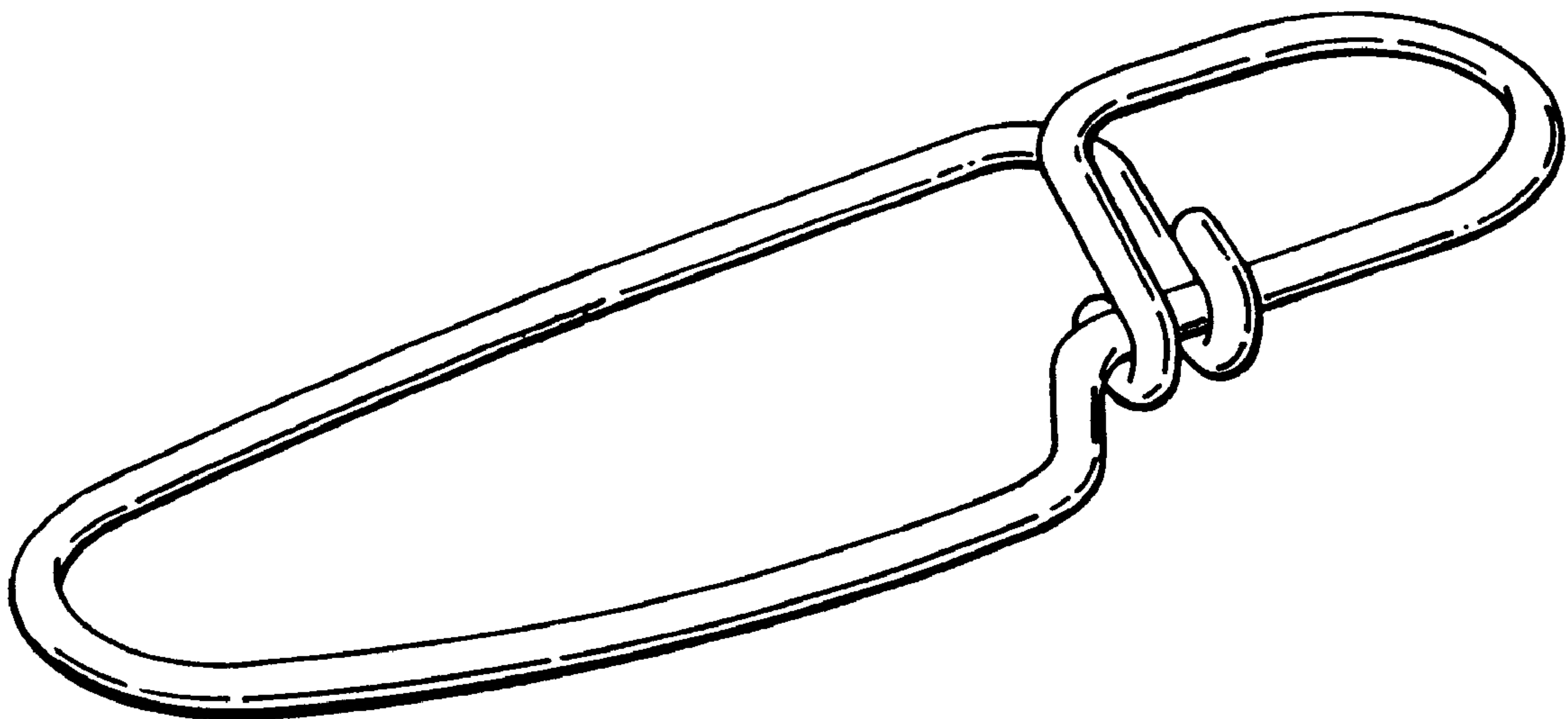

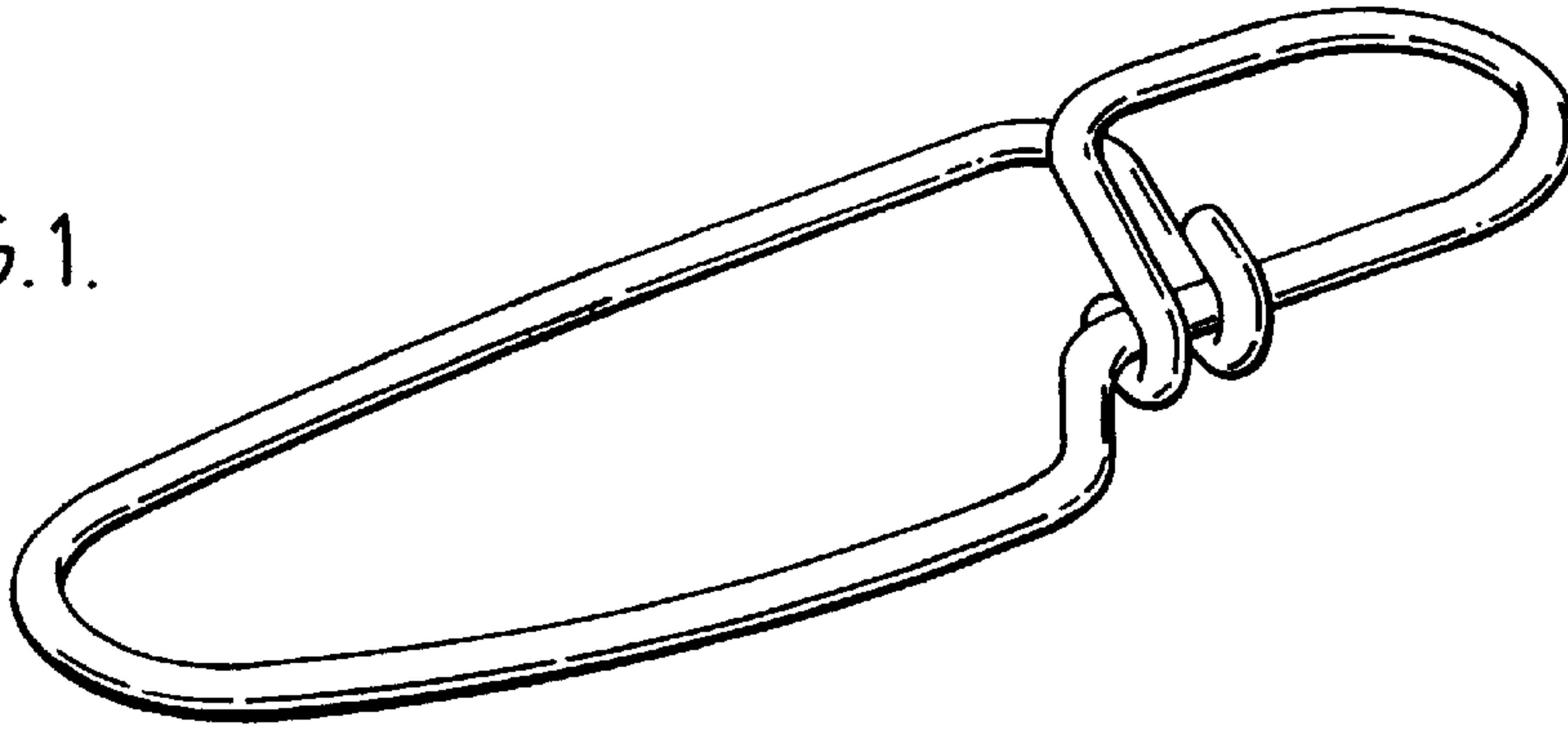

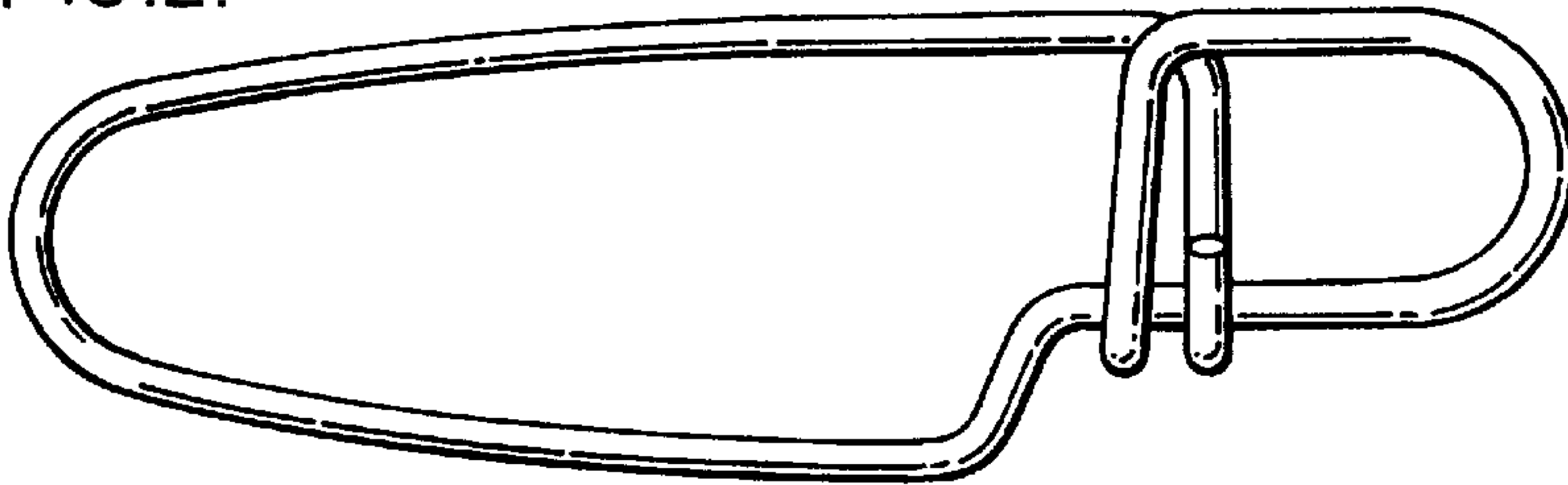

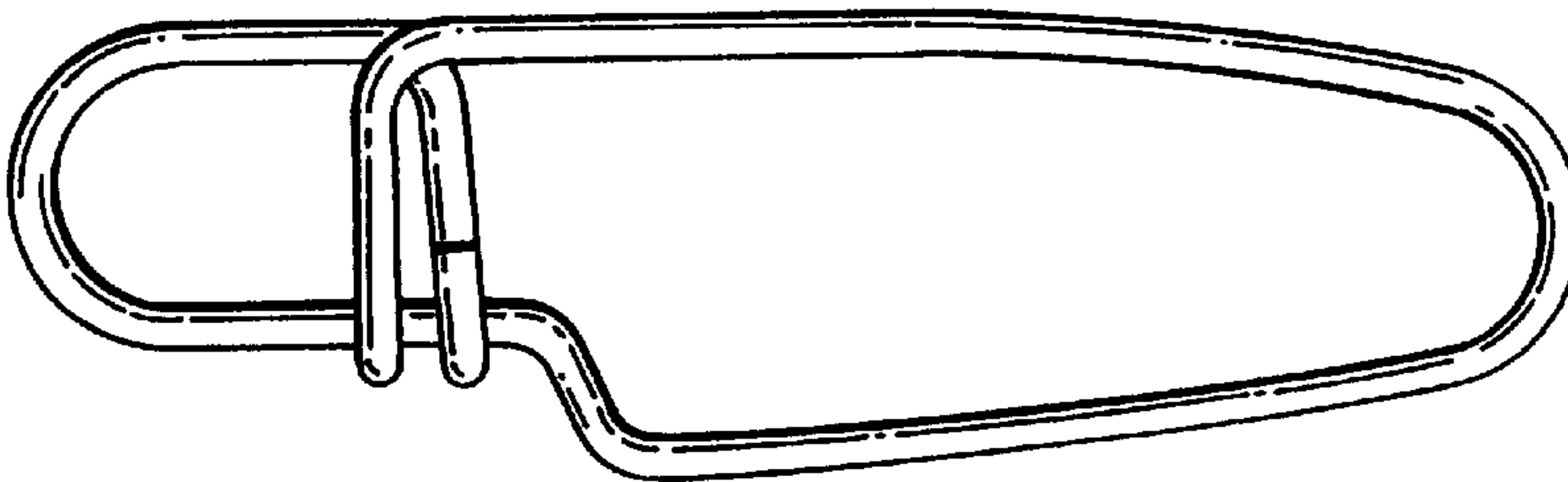

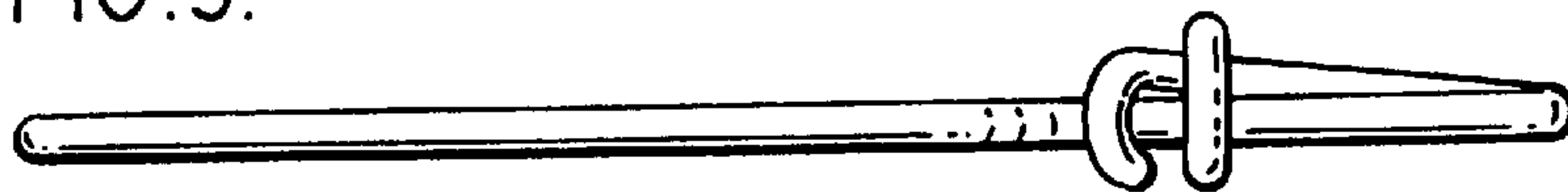

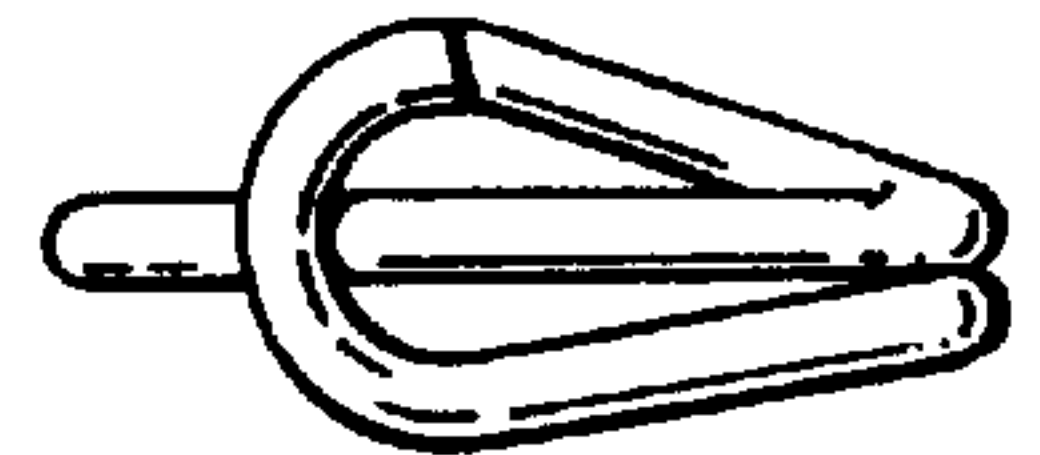
