DESCRIPTION

FIG. 1 is a front elevational view of my lighter case. FIG. 2 is a rear elevational view of my lighter case. FIG. 3 is a left side elevational view of my lighter case. FIG. 4 is a right side elevational view of my lighter case. FIG. 5 is a top plan view of my lighter case; and, FIG. 6 is a bottom plan view of my lighter case. The broken lines are shown for illustrative purposes only and form no part of the claimed design.

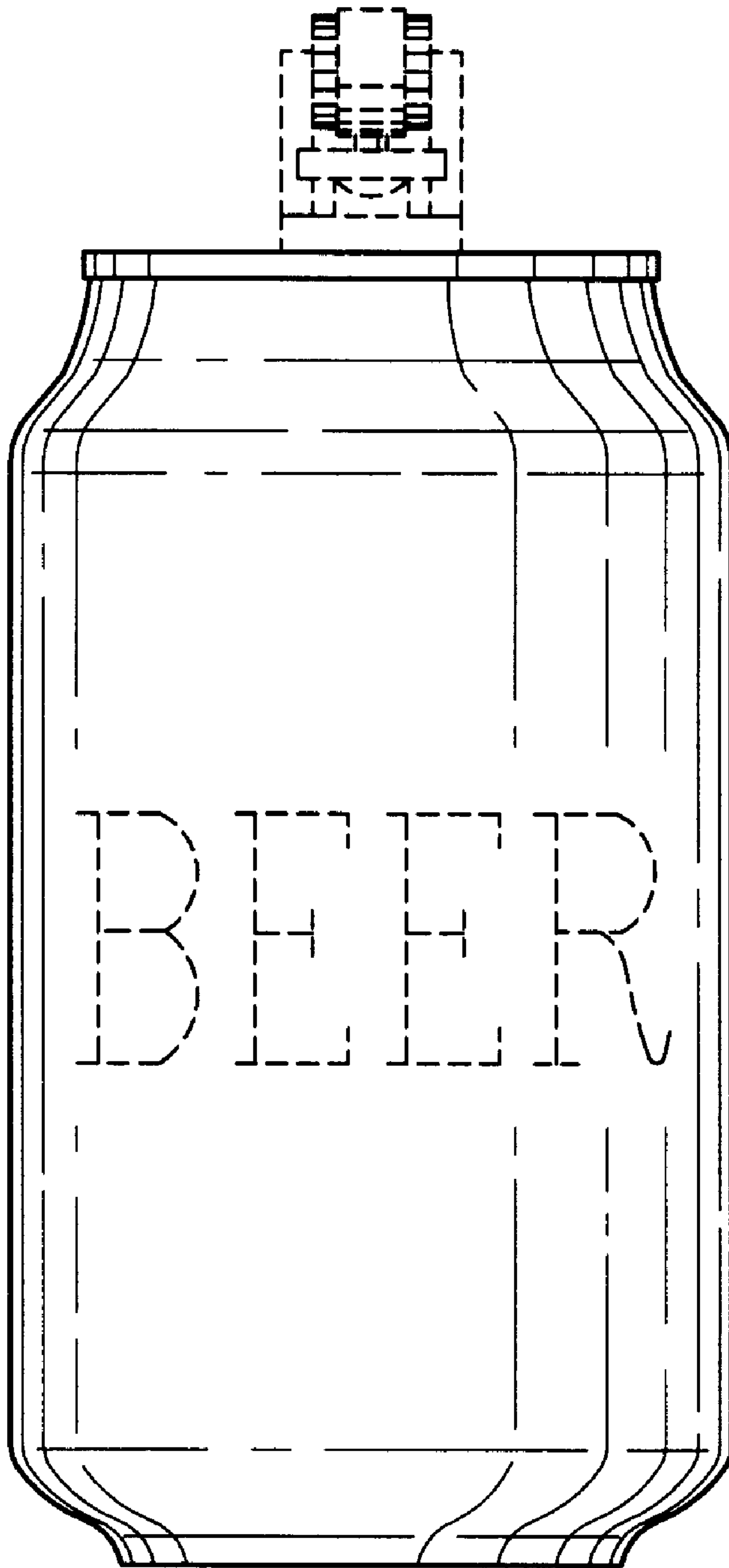

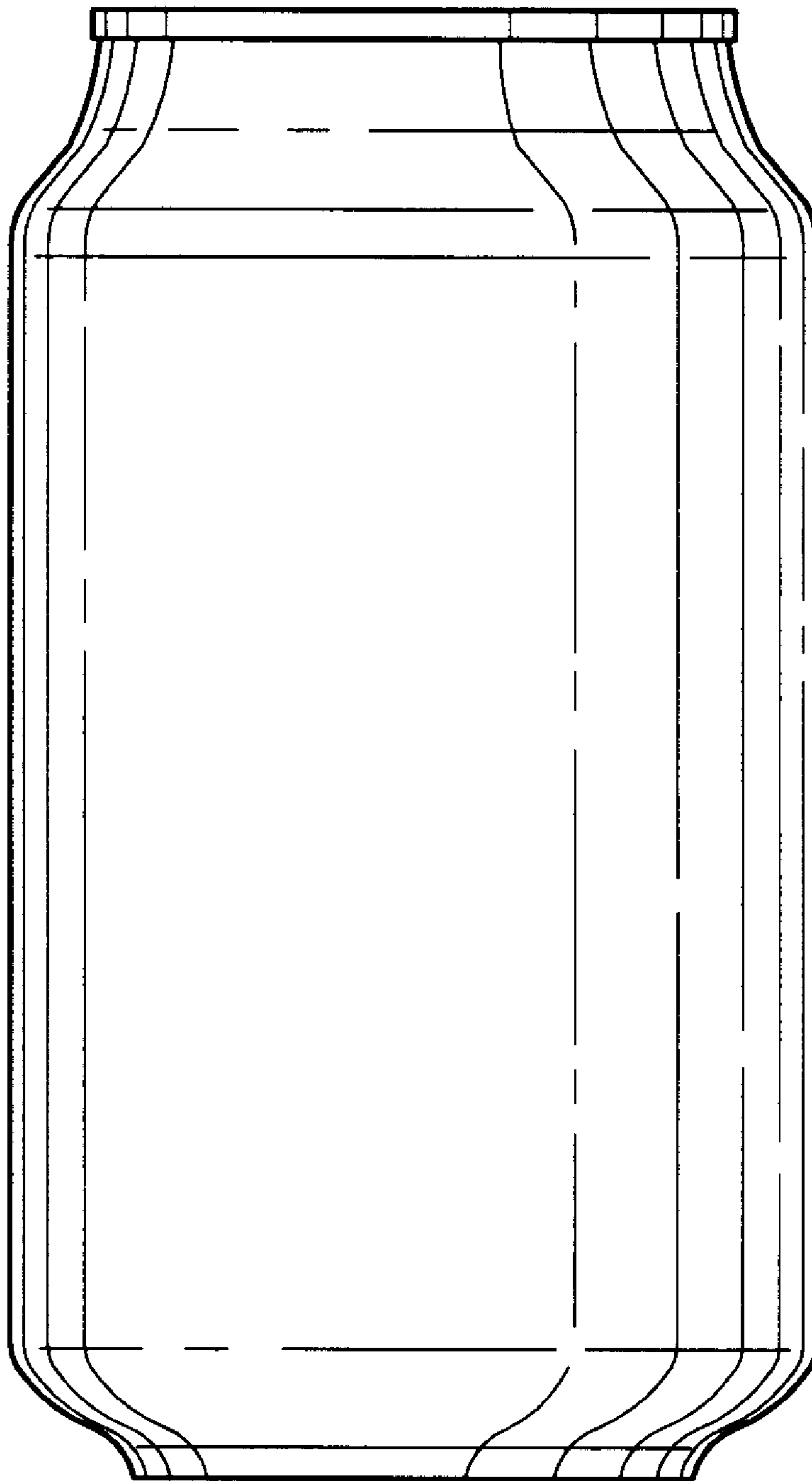

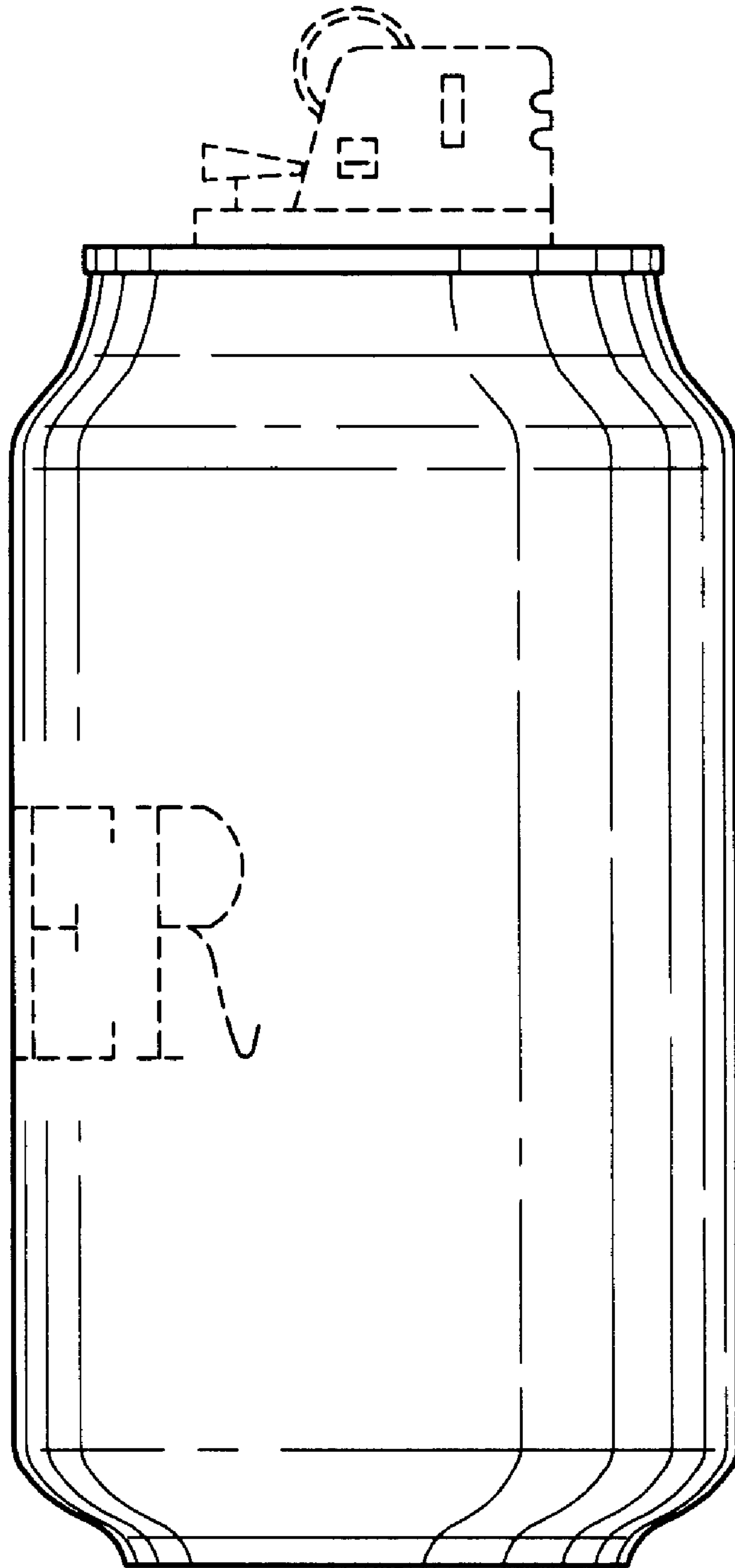

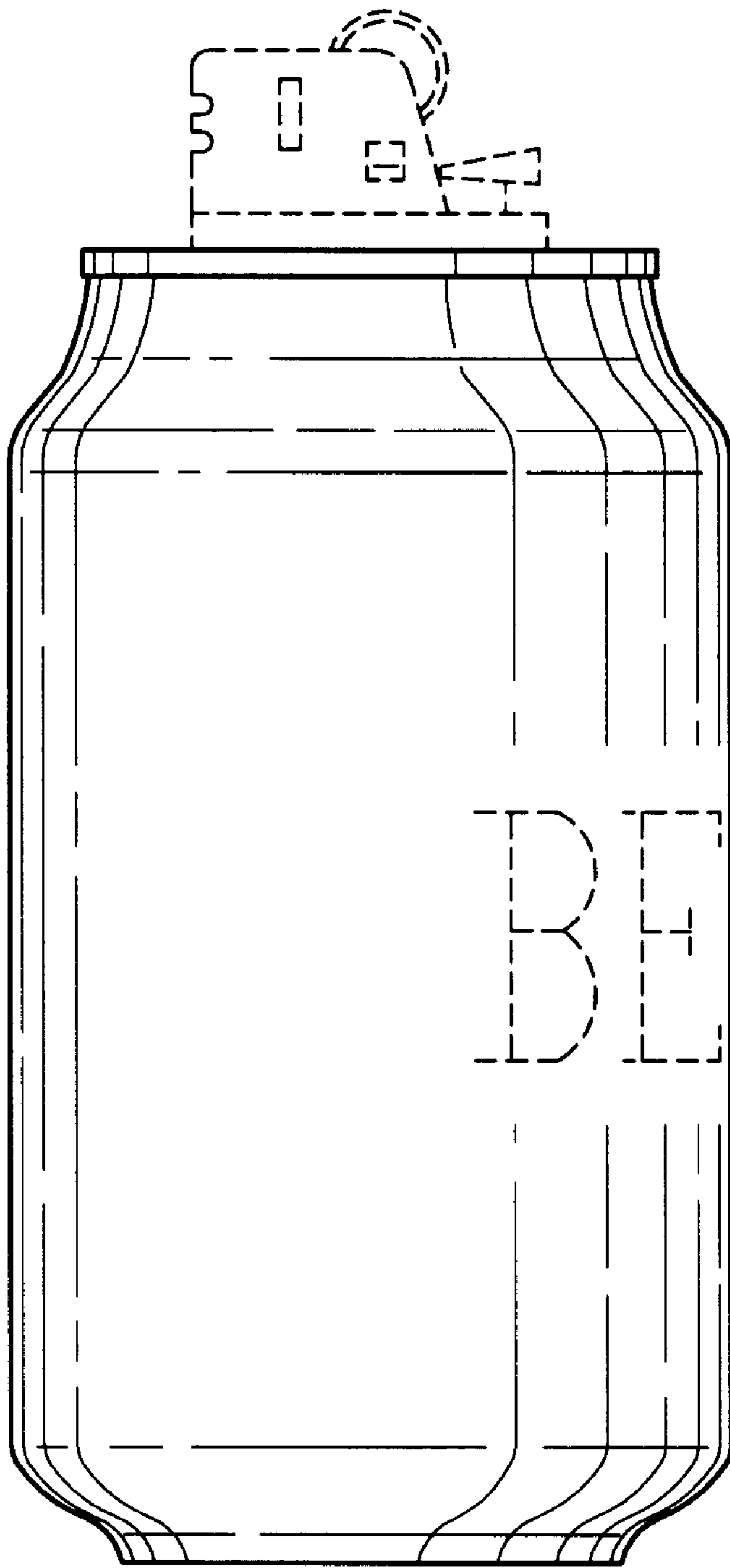

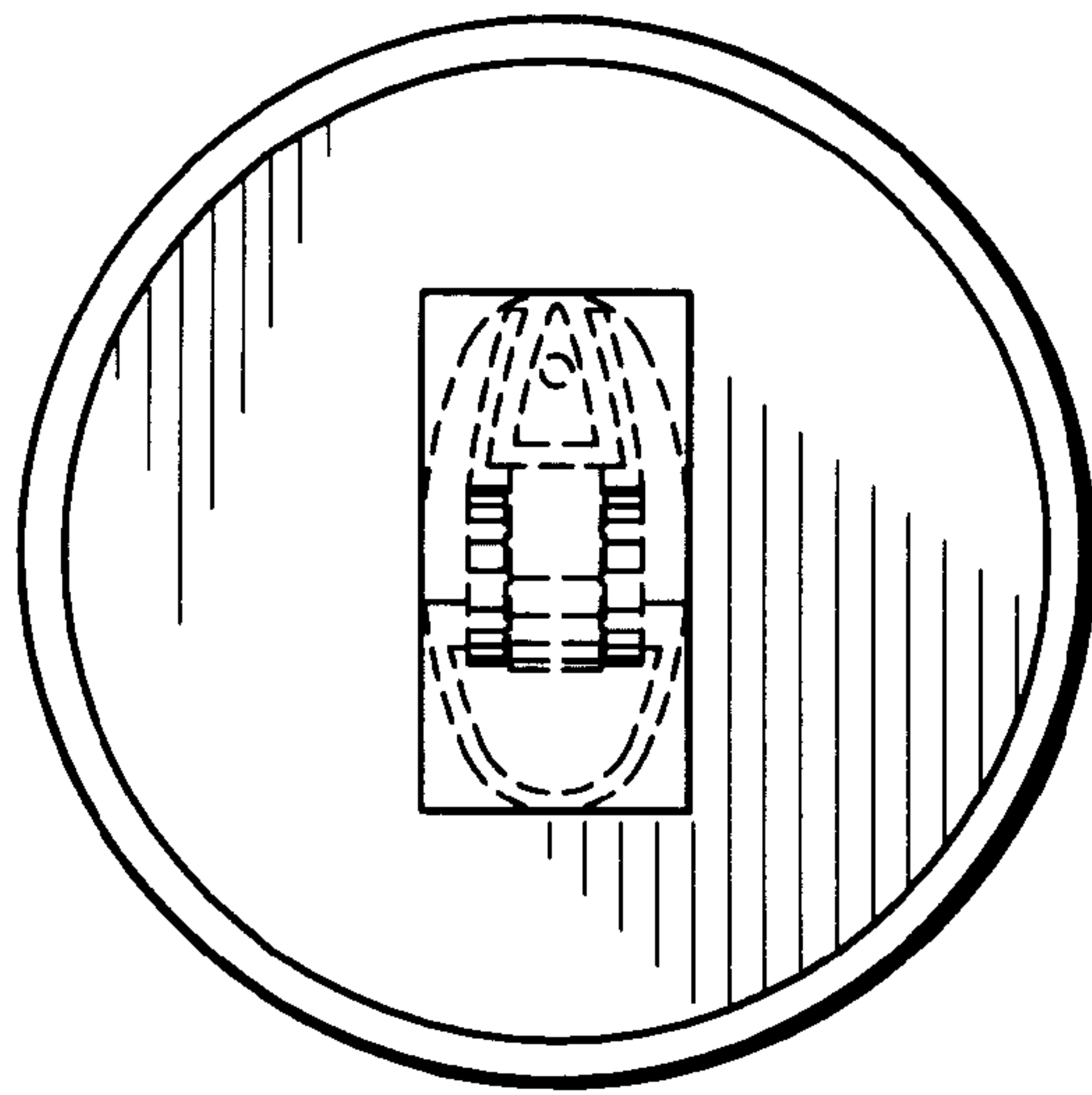

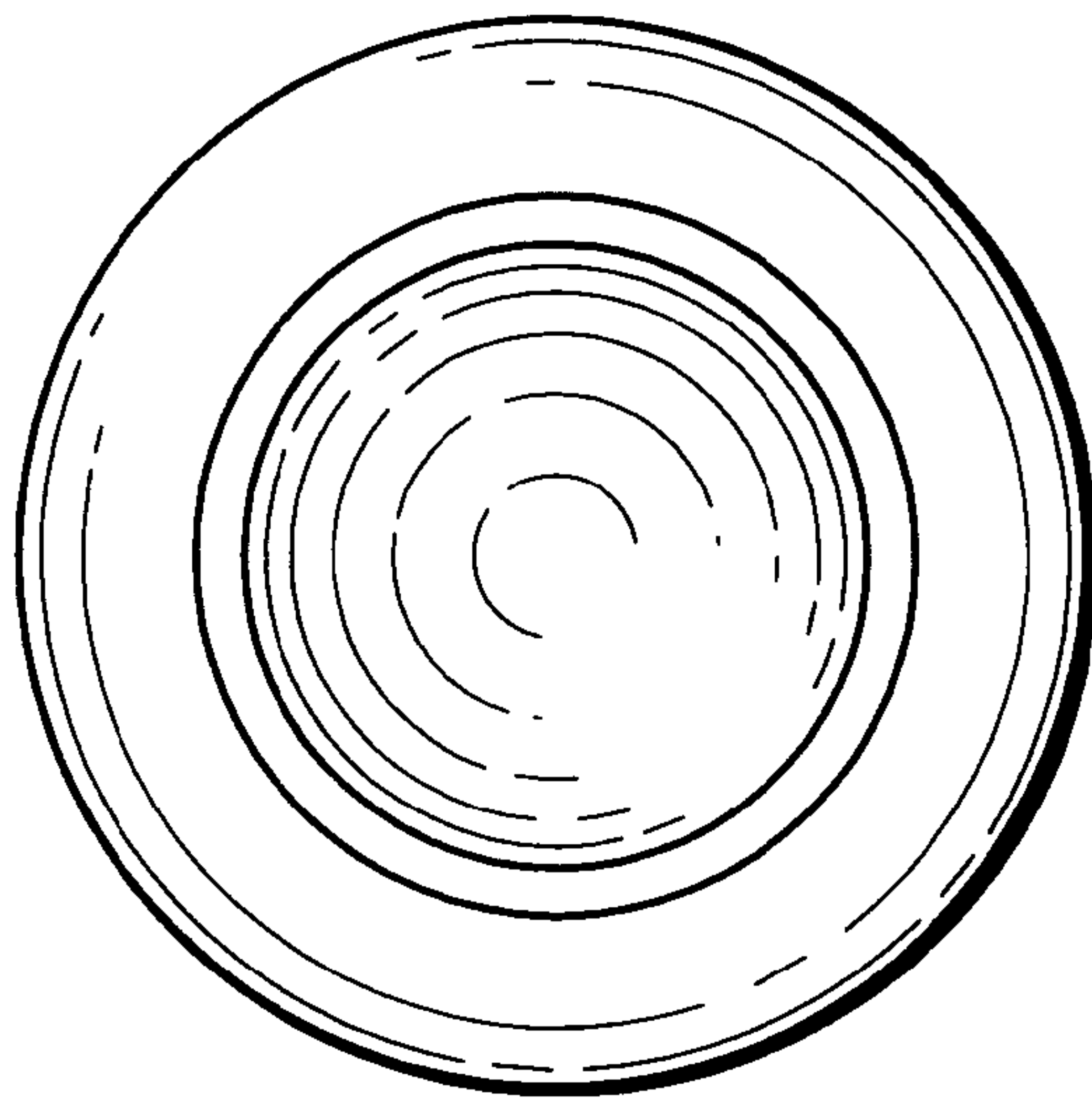
