The ornamental design for a hair bow, as shown and described.

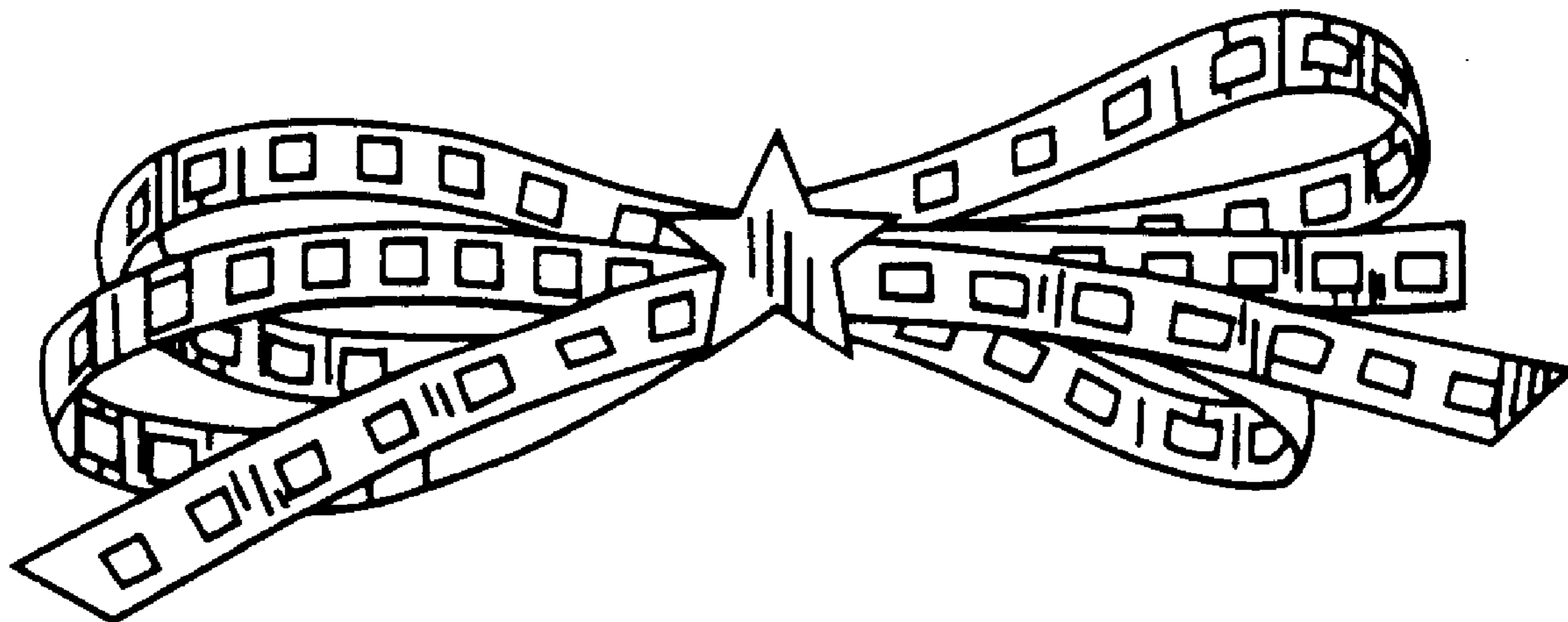
DESCRIPTION

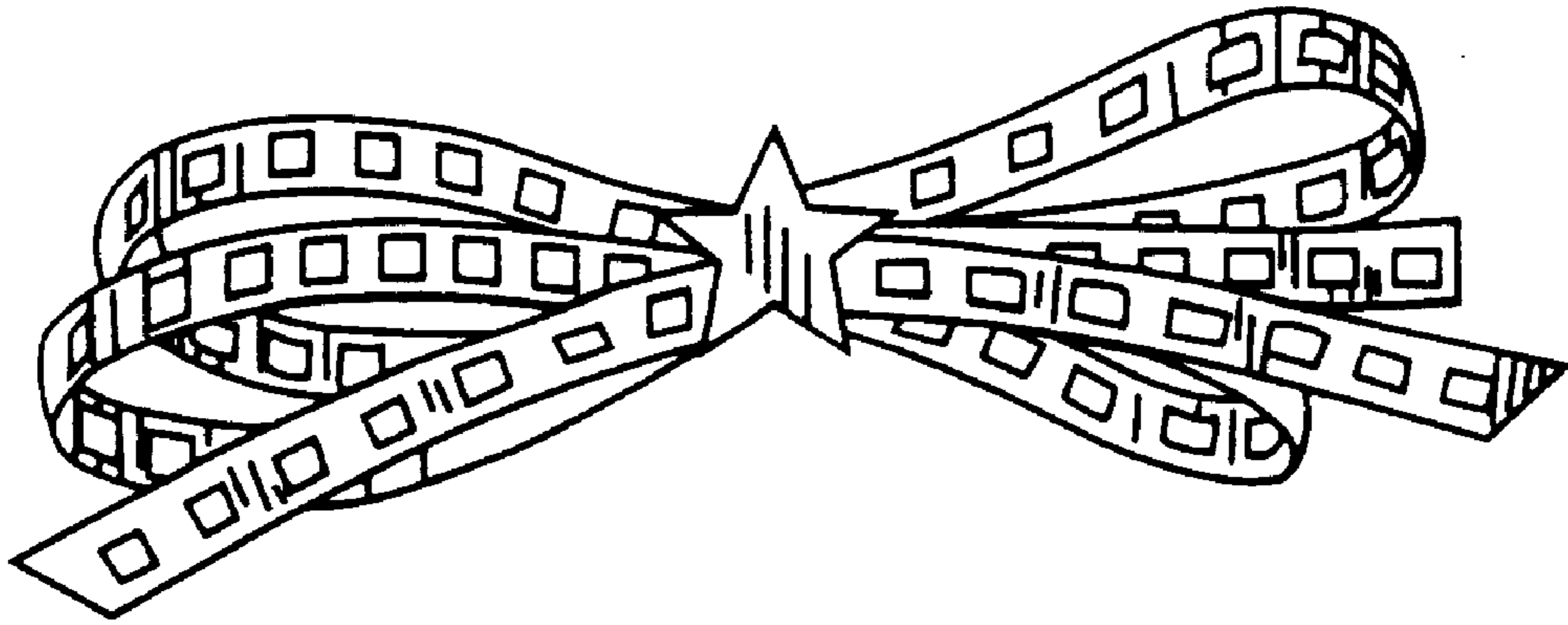

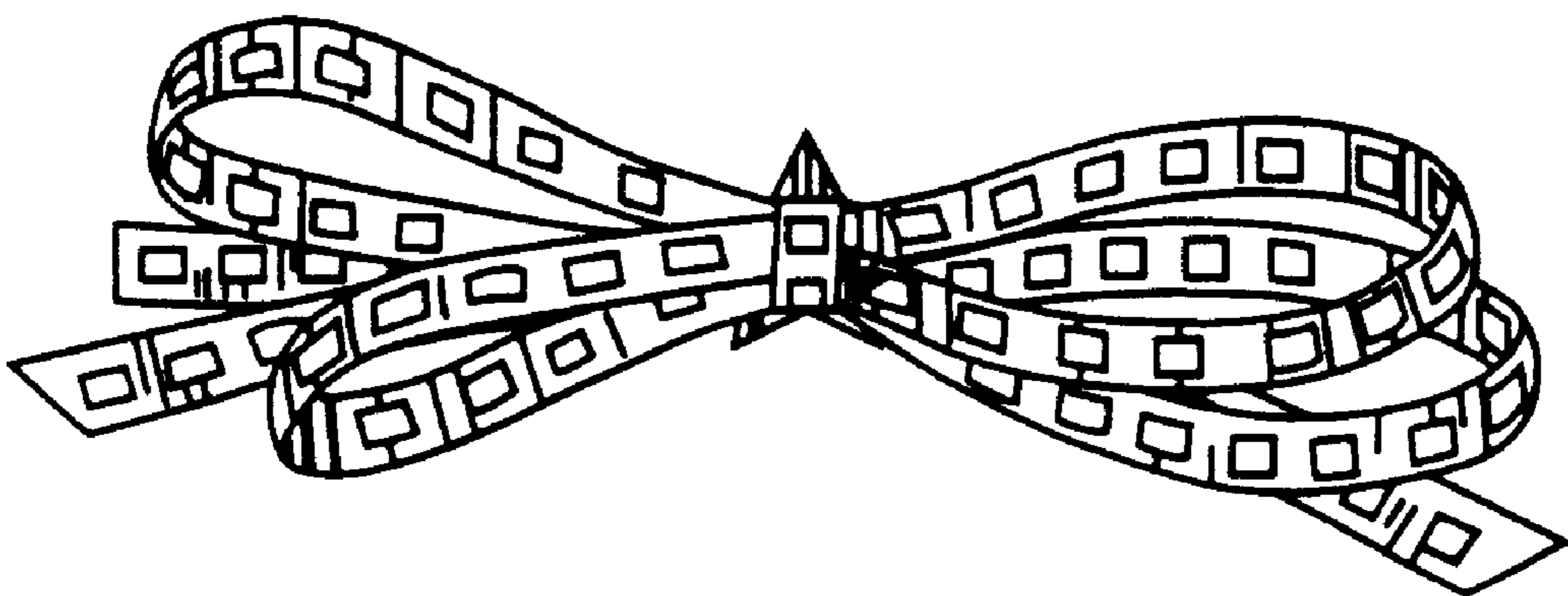
