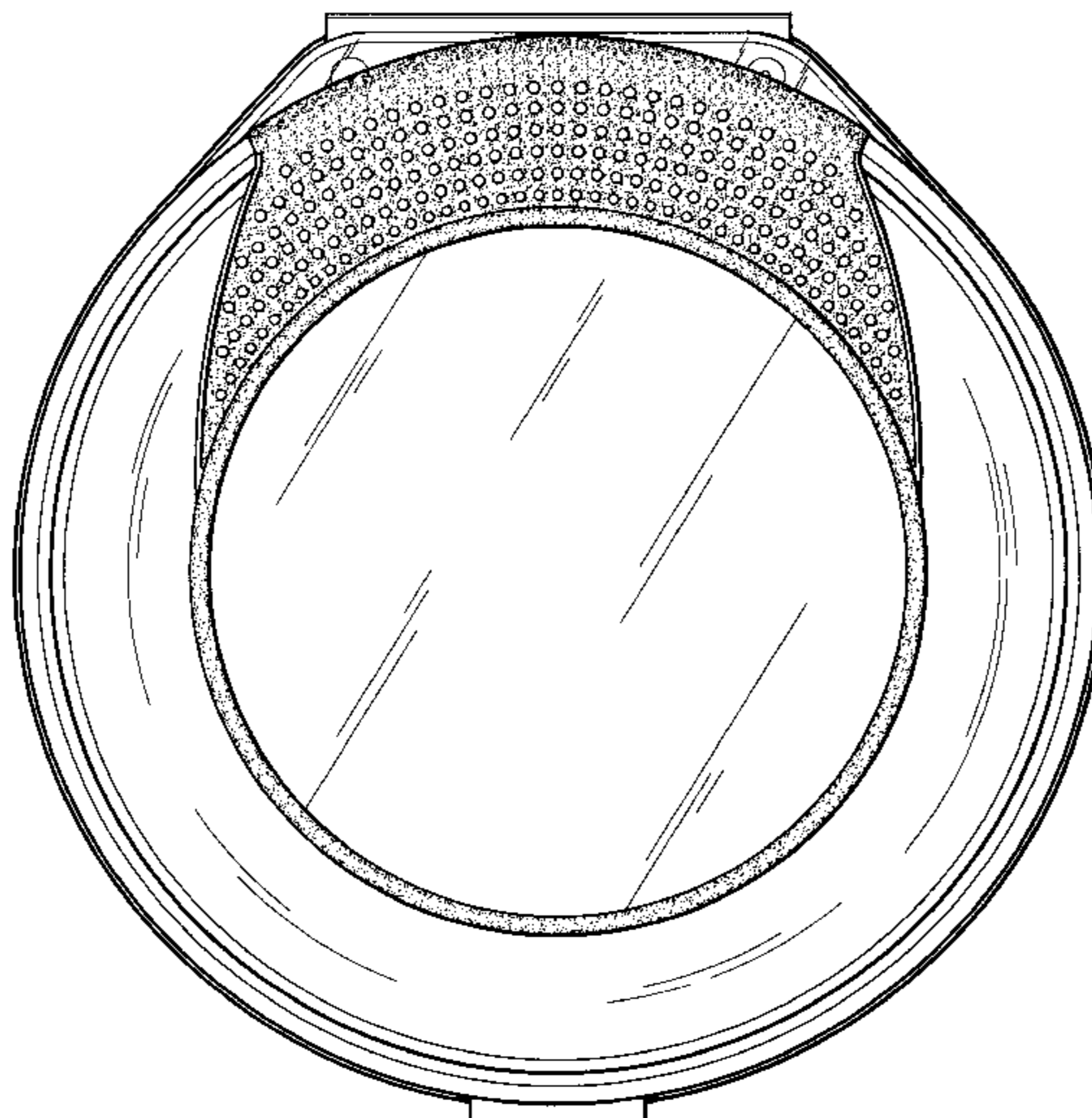
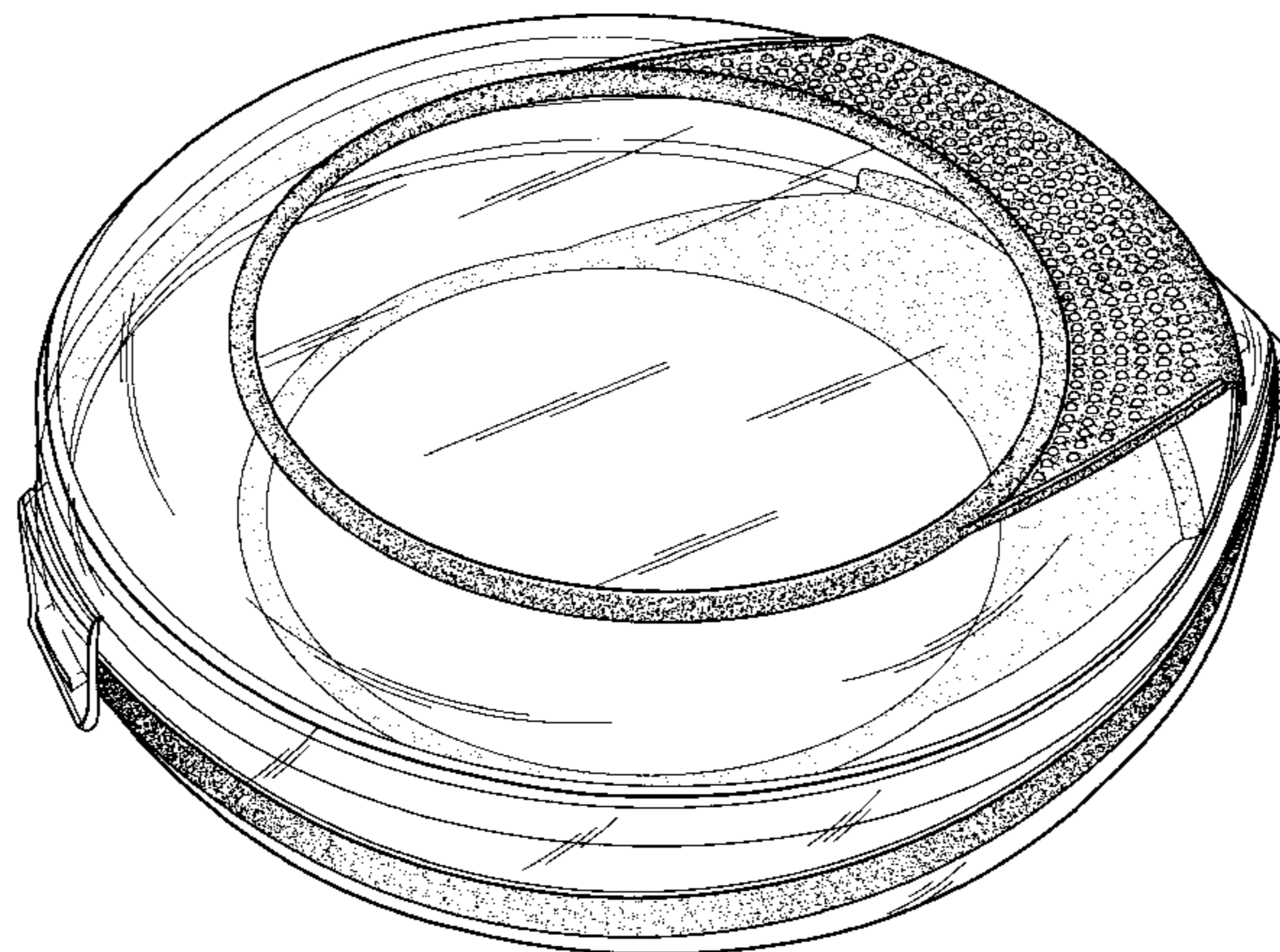
[57] **CLAIM**

The ornamental design for a portable compact disc storage container, as shown and described.

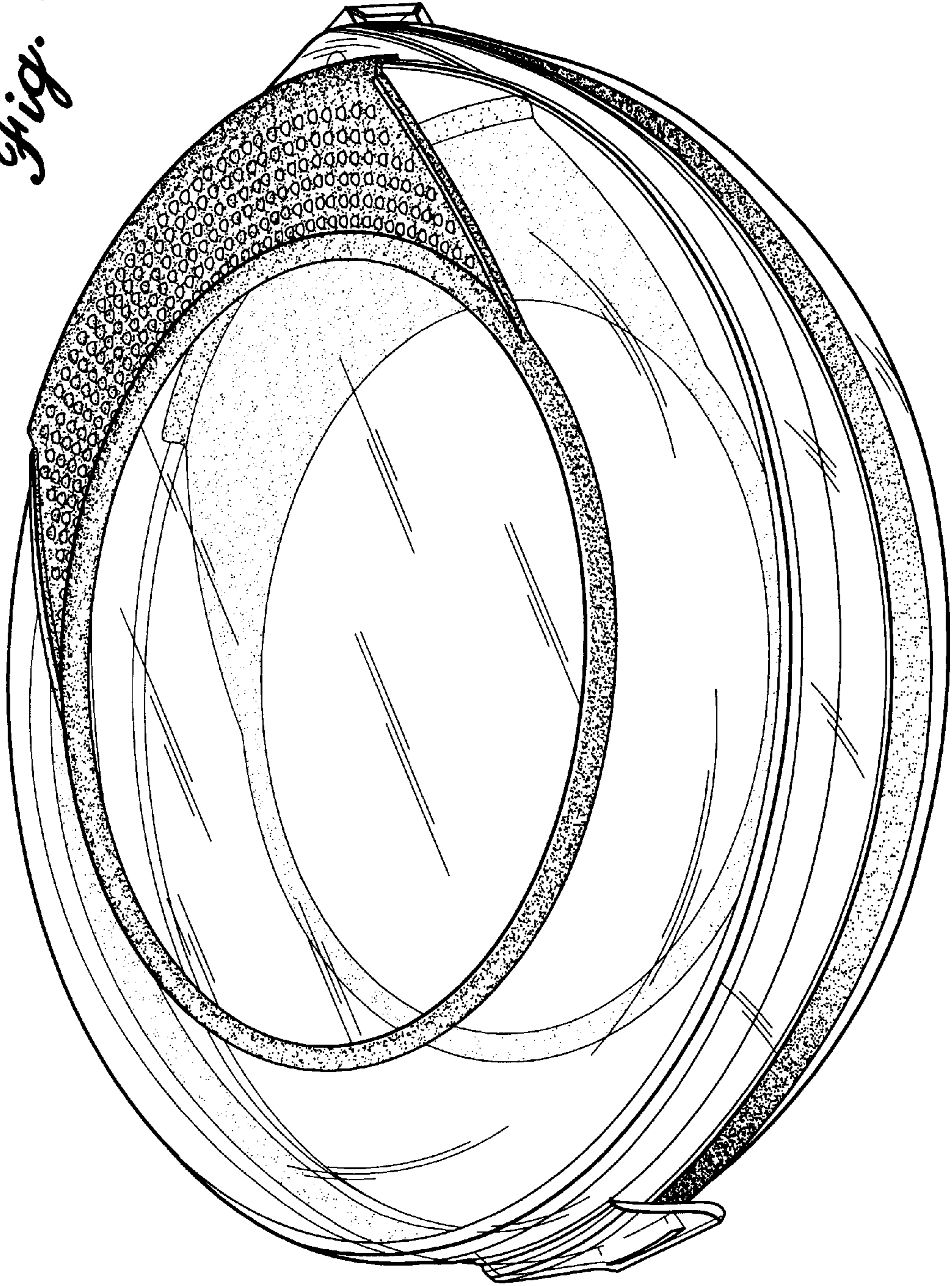
**DESCRIPTION**

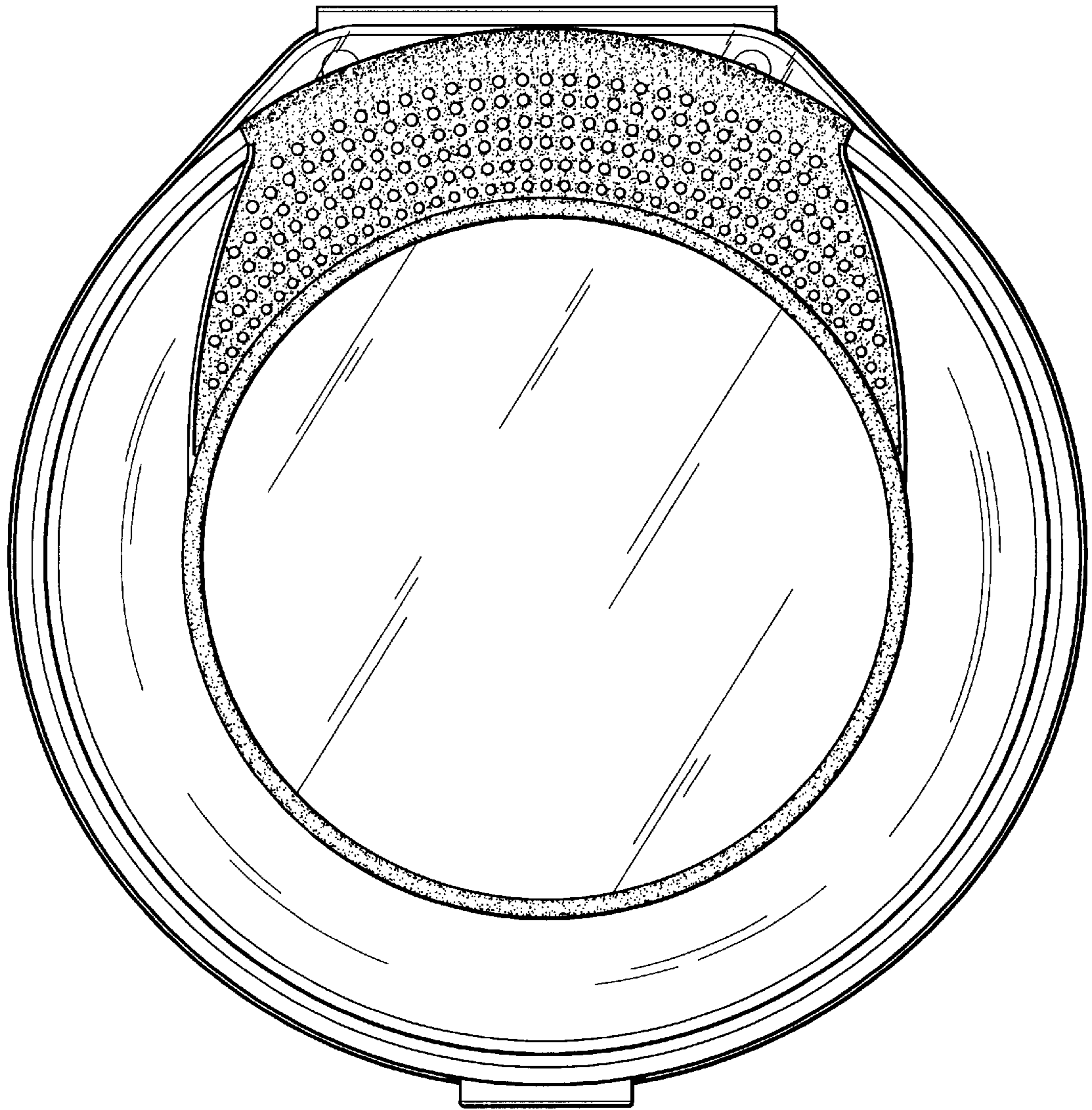

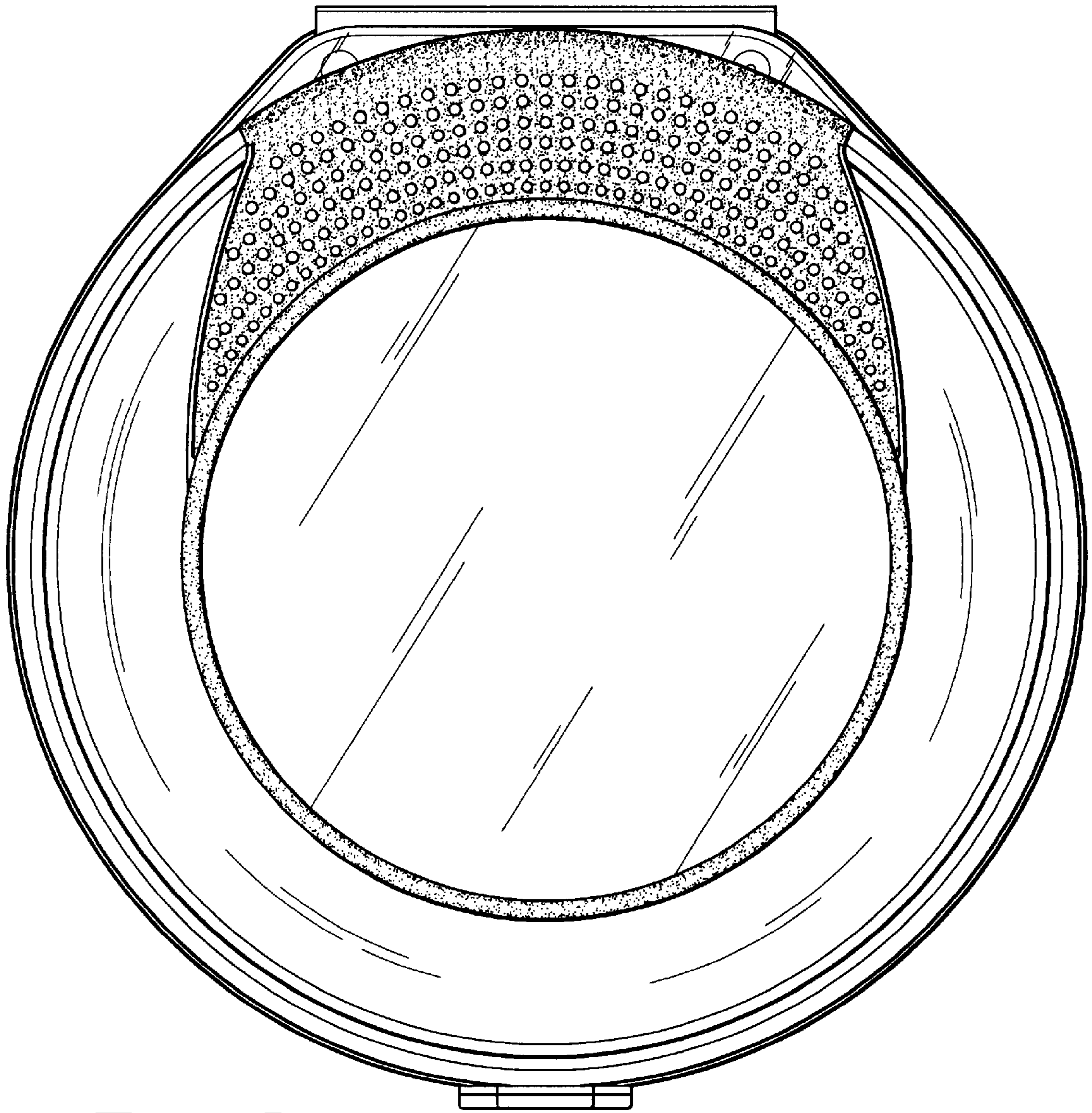

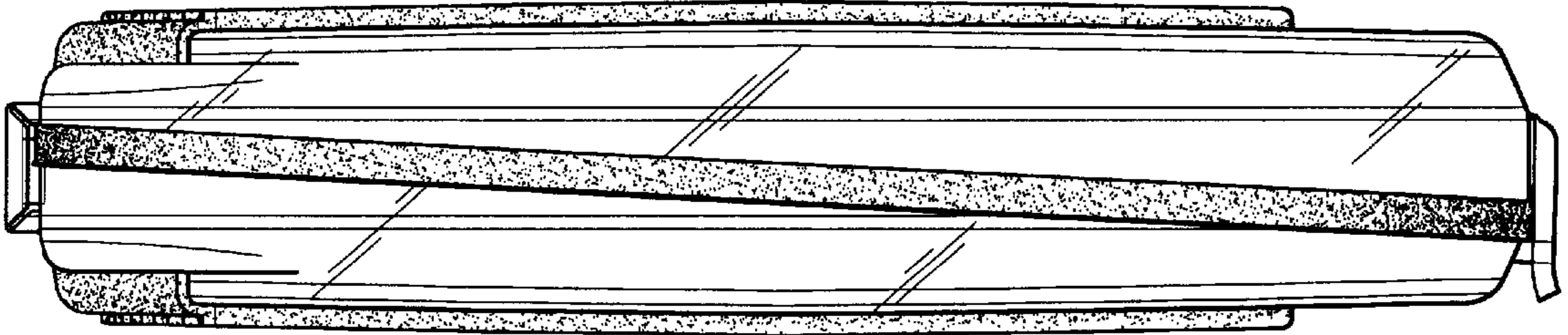




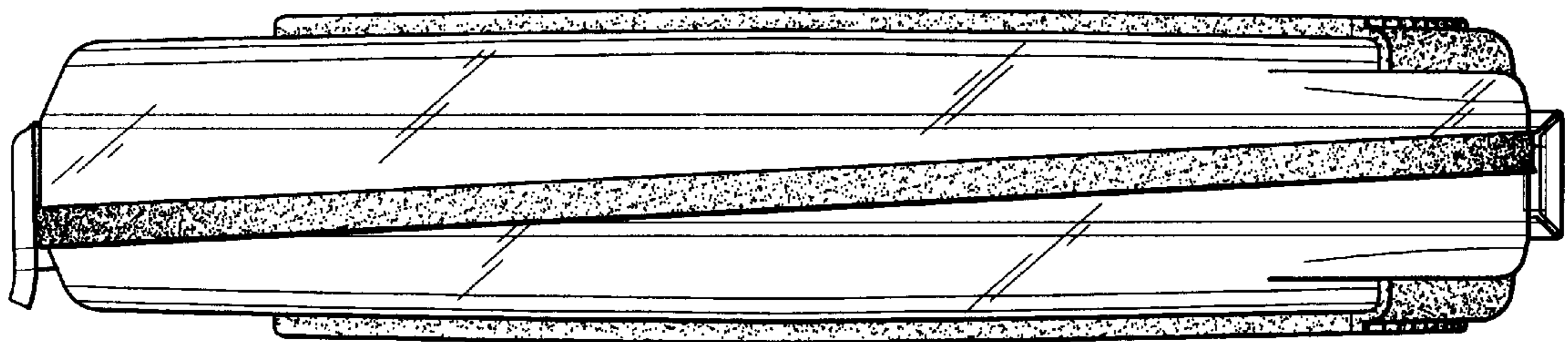

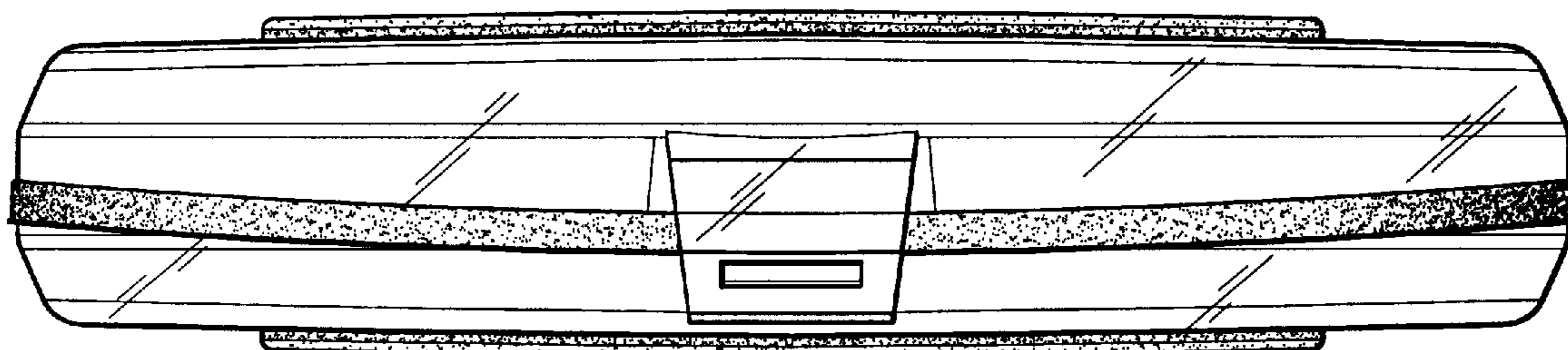

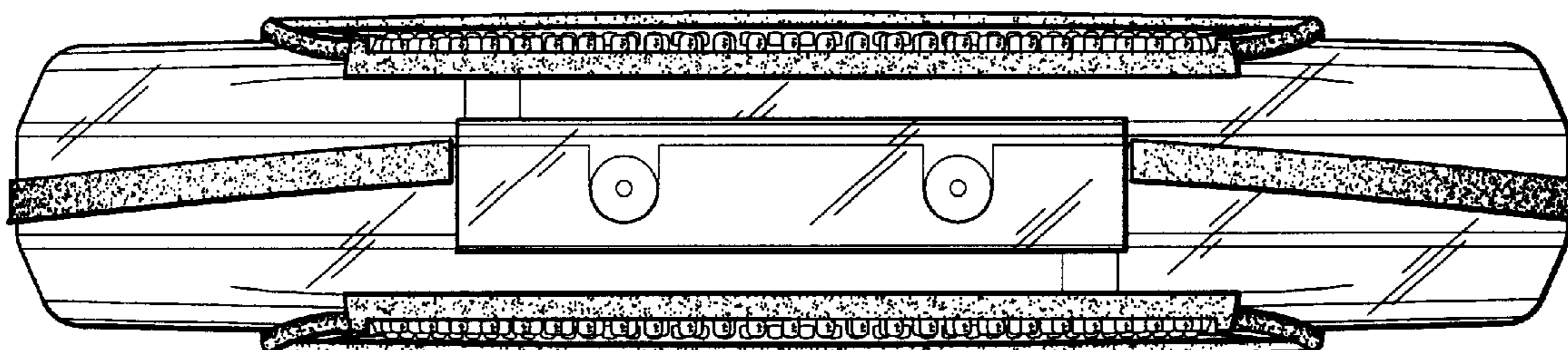
