We claim the ornamental design for a microwave oven, as shown and described.

### DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of our new design for a microwave oven;  
 FIG. 2 is a front elevation view of our new design;  
 FIG. 3 is a rear elevation view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a right side elevation view thereof;  
 FIG. 7 is a left side elevation view thereof;  
 FIG. 8 is a front elevation view with the door open;  
 FIG. 9 is a top, front and right side perspective view thereof with the exhaust outlet cover opened; and,  
 FIG. 10 is a top, front and right side perspective view thereof, the details shown in broken lines are for illustrative purposes only and form no part of the claimed design.

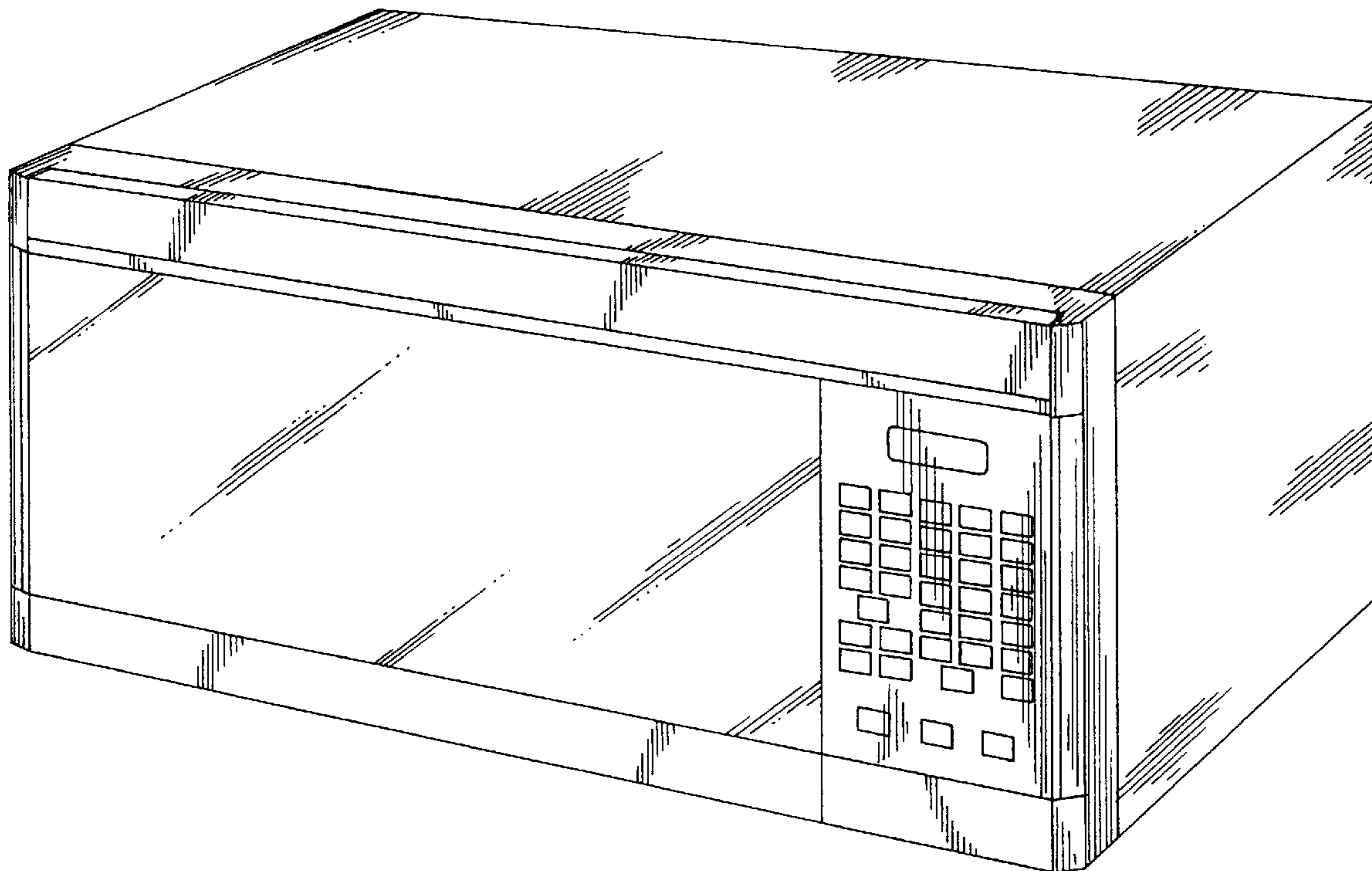

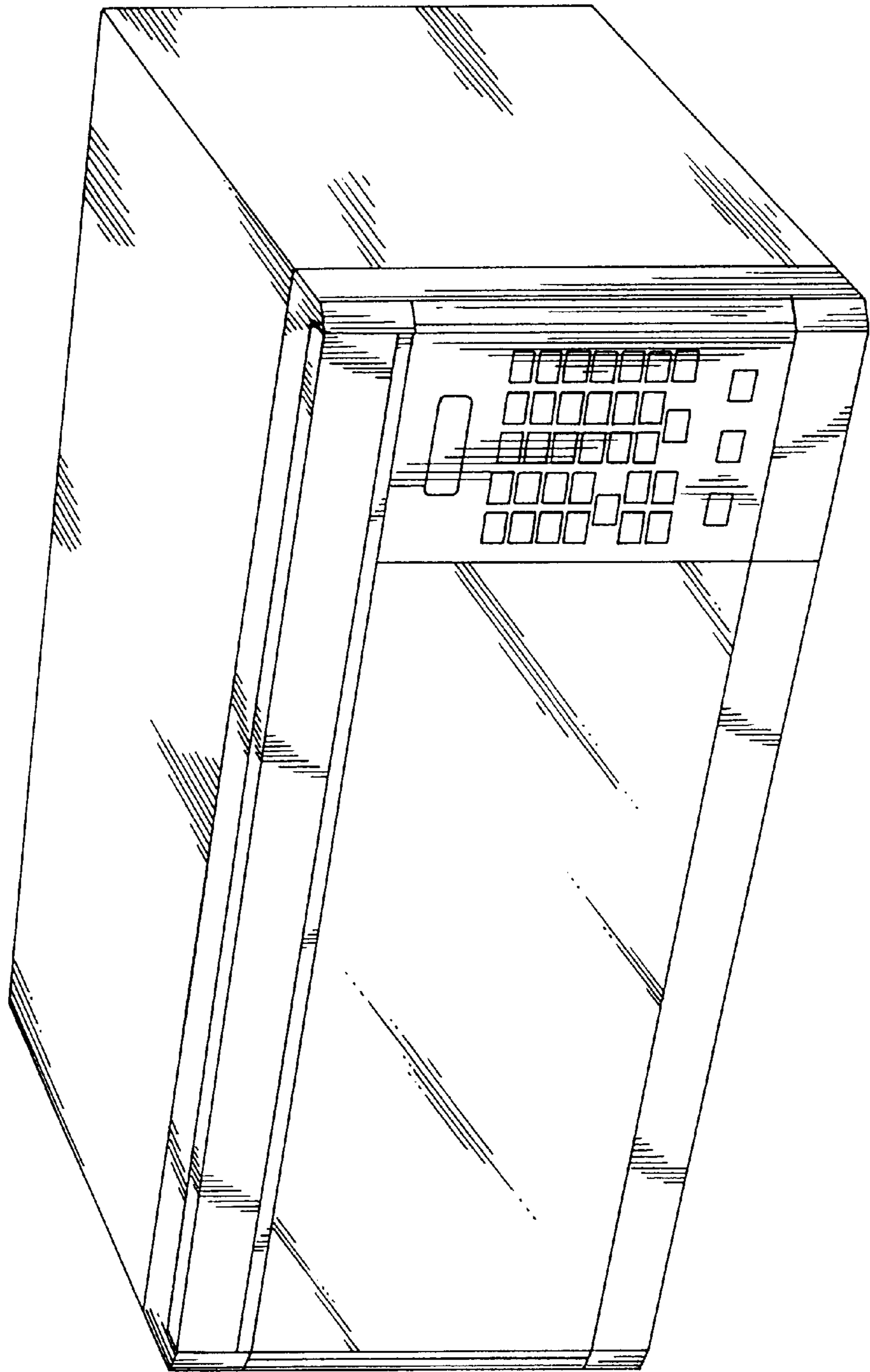

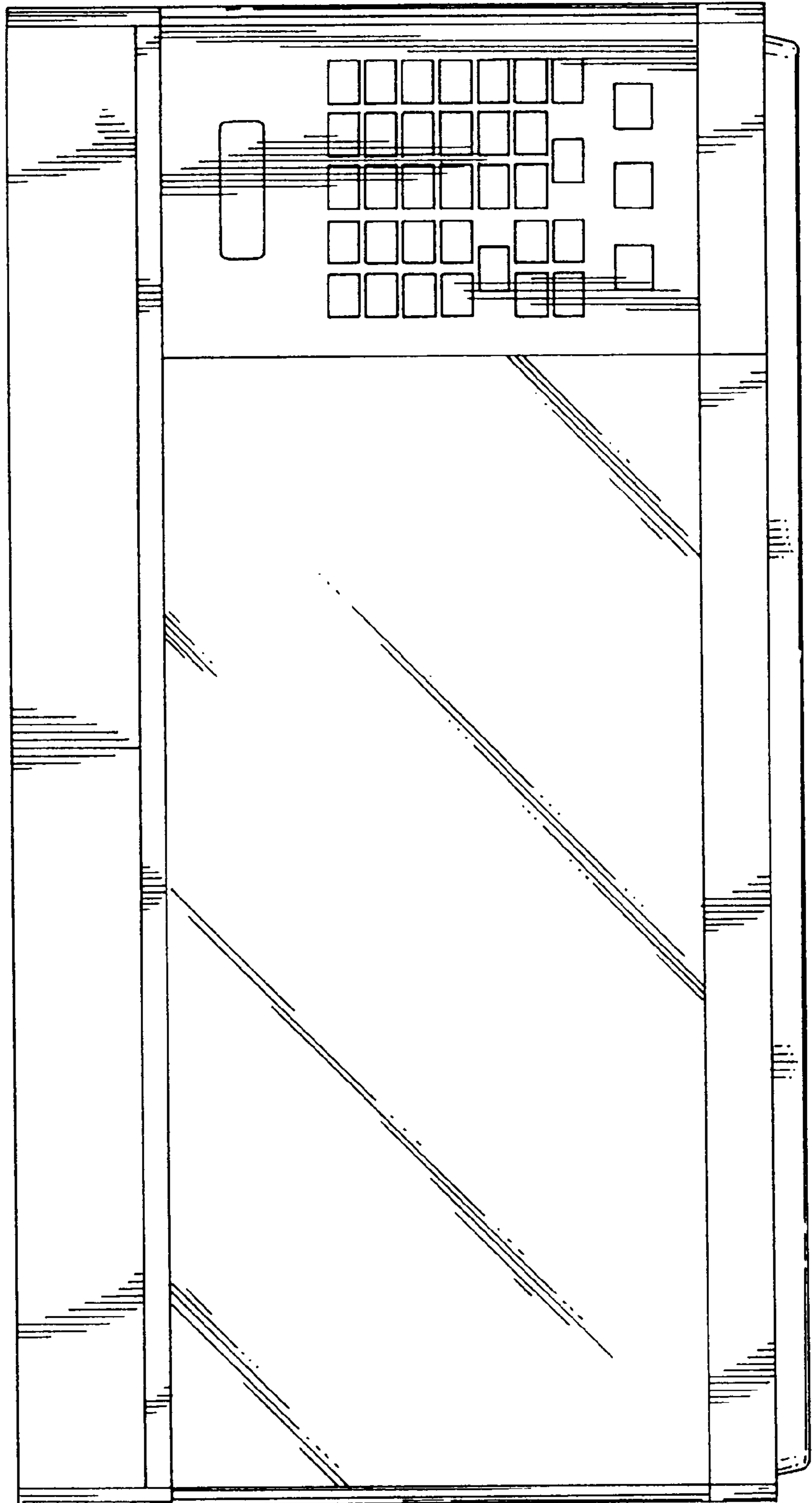

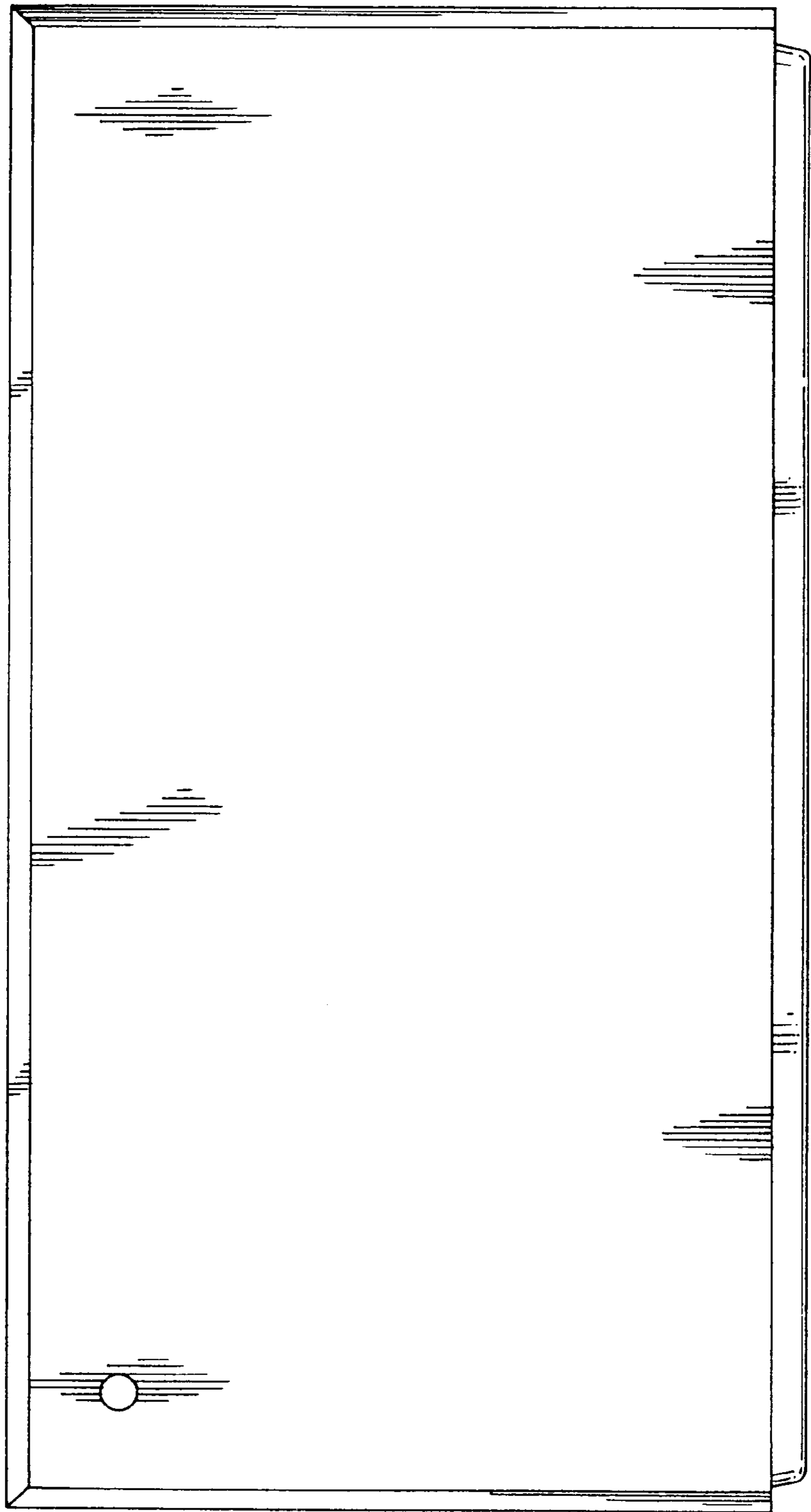

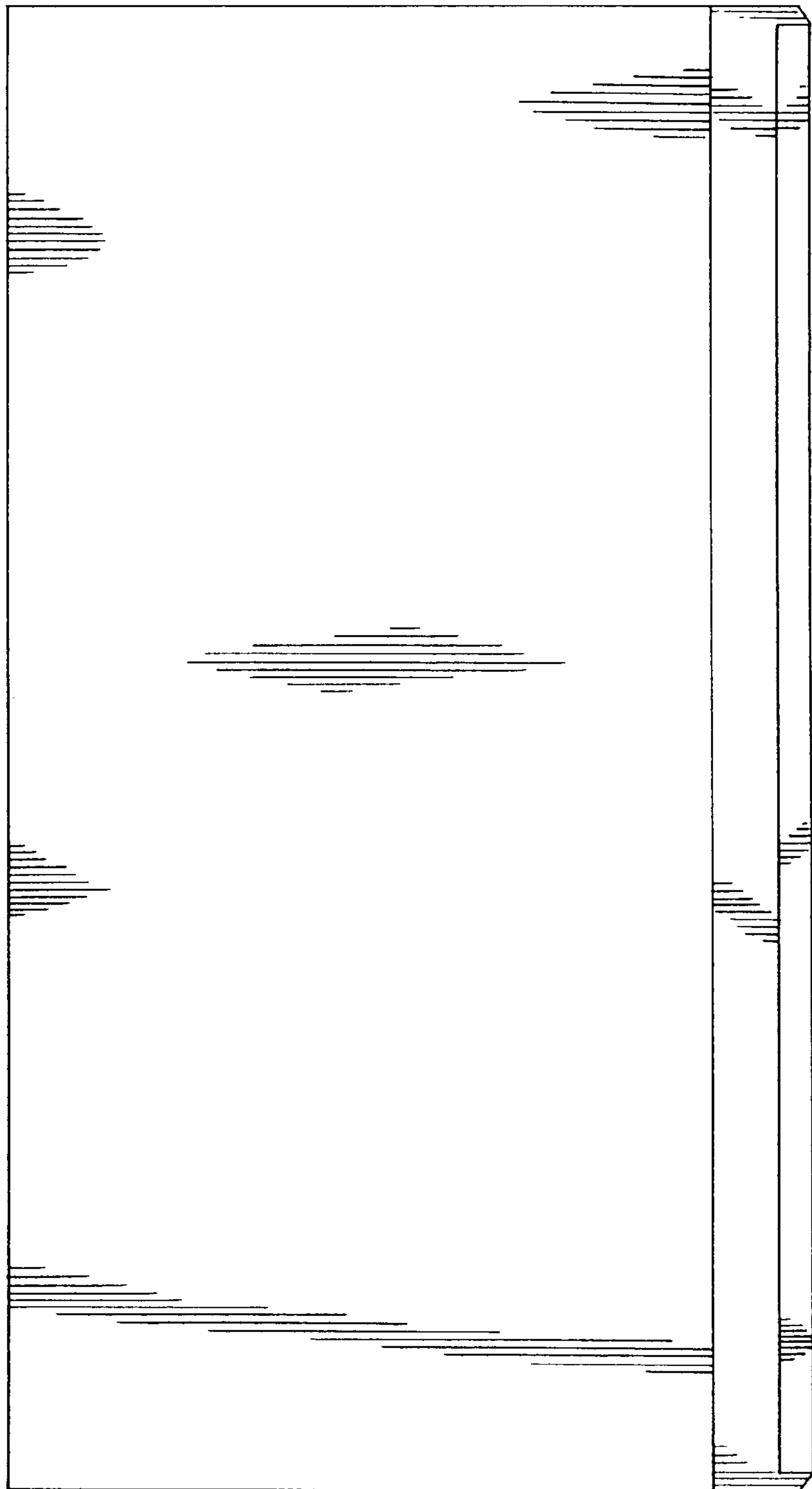

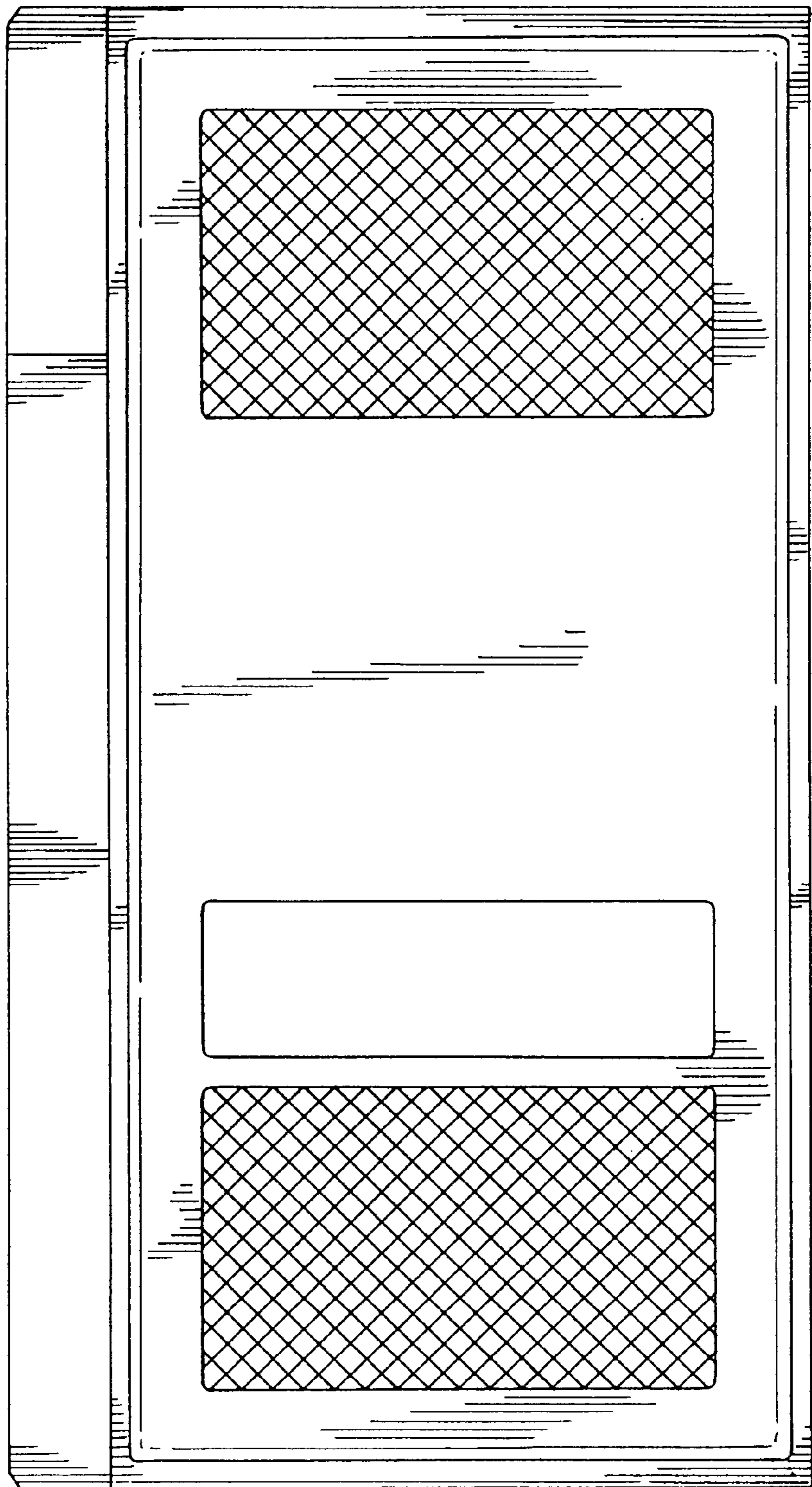

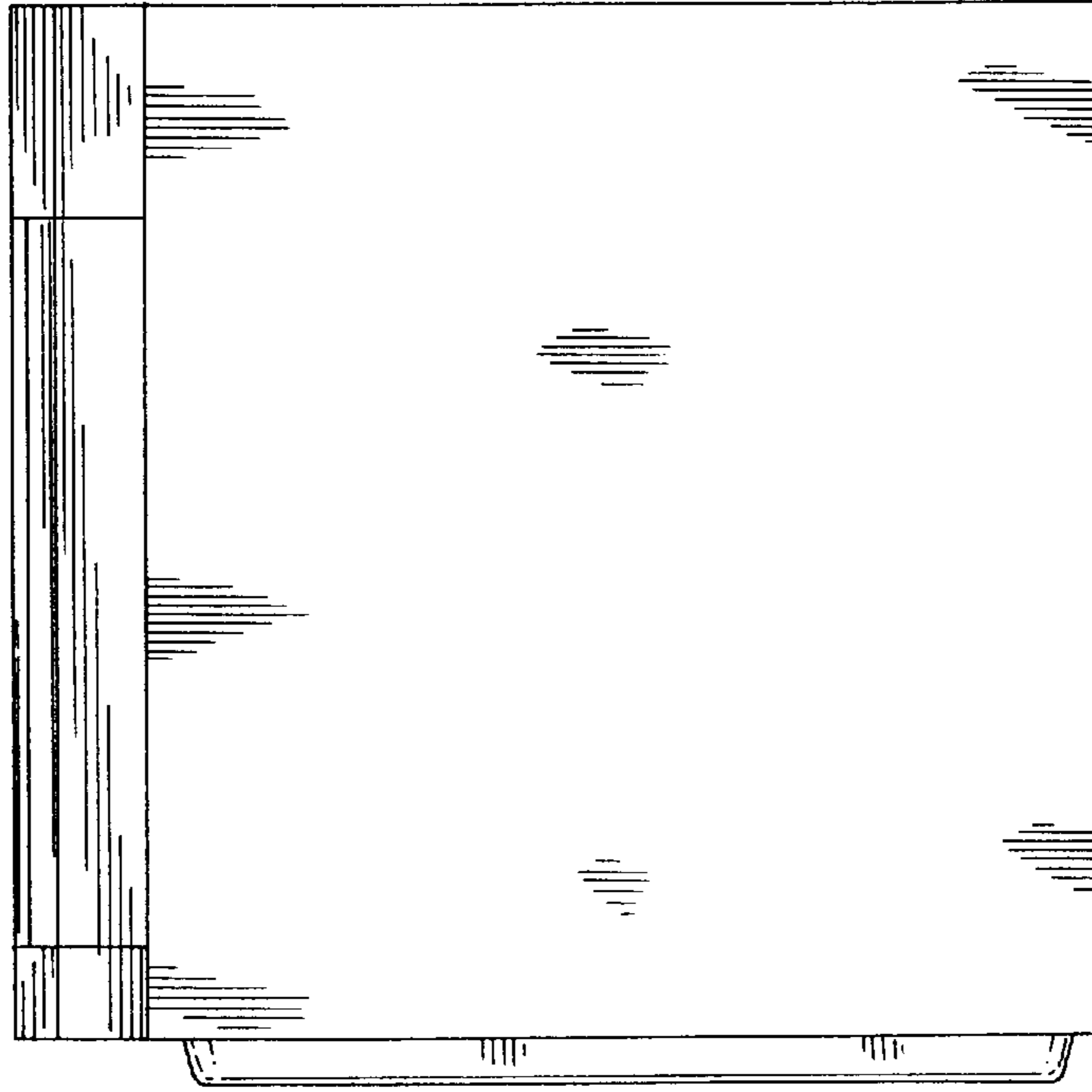

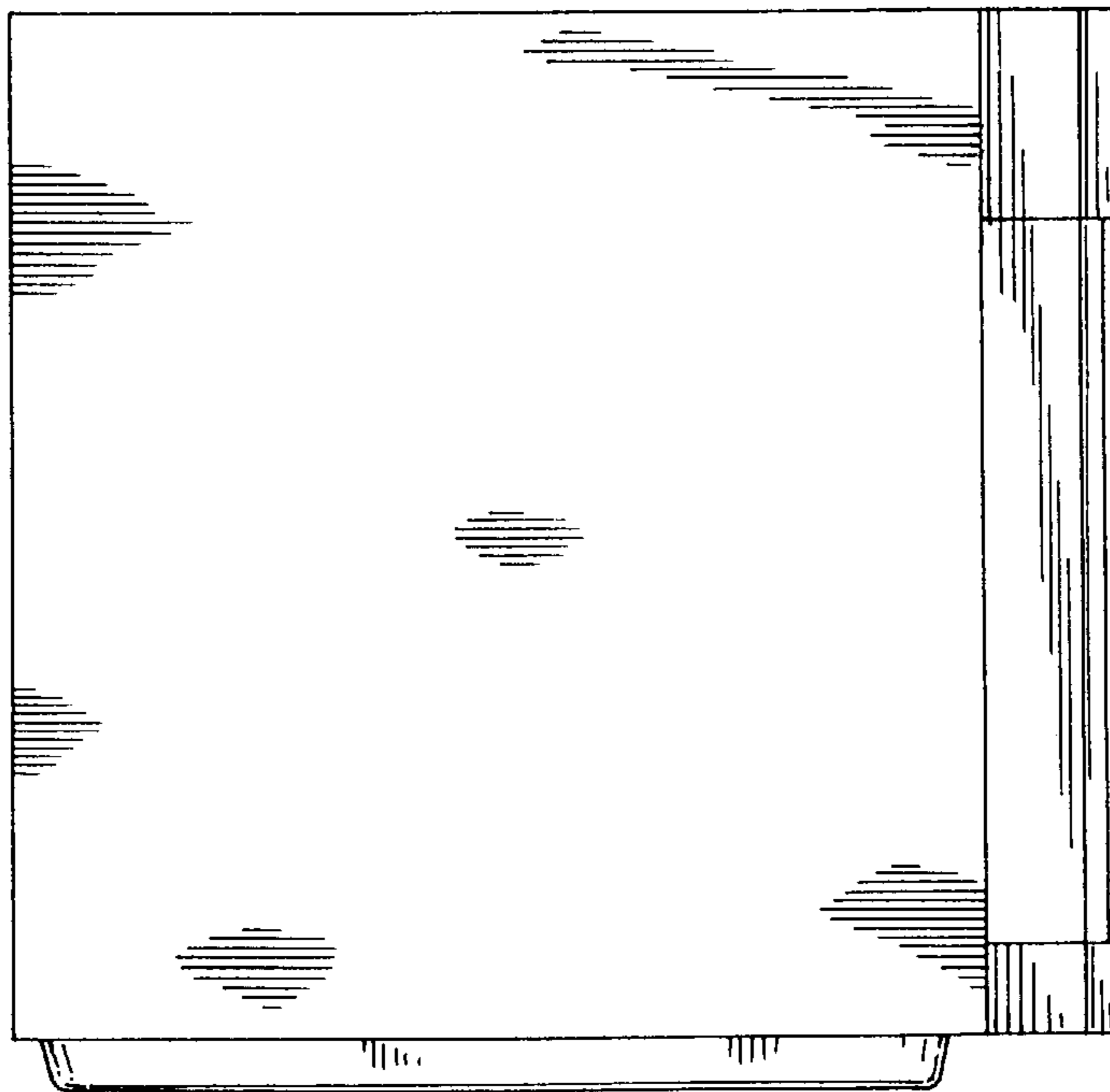

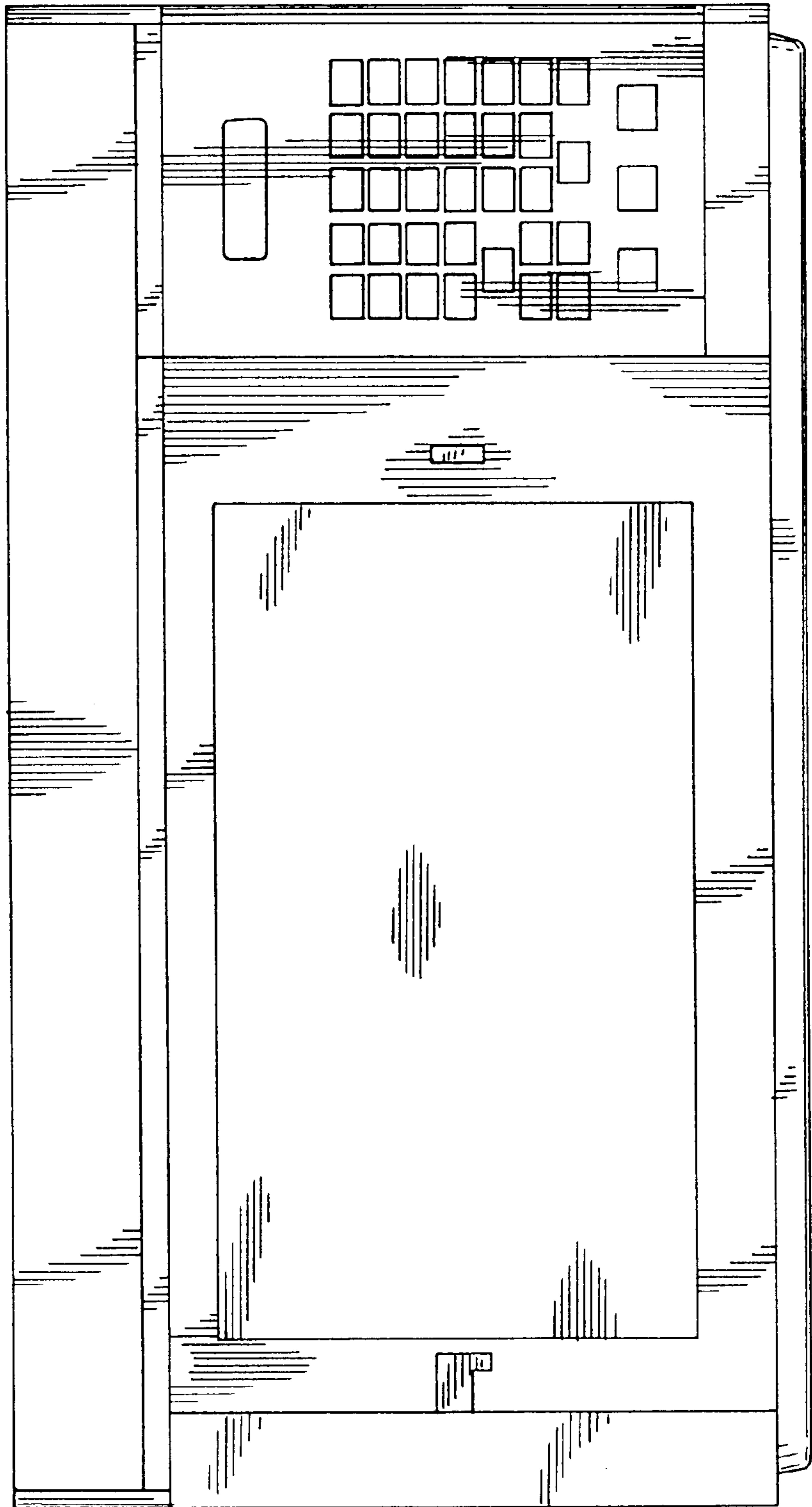

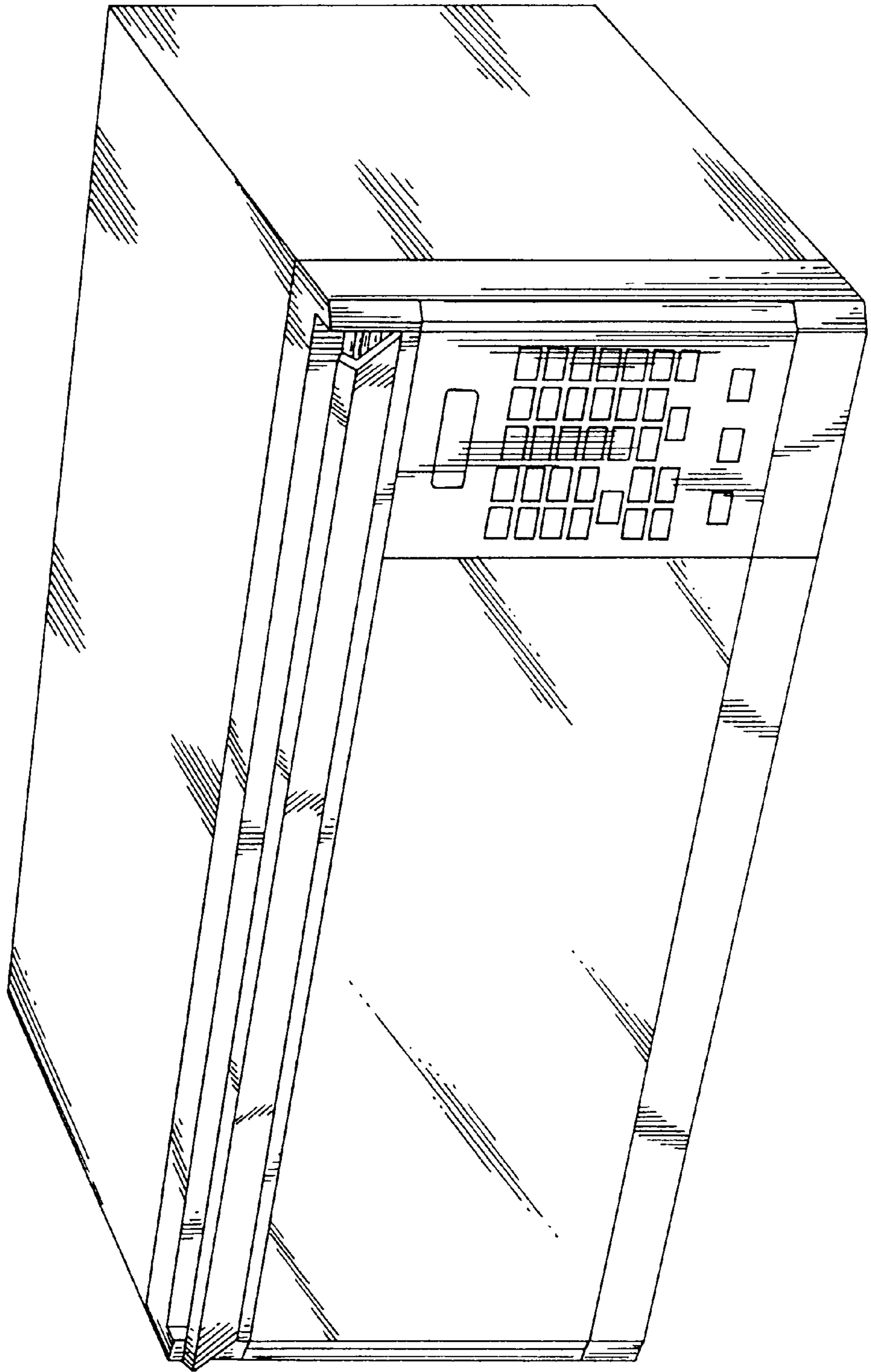
