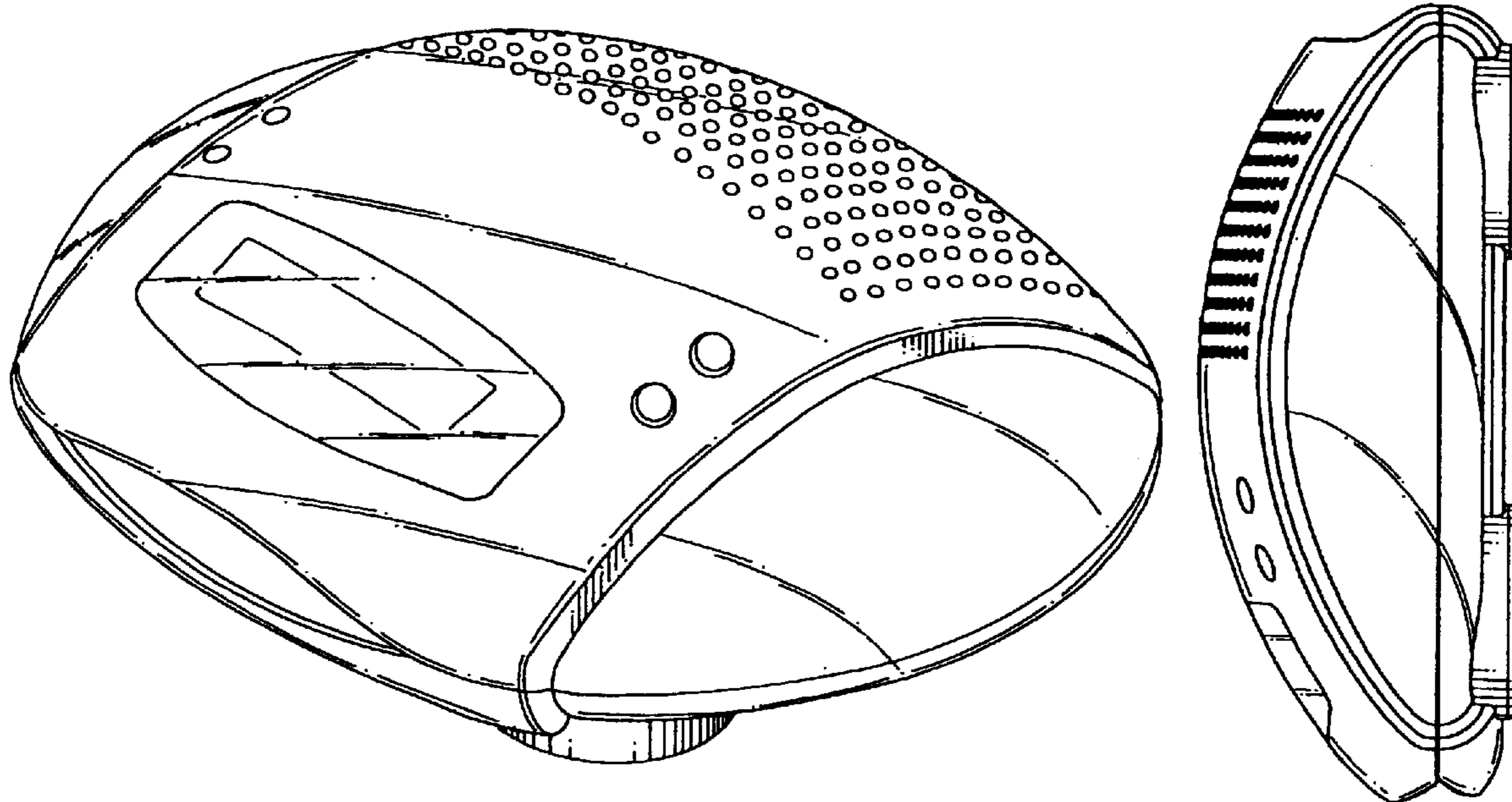
[57] CLAIM

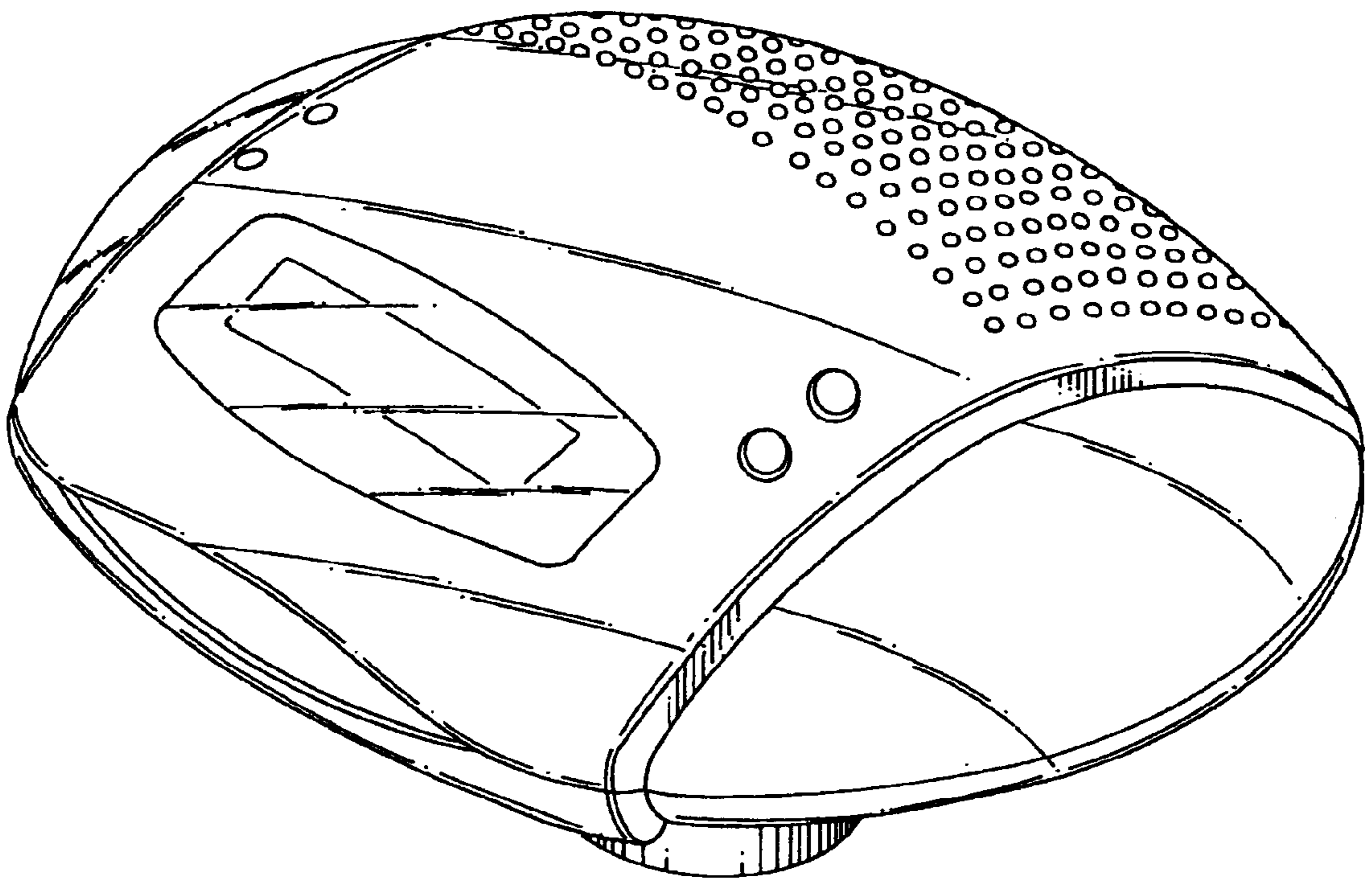

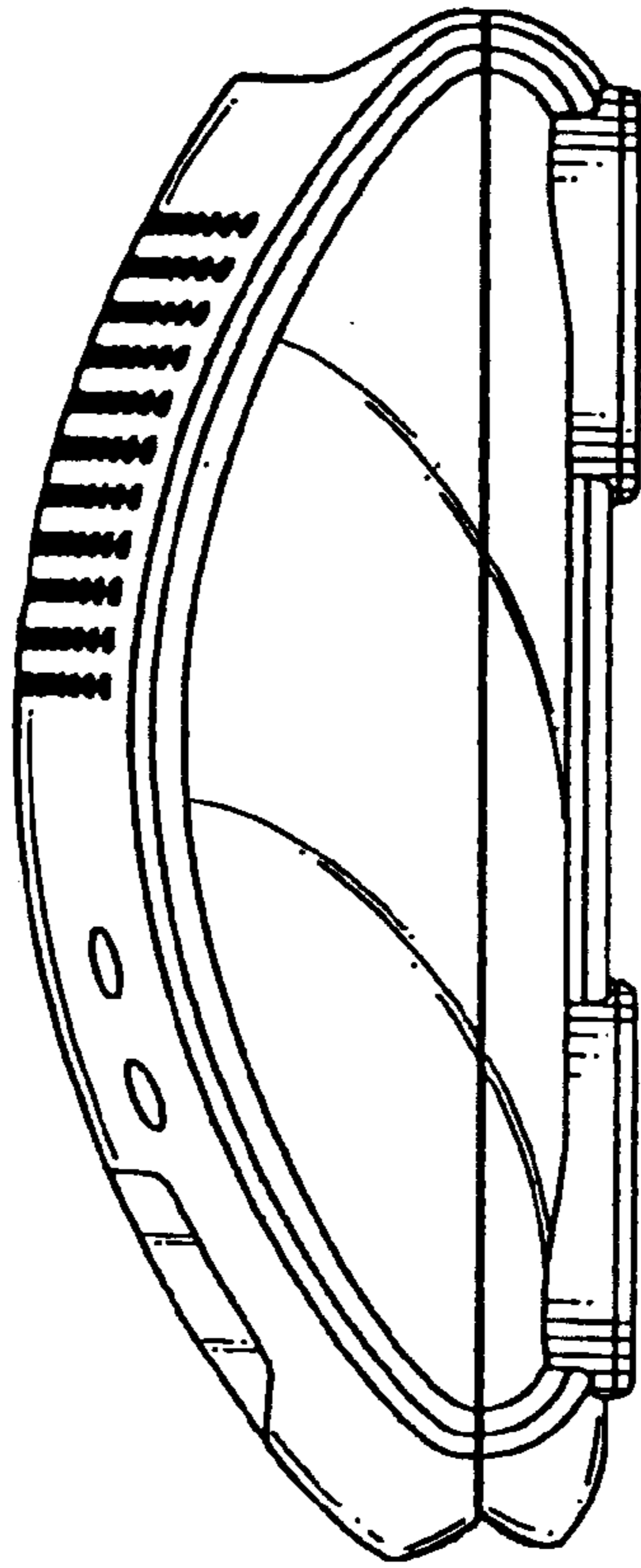

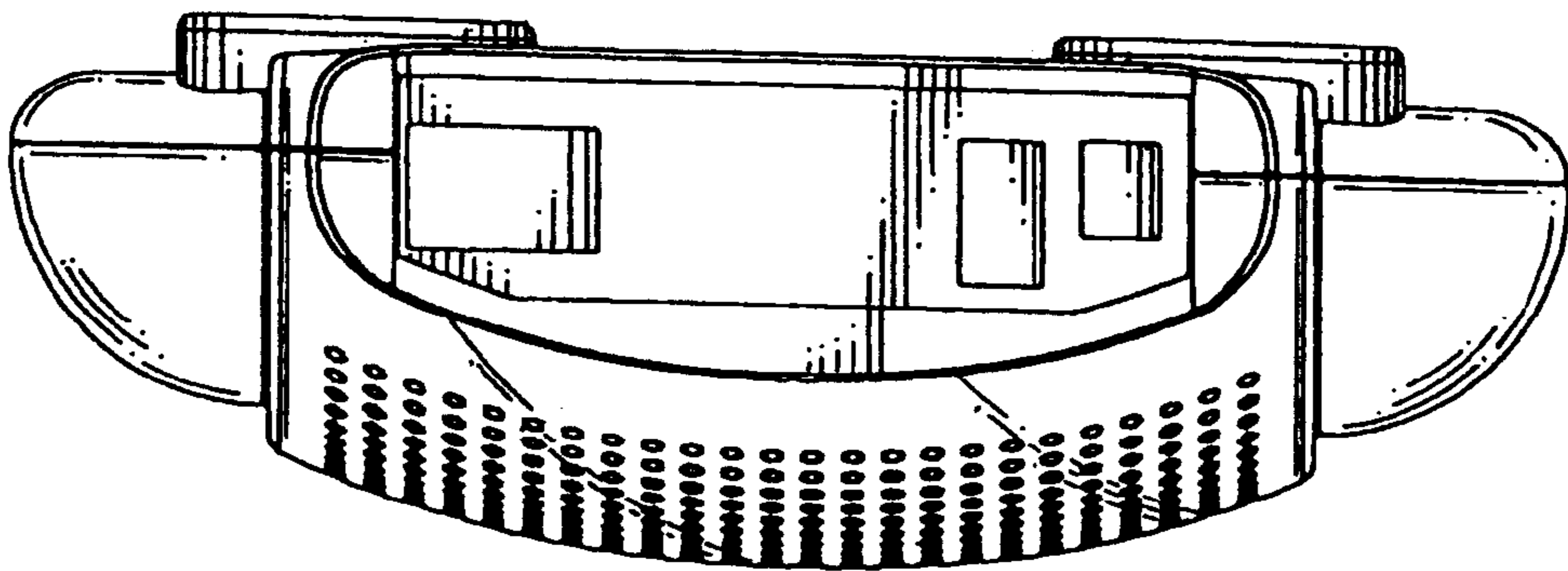

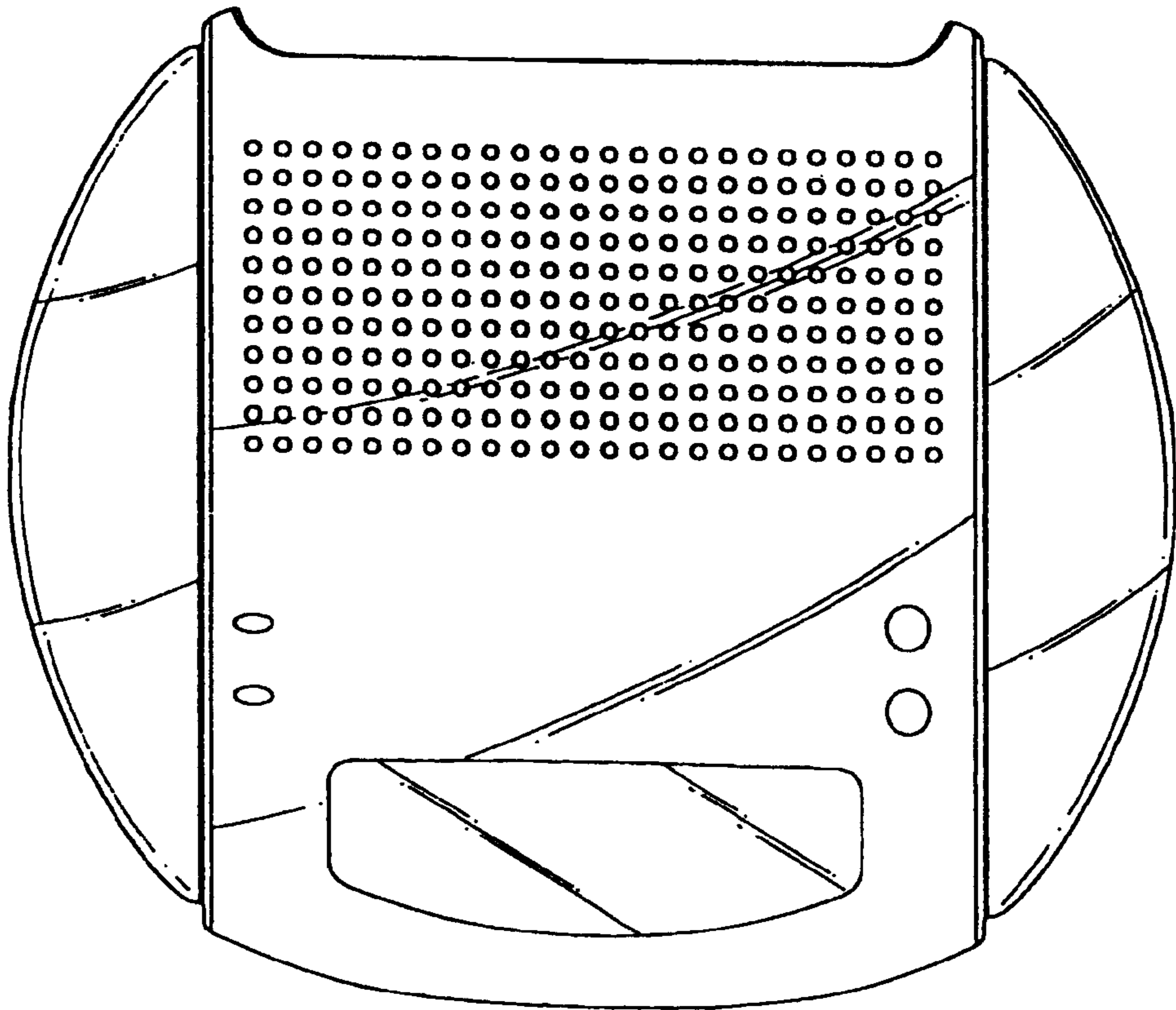

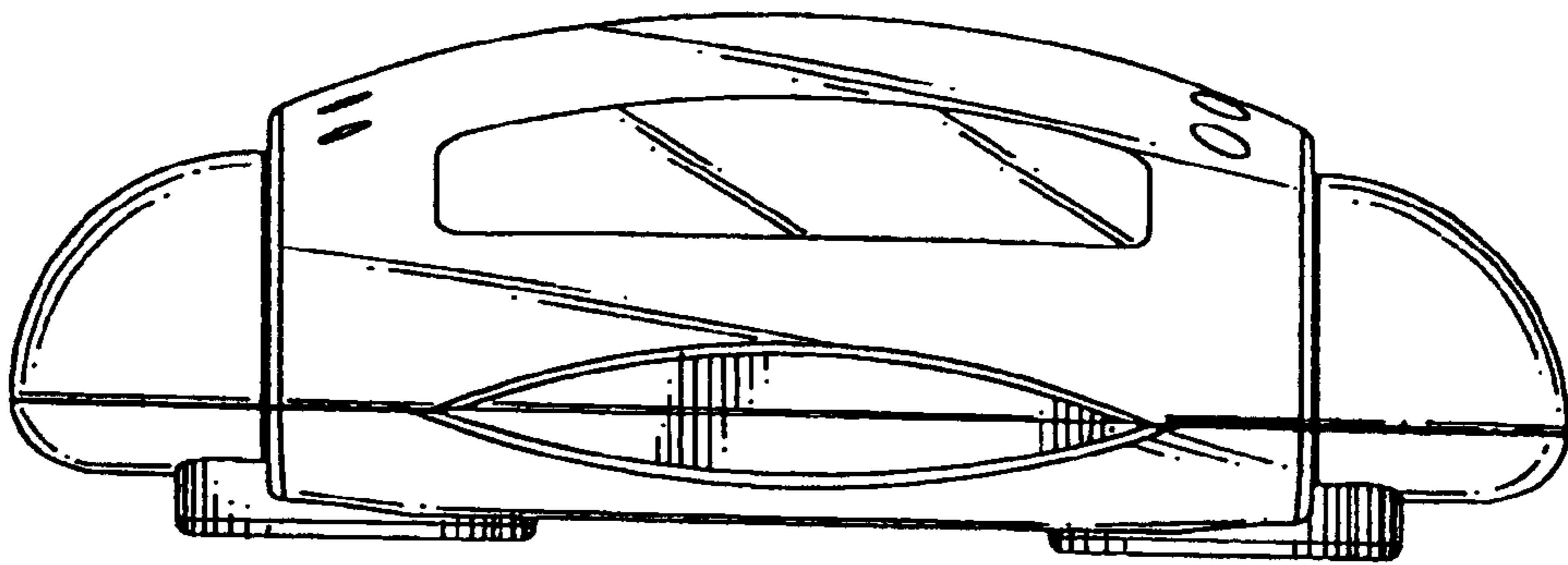

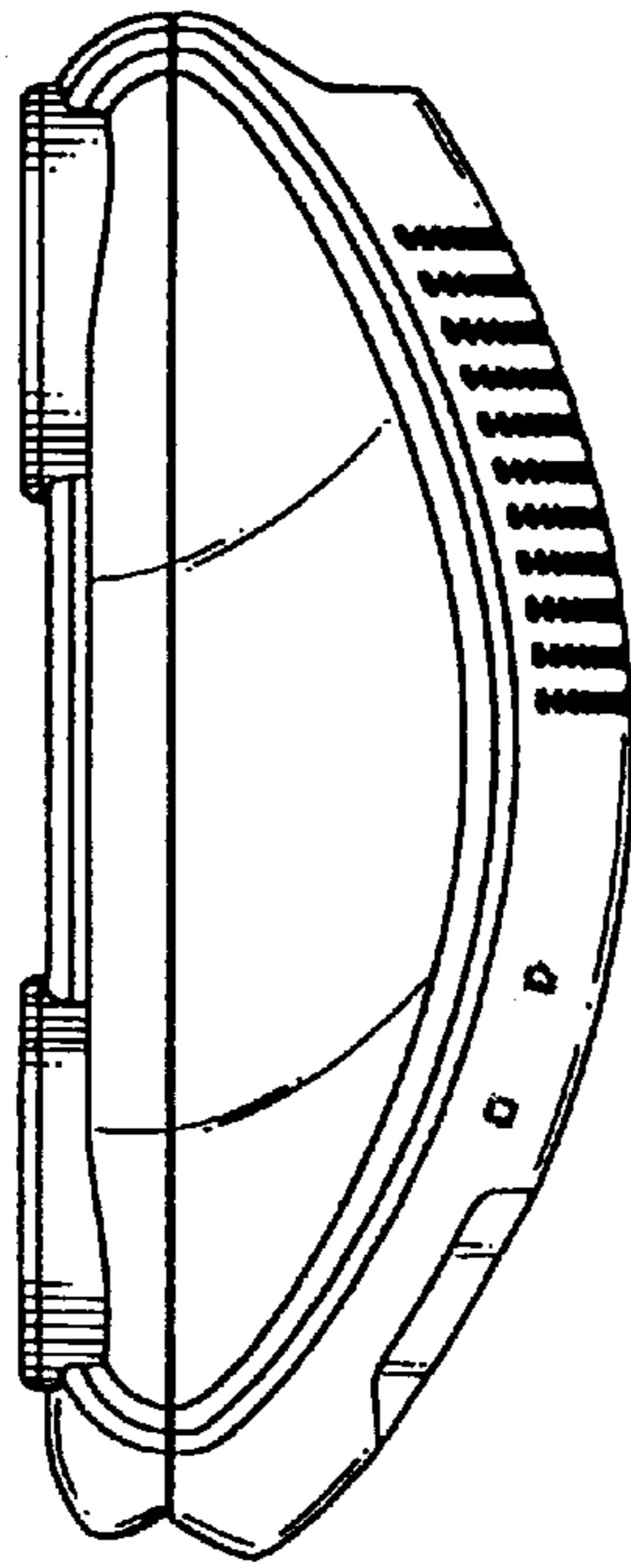

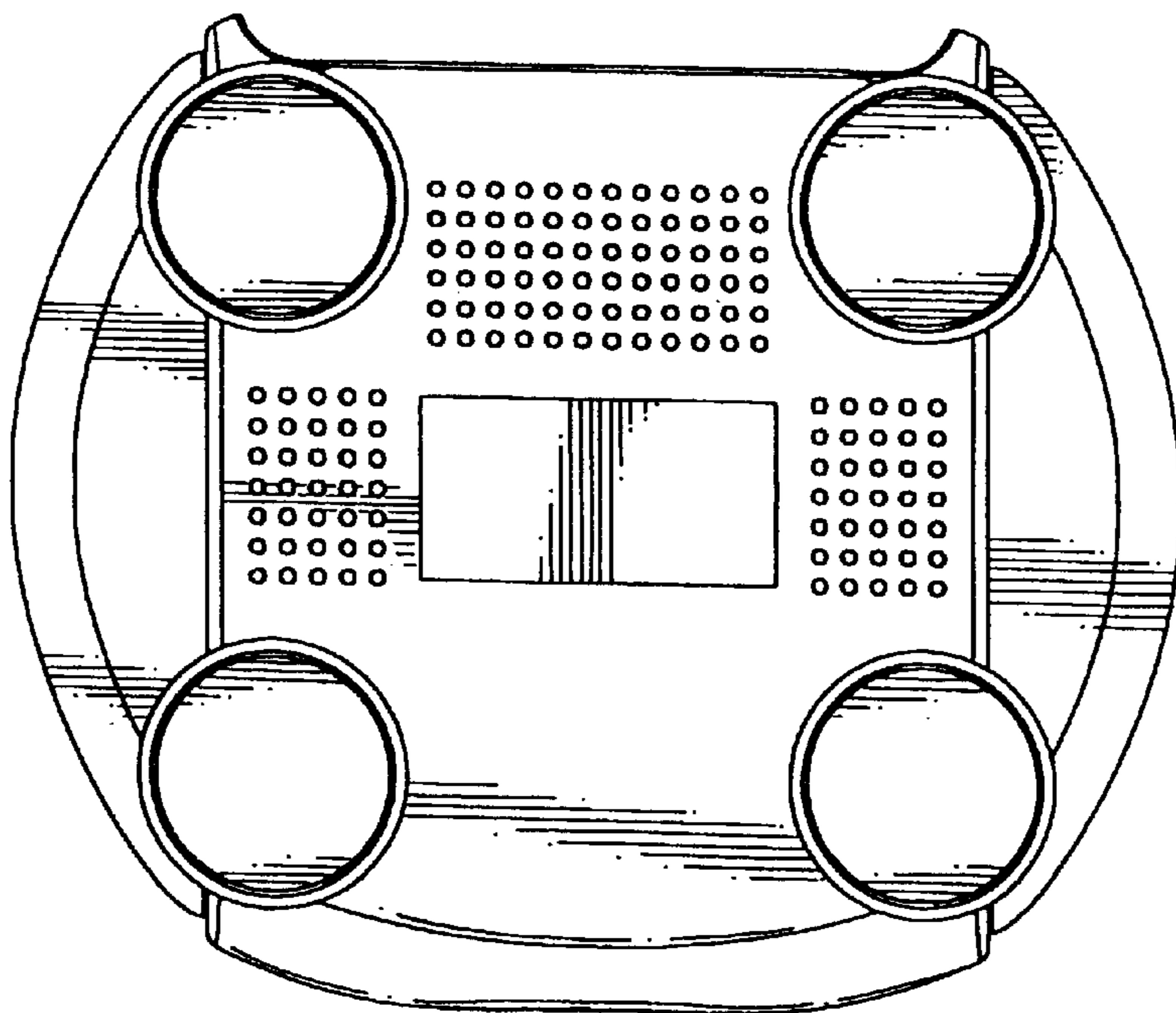
