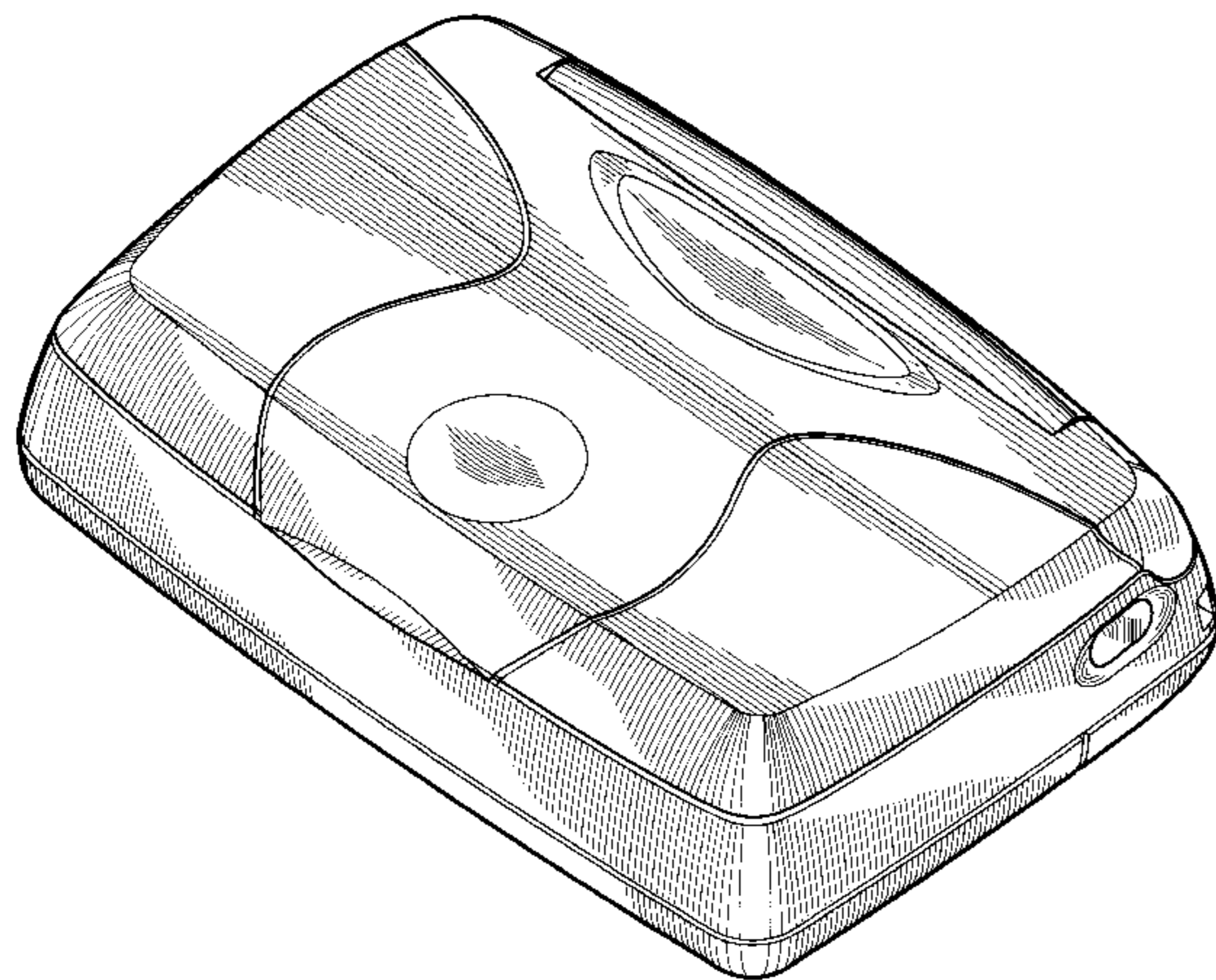
[57] **CLAIM**

The ornamental design for a messaging device with opening cover, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view showing the top, front and right side of a messaging device with opening cover; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof; FIG. 7 is a rear elevation view thereof; and, FIG. 8 is an isometric view of FIG. 1 showing the lid open.

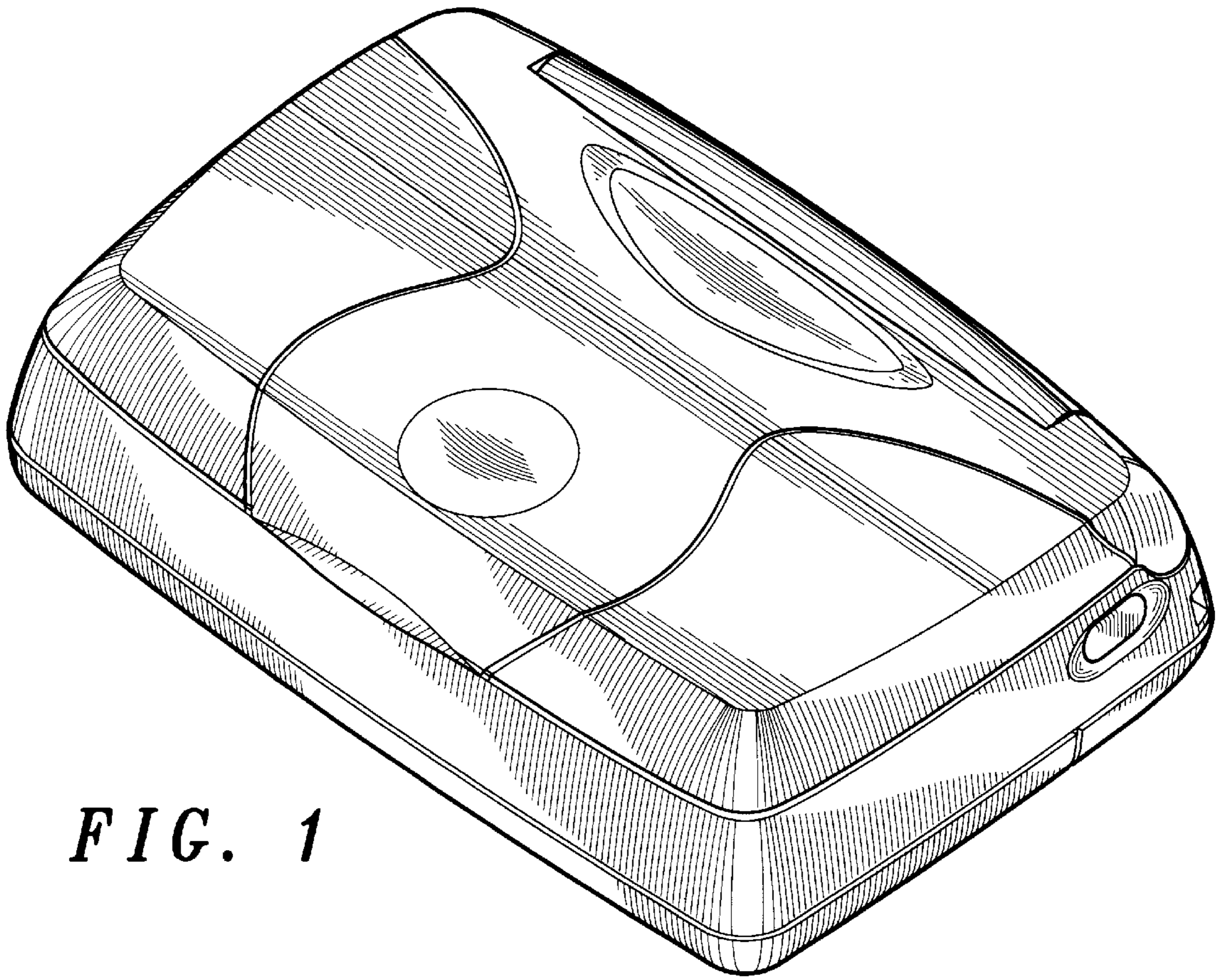

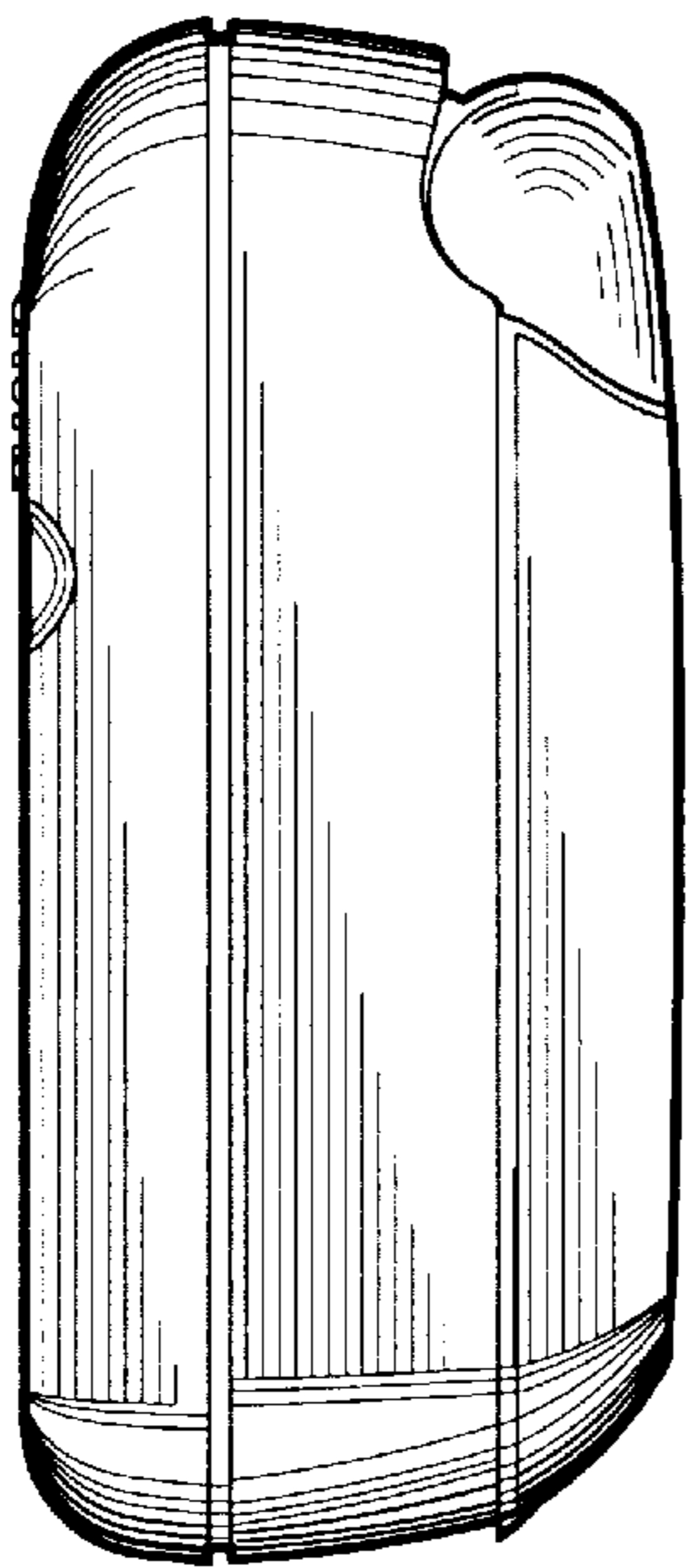

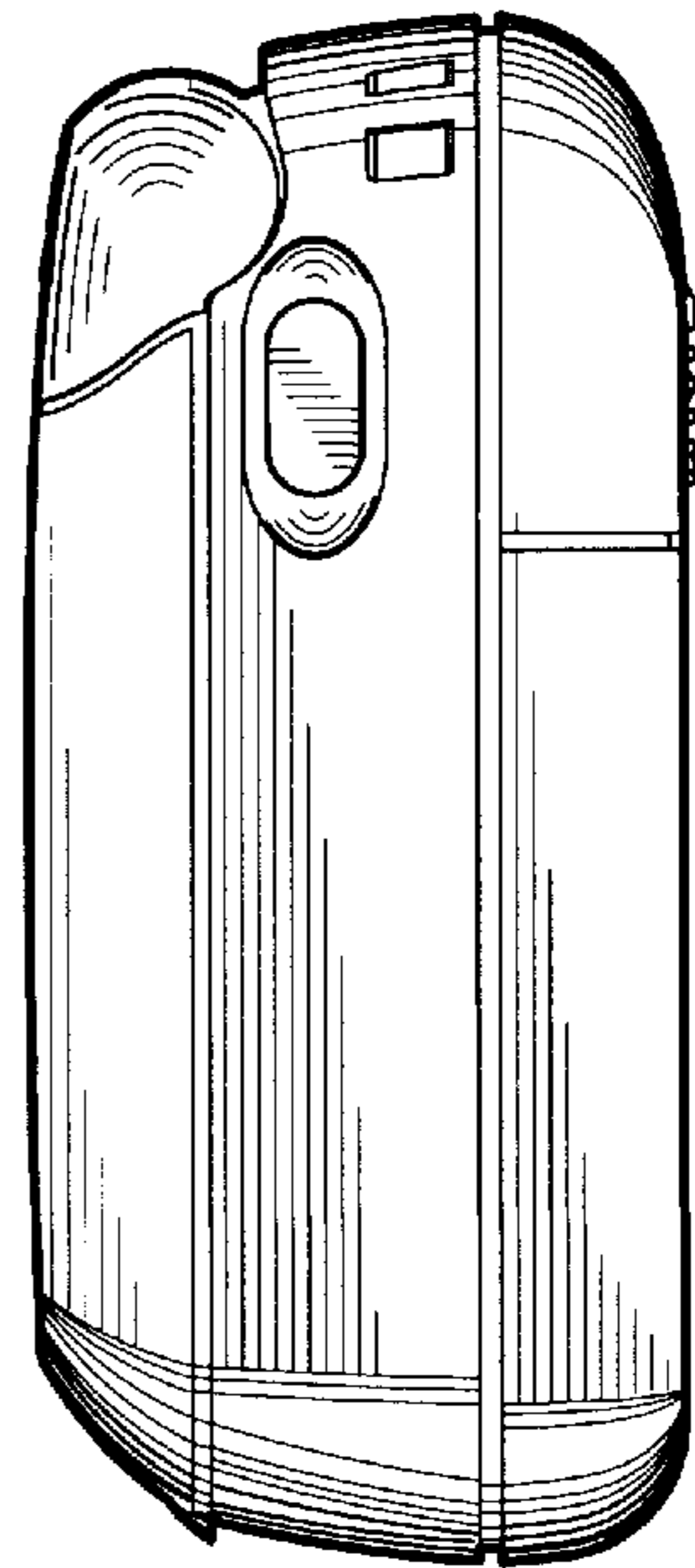

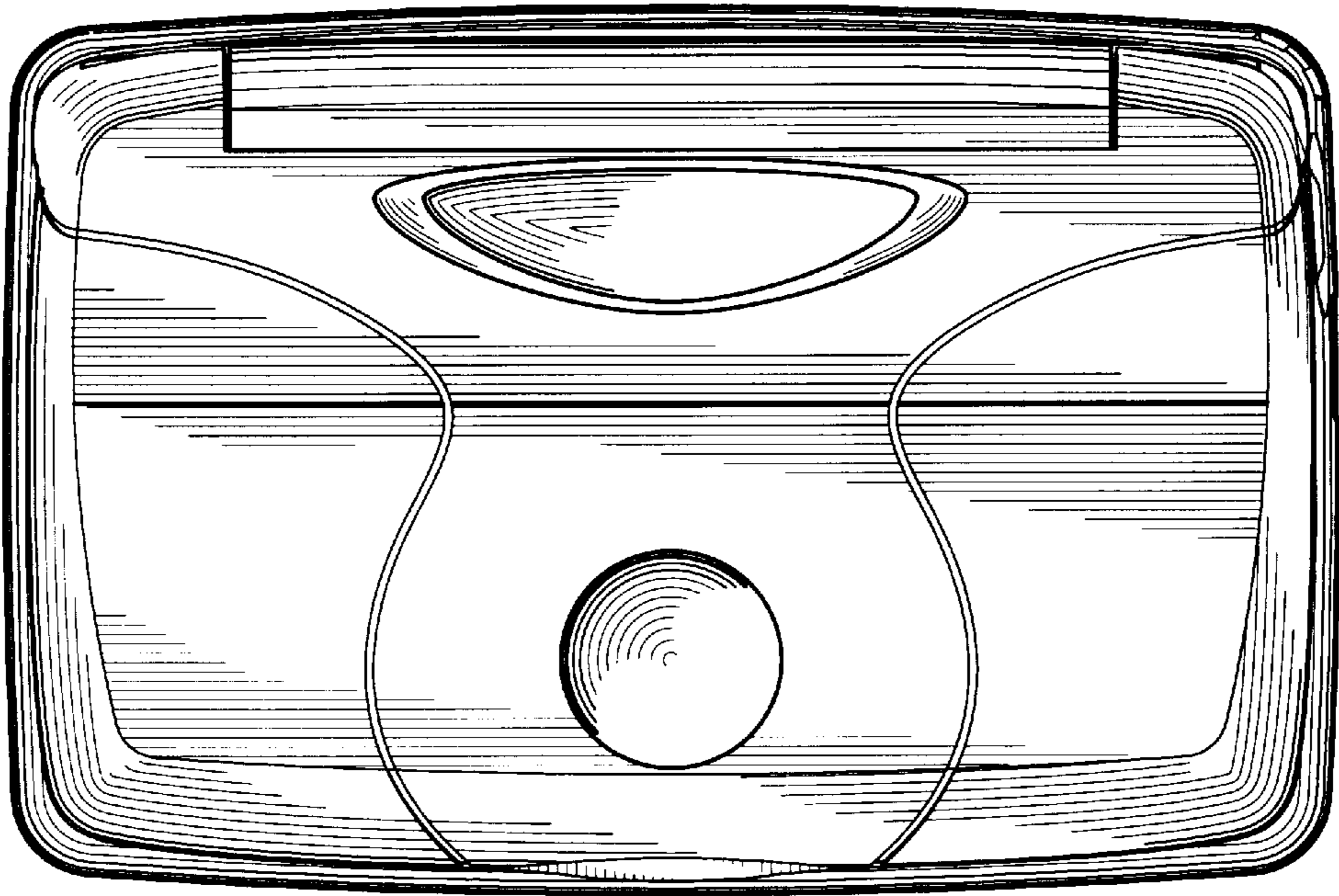

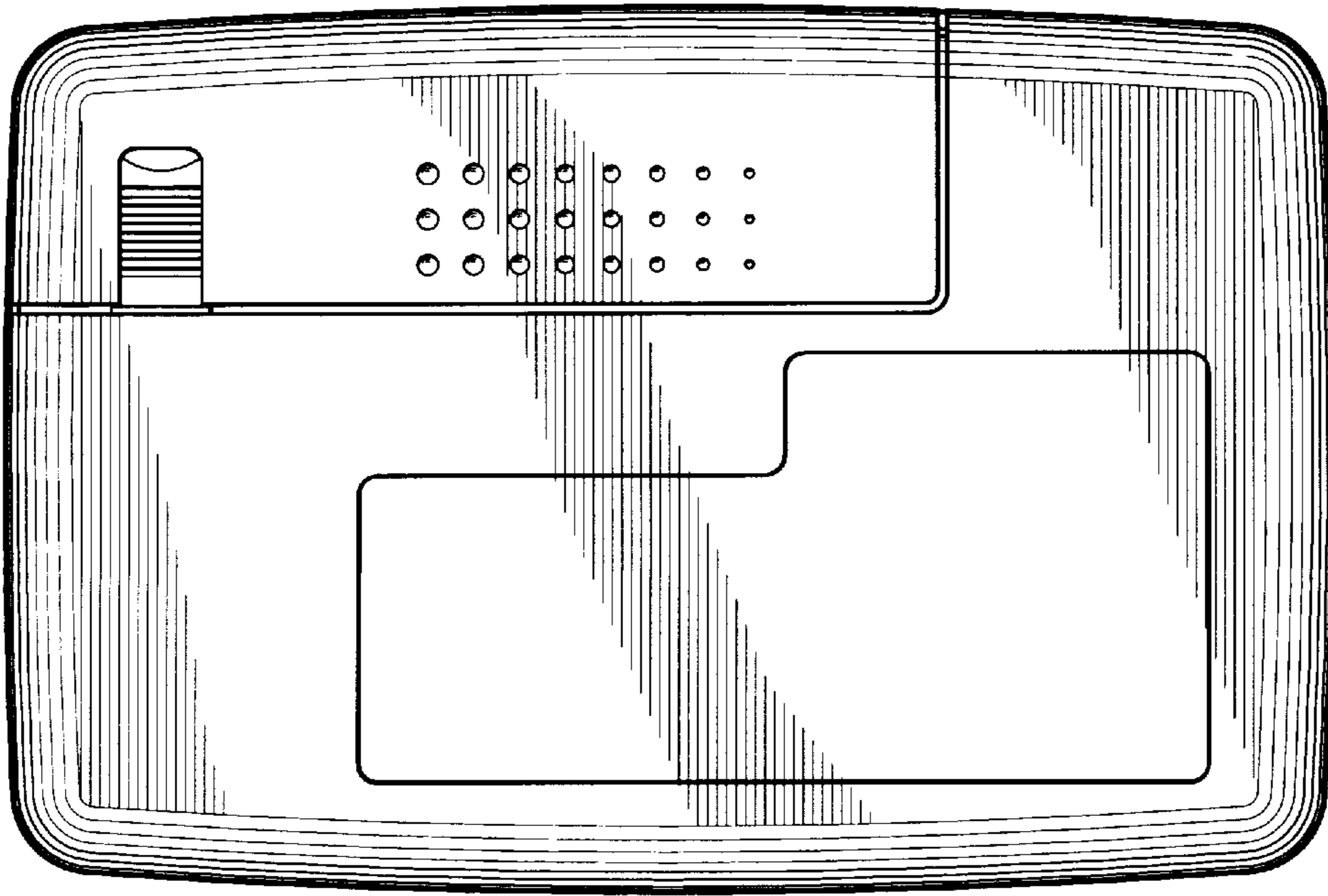

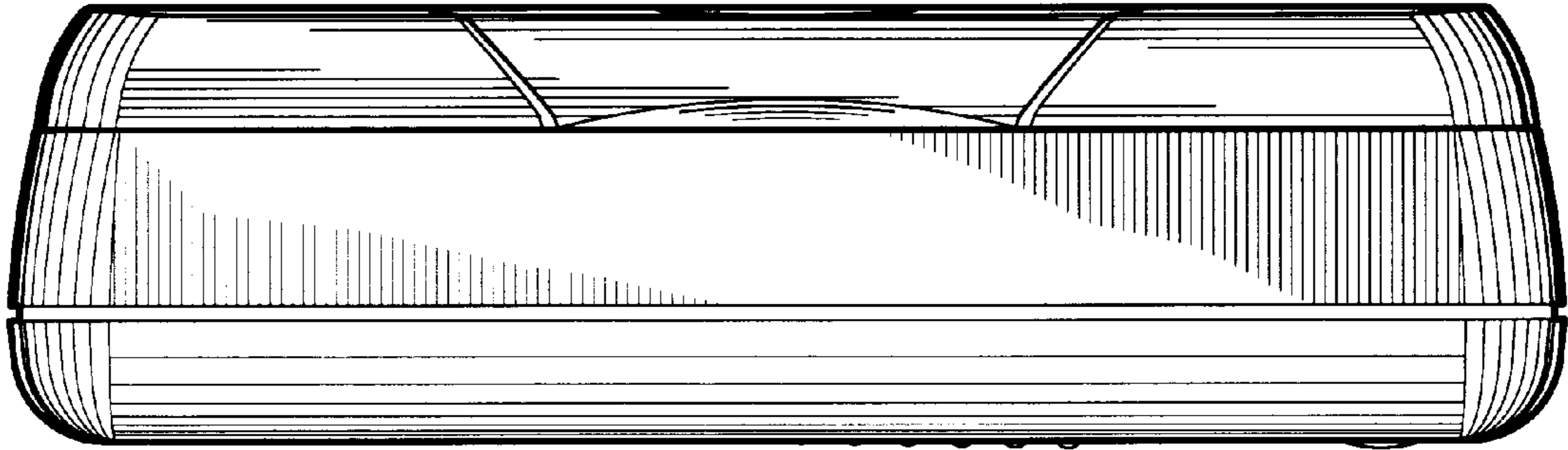

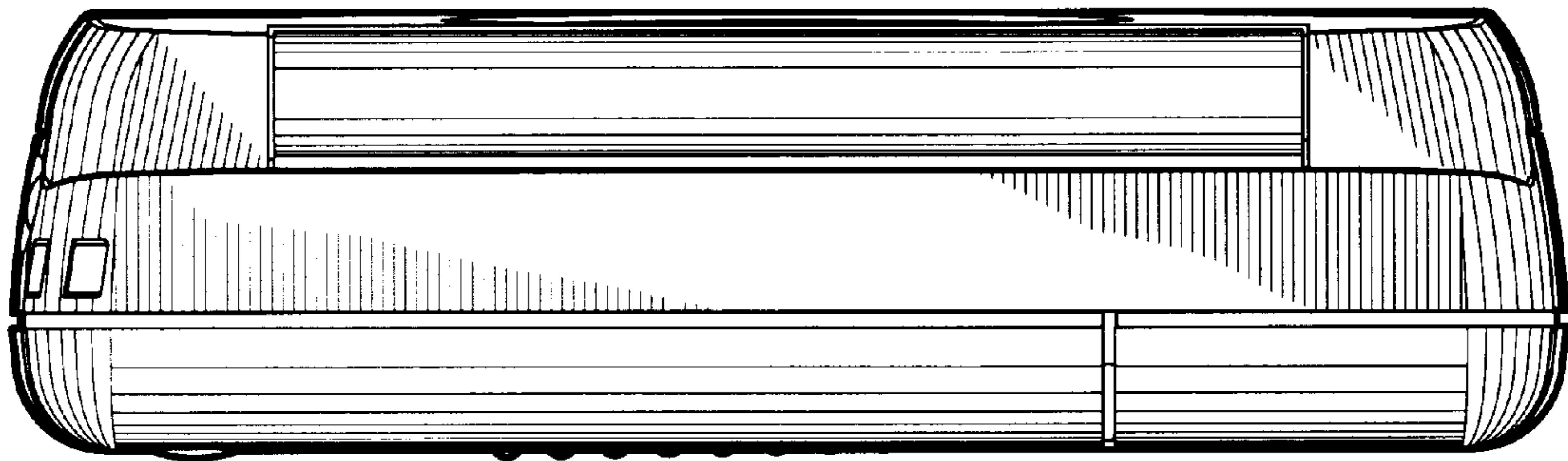

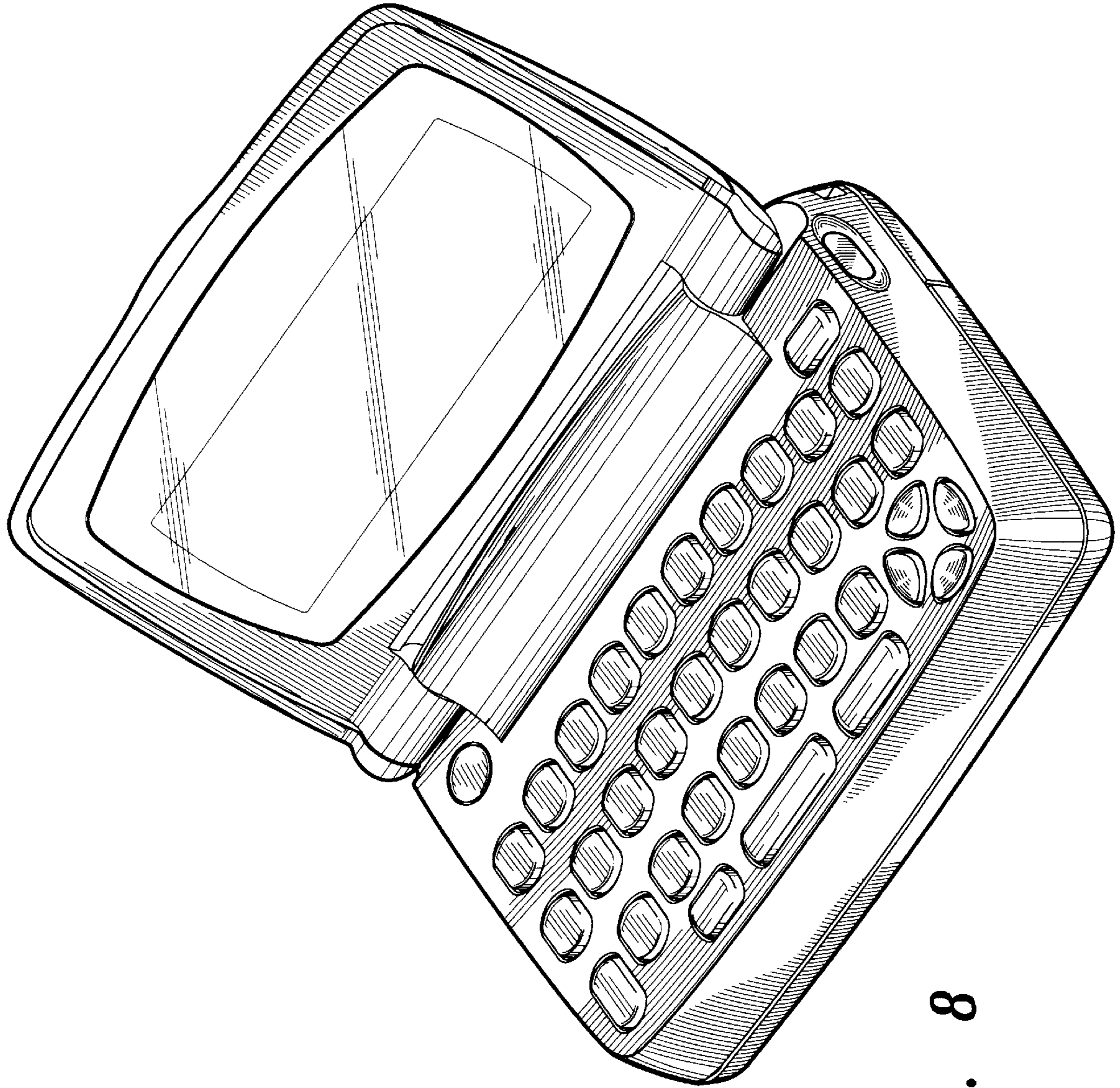
