[57] **CLAIM**

The ornamental design for an exercise mat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an exercise mat of the invention in an open configuration.

FIG. 2 is a top plan view of the exercise mat of FIG. 1.

FIG. 3 is a left side view of the exercise mat of FIG. 1.

FIG. 4 is a right side view of the exercise mat of FIG. 1.

FIG. 5 is a bottom plan view of the exercise mat of FIG. 1.

FIG. 6 is a first end view of the exercise mat of FIG. 1.

FIG. 7 is an opposing end view of the exercise mat of FIG. 1.

FIG. 8 is an exploded perspective view showing the moveable pillows elevated from the surface of the exercise mat. FIG. 9 is a bottom plan view of a first pillow of the exercise mat of FIG. 1.

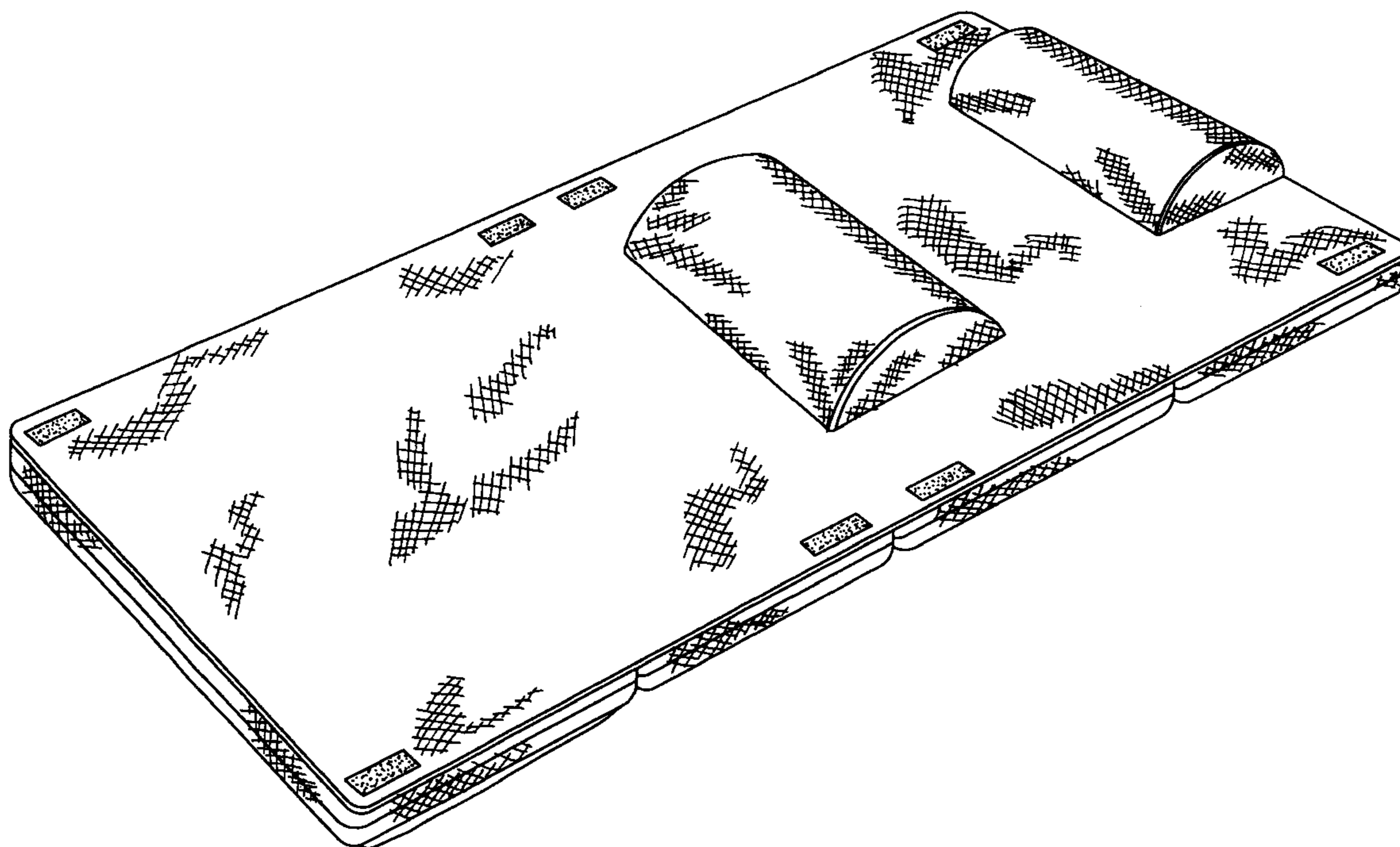
FIG. 10 is a bottom plan view of a second pillow of the exercise mat of FIG. 1.

FIG. 11 is a rear perspective view of the exercise mat of FIG. 1 in a closed configuration.

FIG. 12 is a front perspective view of the exercise mat of FIG. 1 in a closed configuration; and,

FIG. 13 is a rear perspective view of the exercise mat of FIG. 1 with the pillows installed in a retaining pocket.

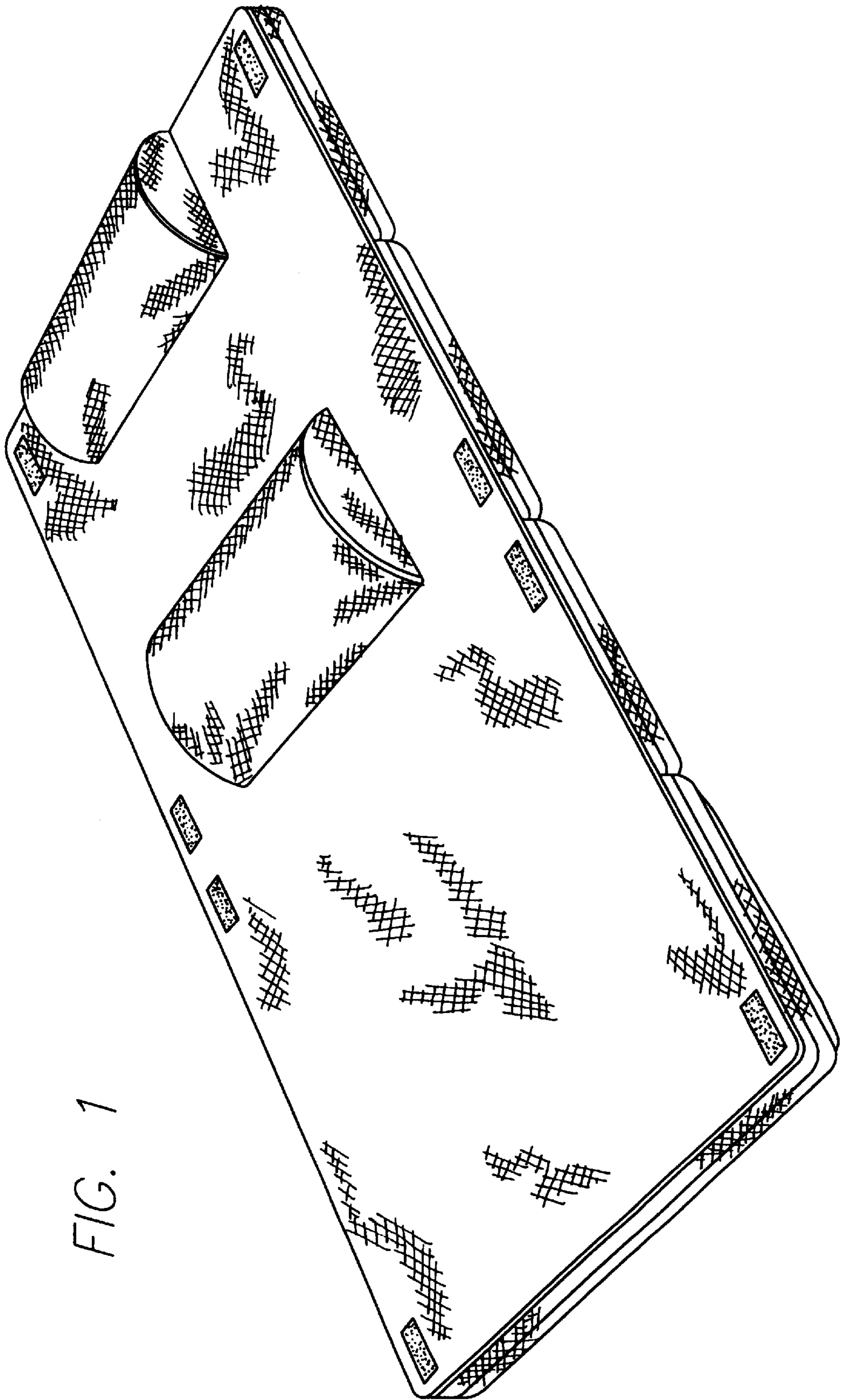

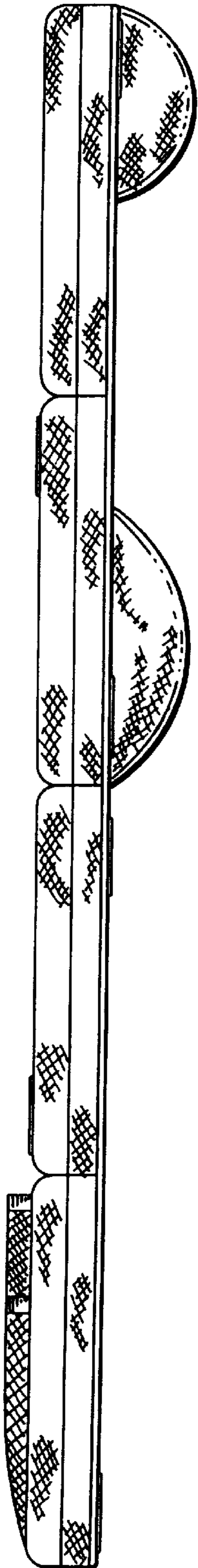

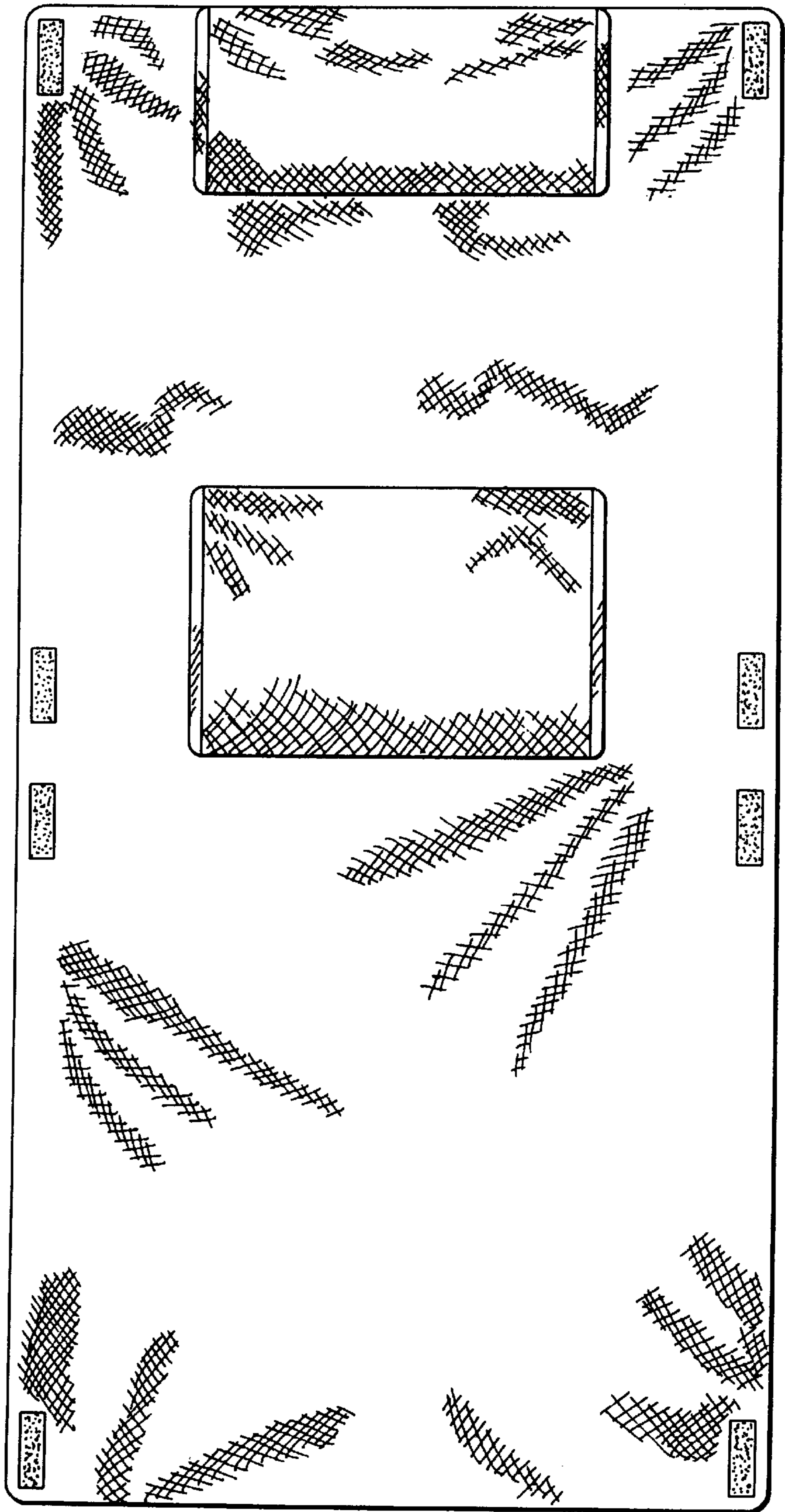

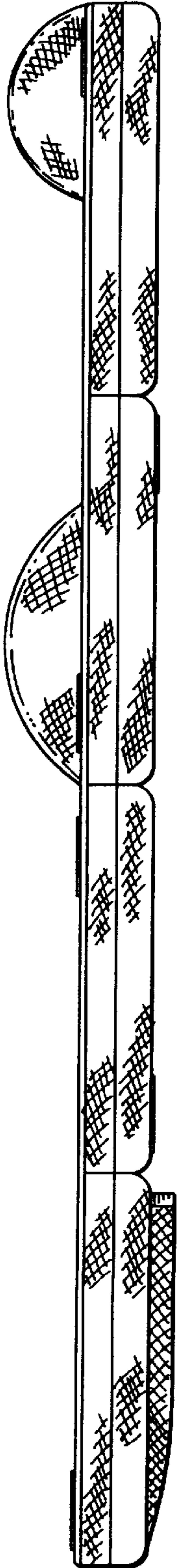
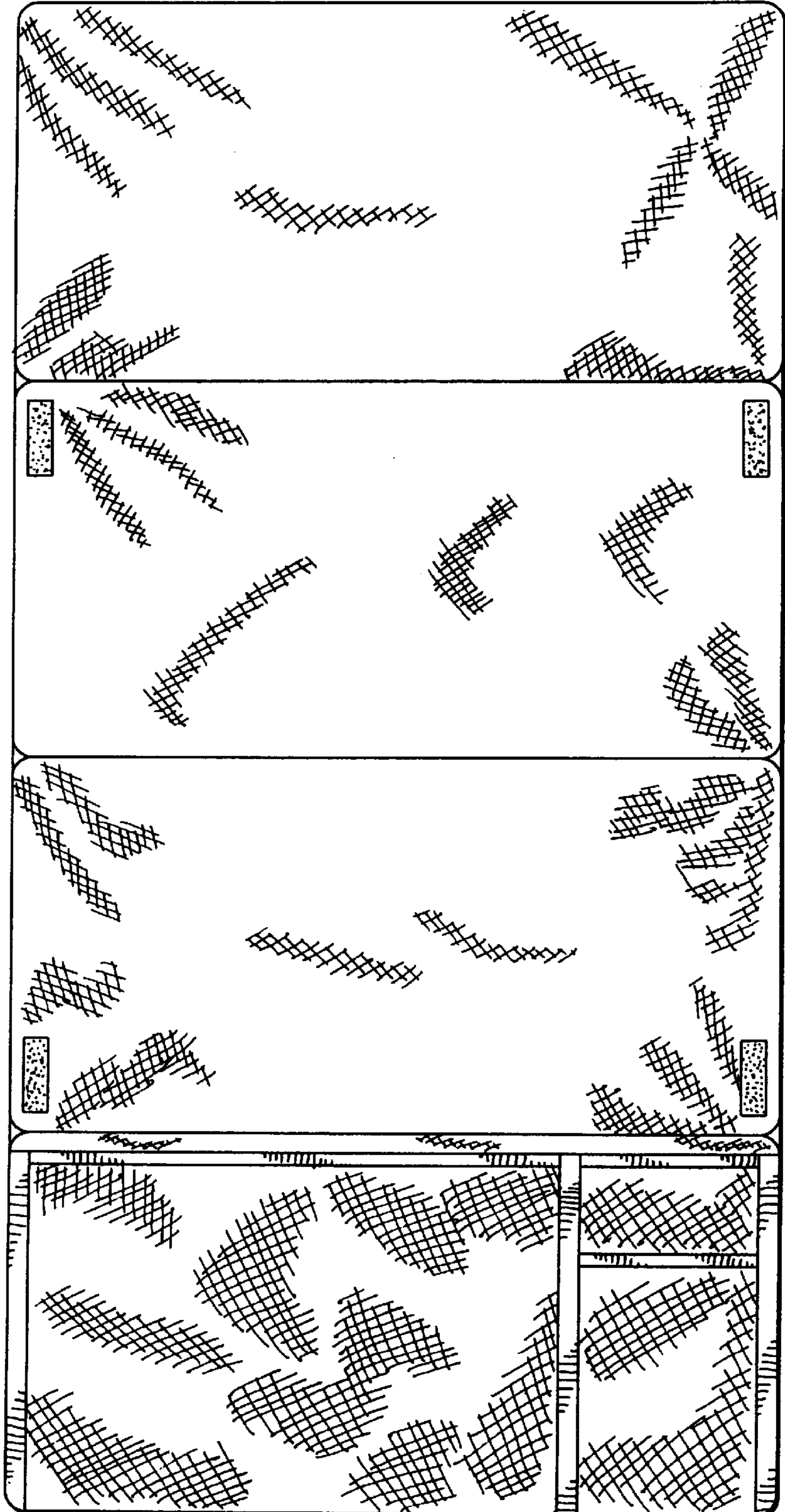

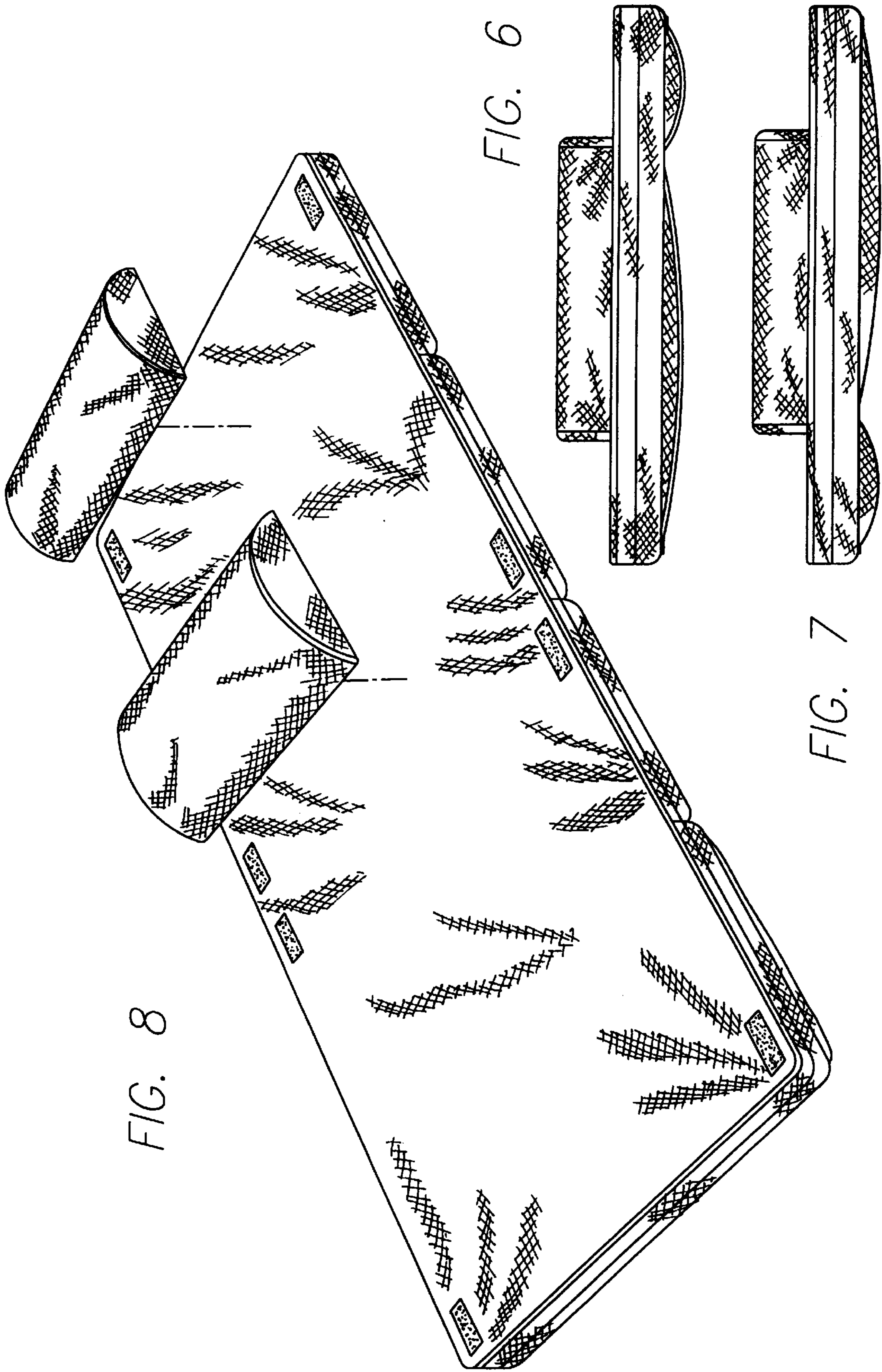

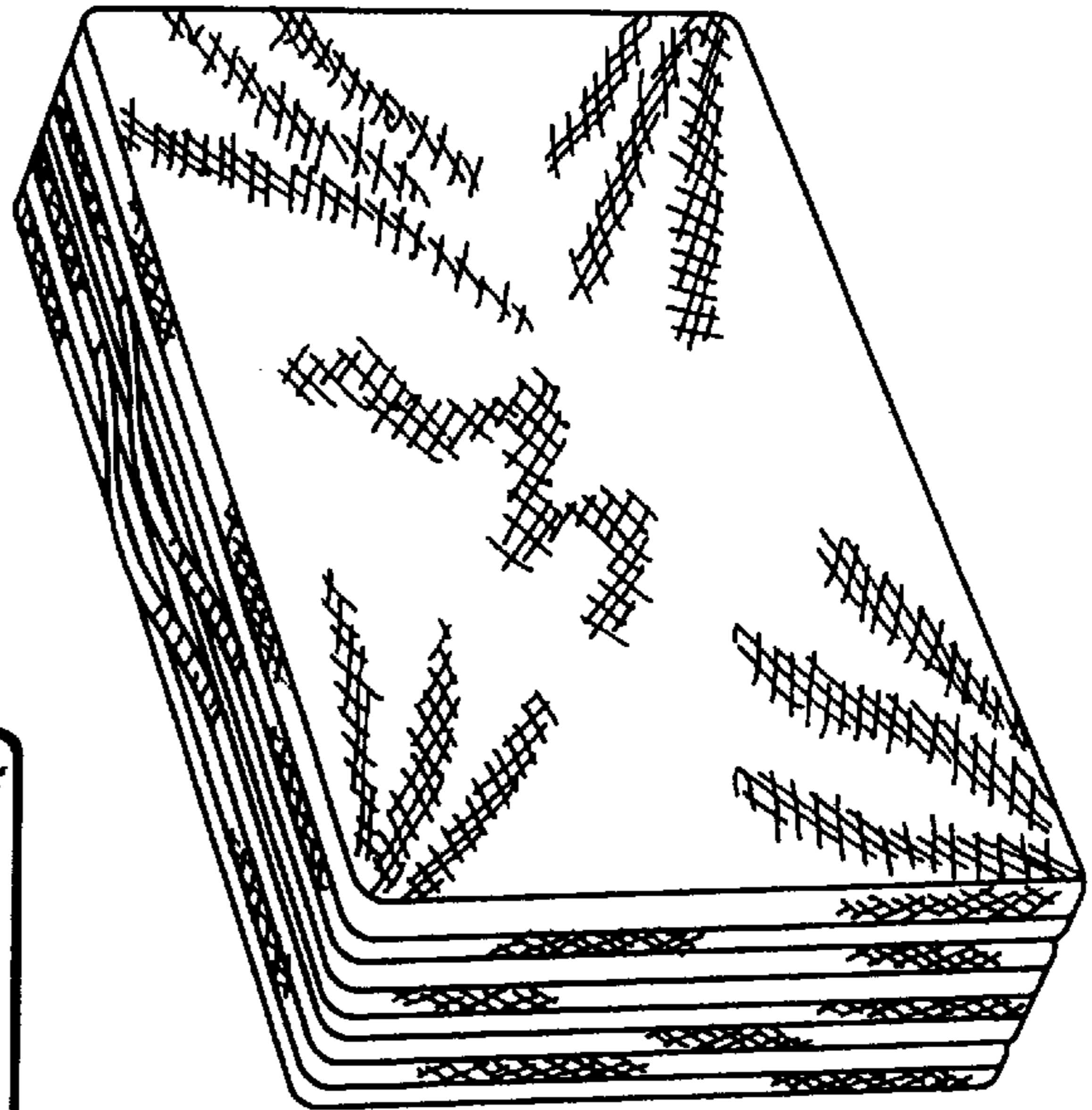
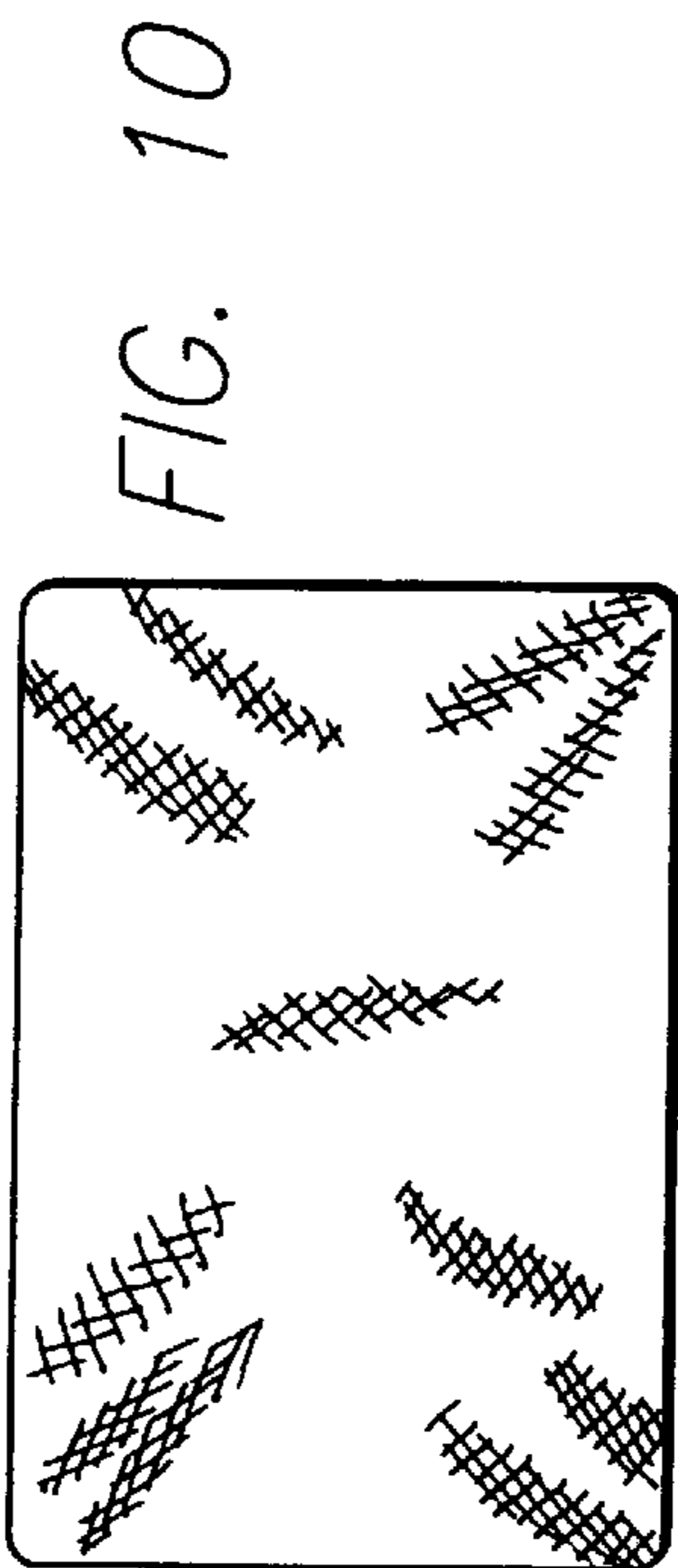
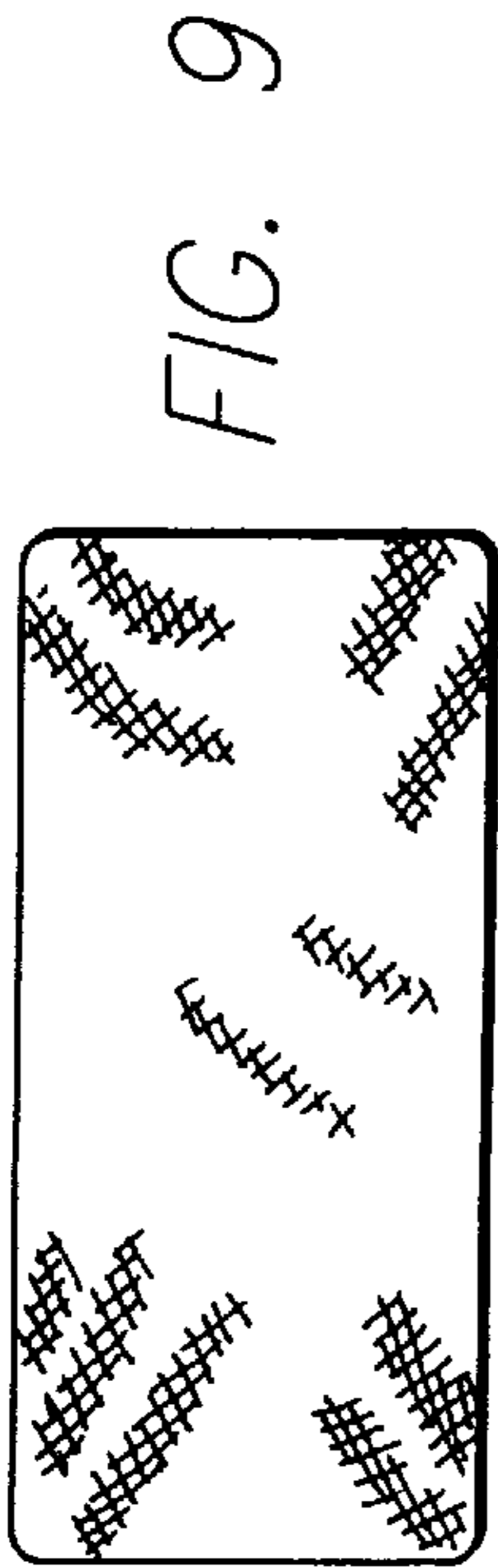
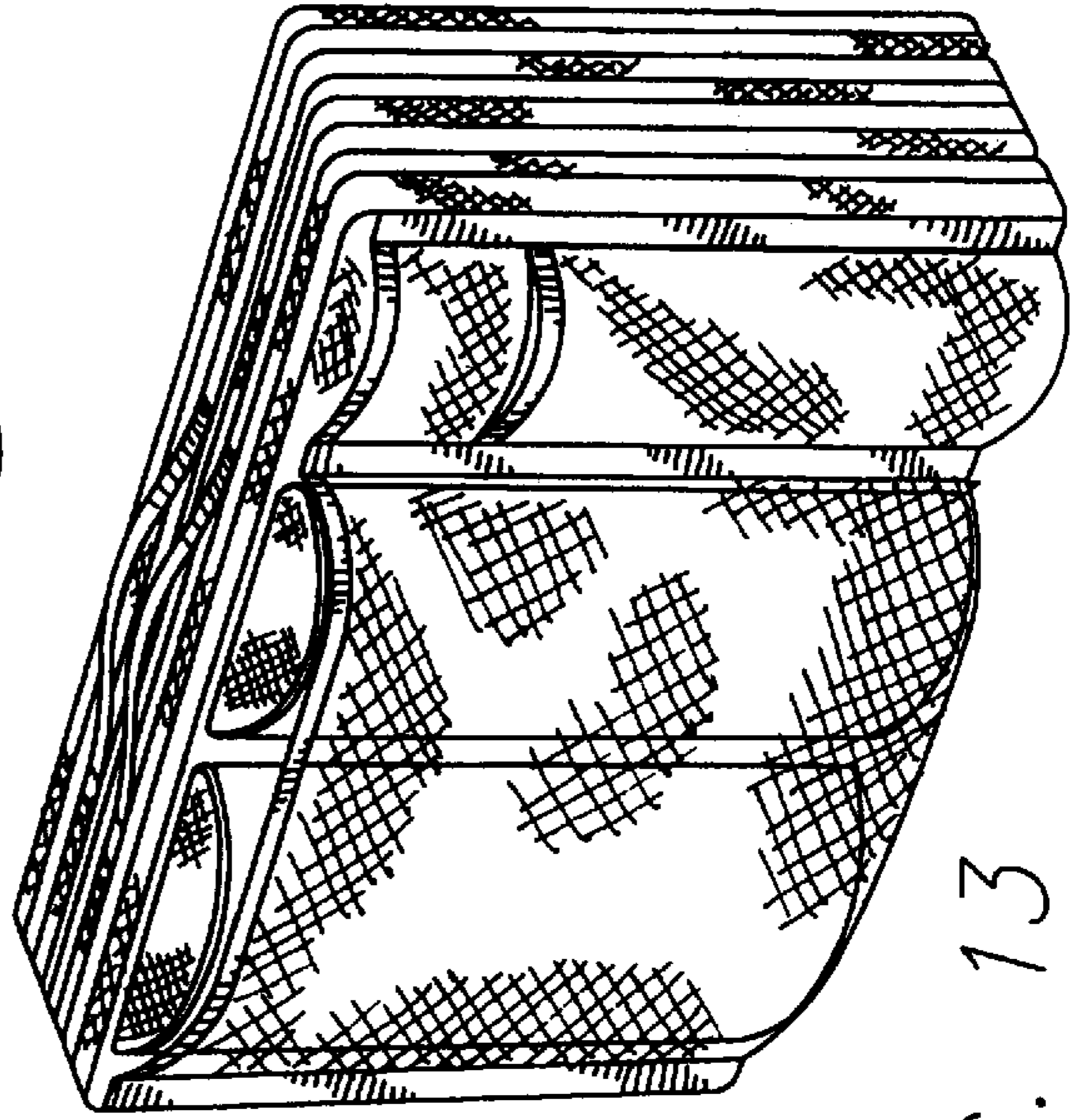
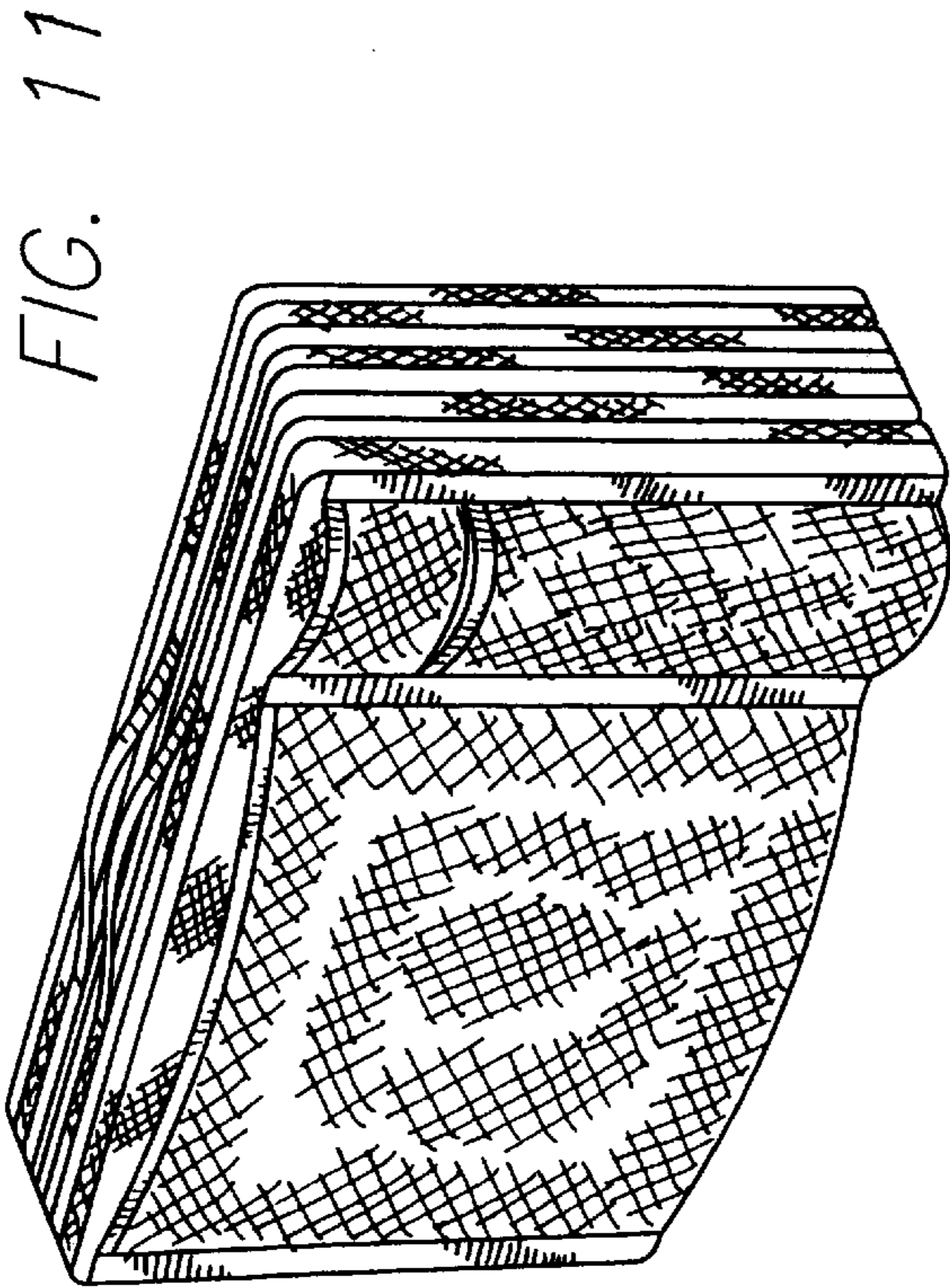
