FIG. 5 is a back edge view of the bandage thereof;

FIG. 6 is a left edge view of the bandage thereof;

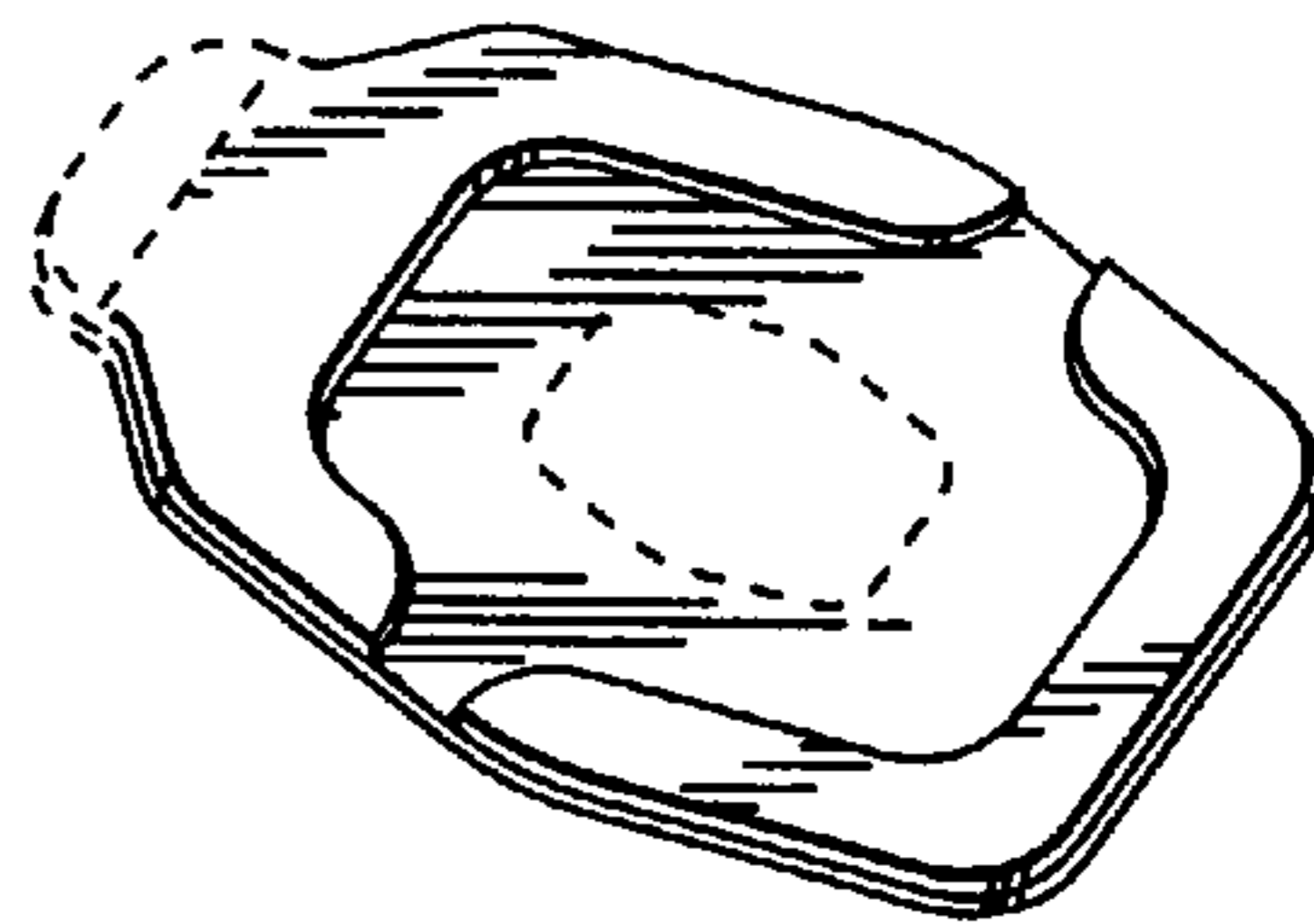
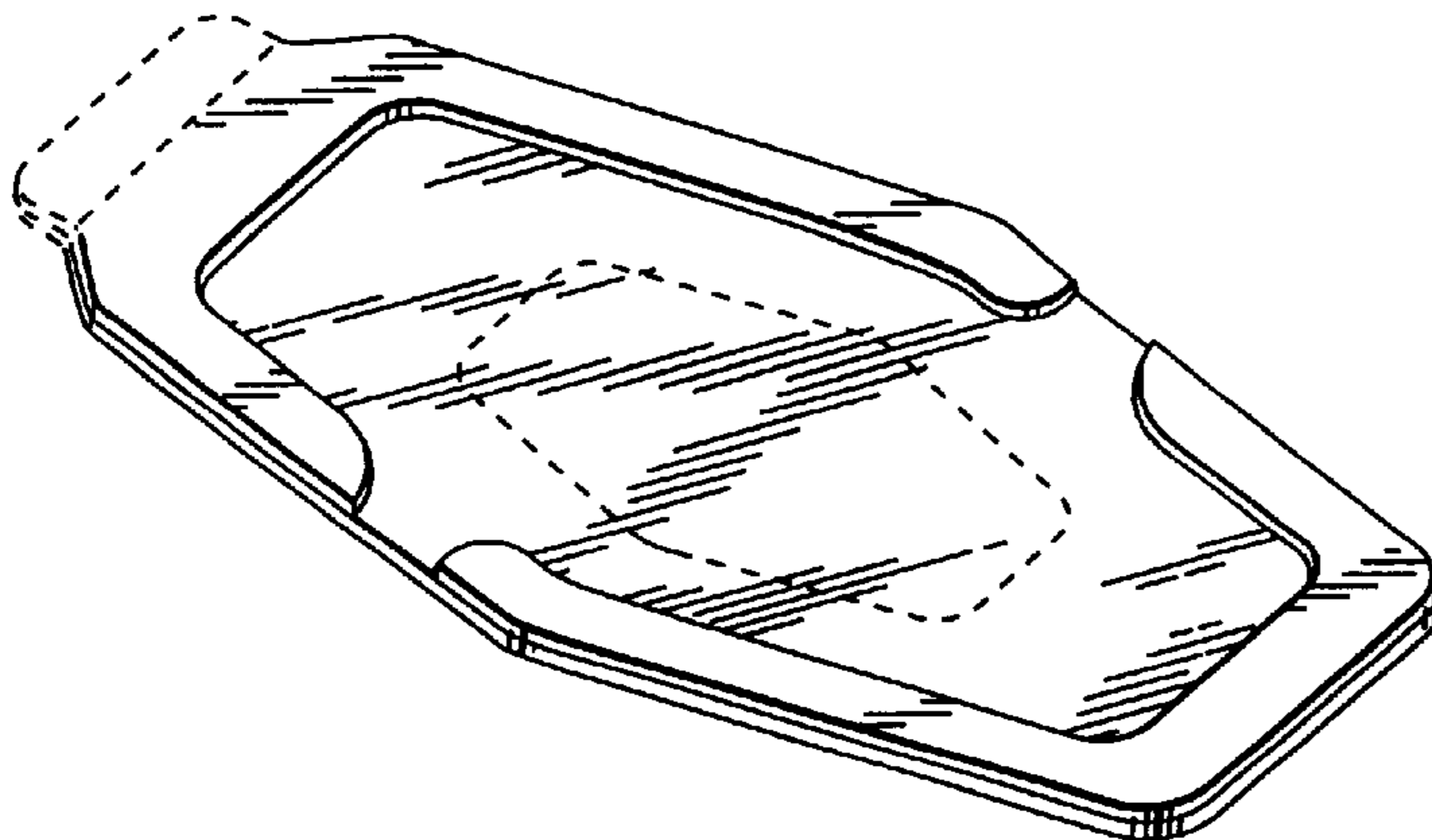
FIG. 7 is a right edge view of the bandage thereof; and,

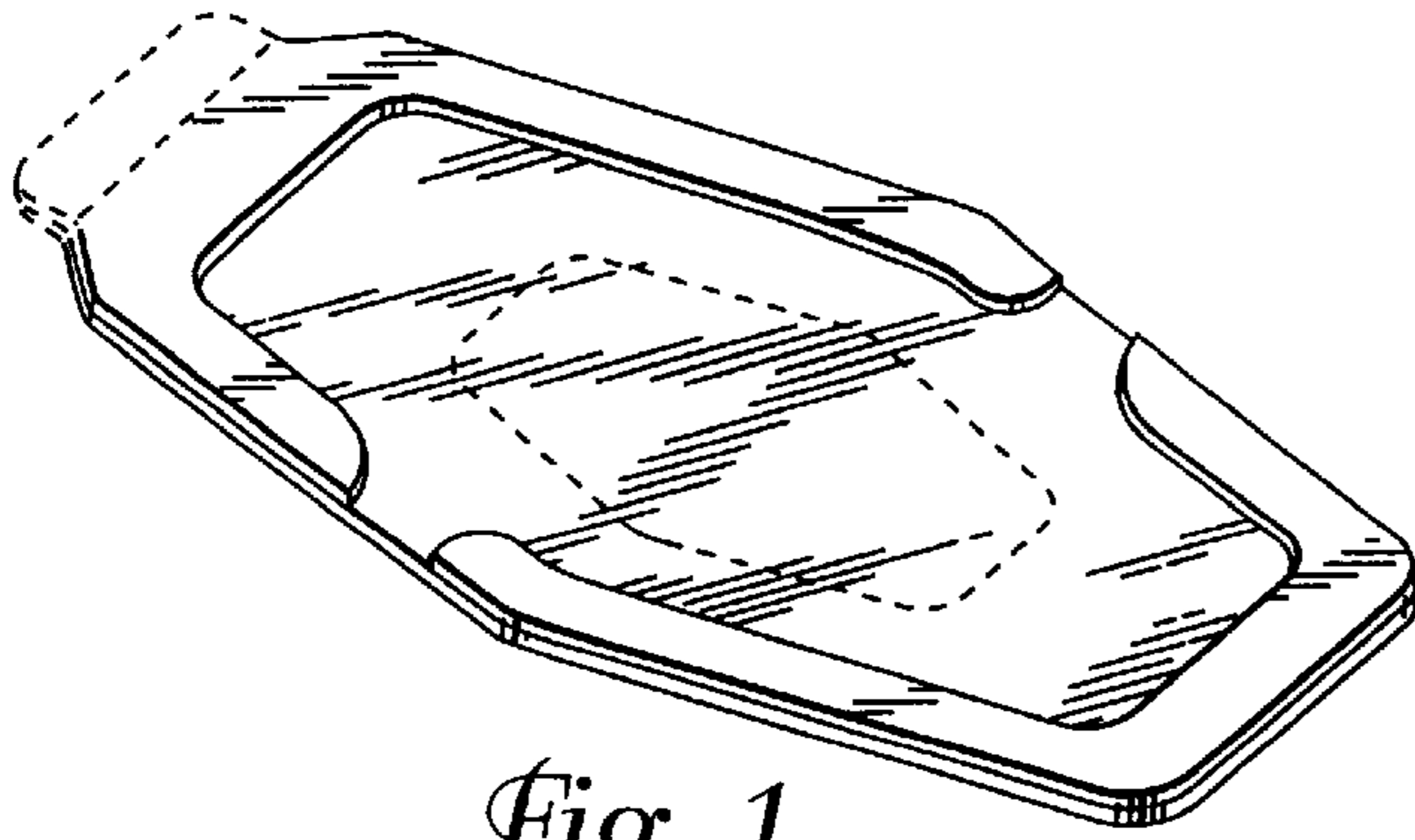

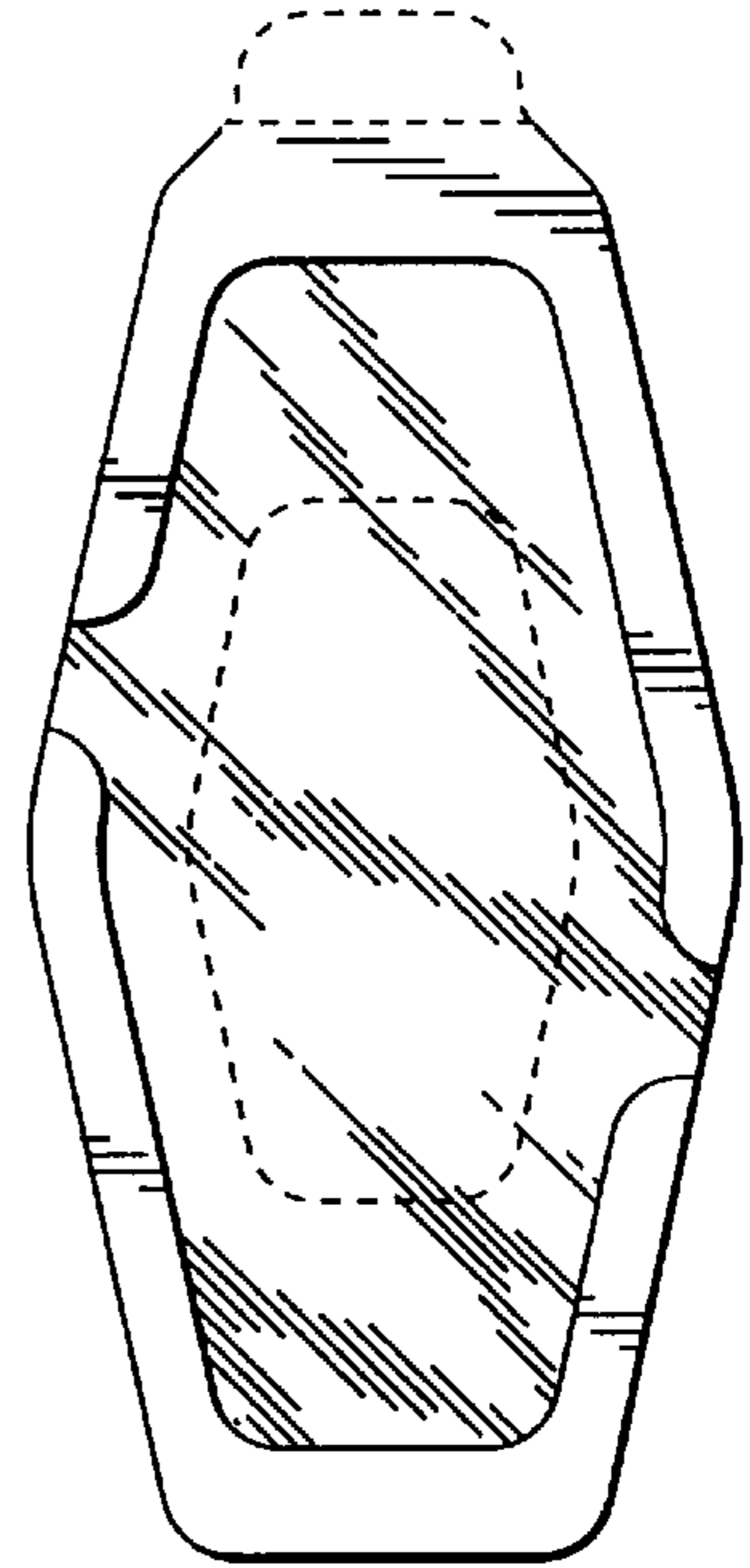

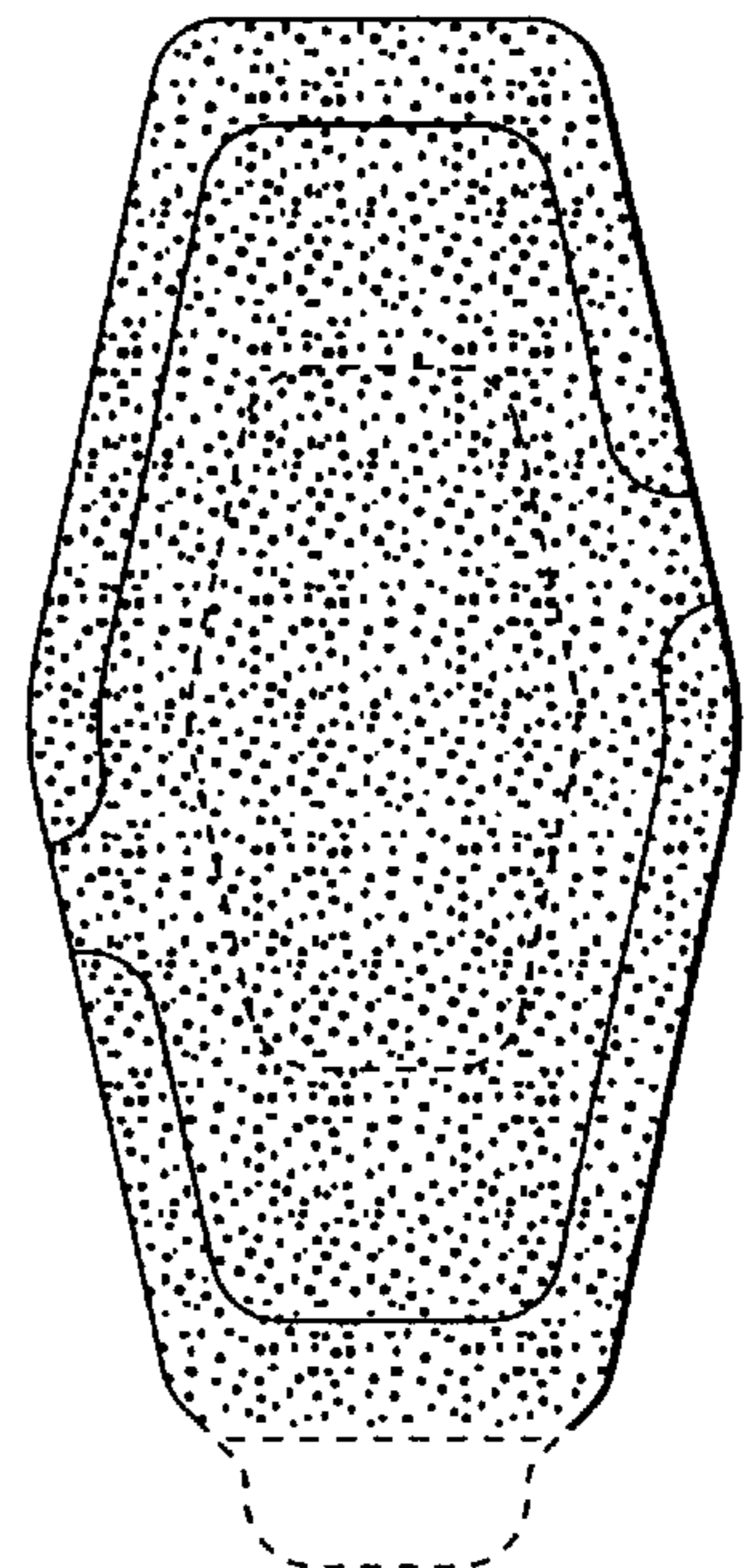

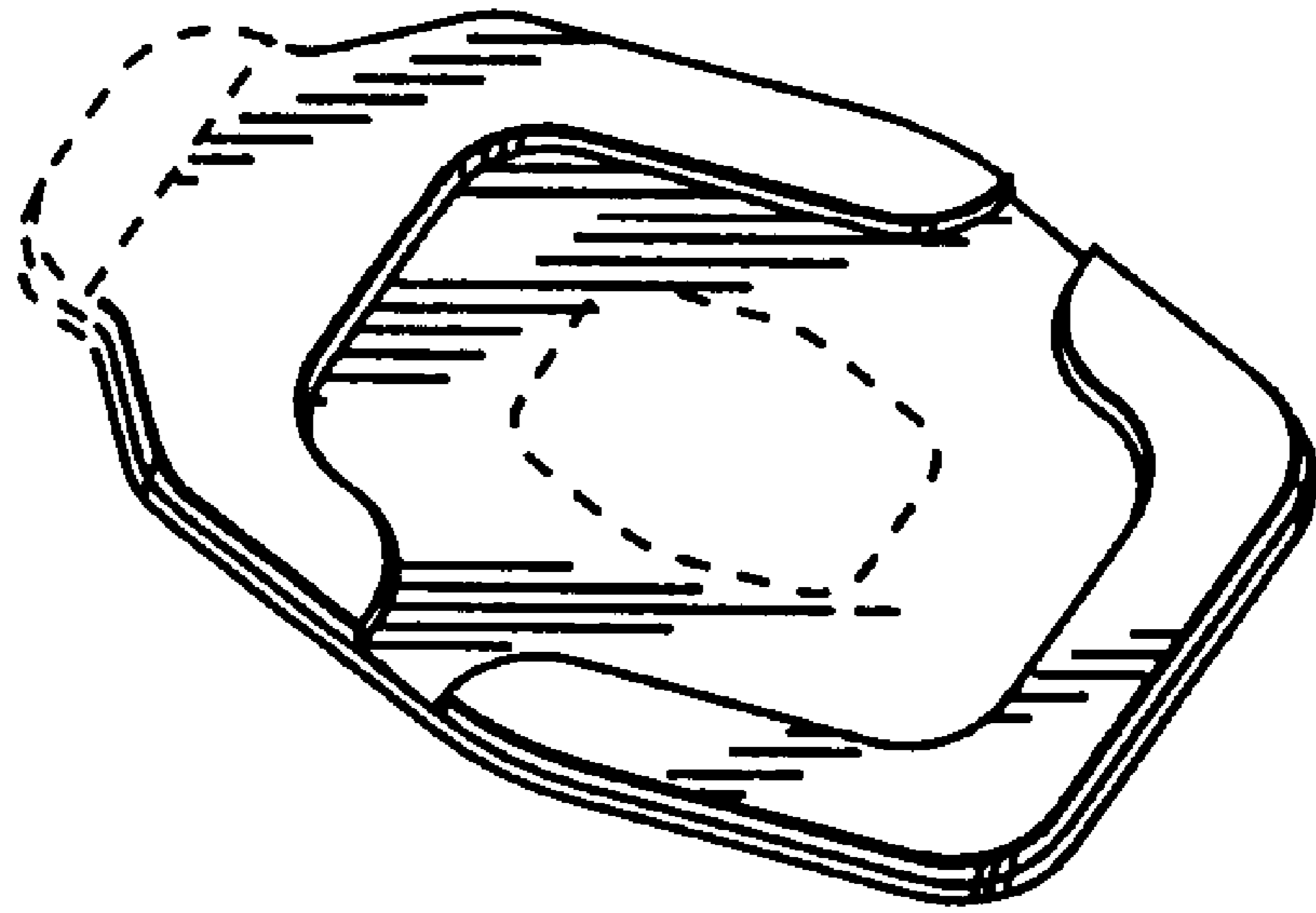
