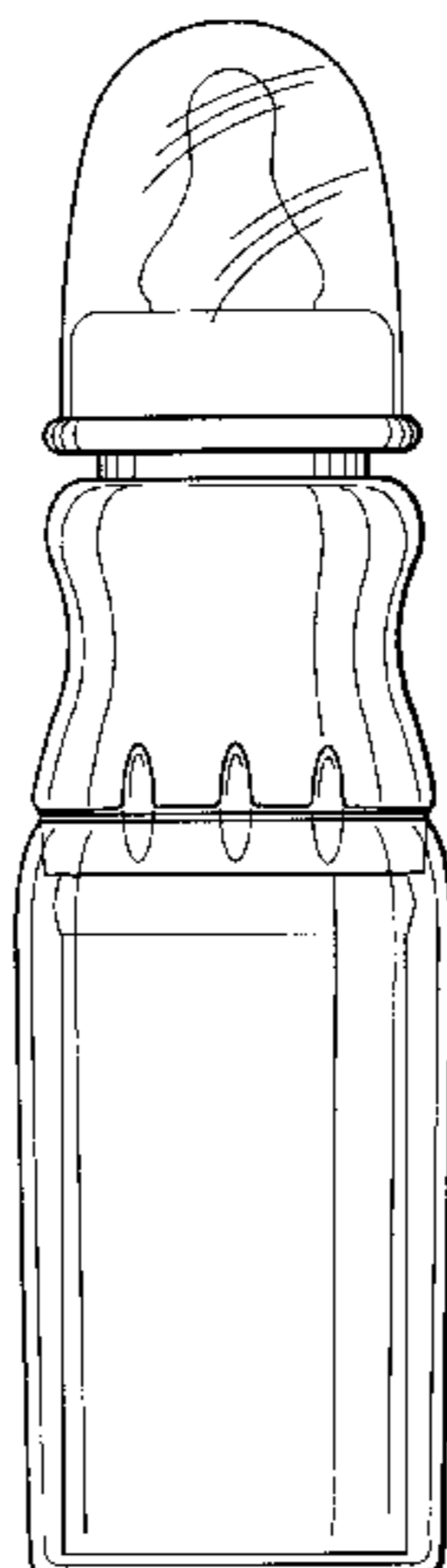
## [57] CLAIM

The ornamental design for a baby bottle, as shown.

### DESCRIPTION

FIG. 1 is a front elevational view of a baby bottle embodying my new design, the rear elevational view being a mirror image;  
 FIG. 2 is a left side elevational view thereof, the right side elevational view being a mirror image;  
 FIG. 3 is a top plan view thereof; and,  
 FIG. 4 is a bottom plan view thereof.

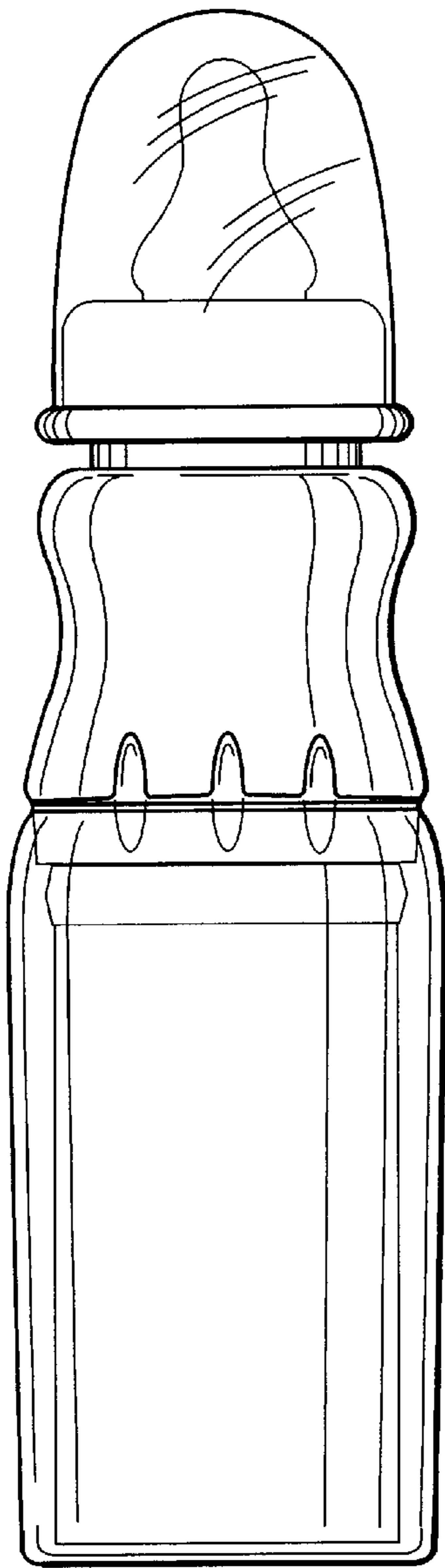

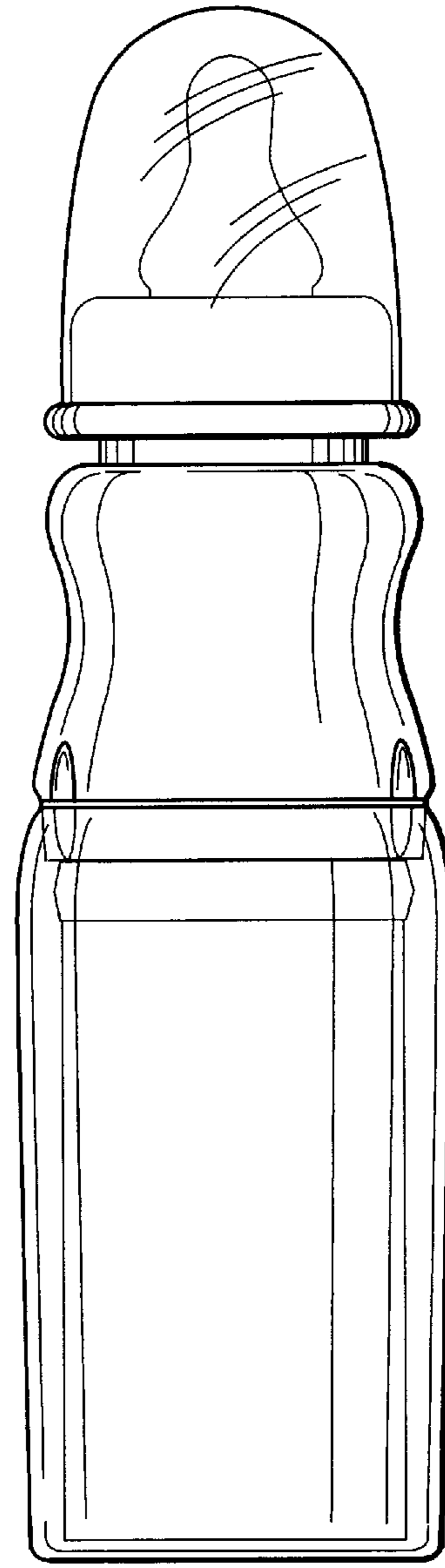

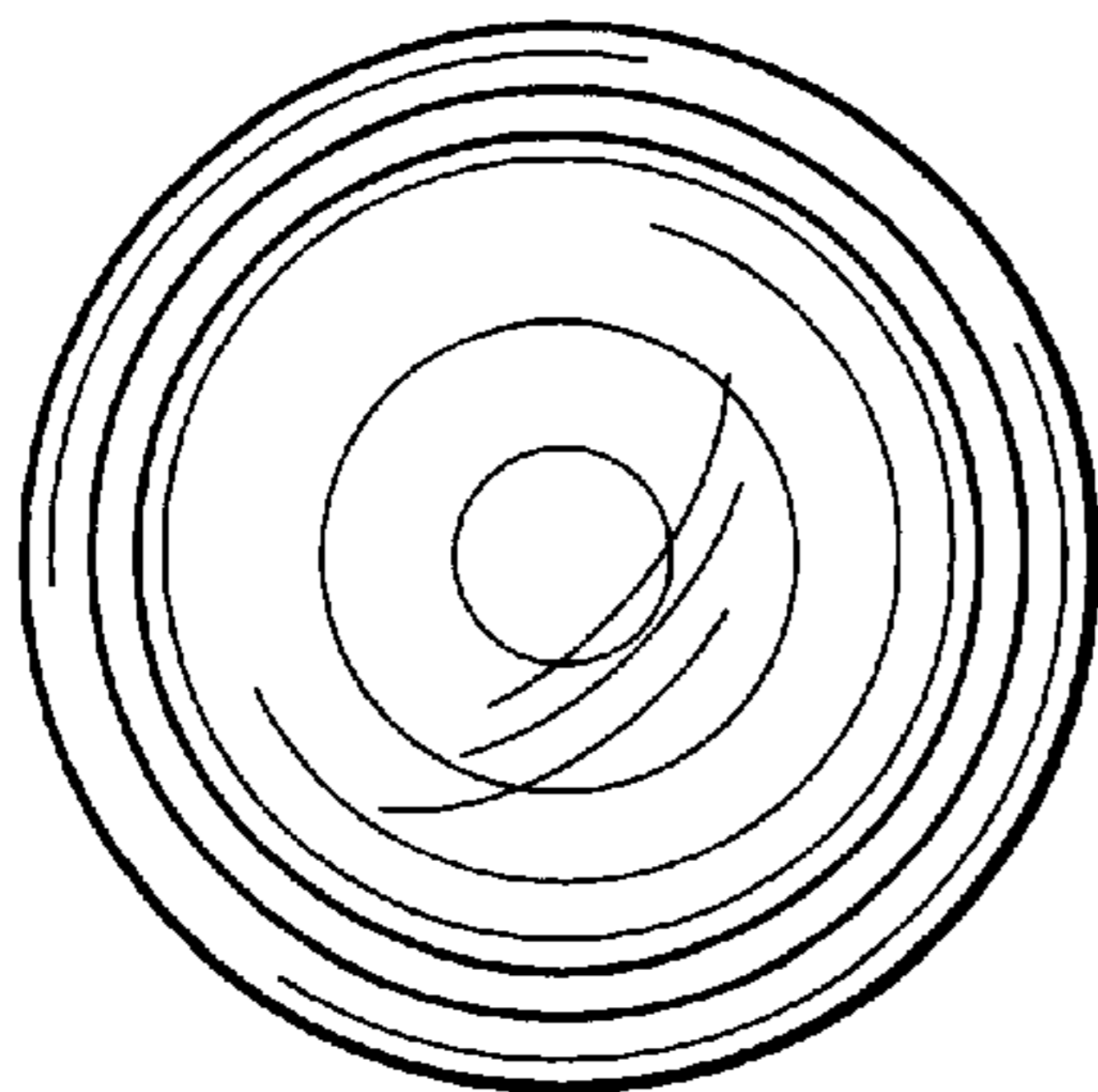

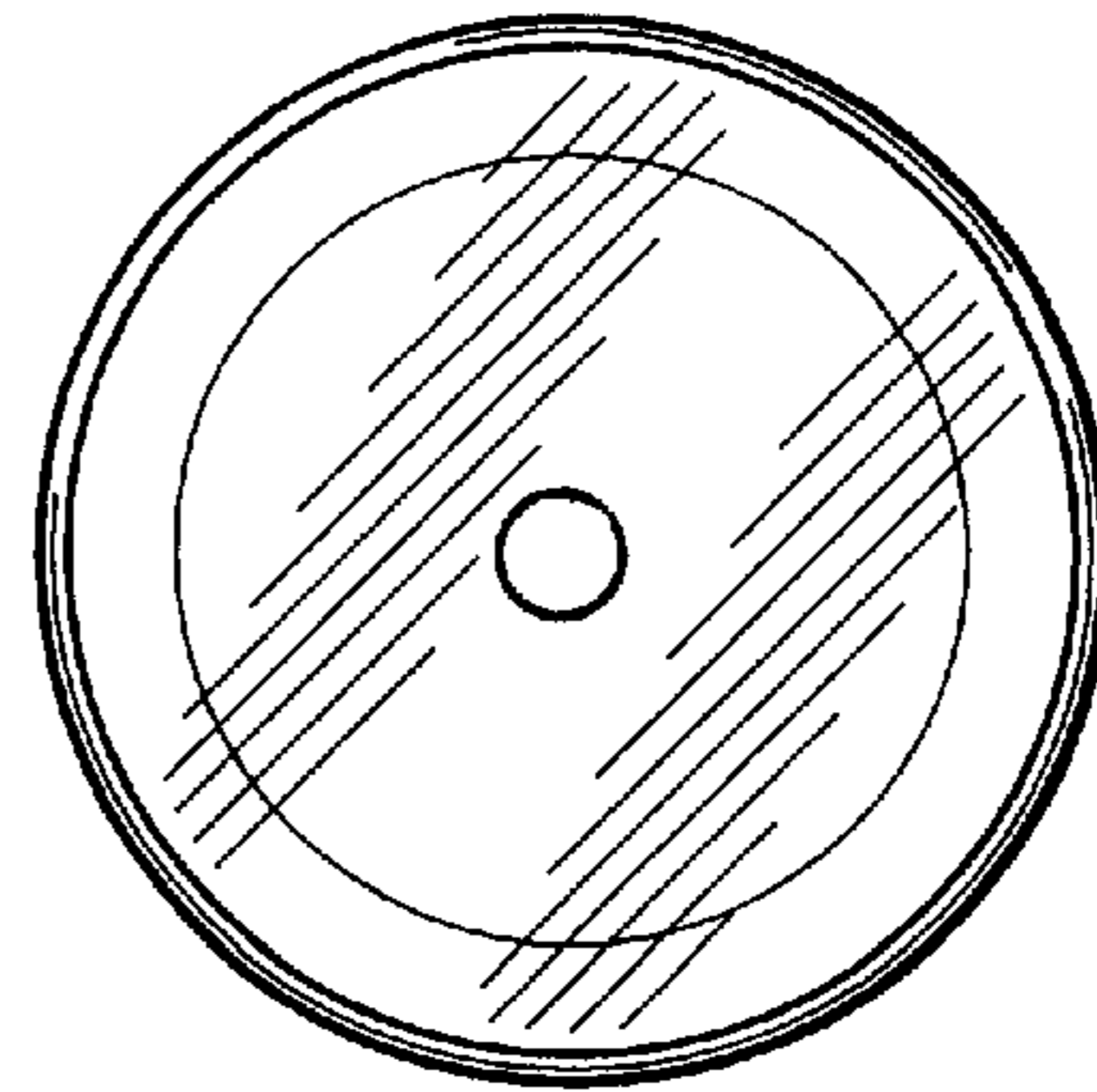
