DESCRIPTION

FIG. 5 is a front and top perspective view thereof;

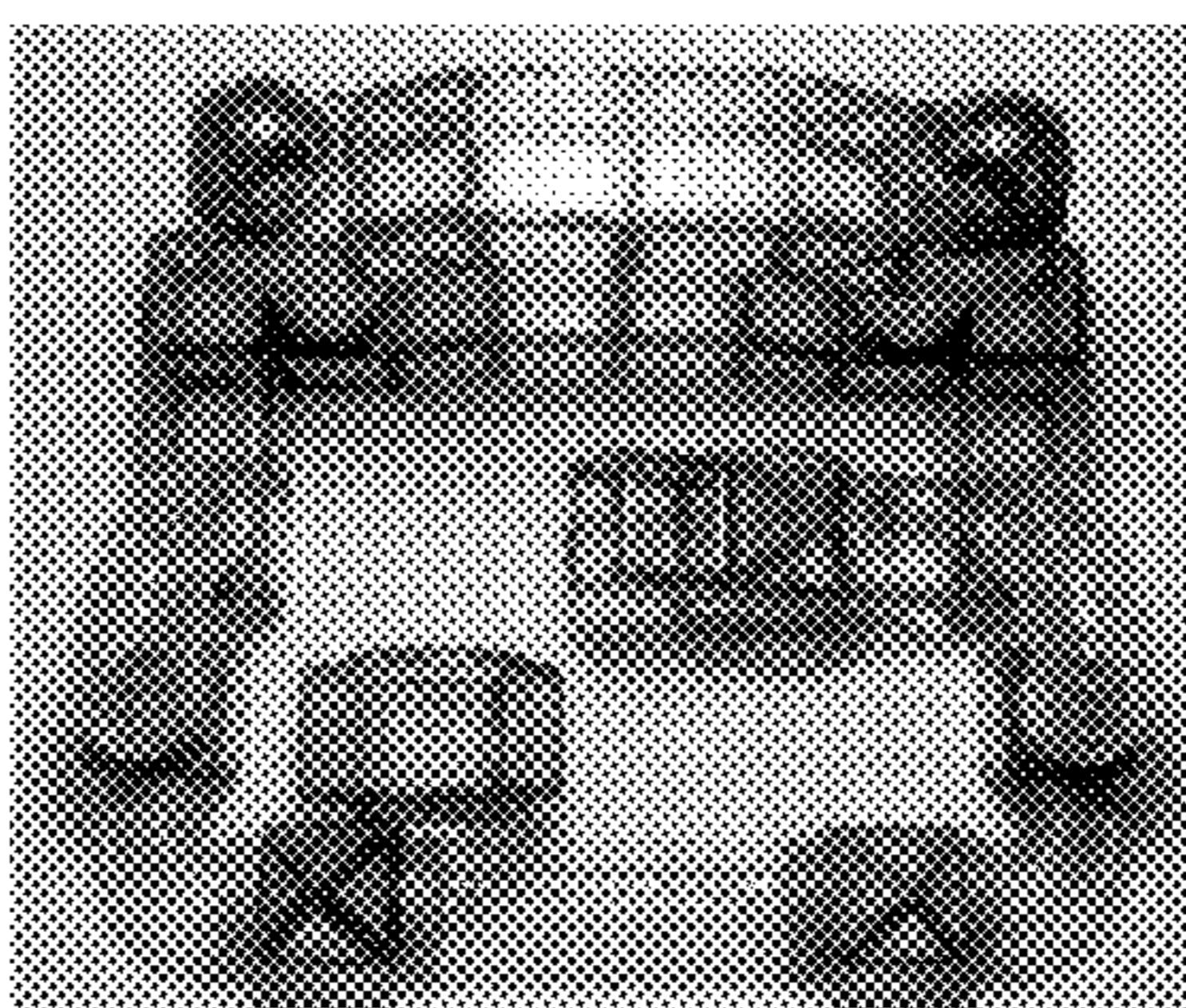
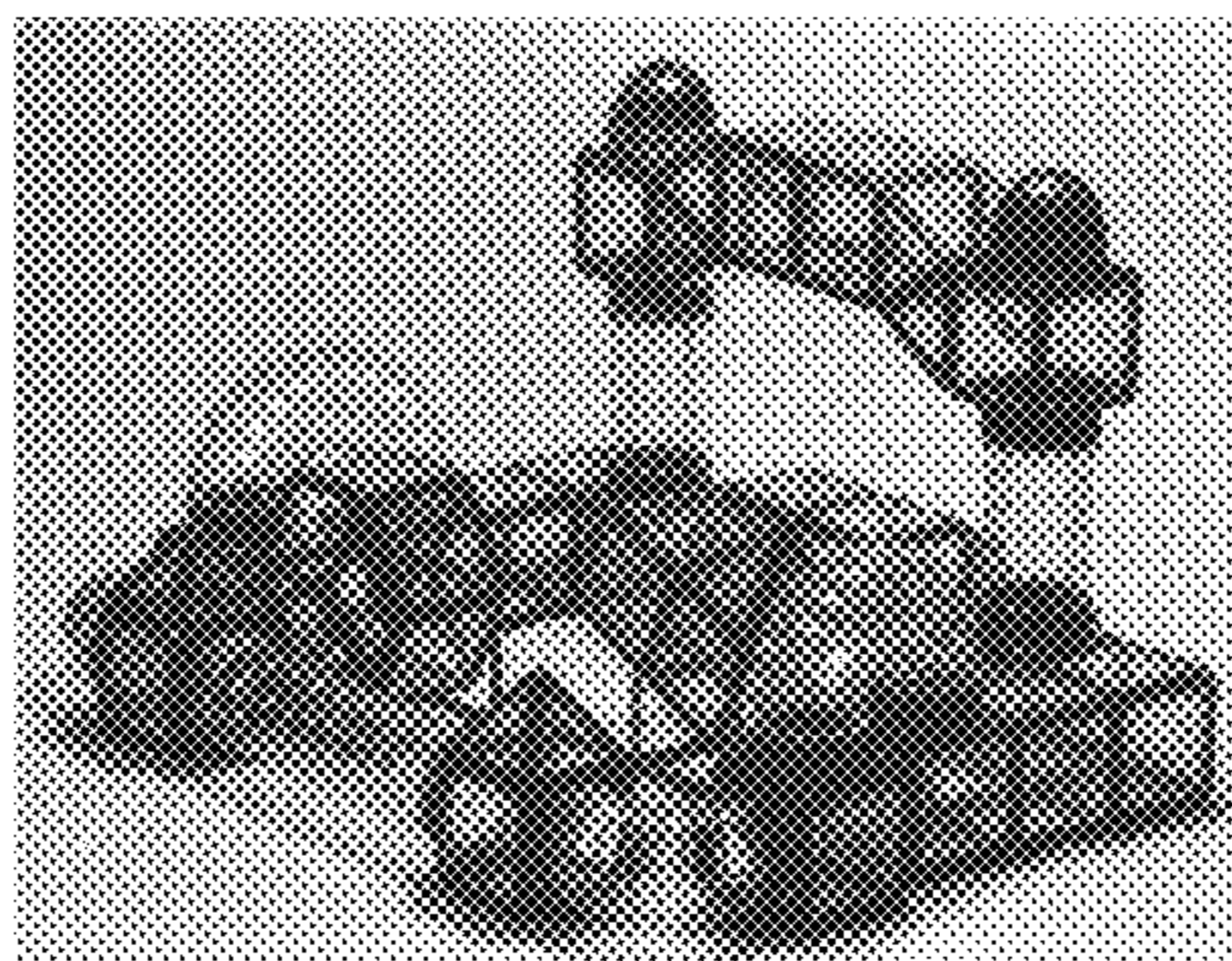
FIG. 6 is a rear and top perspective view thereof;

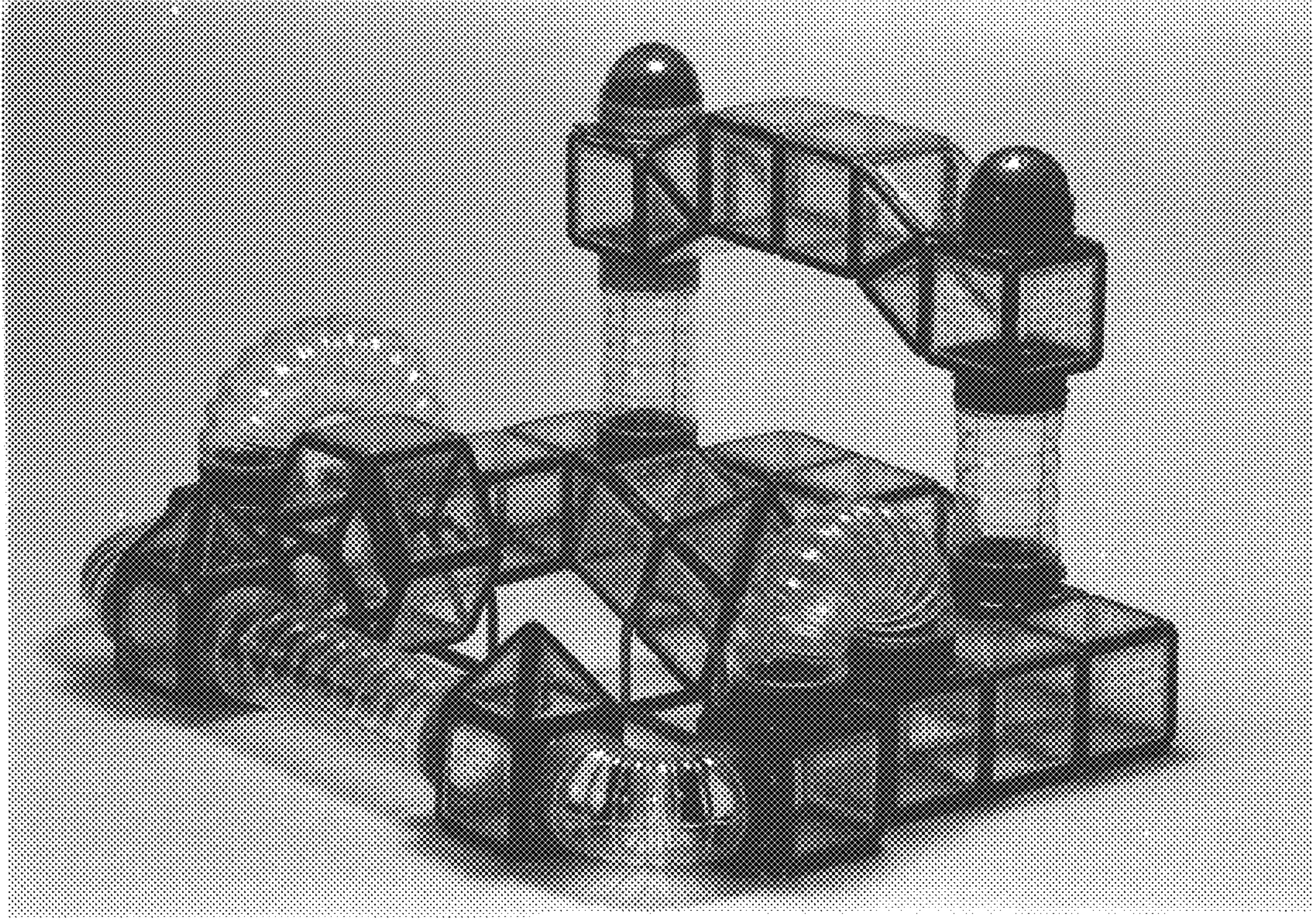

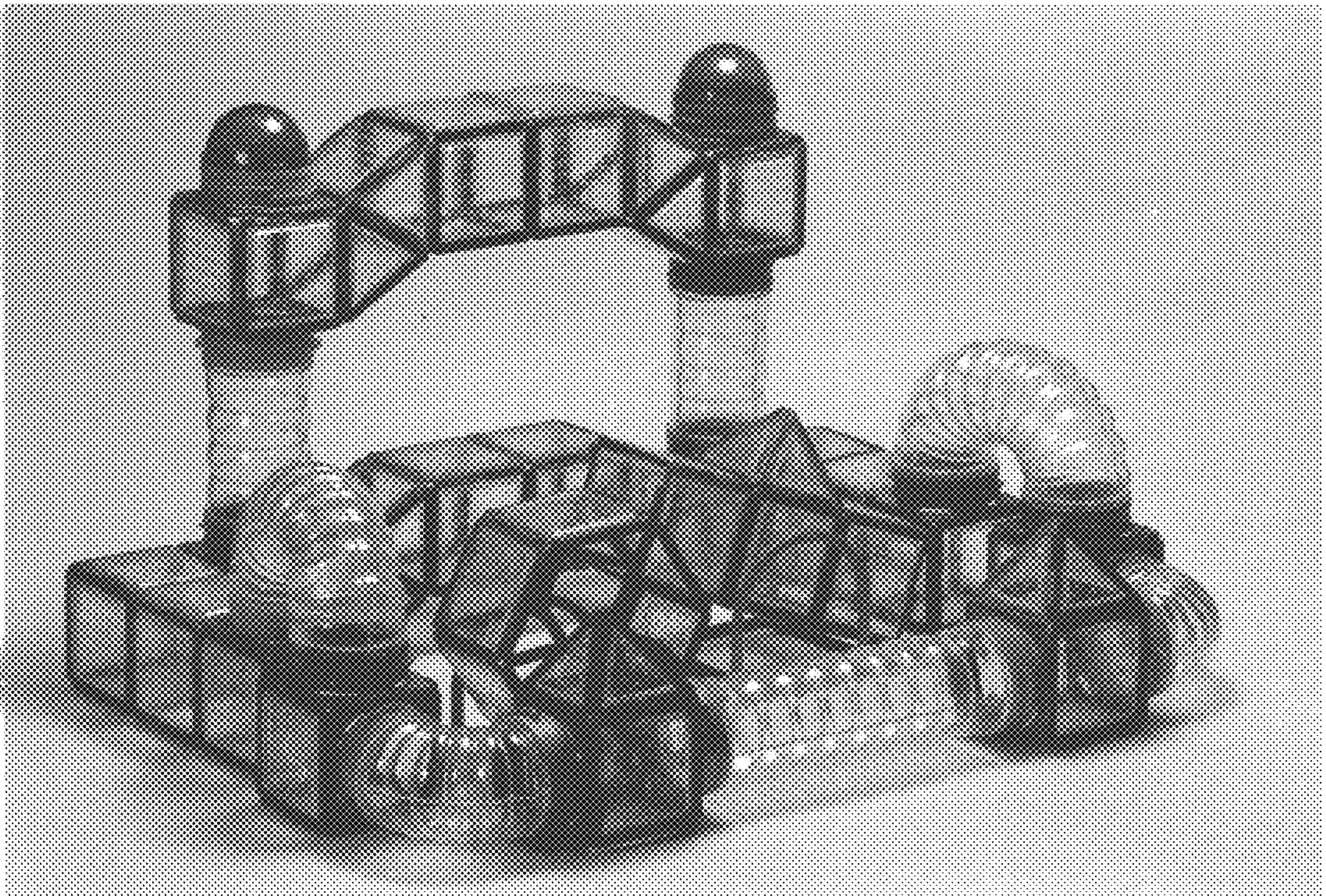

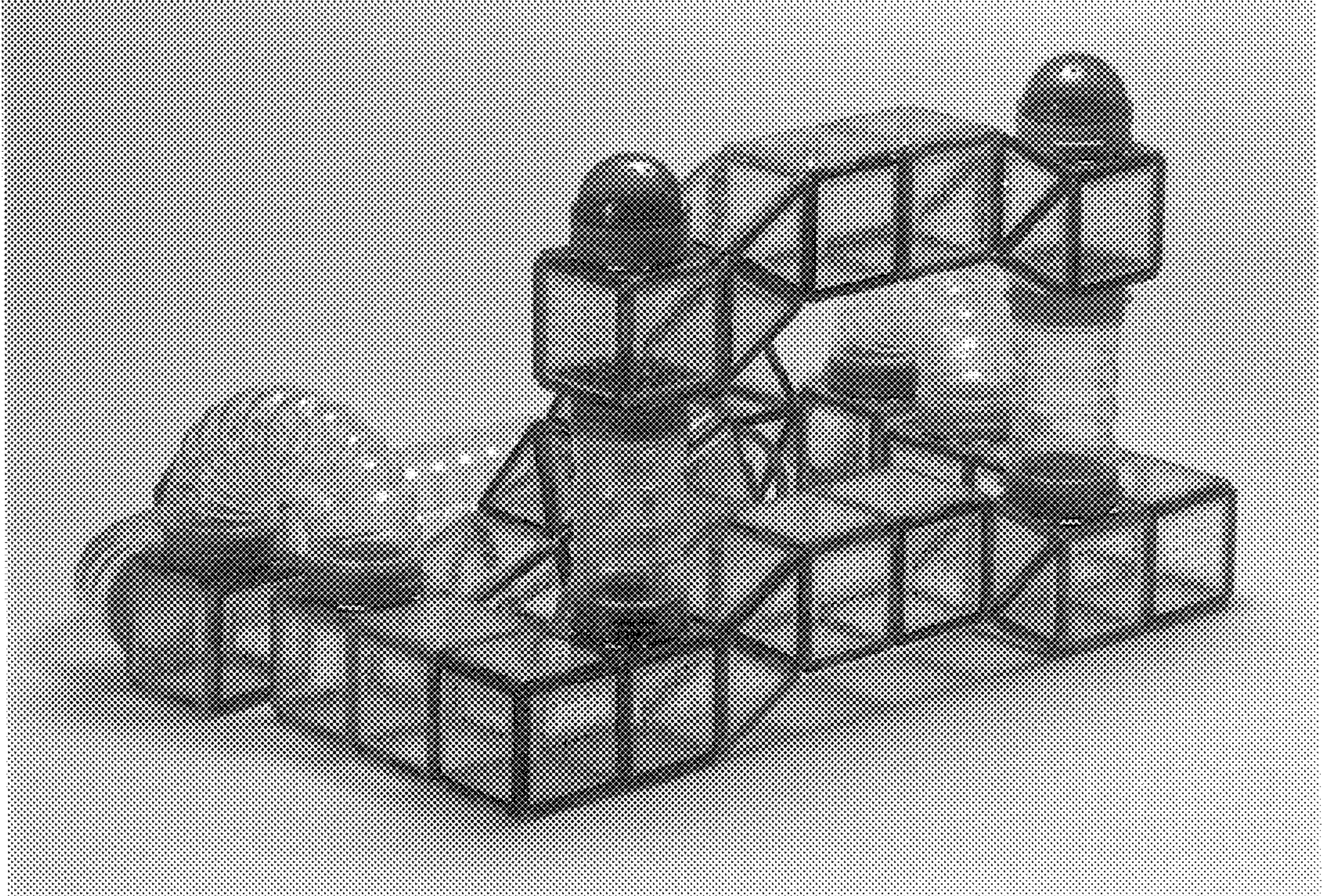

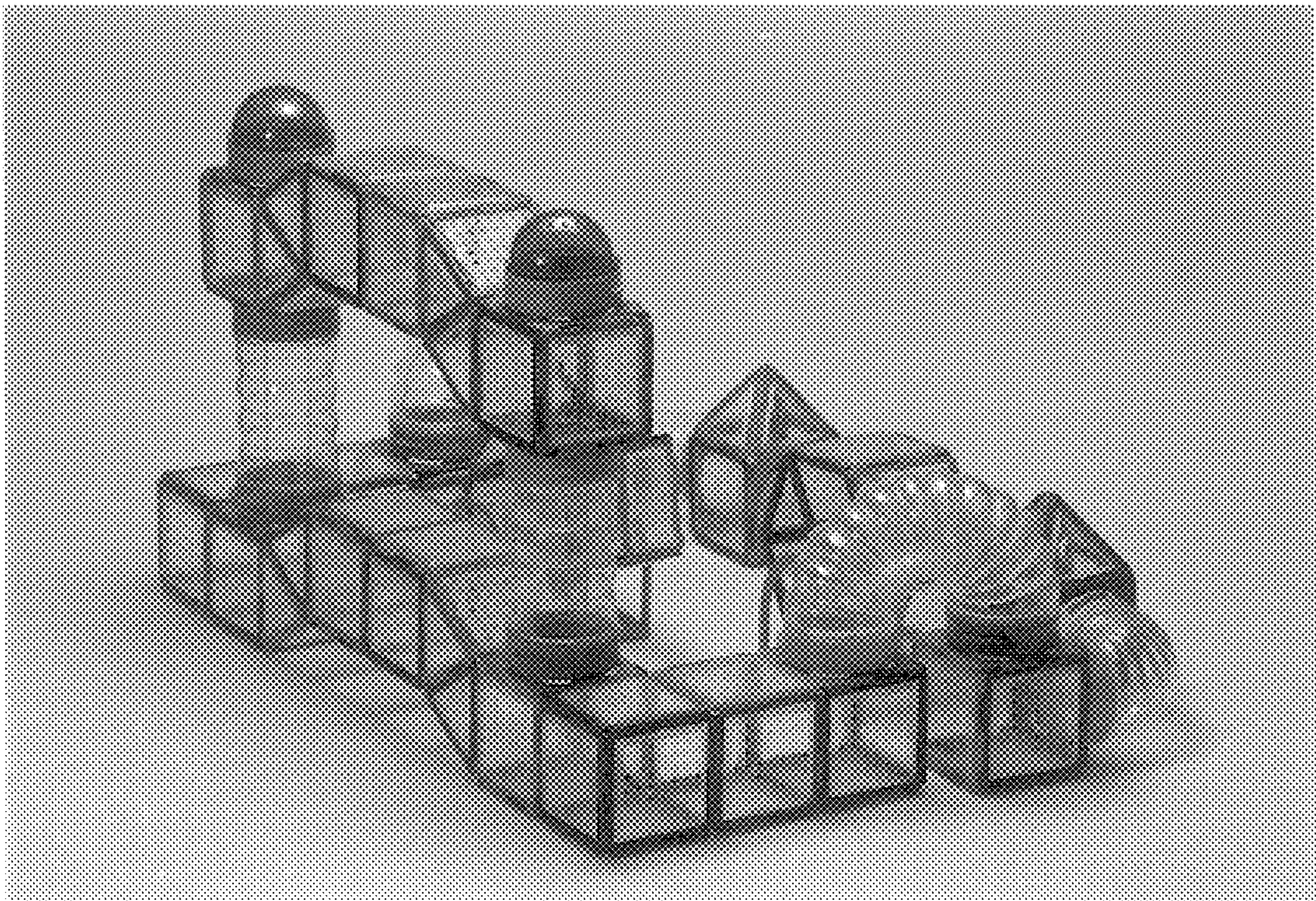

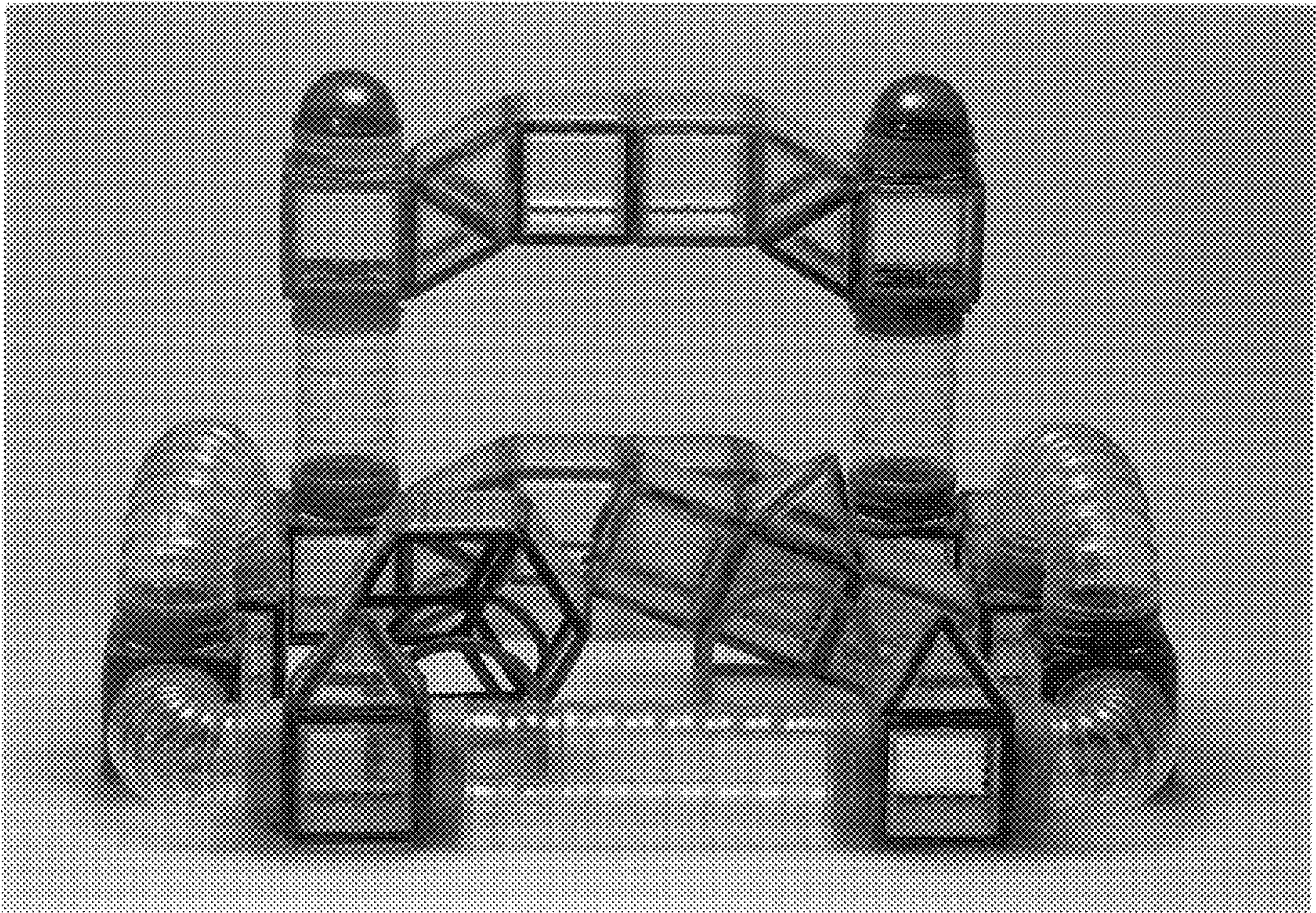

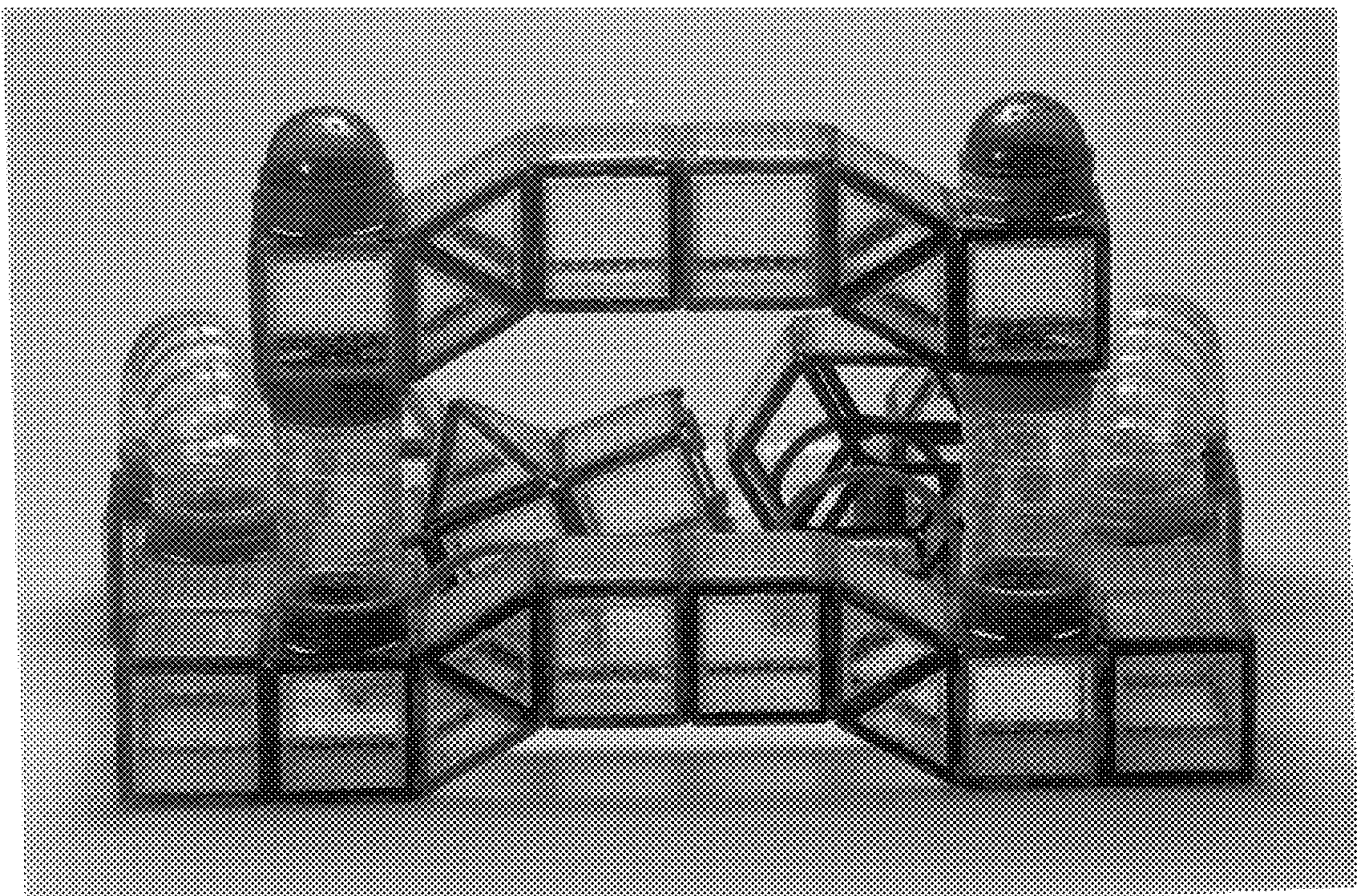

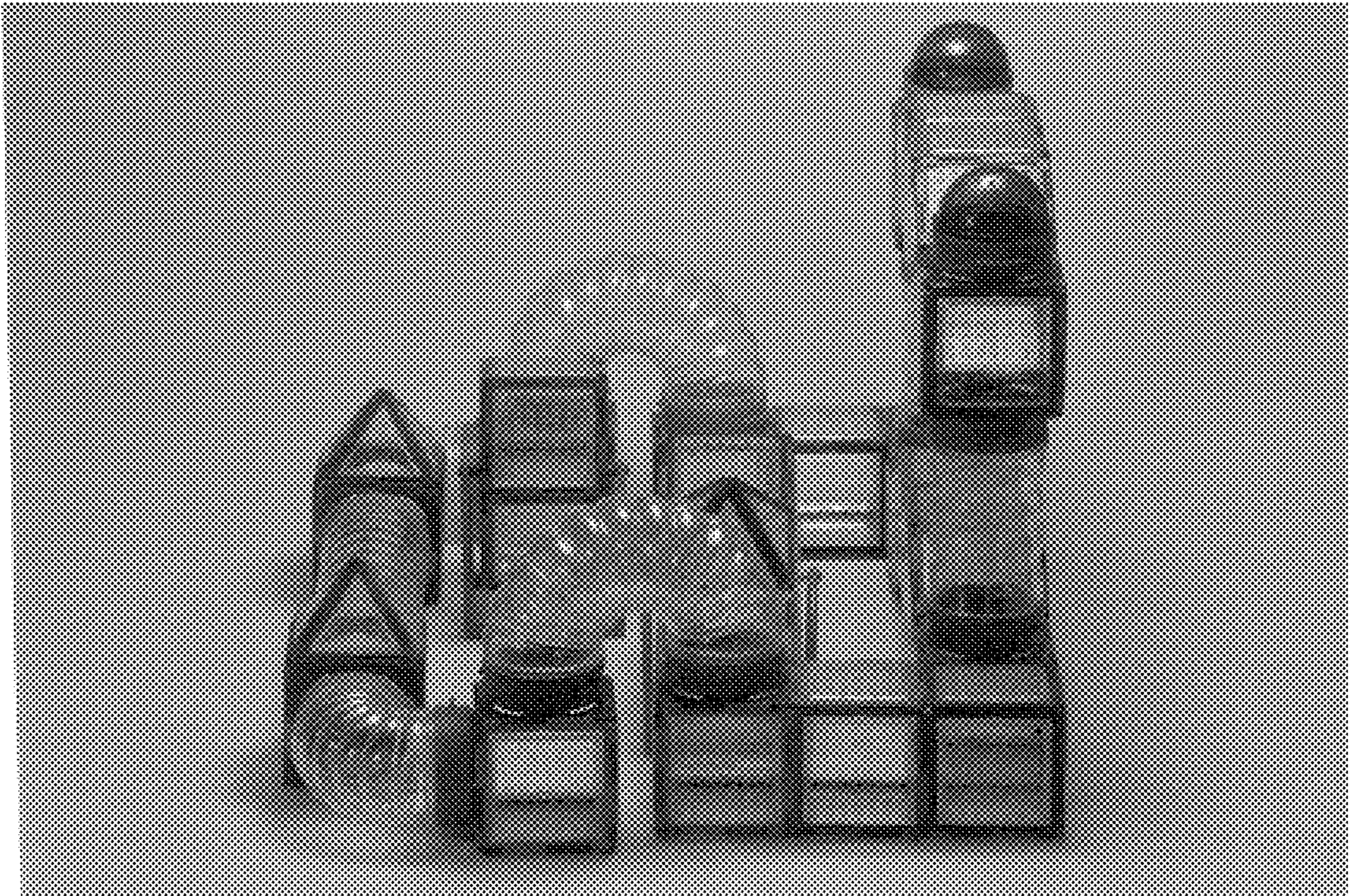

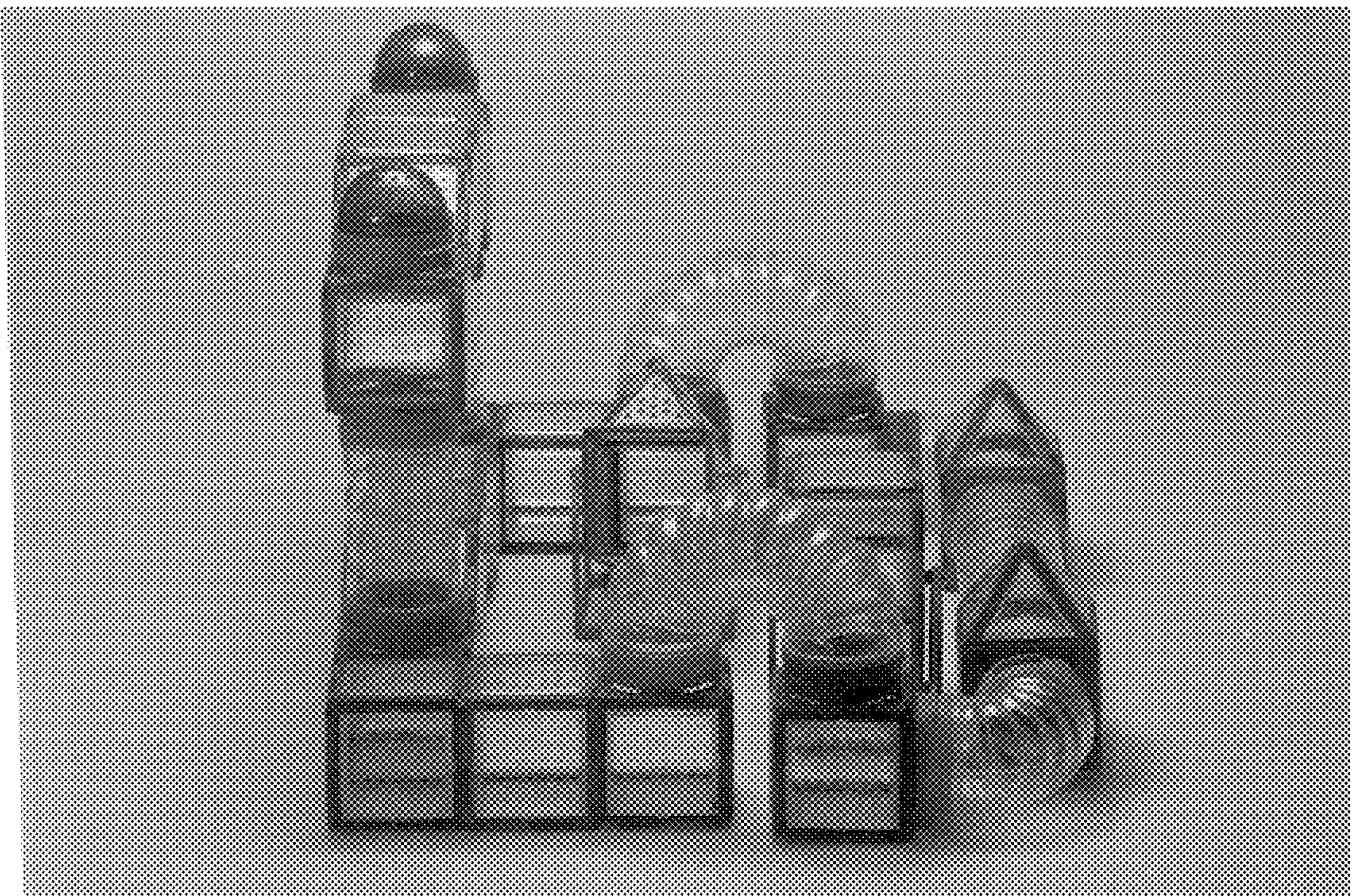
