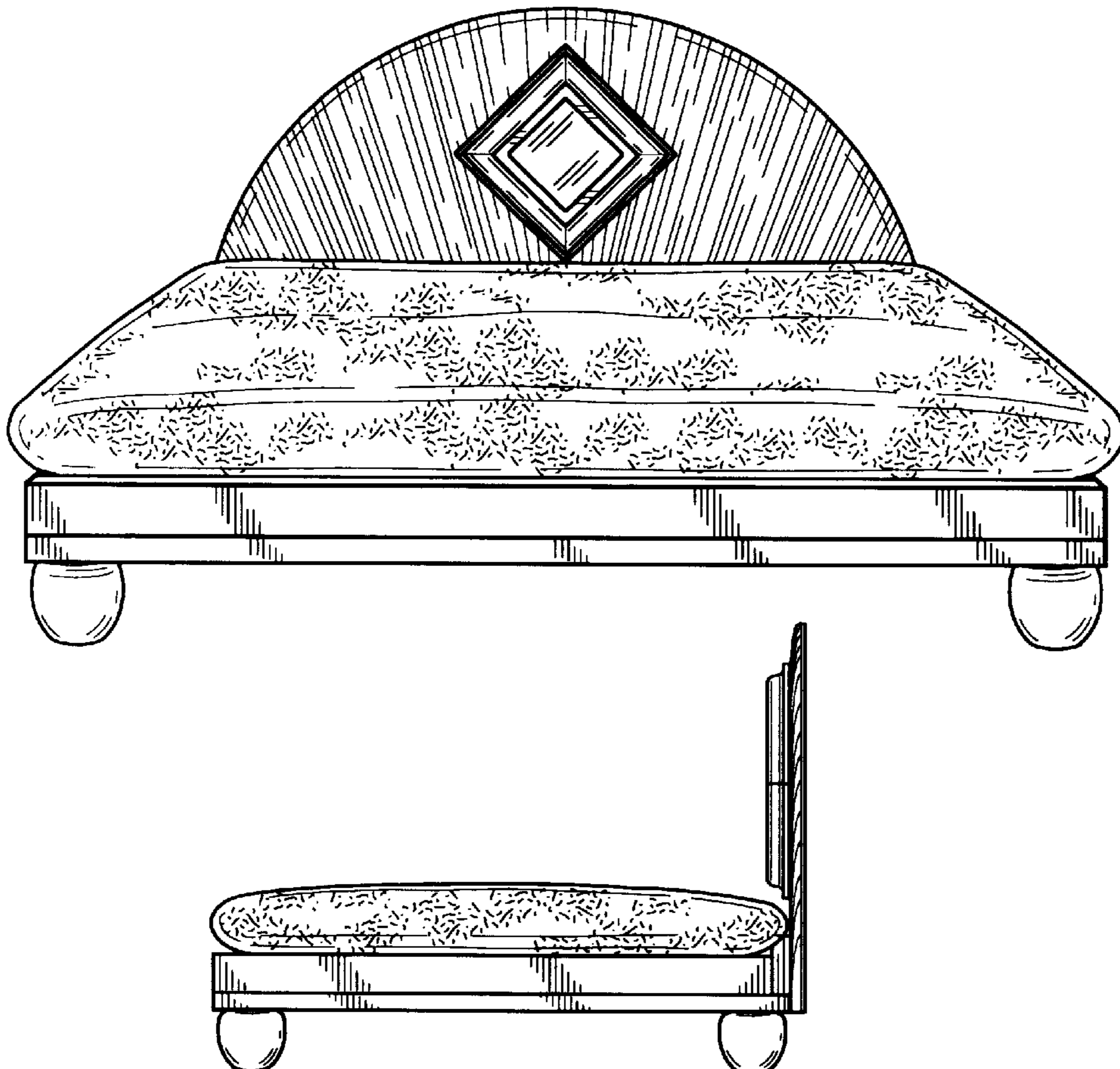
[57] **CLAIM**

The ornamental design for a pet bed, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the pet bed showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;

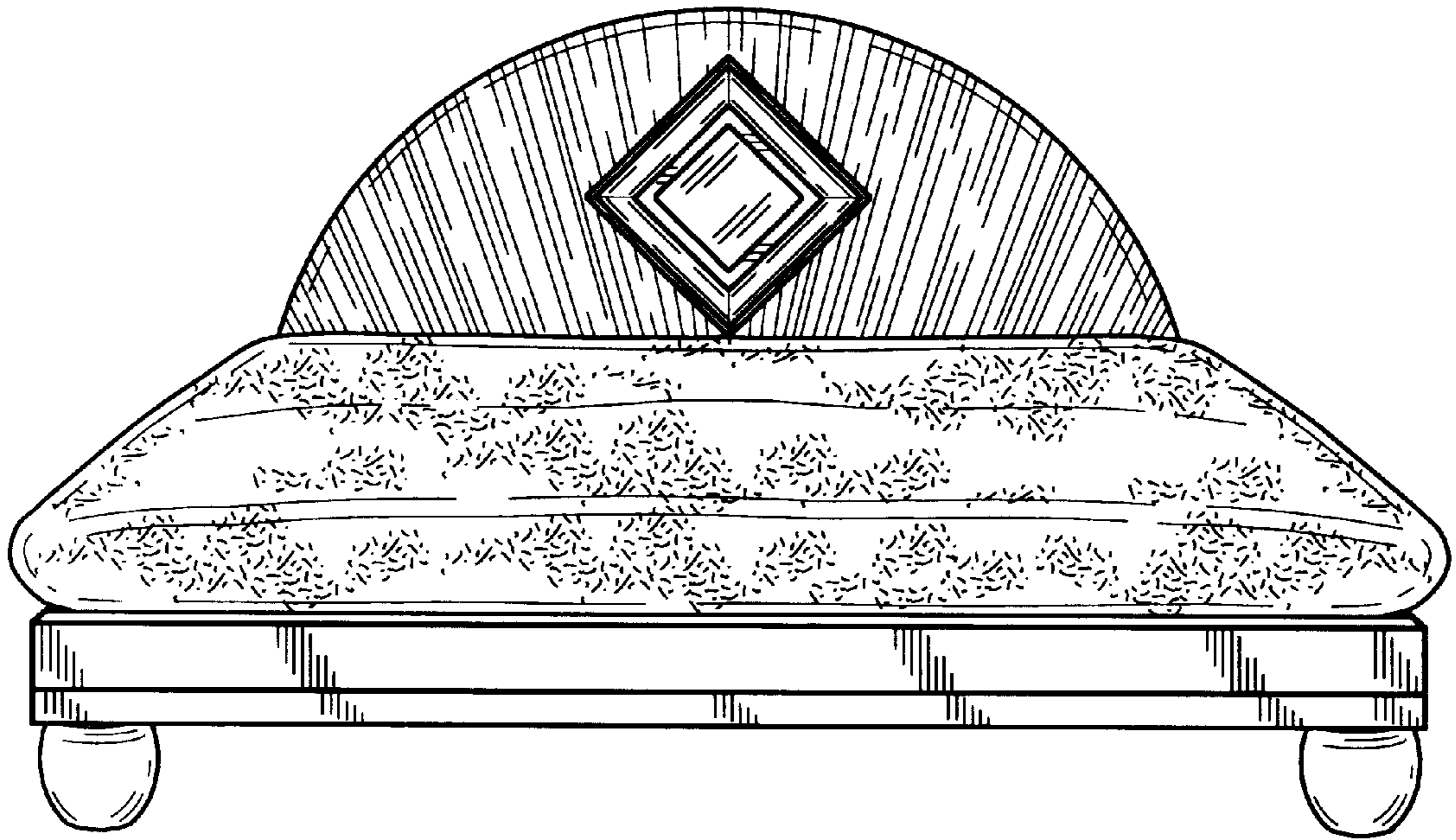

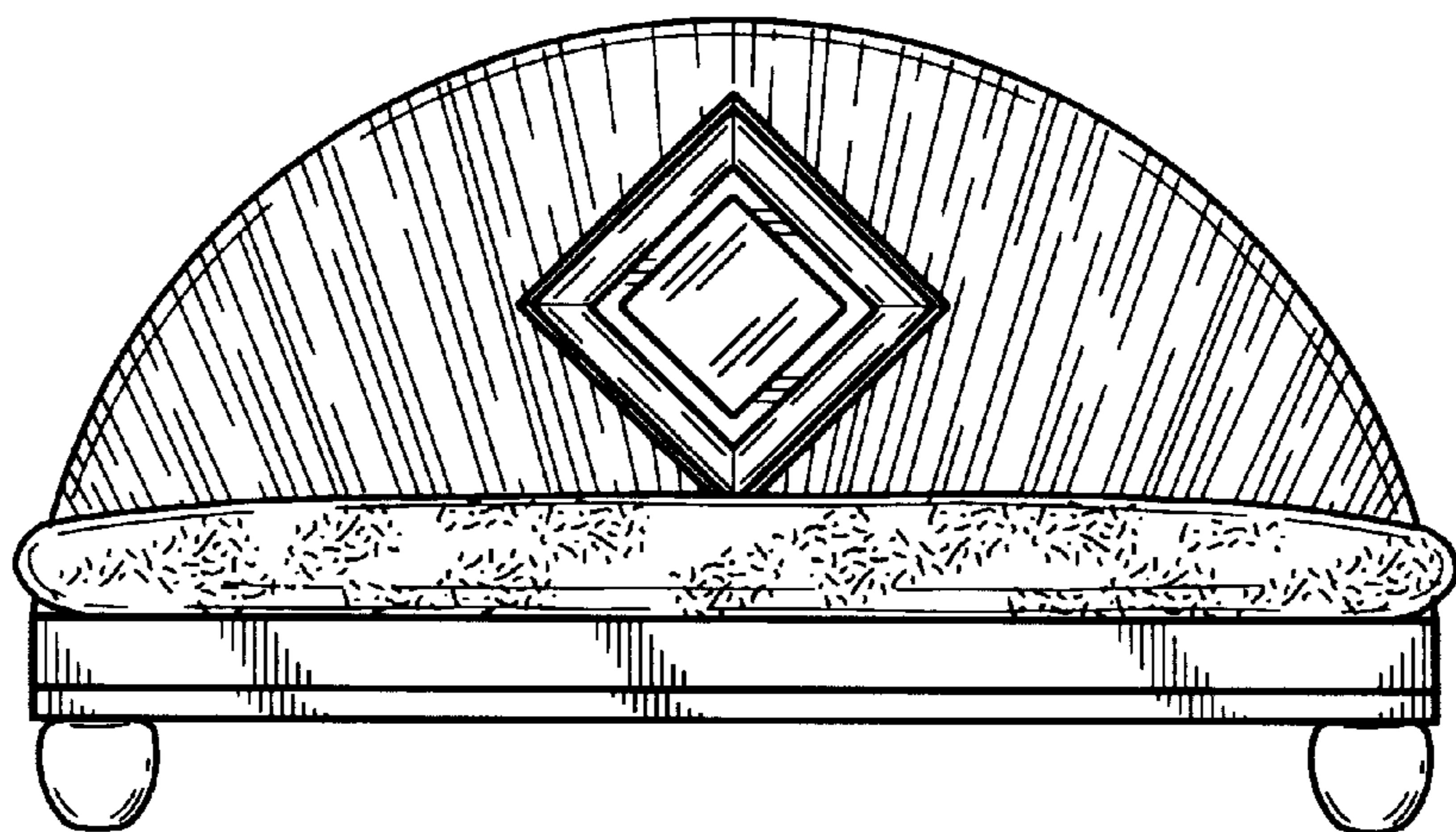

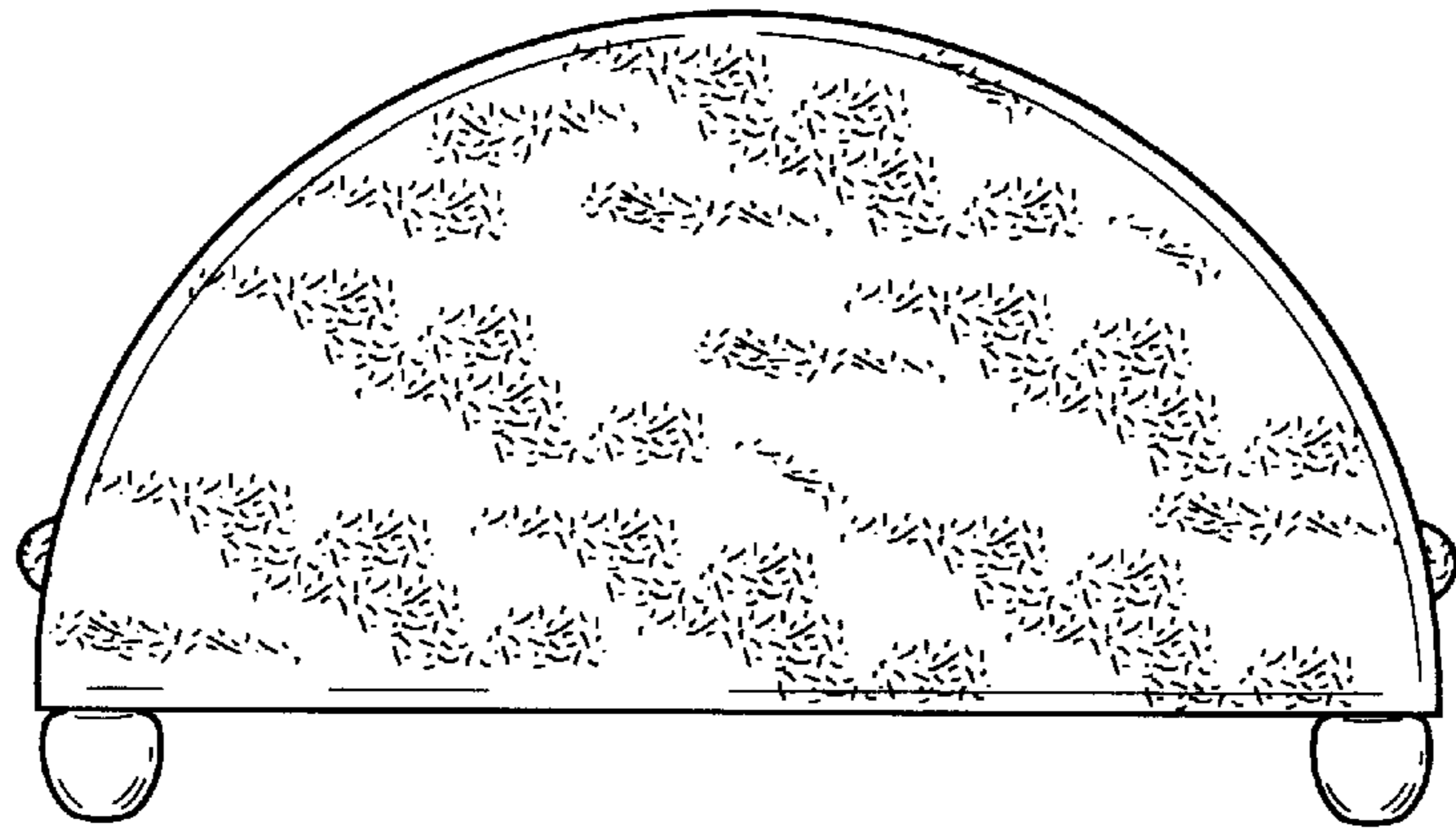

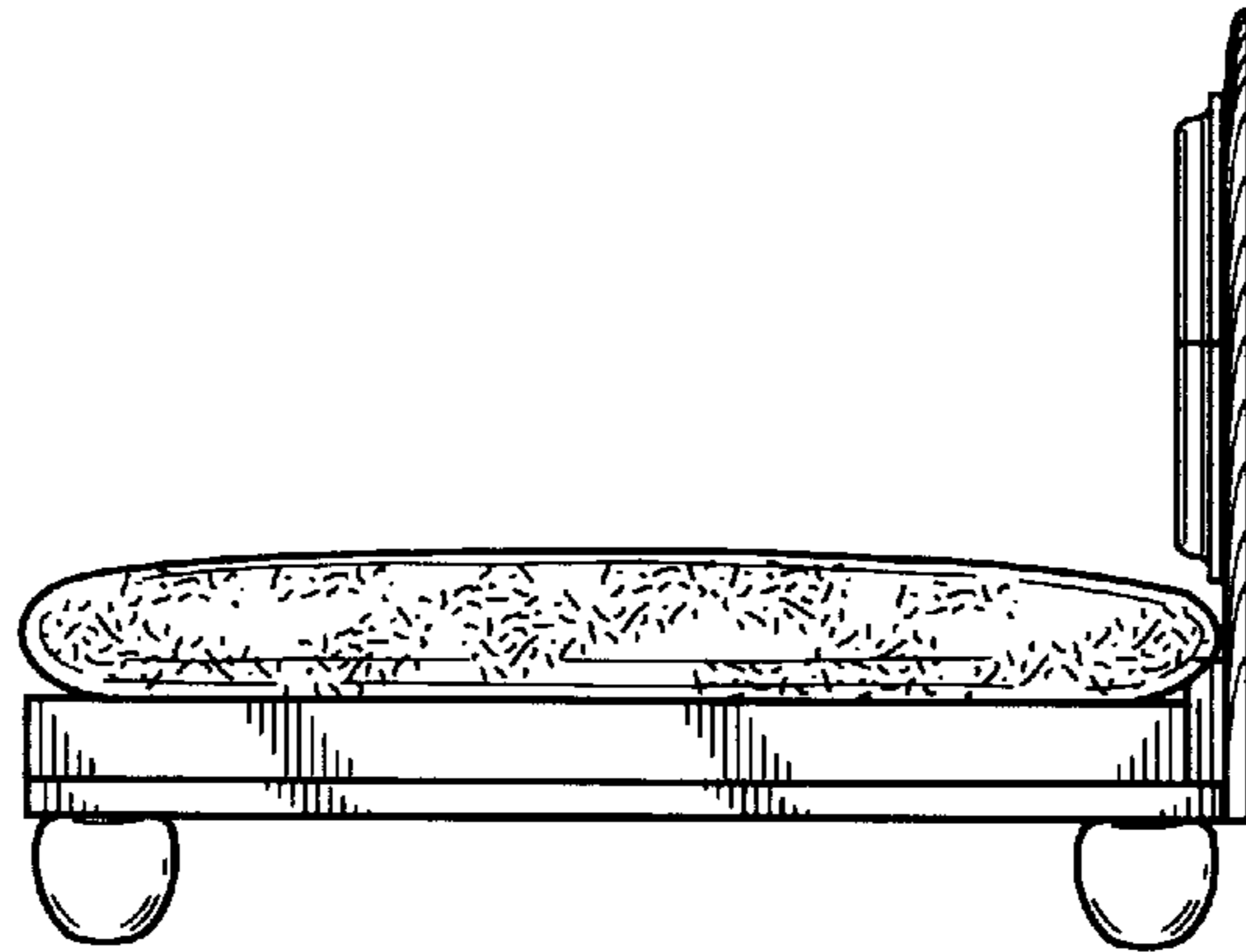

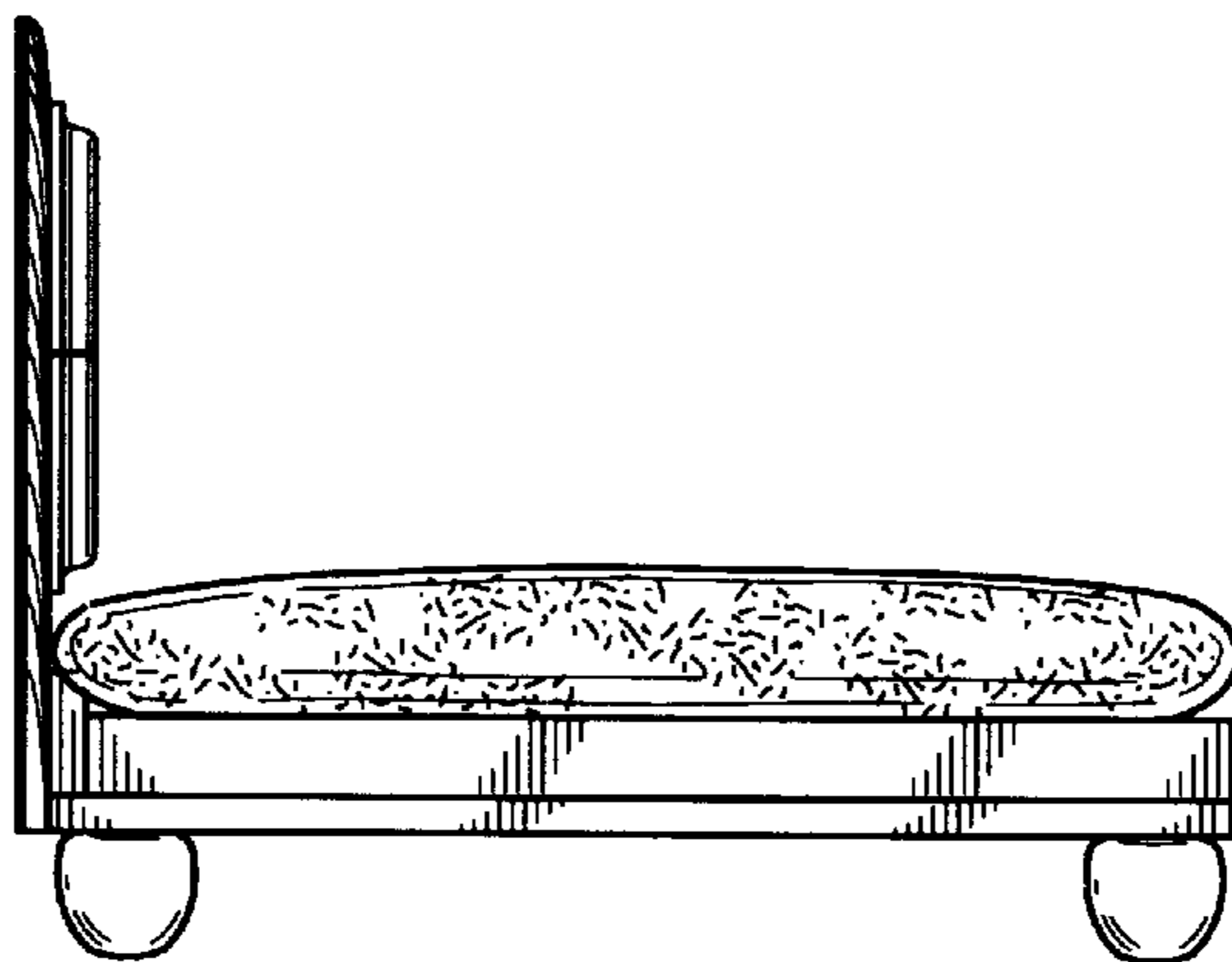

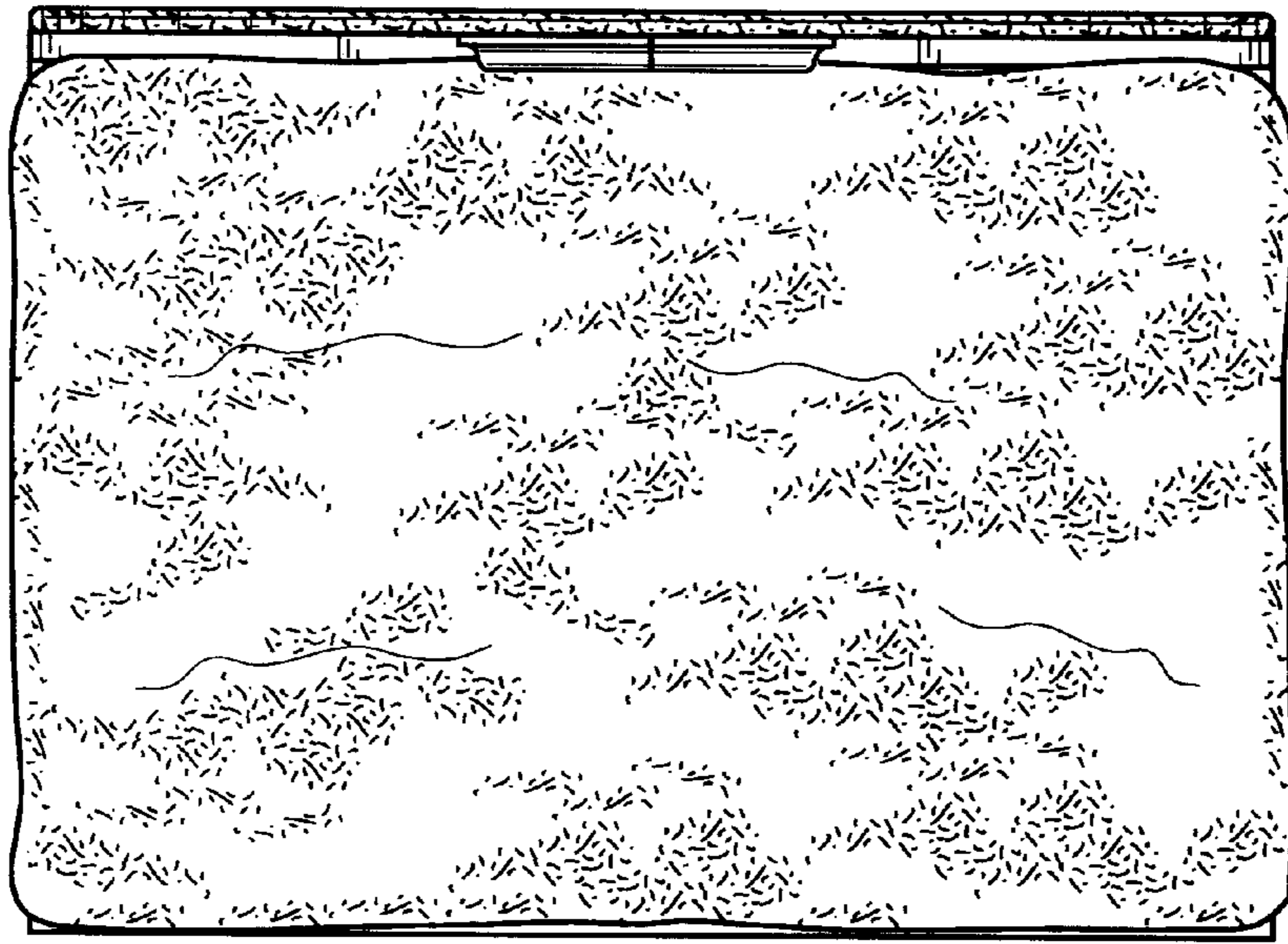

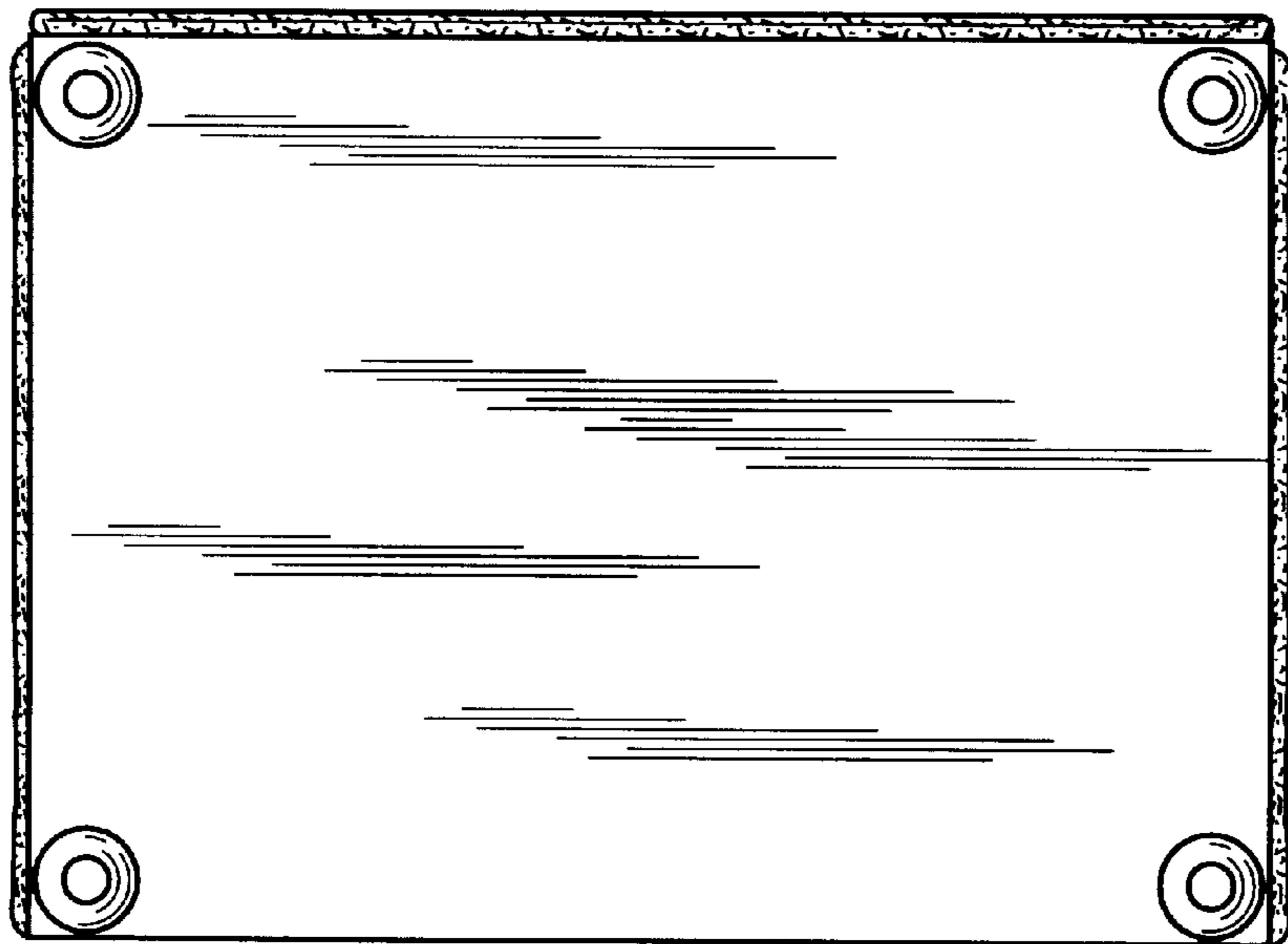
