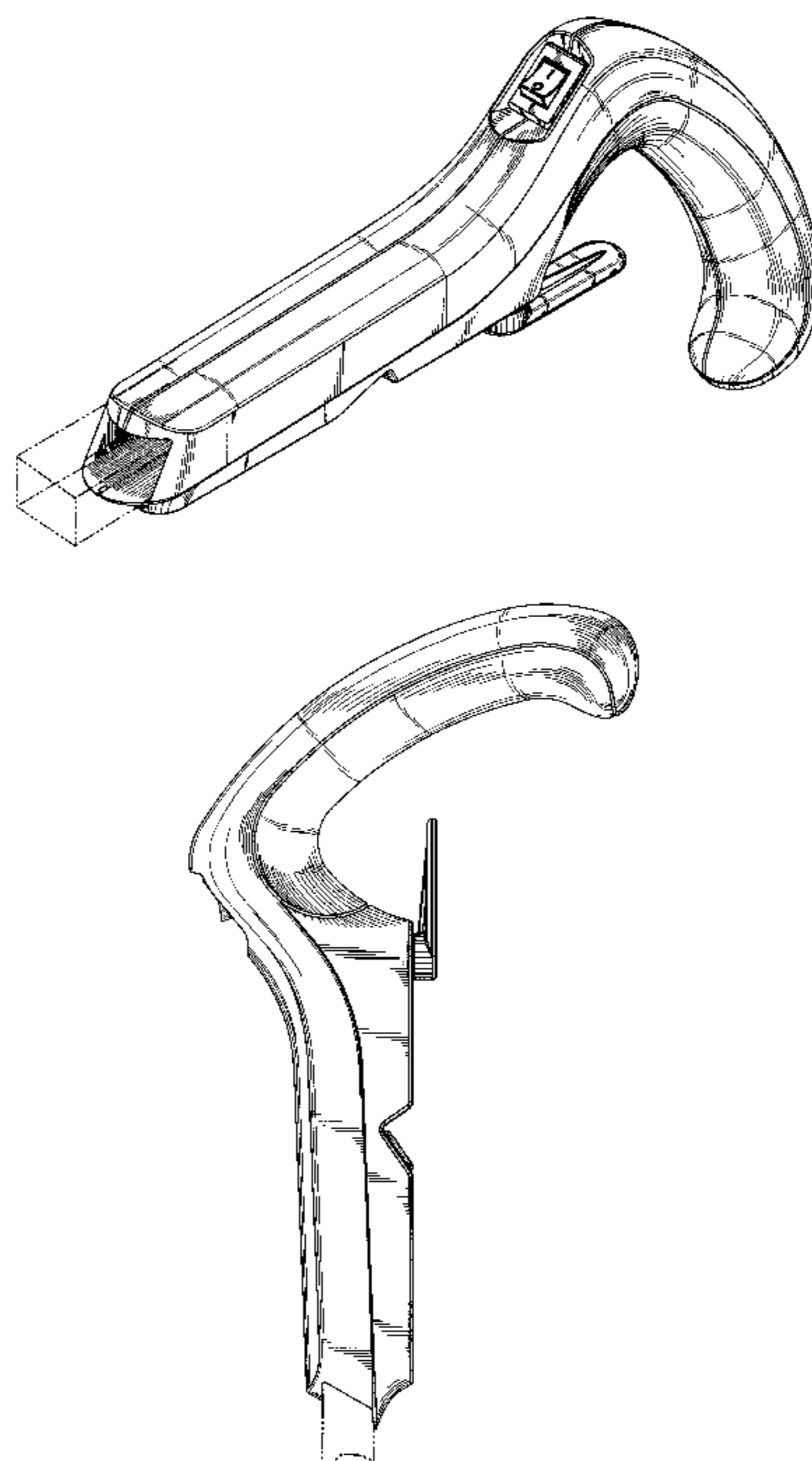
[57] CLAIM

We claim the design for a handle for vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for vacuum cleaner showing our new design;
 FIG. 2 is a right side view thereof, the left side view being a mirror image thereof;
 FIG. 3 is a front view thereof; and,
 FIG. 4 is a rear view thereof.
 The top and bottom portions of the article not shown in the drawing or described in the specification form no part of the claimed design.
 The detail shown in broken lines in all views is for illustrative purposes only and forms no part of the claimed design.

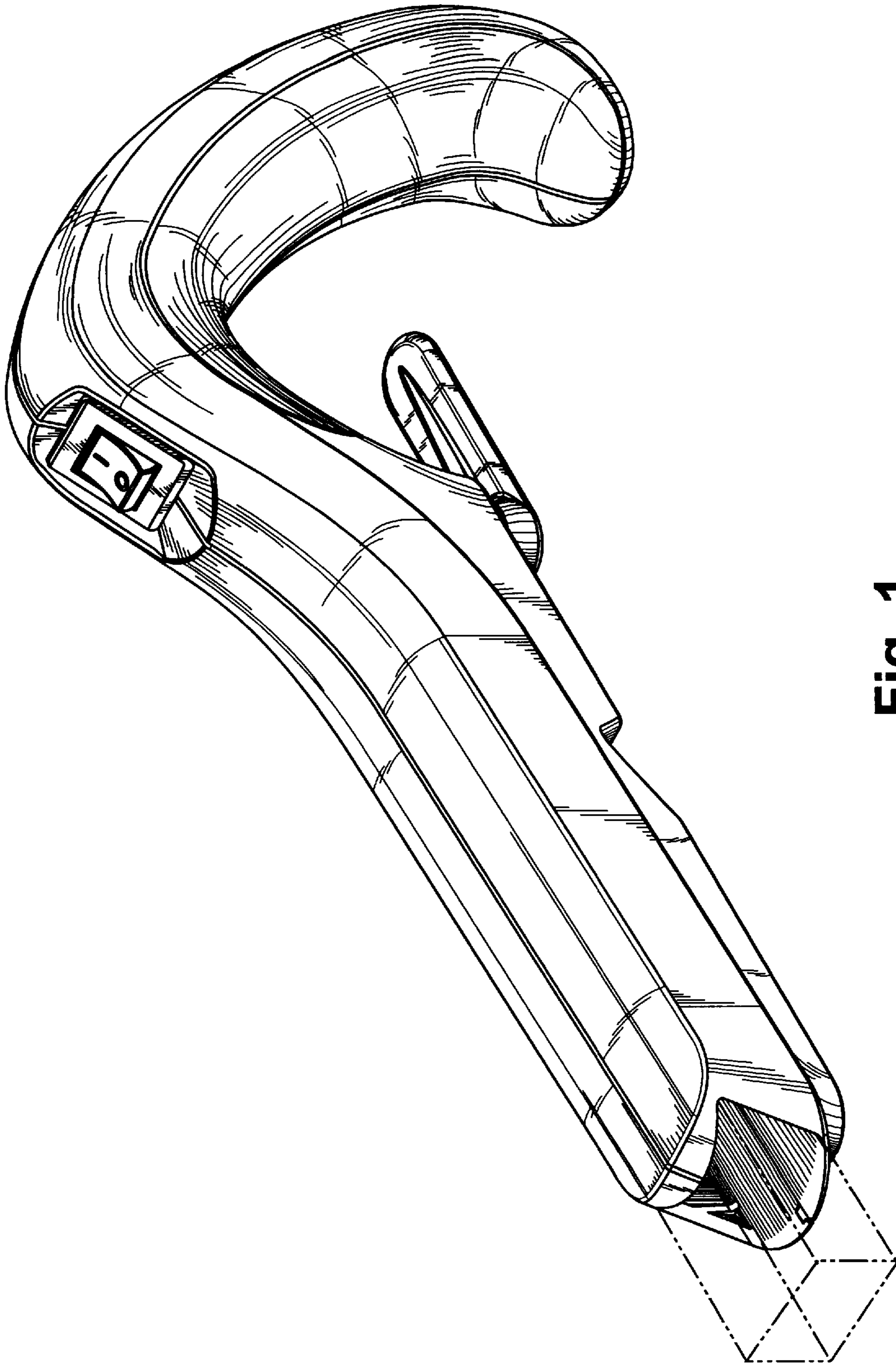

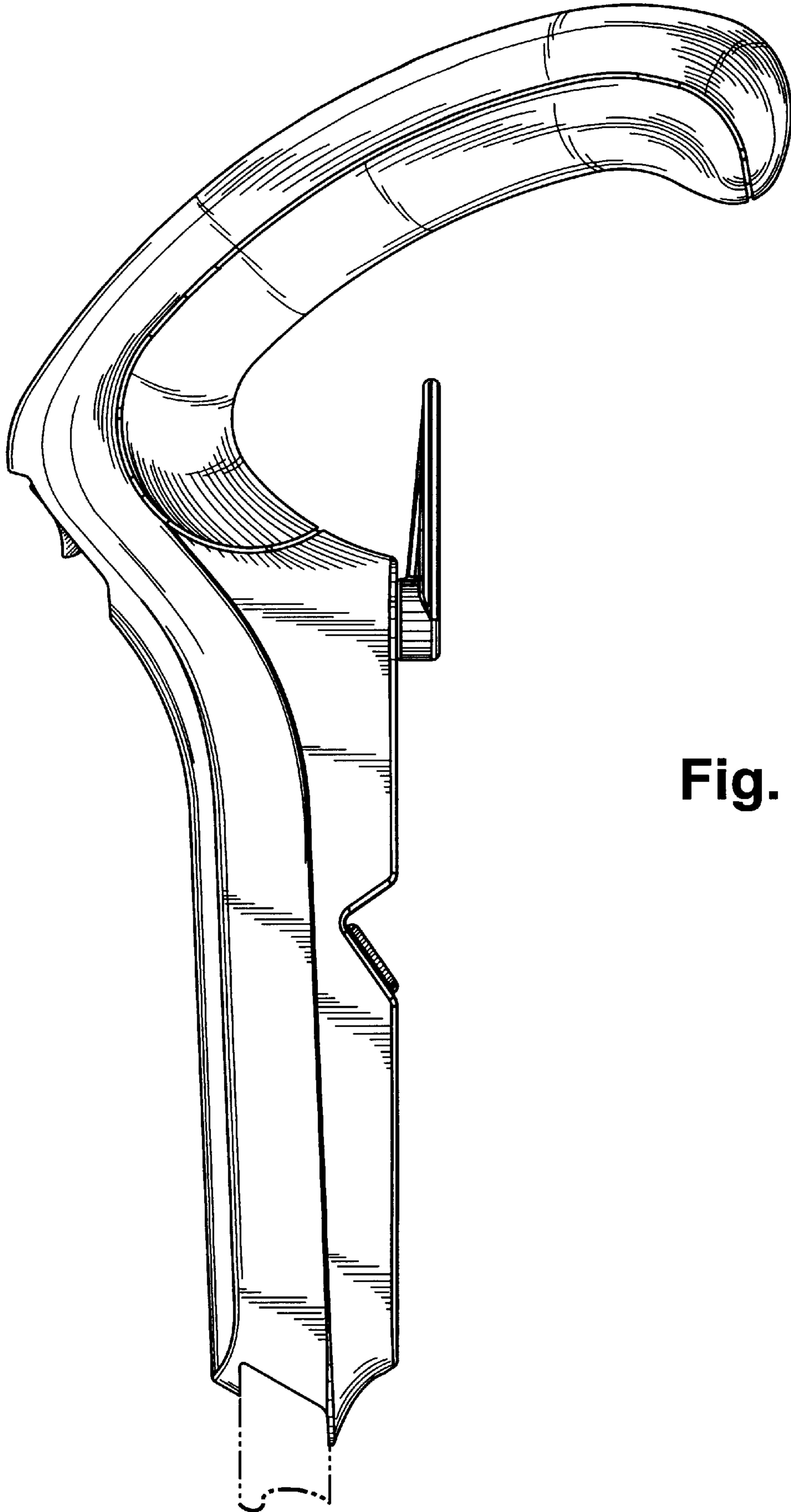

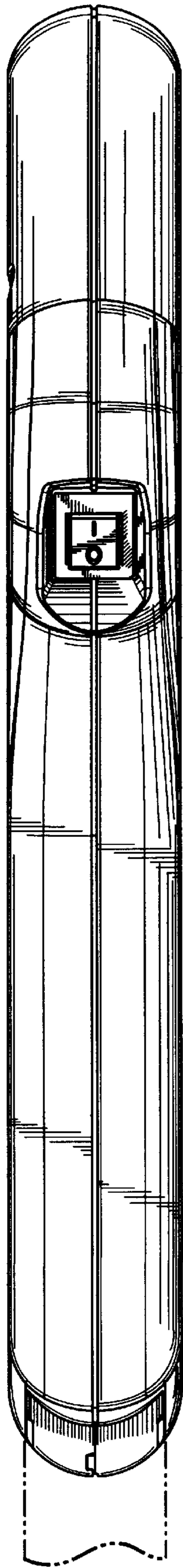

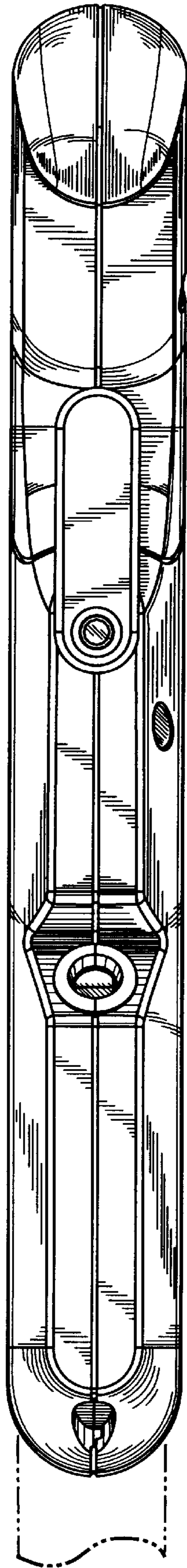
