FIG. 5 is a top view of a bicycle saddle, showing a preferred embodiment of our new ornamental design.

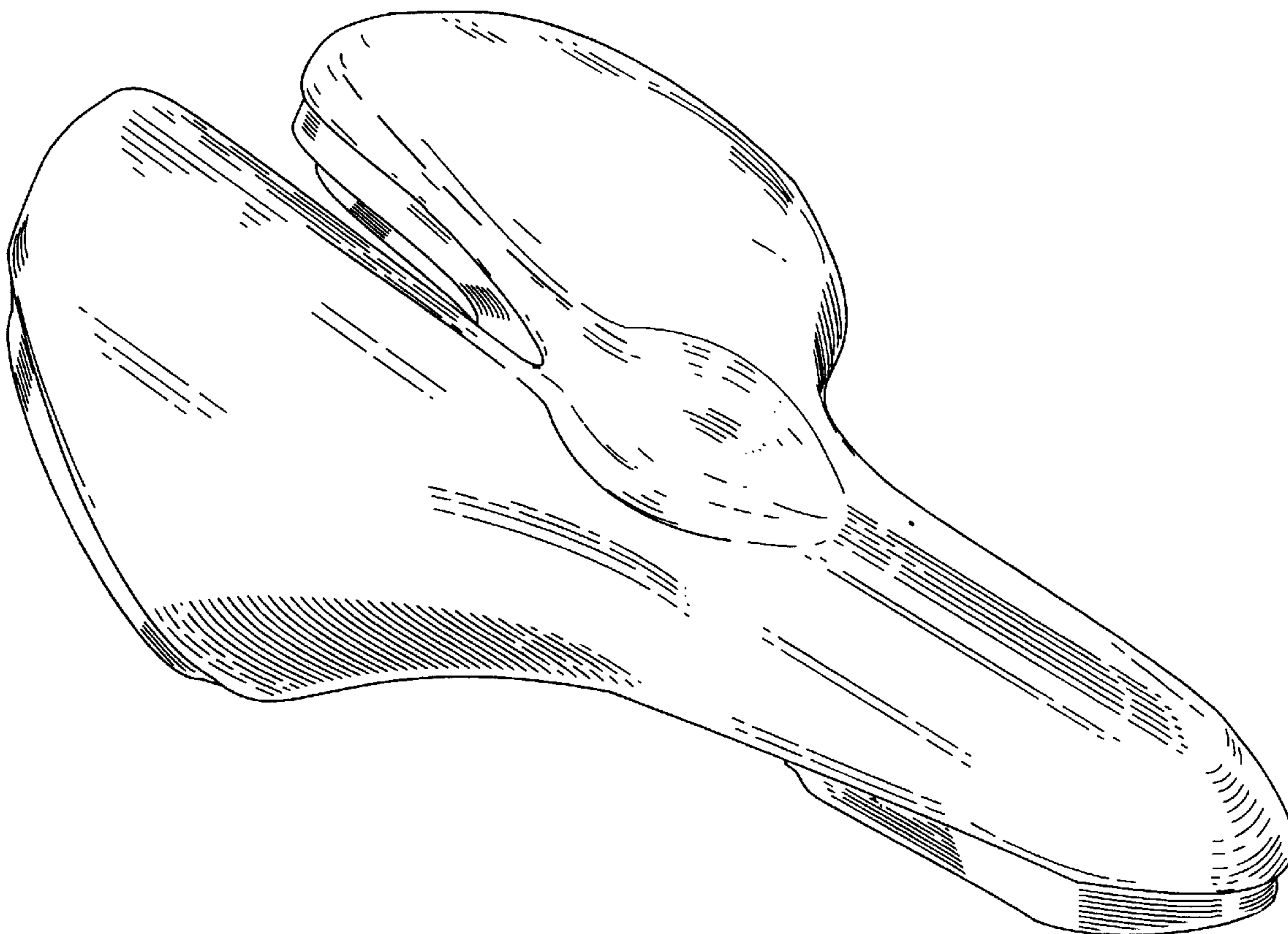
FIG. 6 is a bottom view of a bicycle saddle, showing a preferred embodiment of our new ornamental design.

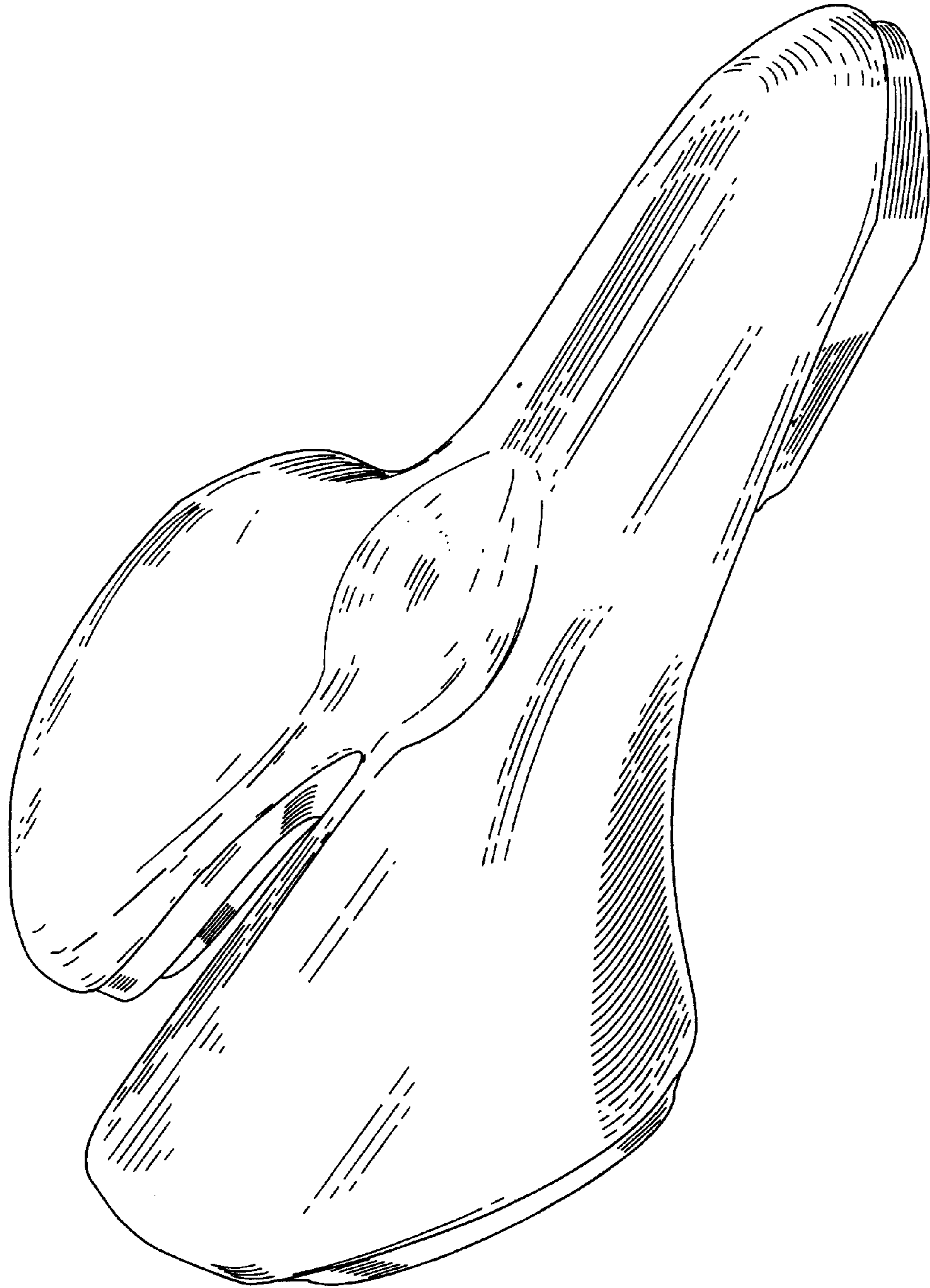

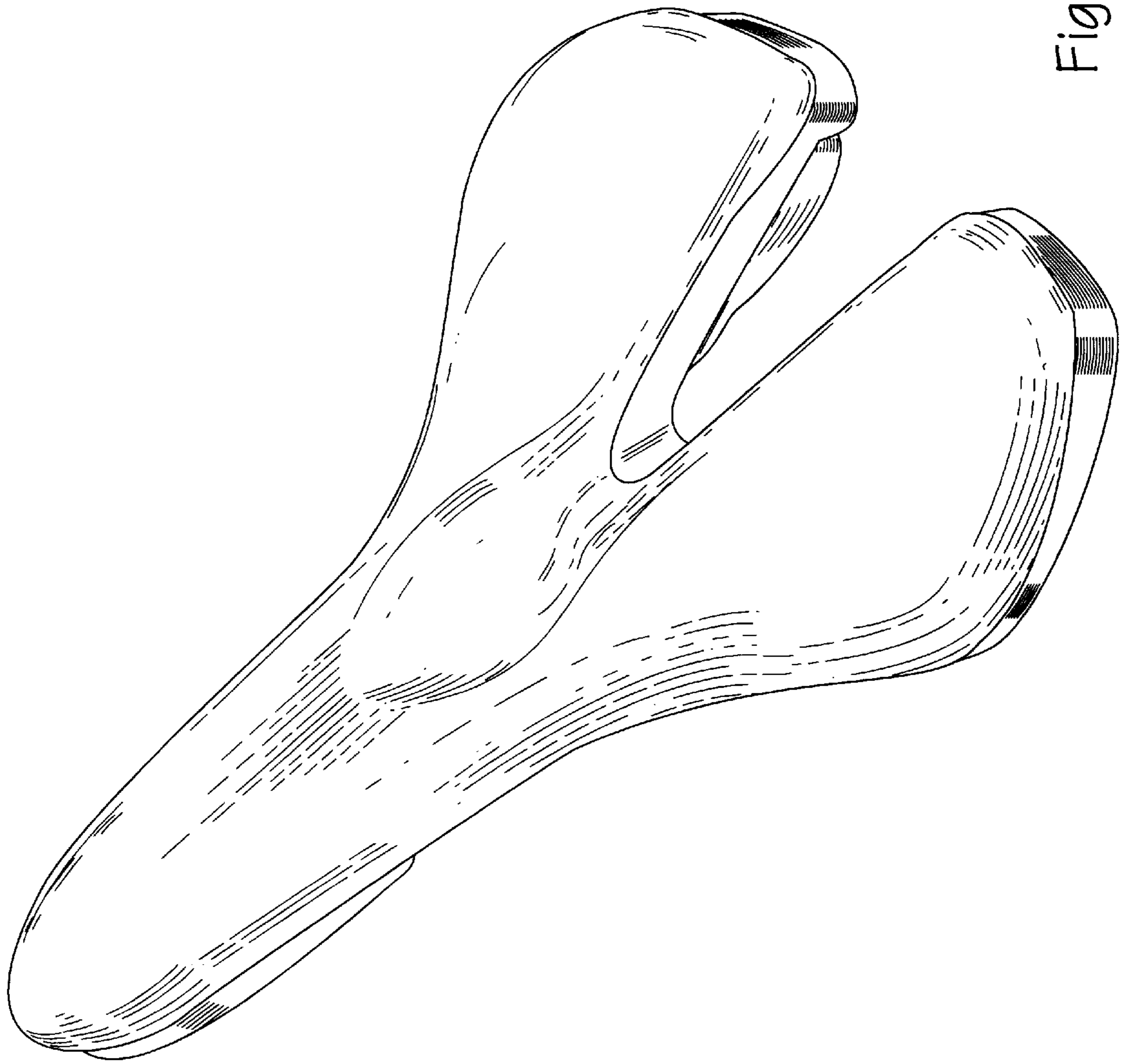

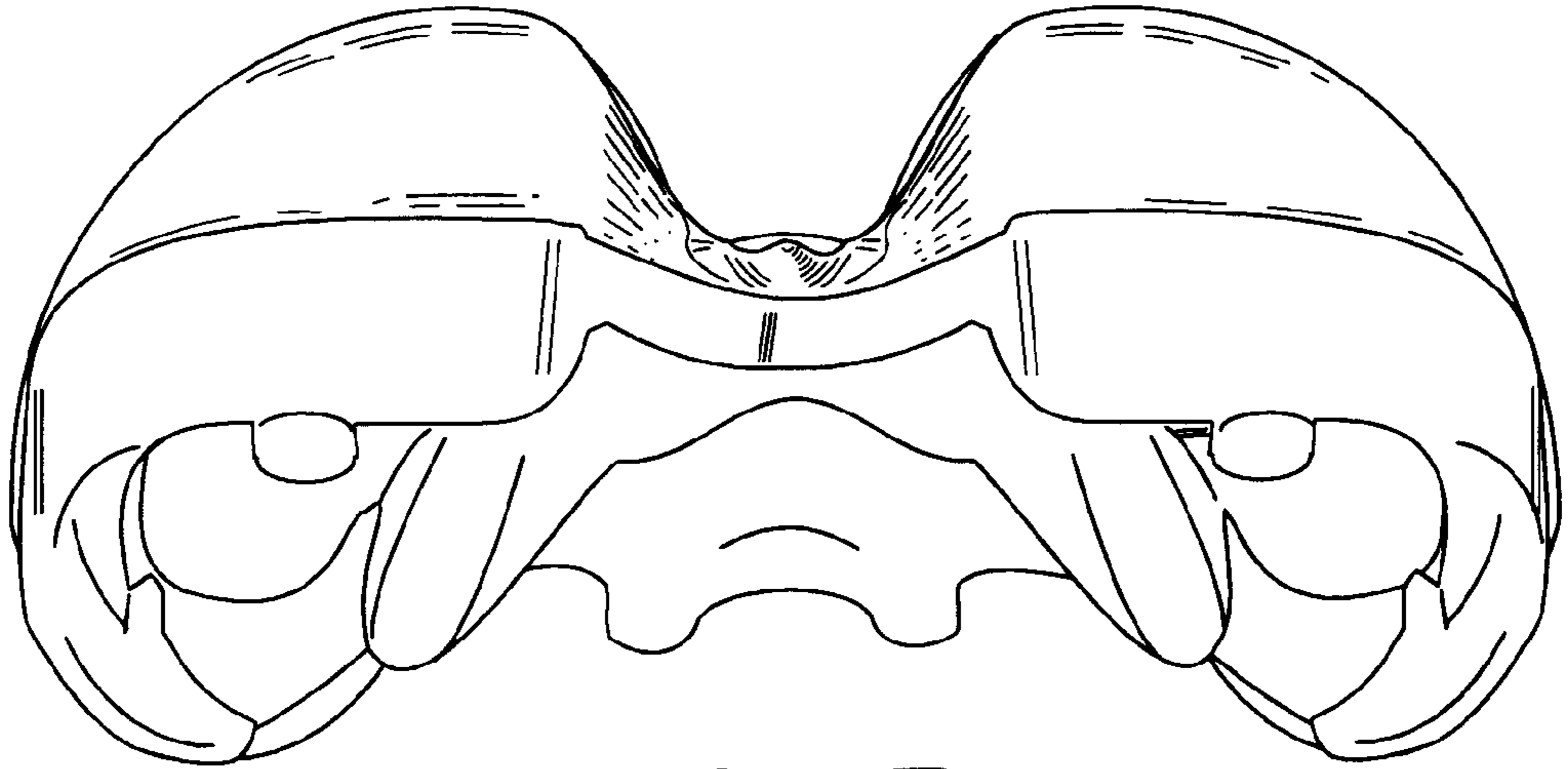

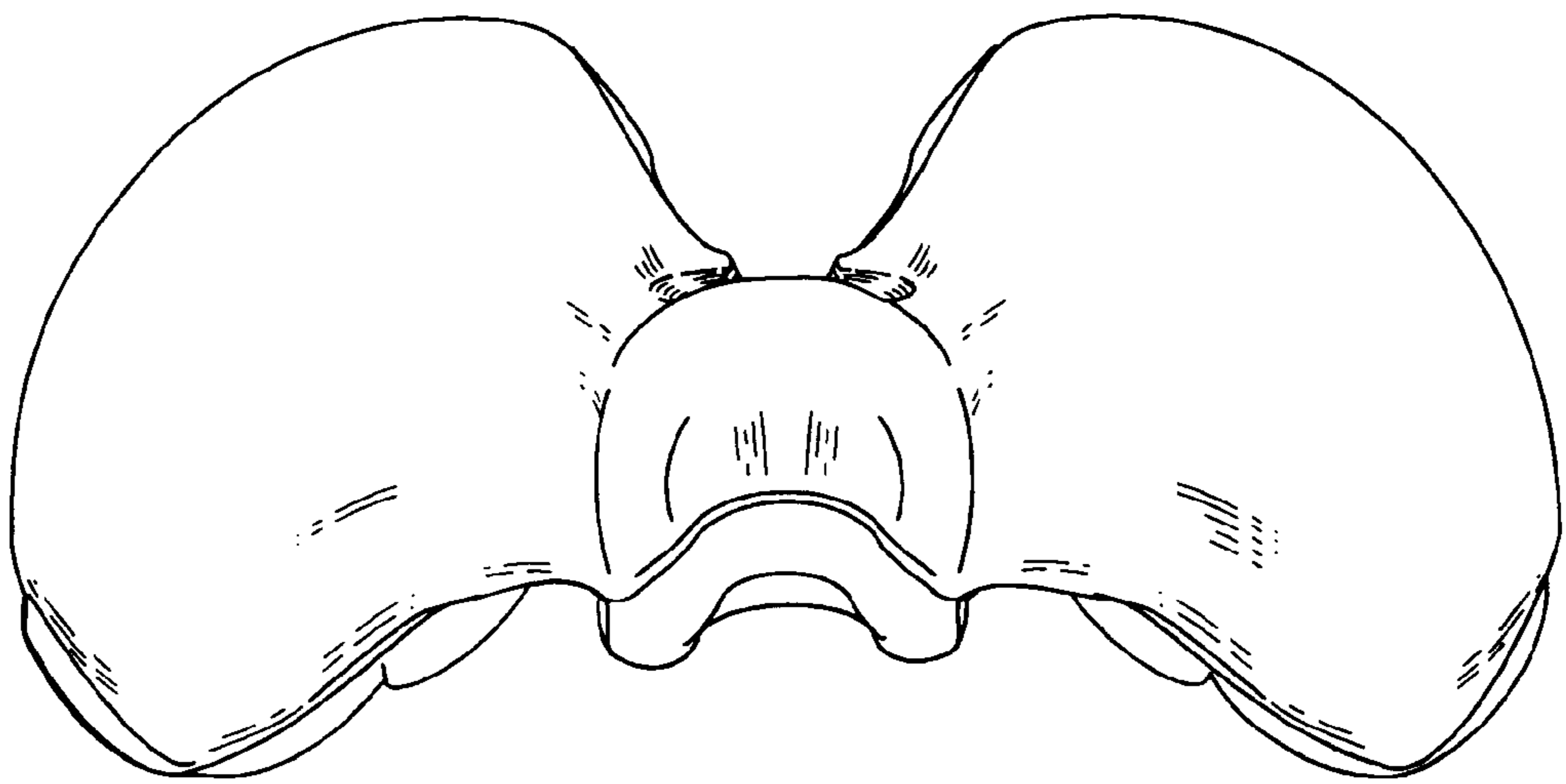

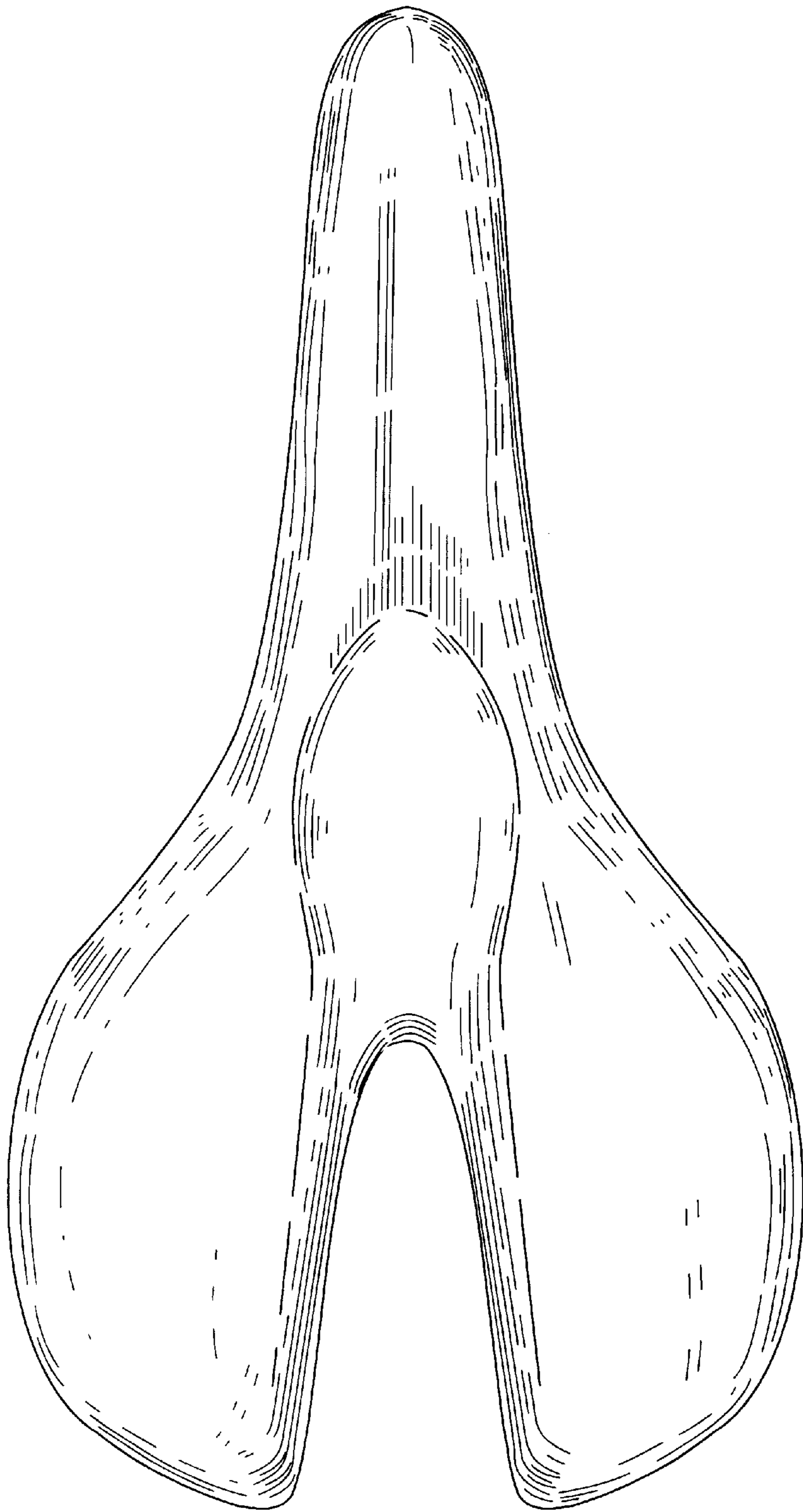

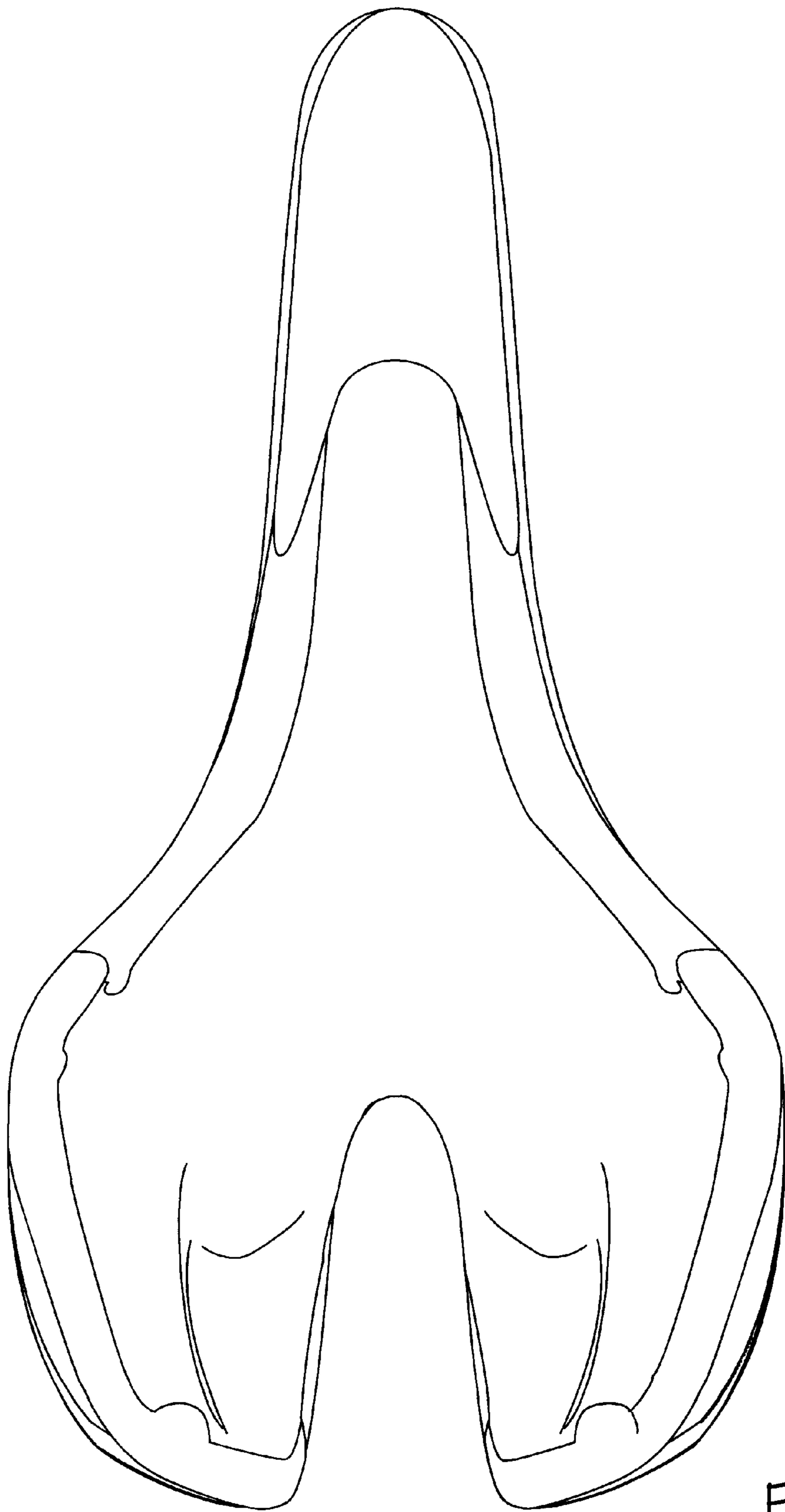

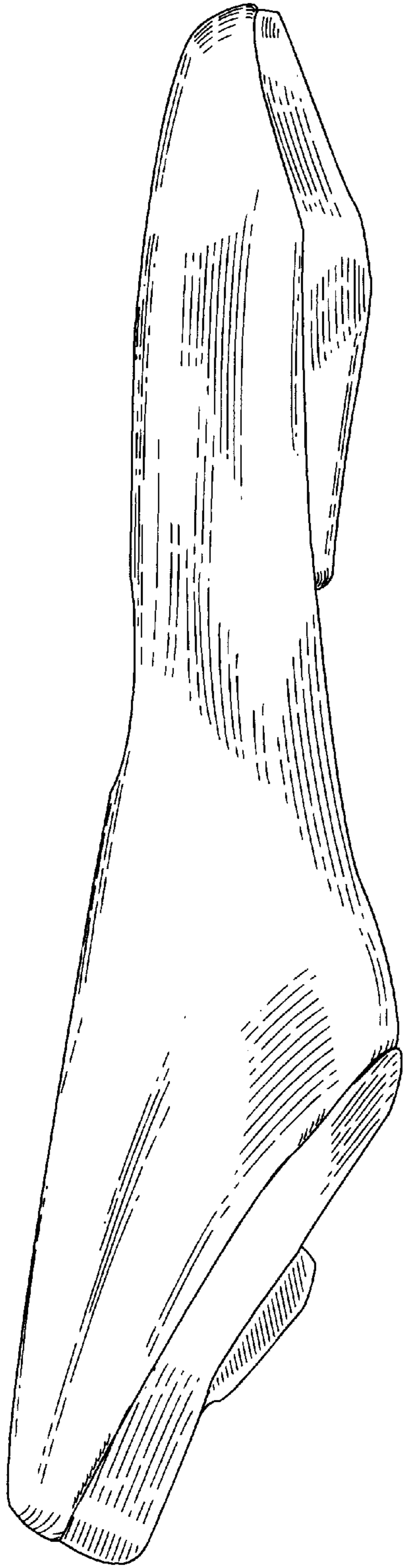

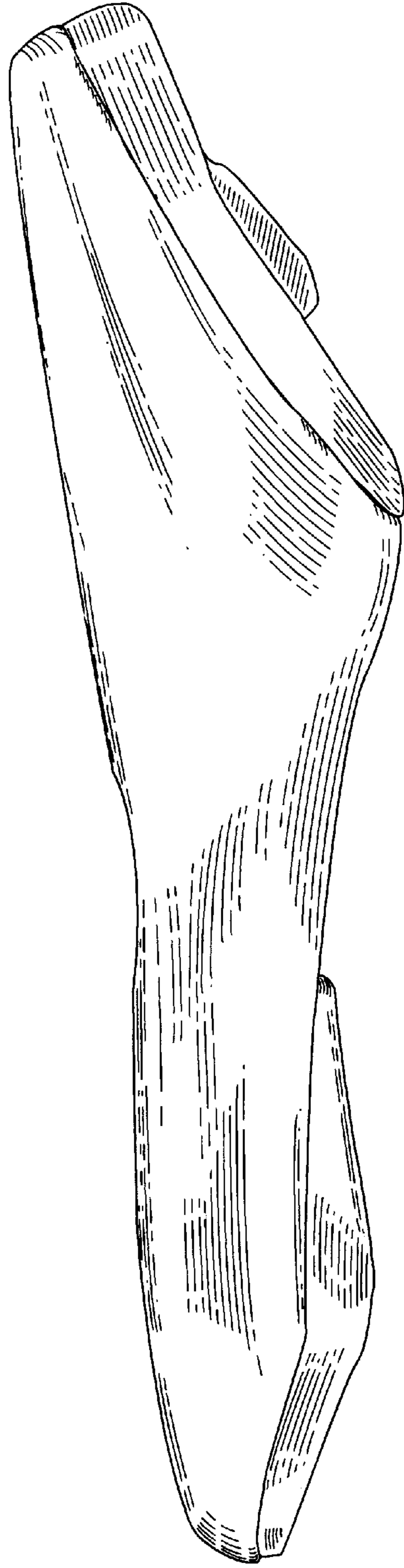
