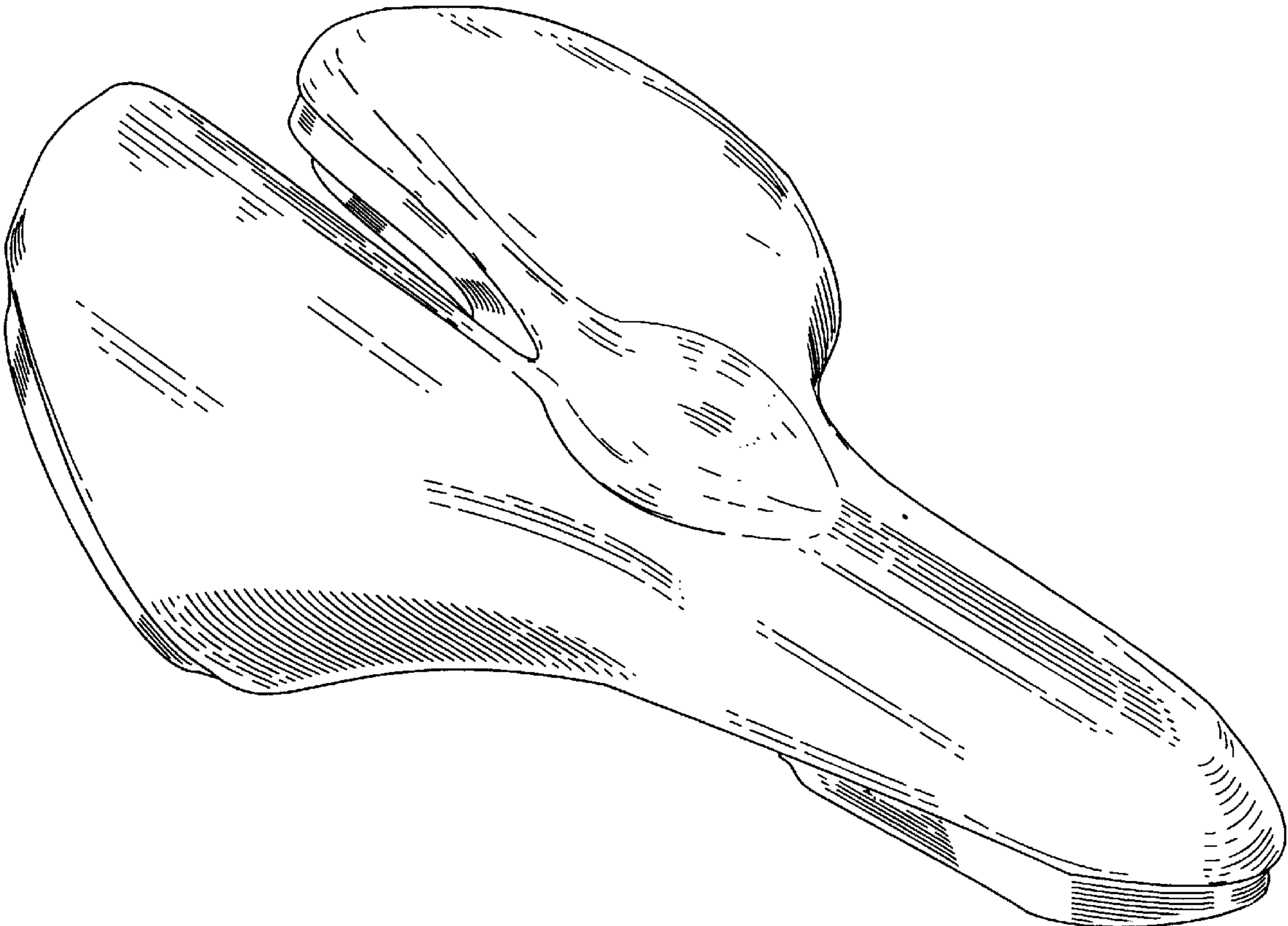
The ornamental design for a bicycle saddle, as shown and described.

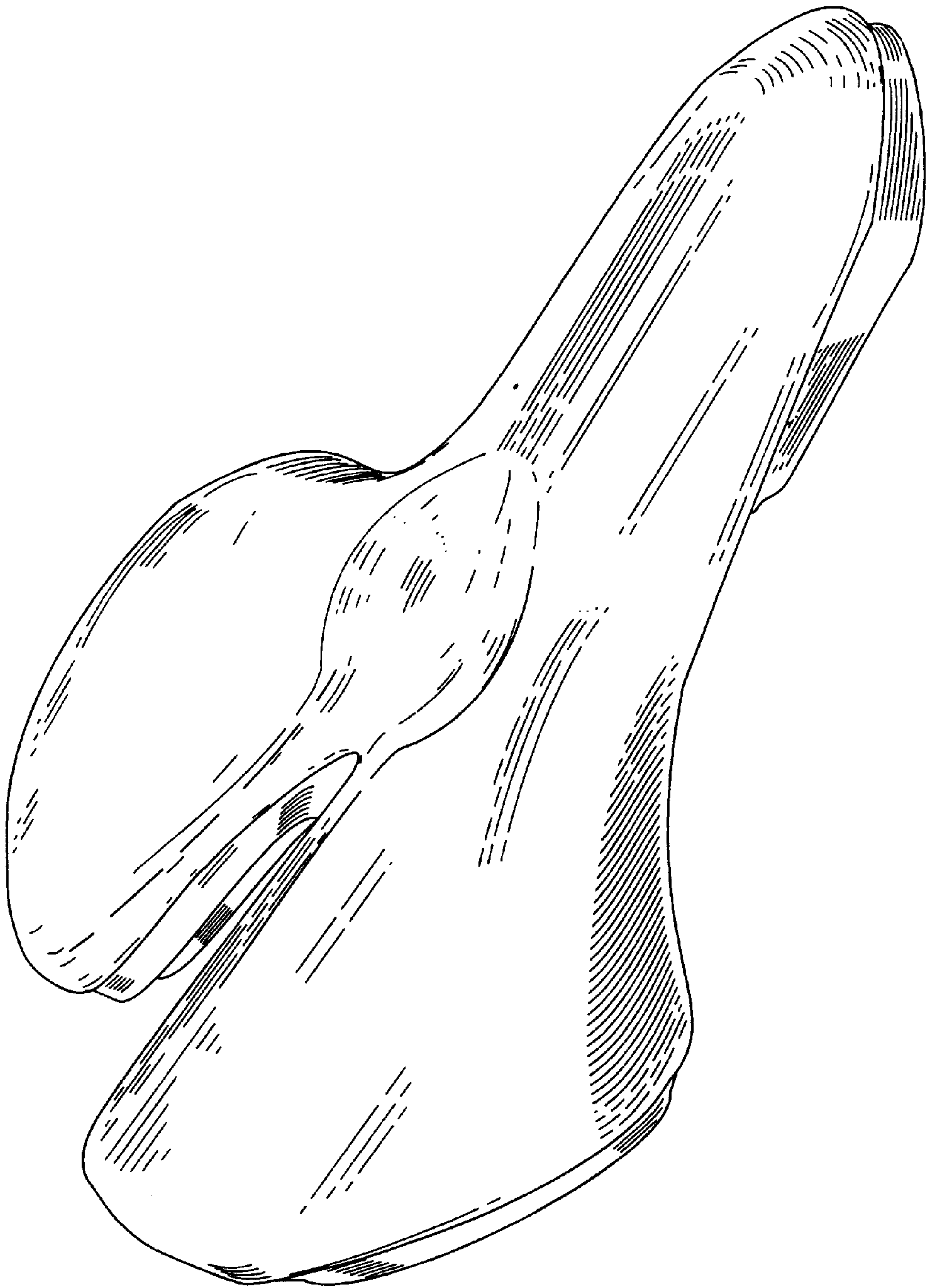

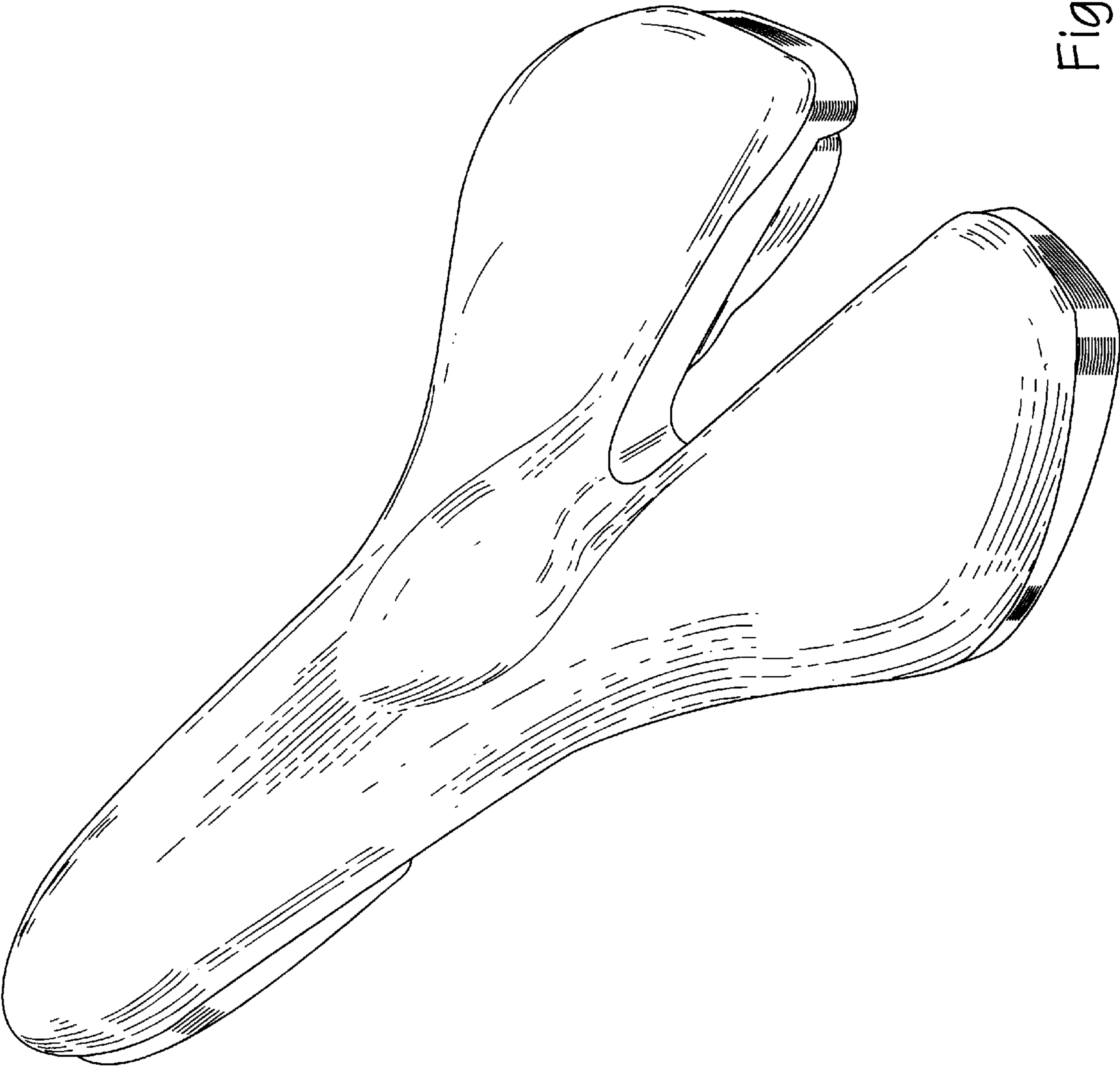

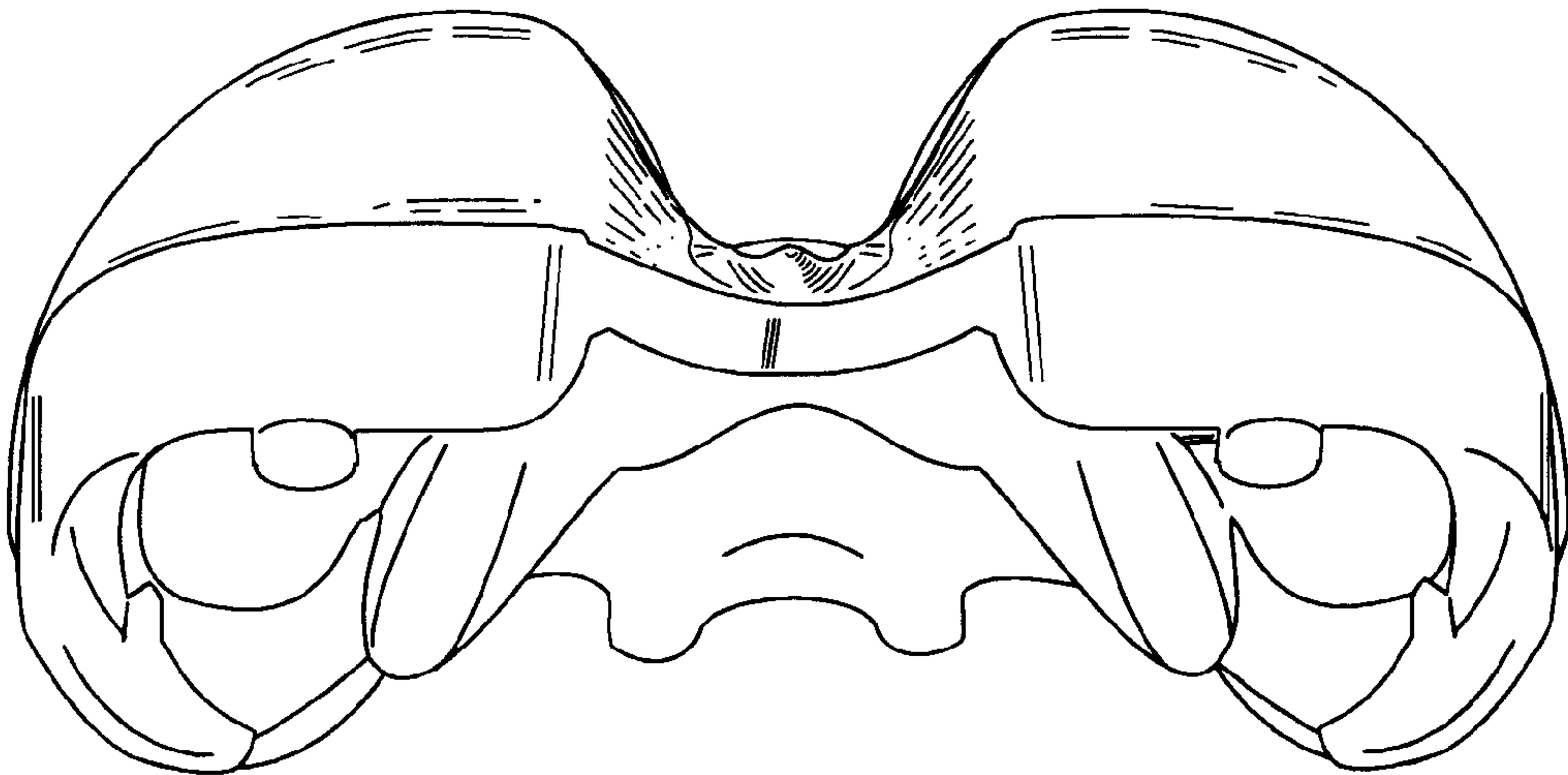

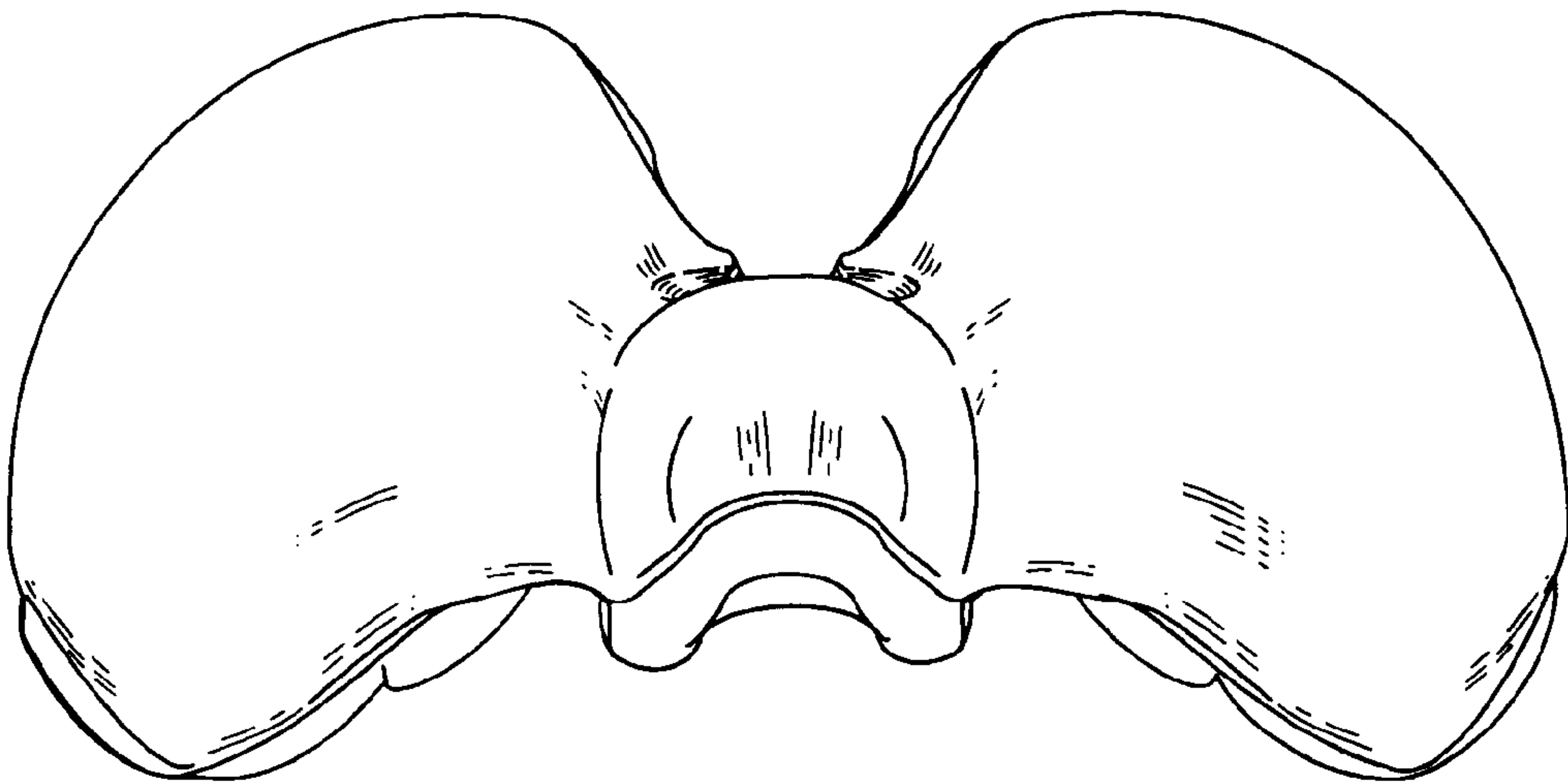

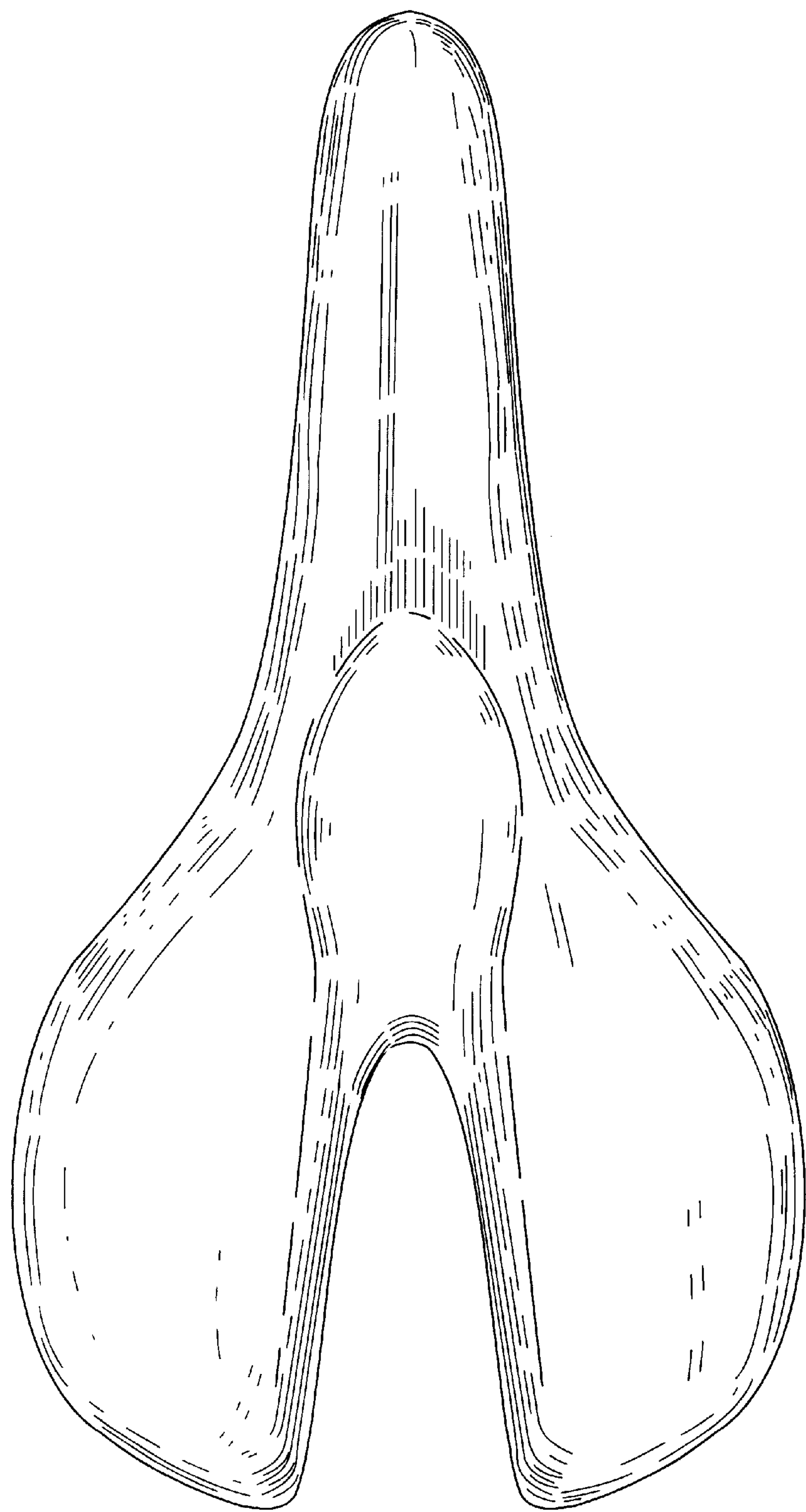

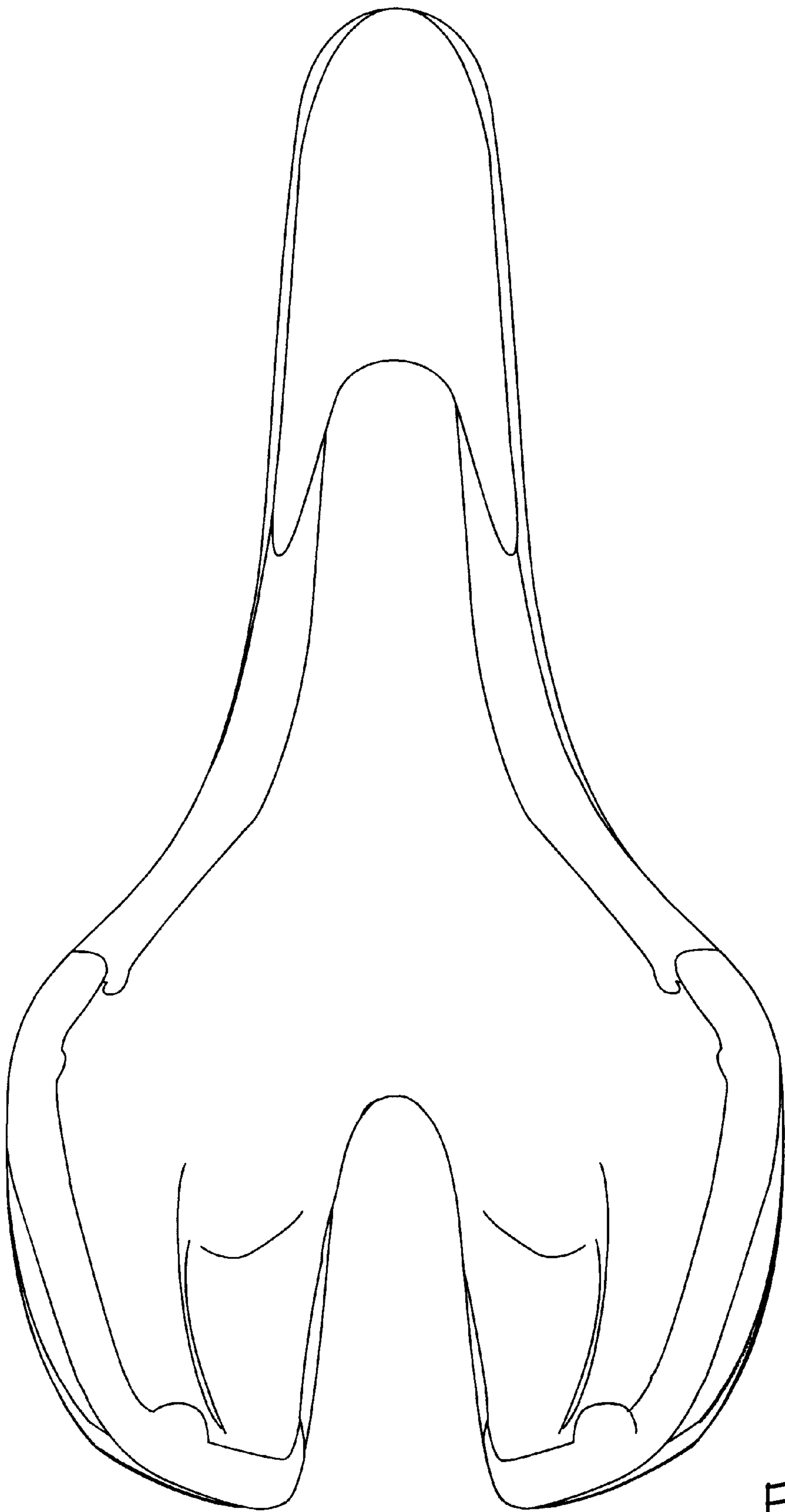

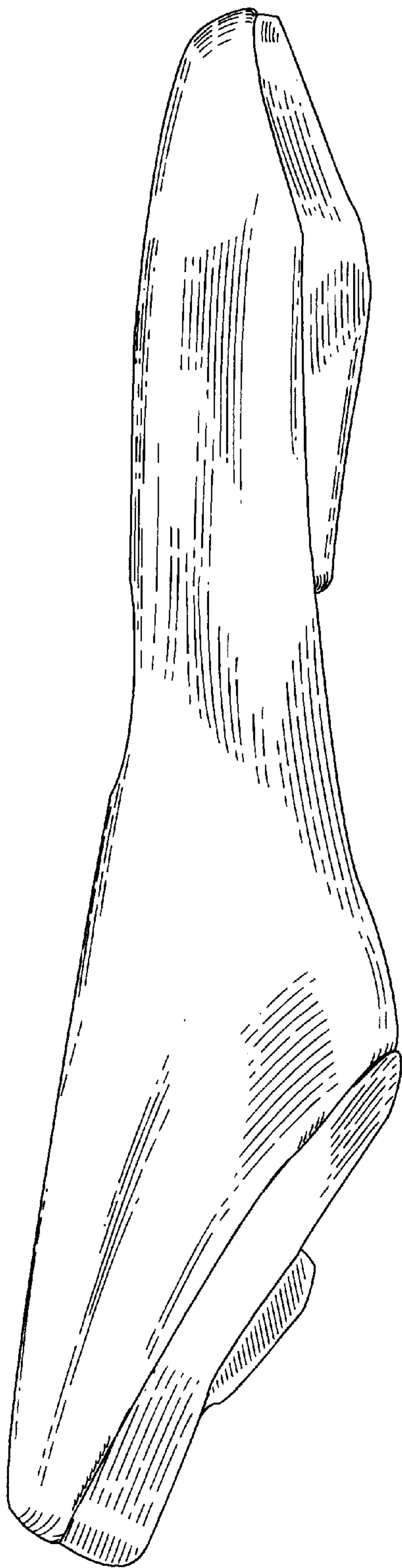

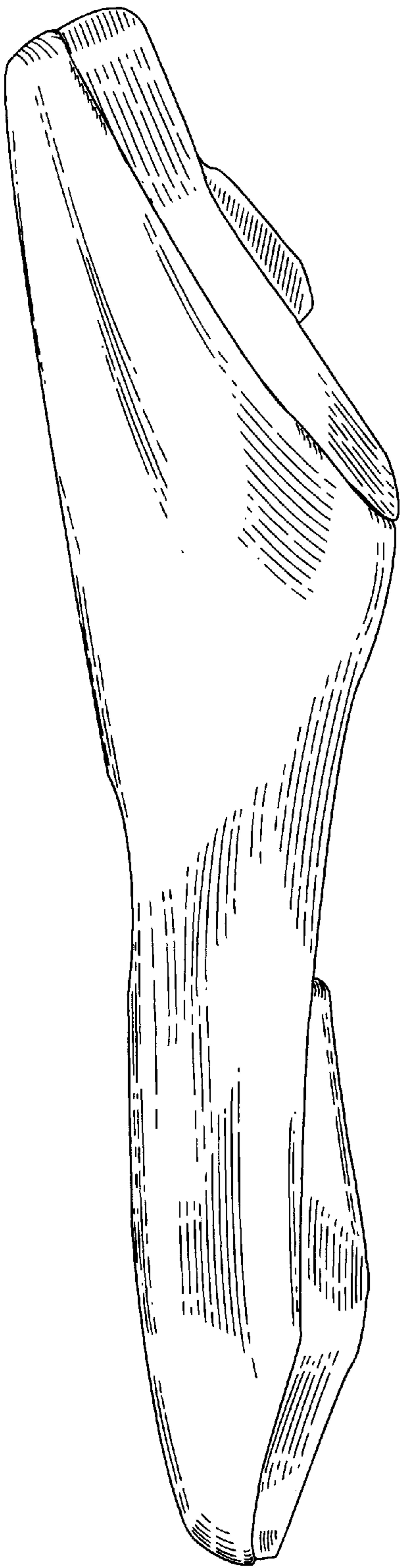
