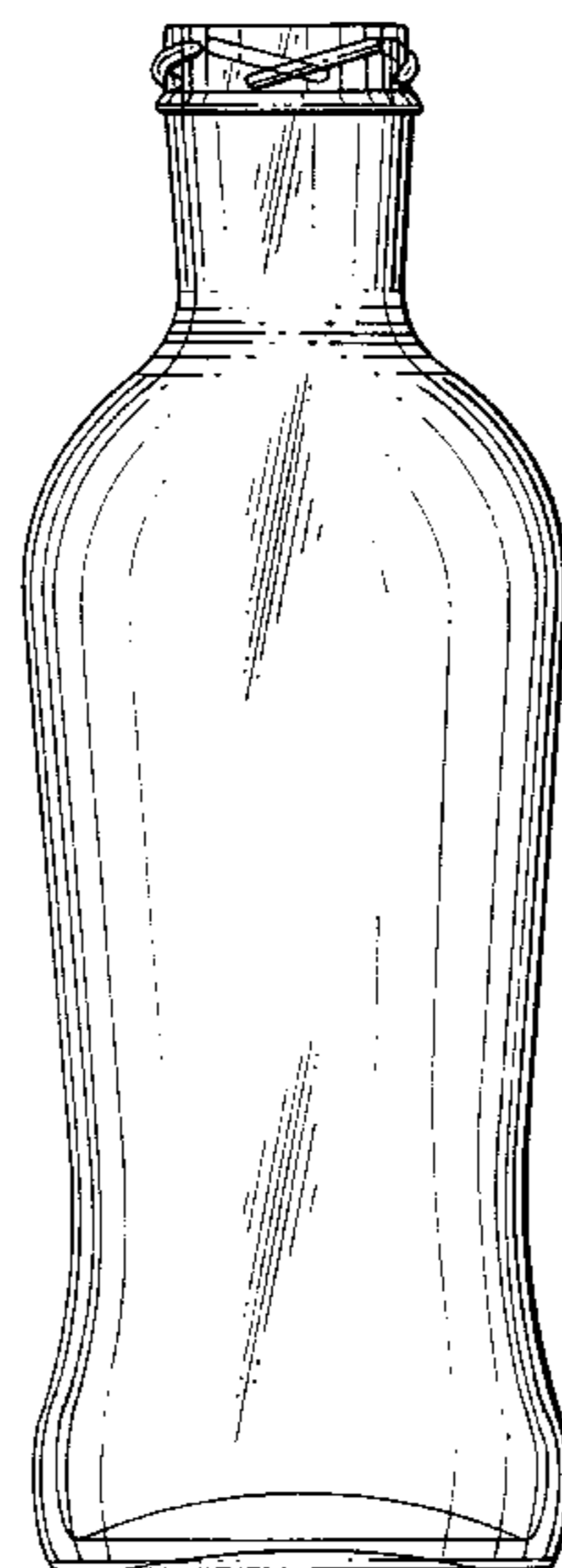
### [57] CLAIM

The ornamental design for a bottle, as shown and described.

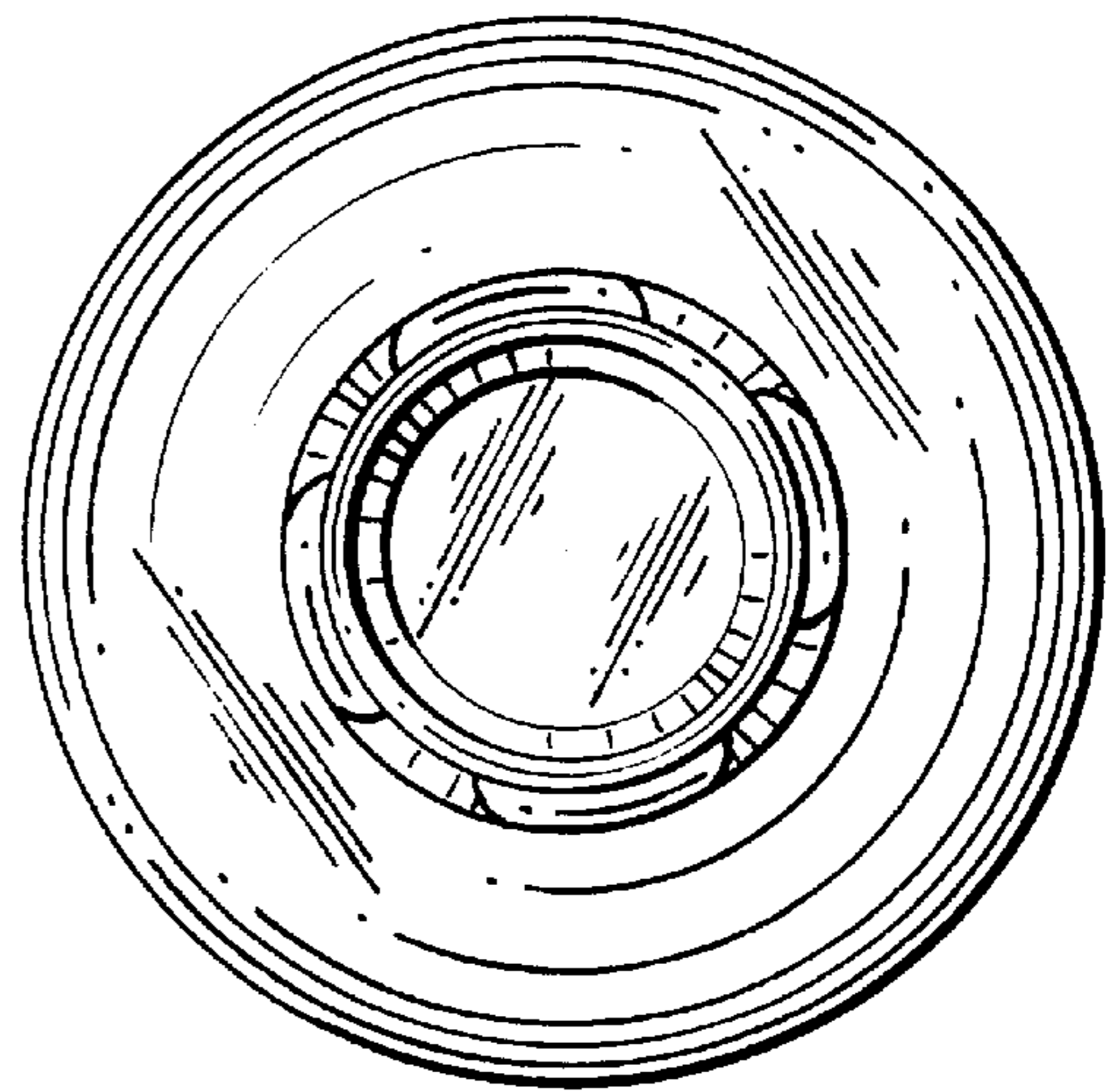
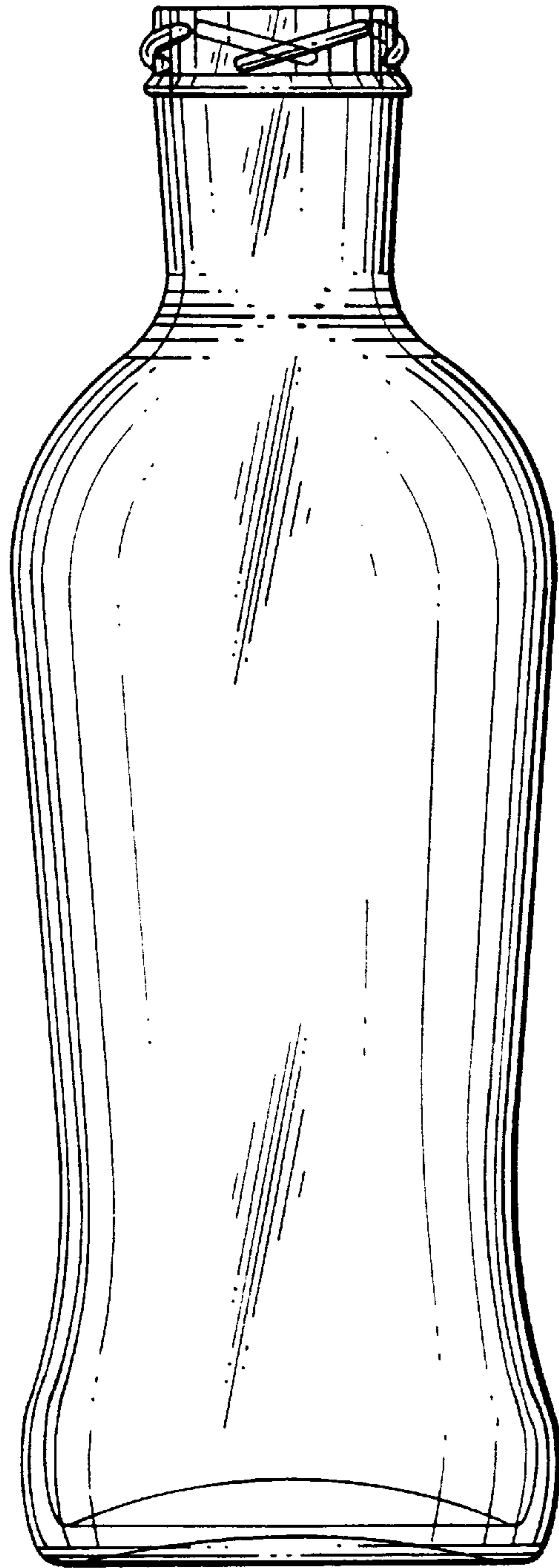
### DESCRIPTION

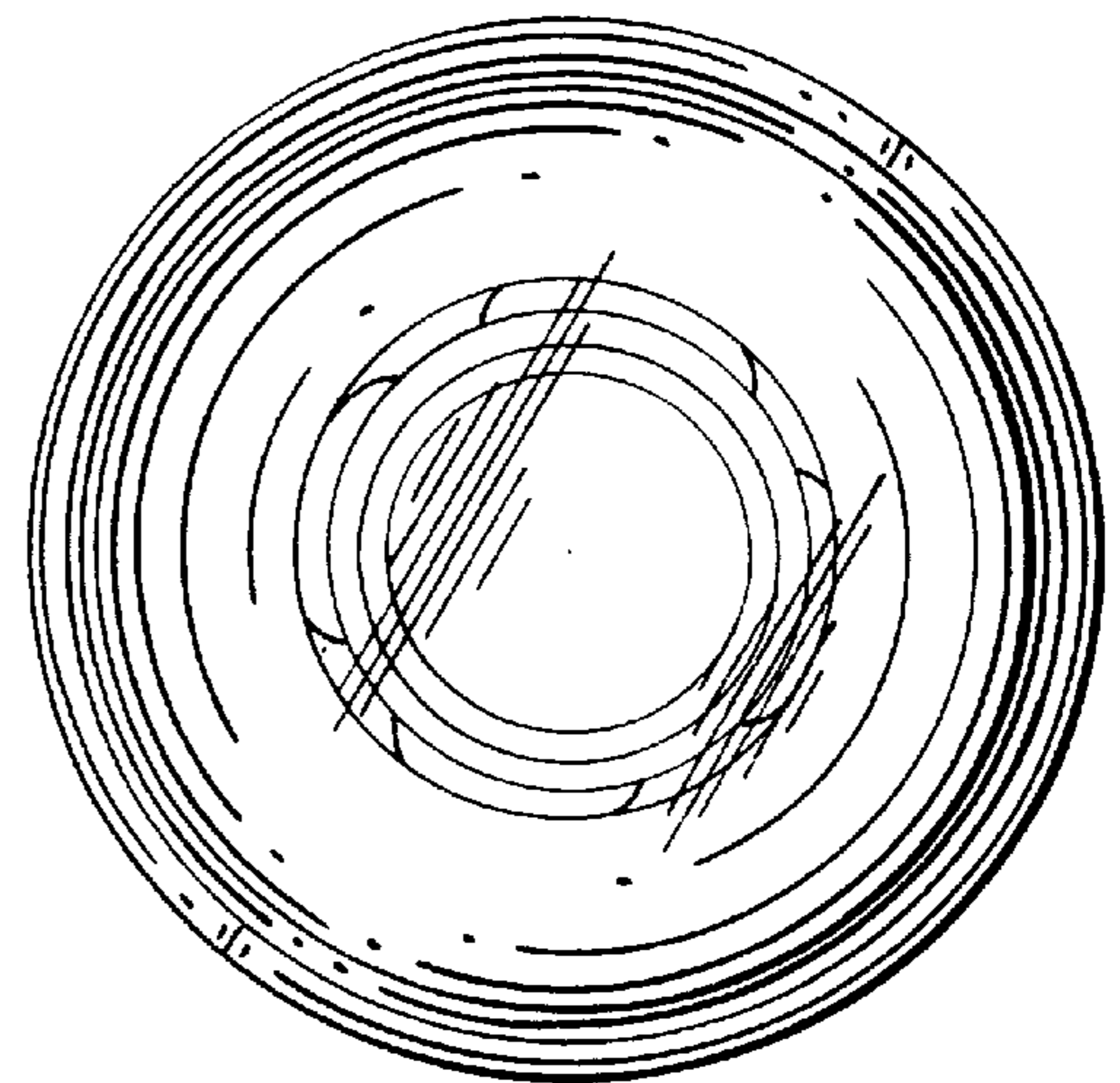
