The ornamental design for a cork extractor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cork extractor showing my new design;

FIG. 2 is a right side view thereof, the left side being a mirror image;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a right side view of a second embodiment showing my new design, the left side view being a mirror image;

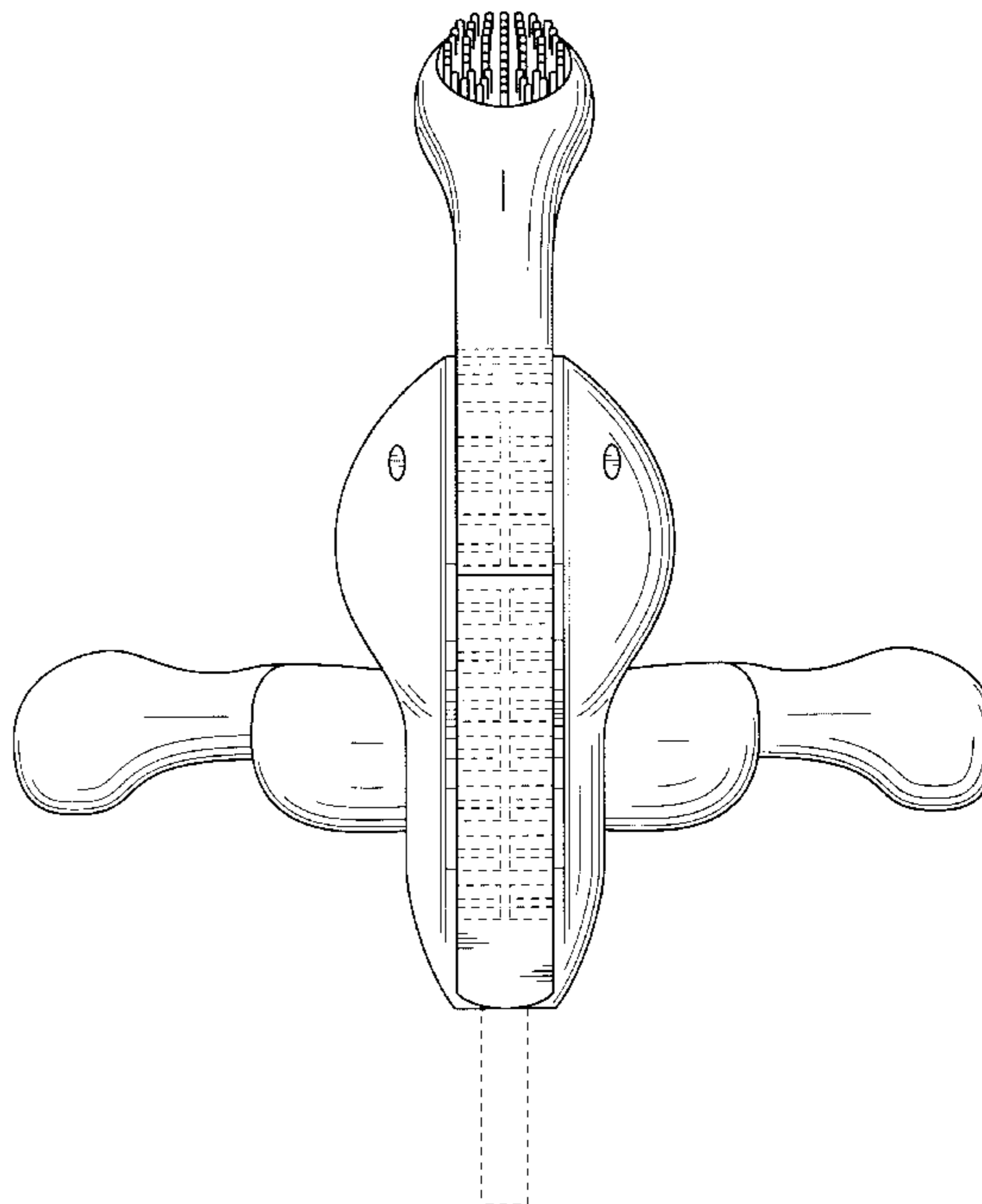
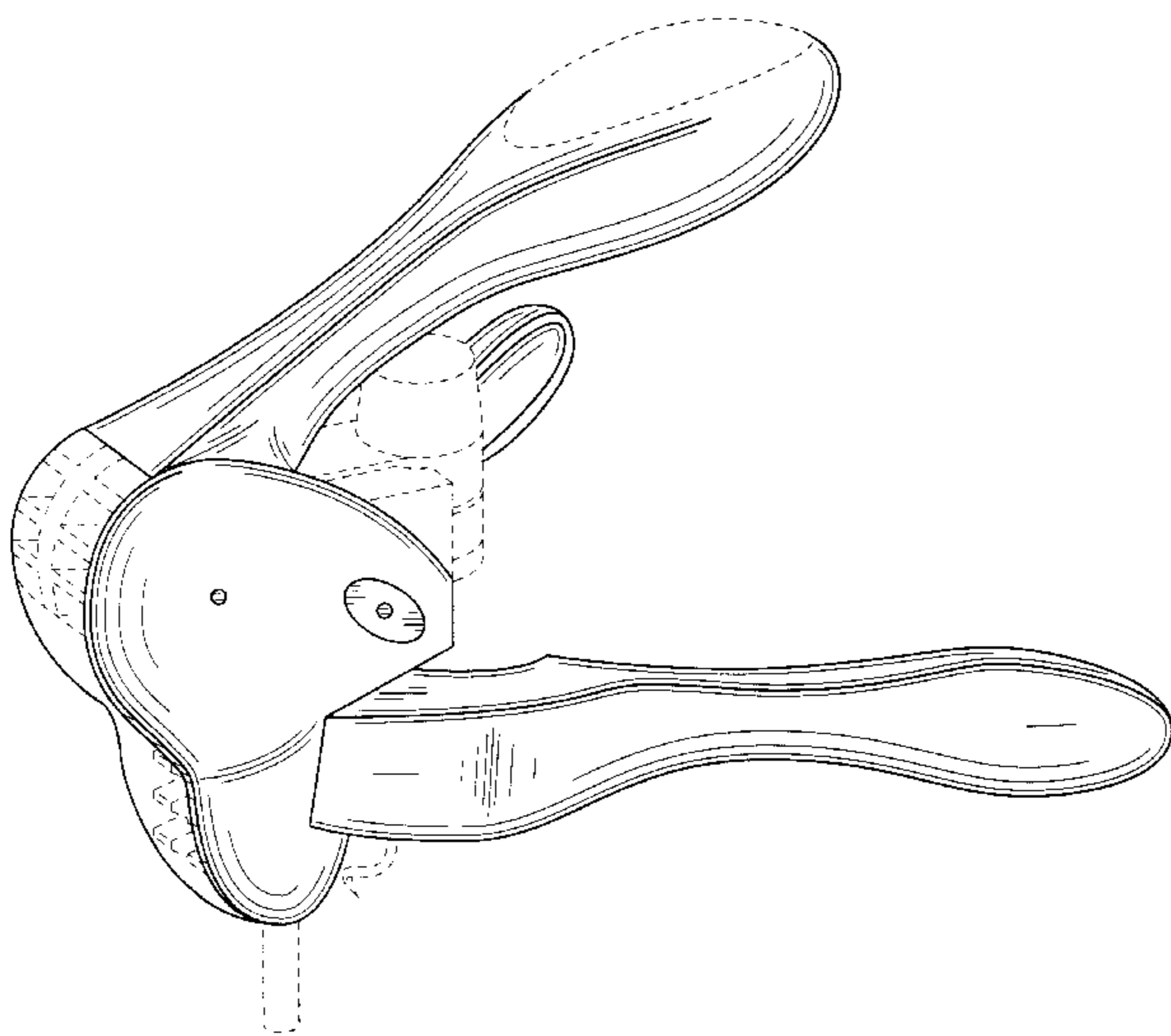
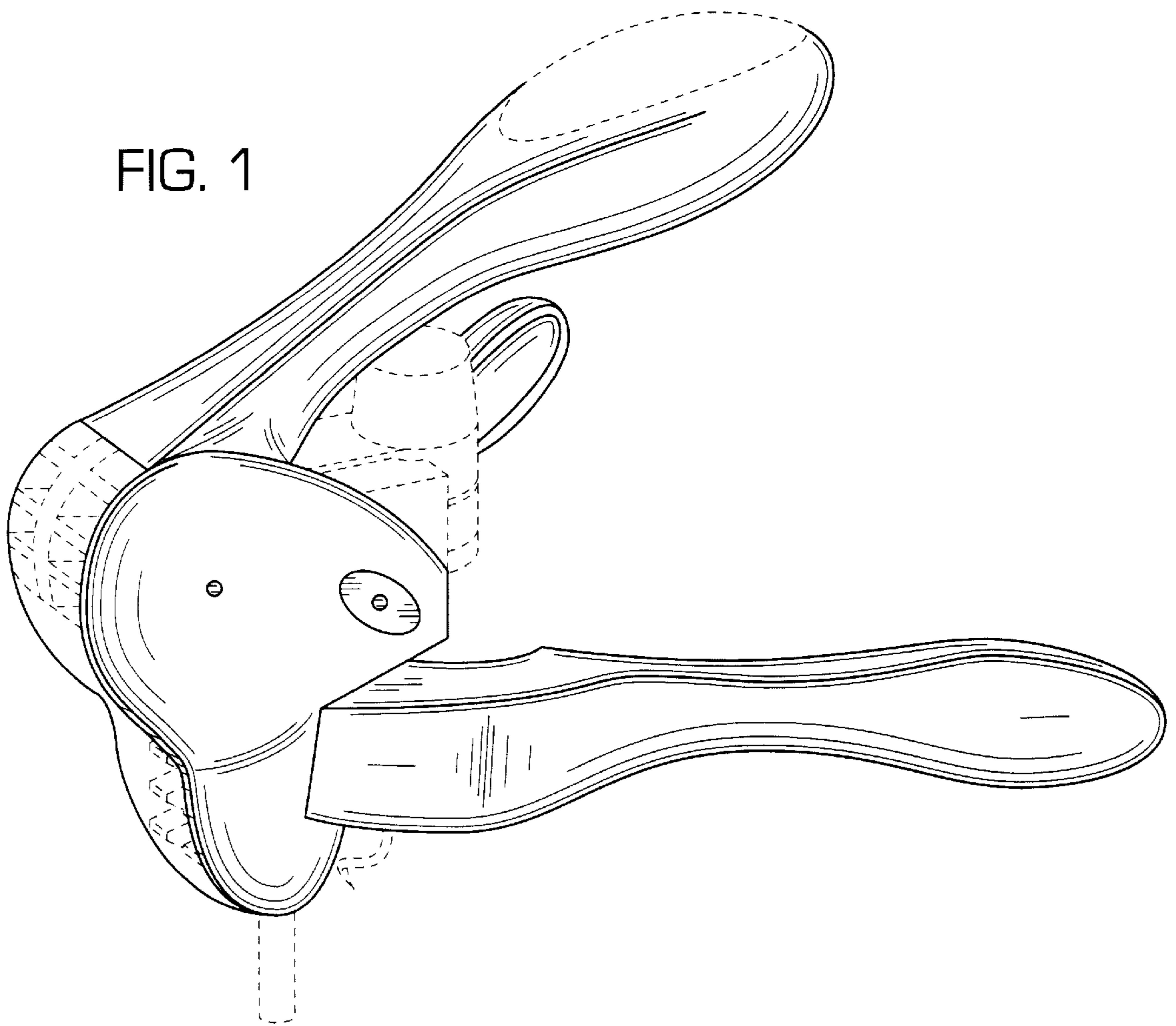

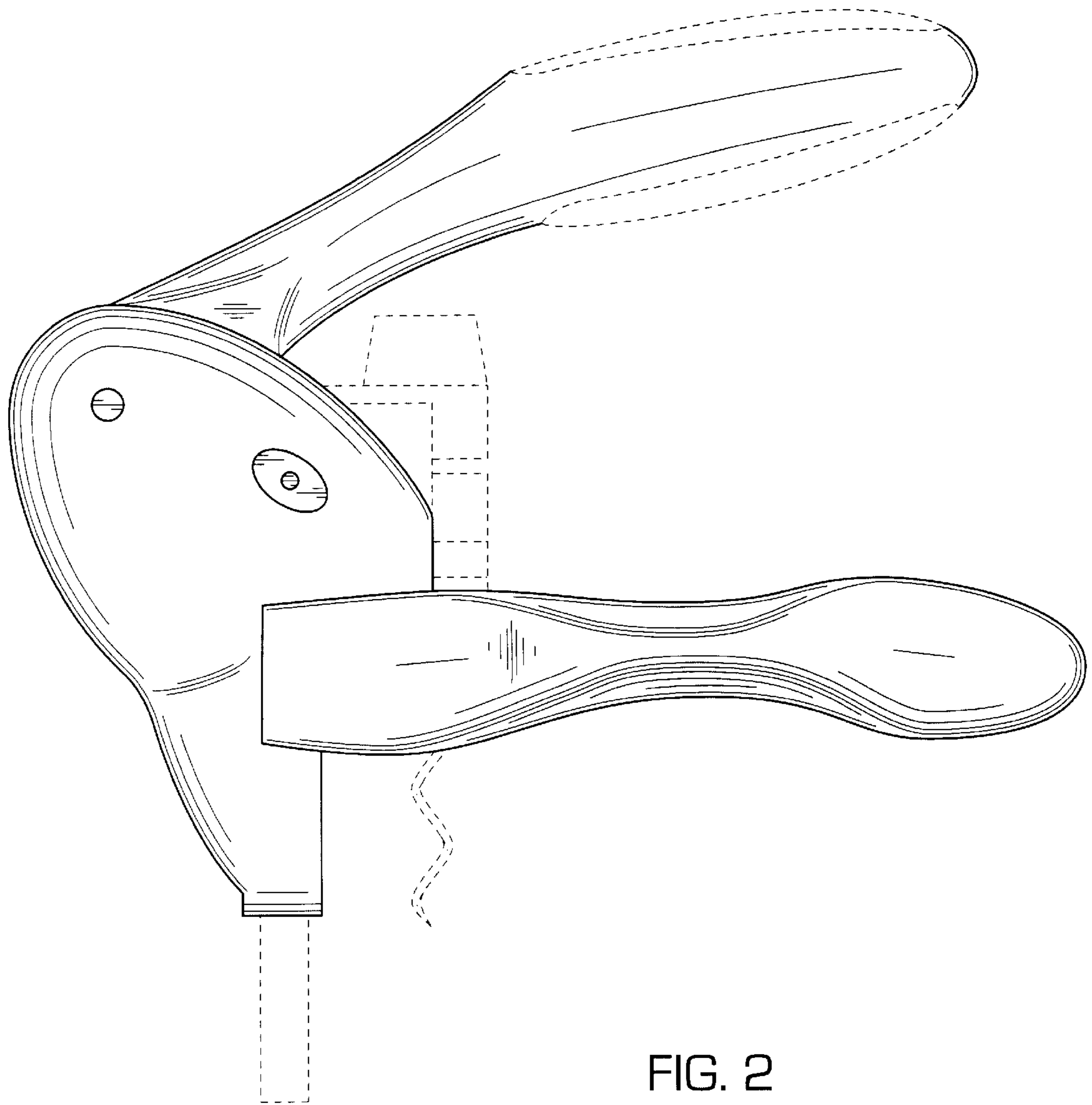

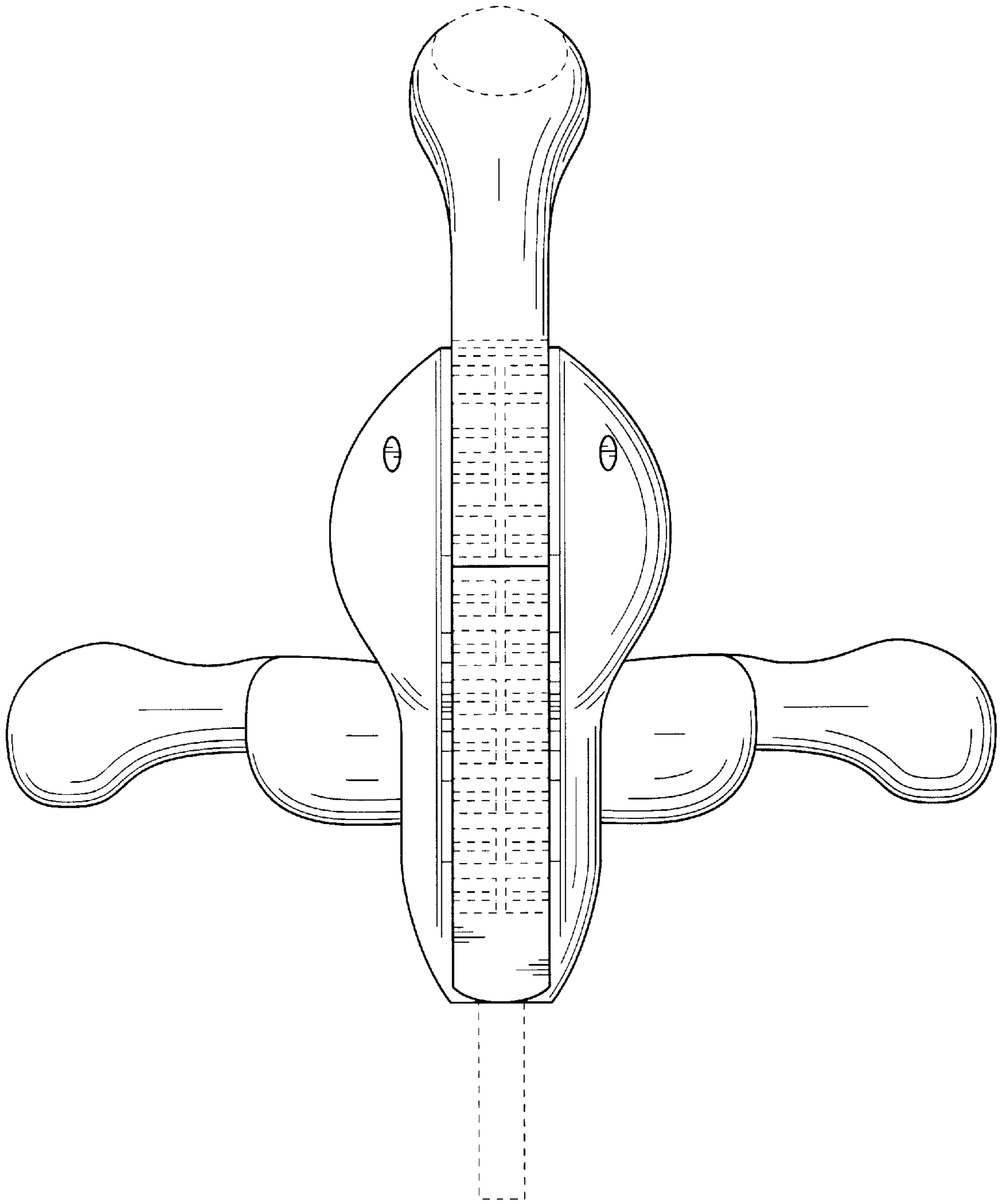

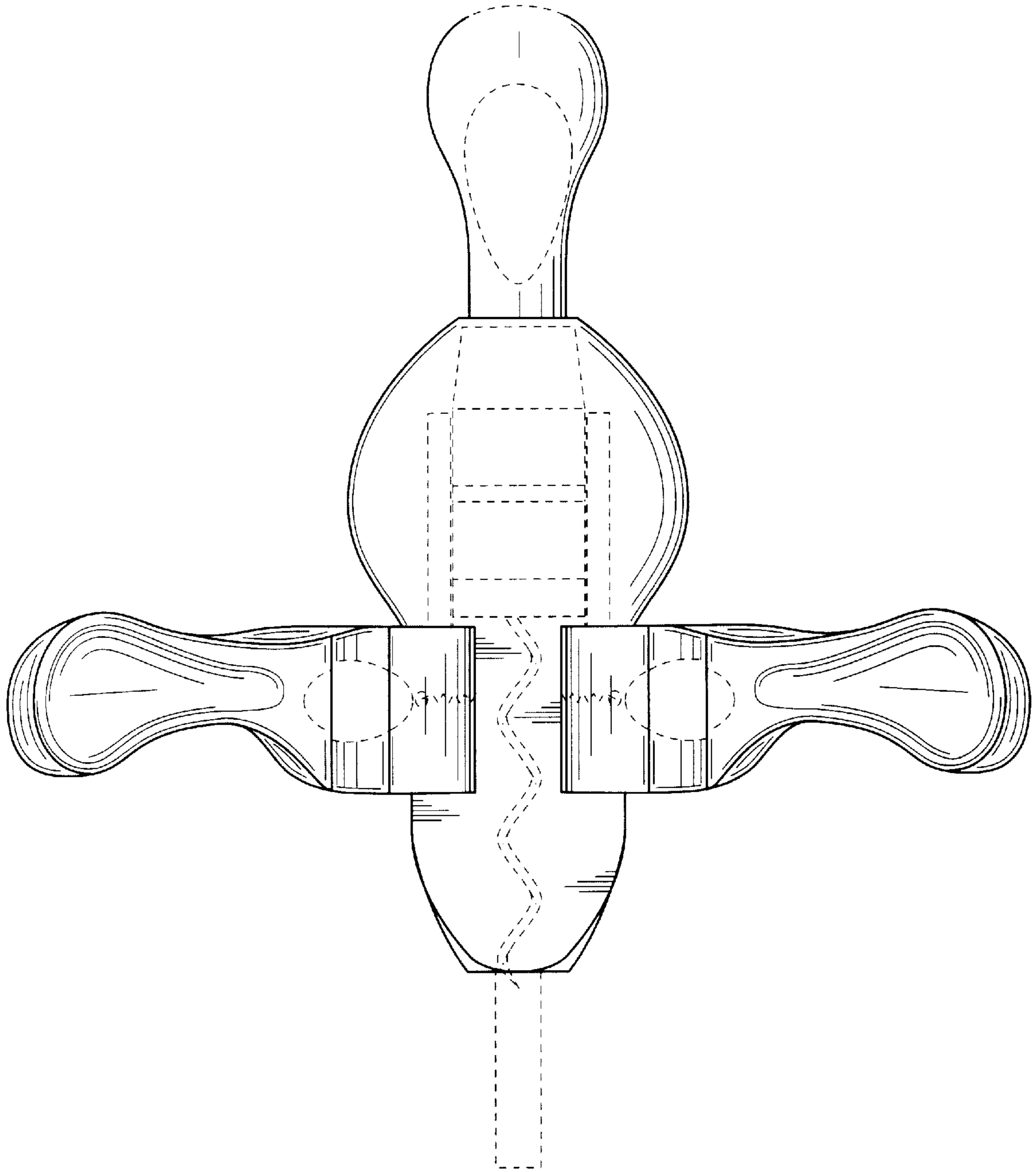

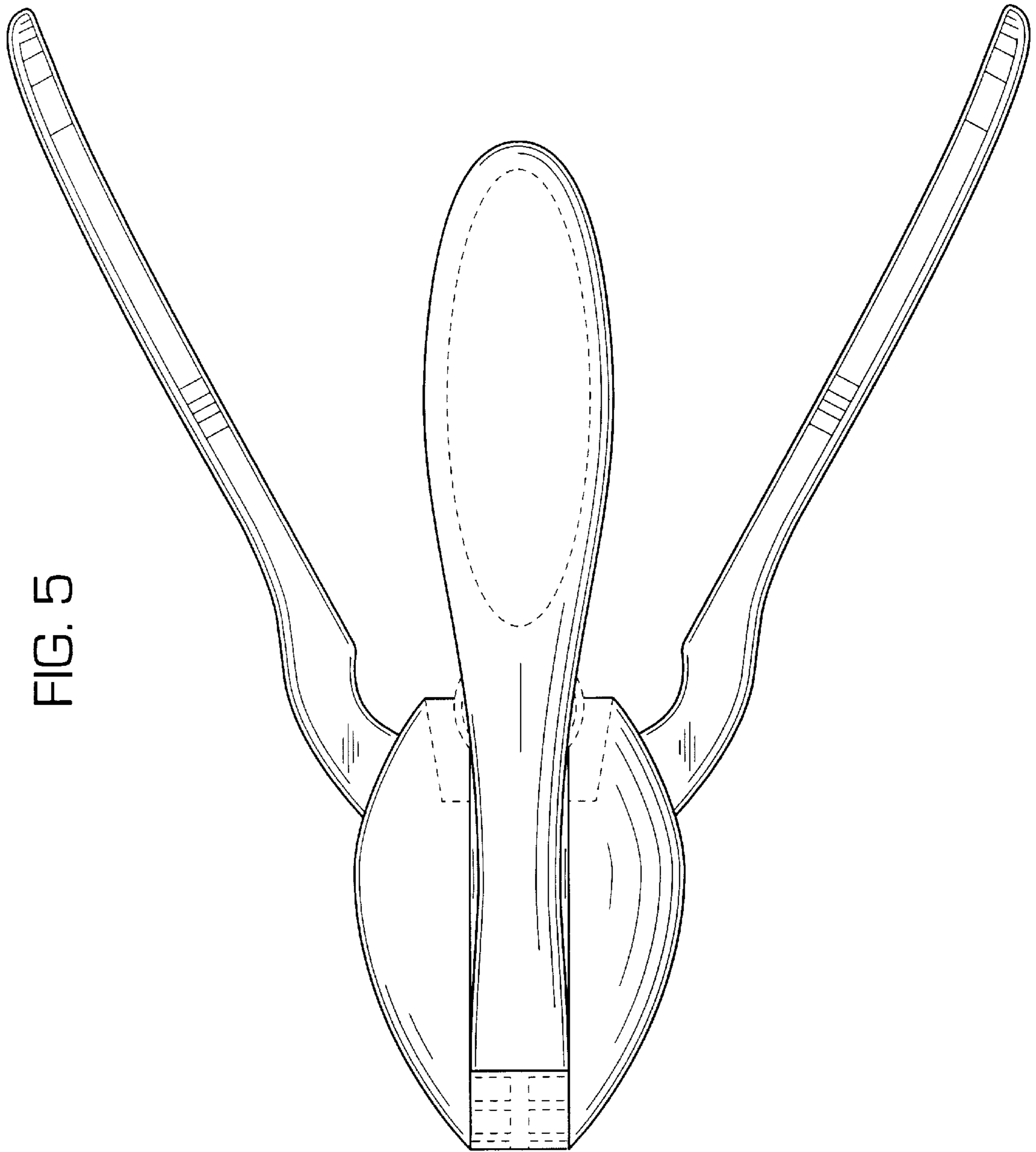

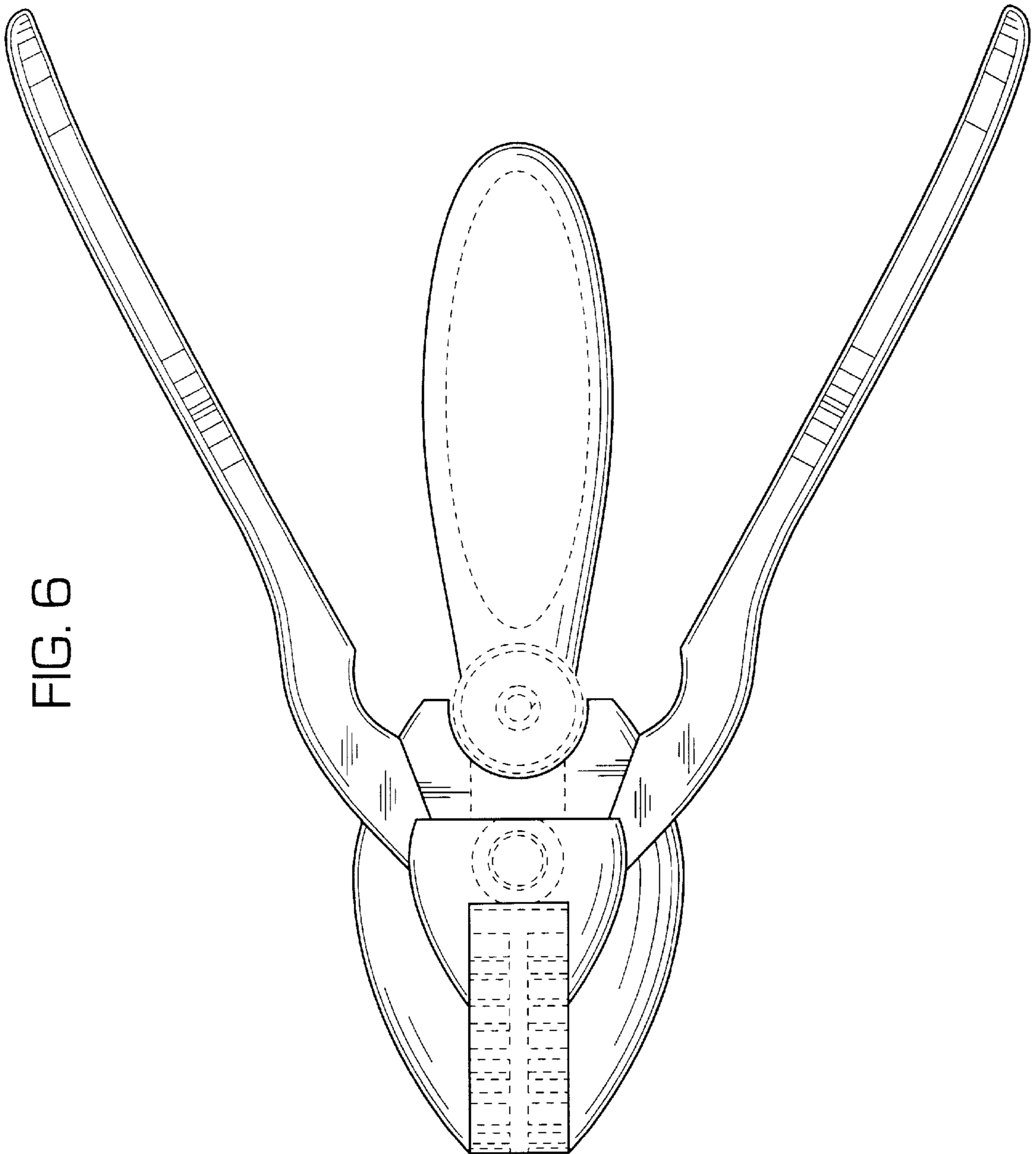
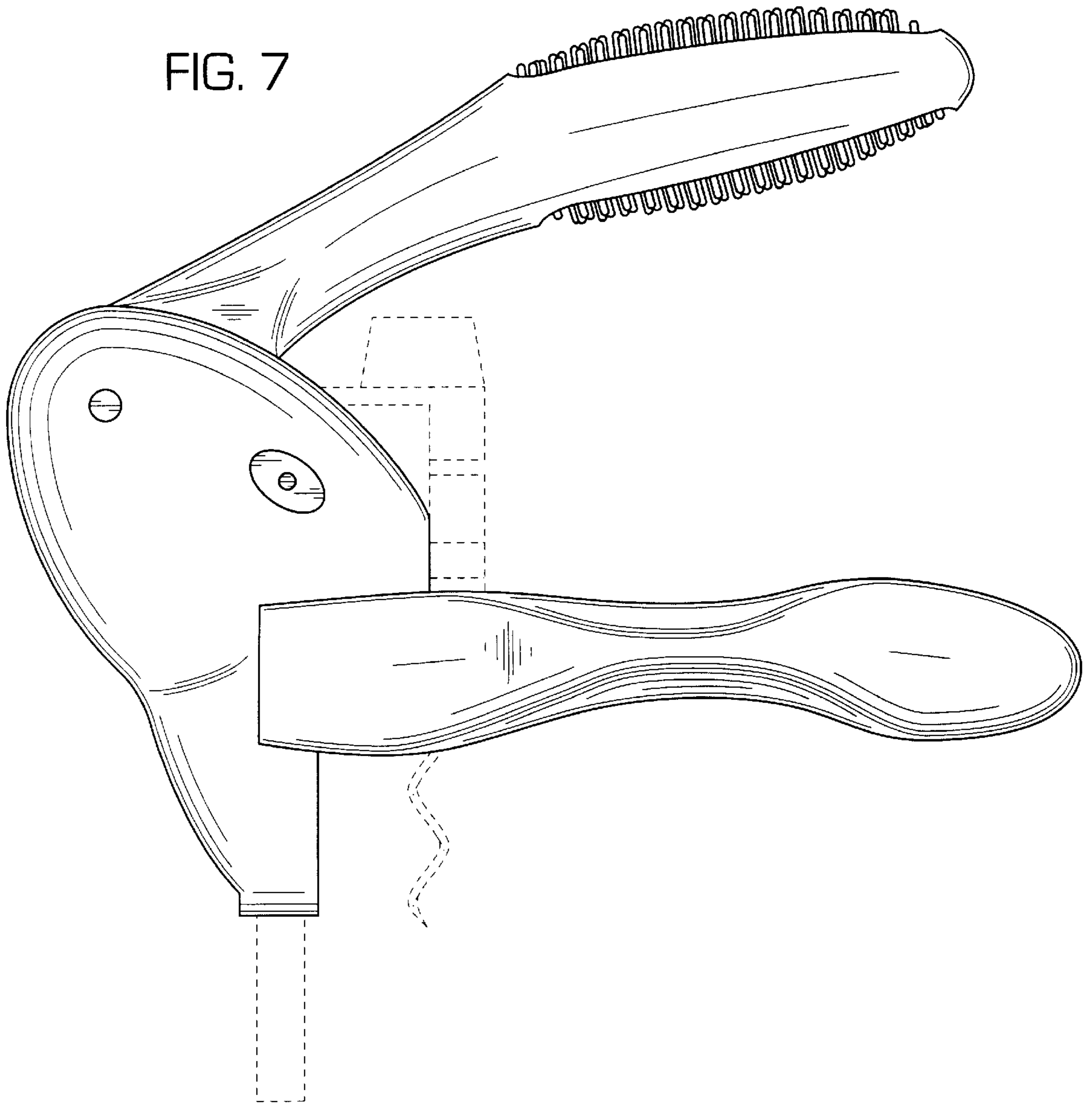

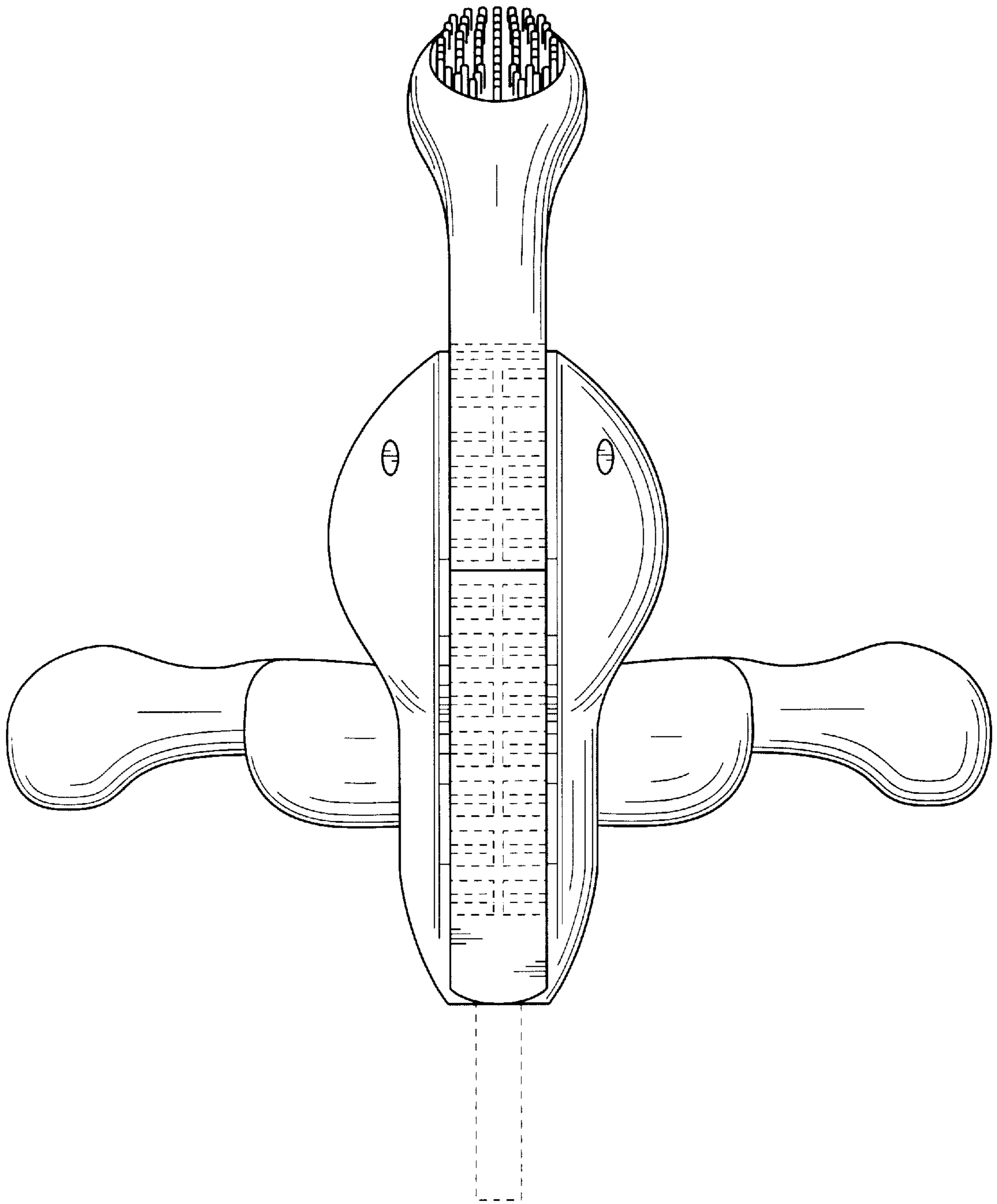

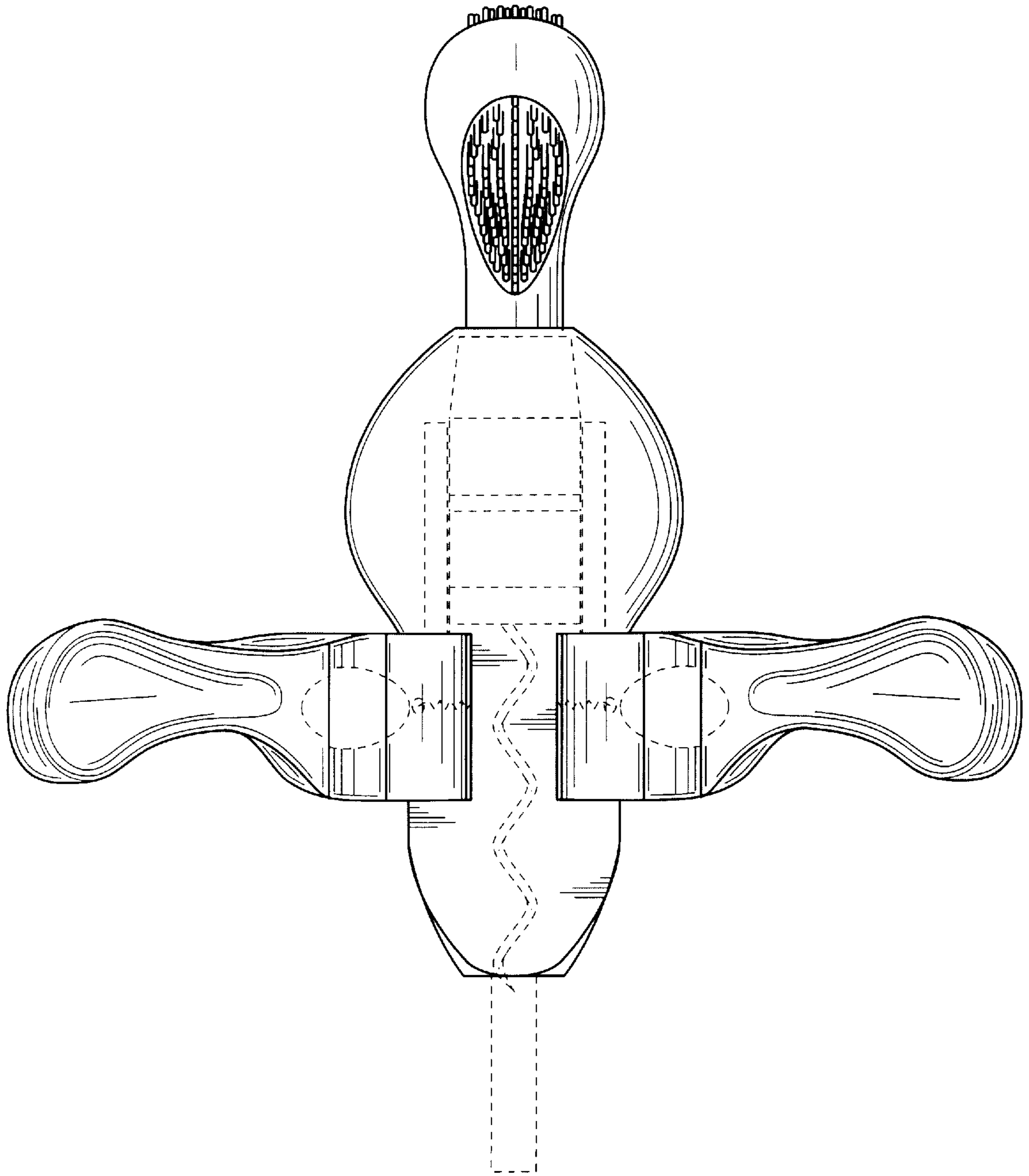

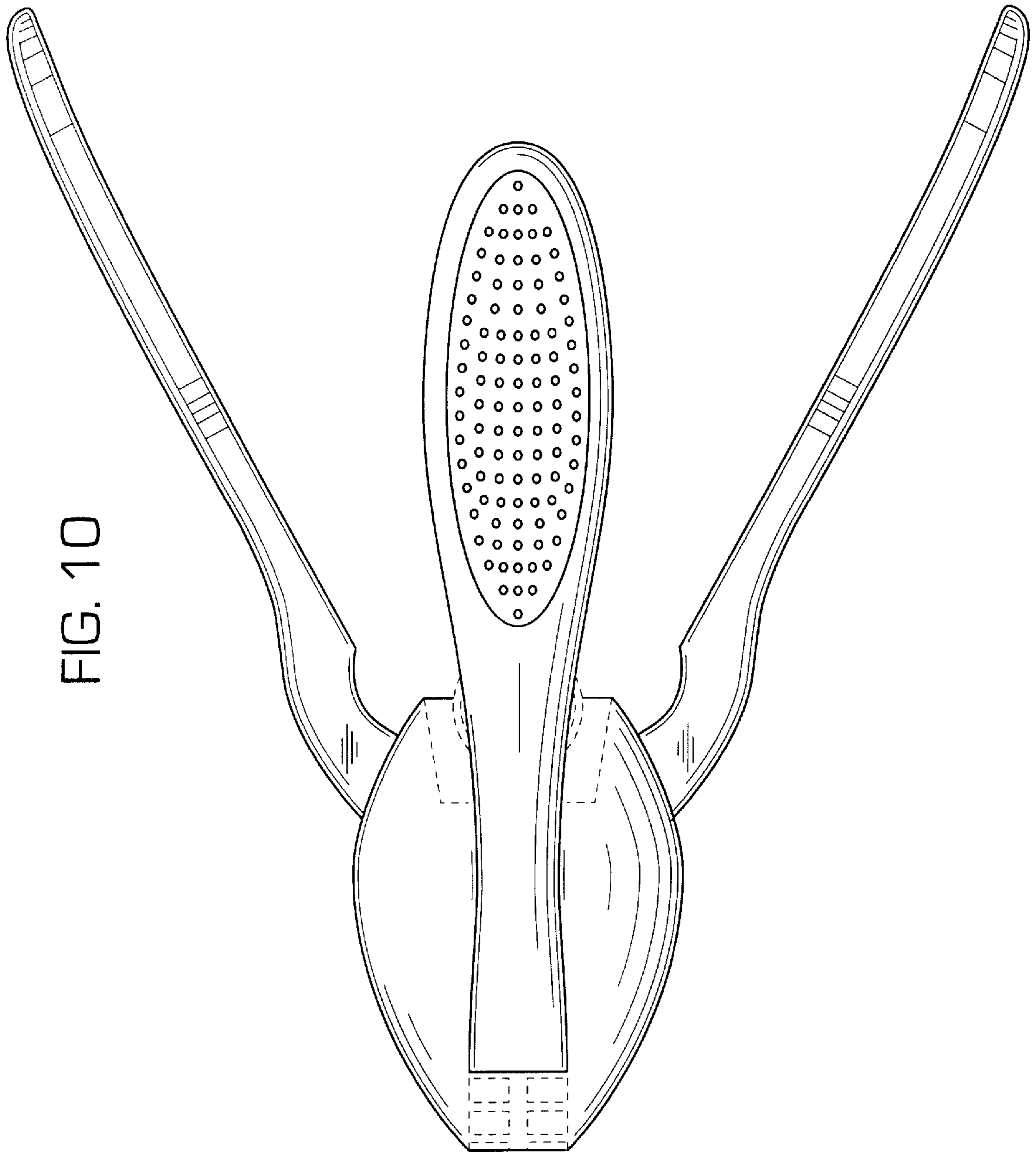

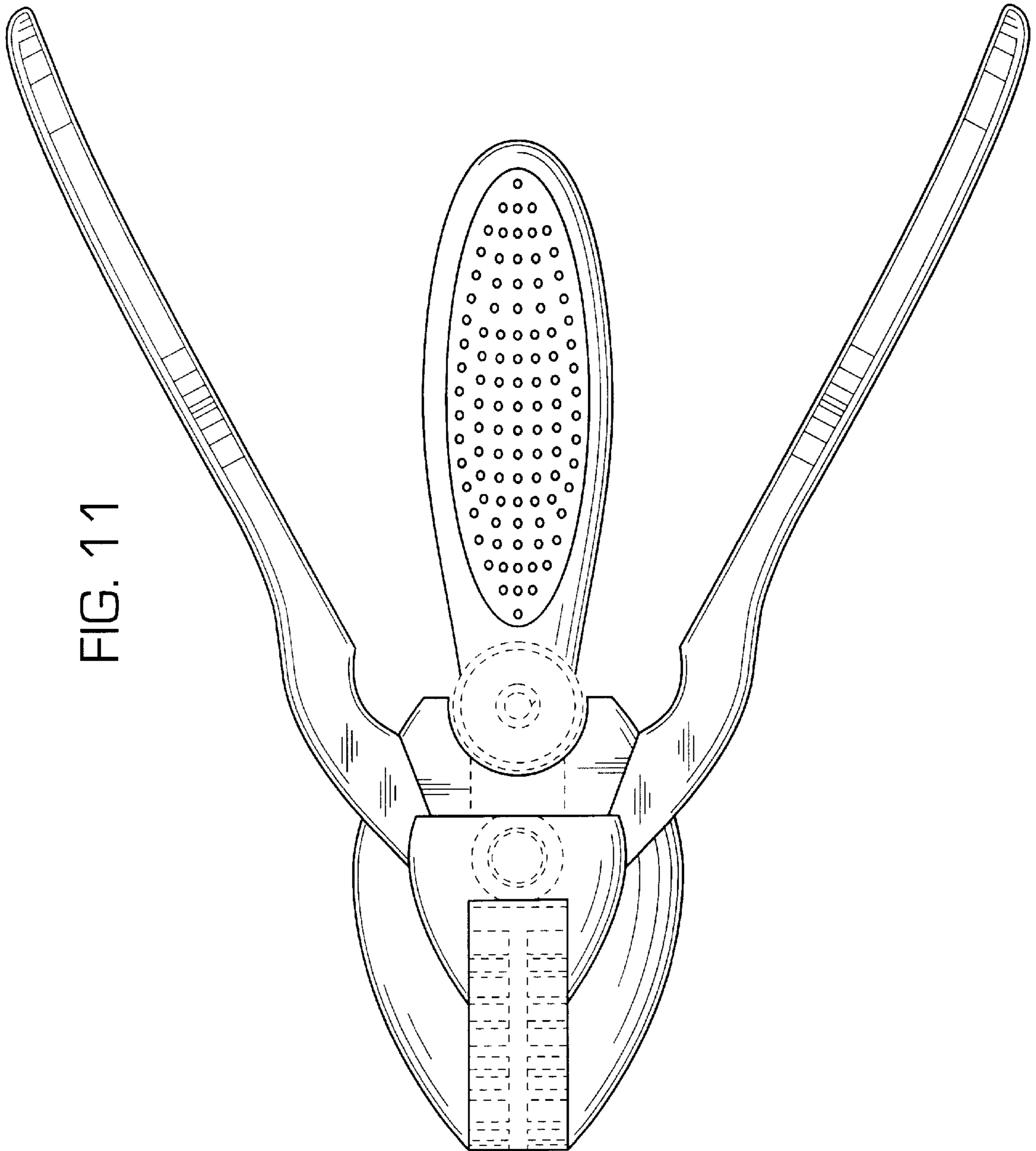
