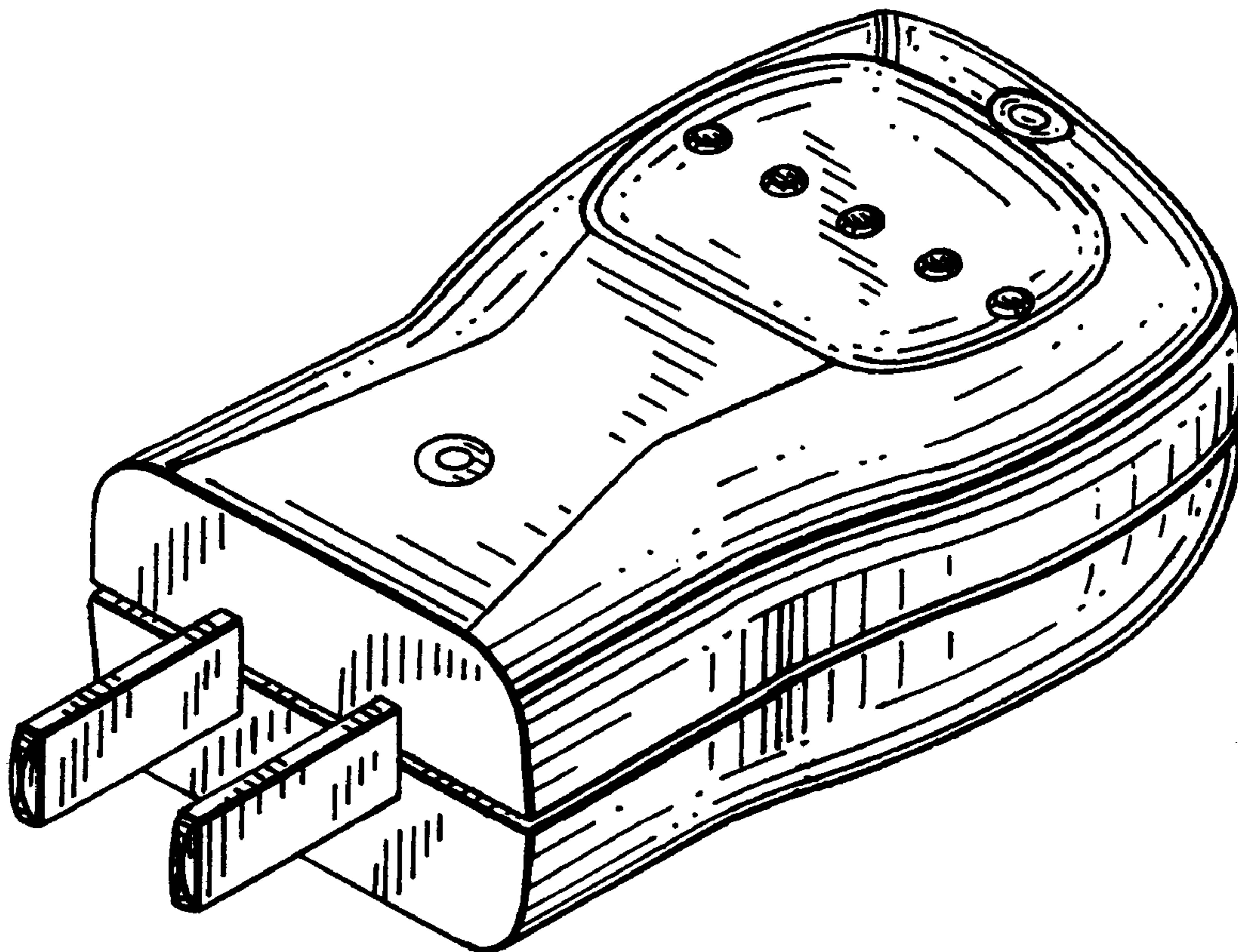
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom plan view showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a bottom, front and right side perspective view thereof; FIG. 7 is a bottom, rear and left side perspective view thereof; and, FIG. 8 is a front elevational view thereof.

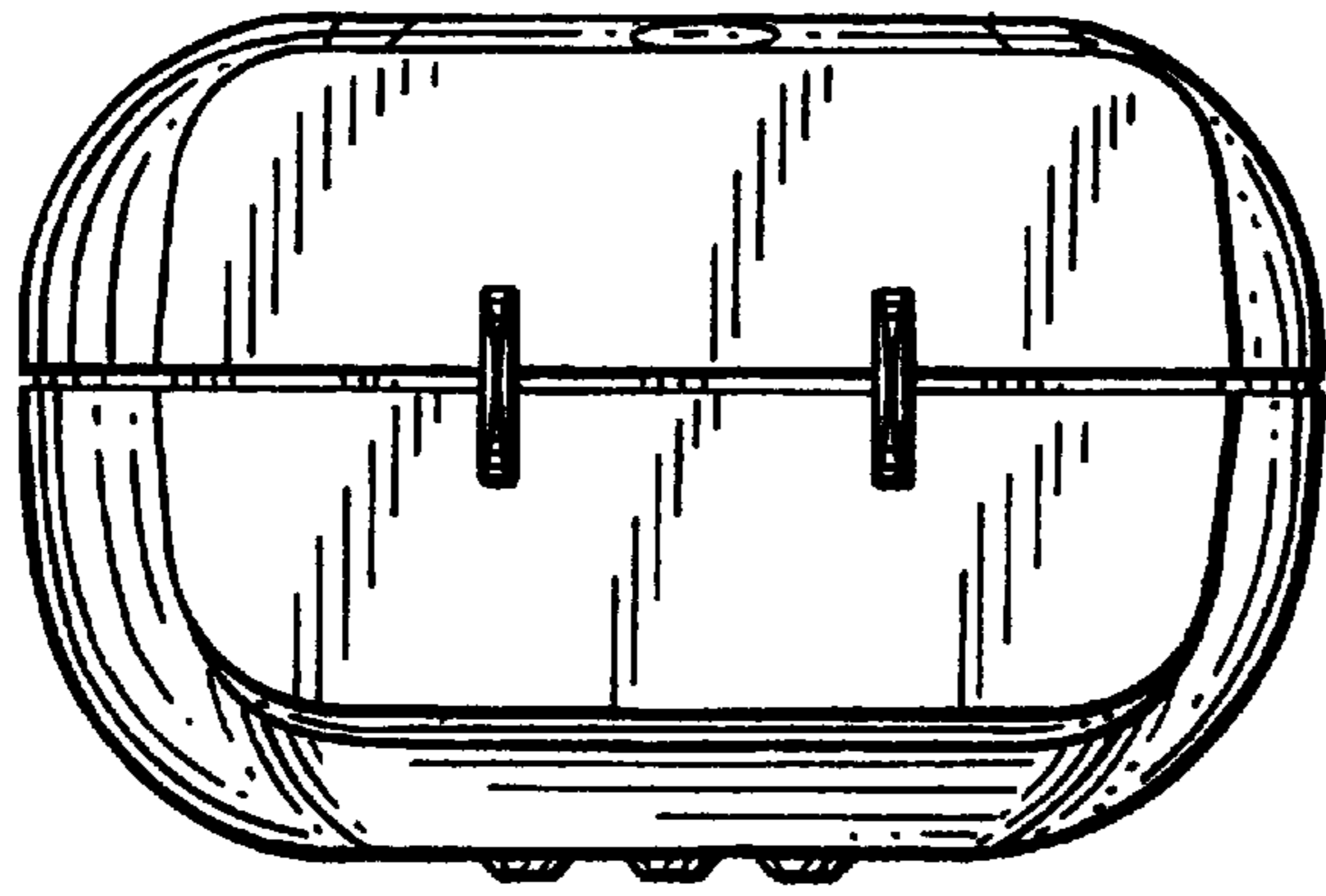

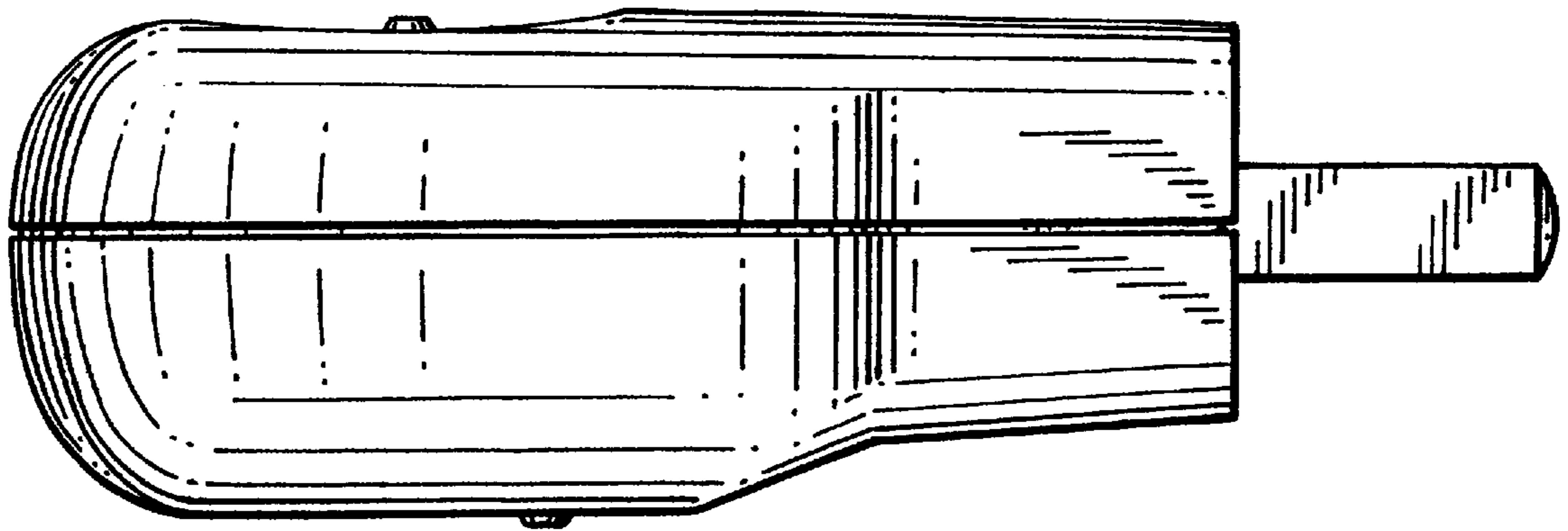

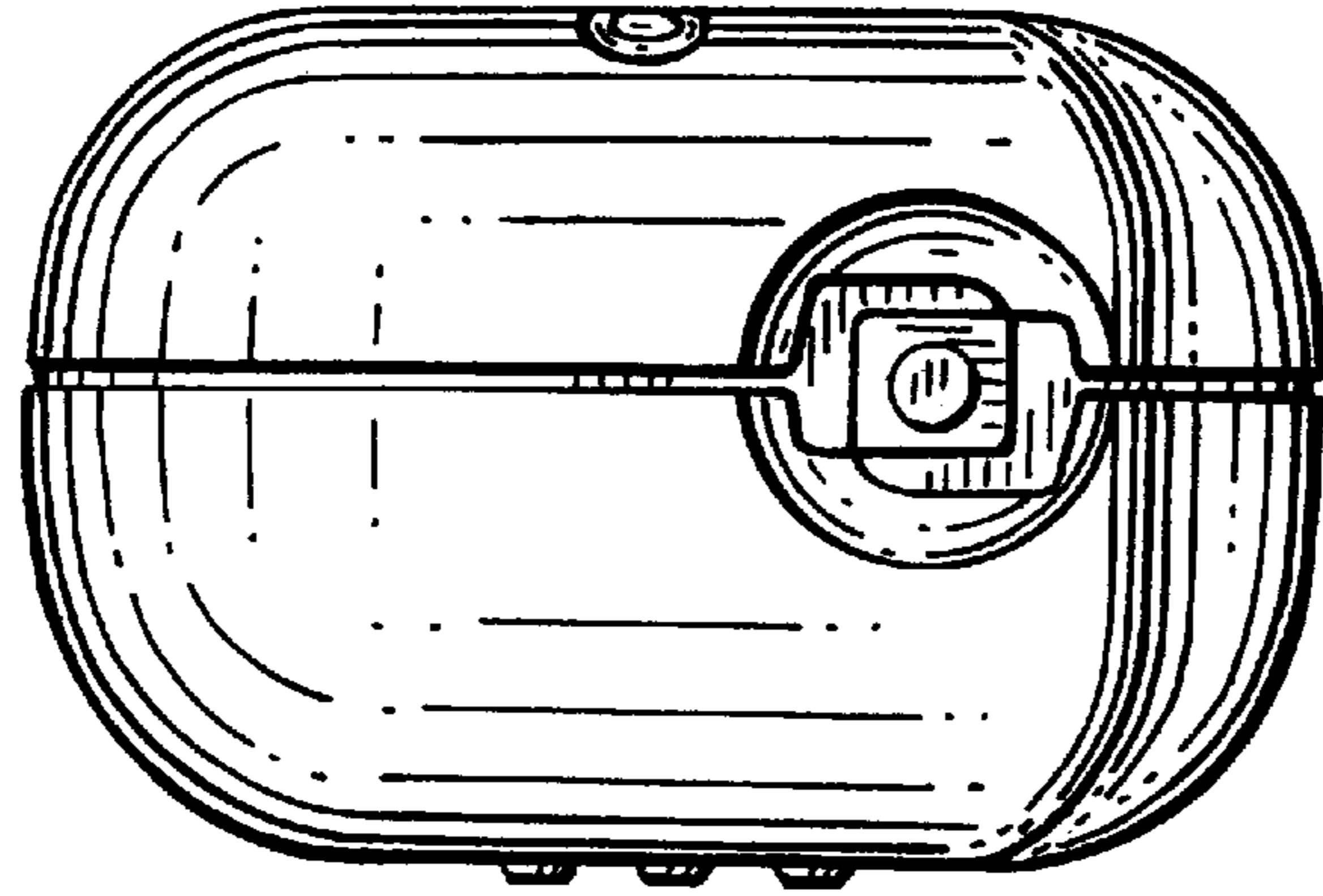

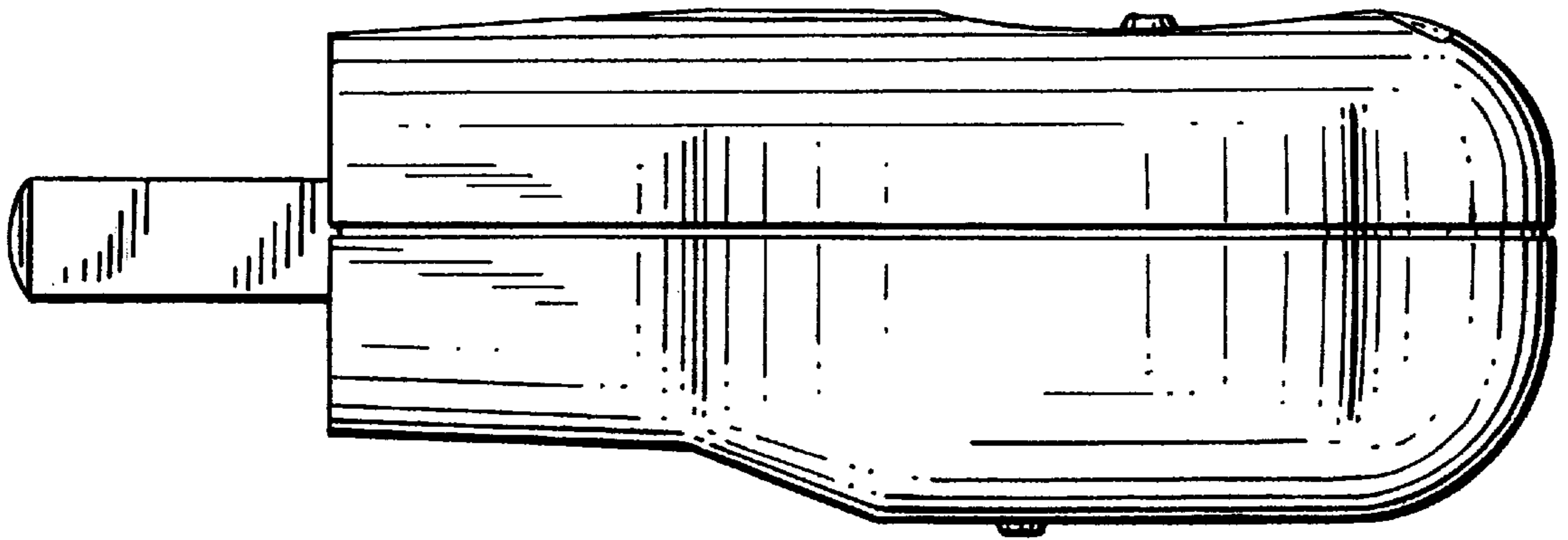

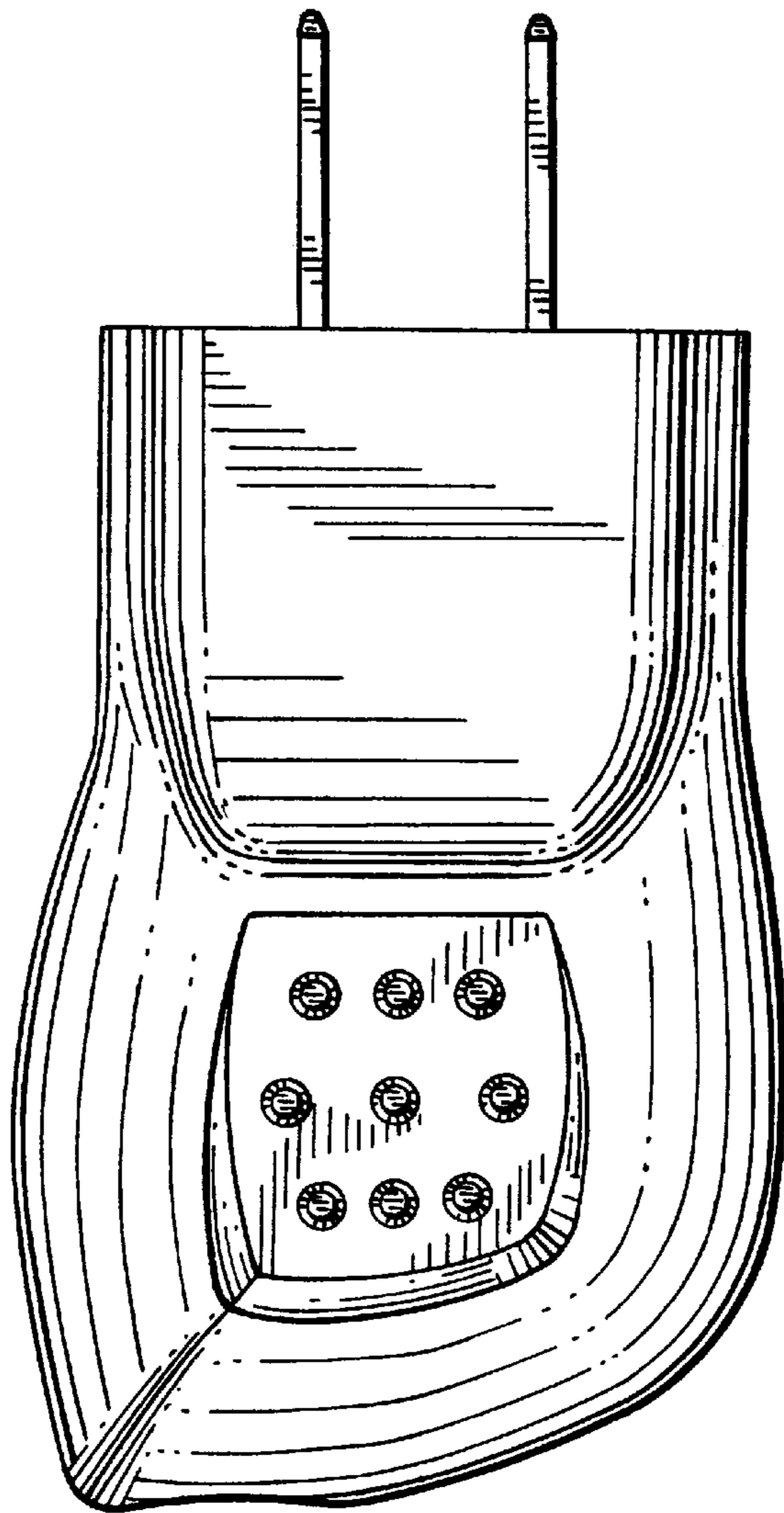

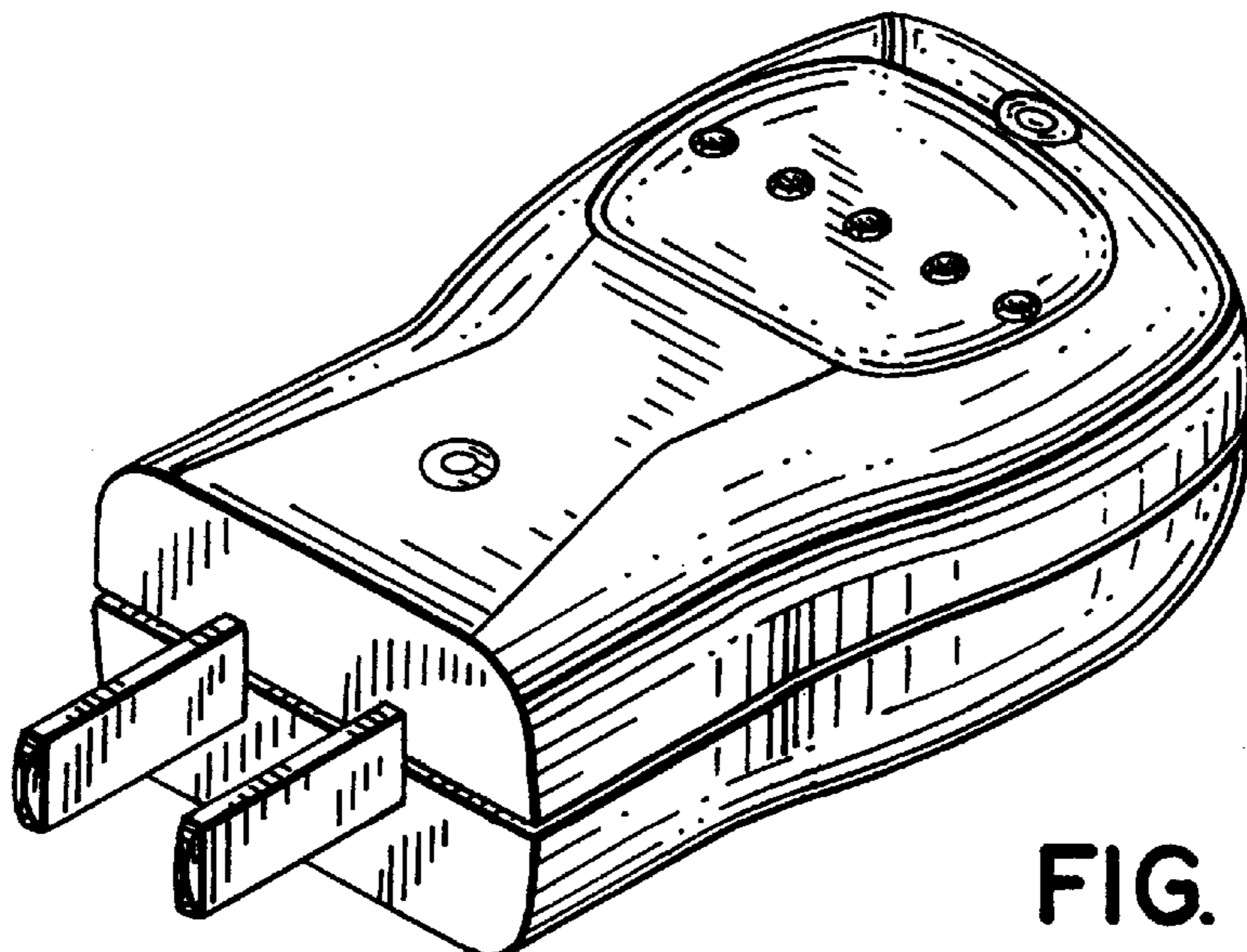

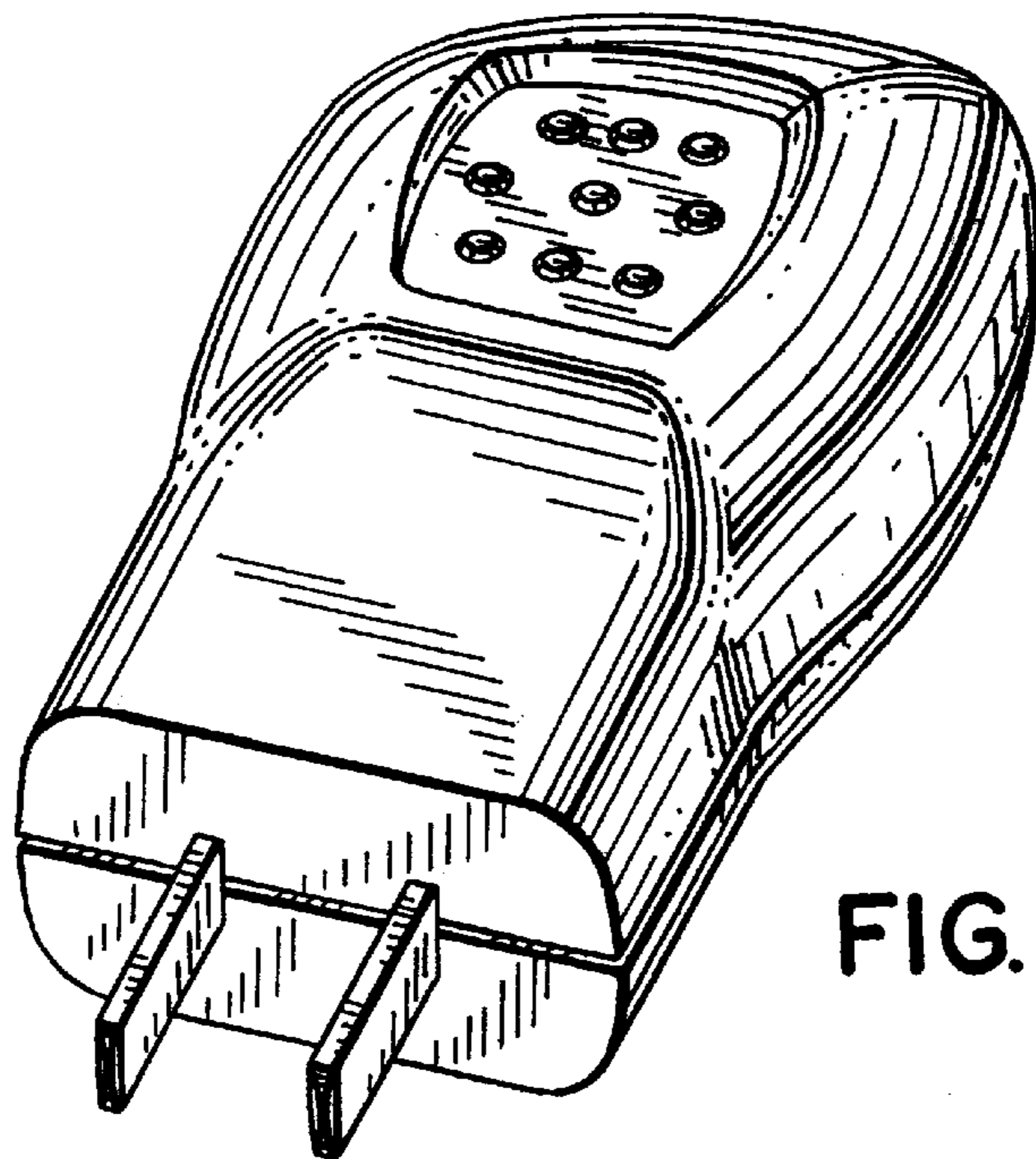

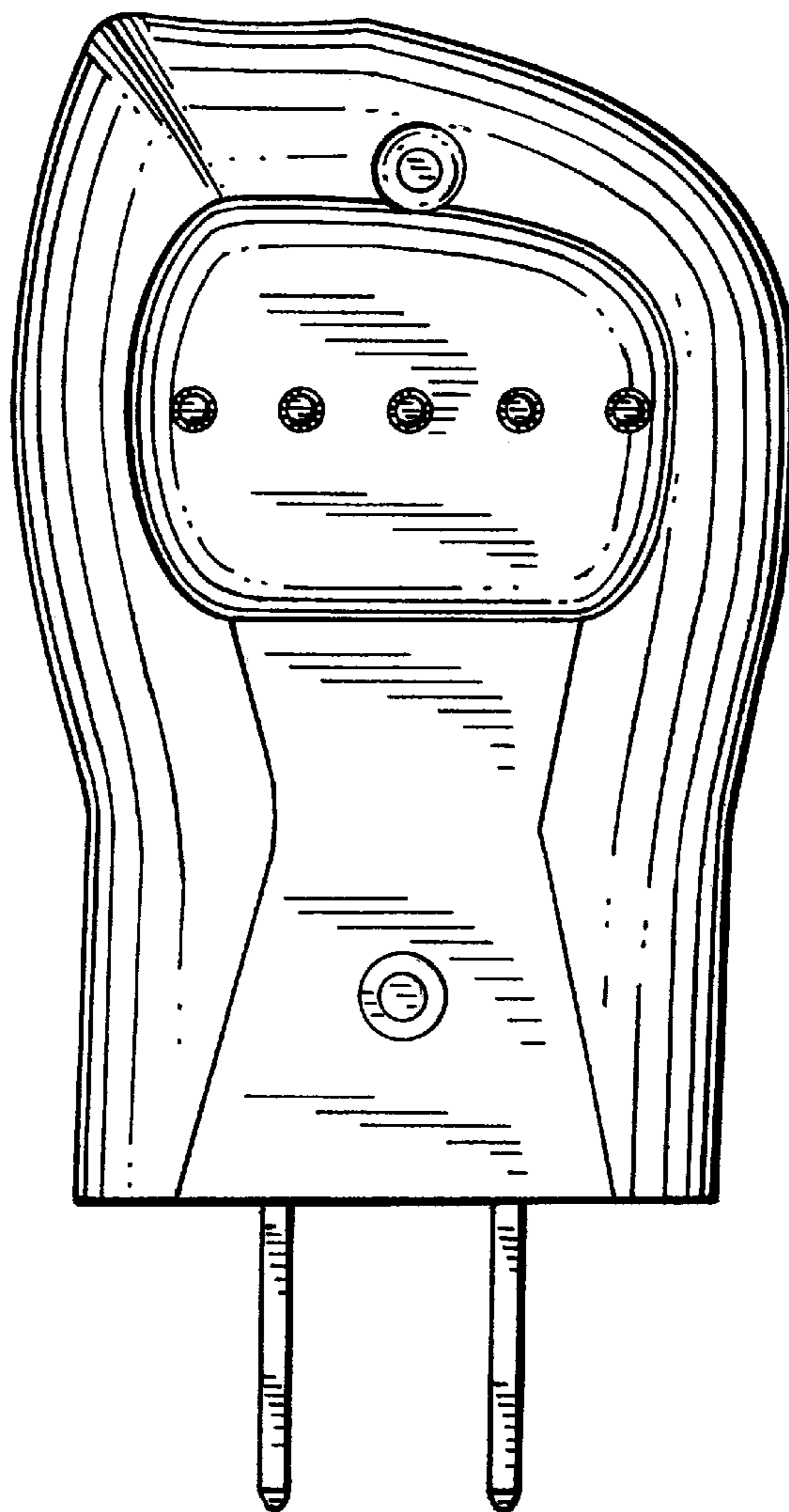
