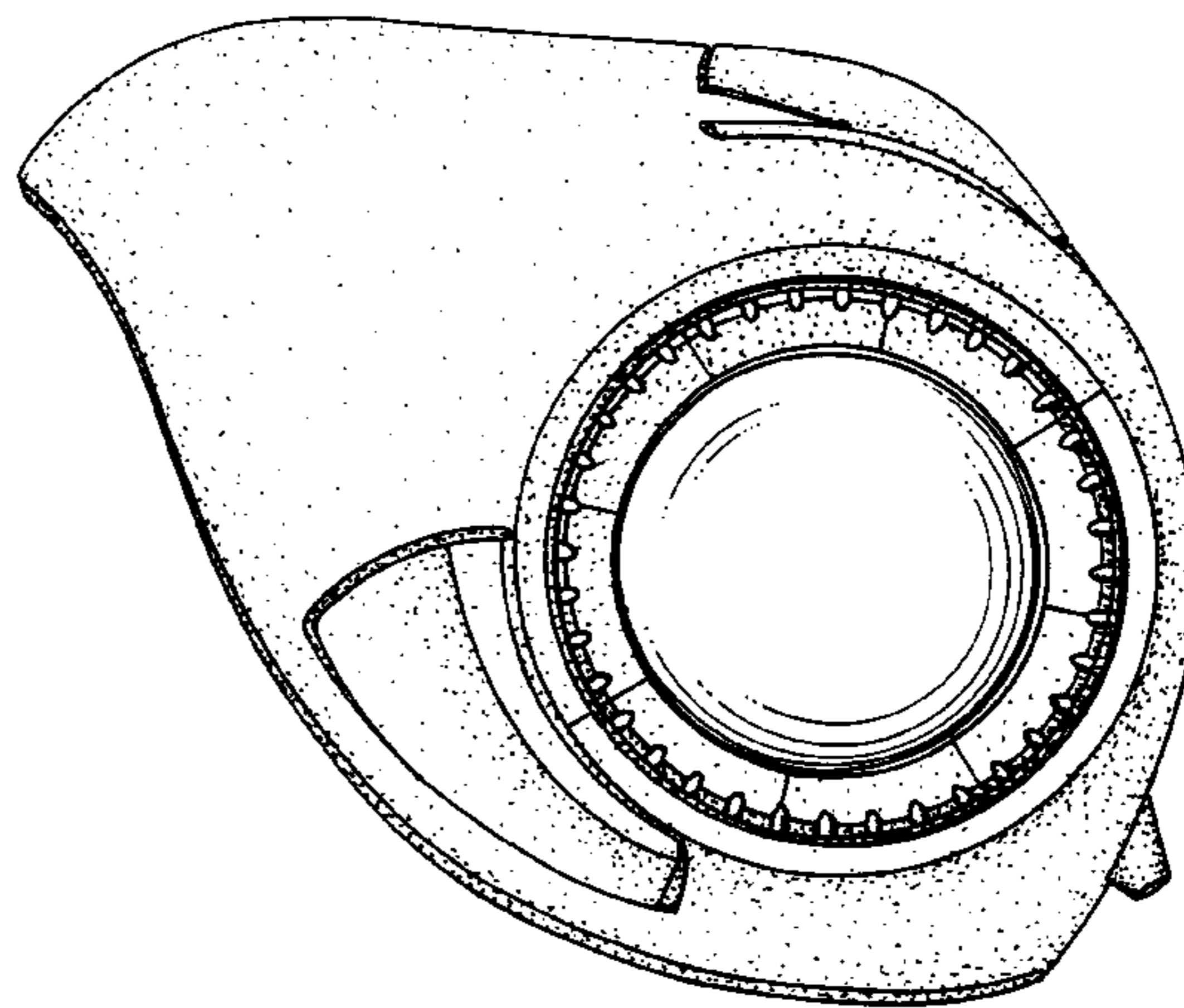
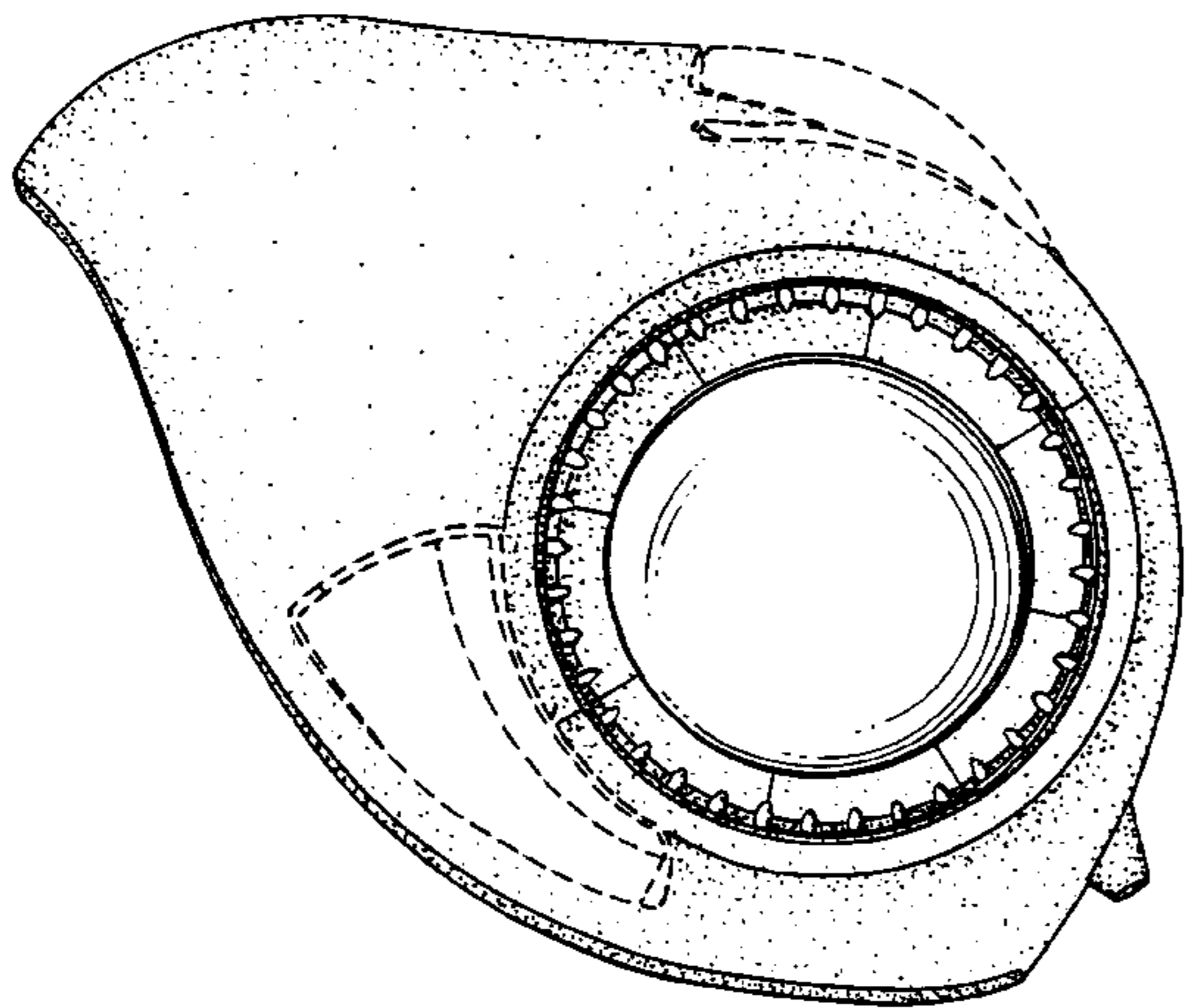
The ornamental design for mouse pointing device, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a mouse pointing device showing one embodiment of our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of an alternate embodiment; FIG. 9 is a top plan view thereof; FIG. 10 is a rear elevational view thereof; FIG. 11 is a right side elevational view thereof; FIG. 12 is a left side elevational view thereof; FIG. 13 is a front elevational view thereof; and, FIG. 14 is a bottom plan view thereof.

The broken lines drawings of buttons in FIGS. 1-6, and the details in FIG. 7 are for illustrative purposes only and form no part of the claimed design shown in the first embodiment.

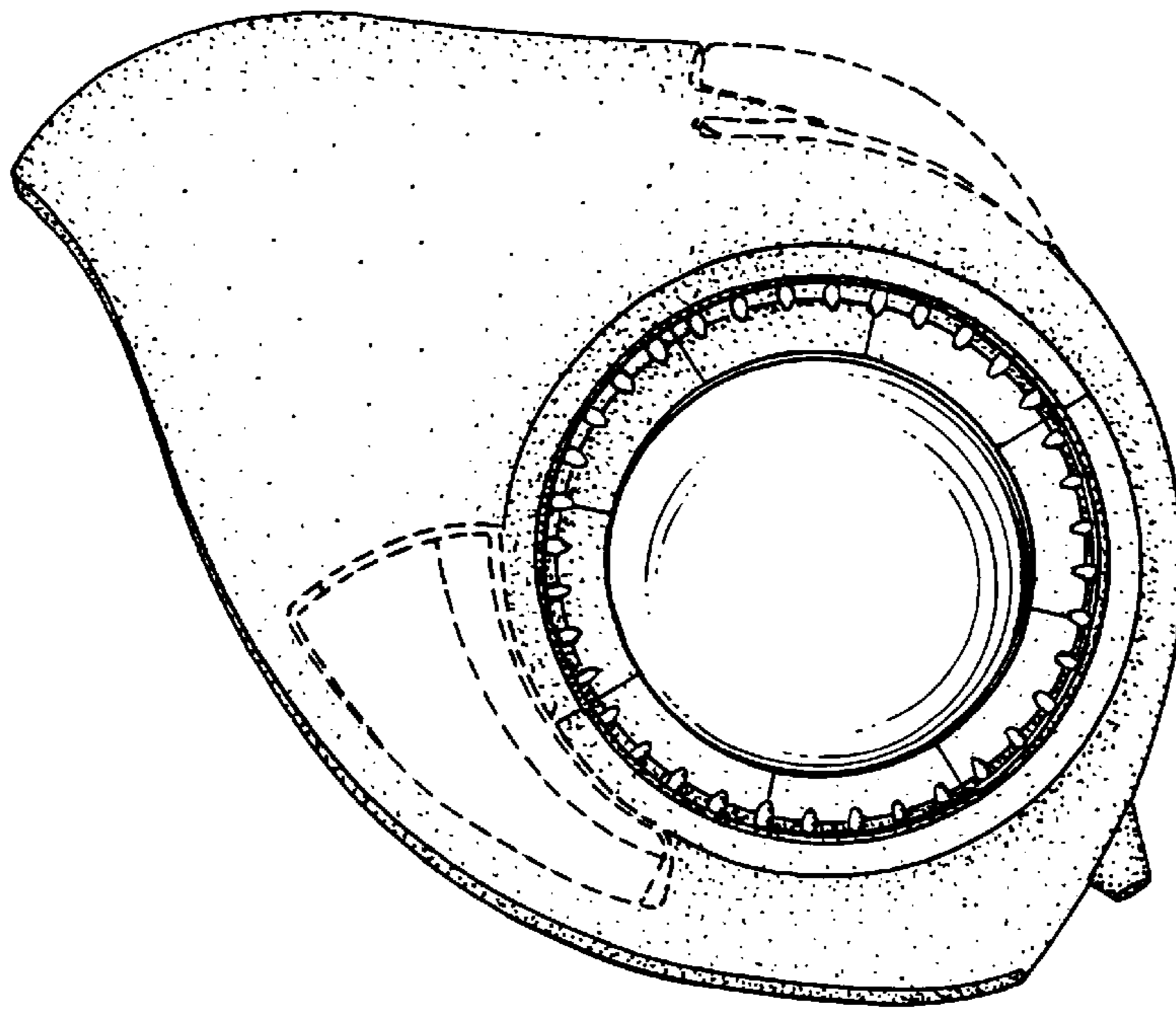

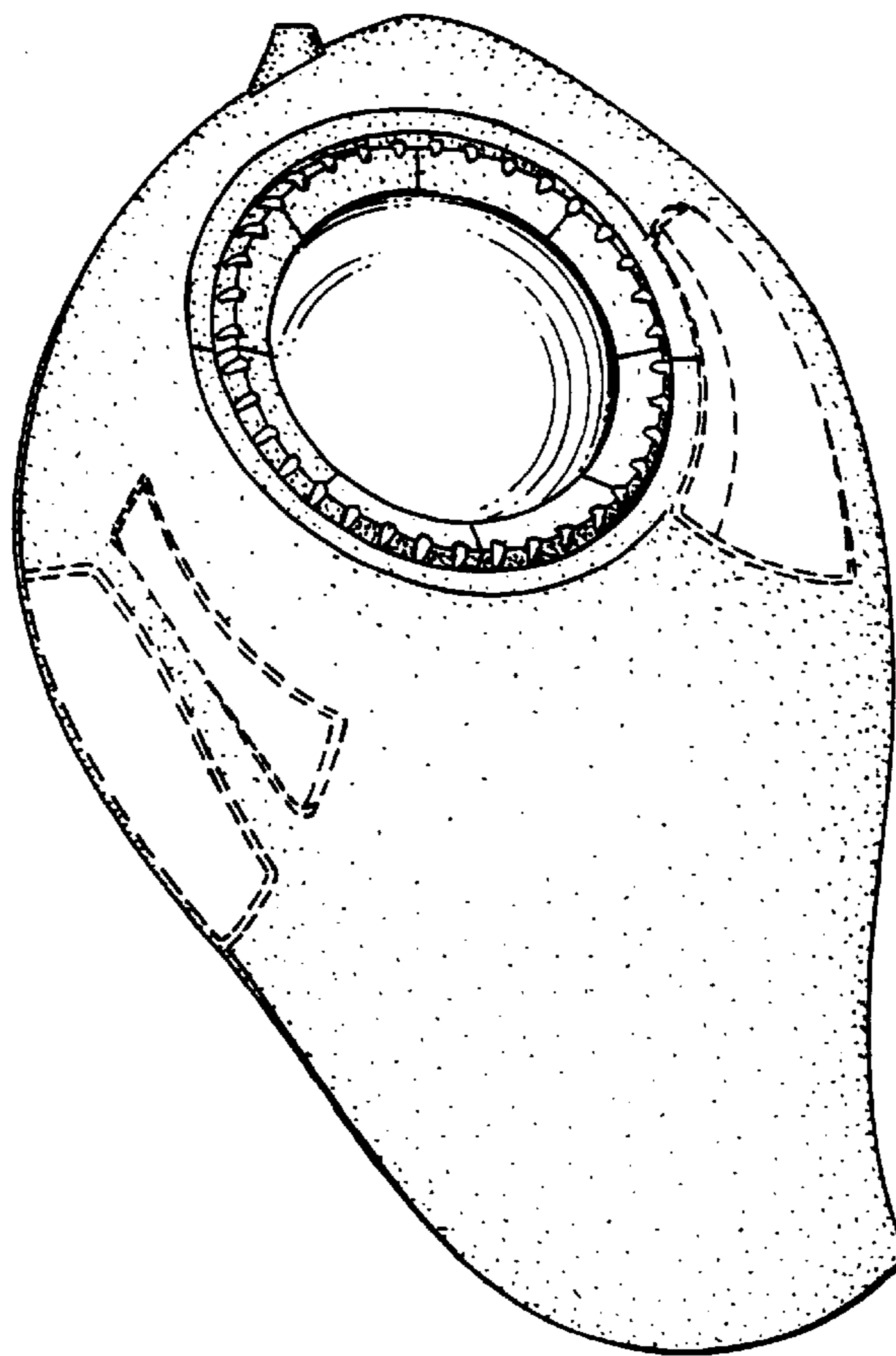
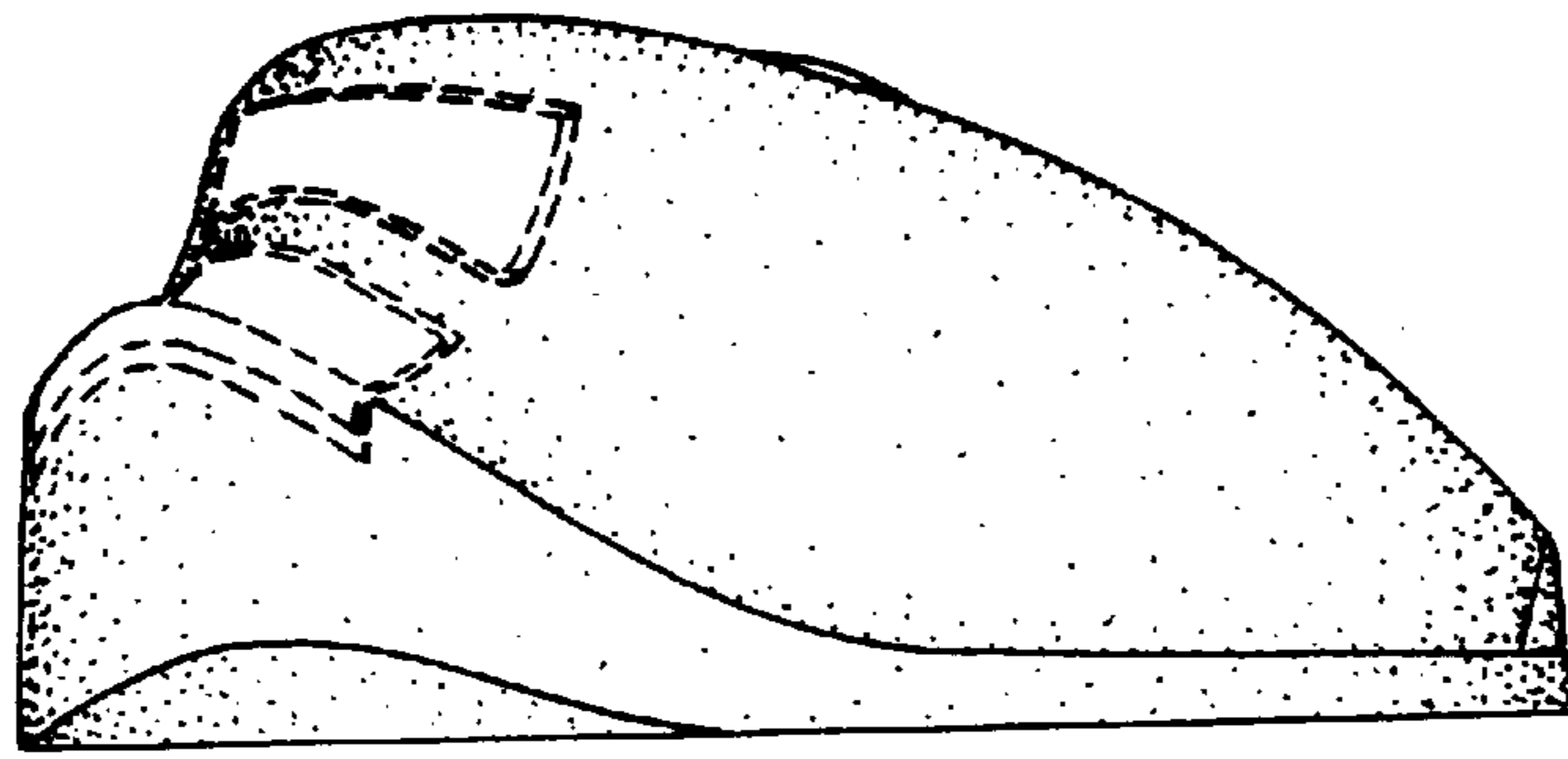
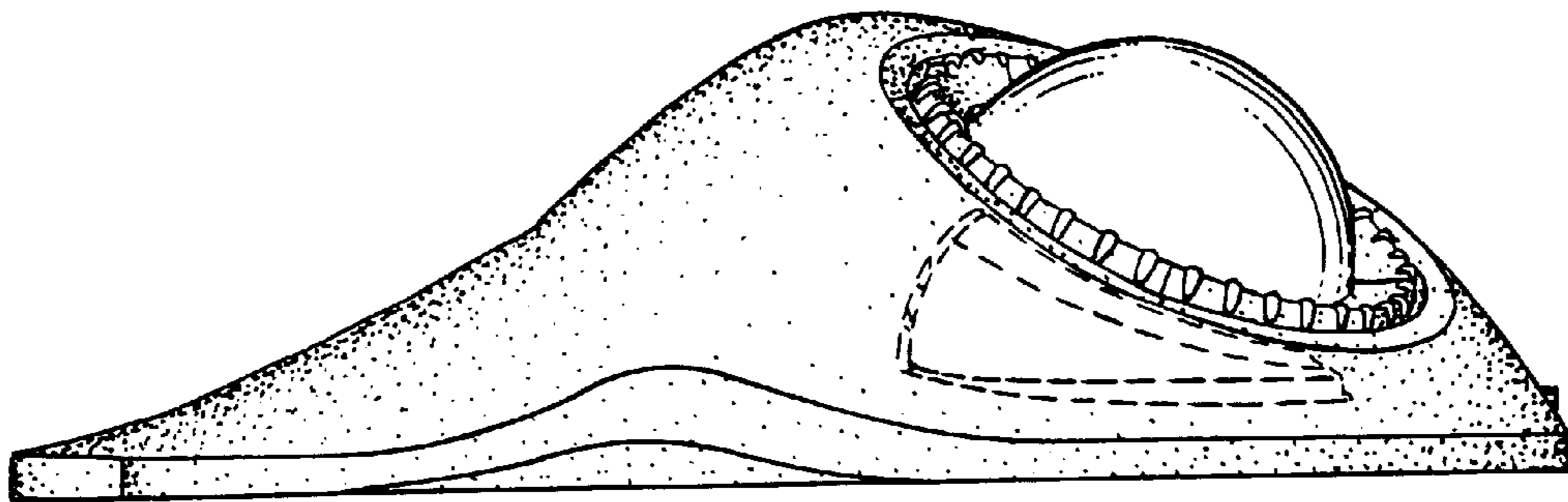


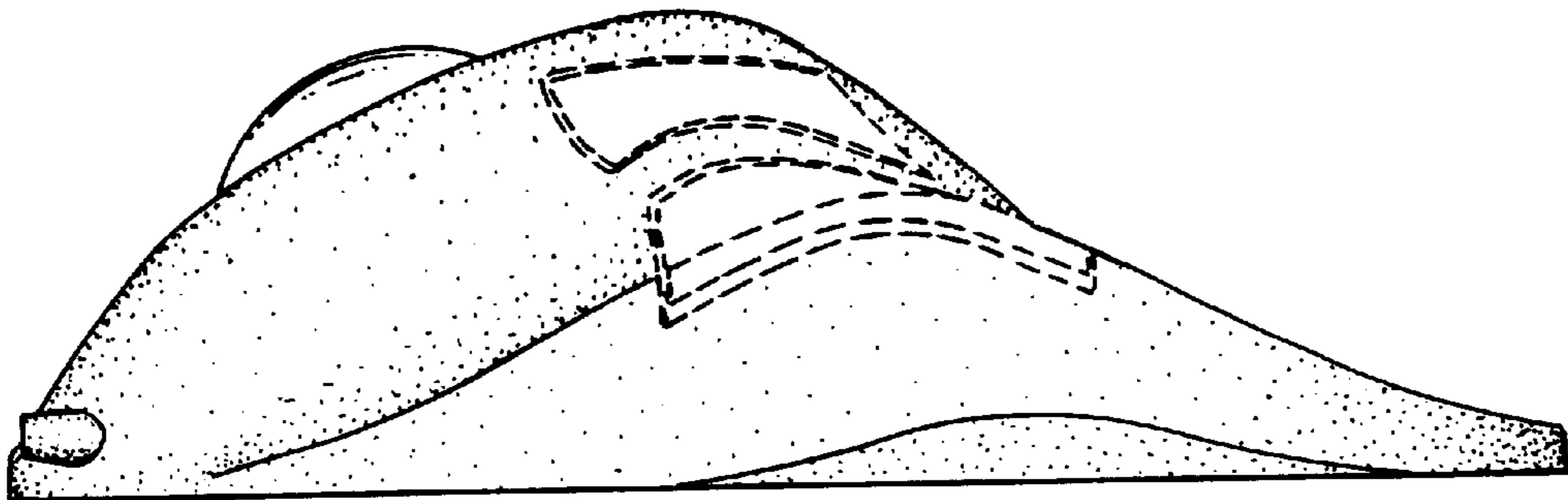

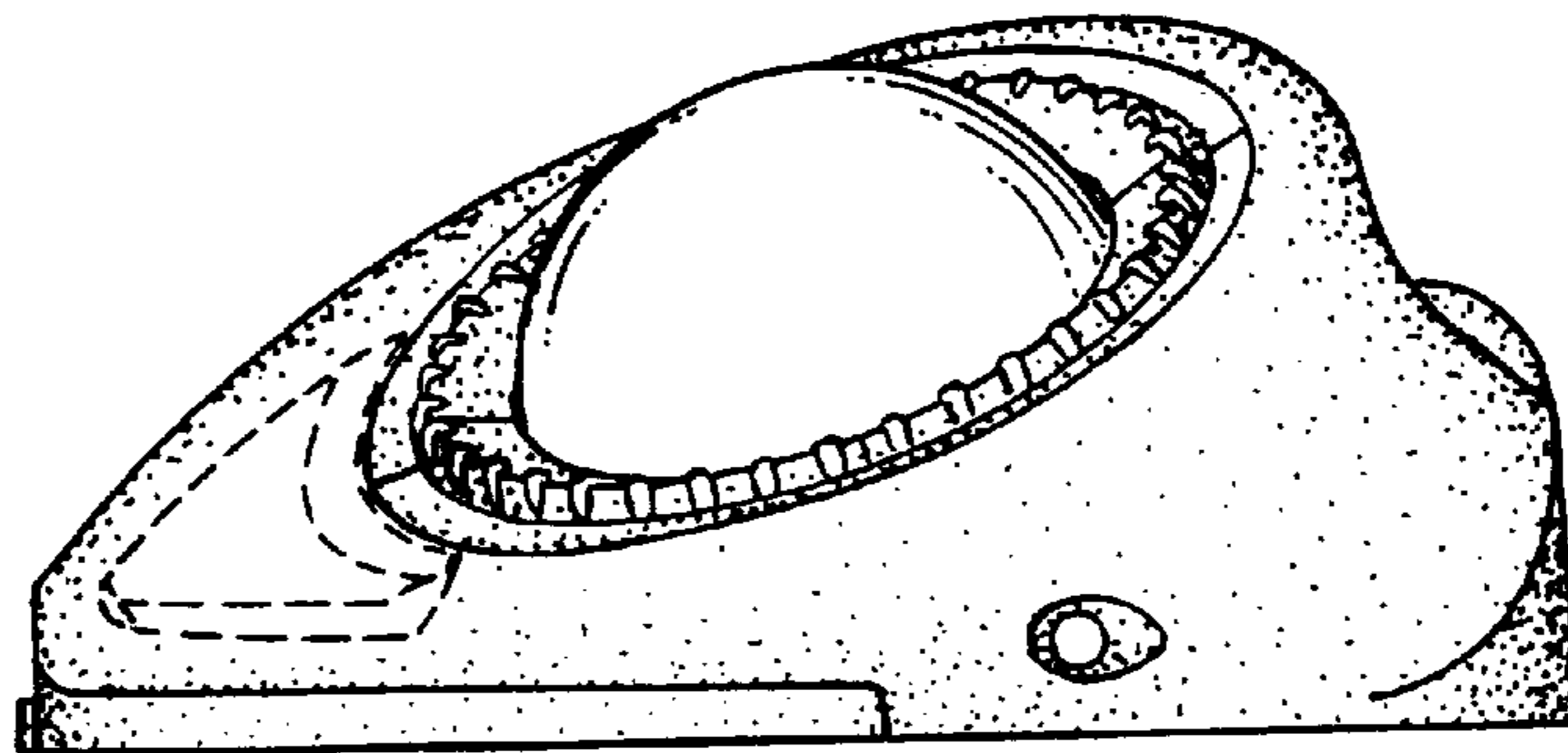

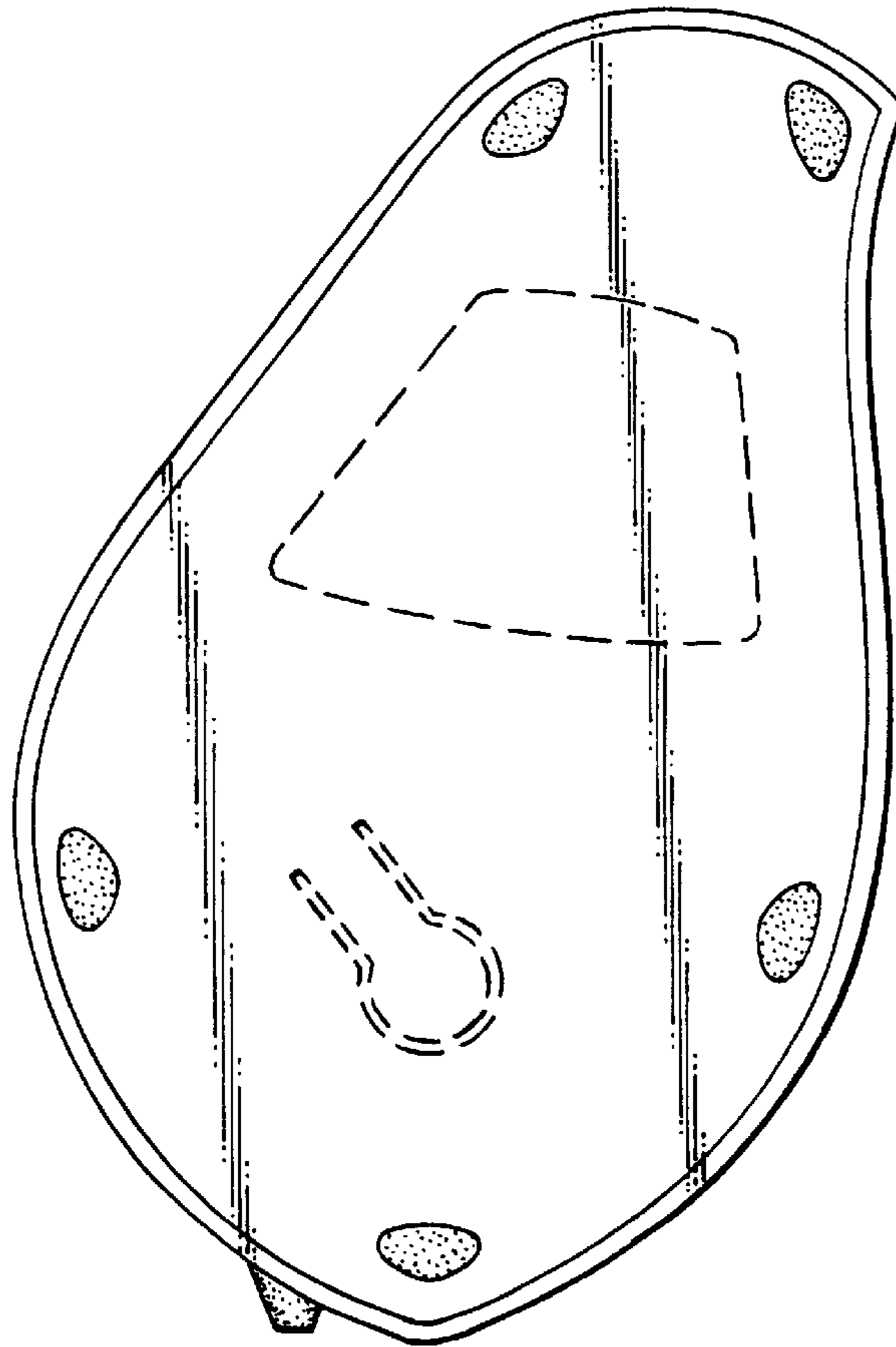

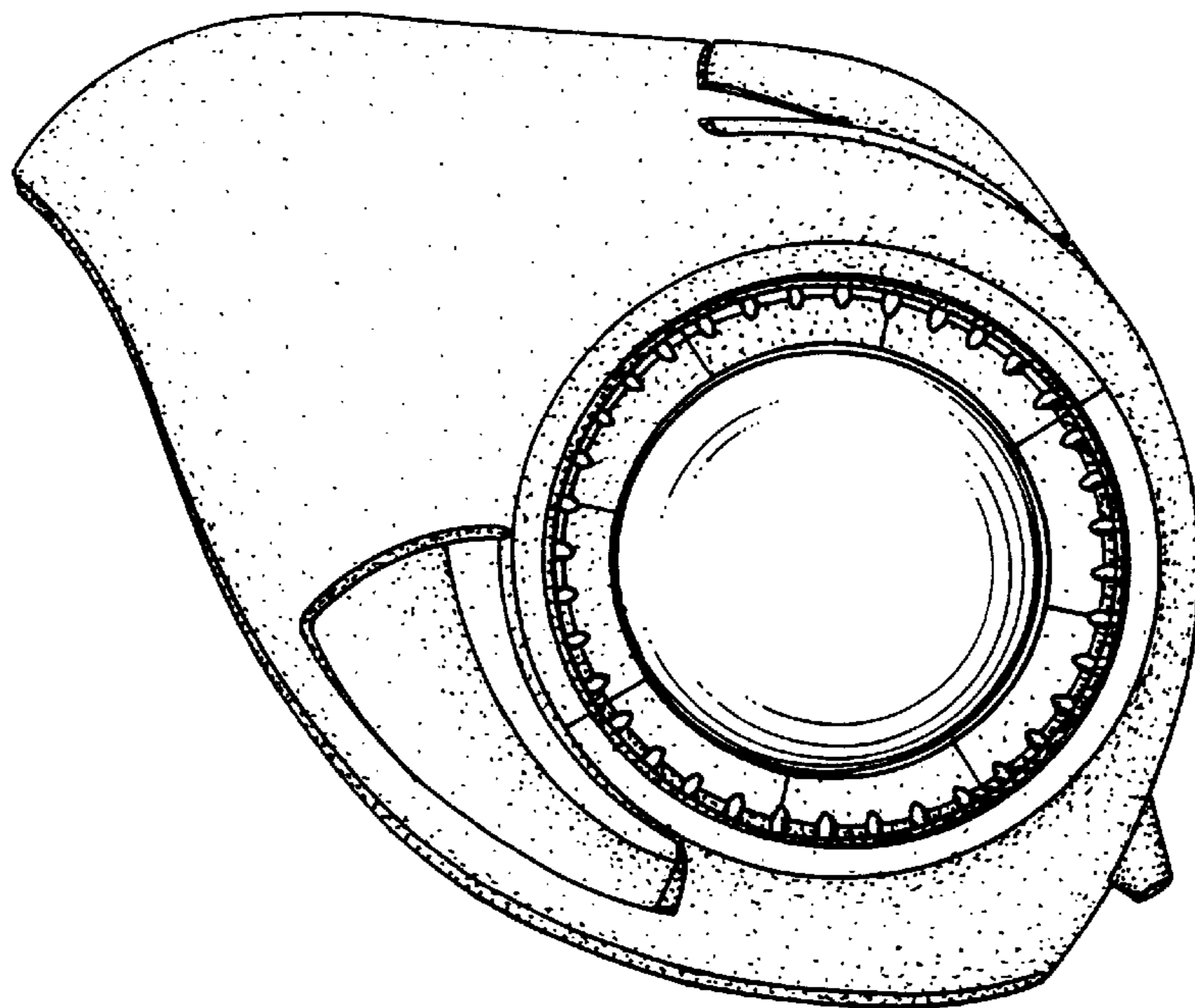
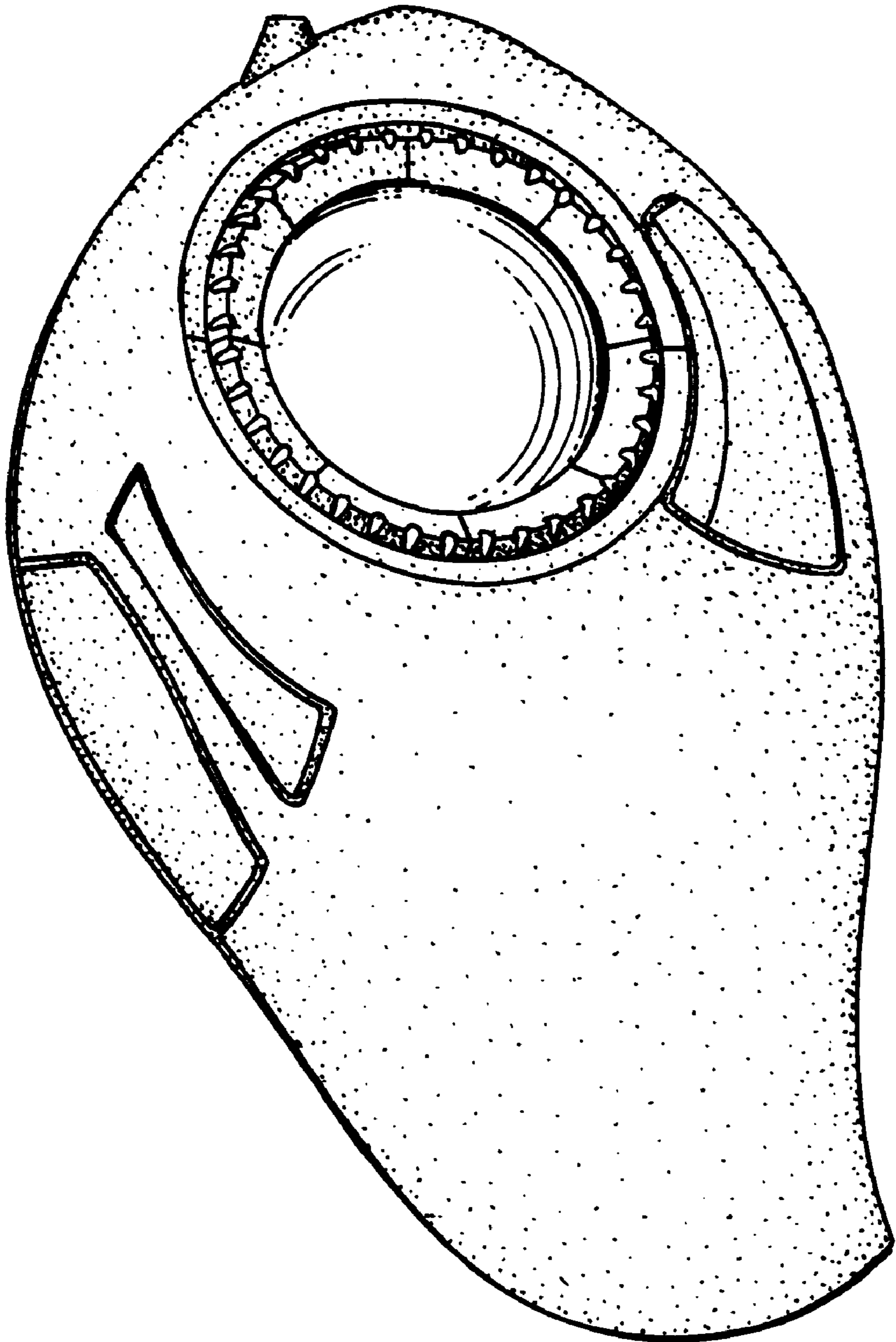
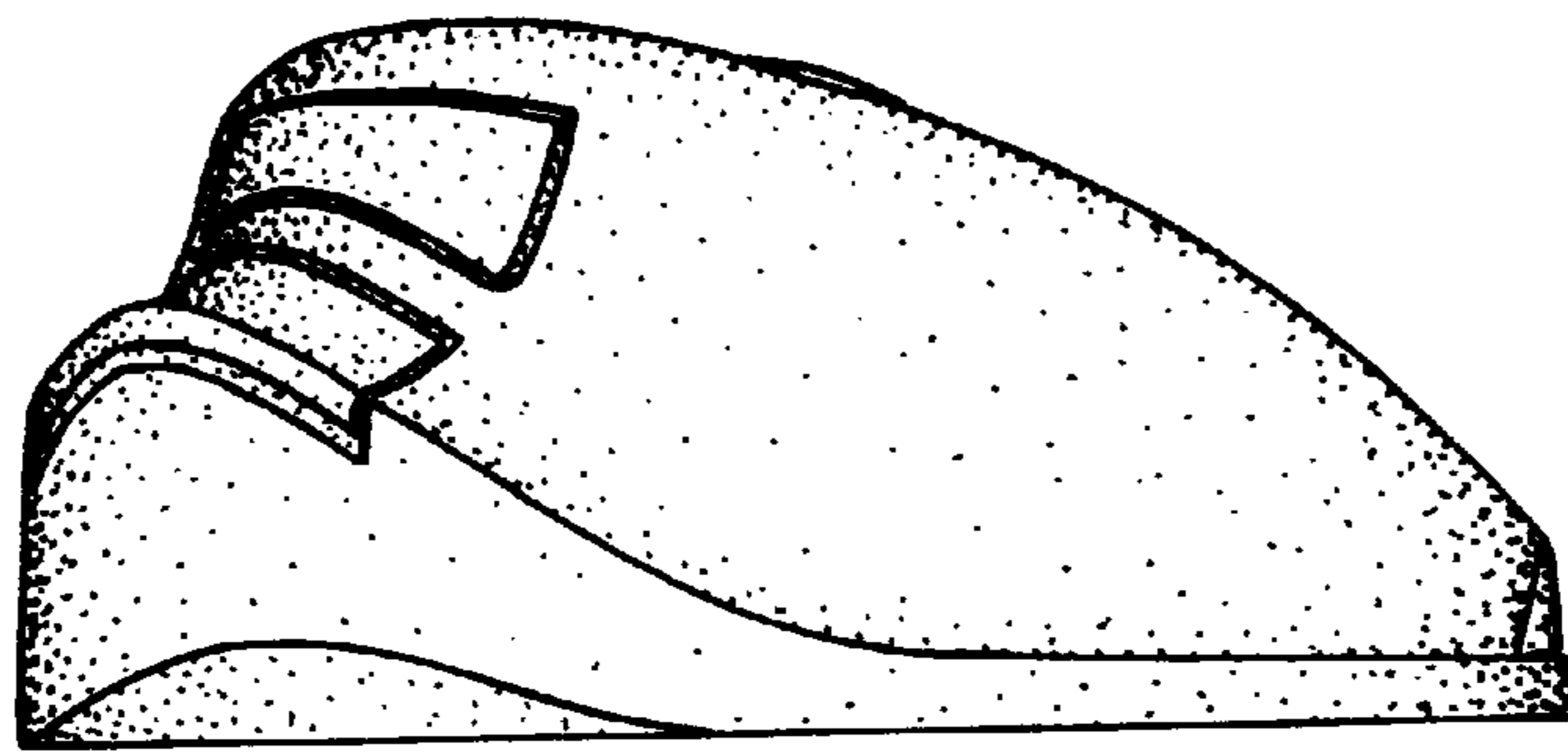


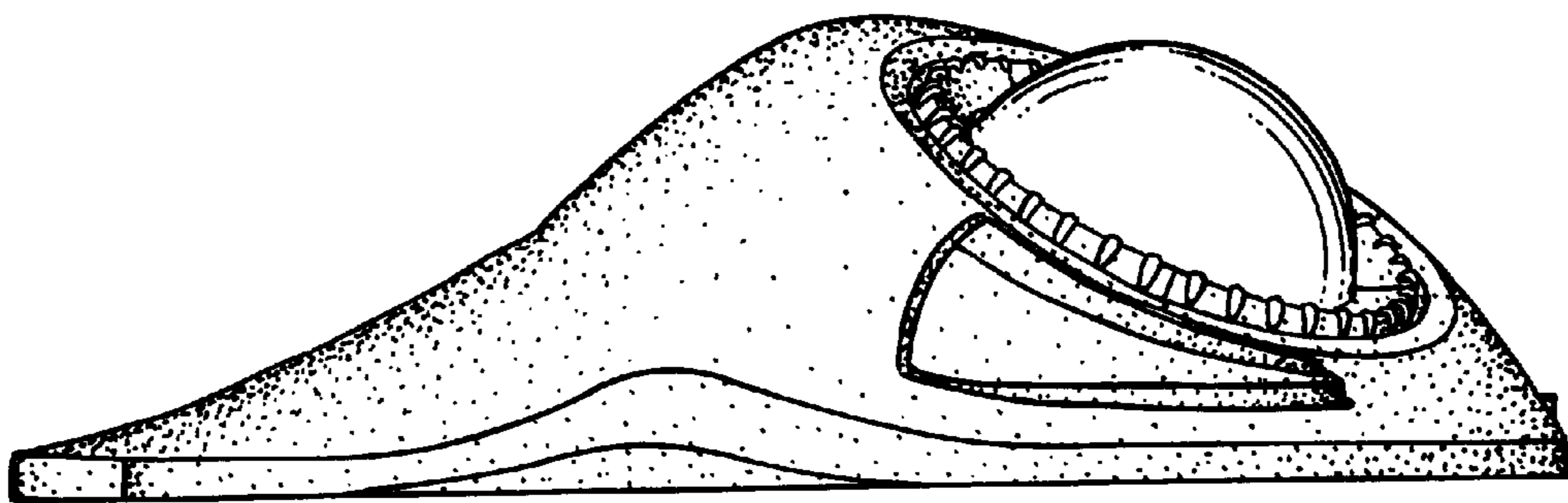

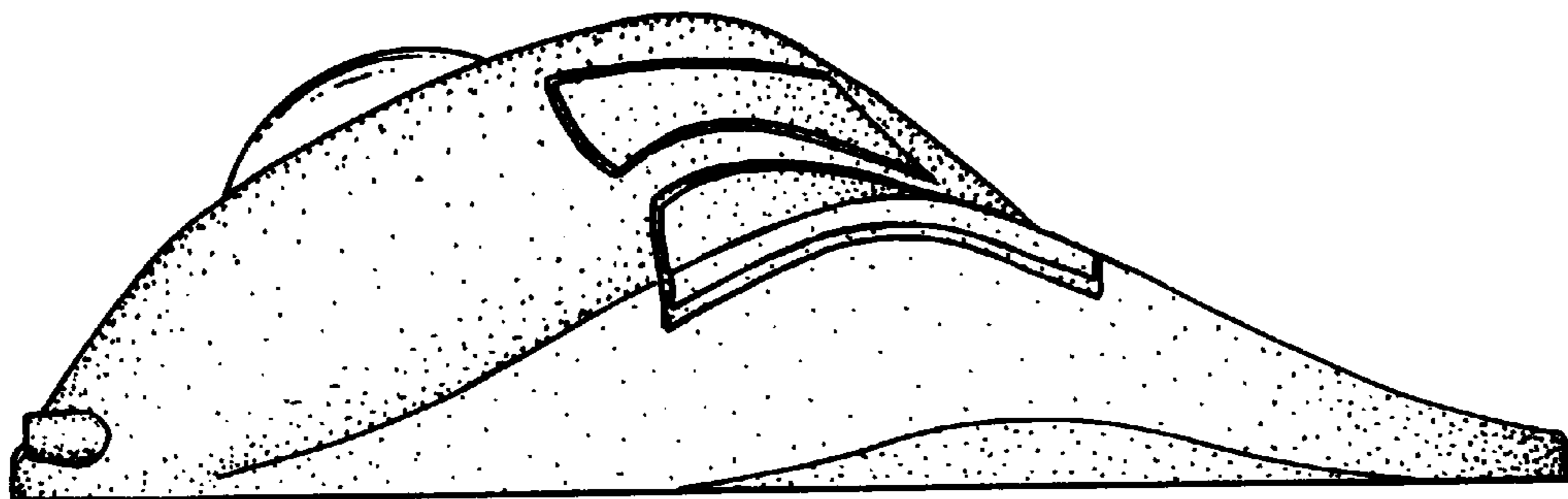

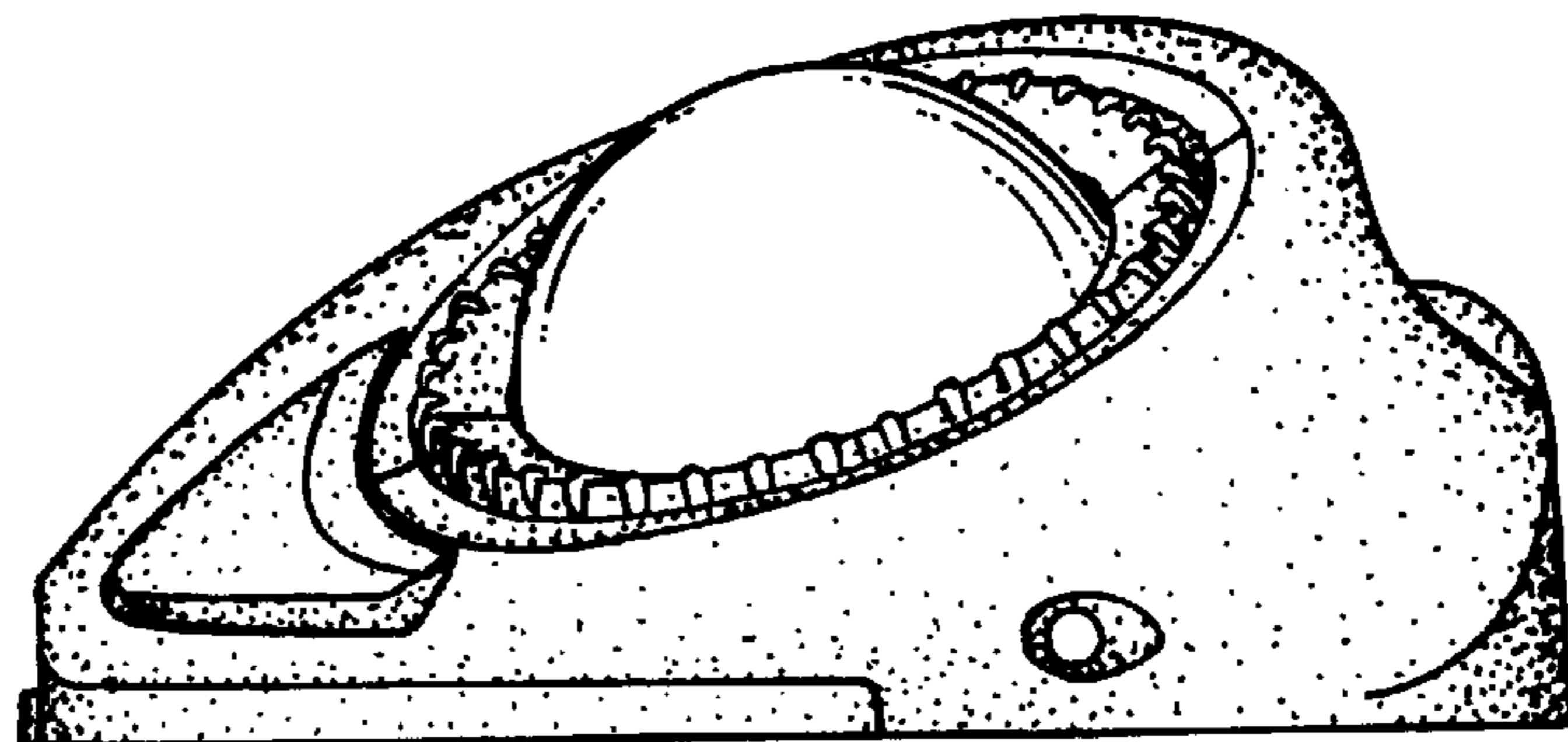

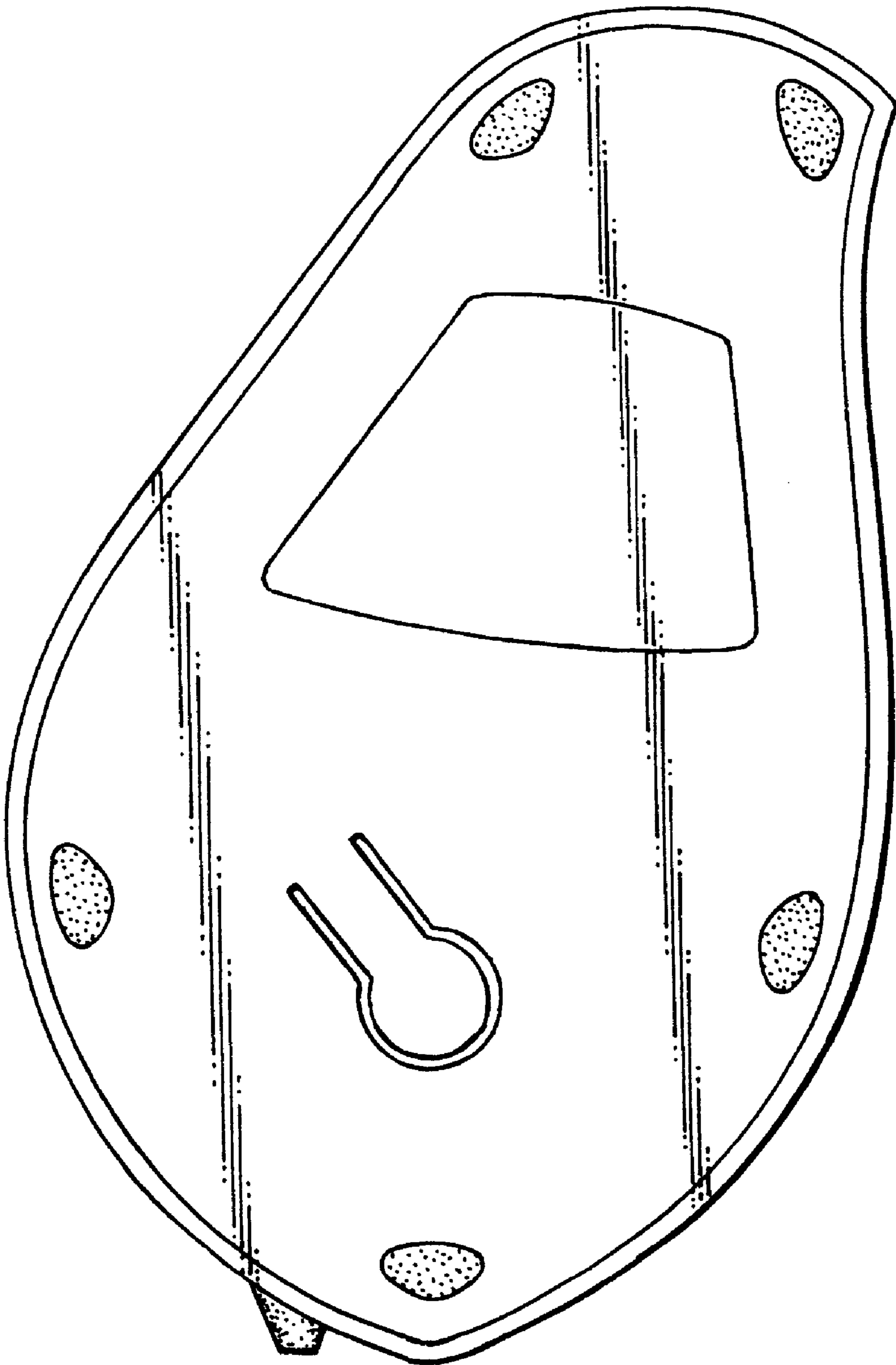
