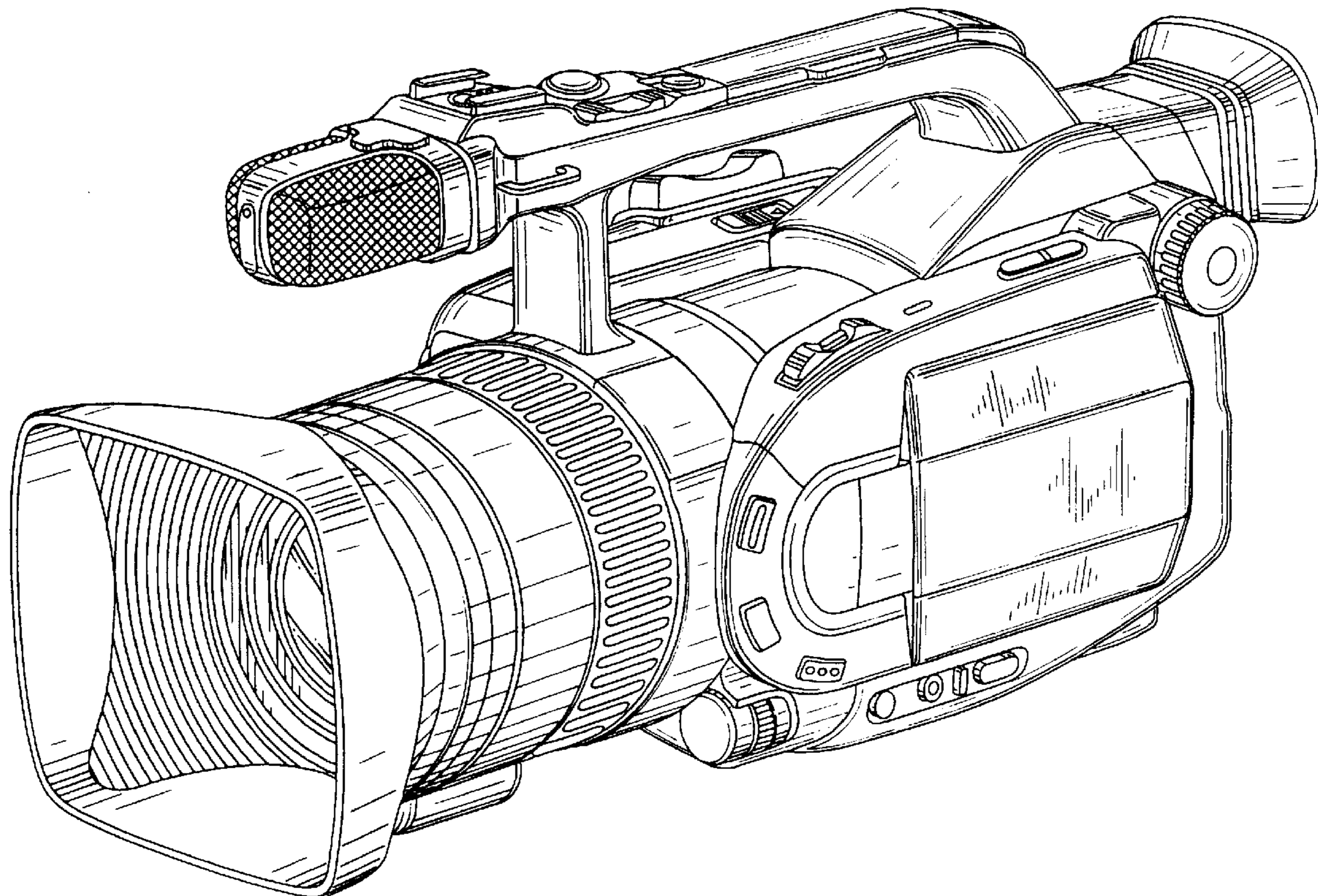
[57] **CLAIM**

The ornamental design for a video camera with tape recorder, as shown and described.

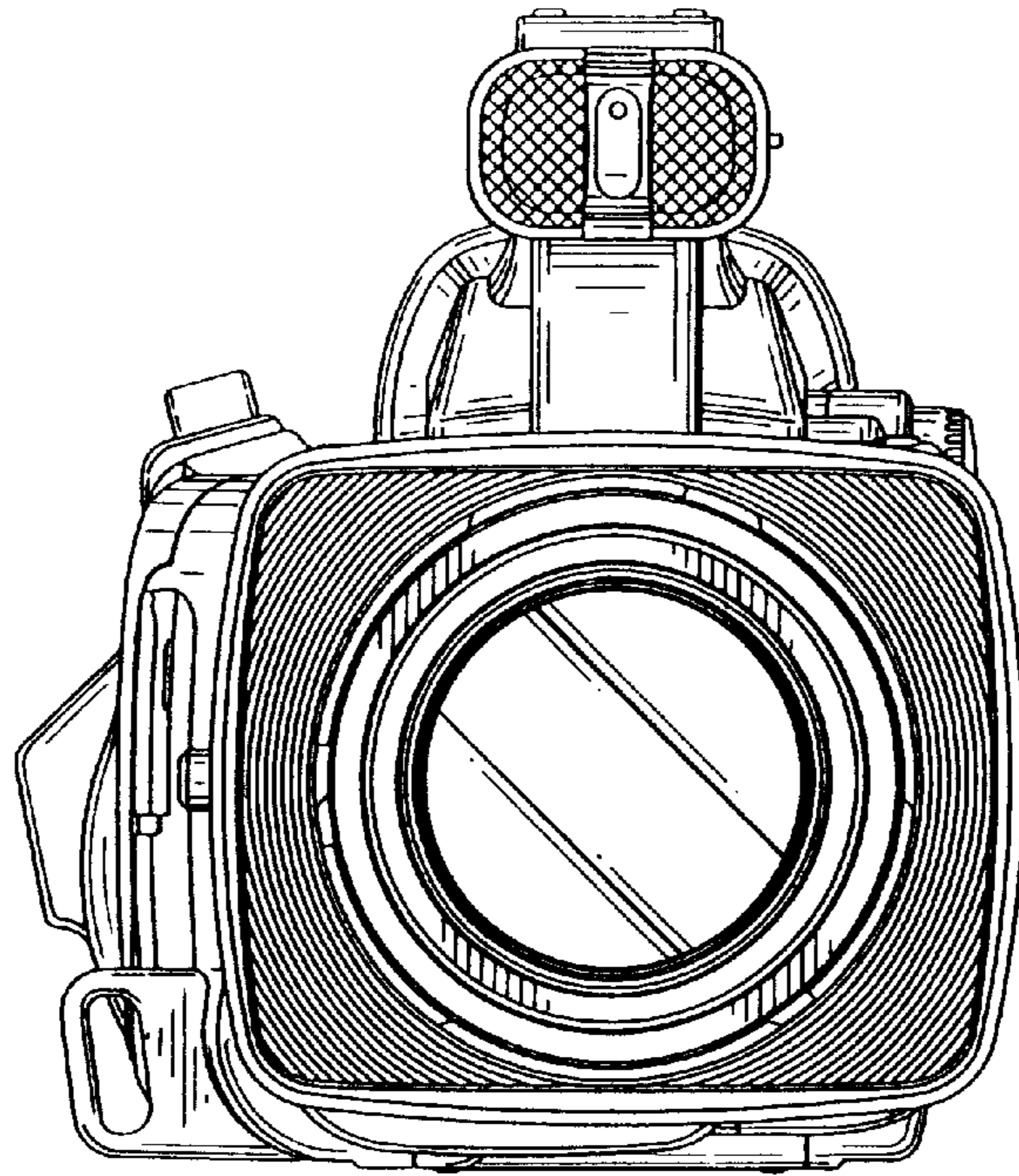
**DESCRIPTION**

FIG. 7 is a perspective view thereof.

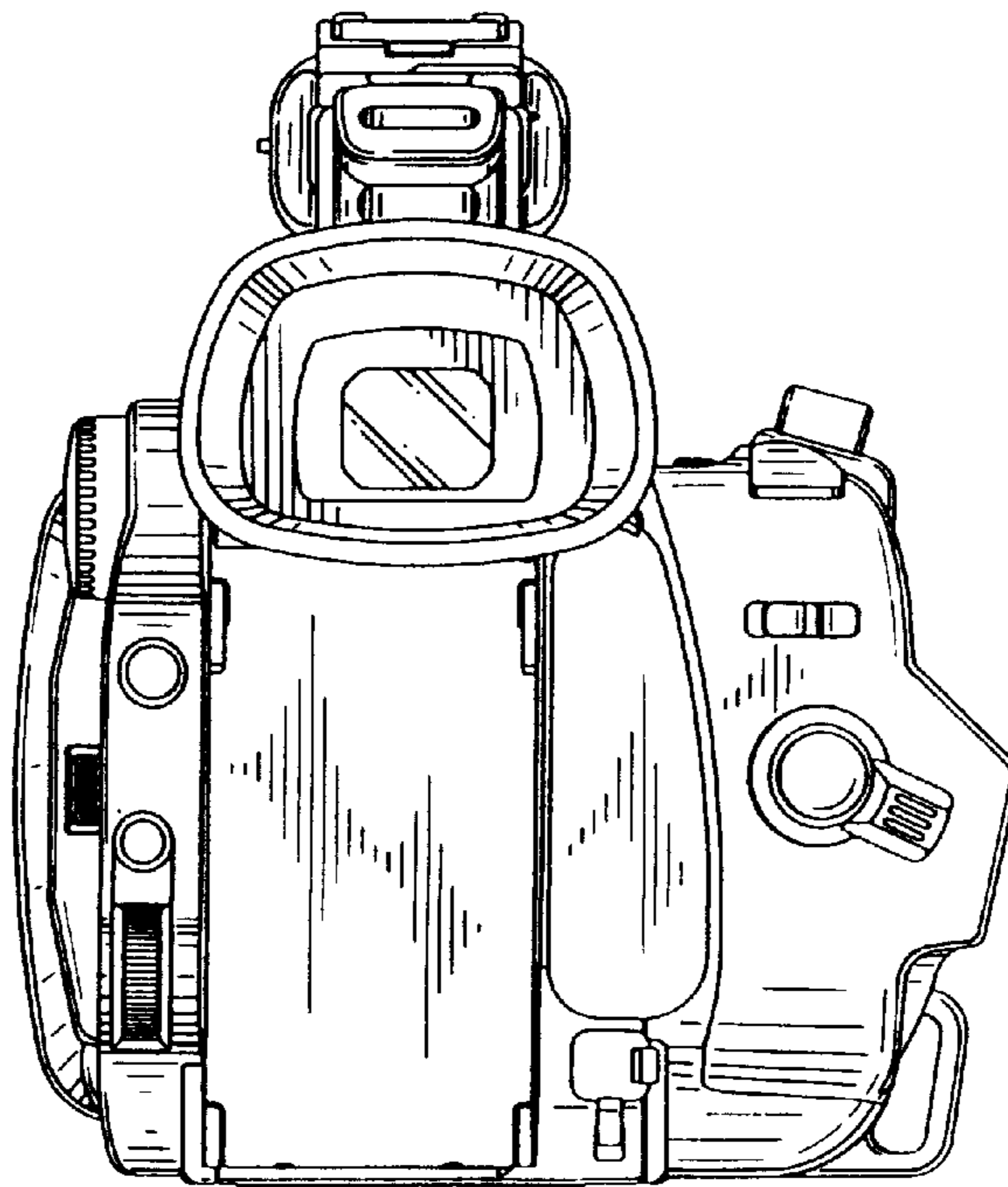

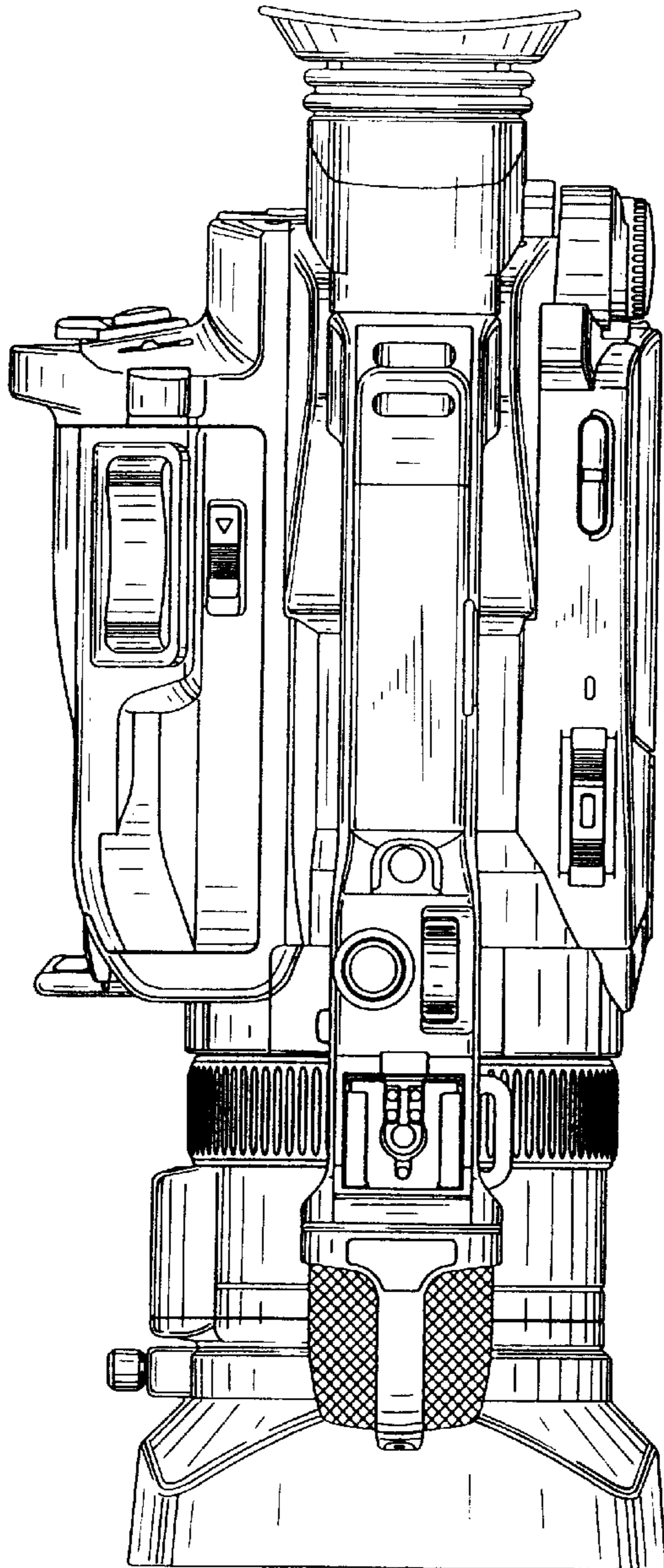

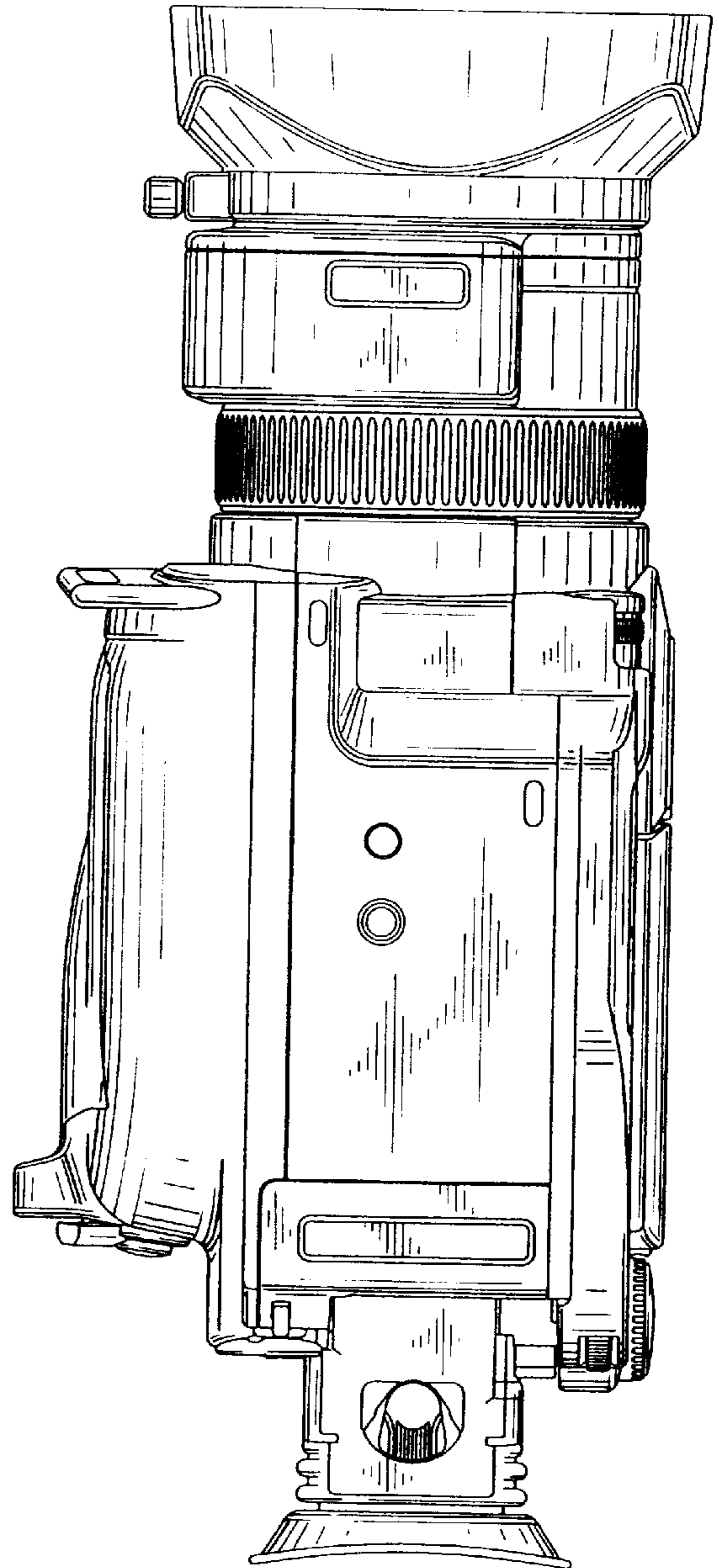

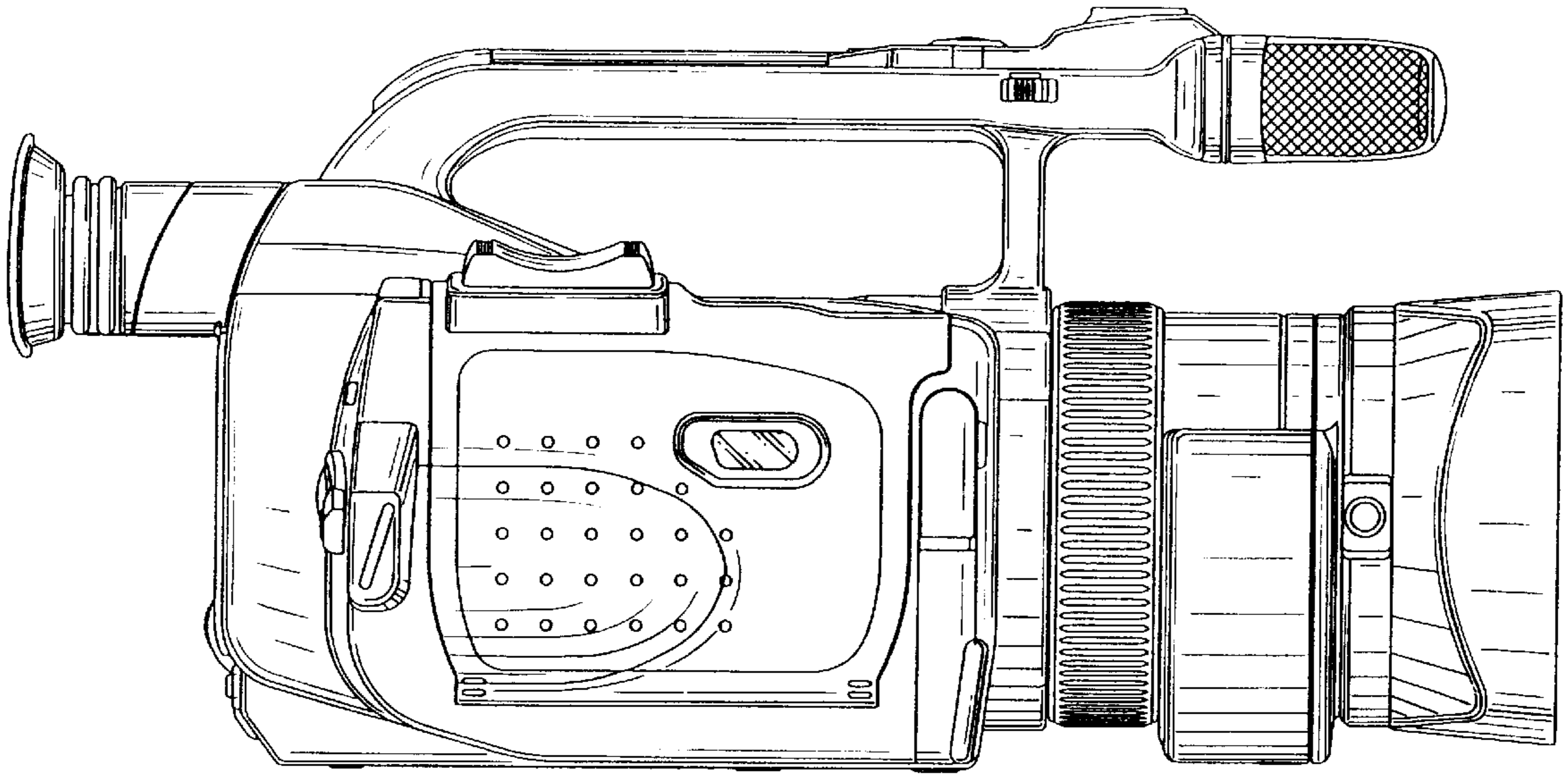

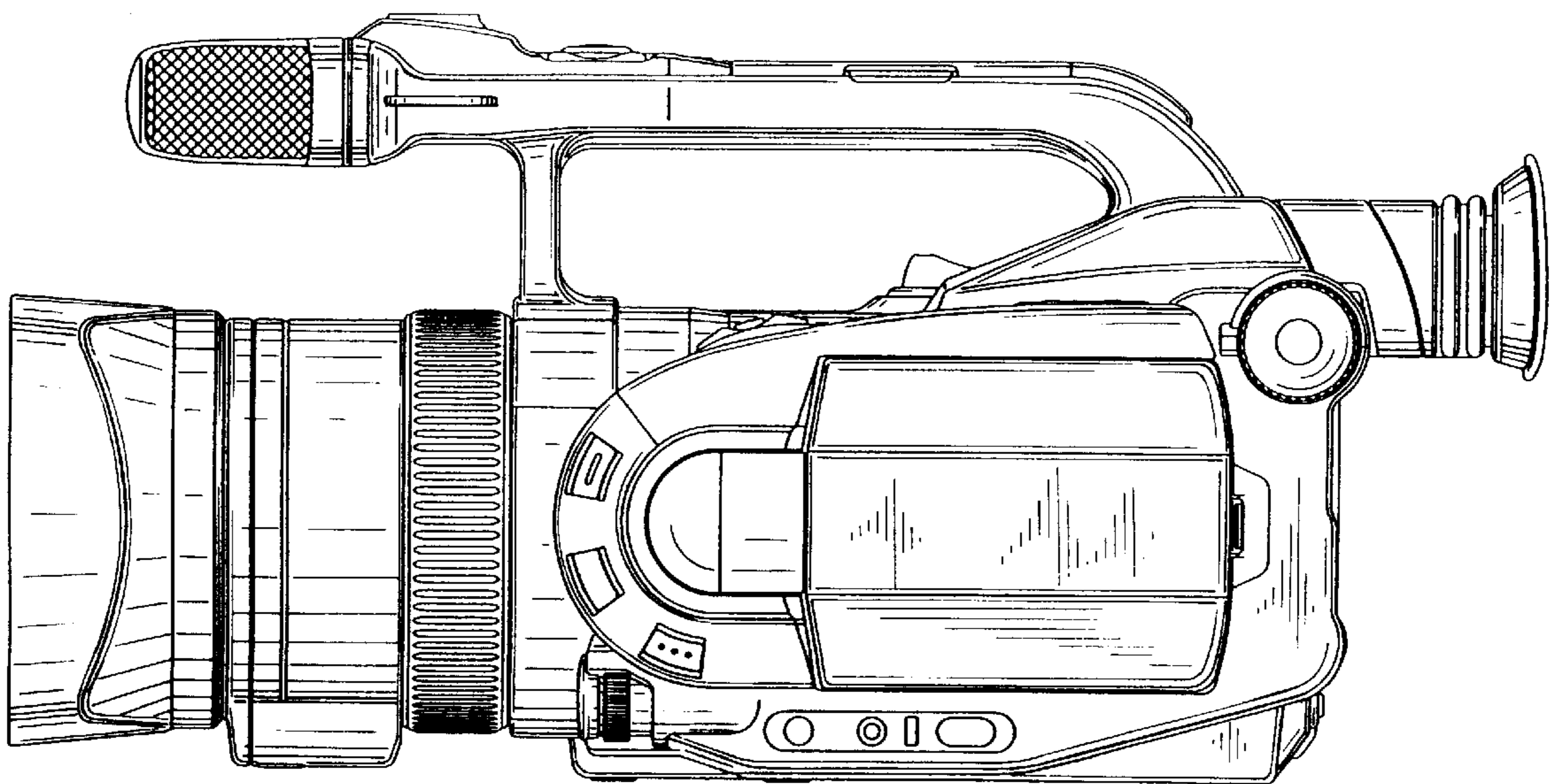
