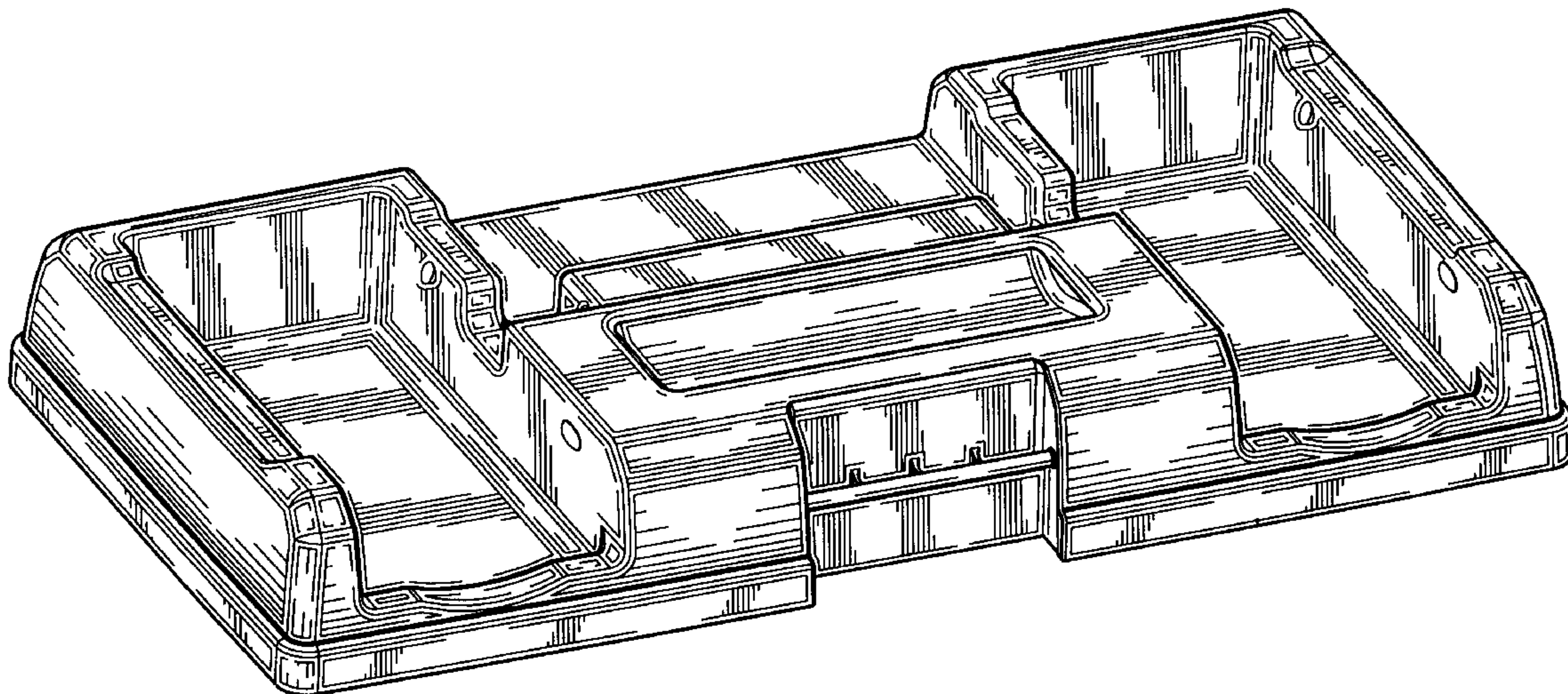
[57] **CLAIM**

The ornamental design for a lid for a tool box, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a lid for a tool box showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; and, FIG. 5 is a right side elevational view thereof, the left side being a mirror image of the right side.

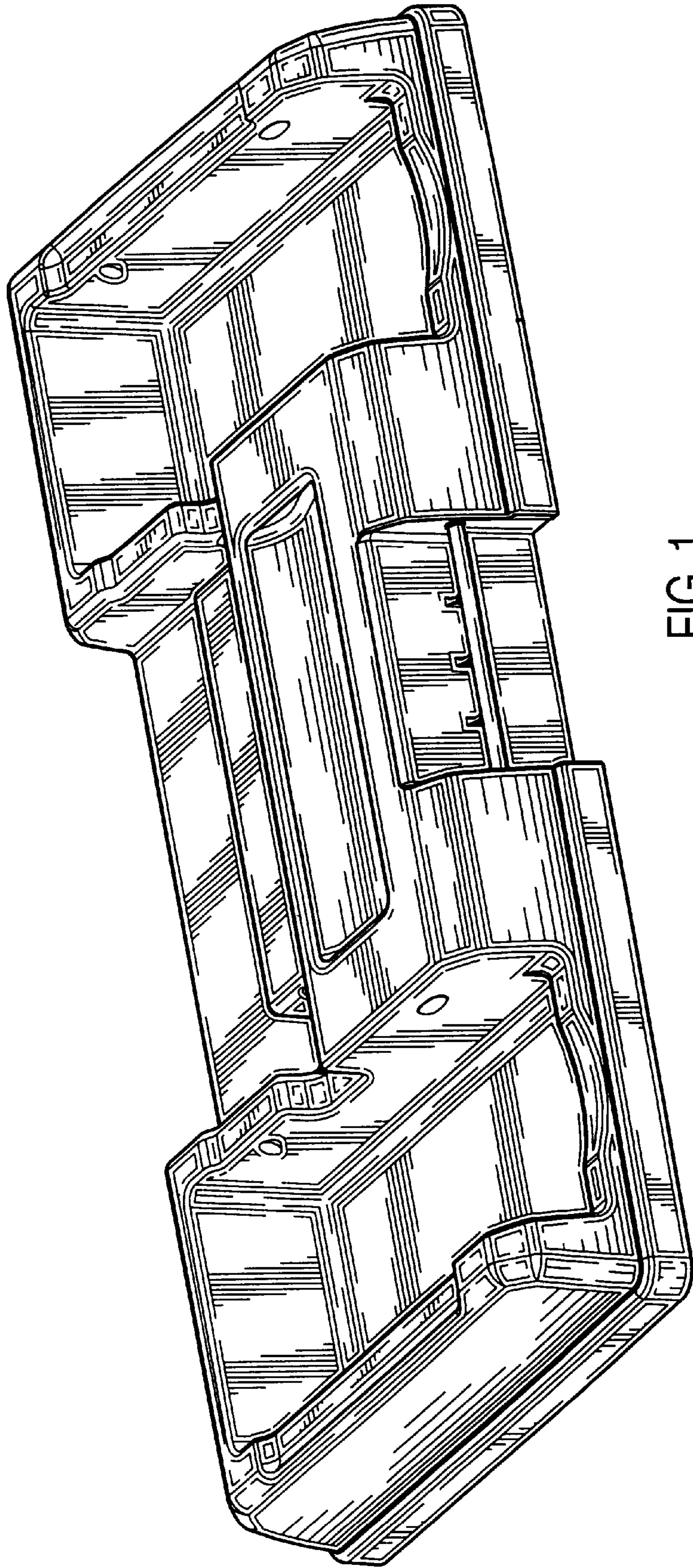

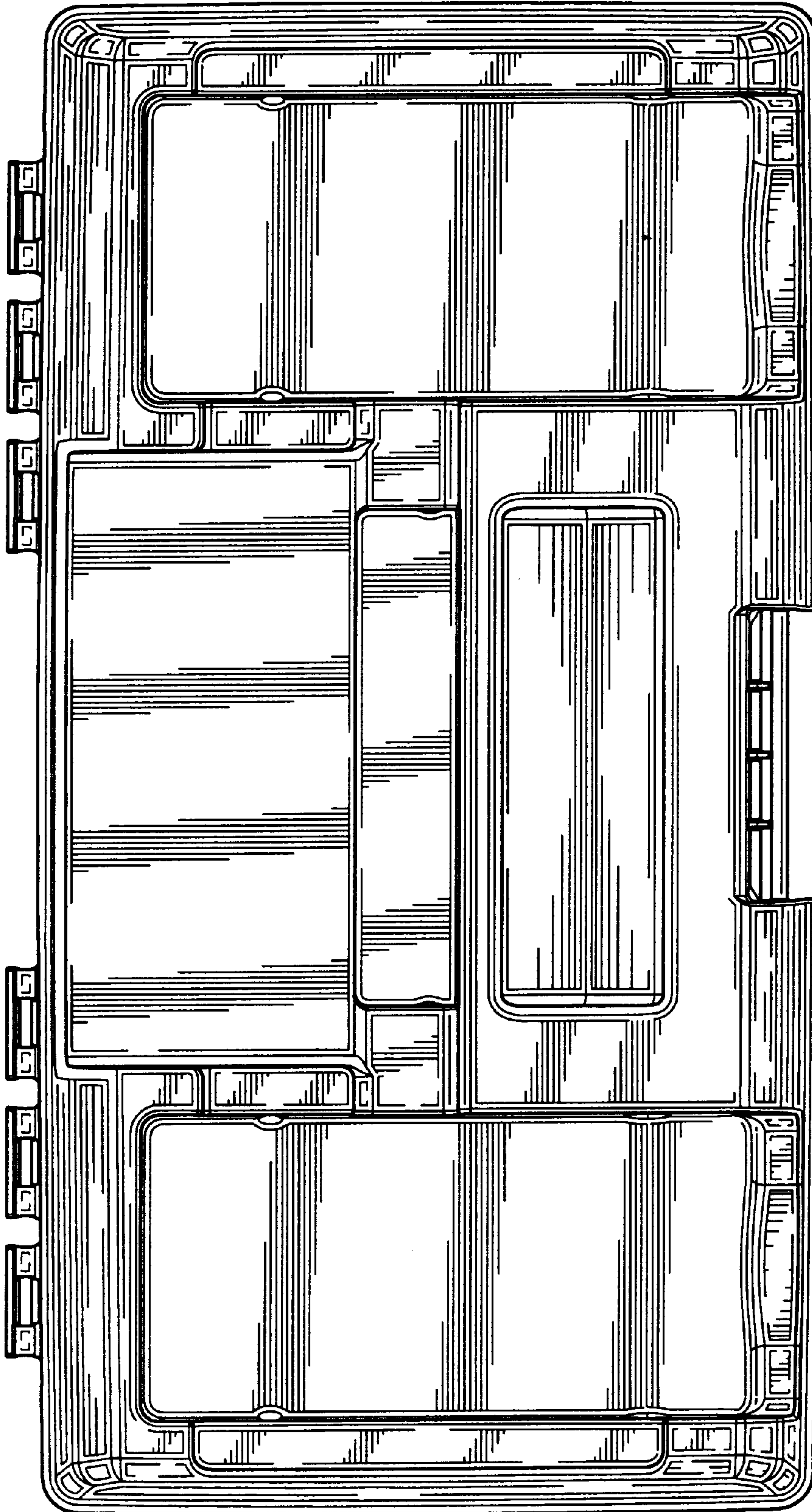

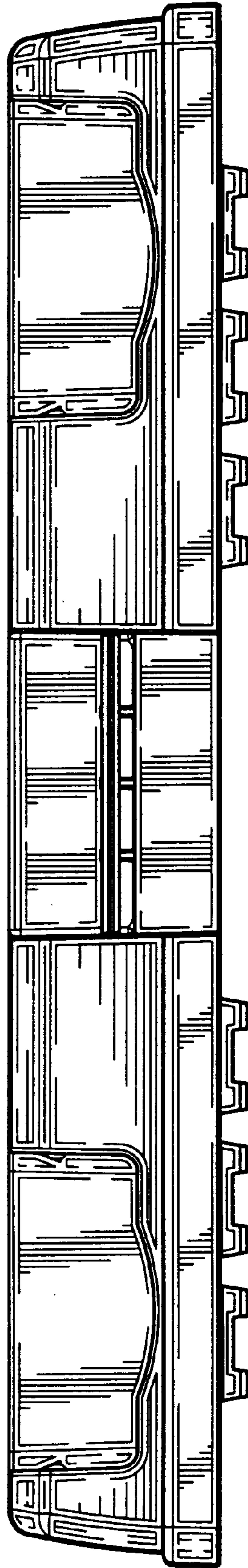

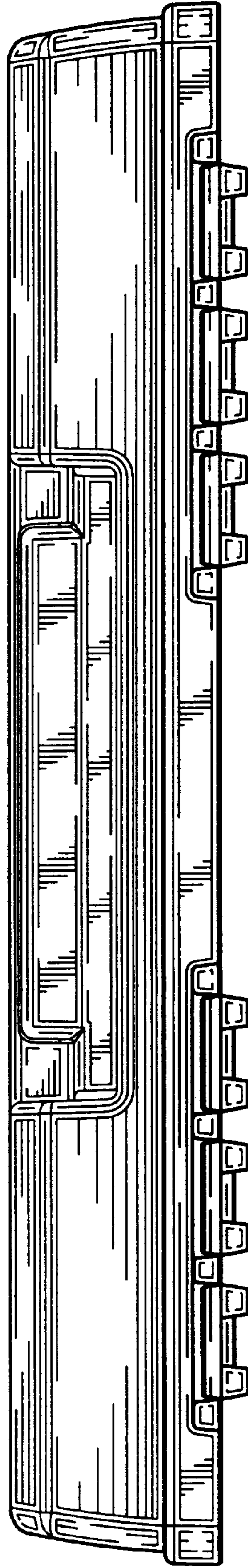

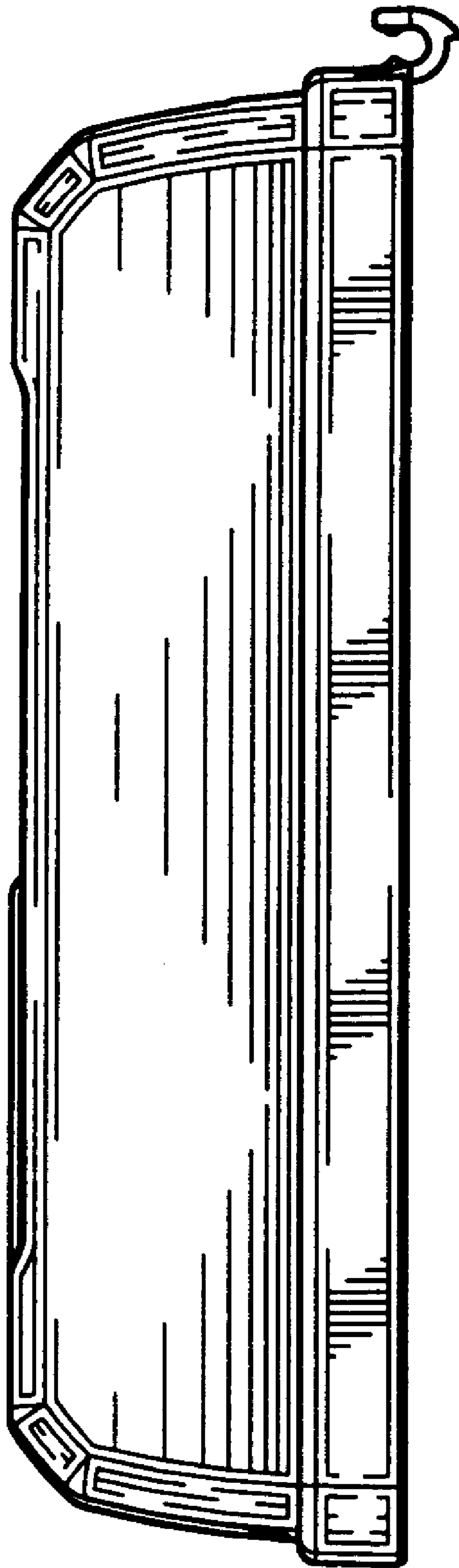
