[57] **CLAIM**

The ornamental design for a pair of motorcycle fairing guards, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a motorcycle front fairing on which are mounted a pair of motorcycle fairing guards in accordance with our new design, wherein the motorcycle front fairing is shown in dashed lines and forms no part of our invention.

FIG. 2 is an enlarged front elevational view of the right hand fairing guard of the pair of motorcycle fairing guards, shown separately for ease of illustration.

FIG. 3 is a left end view of FIG. 2.

FIG. 4 is a right end view of FIG. 2.

FIG. 5 is a top view of FIG. 2.

FIG. 6 is a bottom view of FIG. 2.

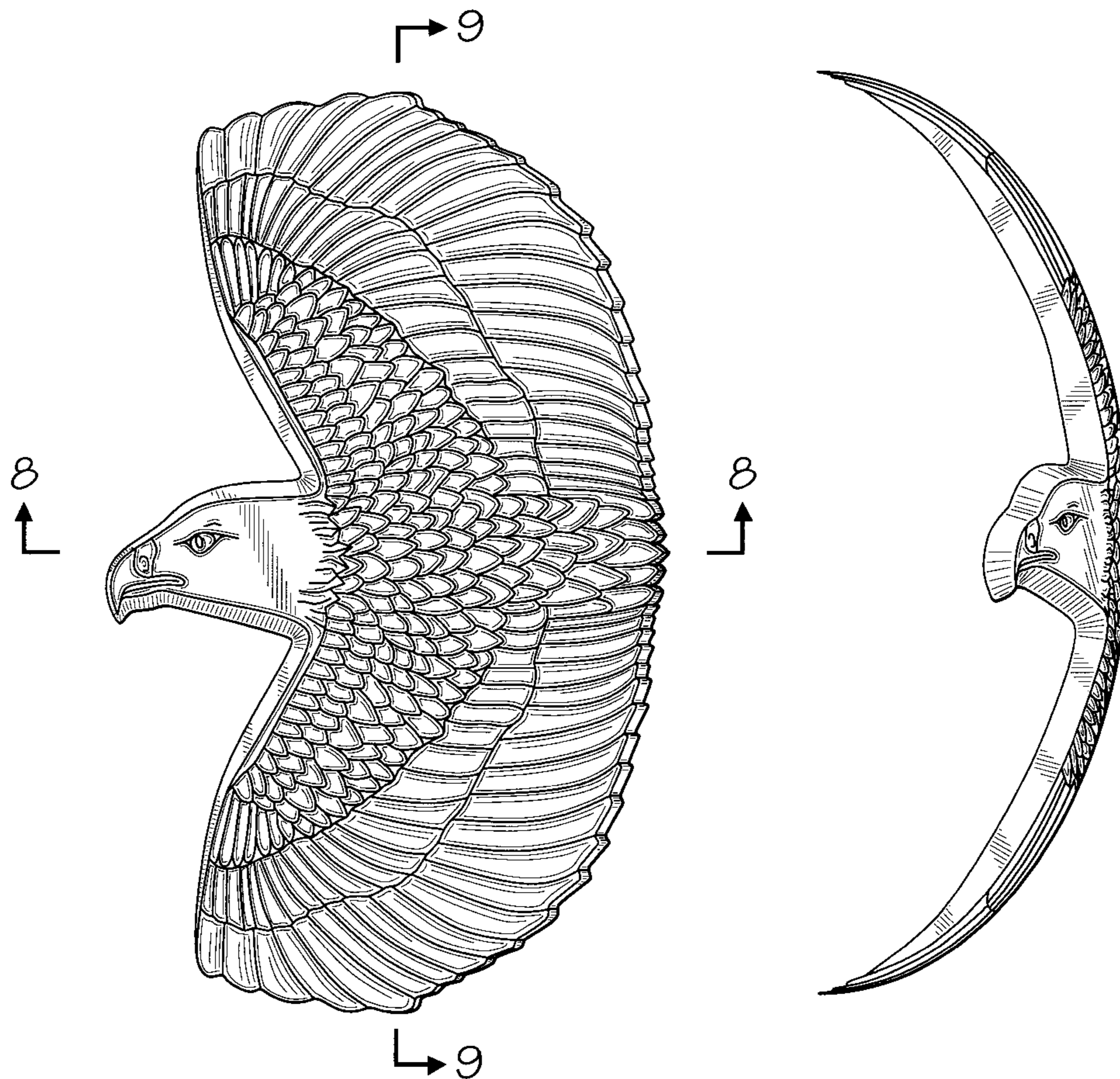
FIG. 7 is a rear elevational view of FIG. 2.

FIG. 8 is a cross-sectional view thereof taken along the line 8—8 of FIG. 2; and,

FIG. 9 is a cross-sectional view thereof taken along the line 9—9 of FIG. 2.

The left hand fairing guard of the pair of motorcycle fairing guards is a mirror image of the right hand fairing guard.

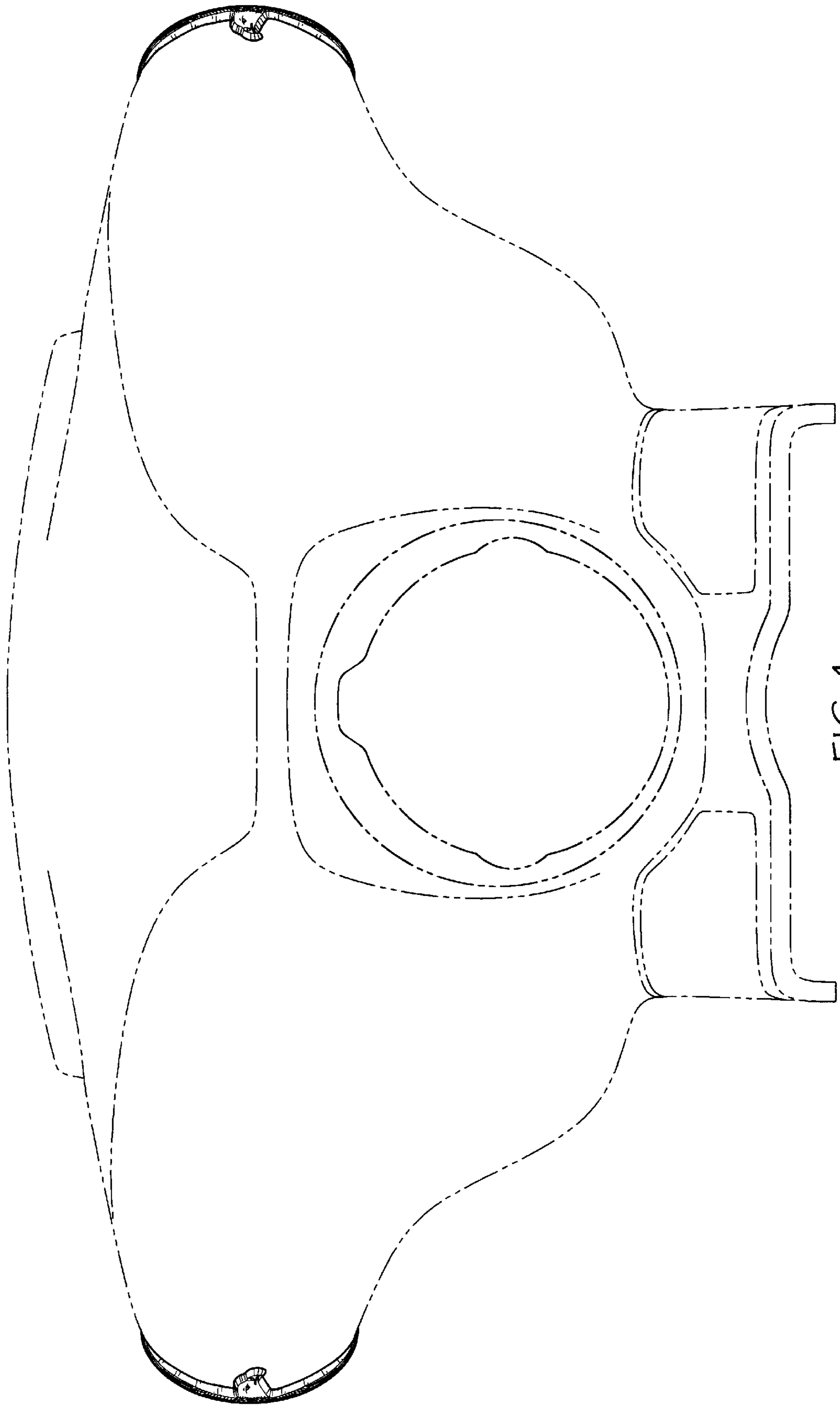

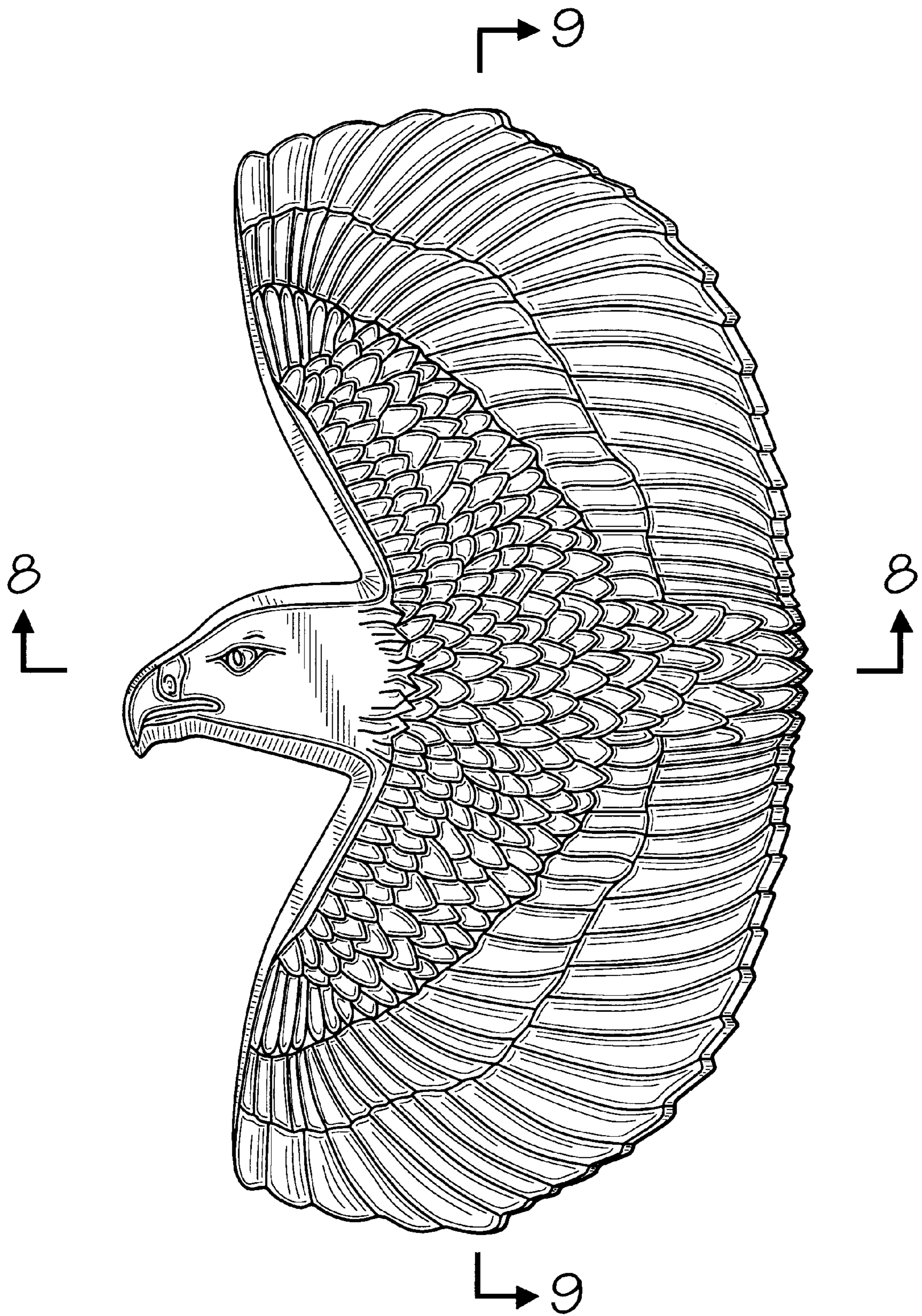

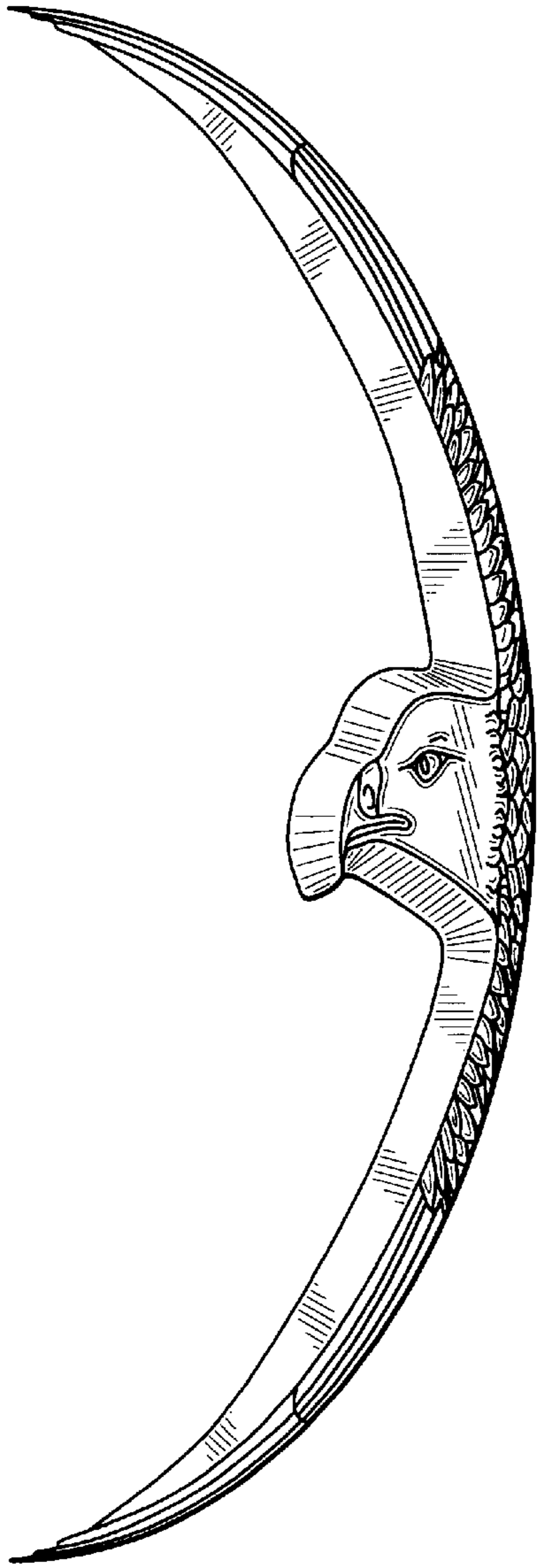

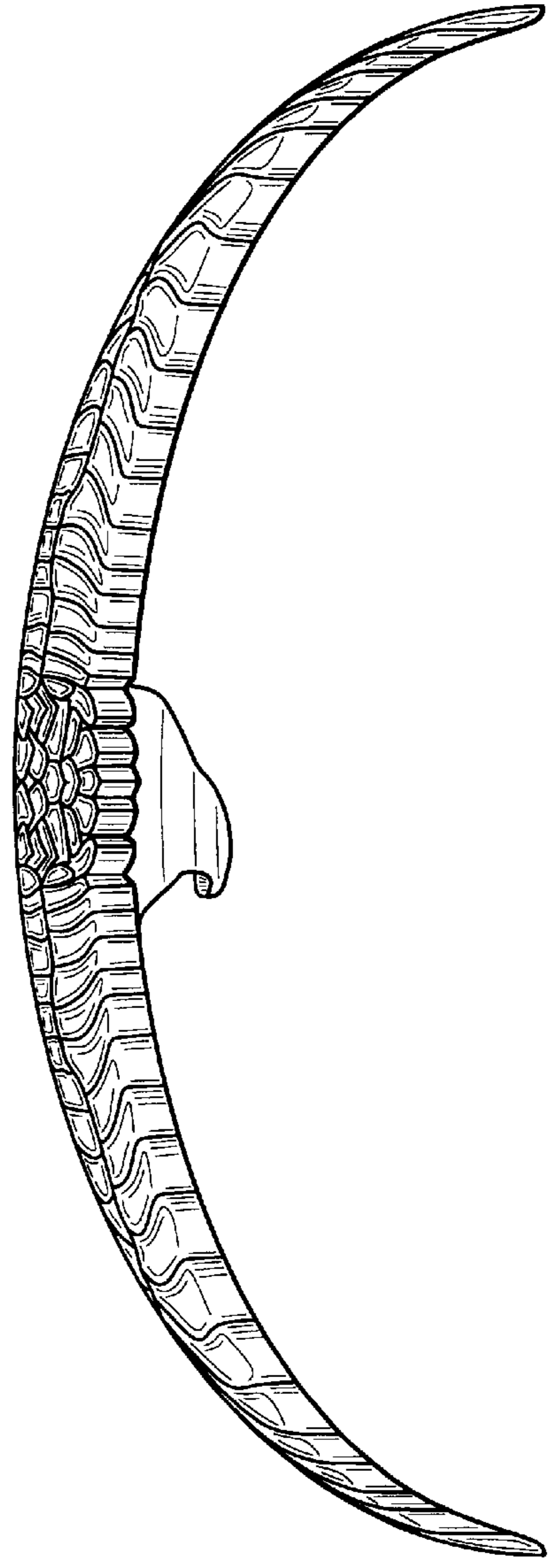

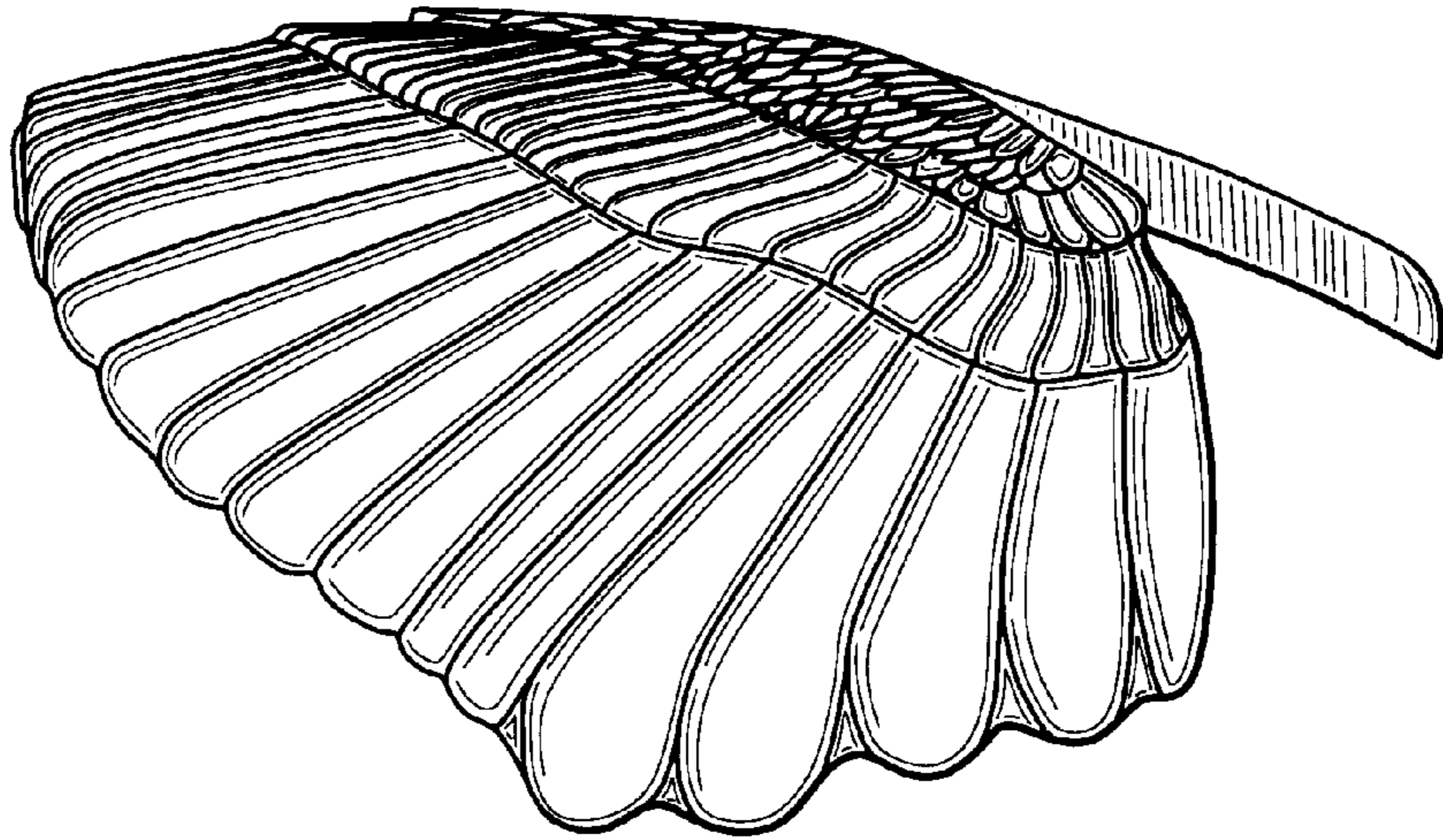

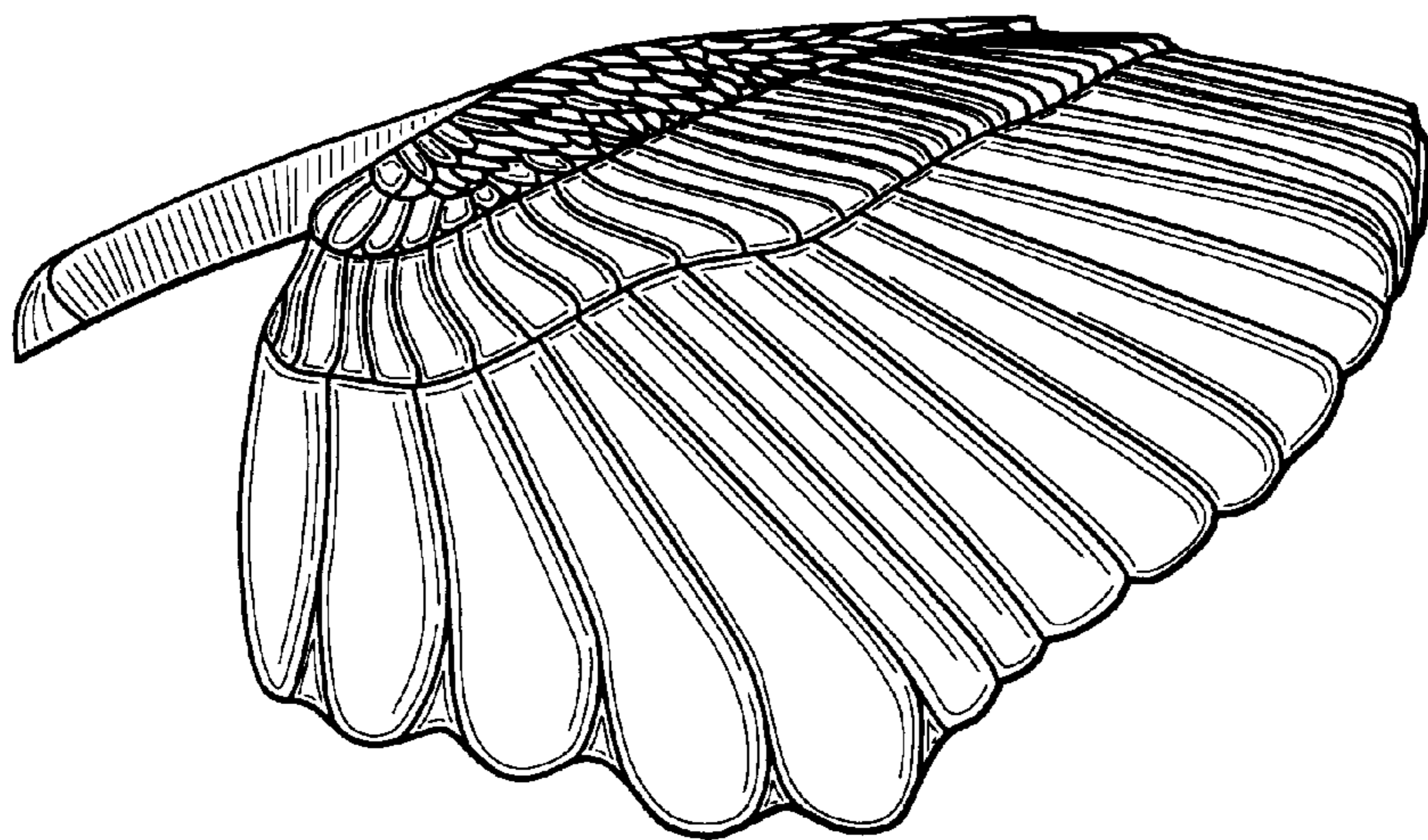

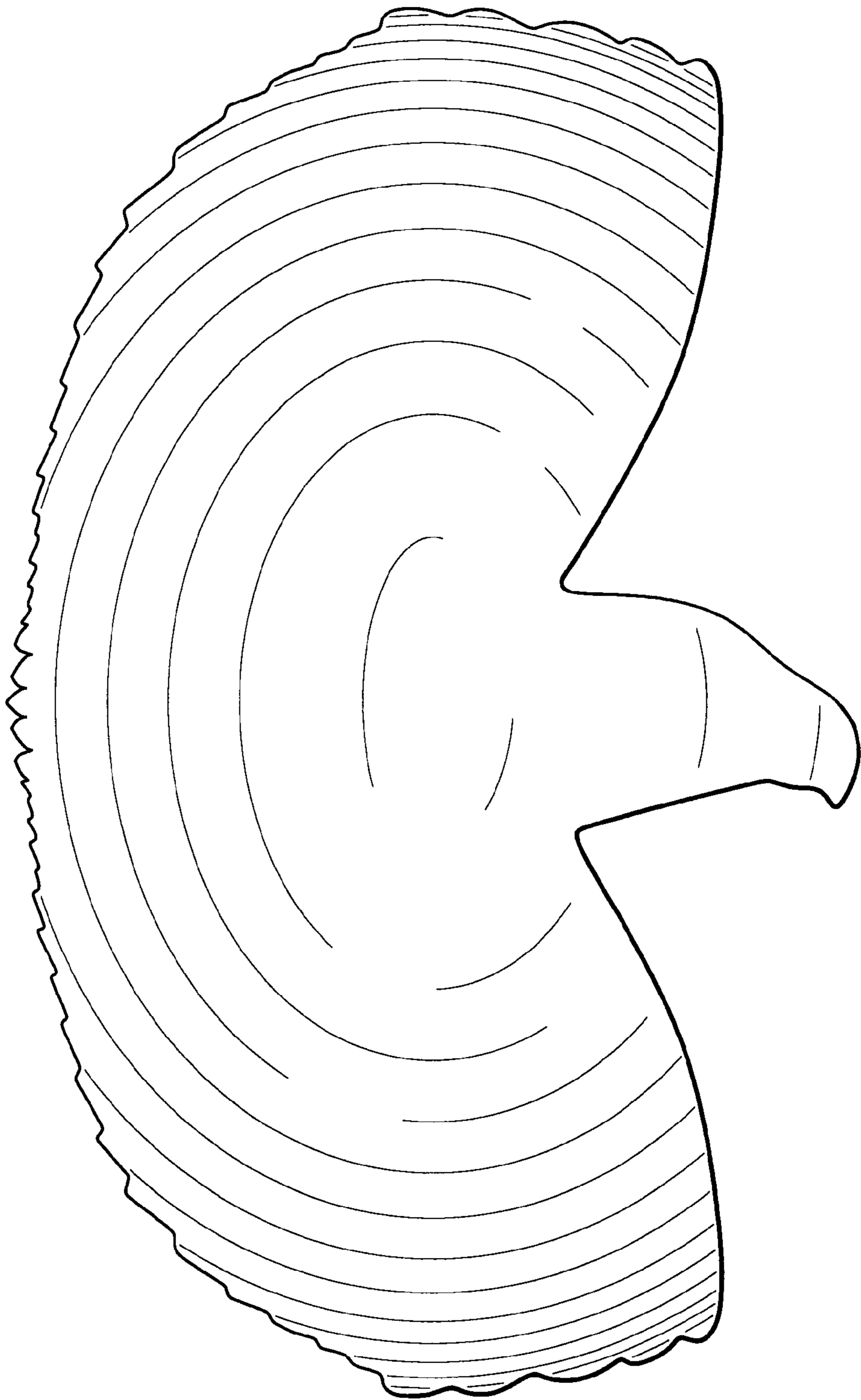

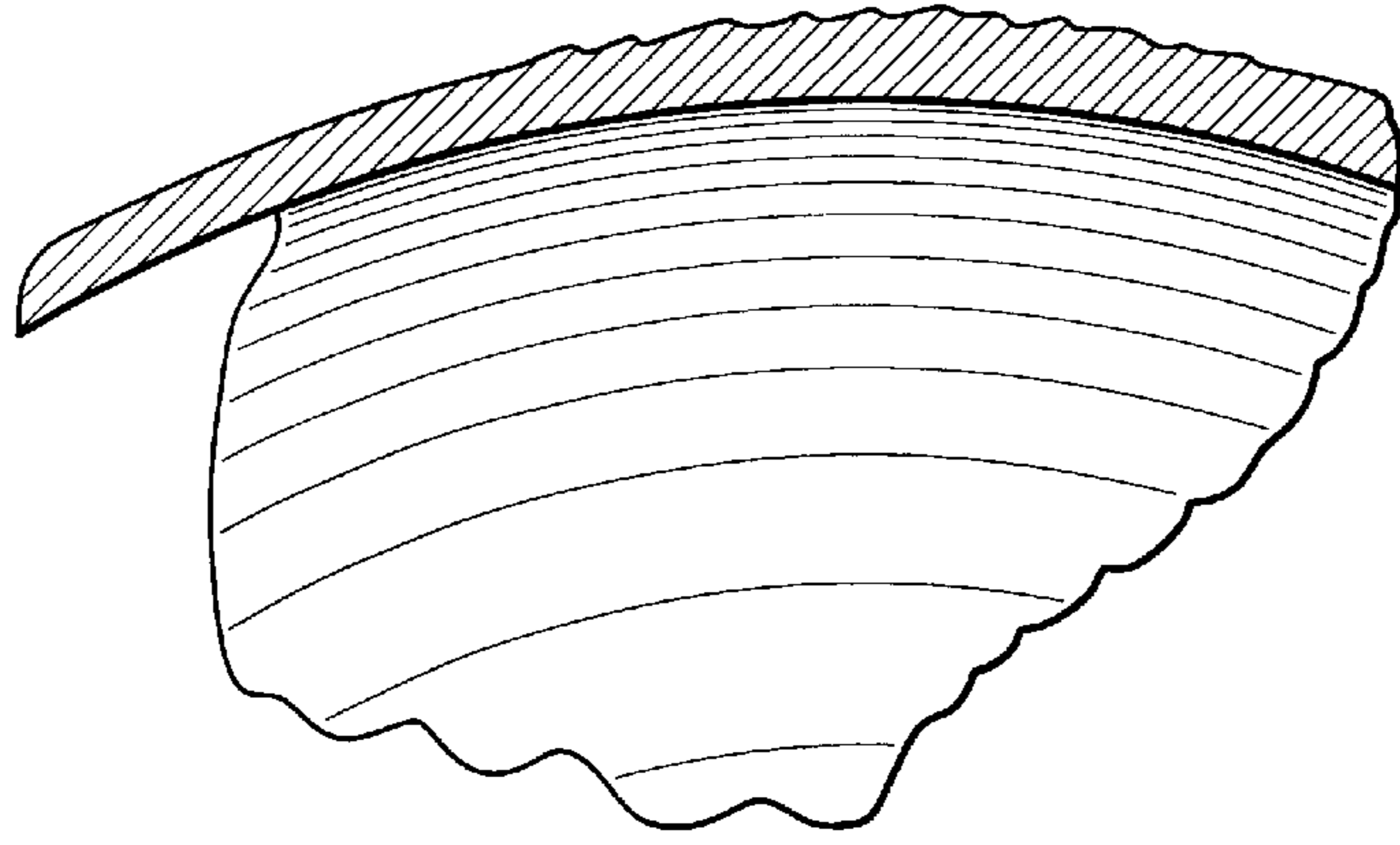

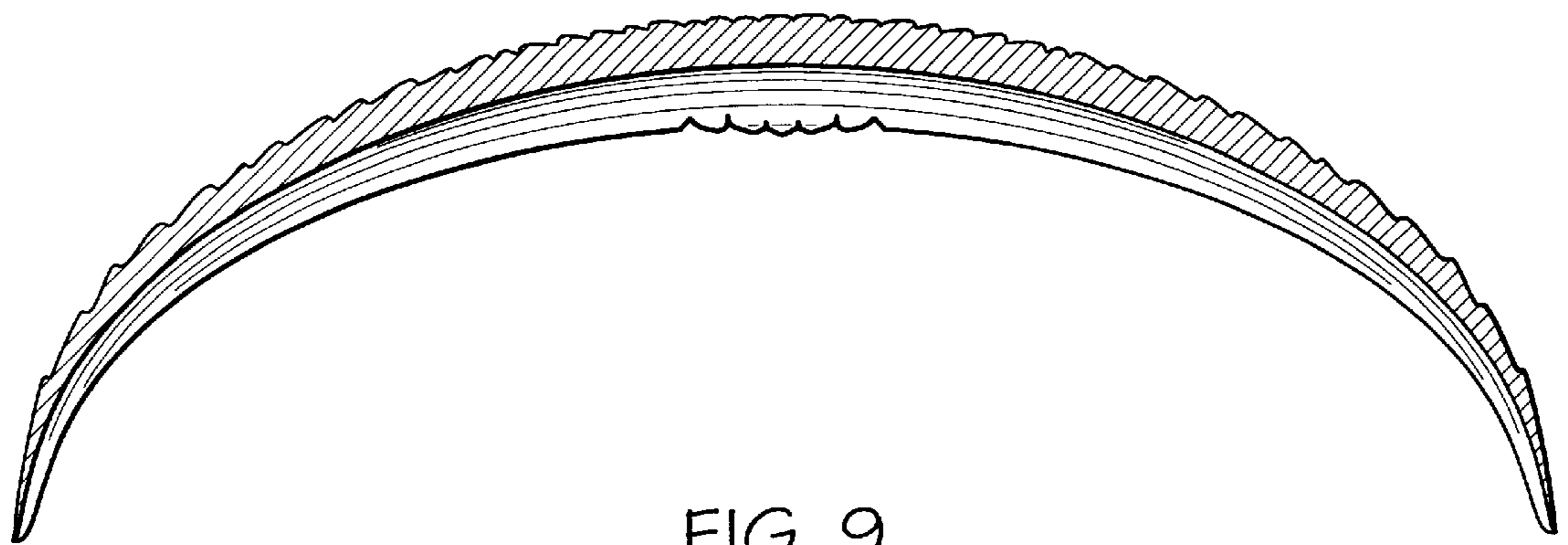
