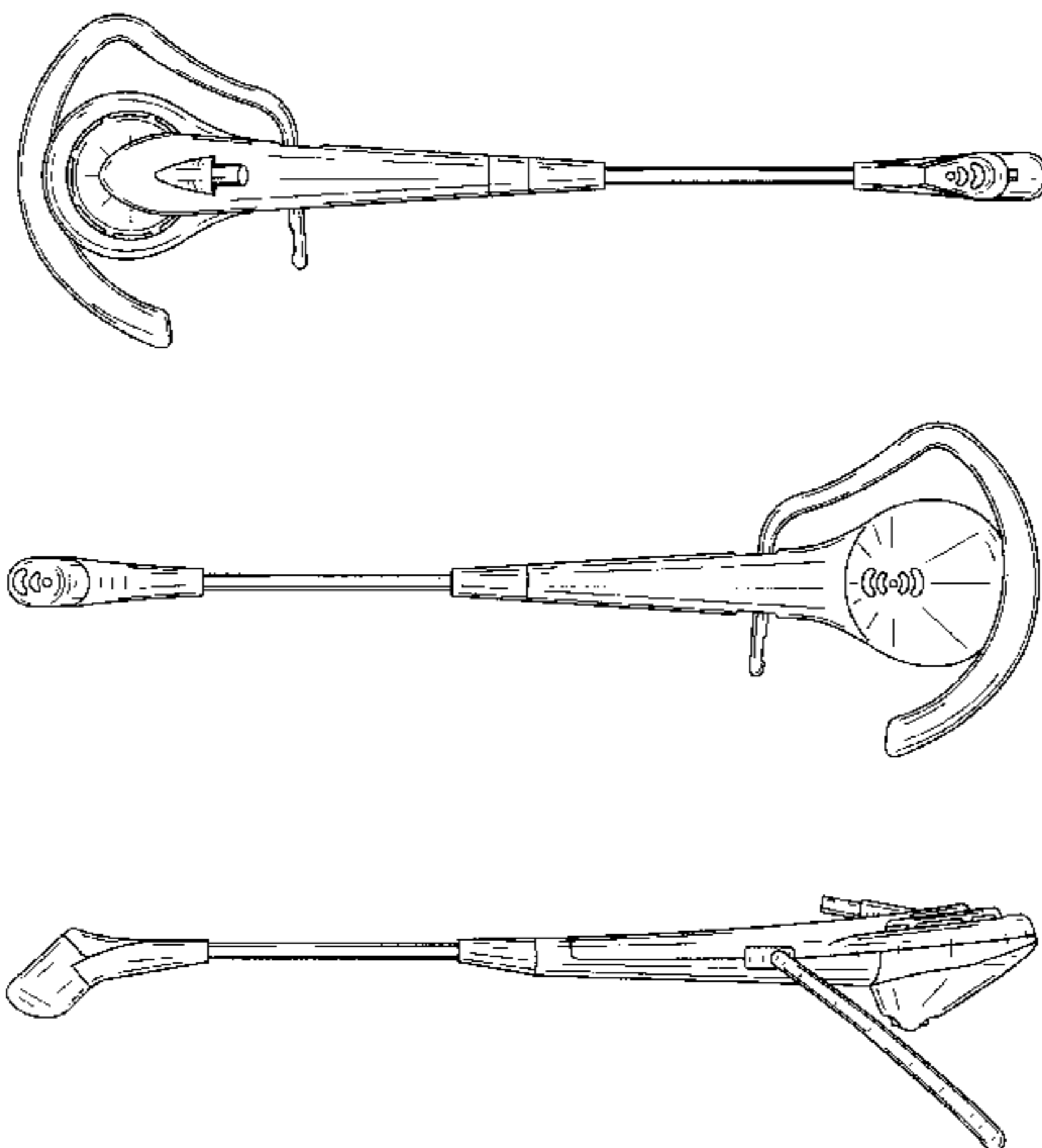
[57] **CLAIM**

The ornamental design for earhook headset, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an earhook headset showing our new design; the broken line human head wearing the earhook headset is for illustrative purposes only and forms no part of the claimed design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

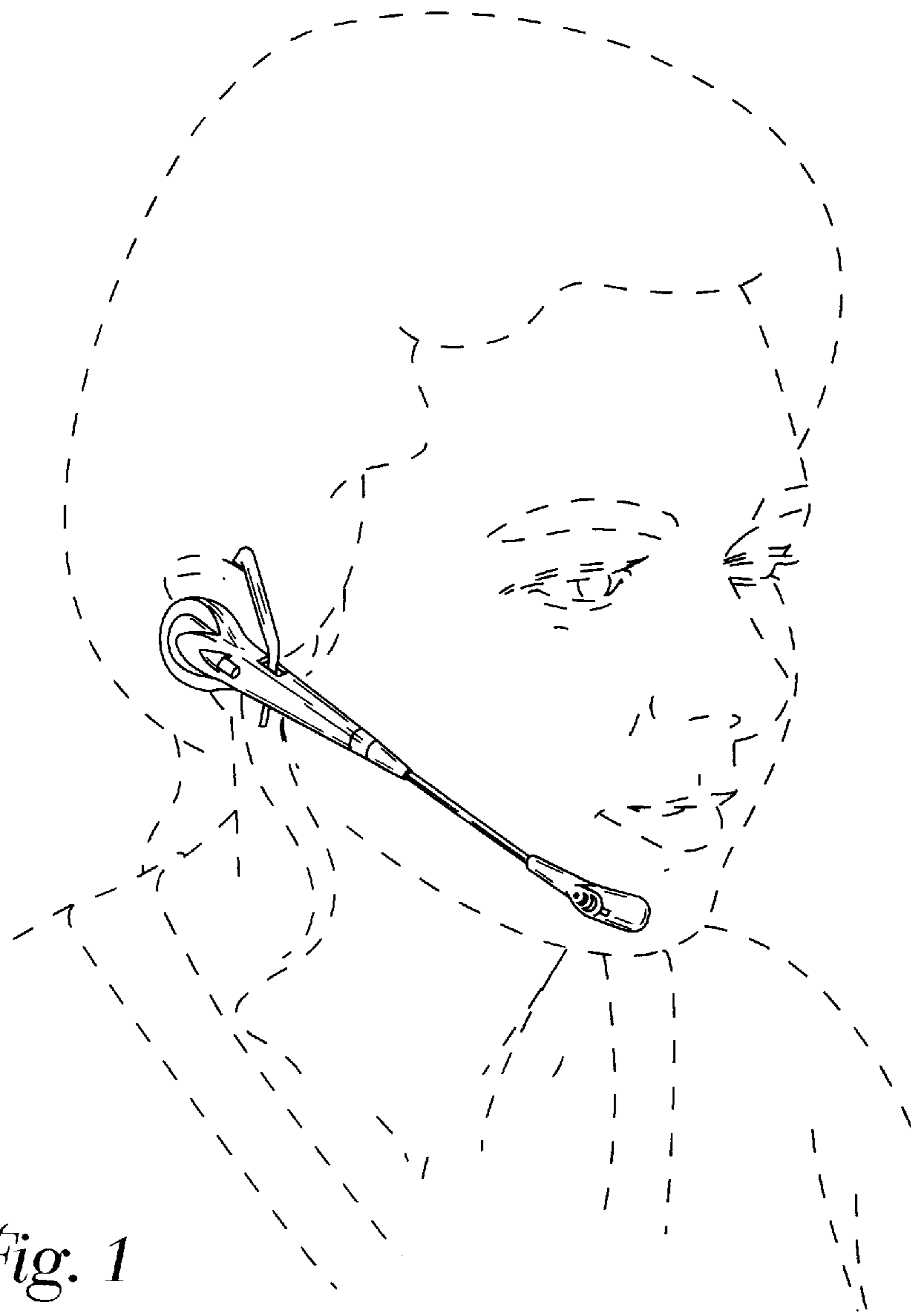

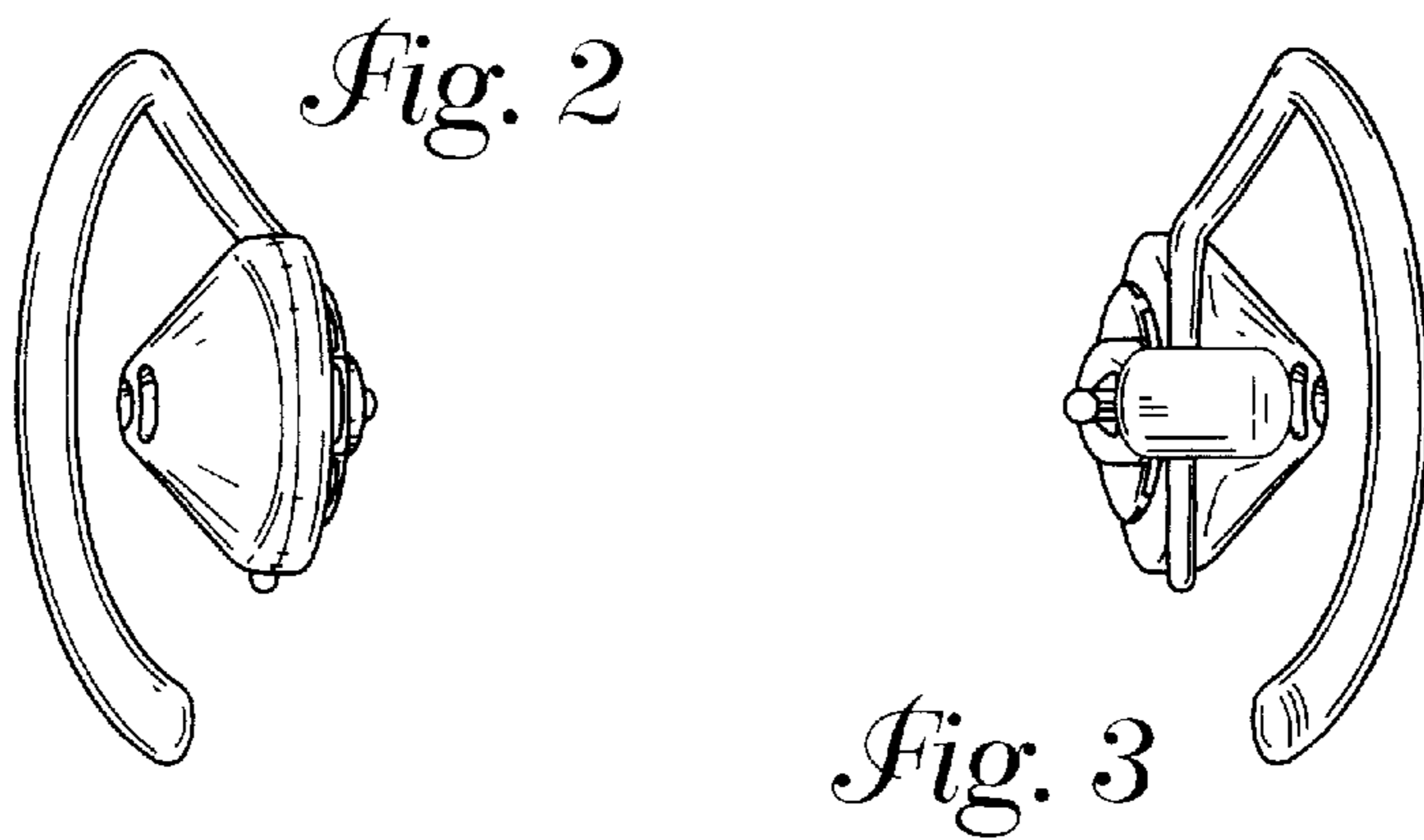

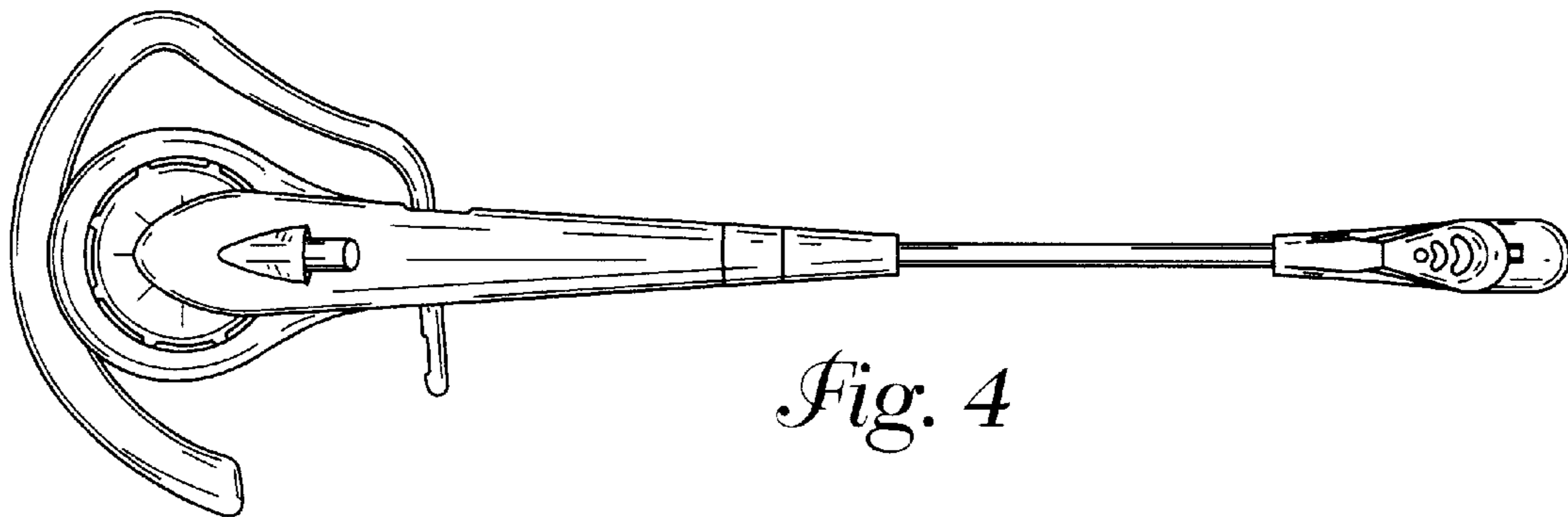

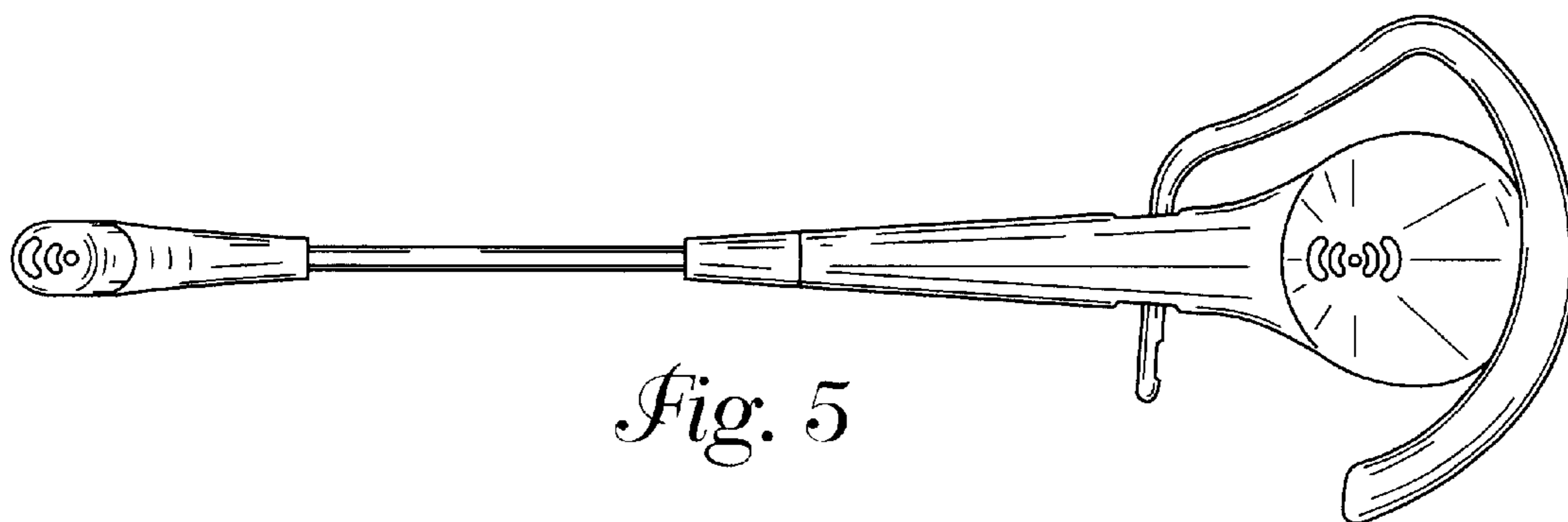

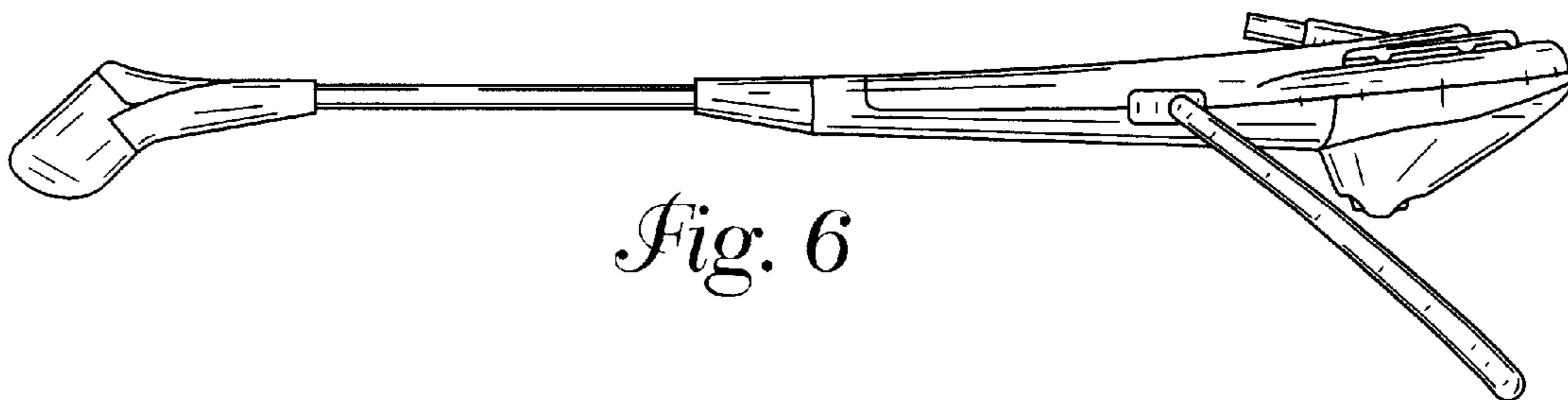

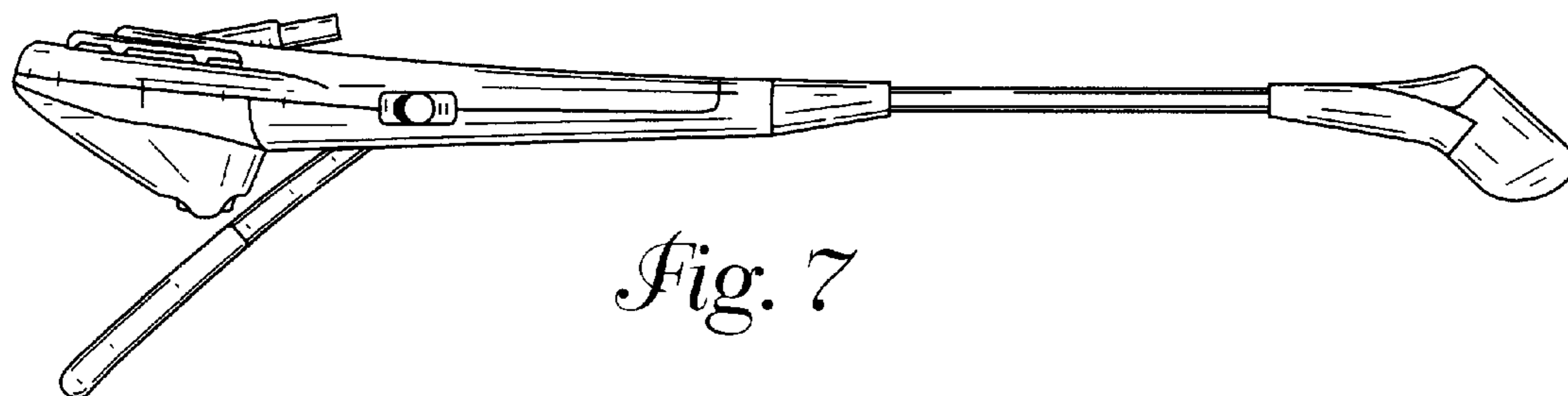
