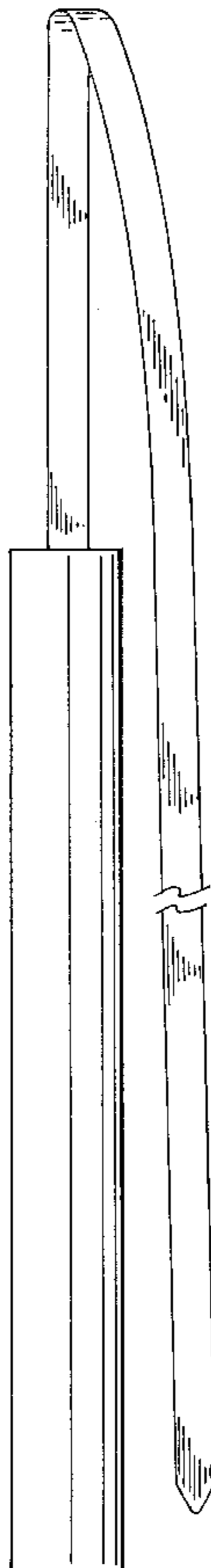
### [57] CLAIM

The ornamental design for a cat toy, as shown and described.

#### DESCRIPTION

FIG. 1 is a front elevational view of a new design for a cat toy, the rear view being a mirror image thereof; FIG. 2 is a side elevational view with reference to FIG. 1, the opposite side view being a mirror image thereof; FIG. 3 is a top plan view, also with reference to FIG. 1; and, FIG. 4 is a bottom plan view.

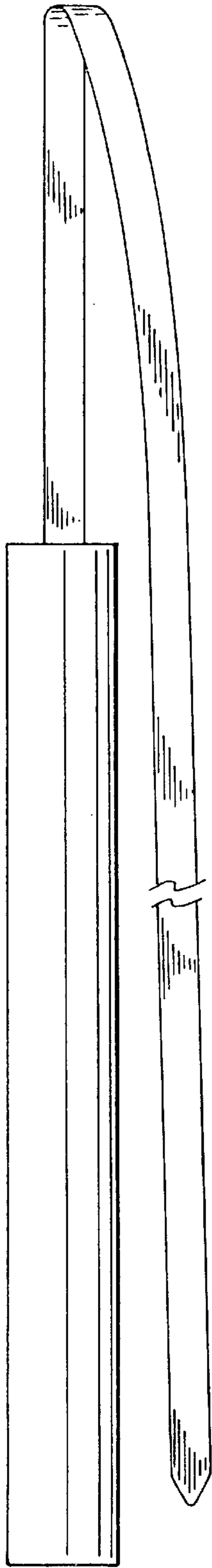

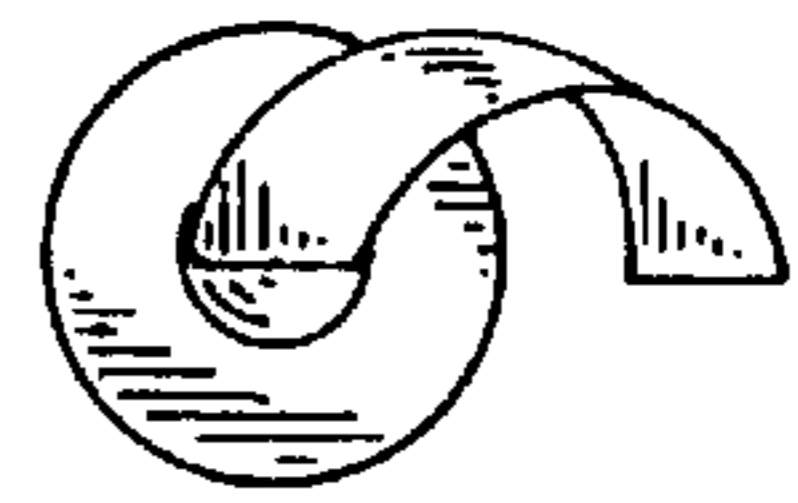

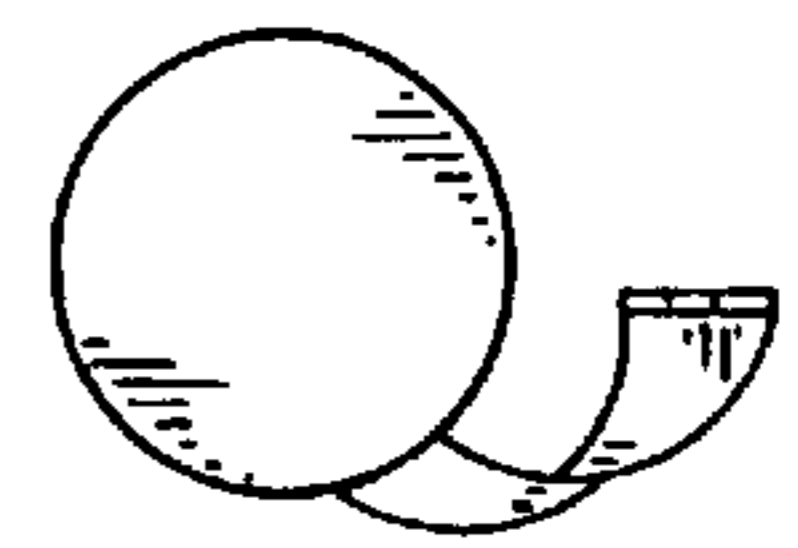
