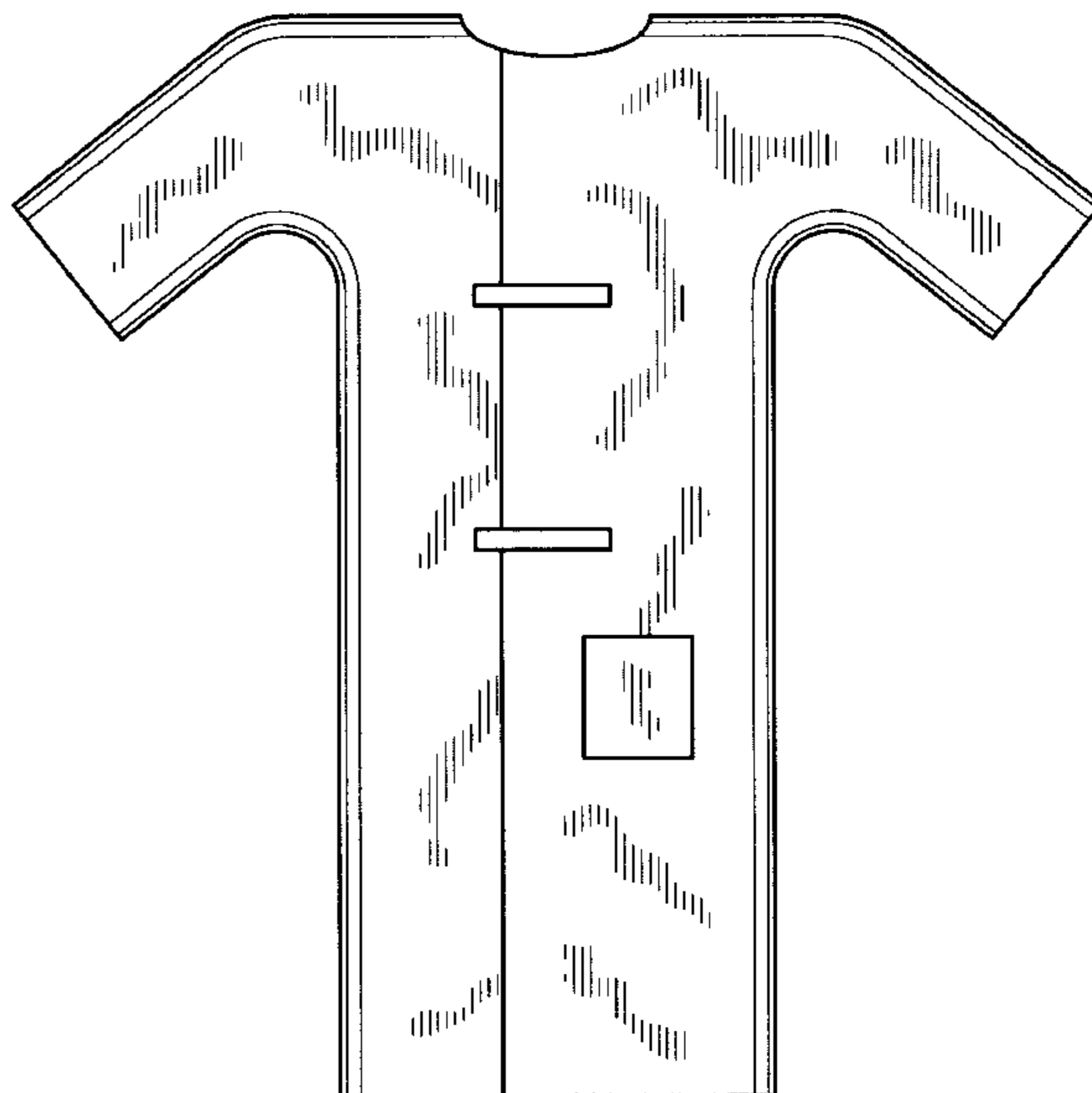
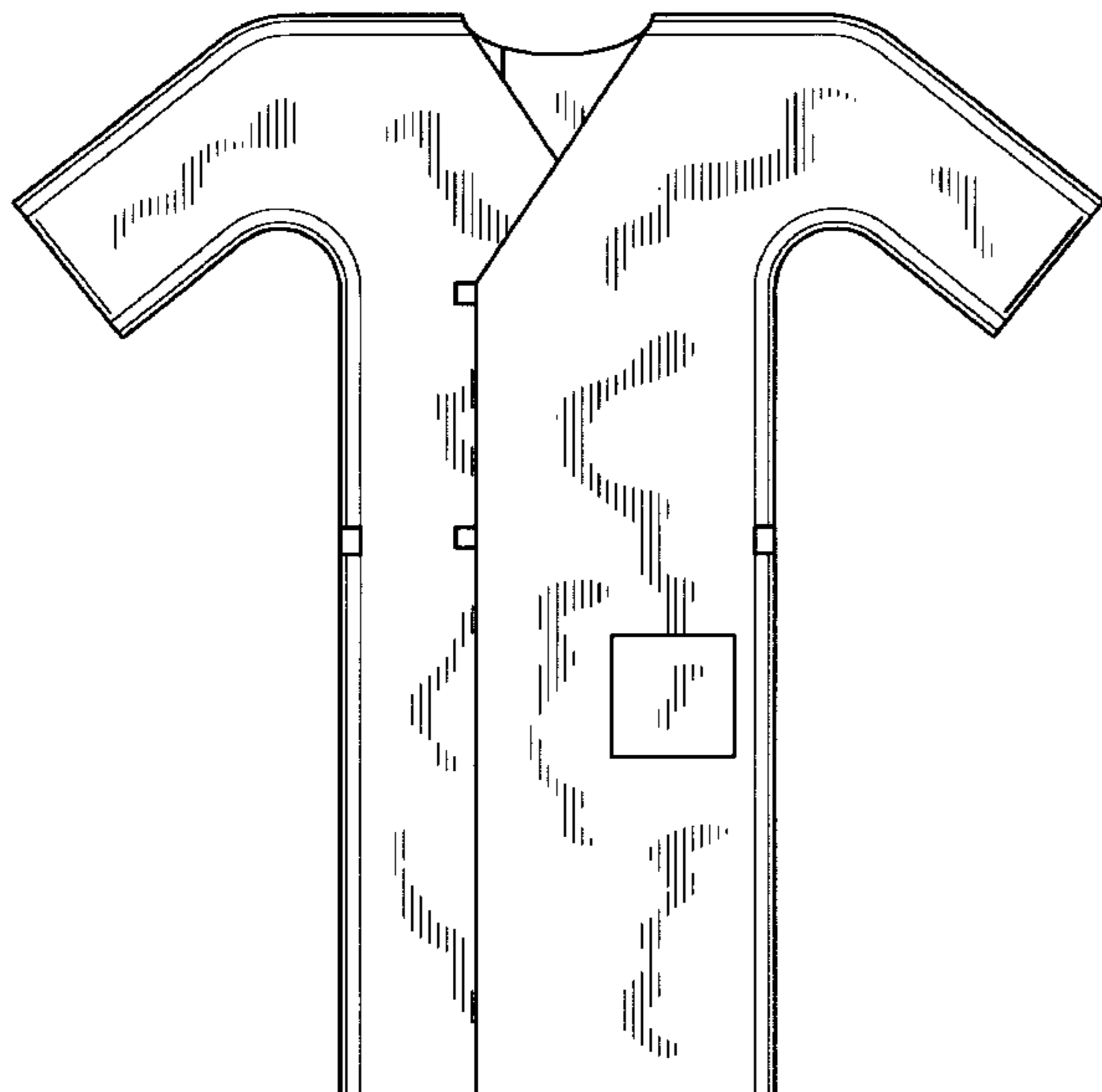

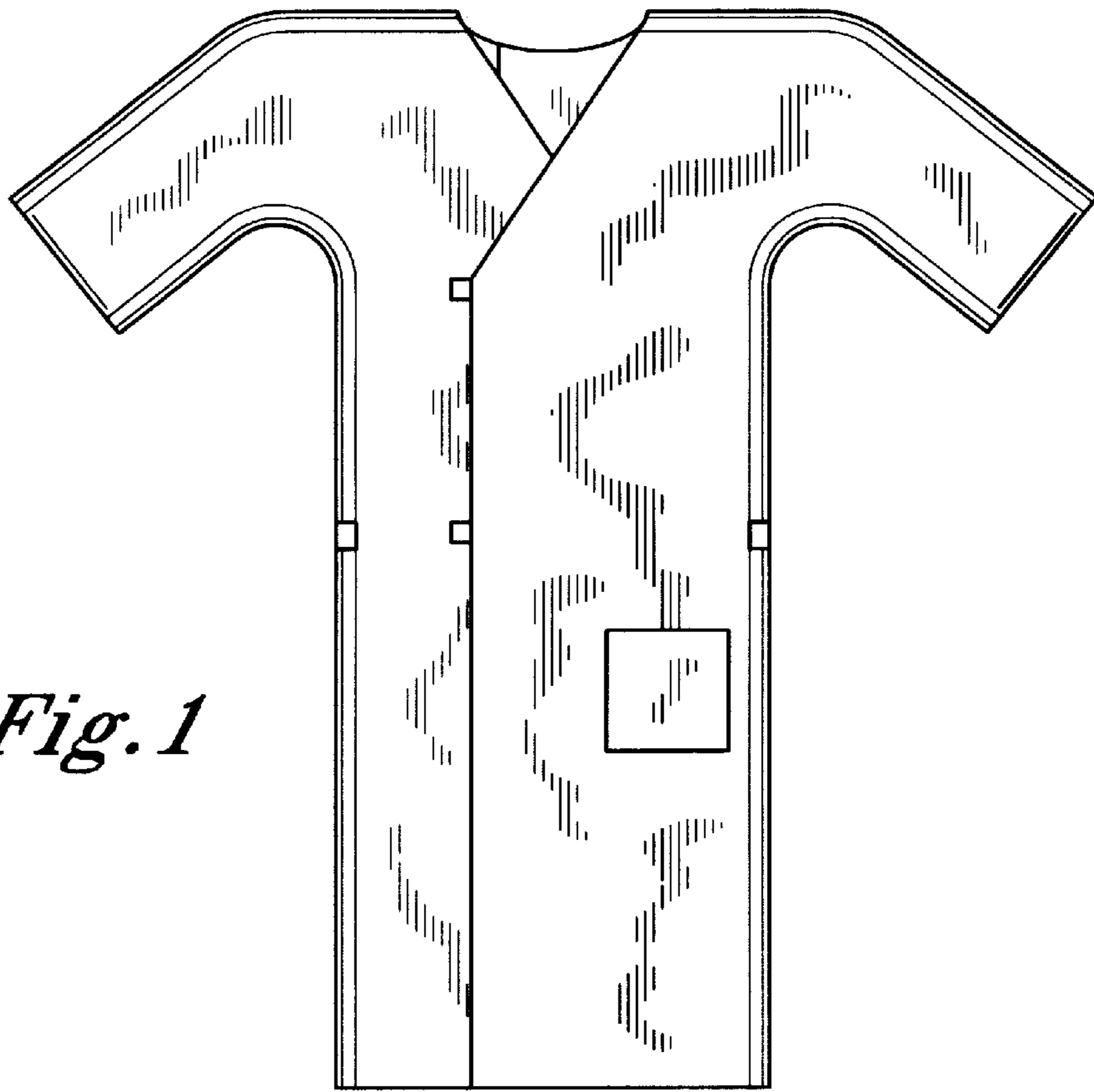
The ornamental design for a patient garment, as shown.

**DESCRIPTION**

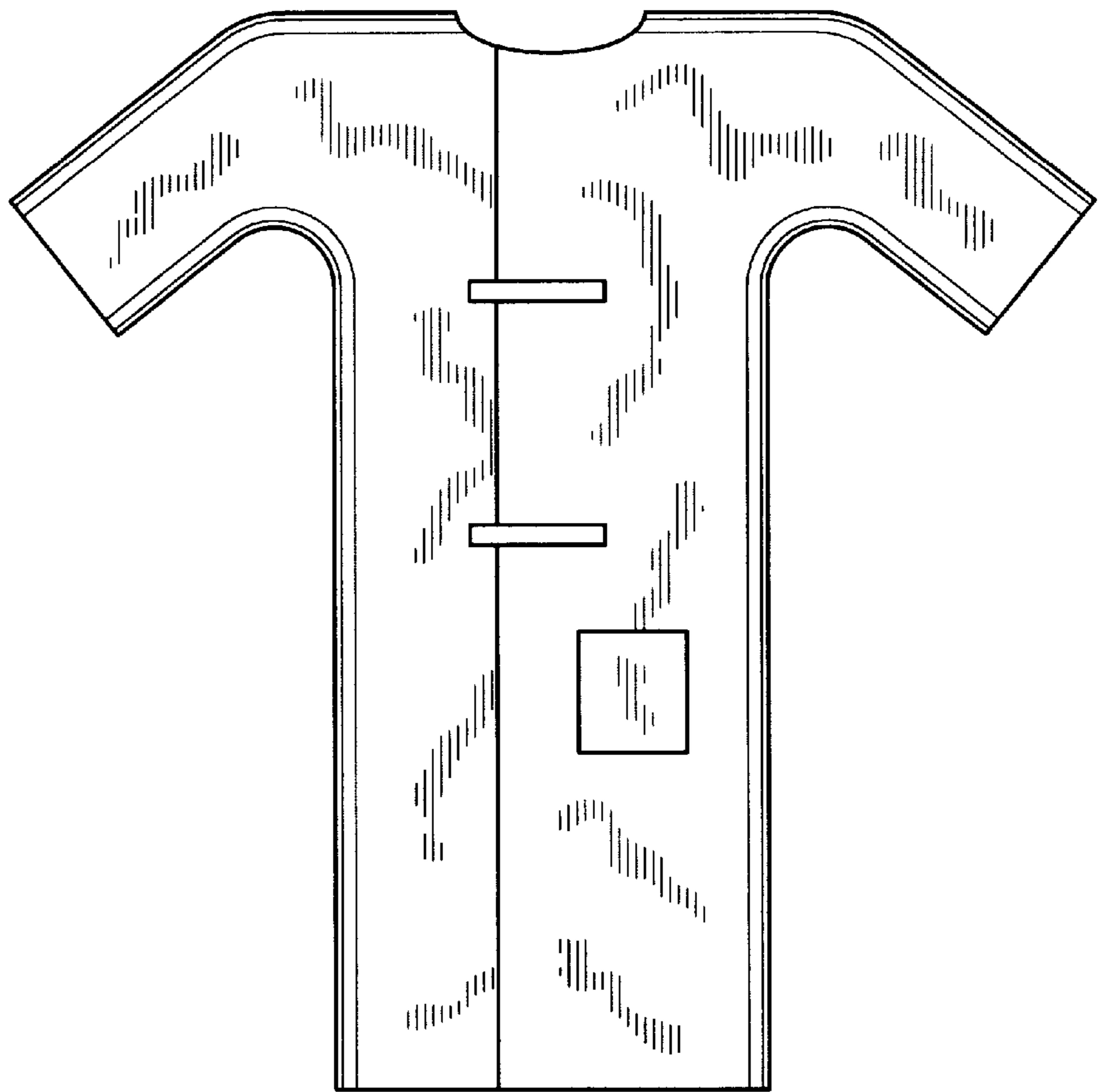
FIG. 1 is a front elevational view of the patient garment of the present invention;

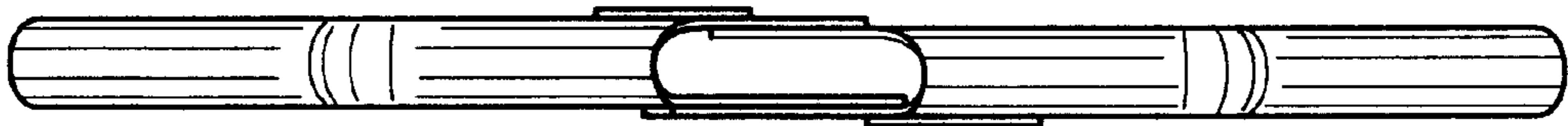
