[57] CLAIM

The ornamental design for a sectional display cube for photos, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present invention showing three faces of the sectional display cube for photos. FIG. 2 is a perspective view of the present invention showing the other three faces of the sectional display cube for photos.

FIG. 3 is an exploded perspective view of the assembled sectional display cube for photos shown in FIG. 1.

FIG. 4 is an exploded perspective view of the sectional display cube for photos shown in FIG. 2.

FIG. 5 is a front elevational view showing the section at left in FIG. 3 for convenience of illustration;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a rear elevational view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a front elevational view showing the section at right in FIG. 3 for convenience of illustration;

FIG. 10 is a rear elevational view thereof;

FIG. 11 is a bottom plan view thereof; and,

FIG. 12 is a top plan view thereof.

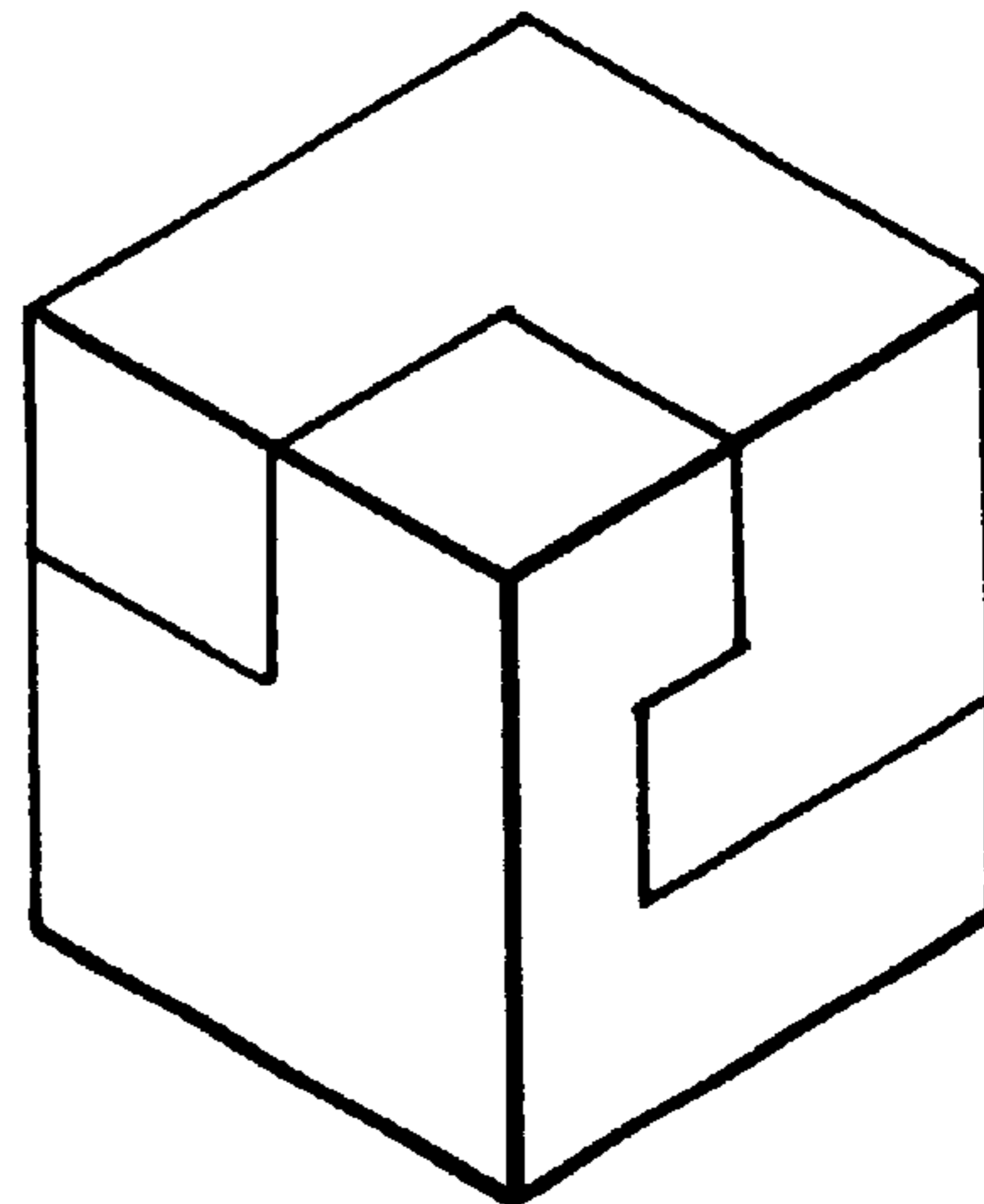
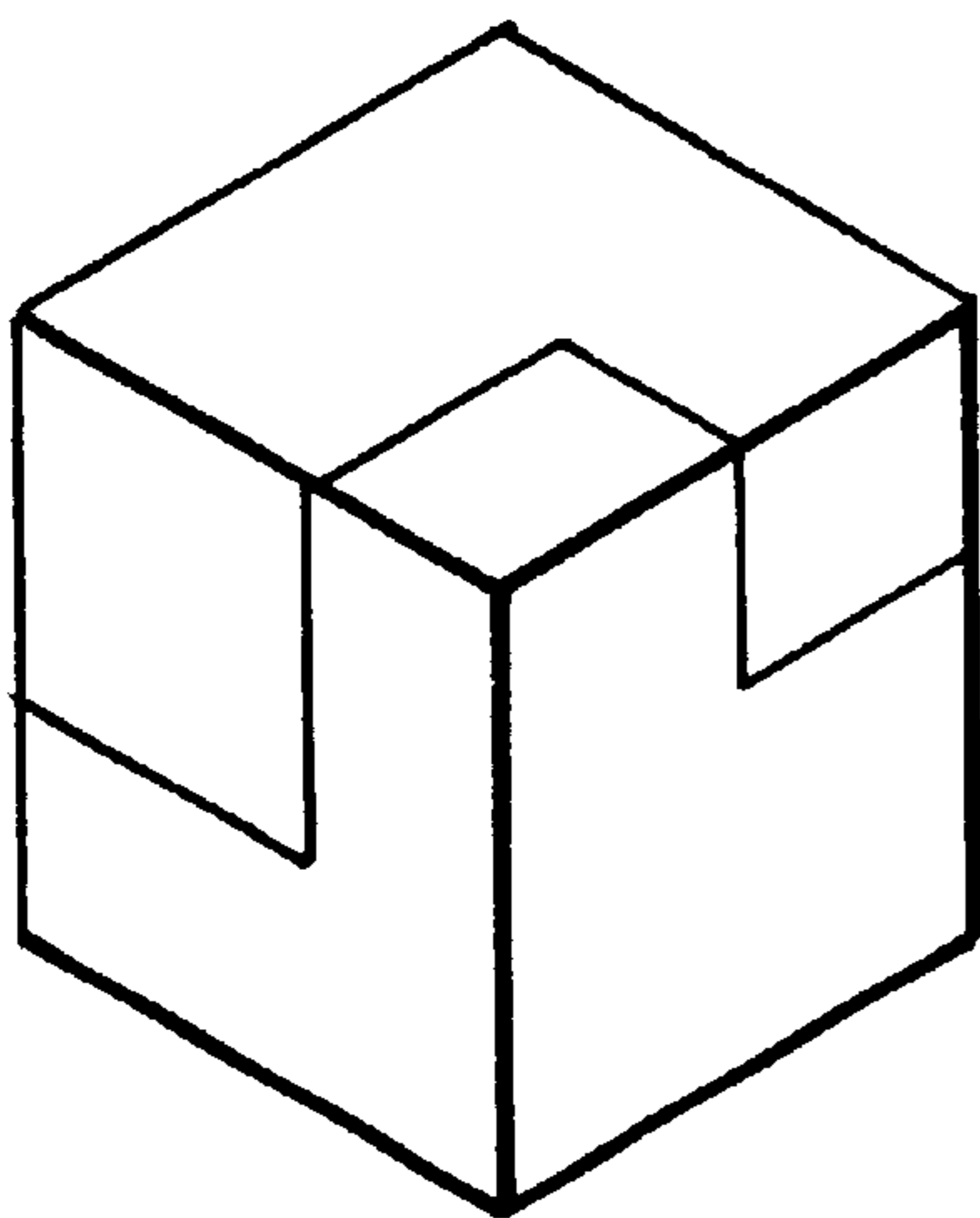

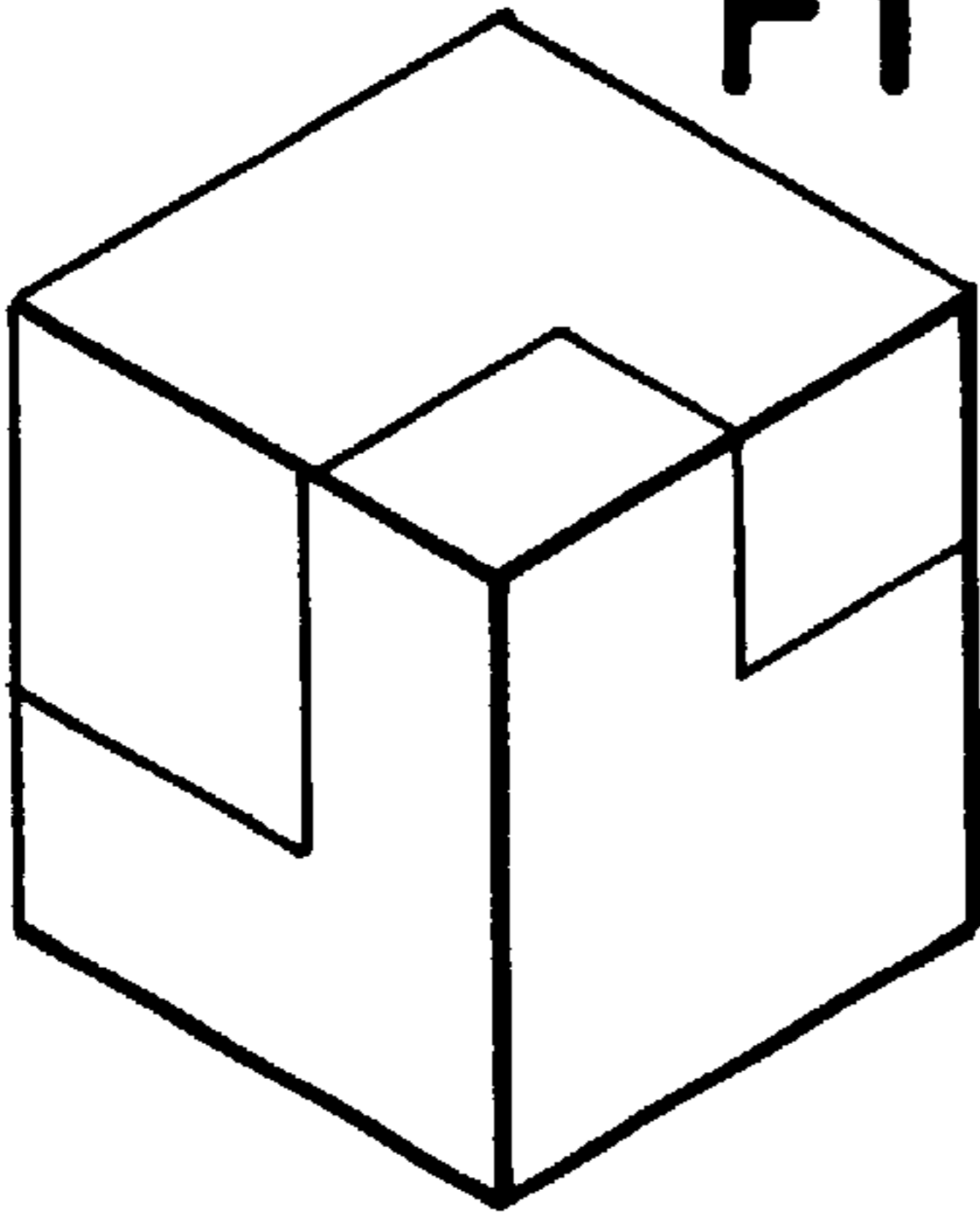

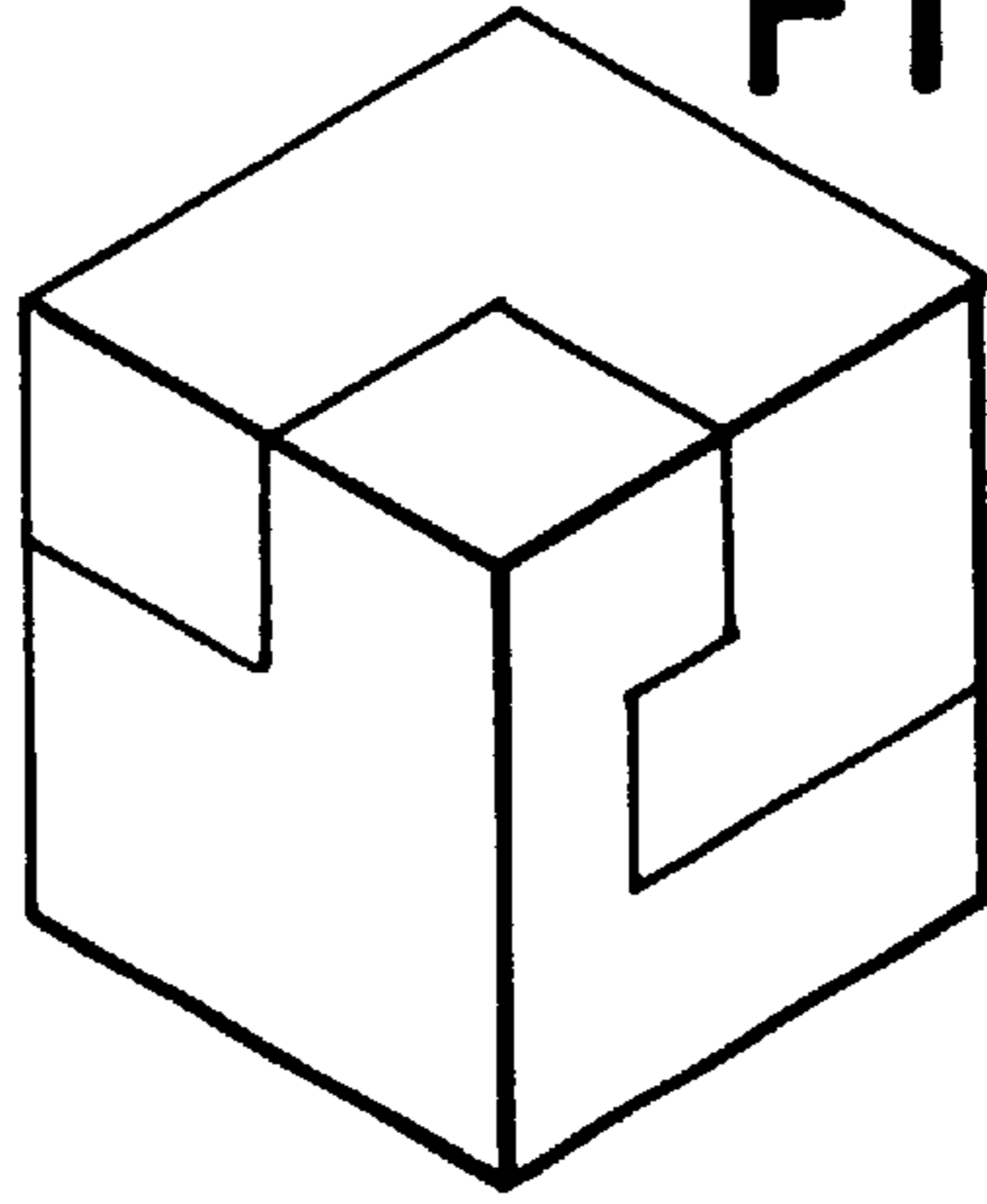

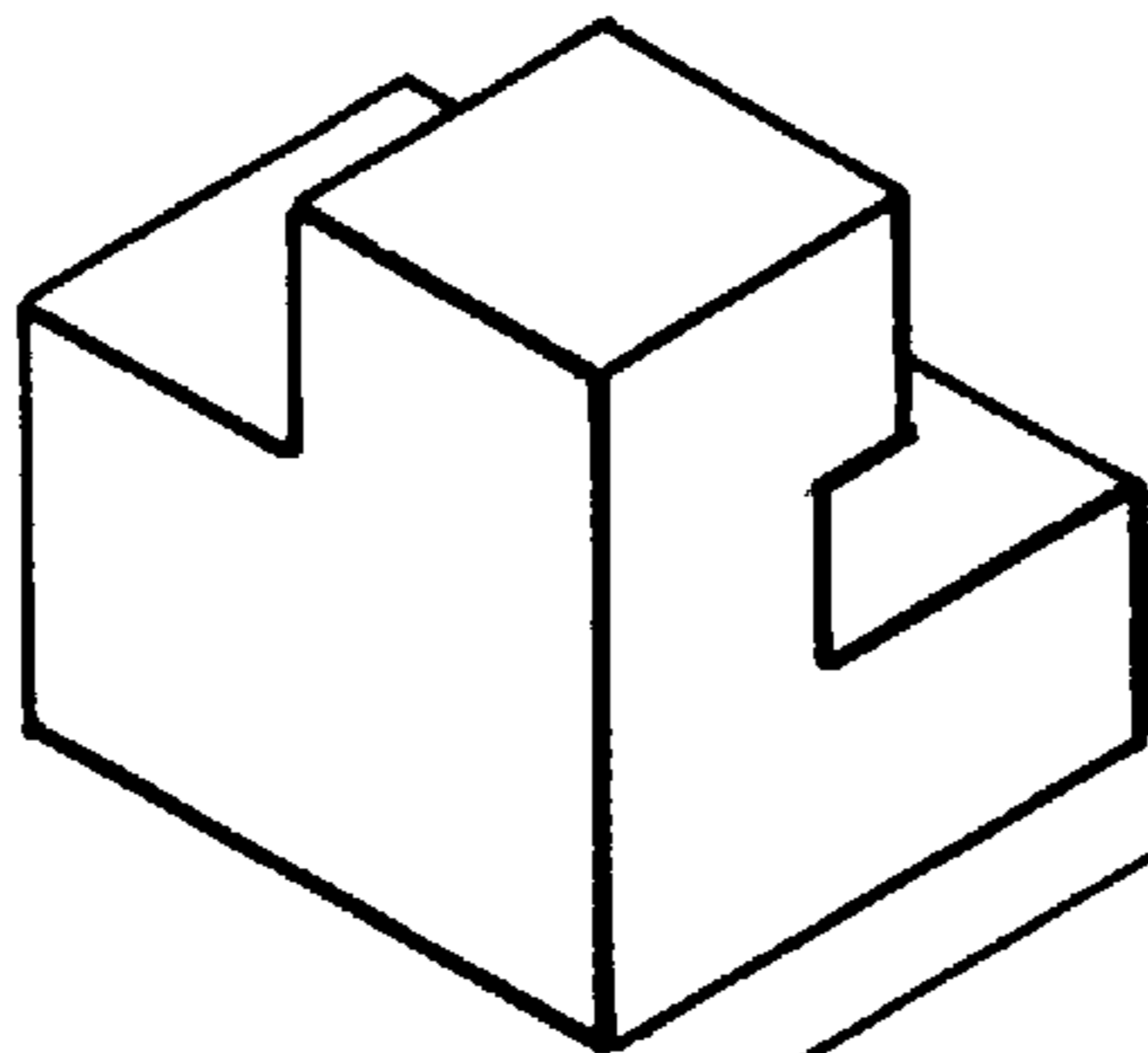
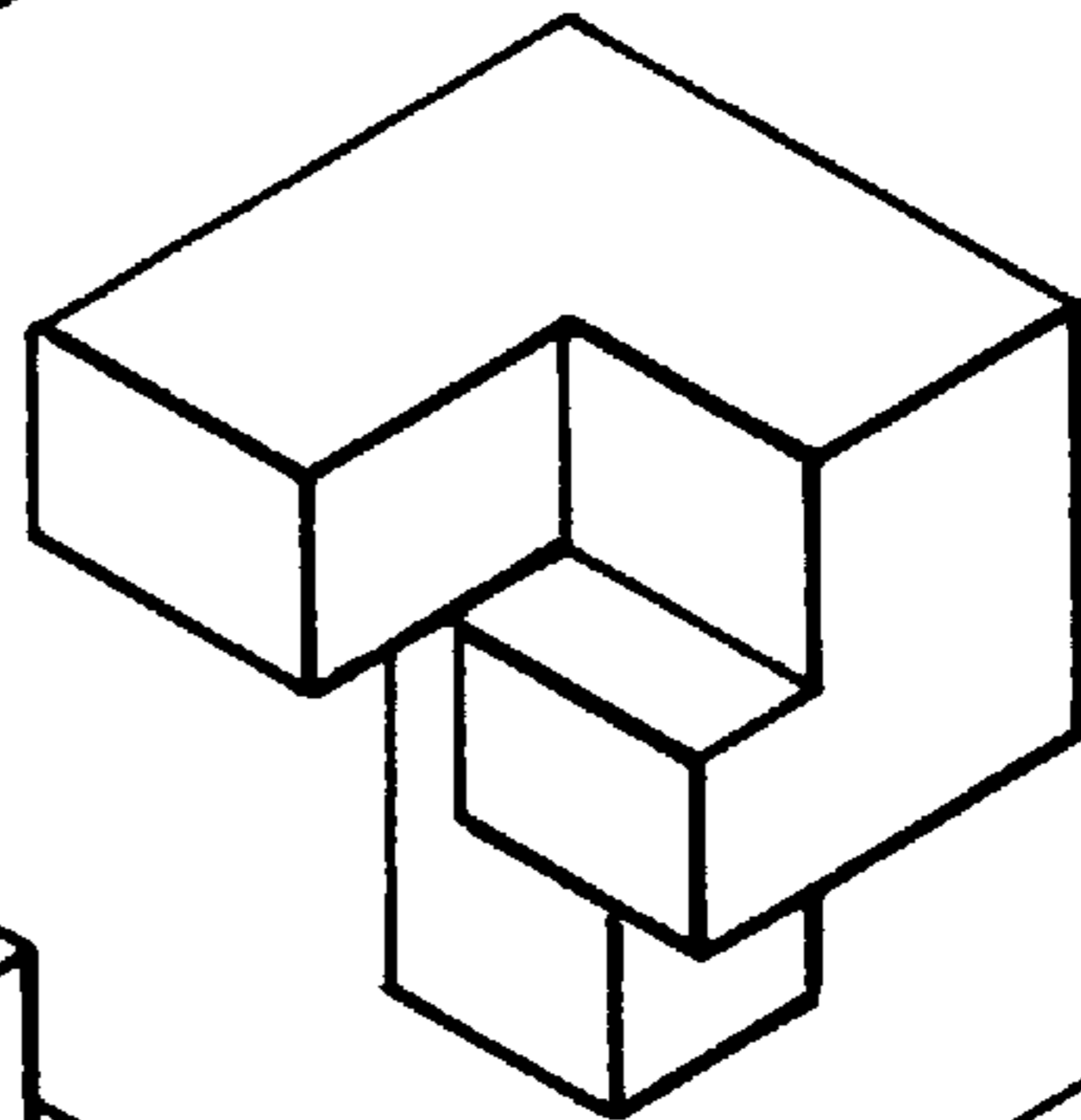
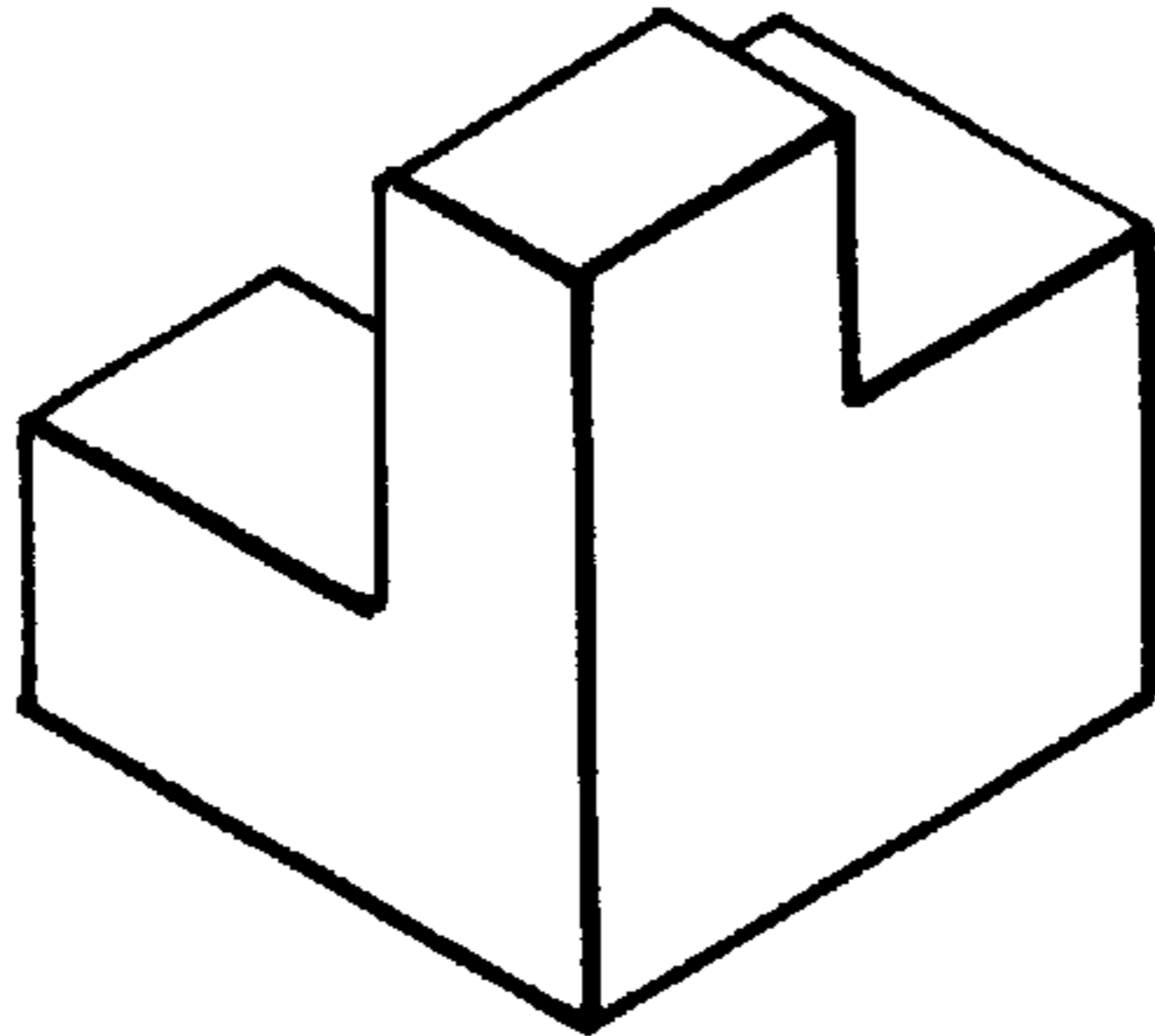
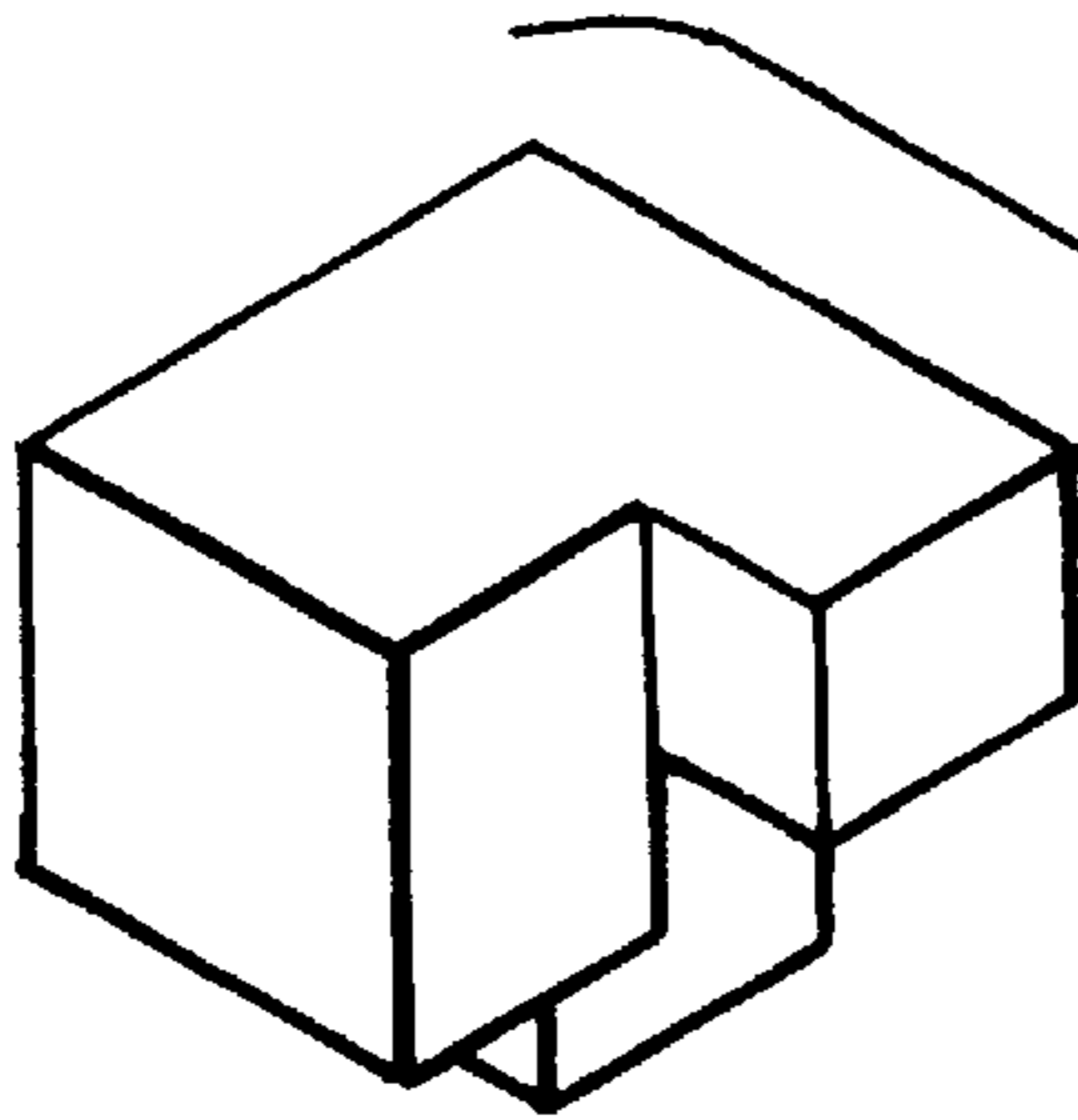

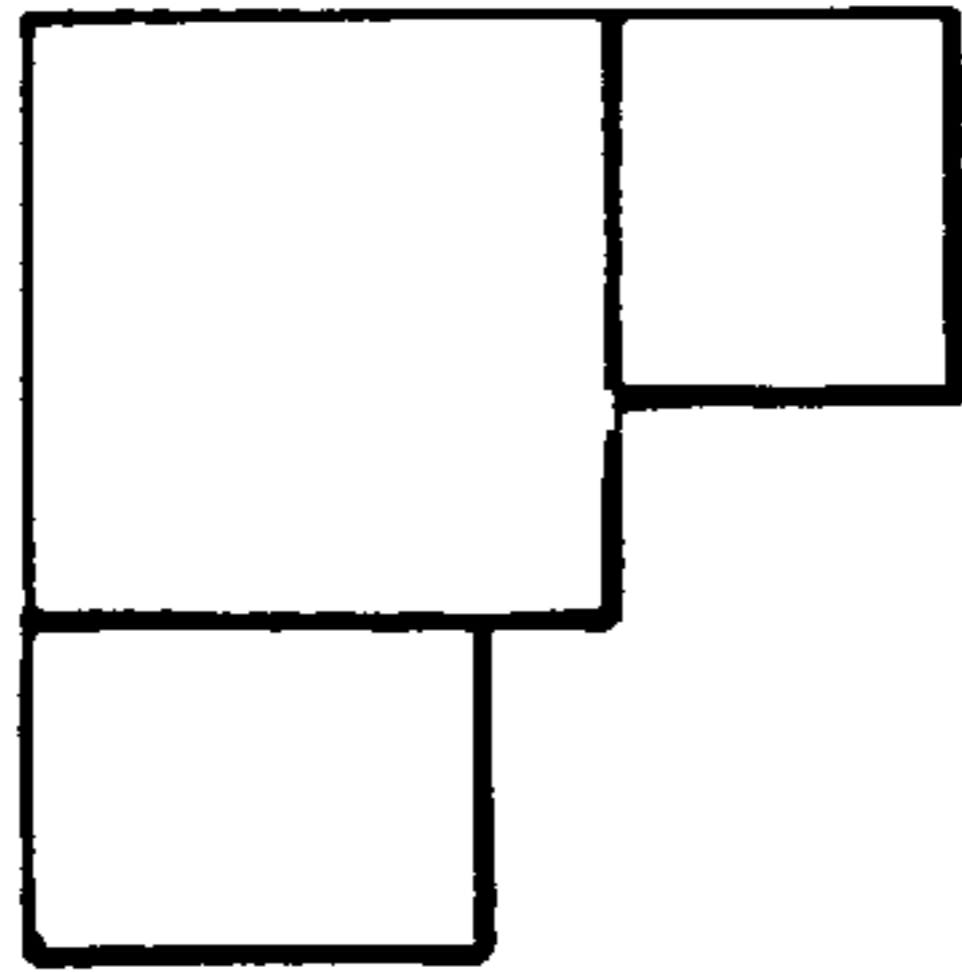

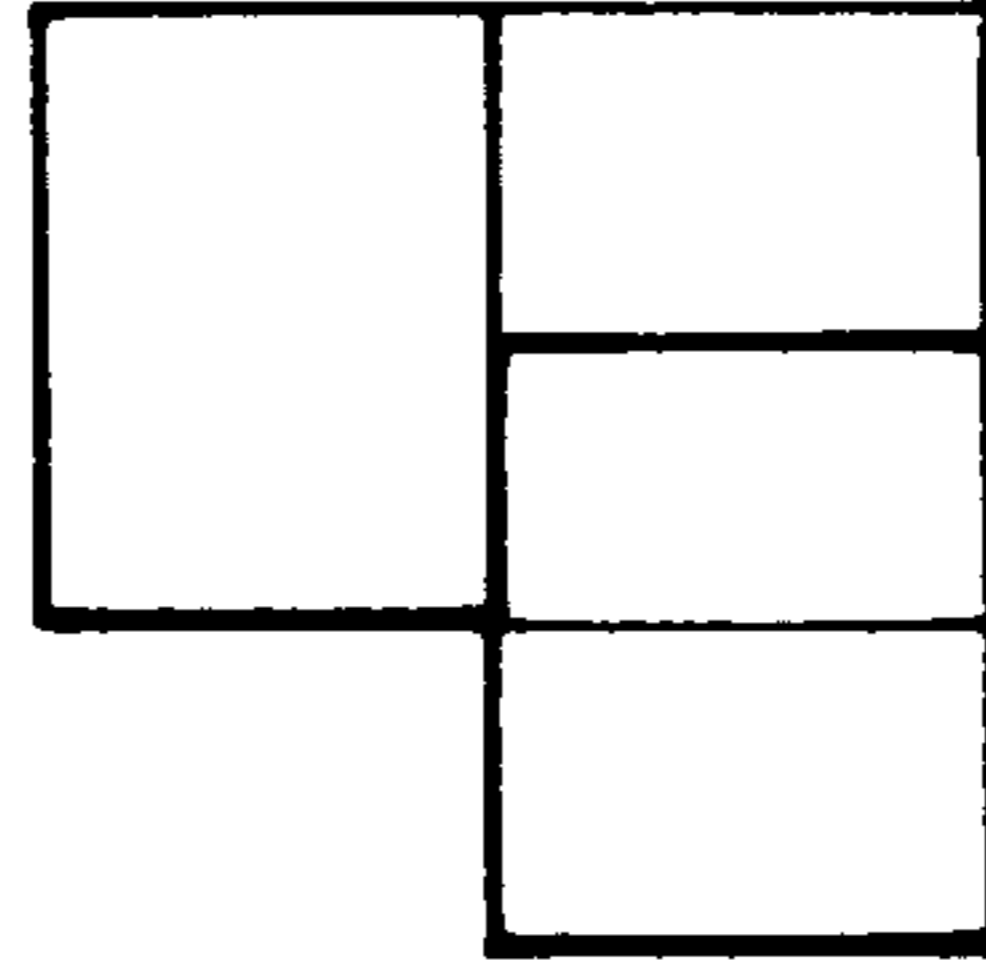

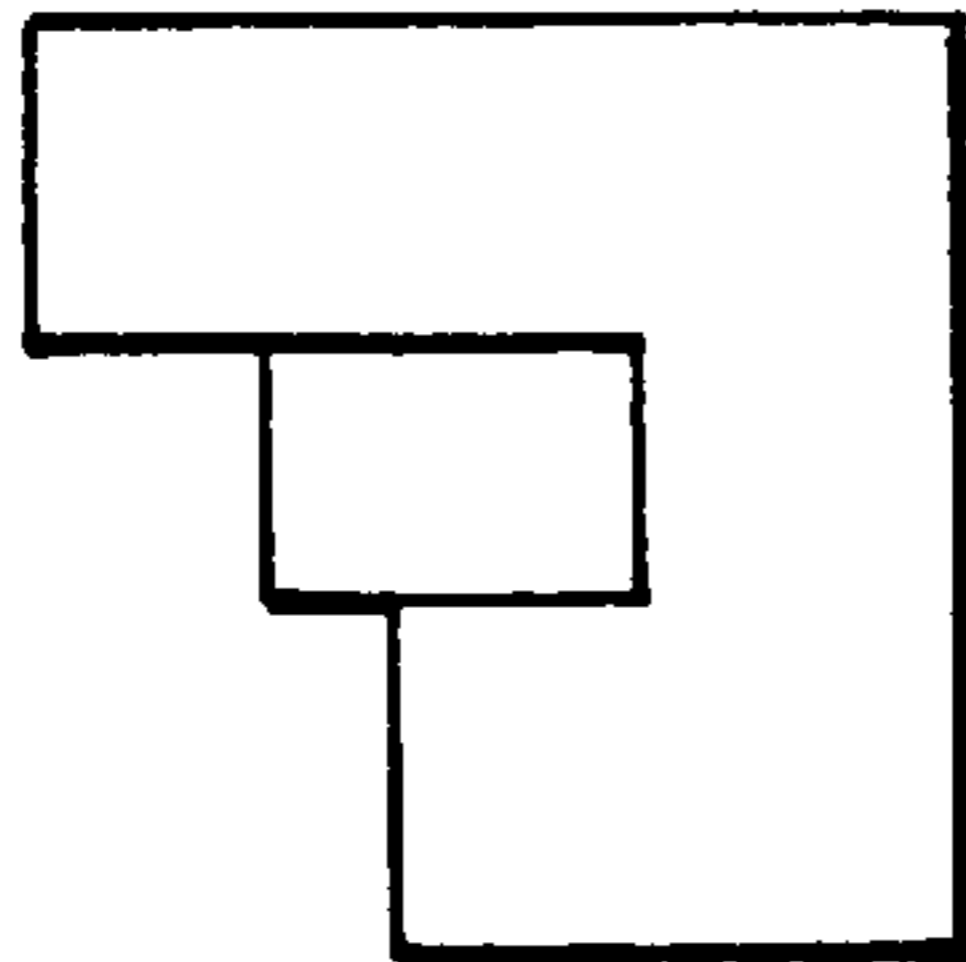

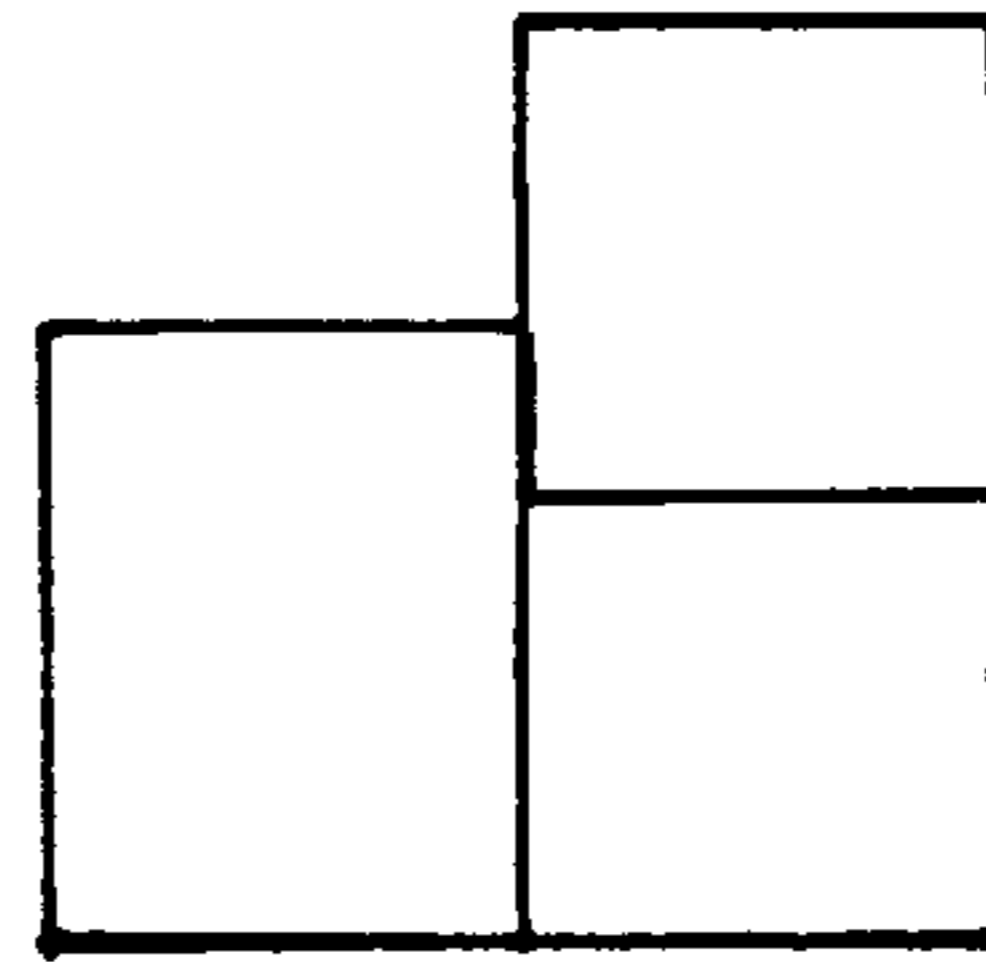

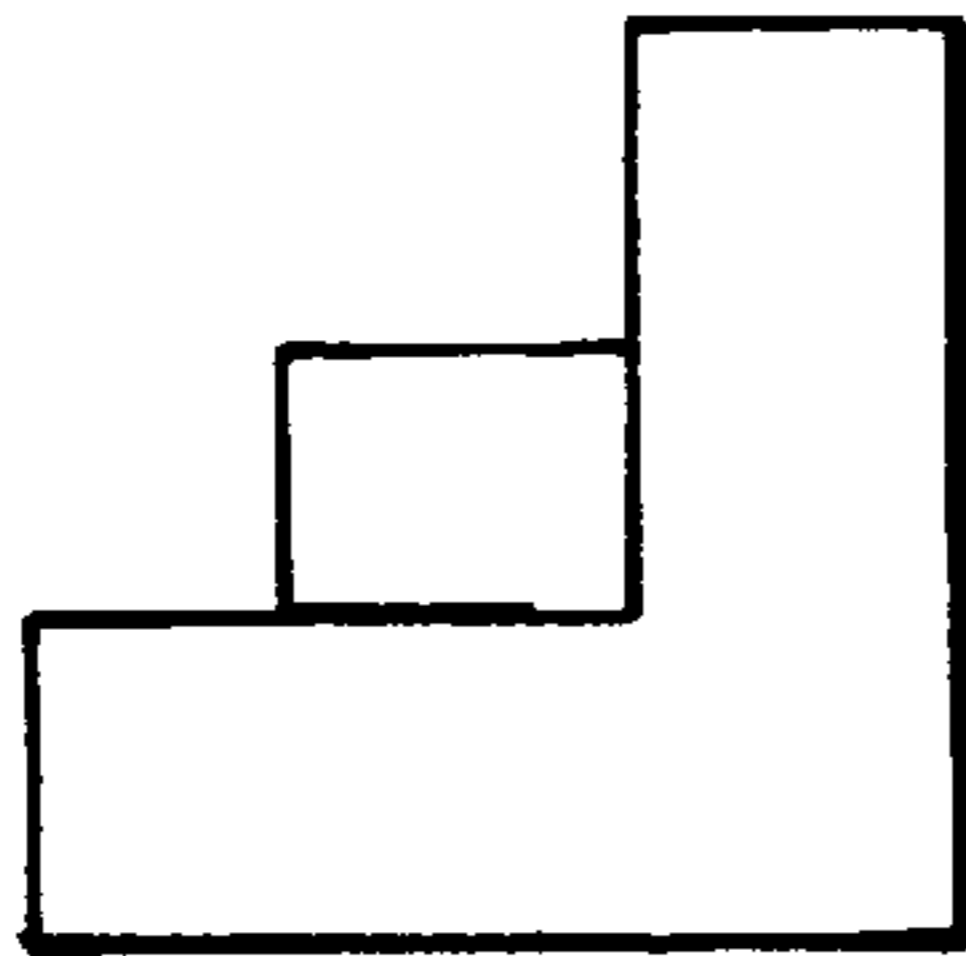

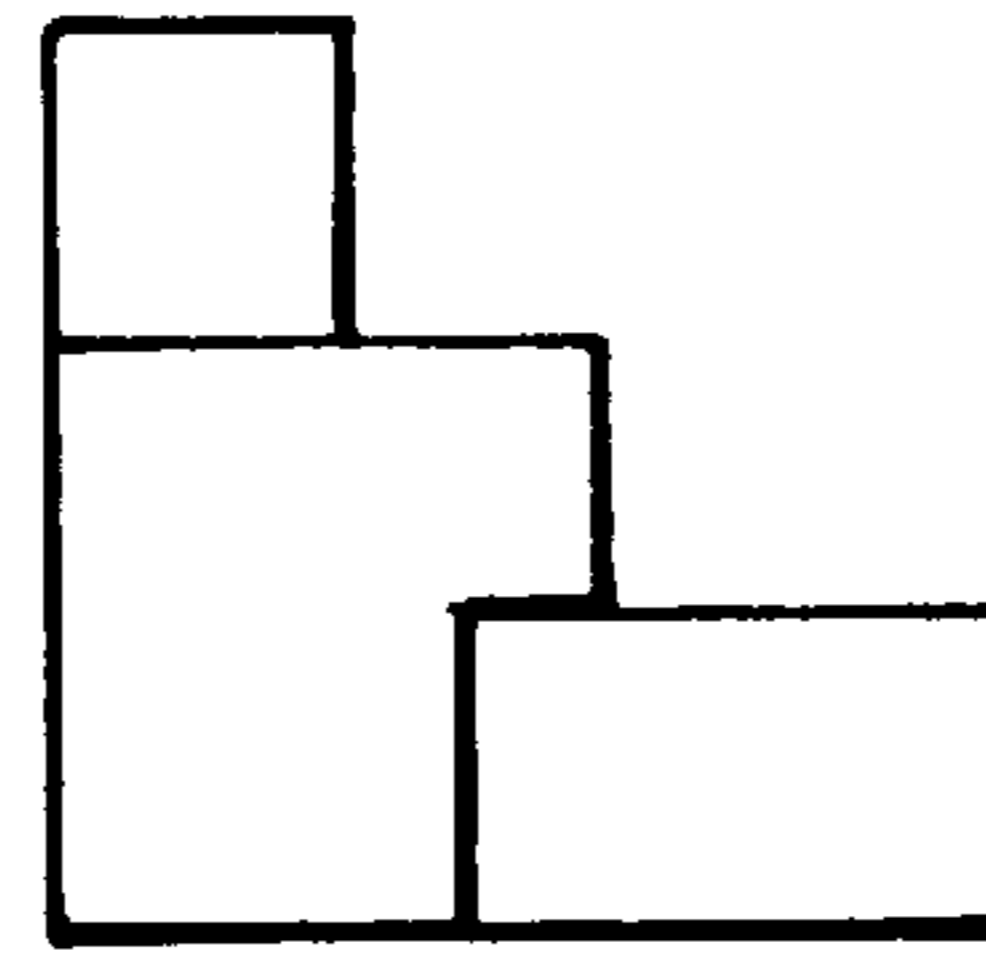

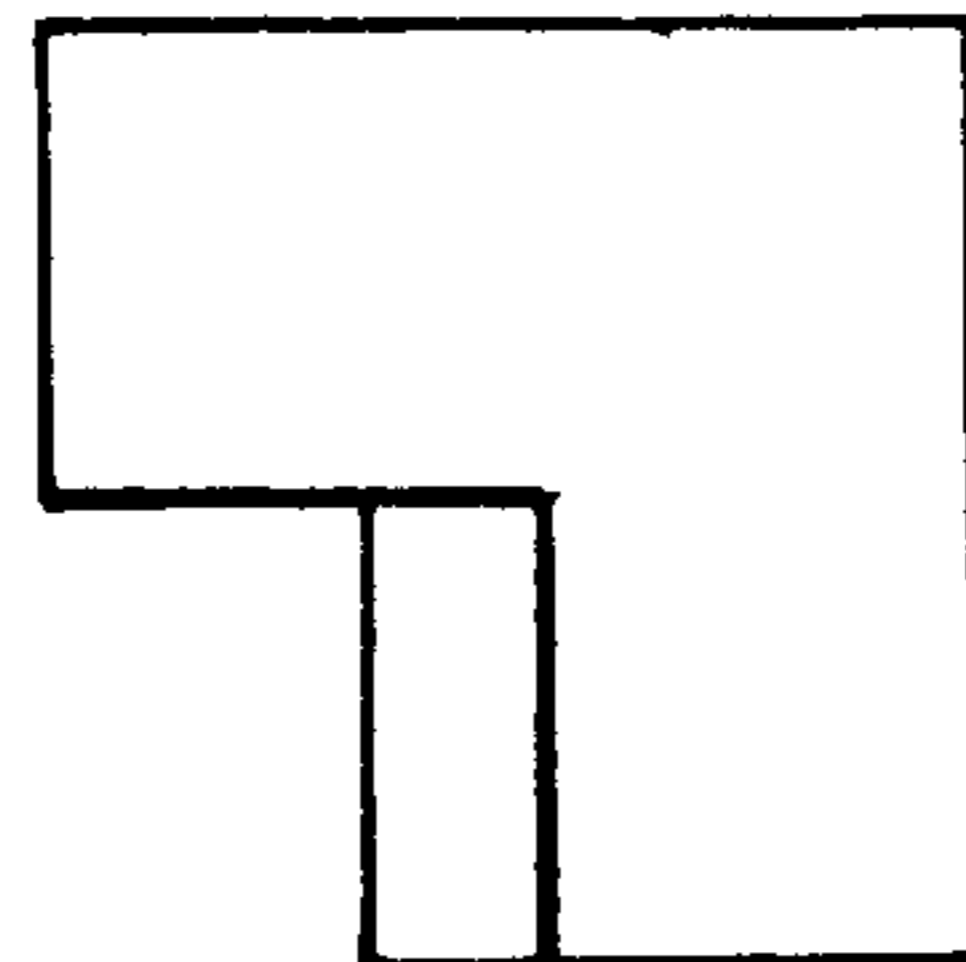
