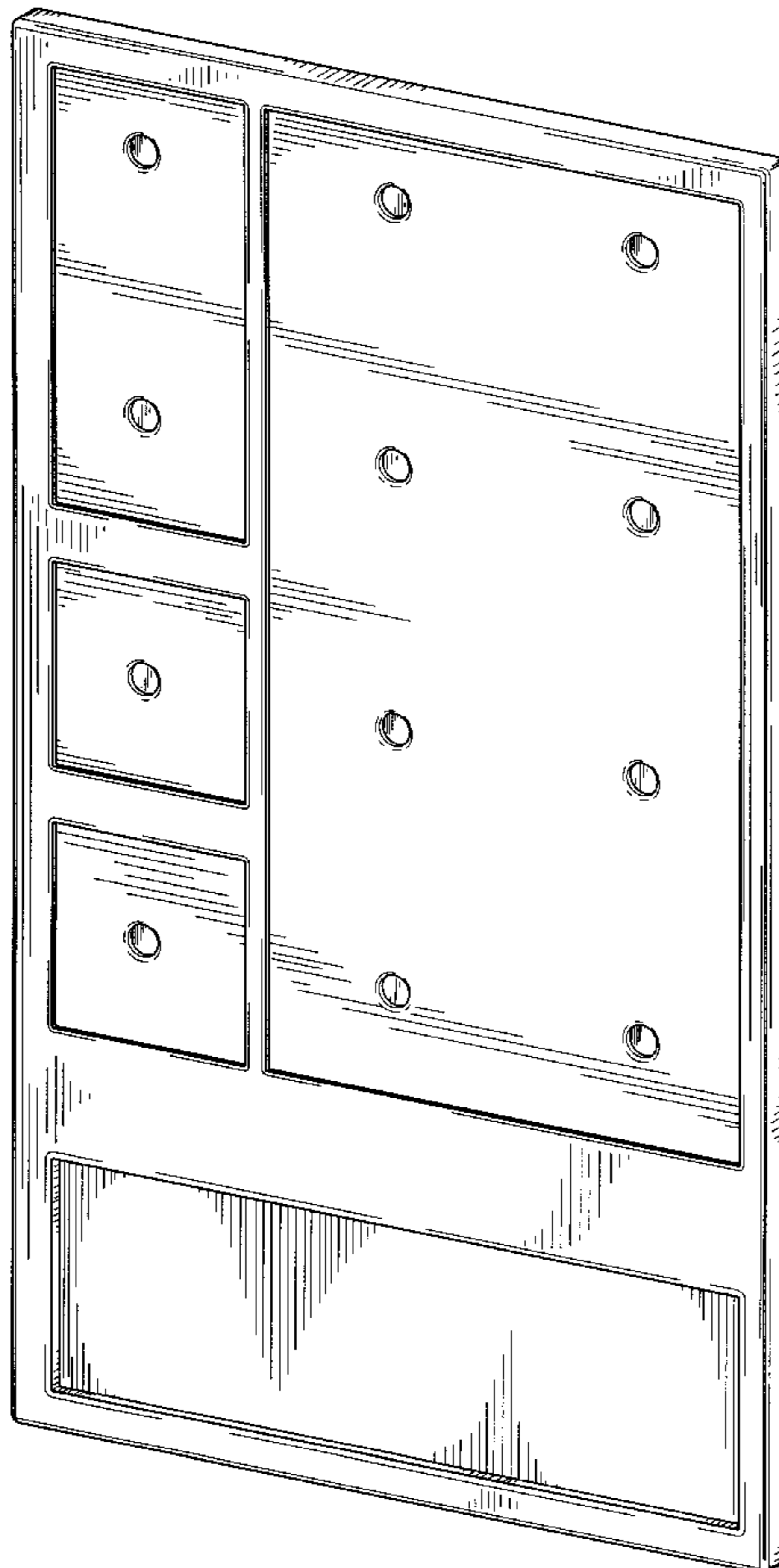
FIG. 1 is a perspective view of the product display panel of the present invention;

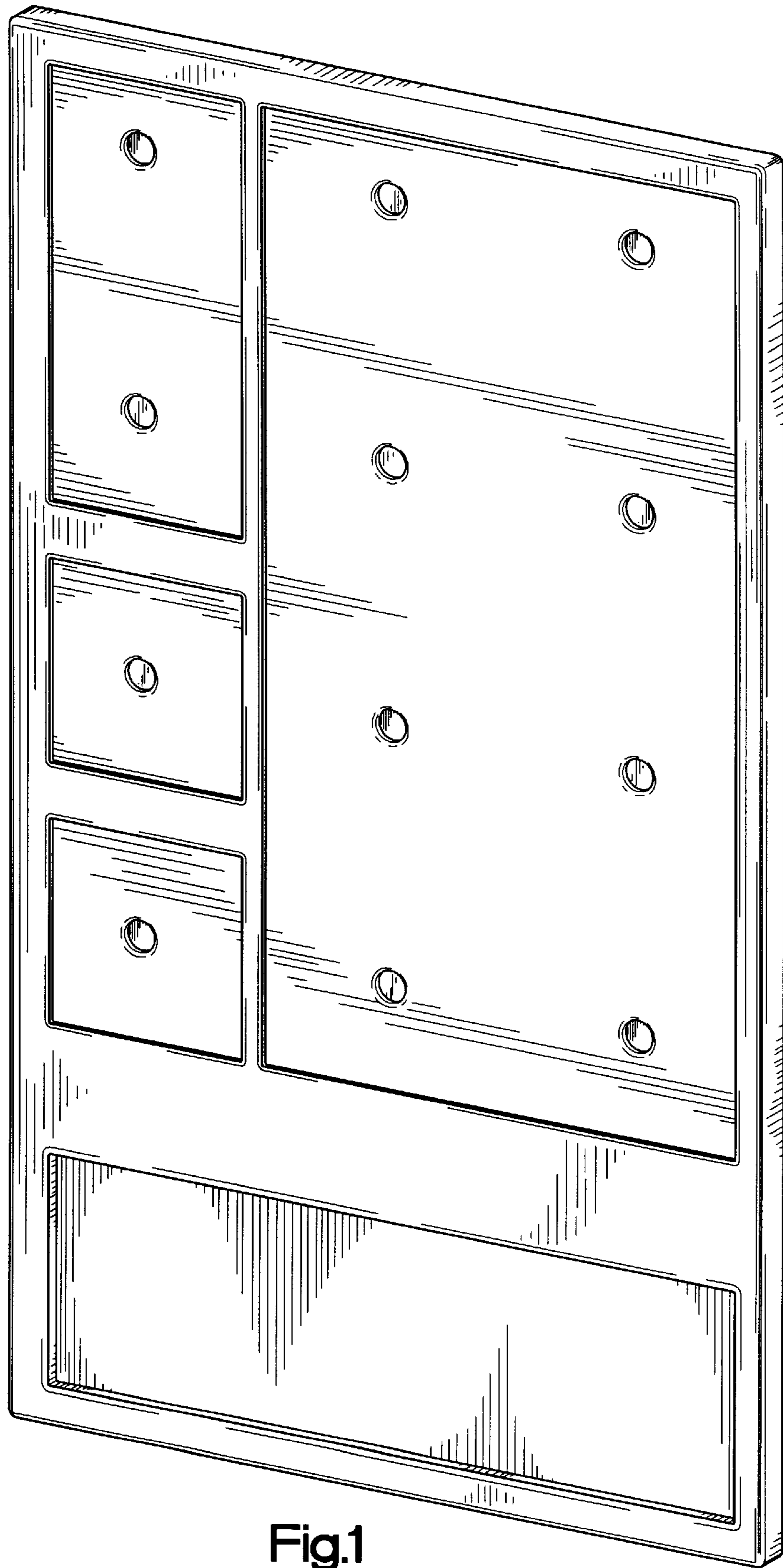

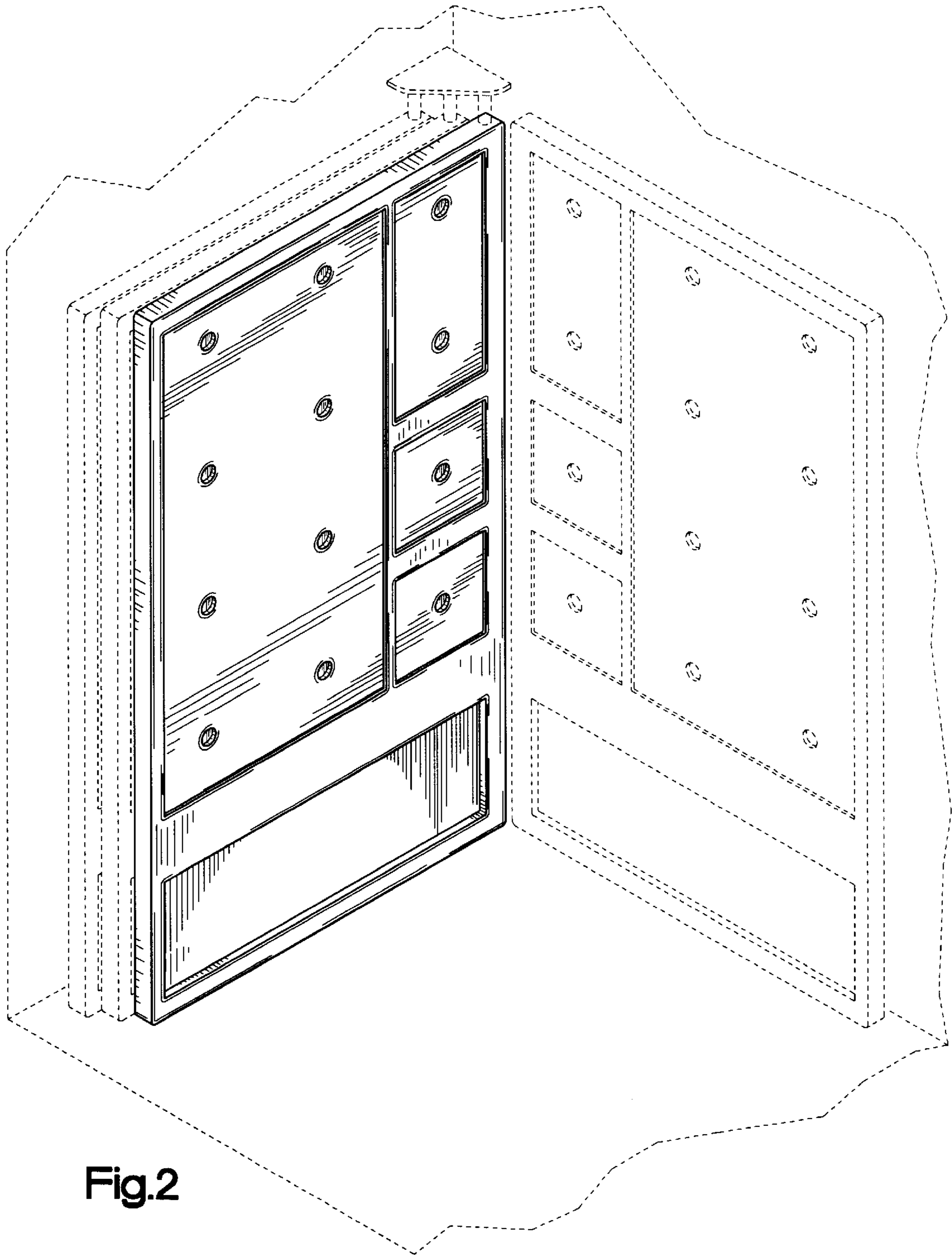

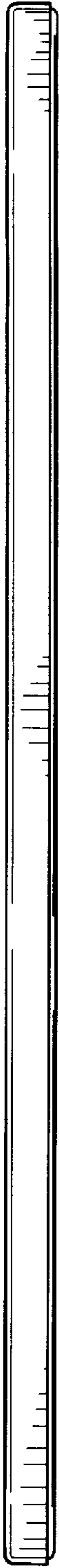

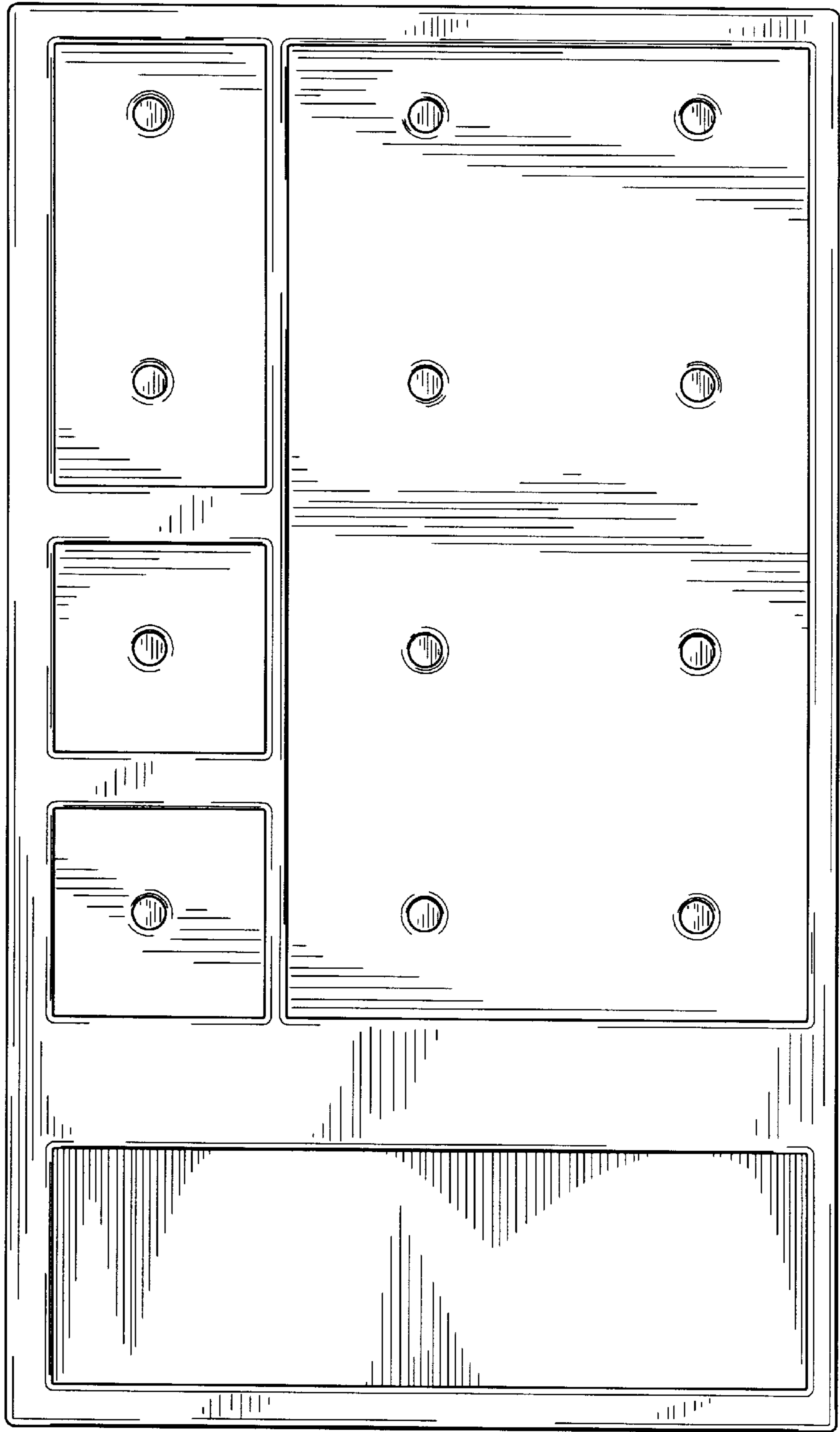

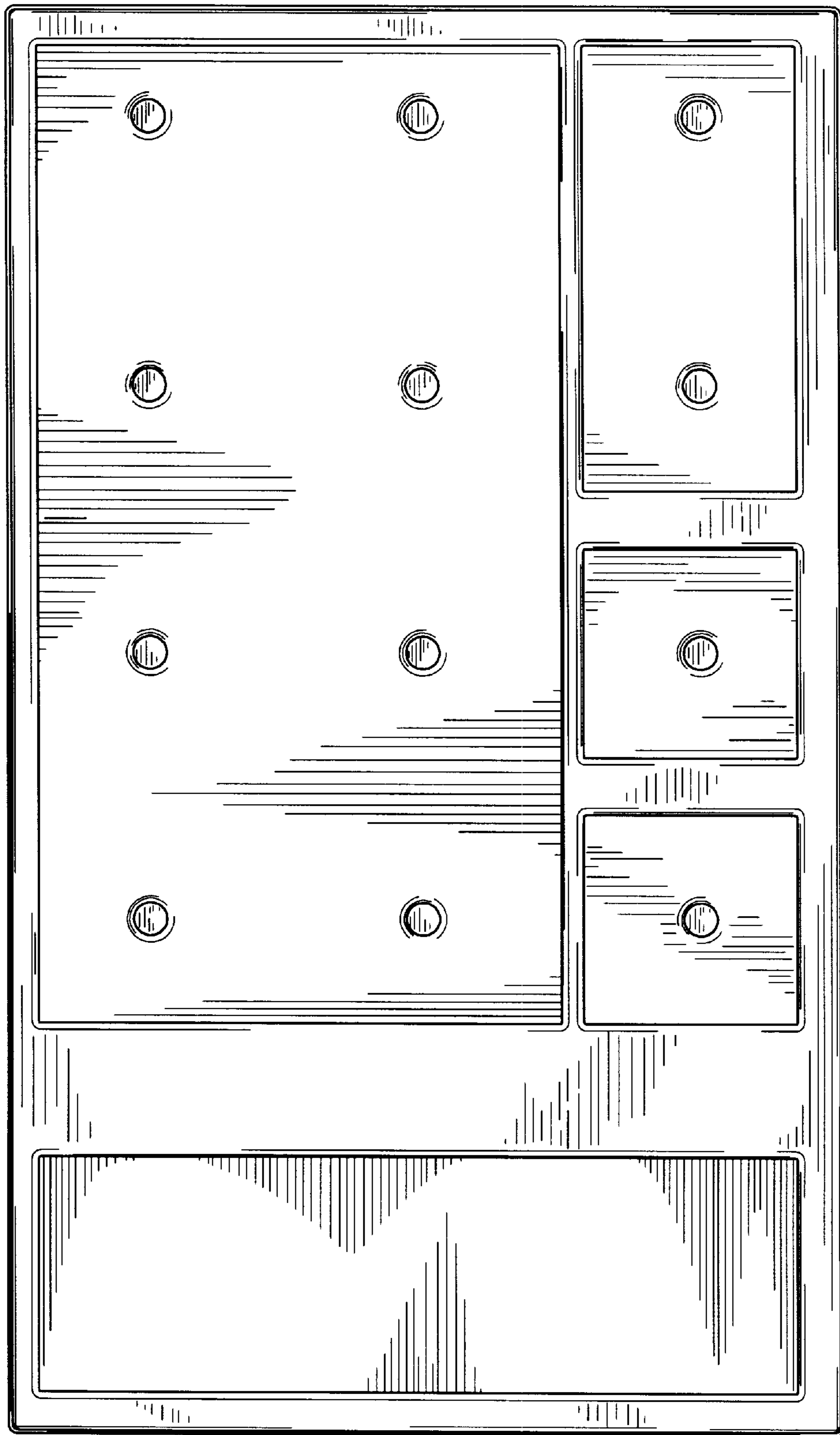
