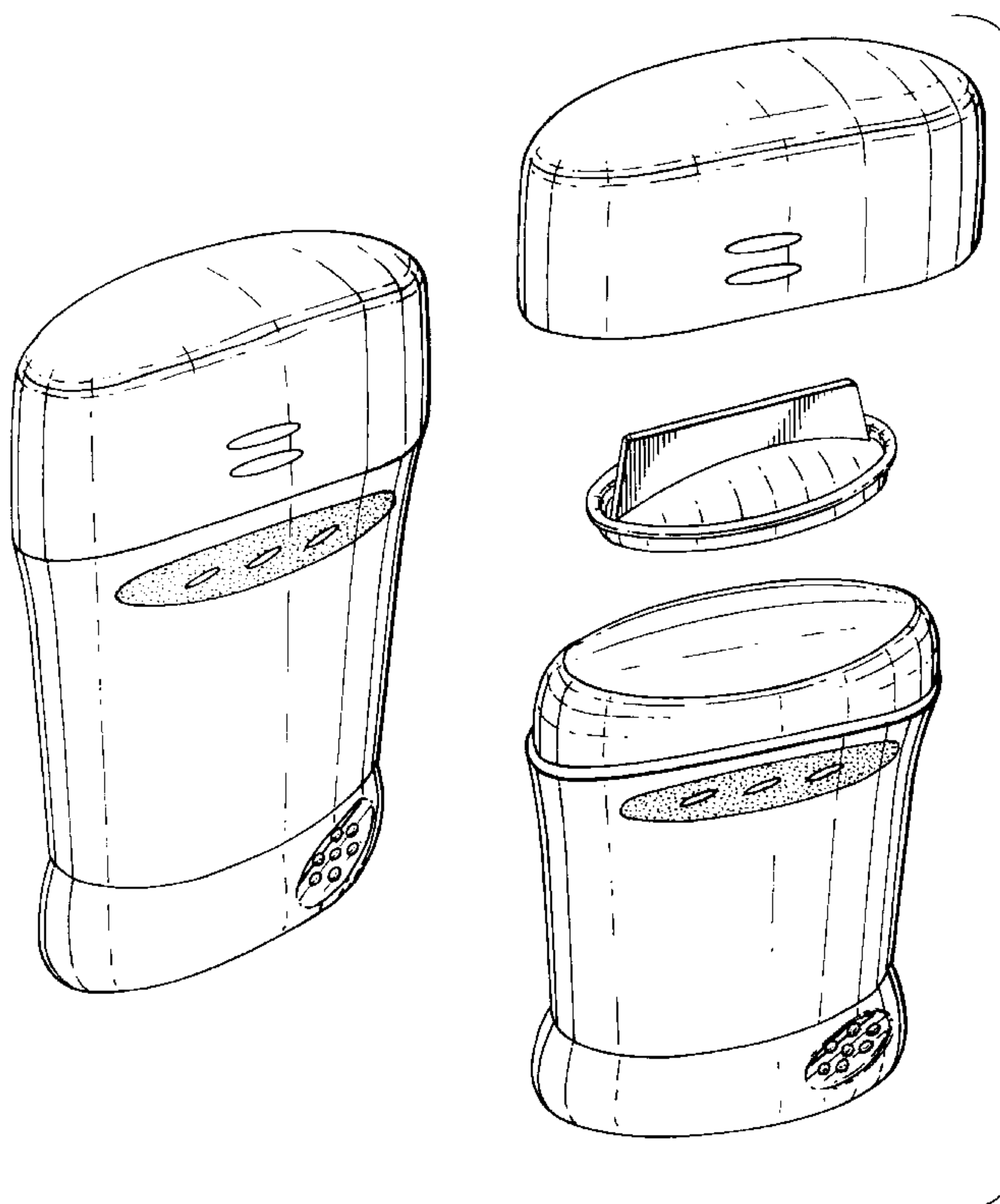
[57] **CLAIM**

The ornamental design for a deodorant dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 of sheet 1 of 2 is a front perspective view from above and one side of the deodorant dispenser showing our new design;  
FIG. 2 of sheet 1 of 2 is an exploded front perspective view from above and one side of the deodorant dispenser of our new design;  
FIG. 3 of sheet 2 of 2 is a rear view of our new design;  
FIG. 4 of sheet 2 of 2 is an elevational view of other side of our new design;  
FIG. 5 of sheet 2 of 2 is an underneath plan view of our new design; and,  
FIG. 6 of sheet 2 of 2 is a plan view of our new design.

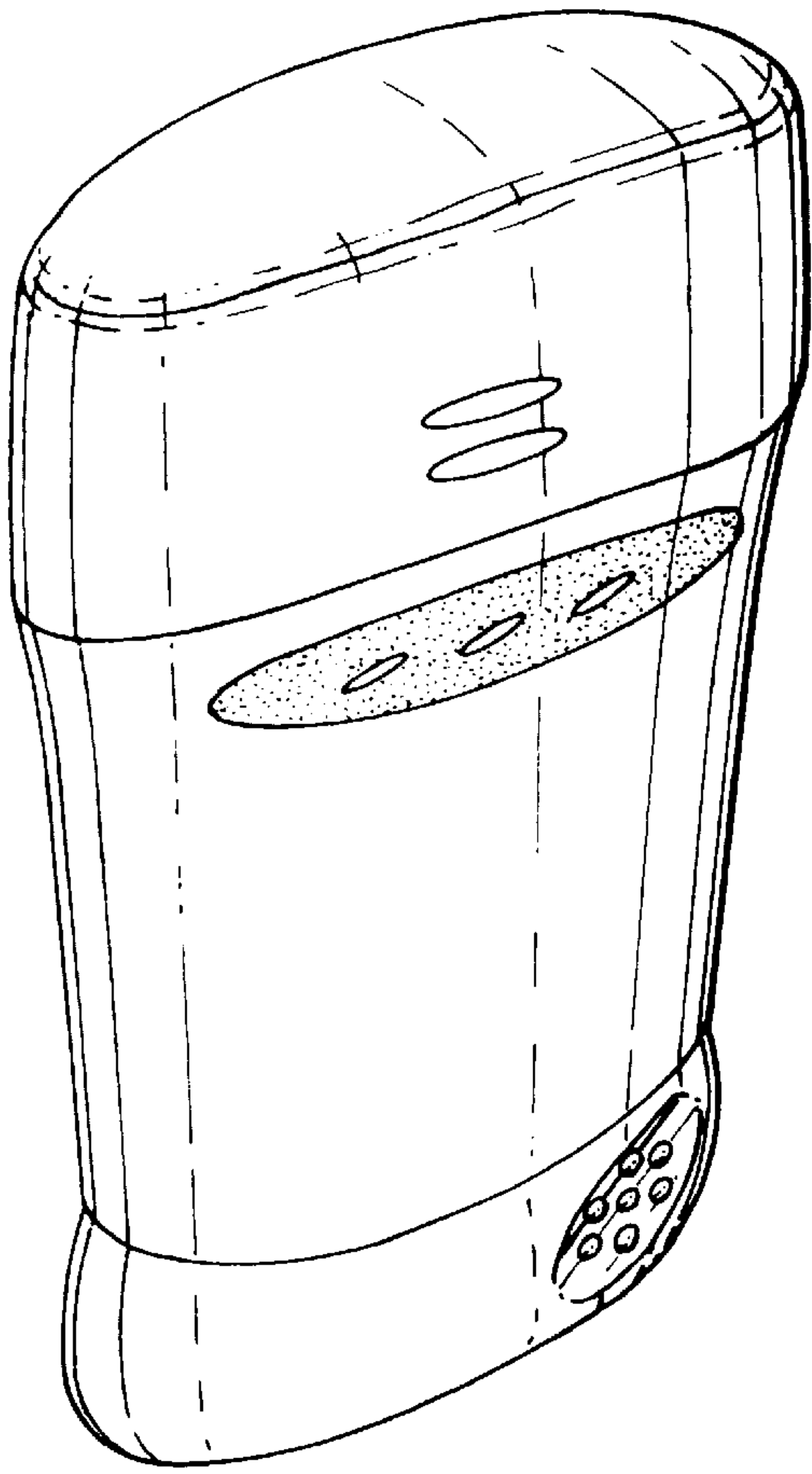

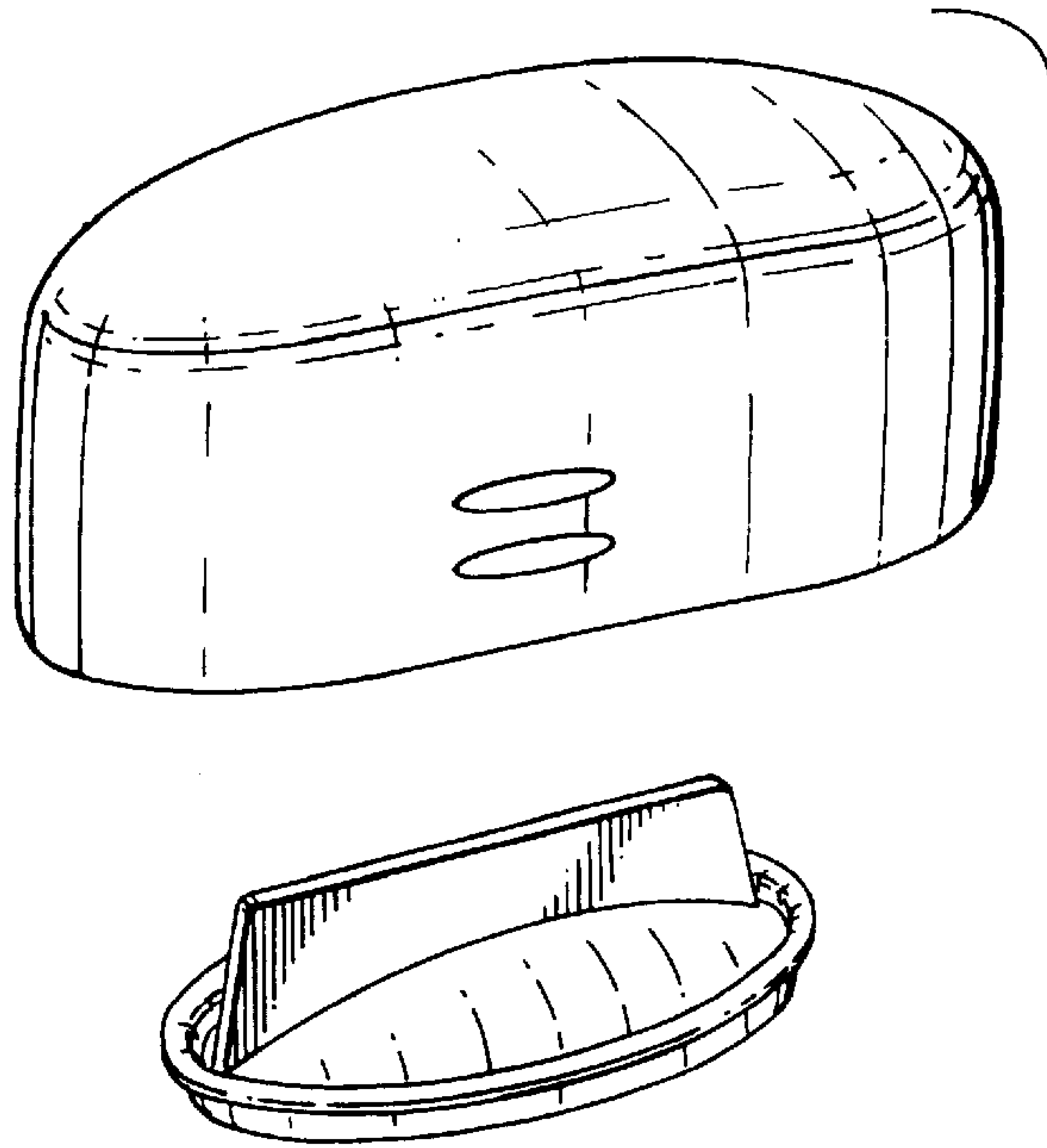

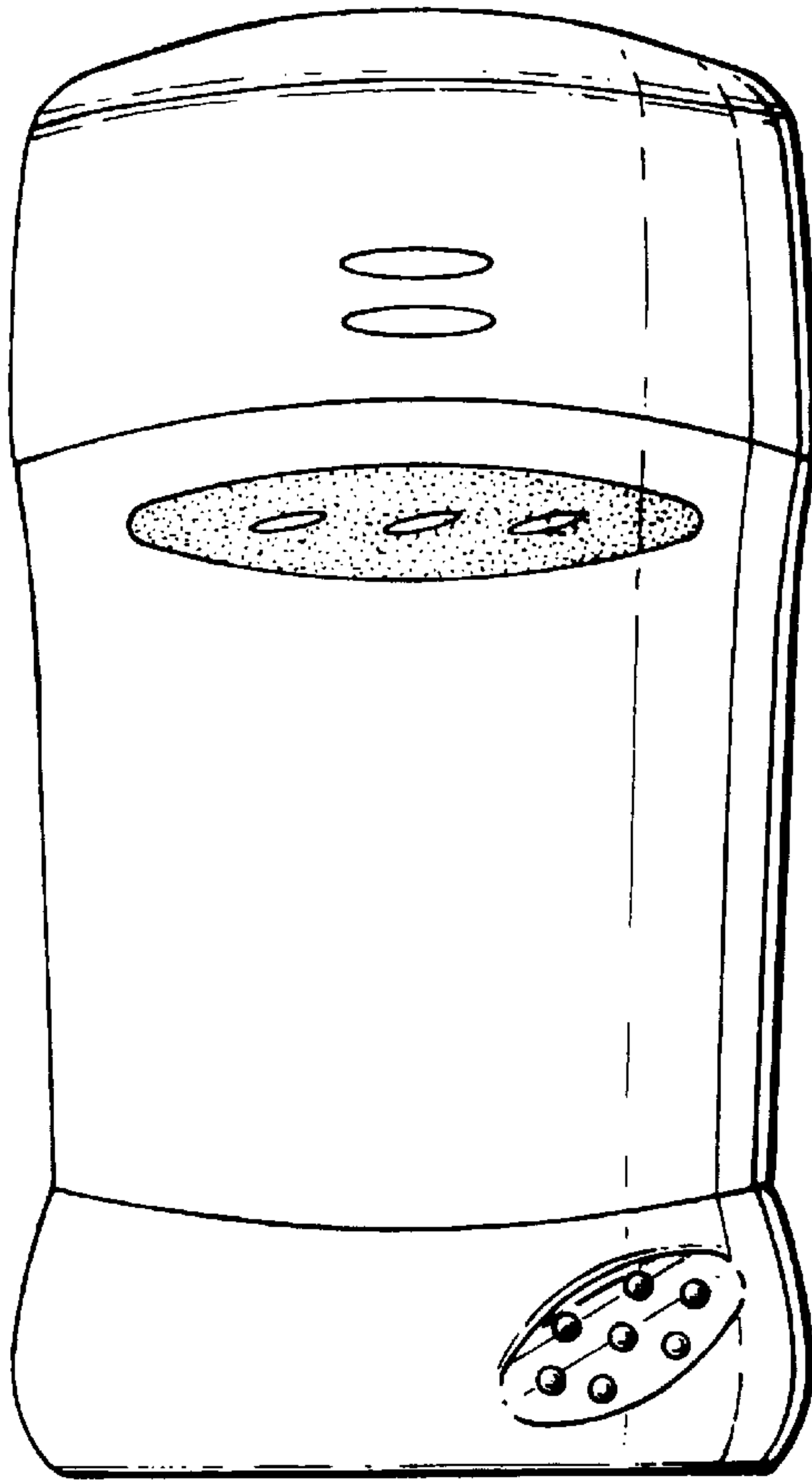

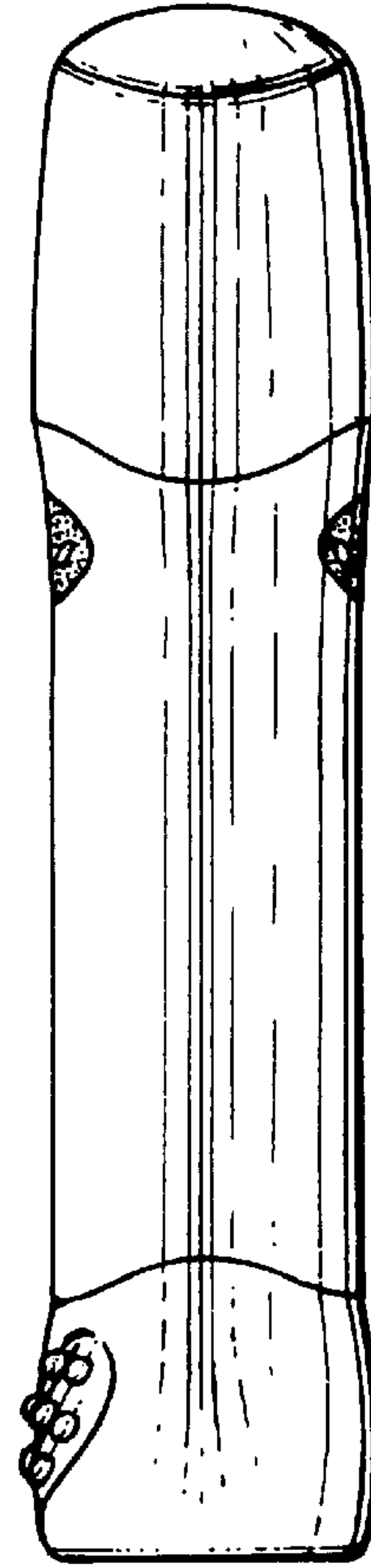

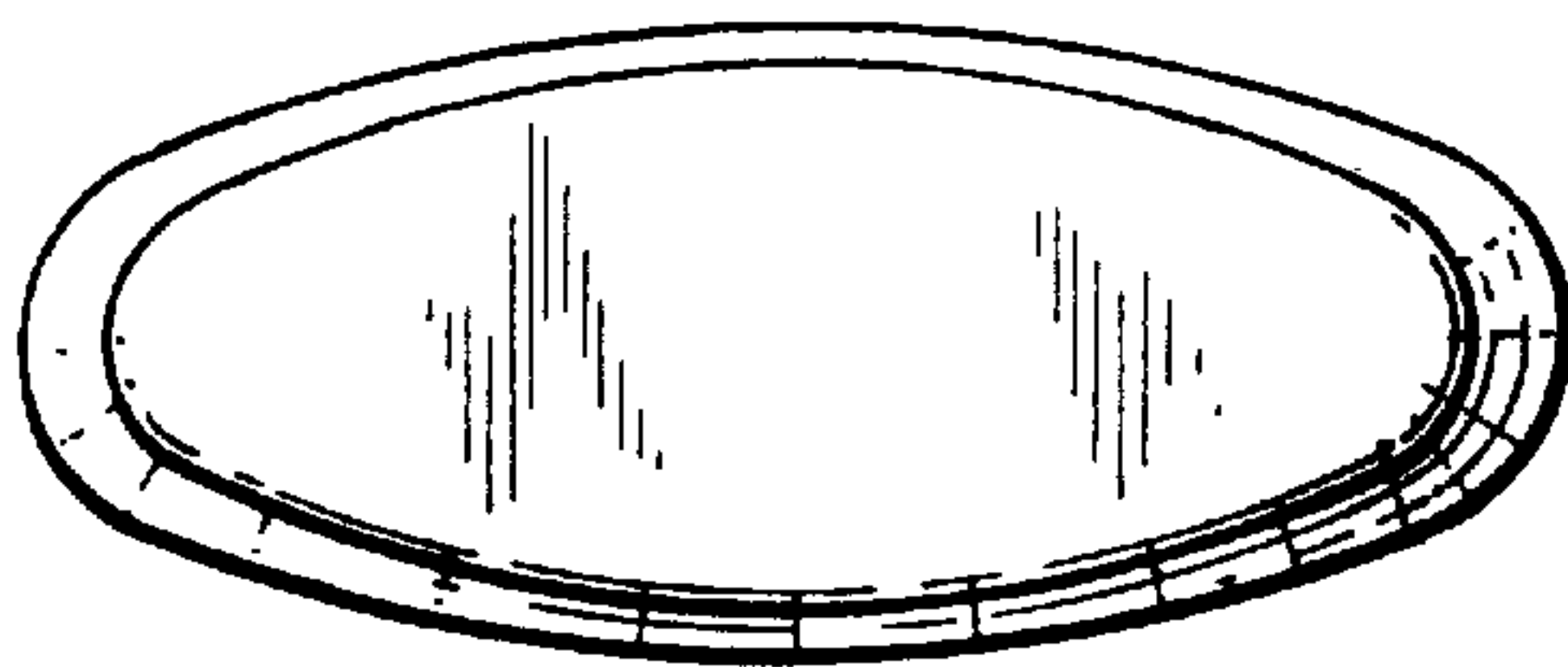

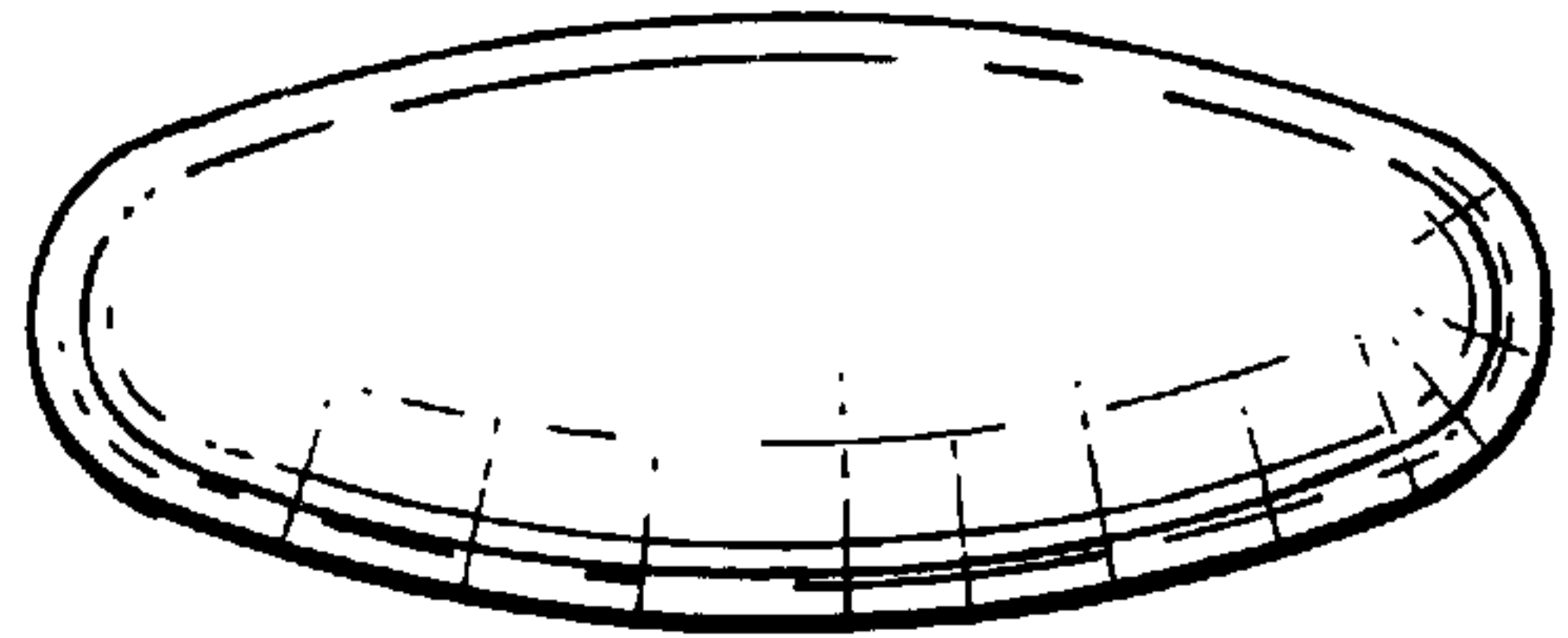
