DESCRIPTION

FIG. 14 is a rear elevational view of FIG. 13;

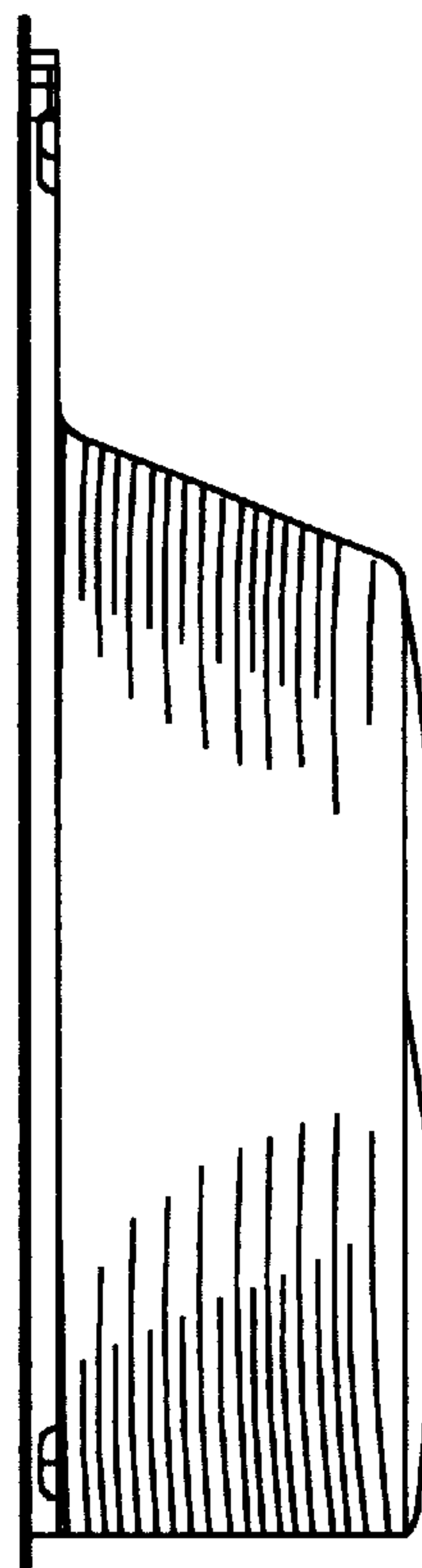
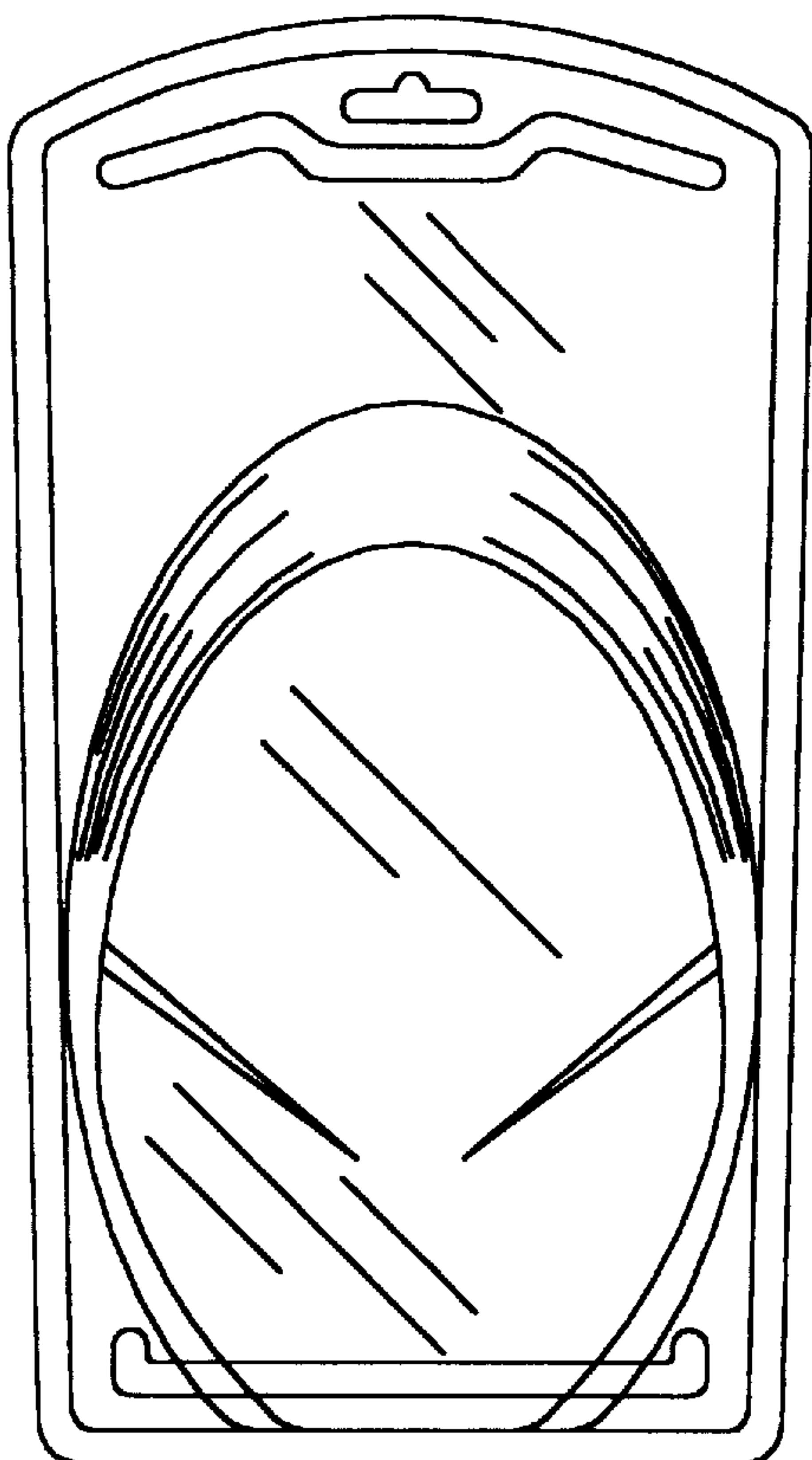
FIG. 15 is a left side elevational view of FIG. 13;

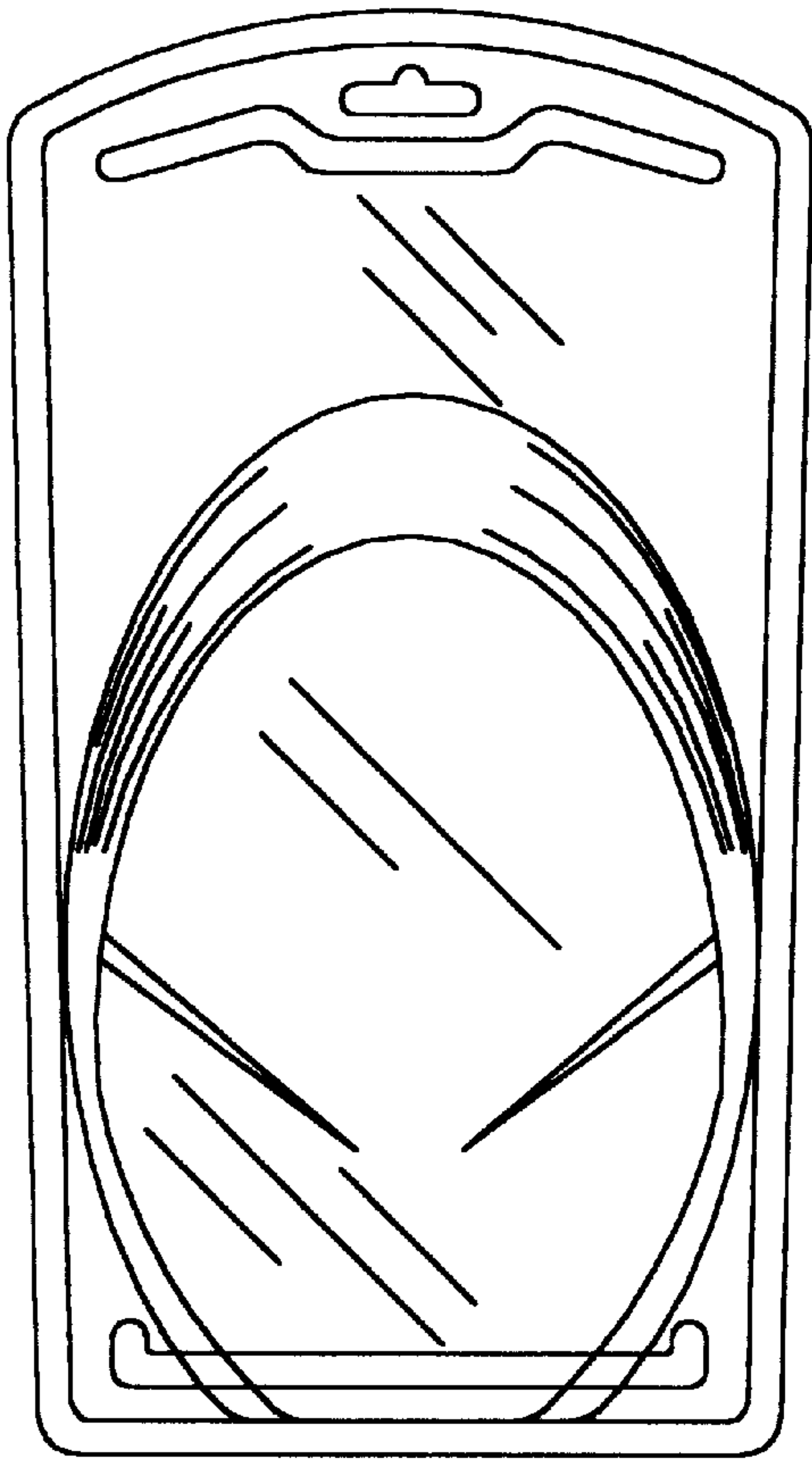

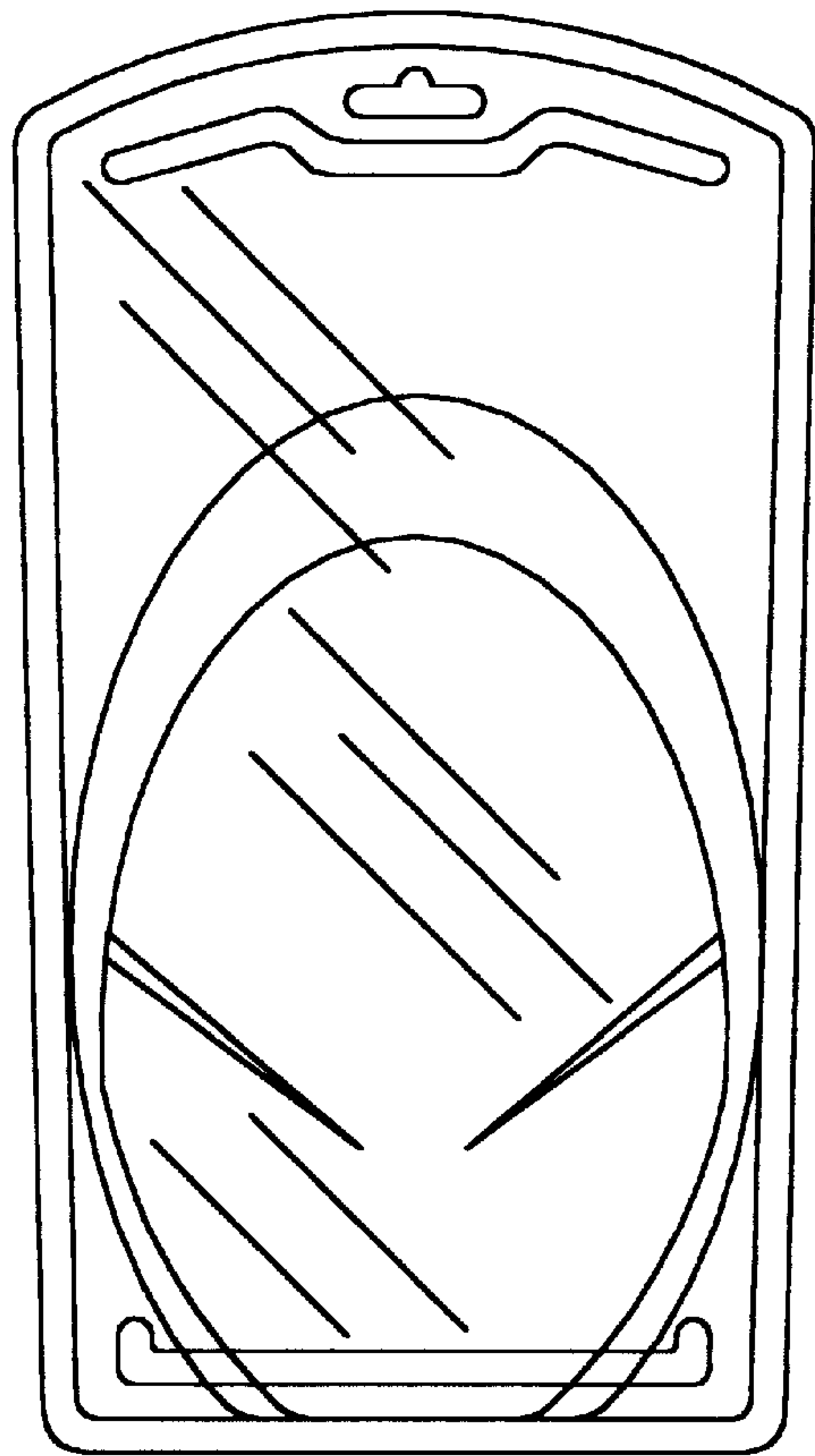

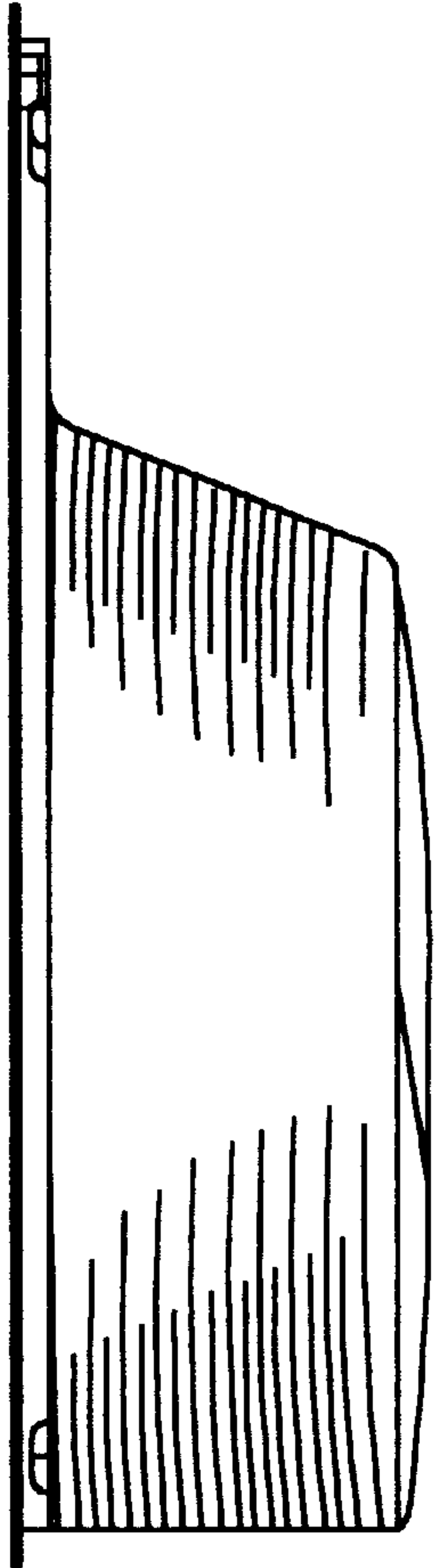

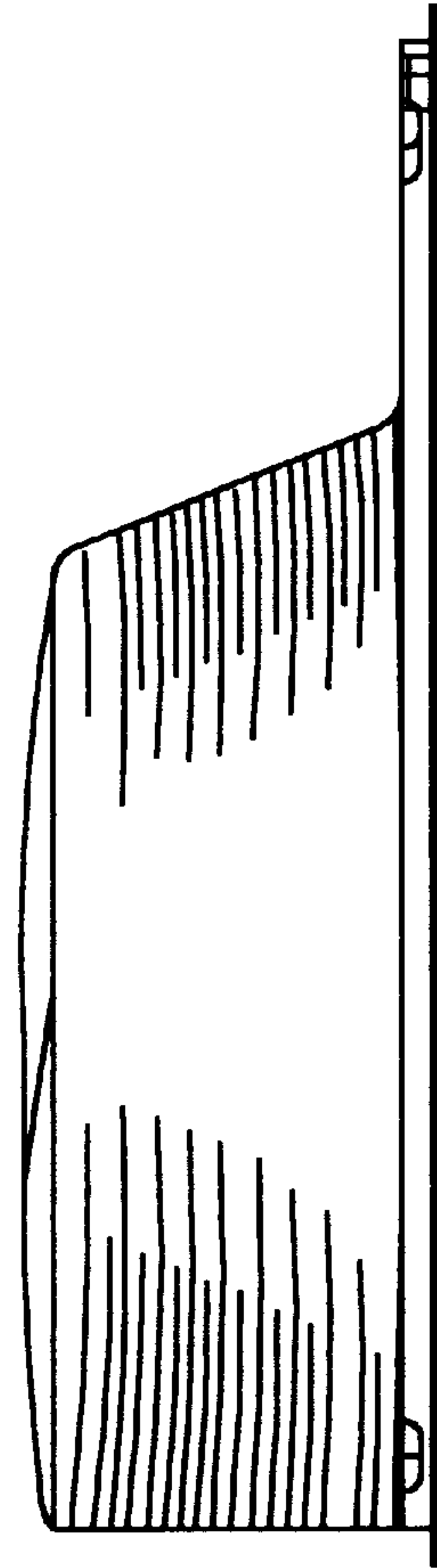

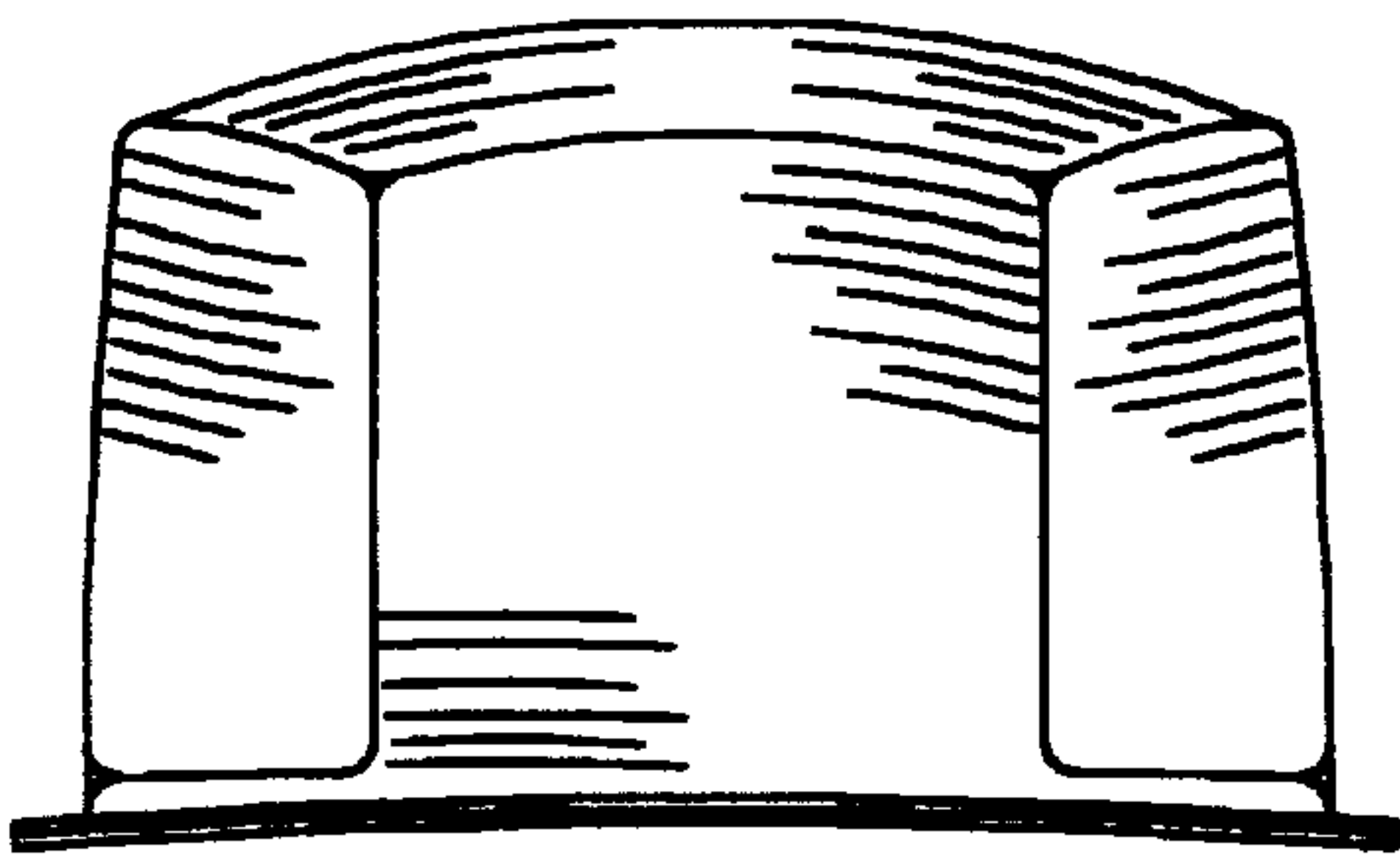

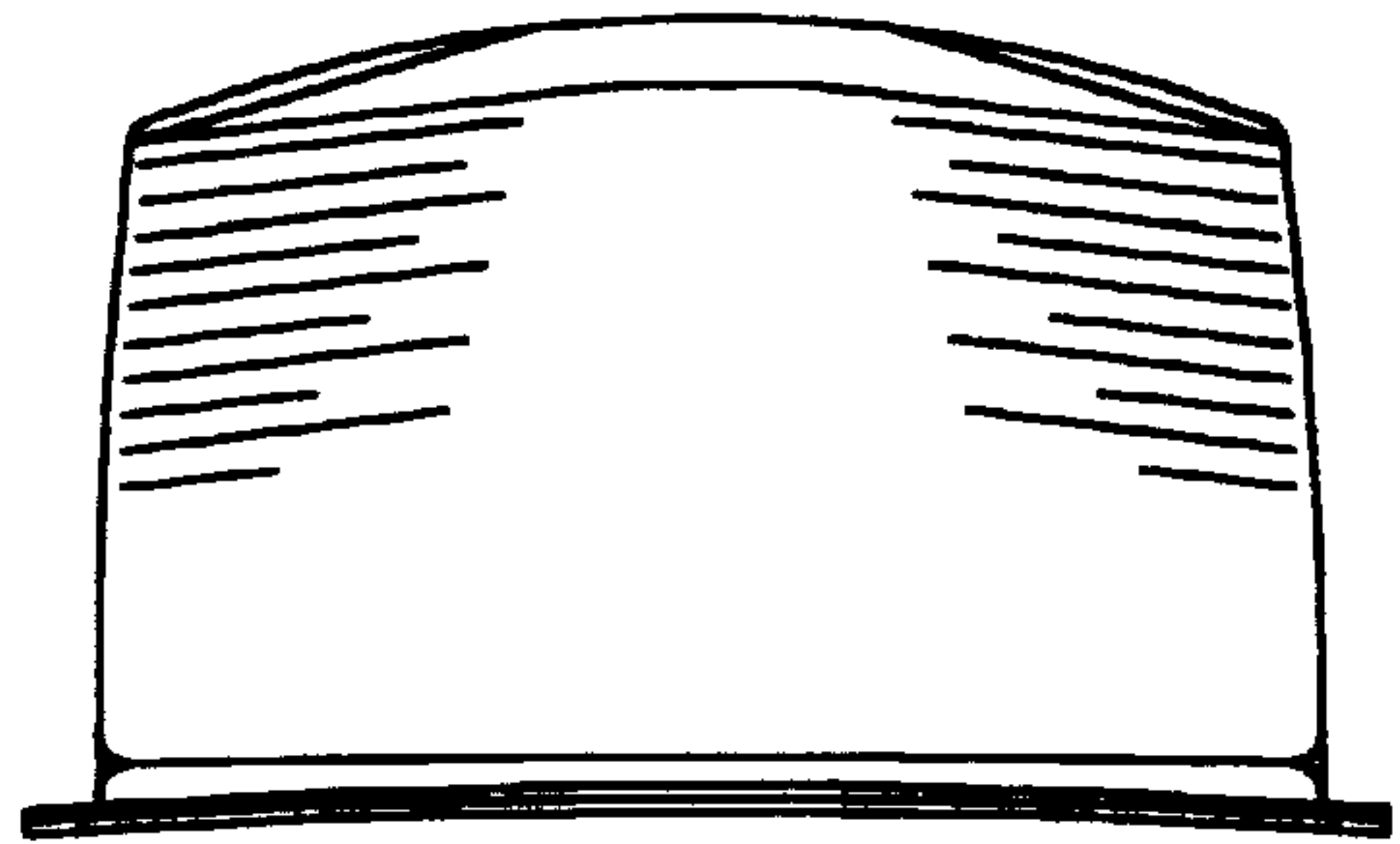

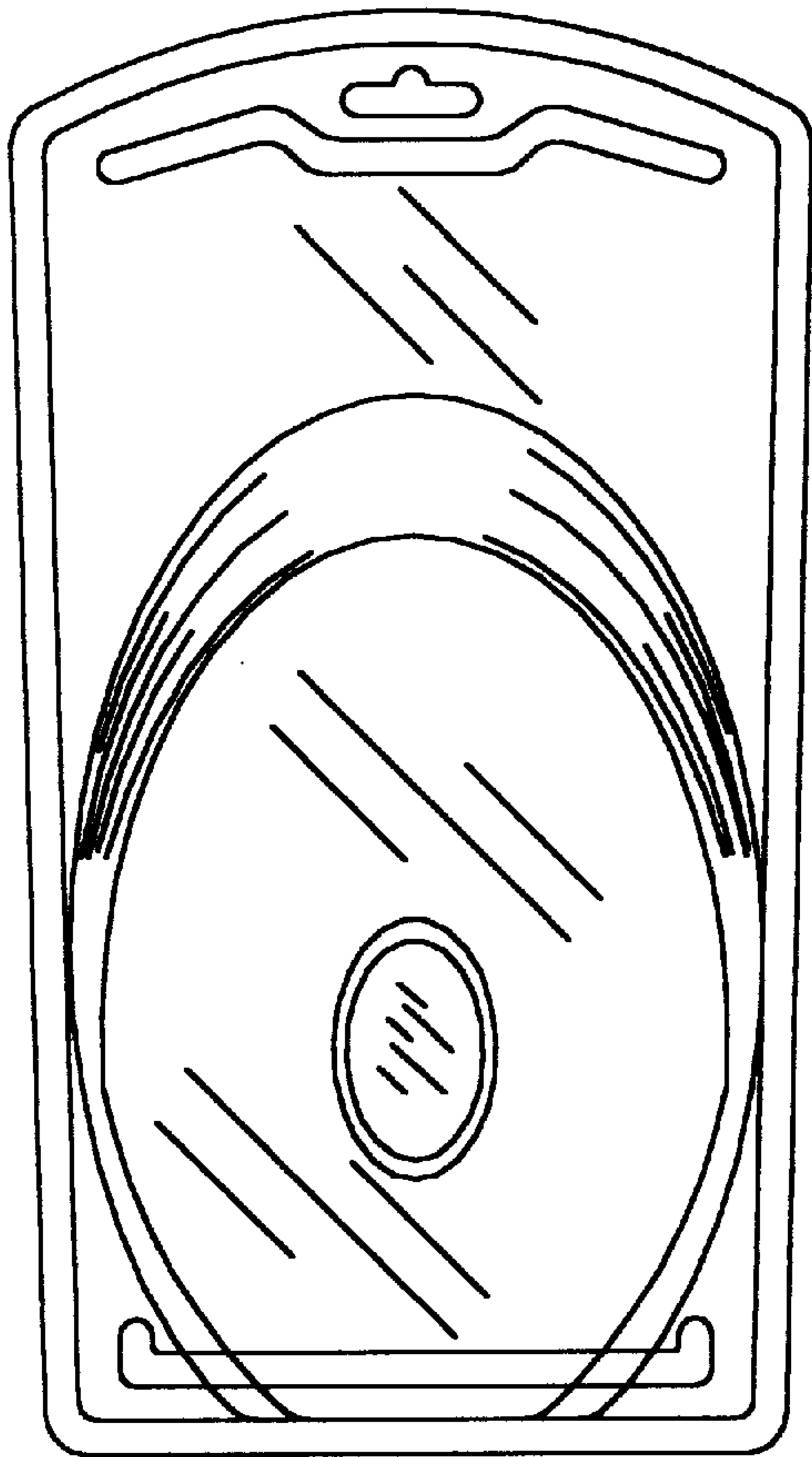

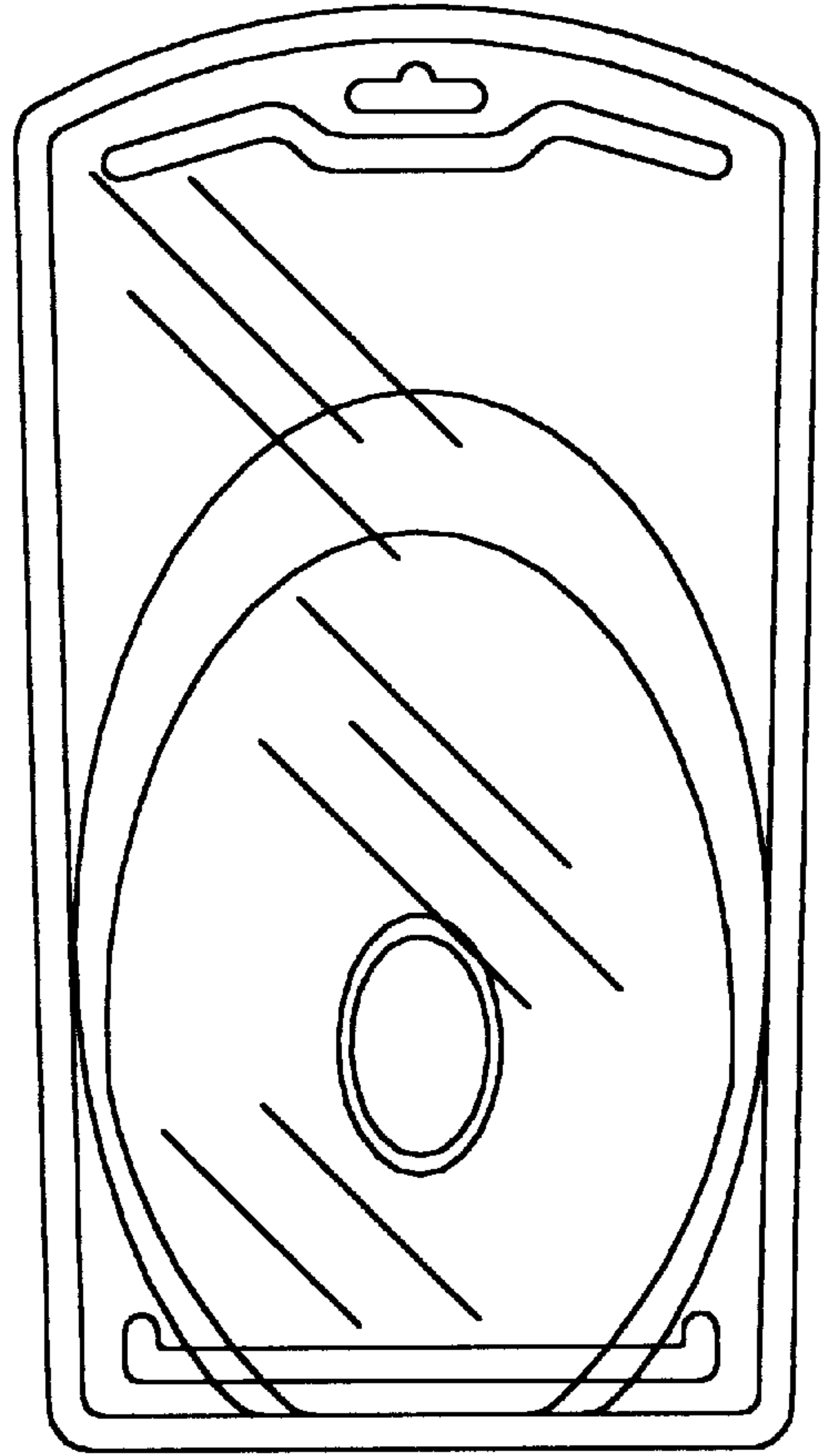

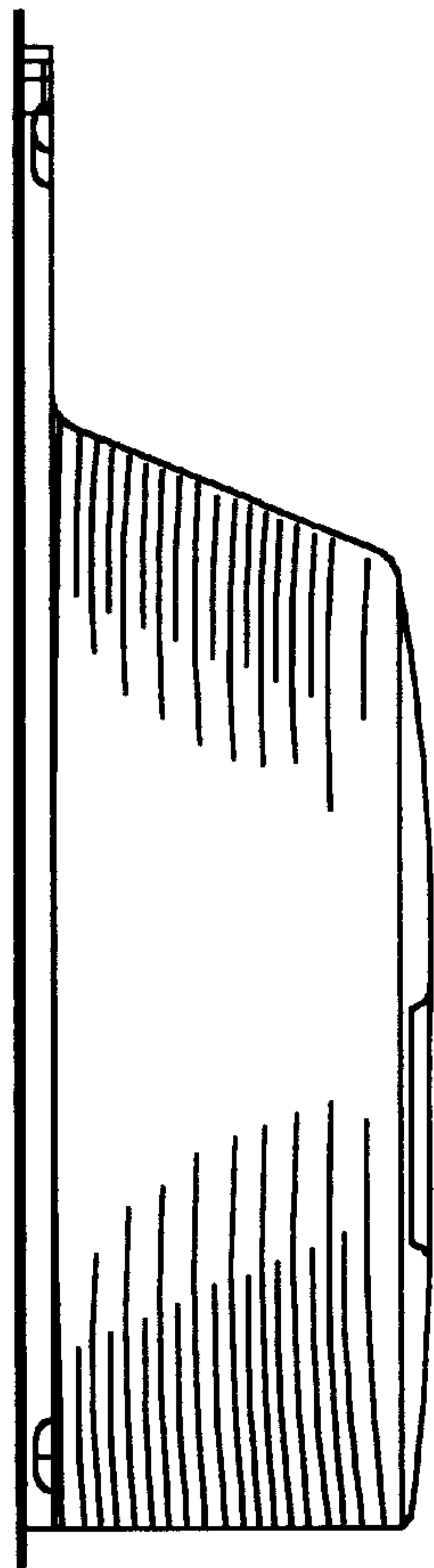

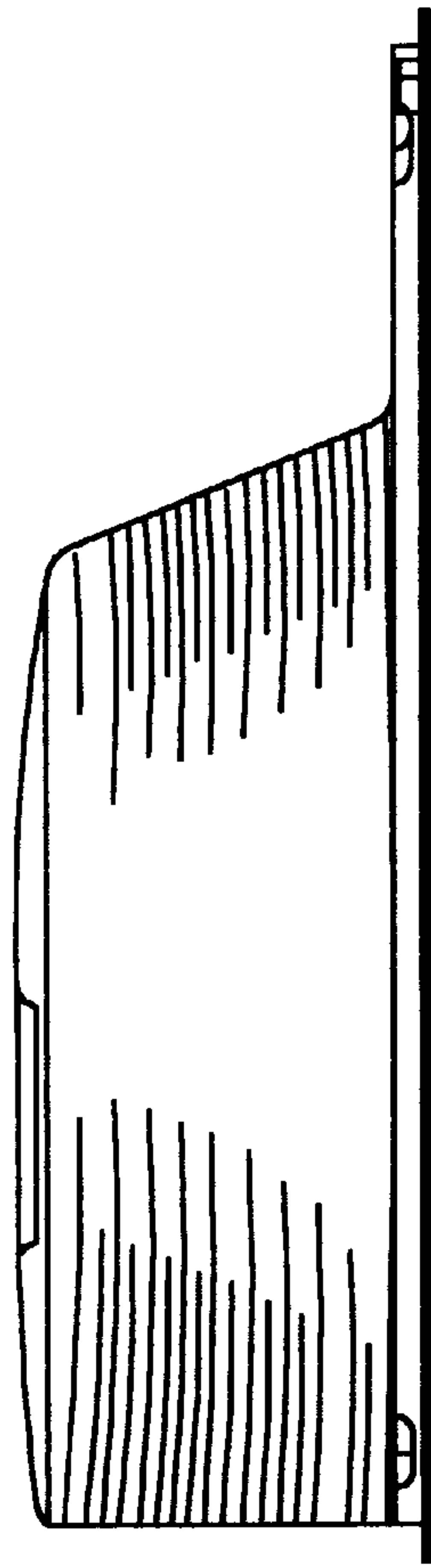

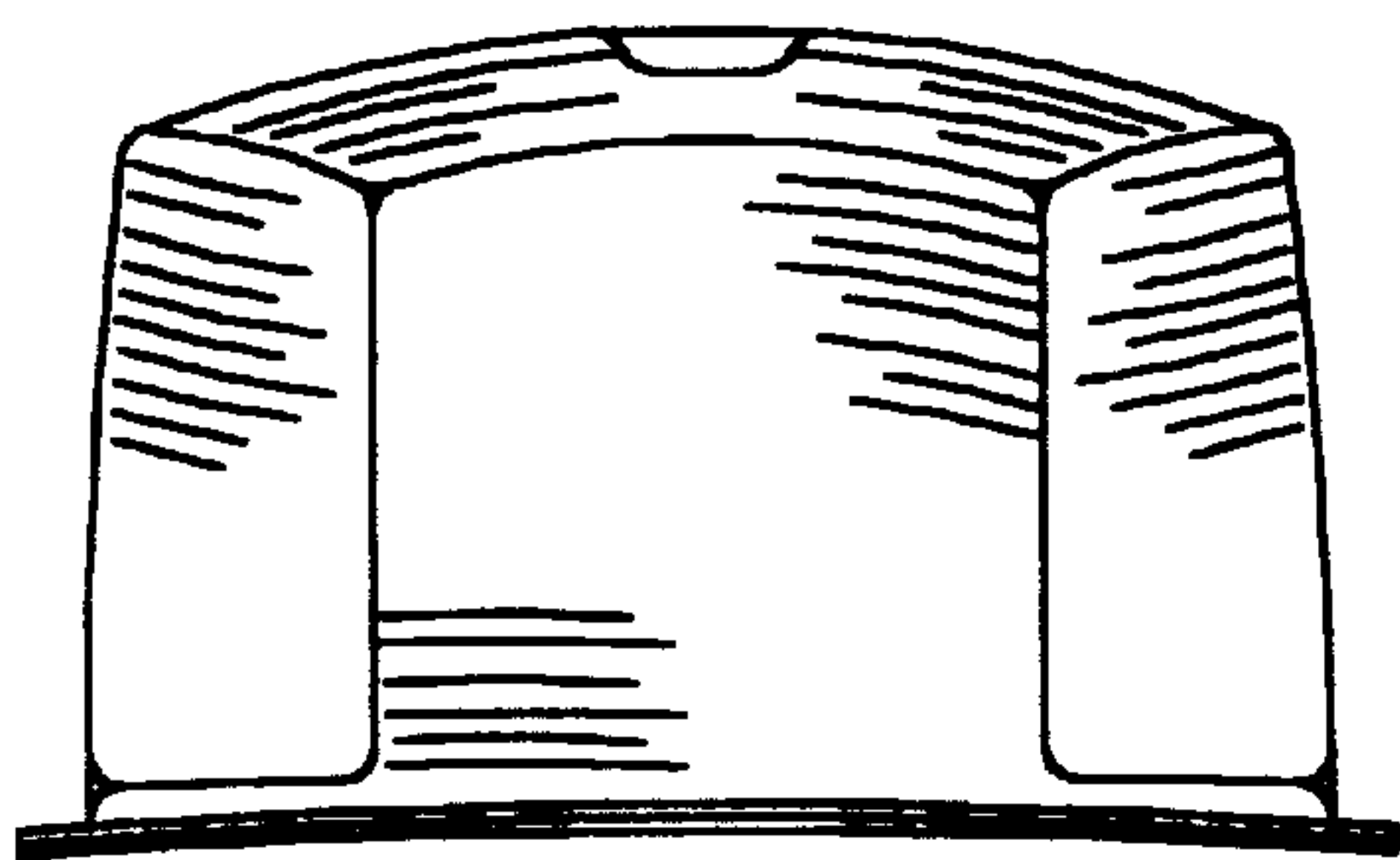

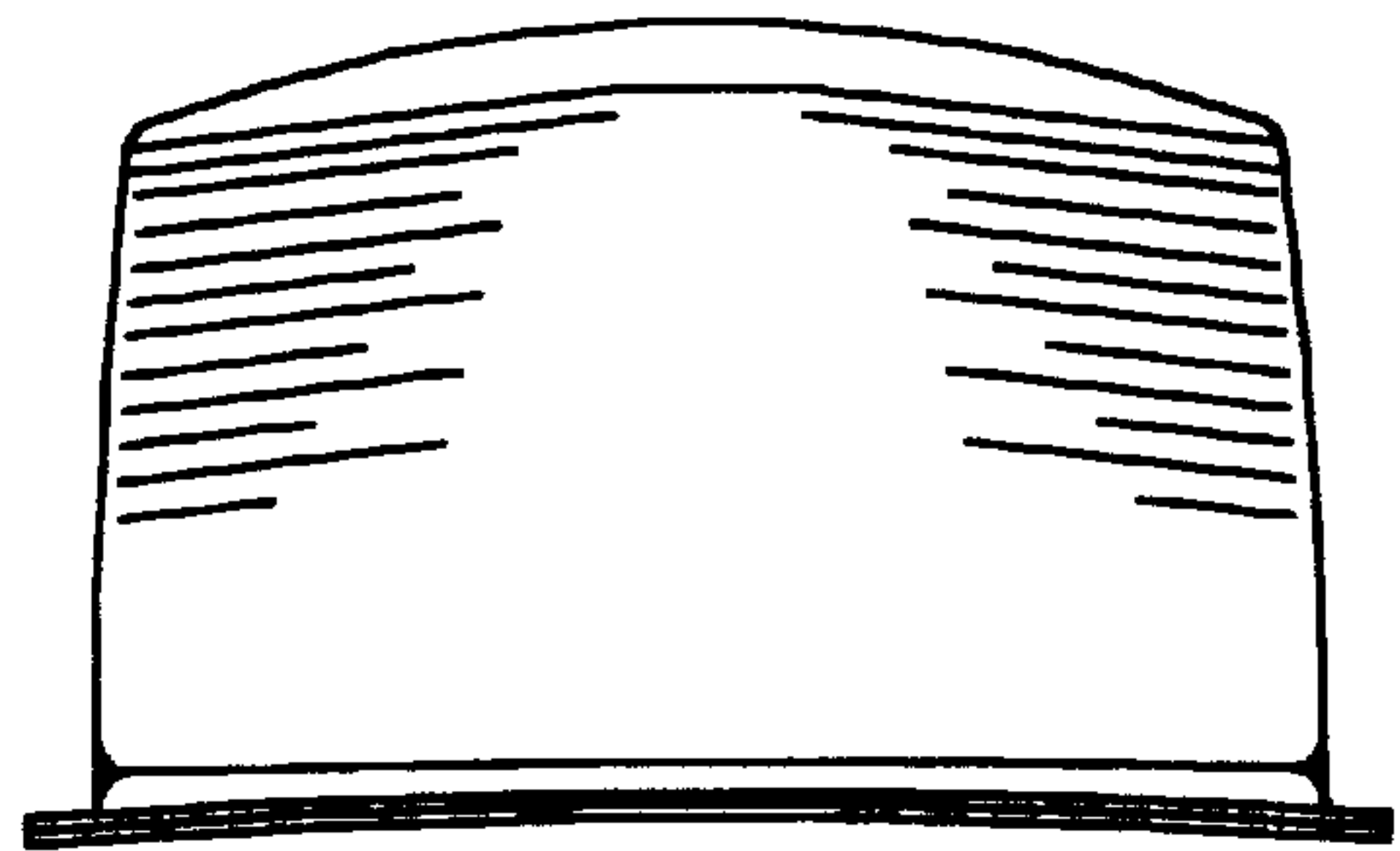

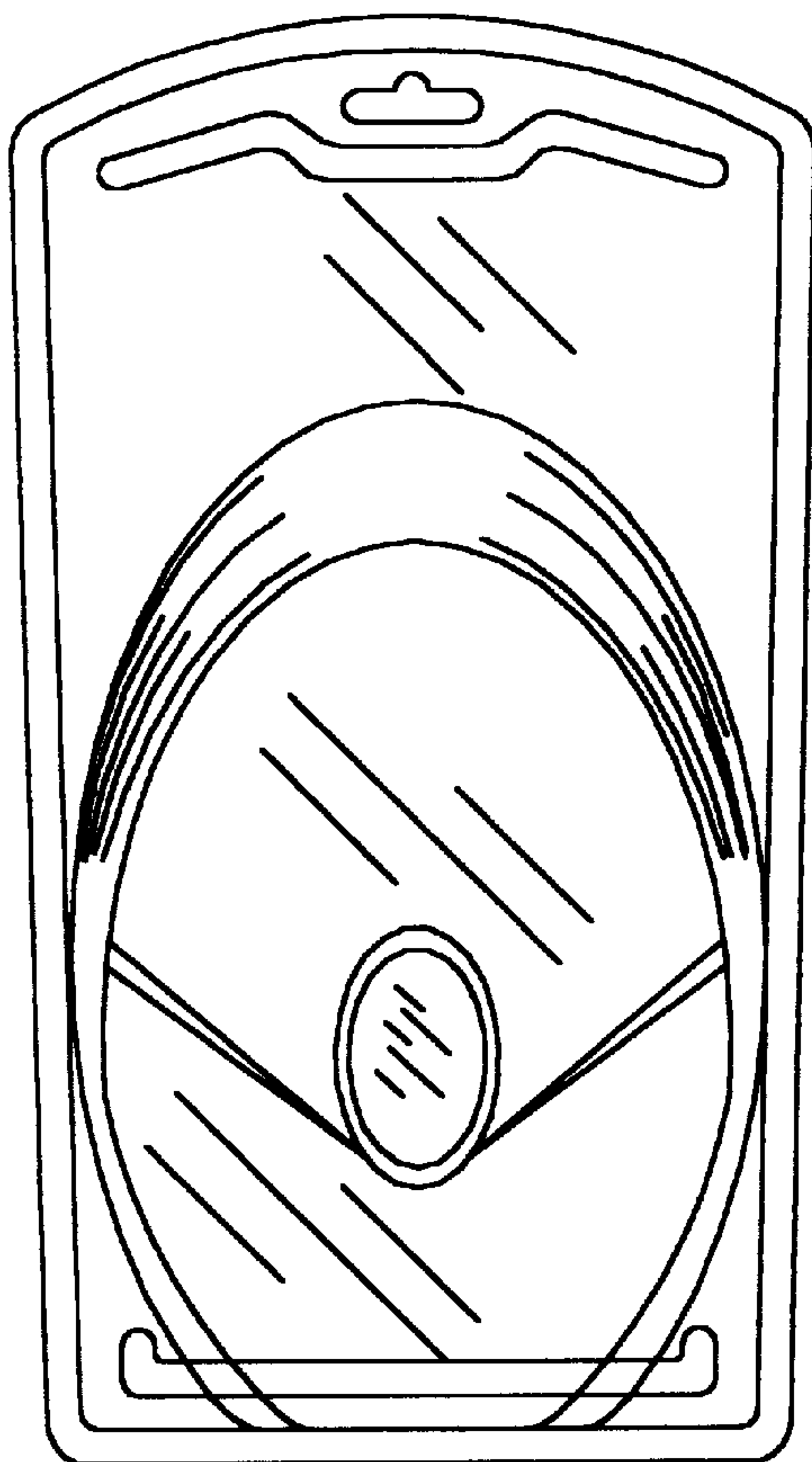

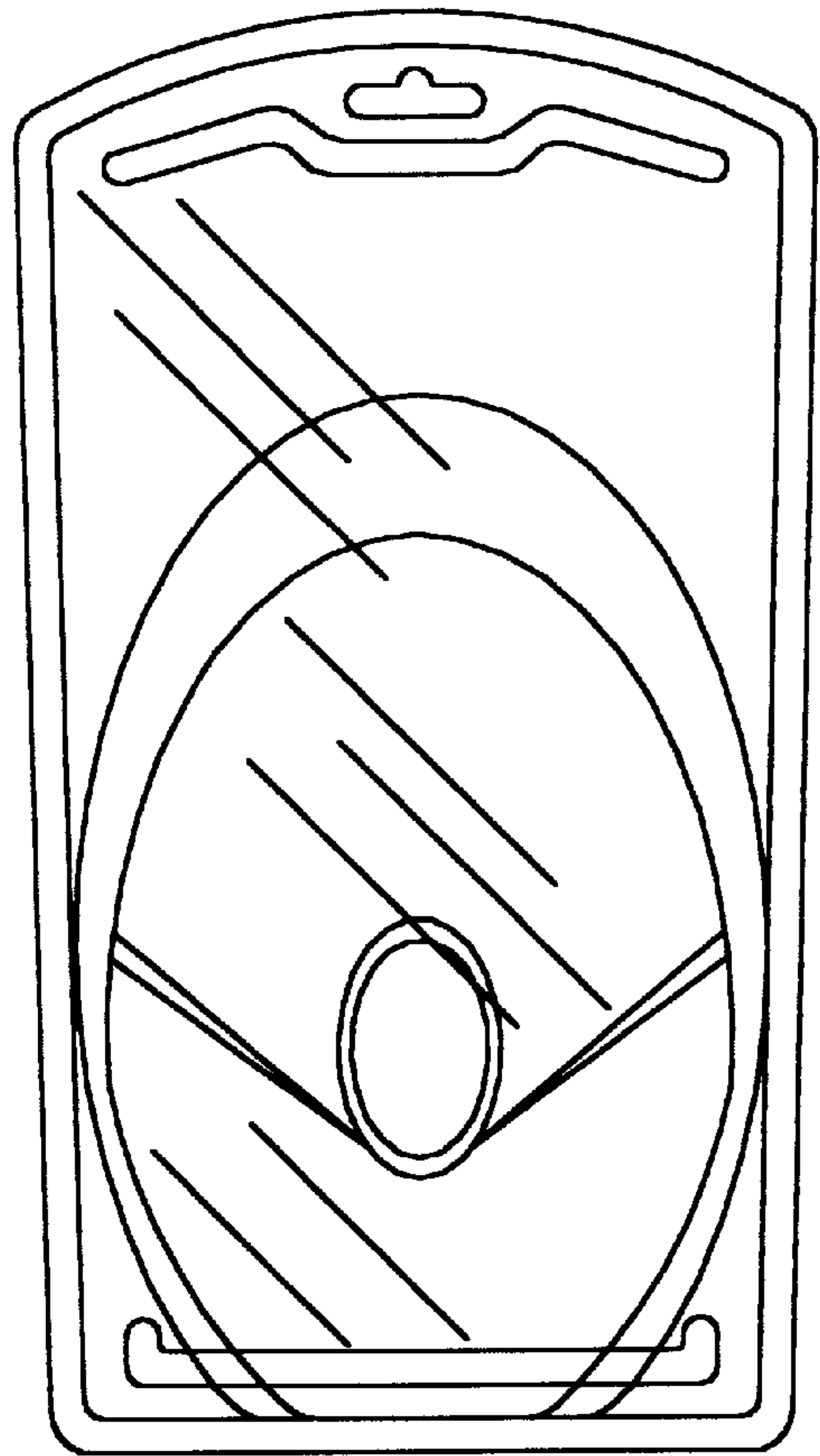

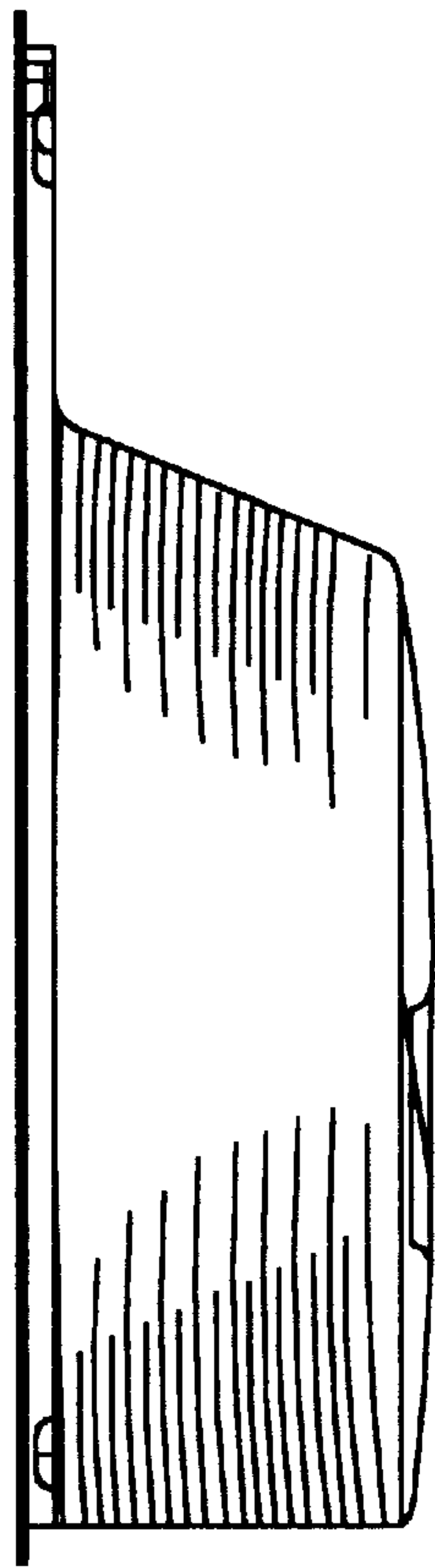

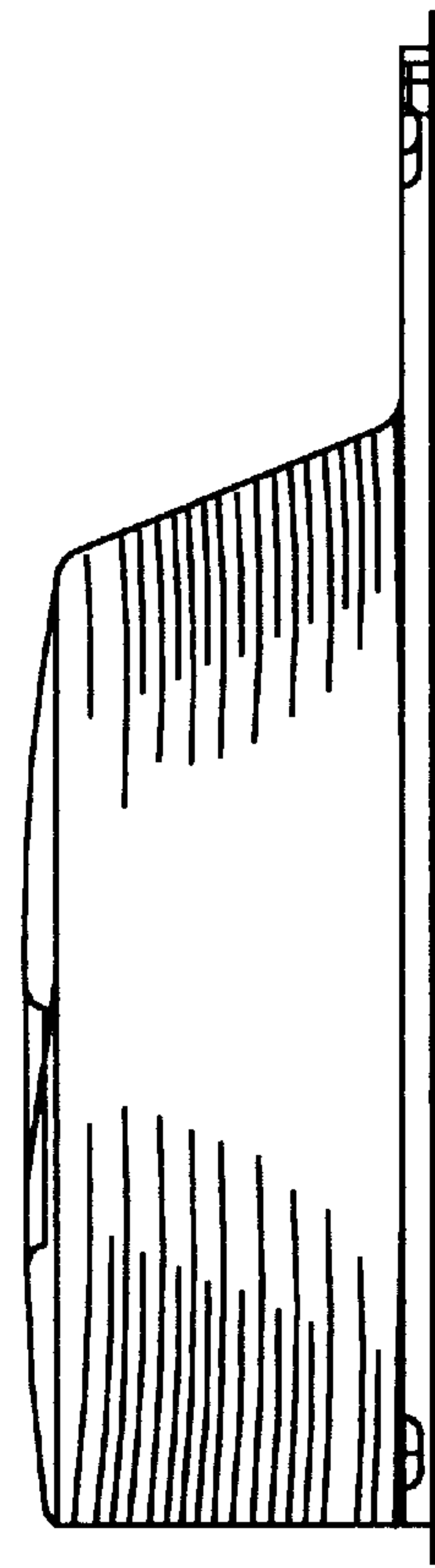

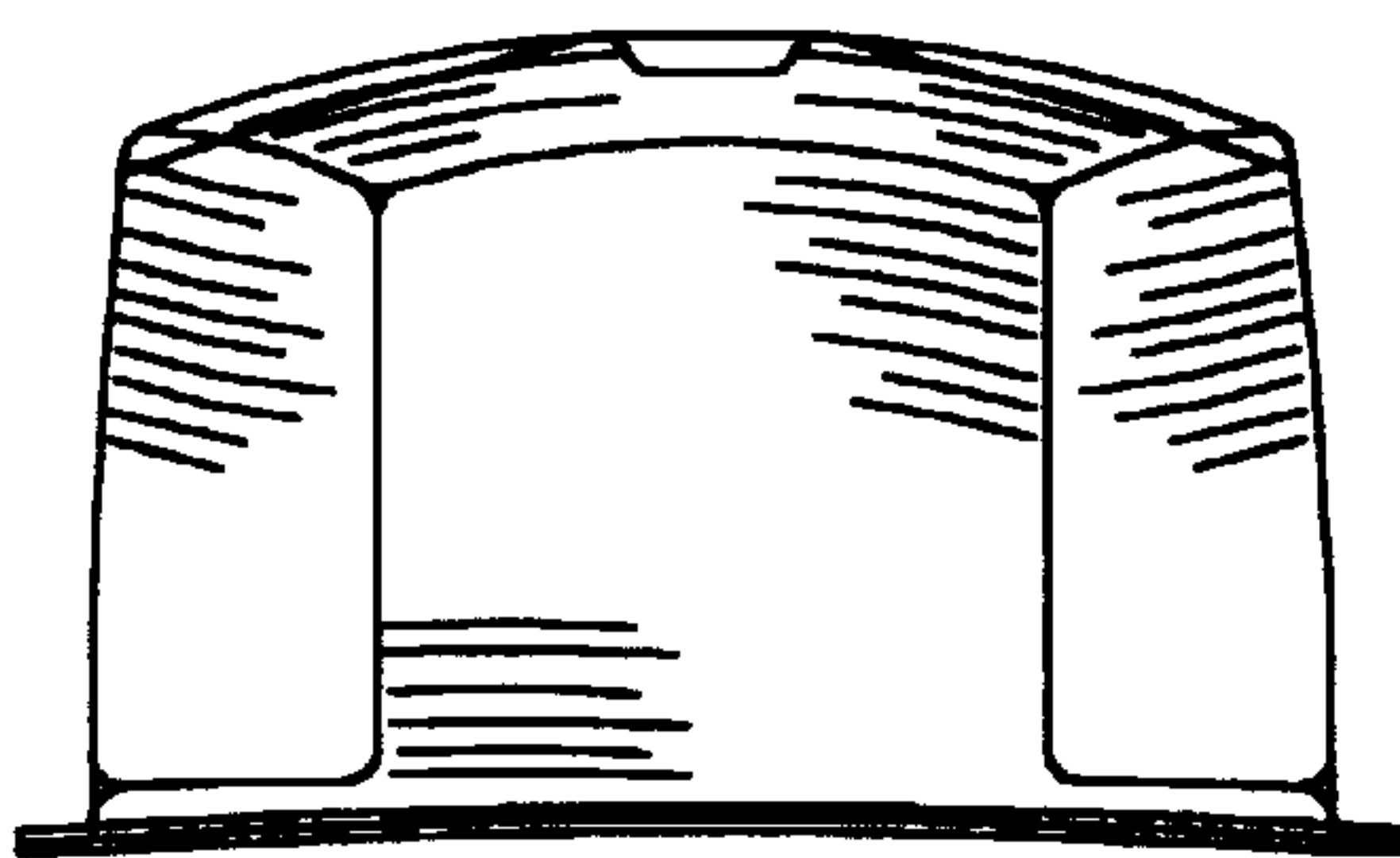

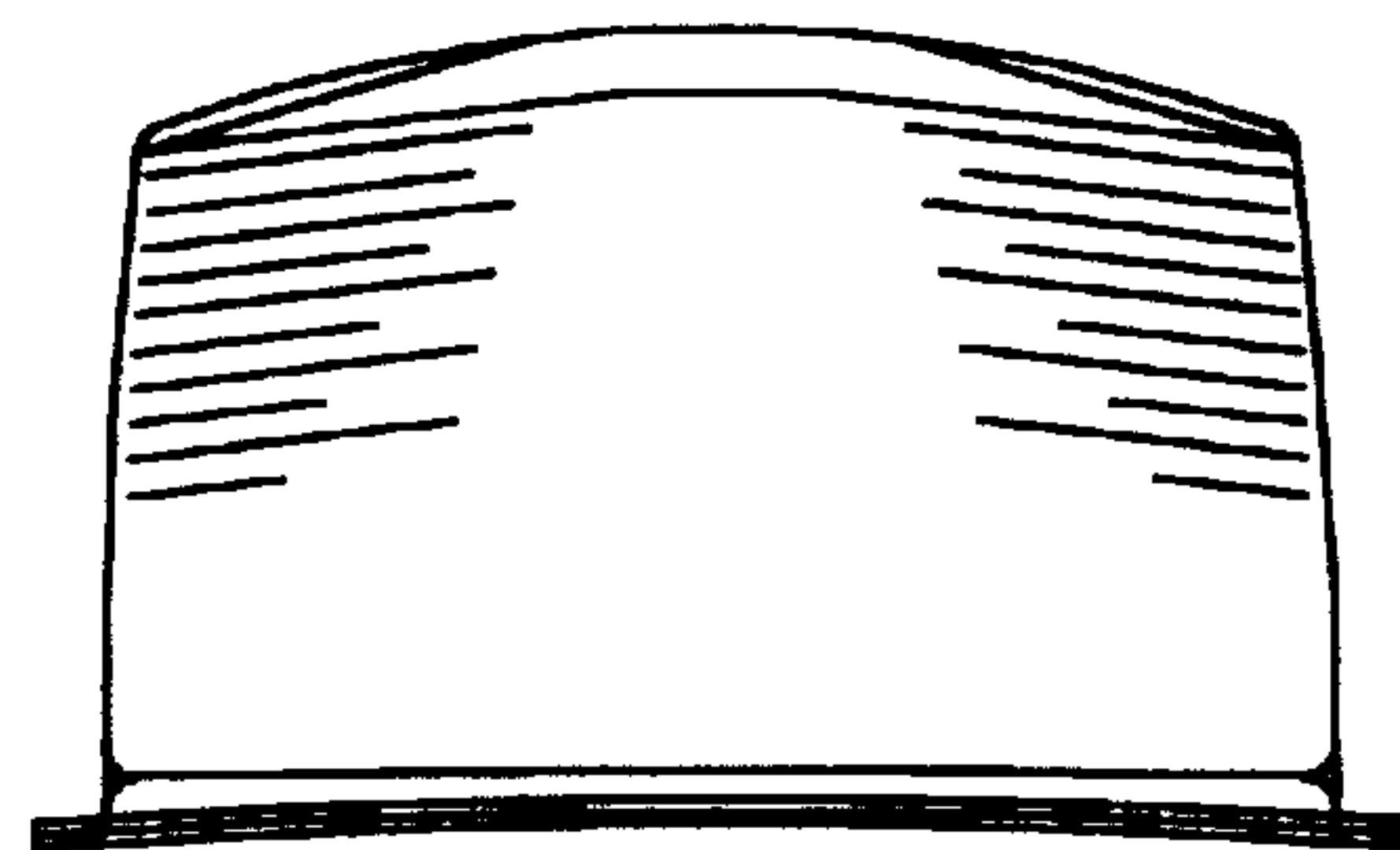
