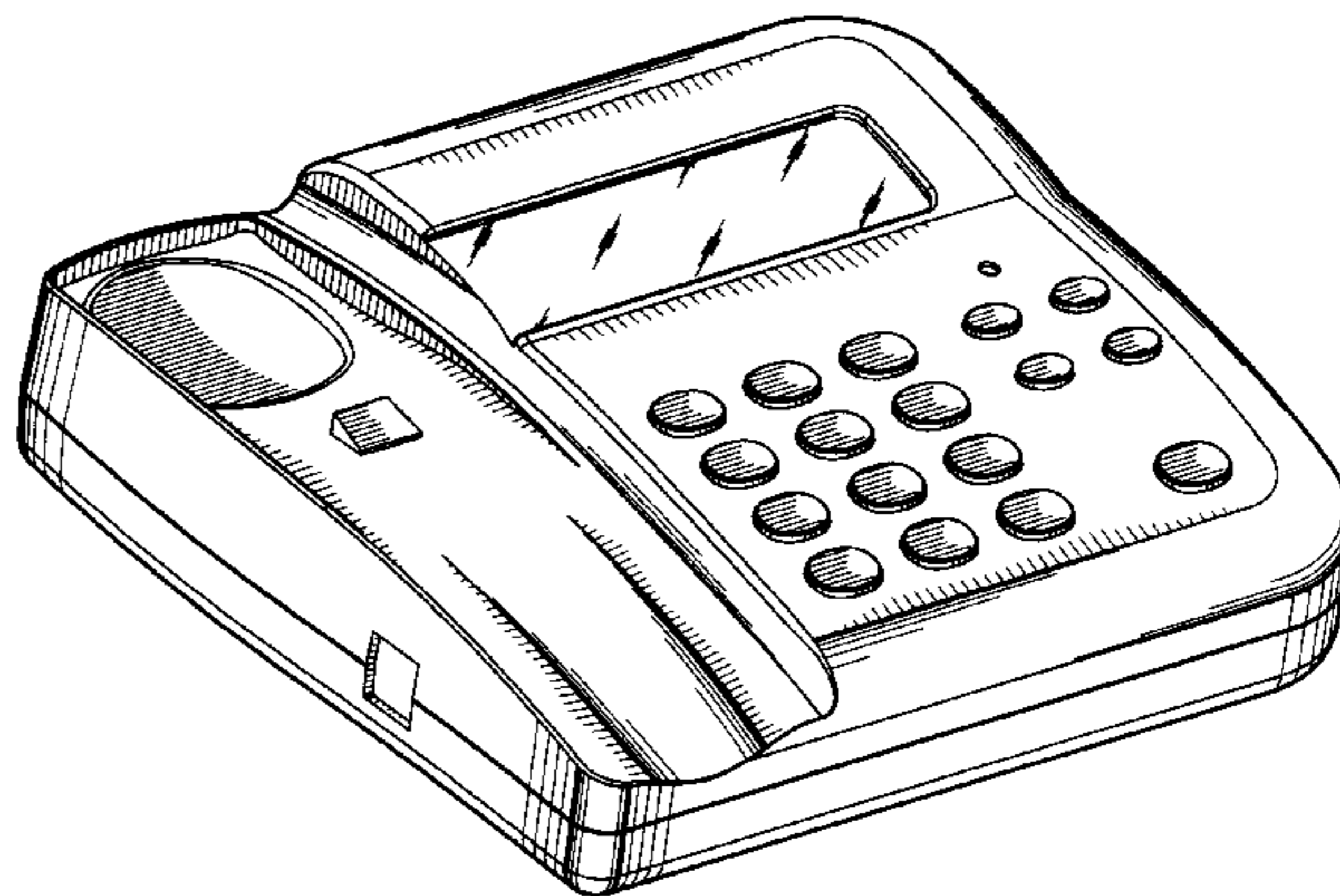
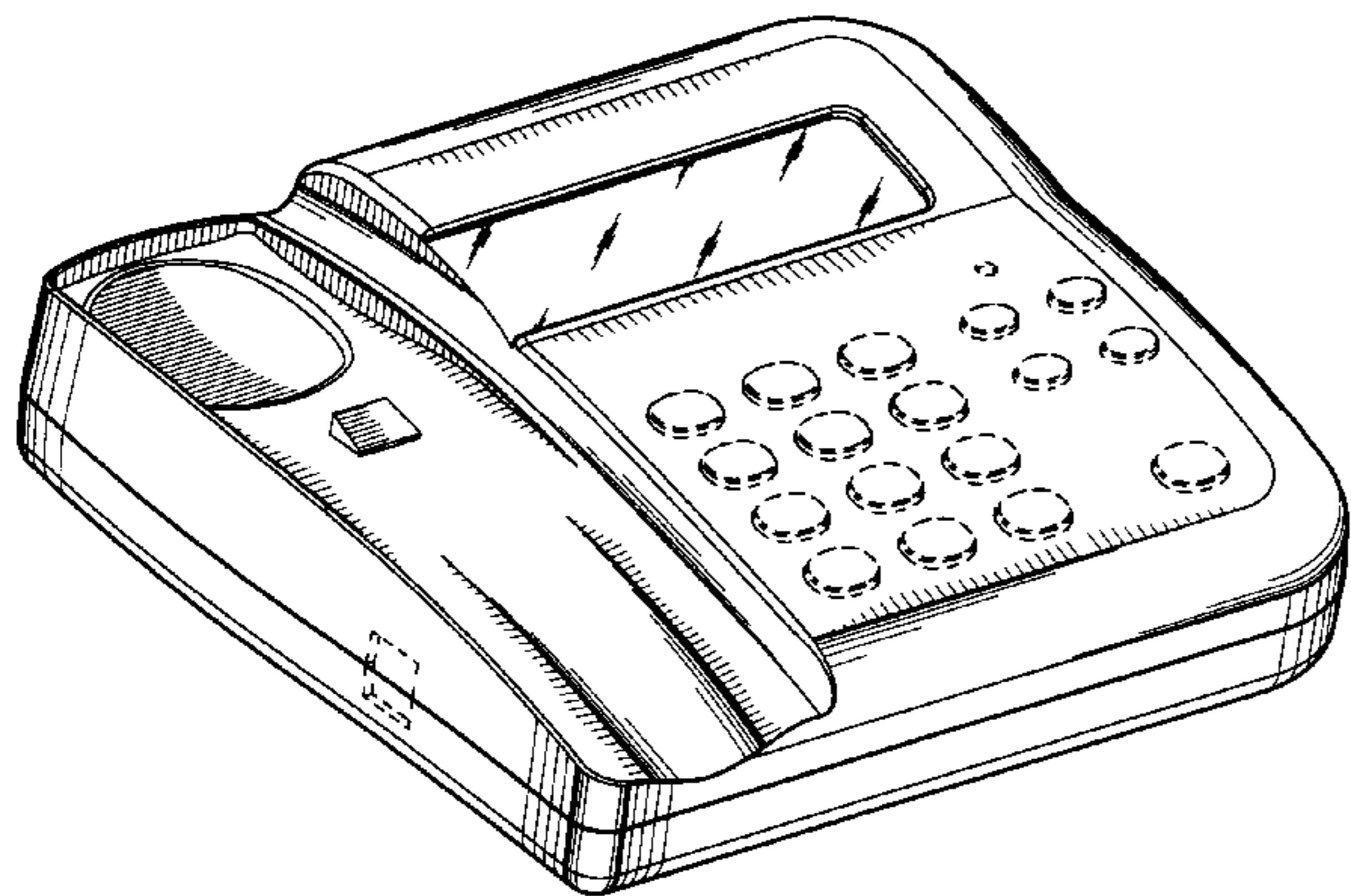
The ornamental design for a cellular telephone housing, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom, and left side perspective view of a first embodiment of a cellular telephone housing; FIG. 2 is a front elevation view of the first embodiment; FIG. 3 is a right side elevation view of the first embodiment; FIG. 4 is a bottom plan view of the first embodiment; FIG. 5 is a top plan view of the first embodiment; FIG. 6 is a rear elevation view of the first embodiment; FIG. 7 is a left side elevation view of the first embodiment; FIG. 8 is a front, bottom, and left side perspective view of a second embodiment of a cellular telephone housing; FIG. 9 is a front elevation view of the second embodiment; FIG. 10 is a right side elevation view of the second embodiment; FIG. 11 is a bottom plan view of the second embodiment; FIG. 12 is a top plan view of the second embodiment; FIG. 13 is a rear elevation view of the second embodiment; and, FIG. 14 is a left side elevation view of the second embodiment.

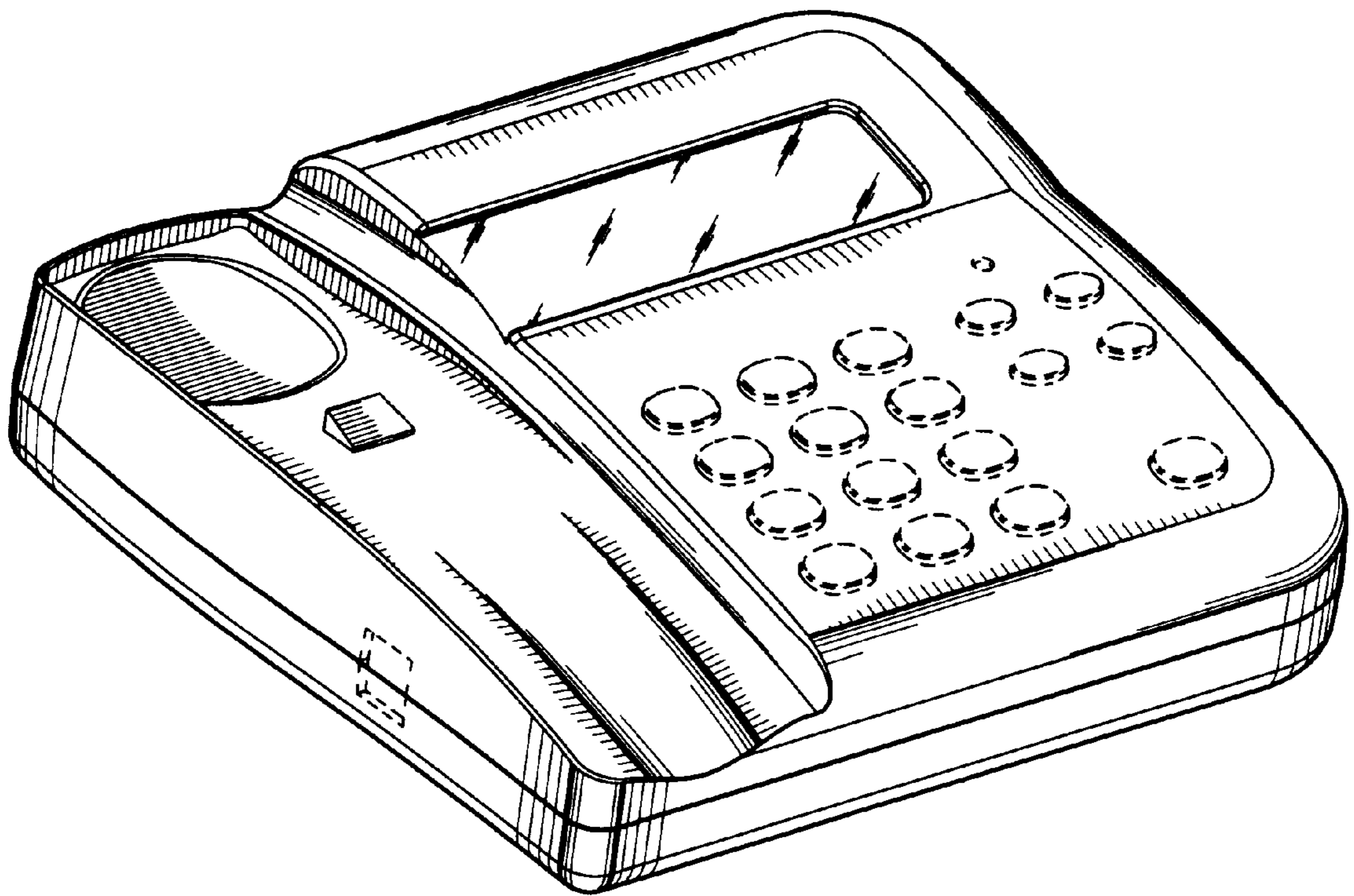

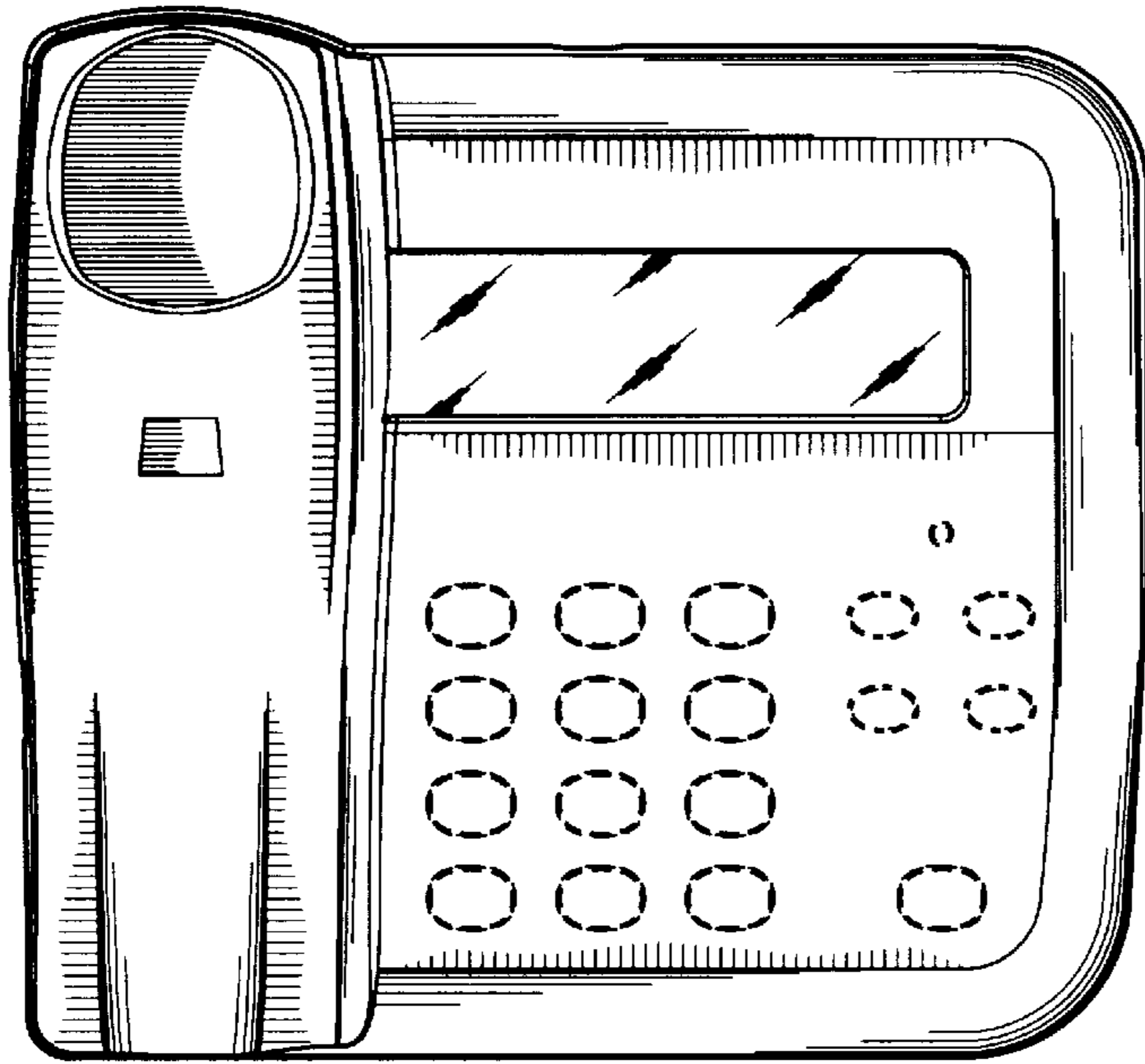

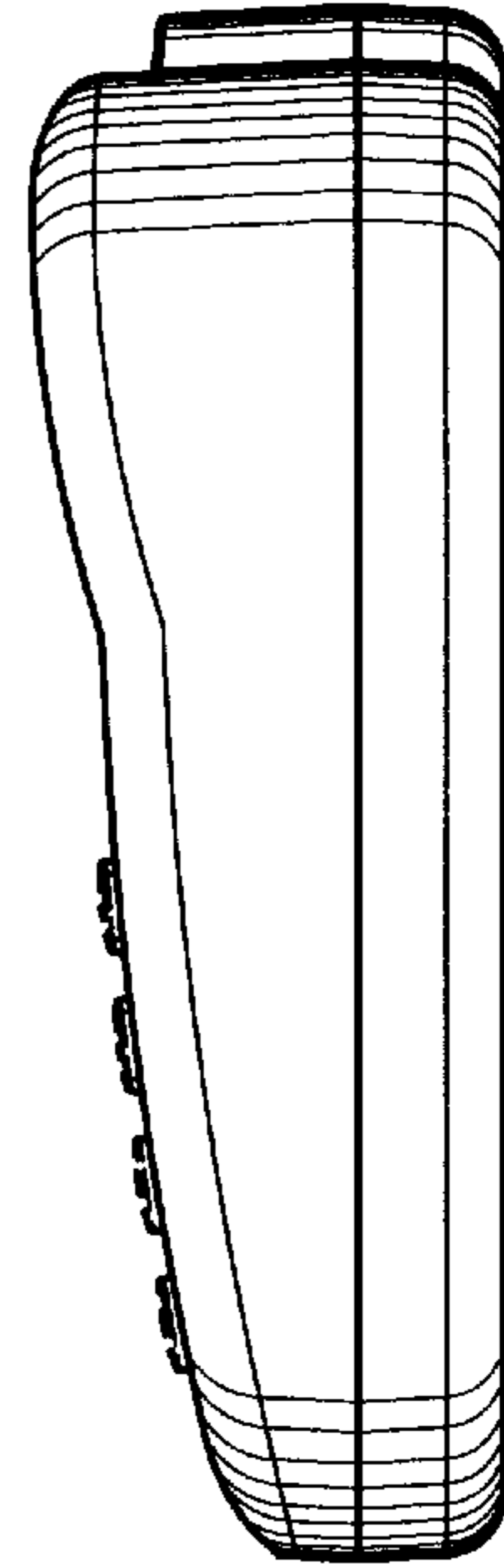

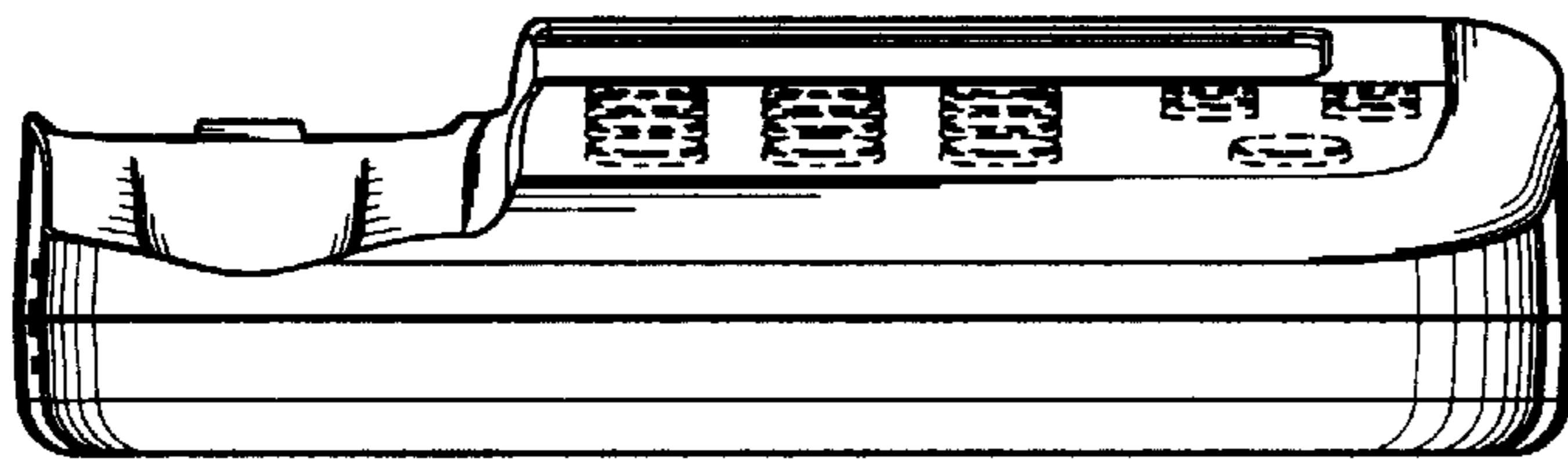

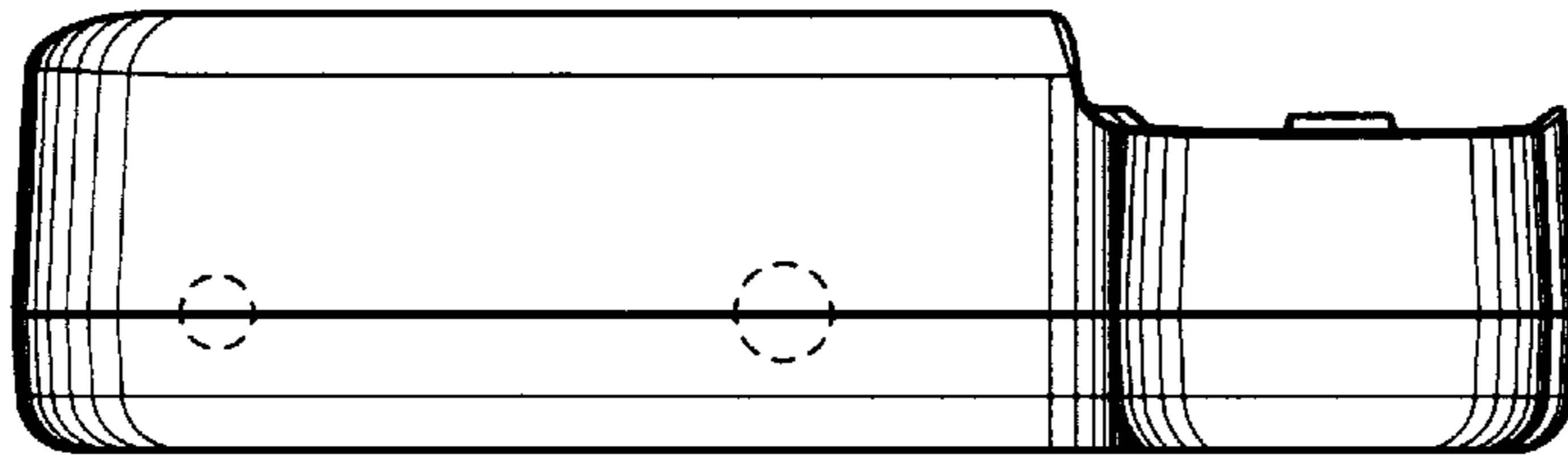

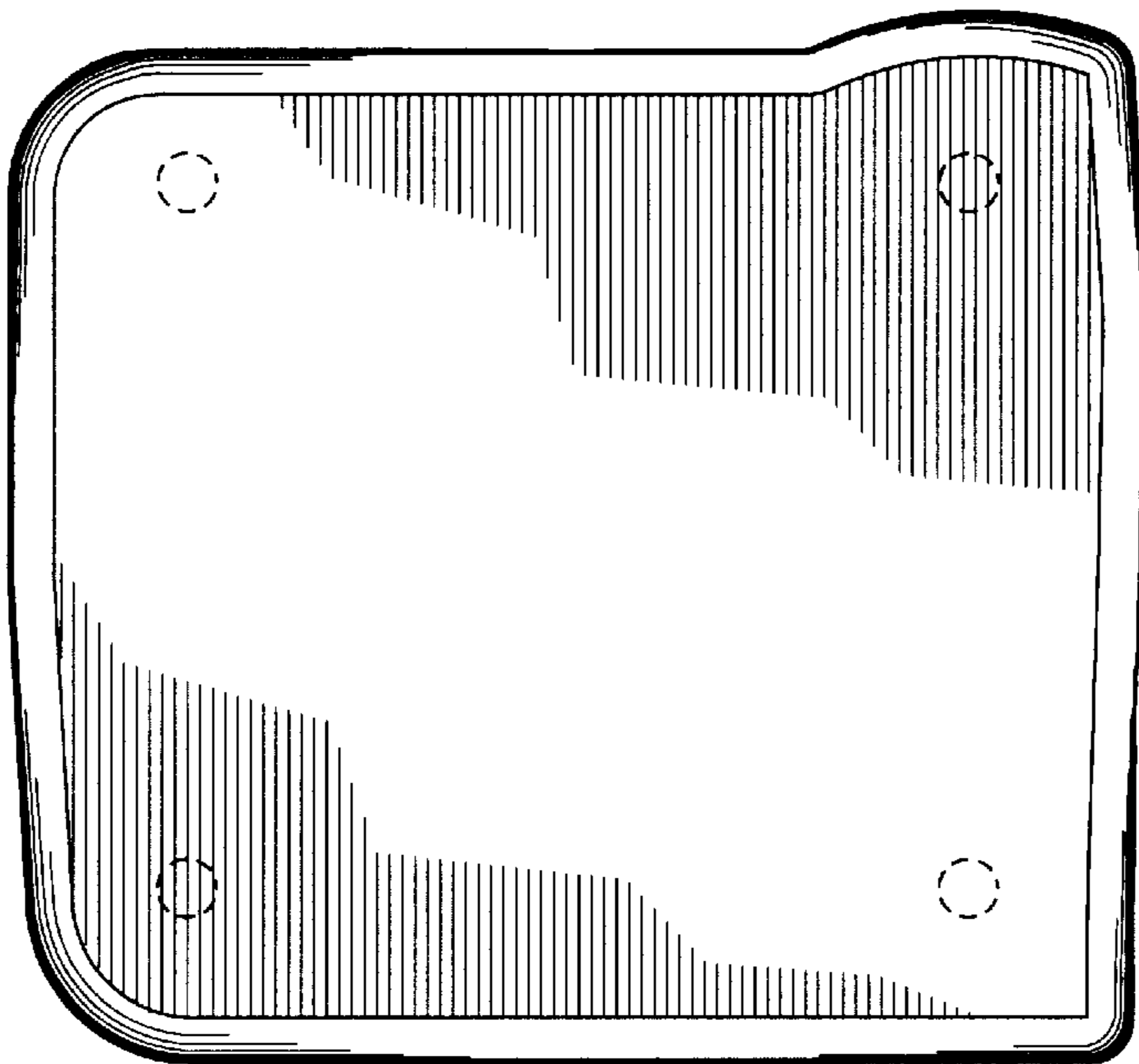

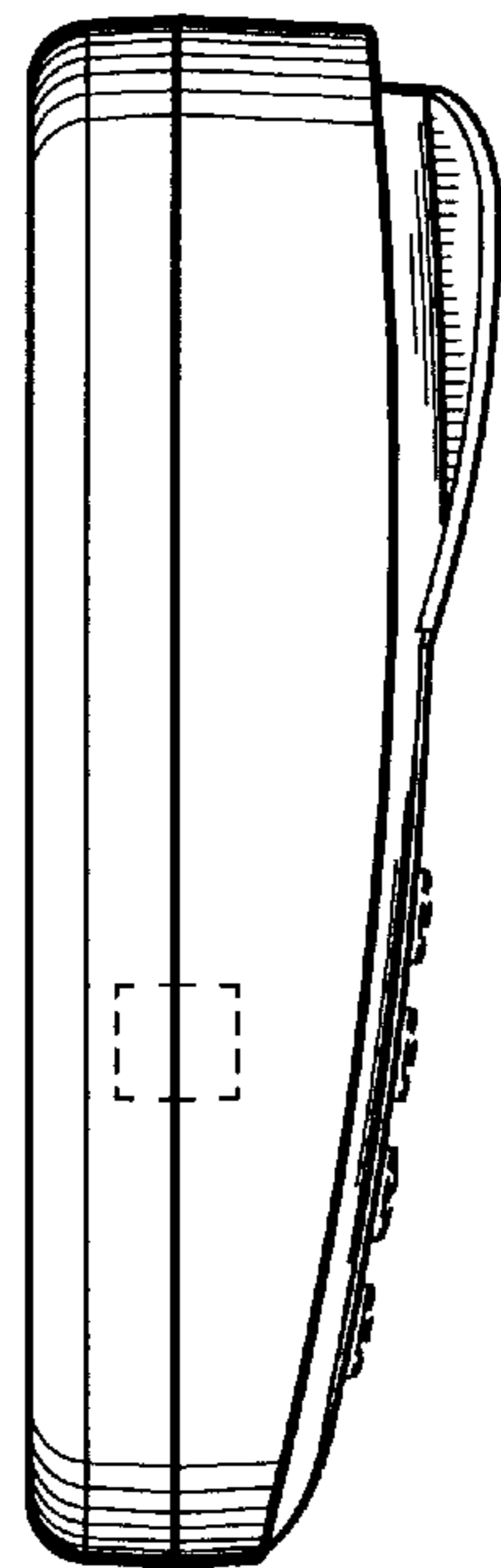

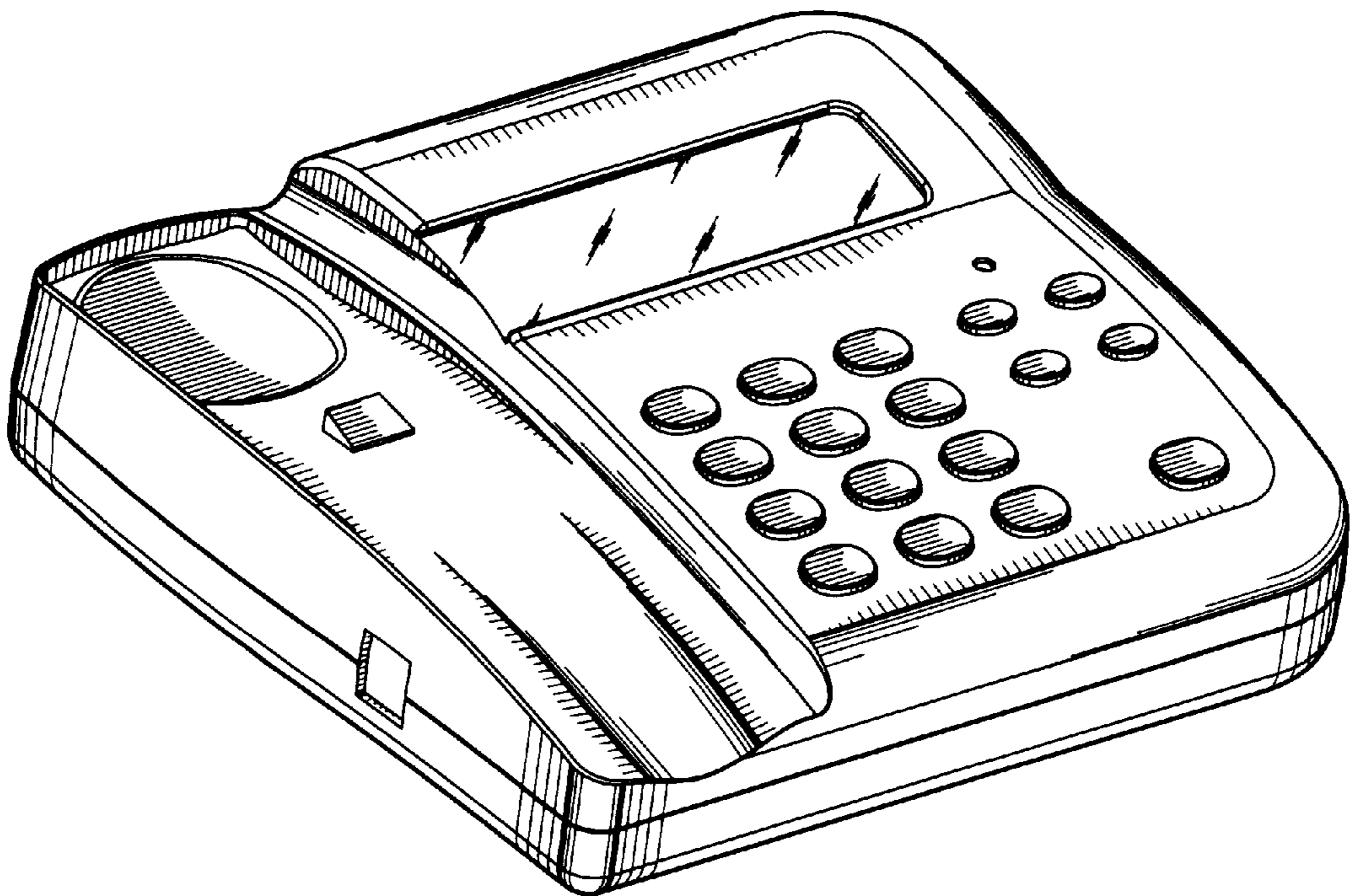

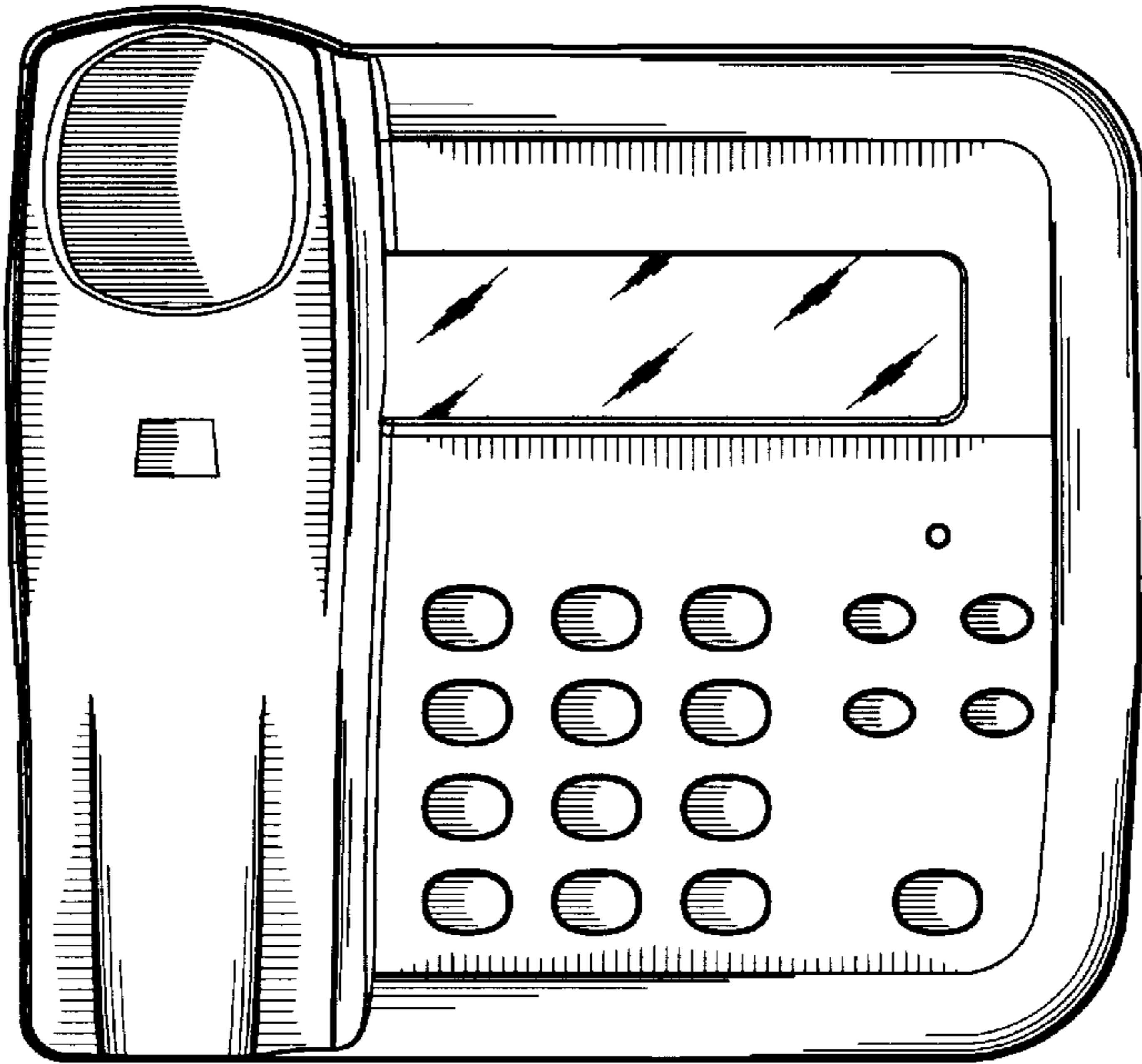

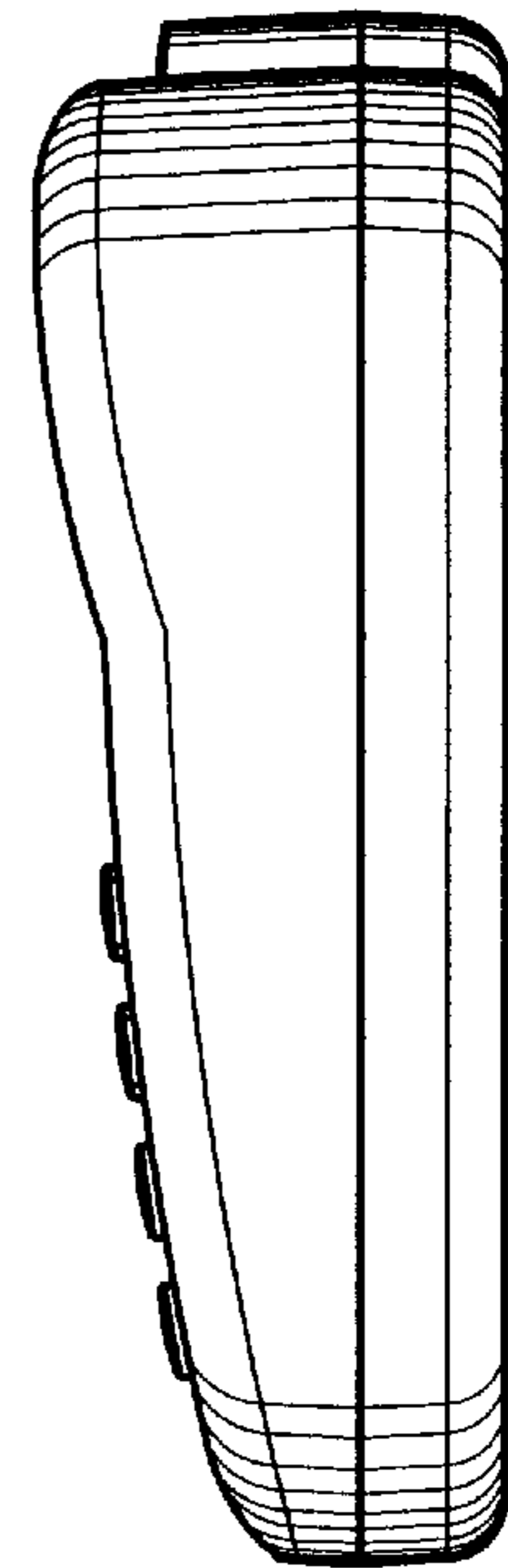

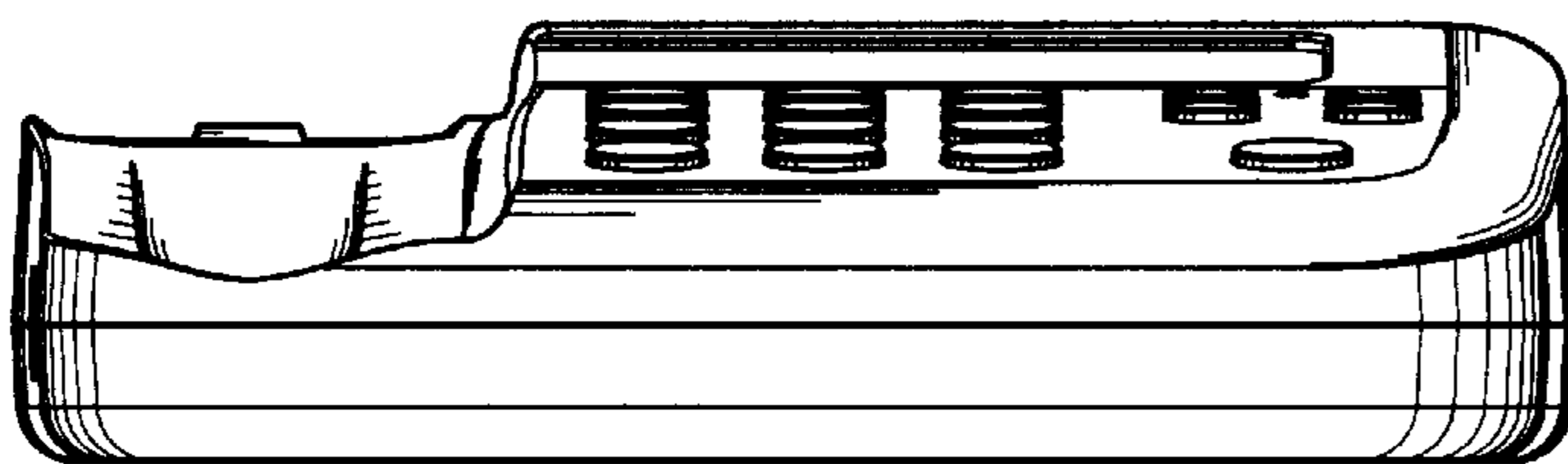

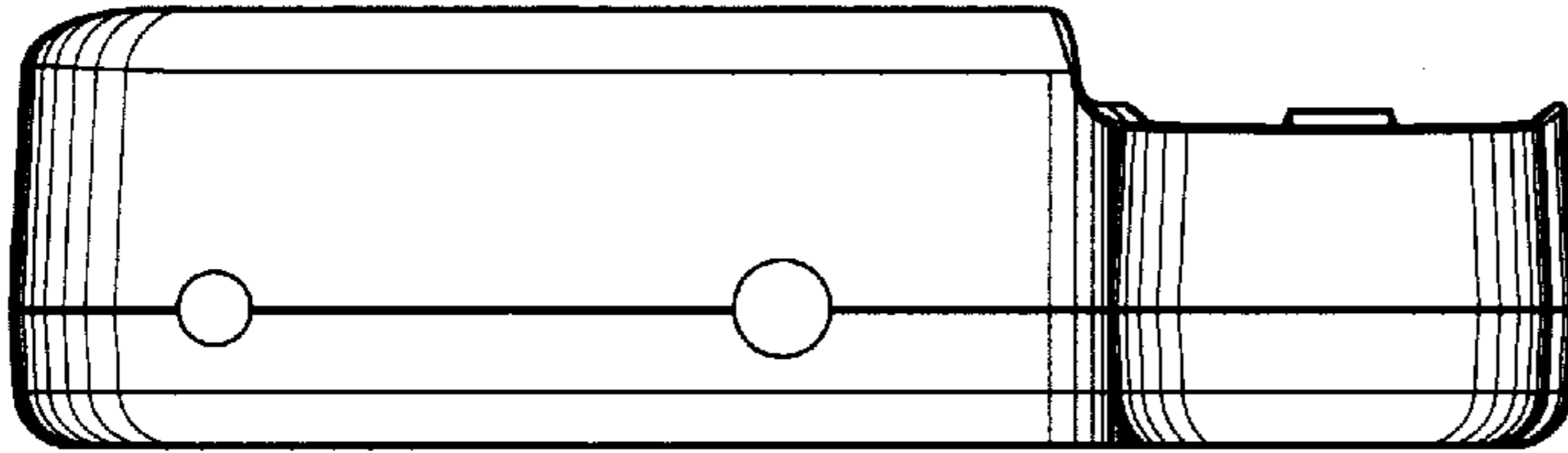

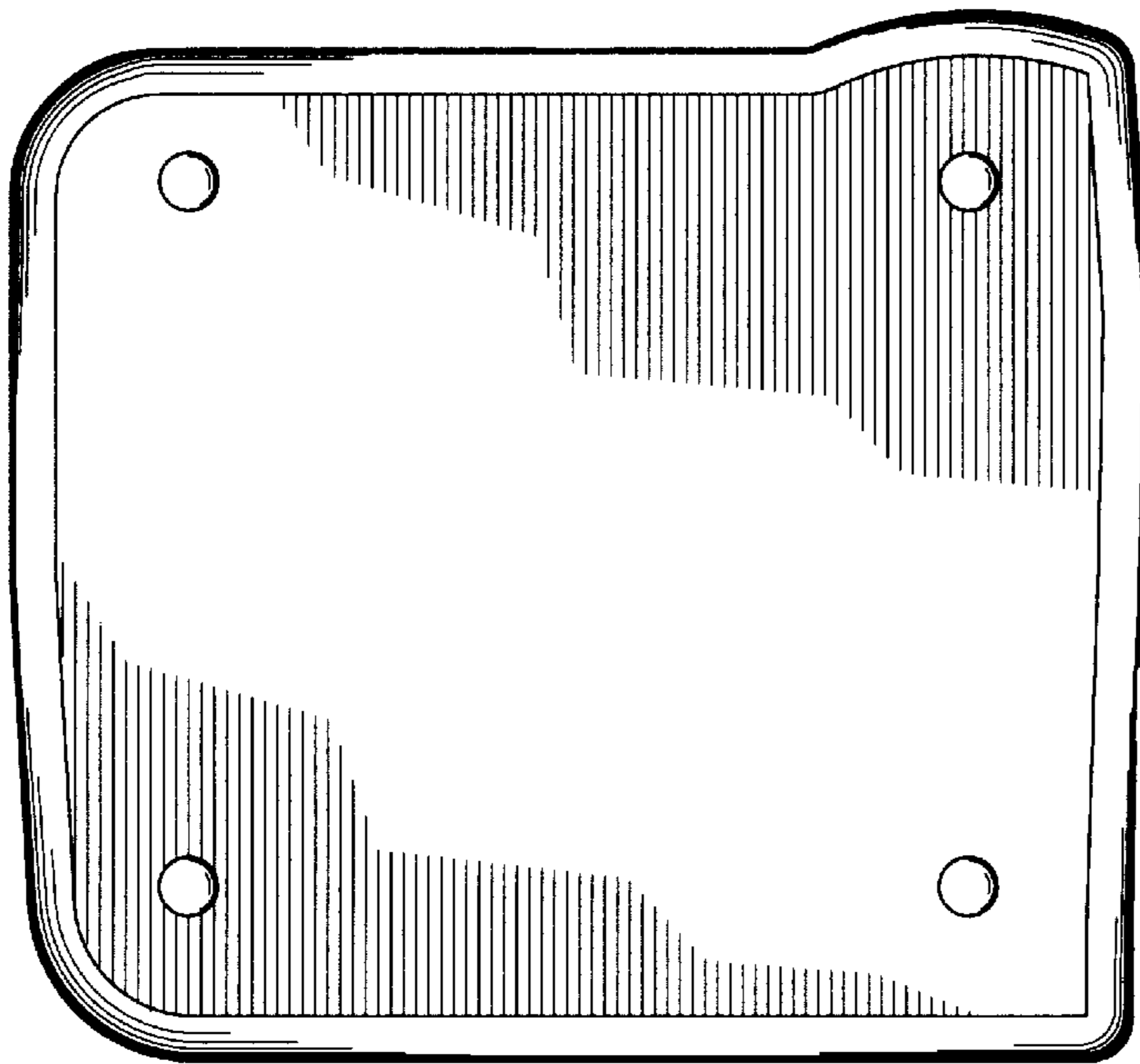

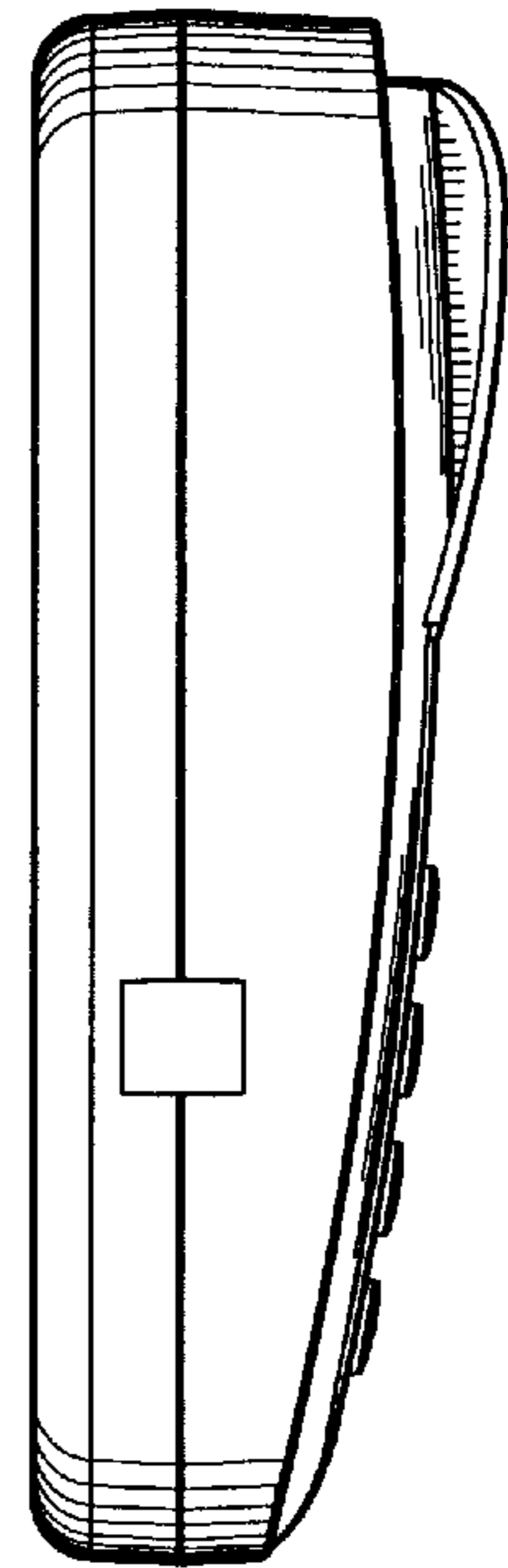
