DESCRIPTION

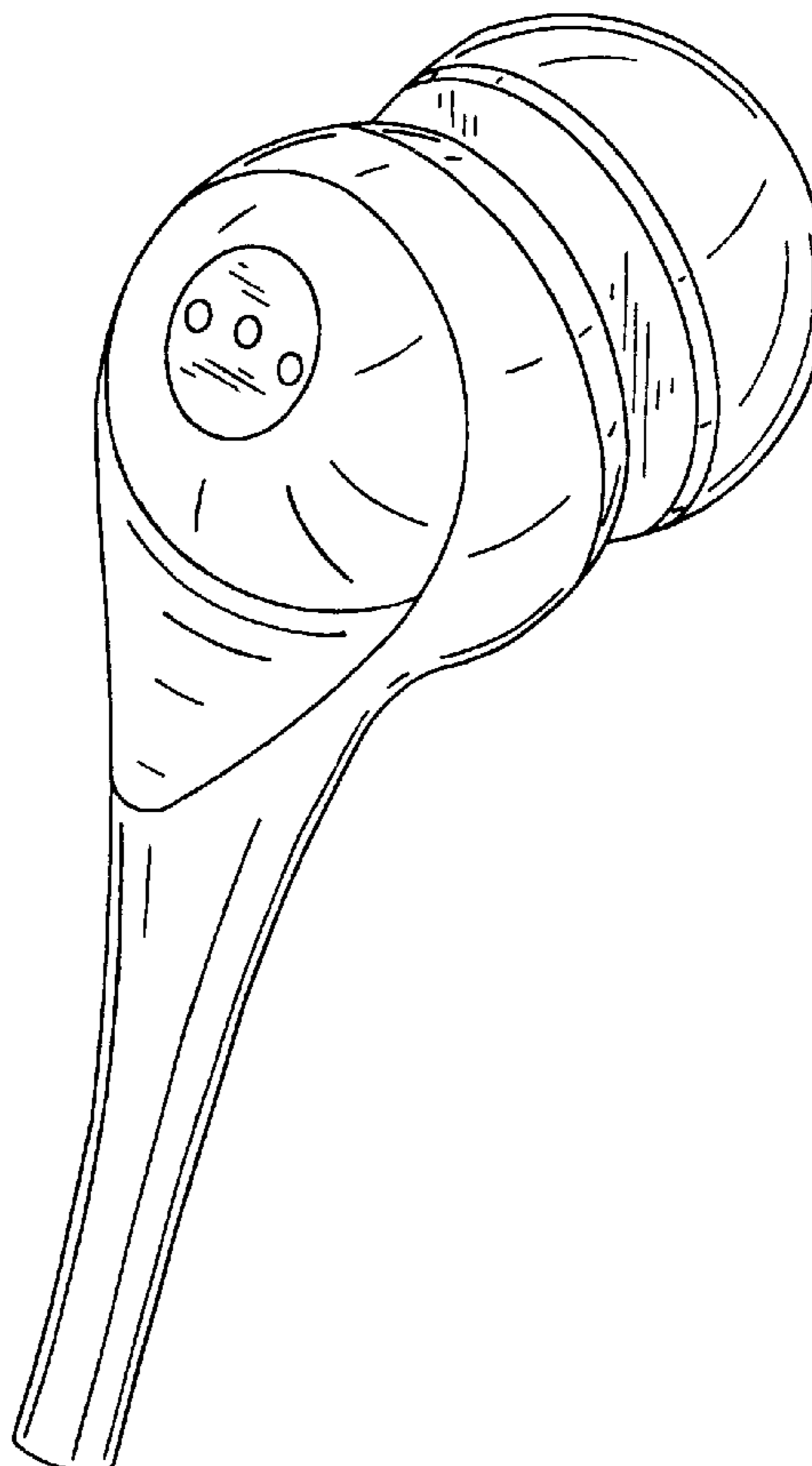
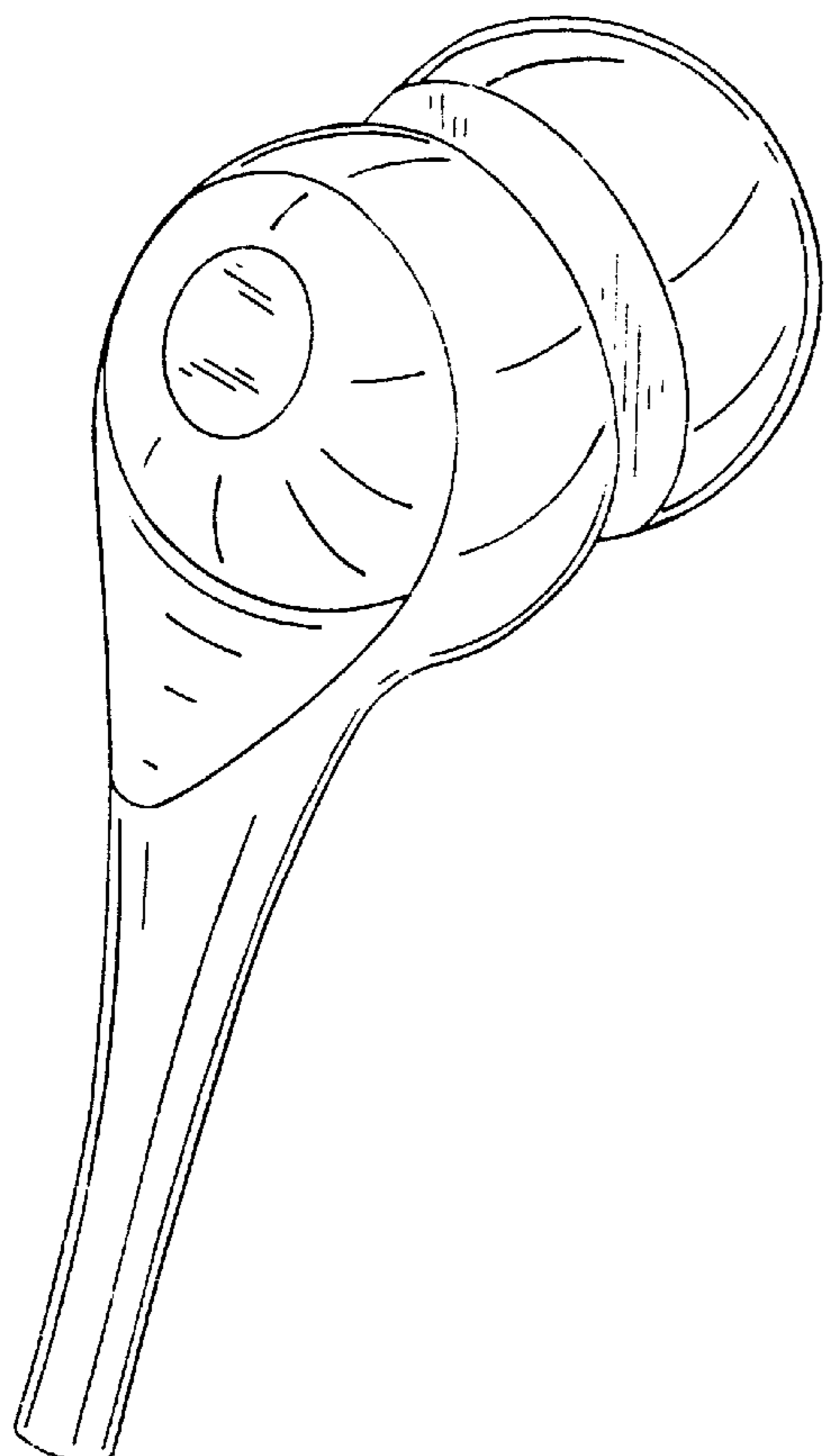

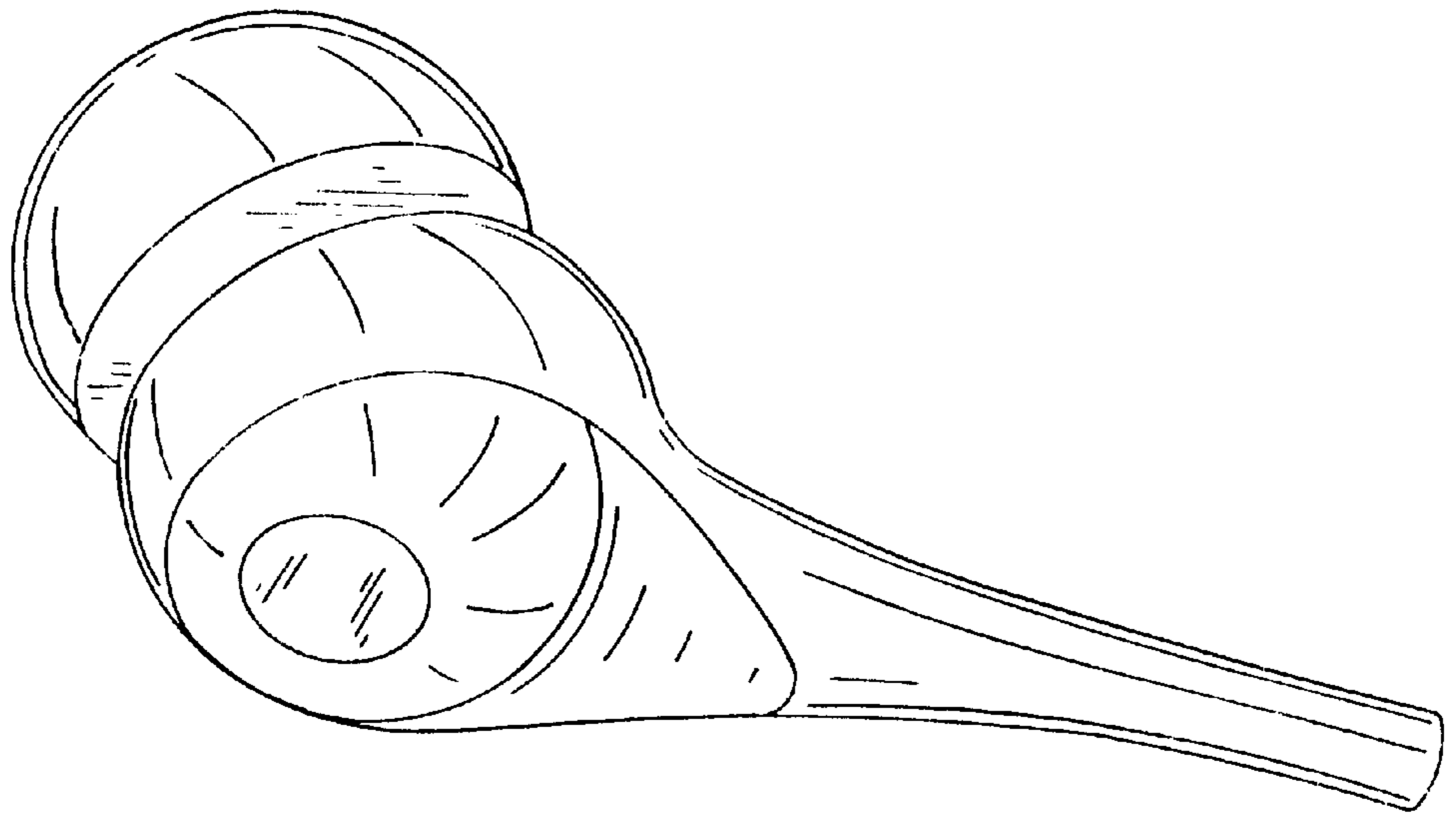

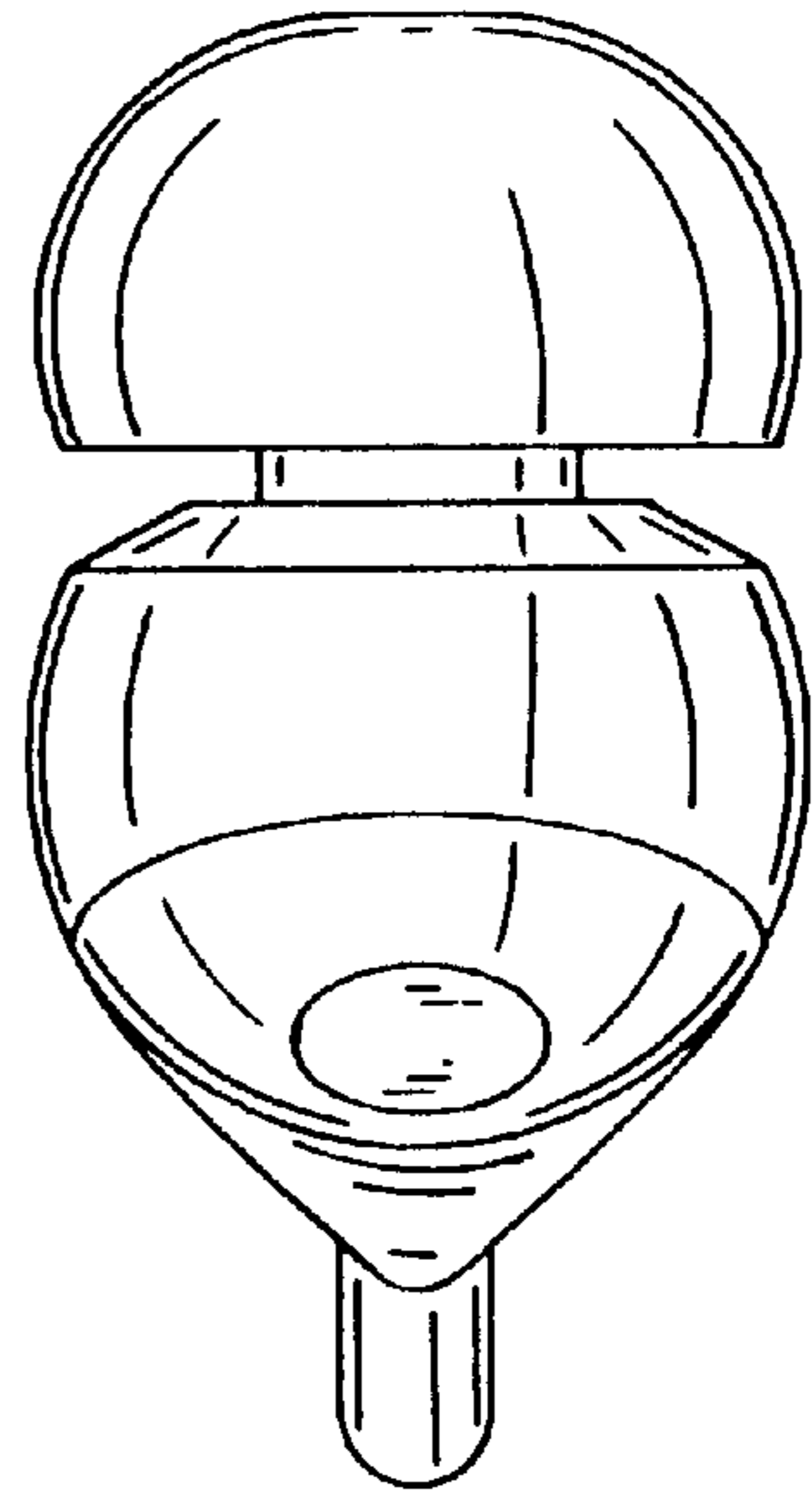

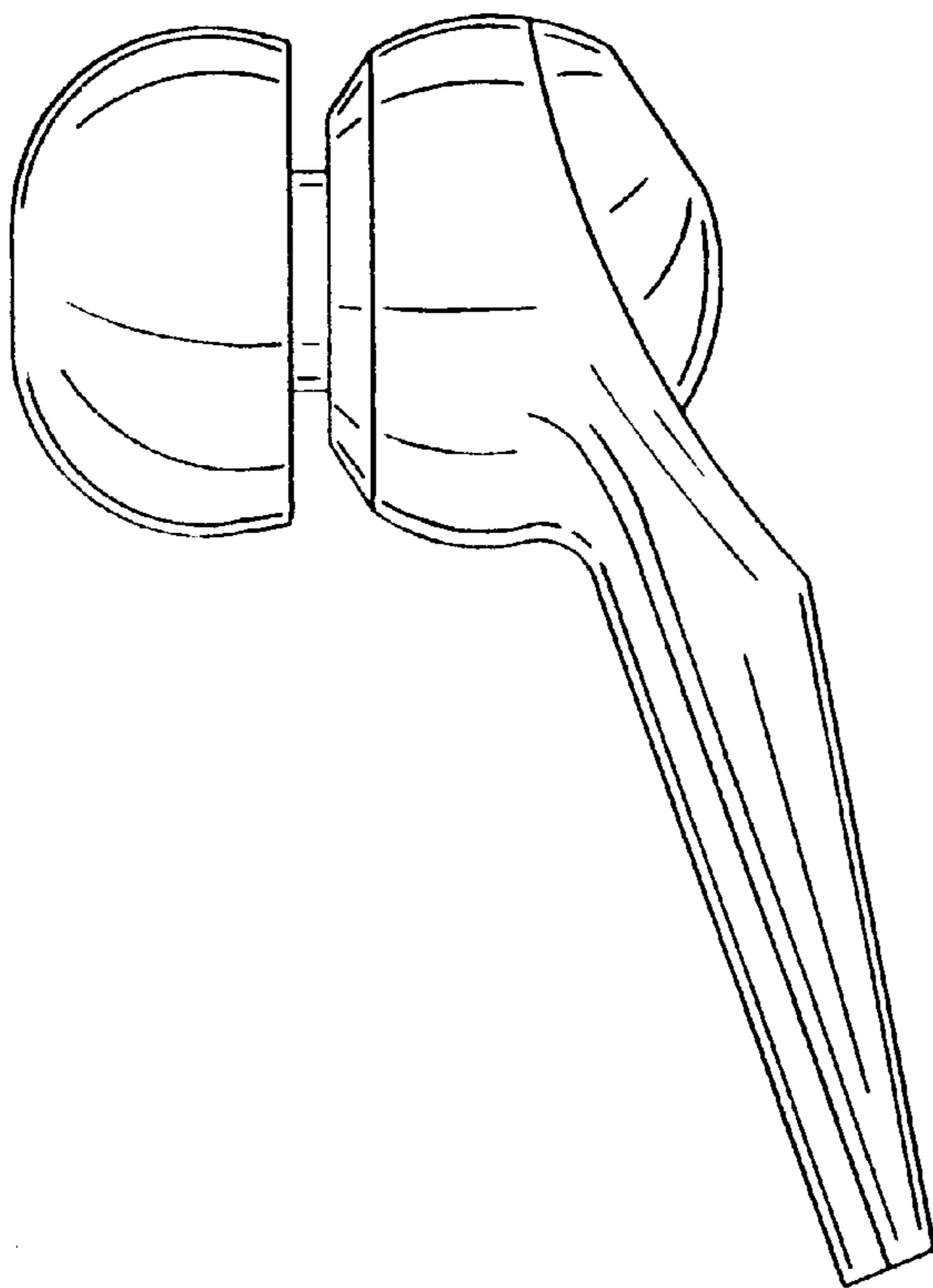

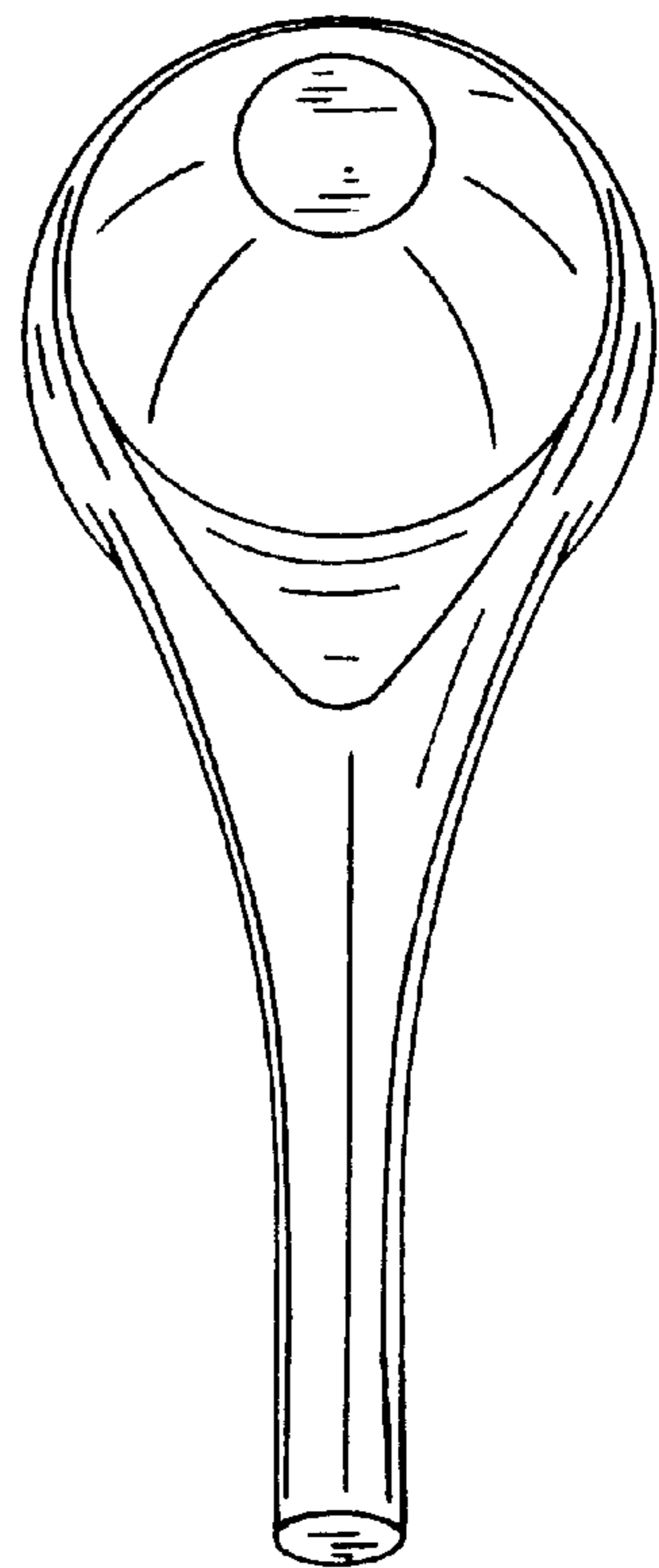

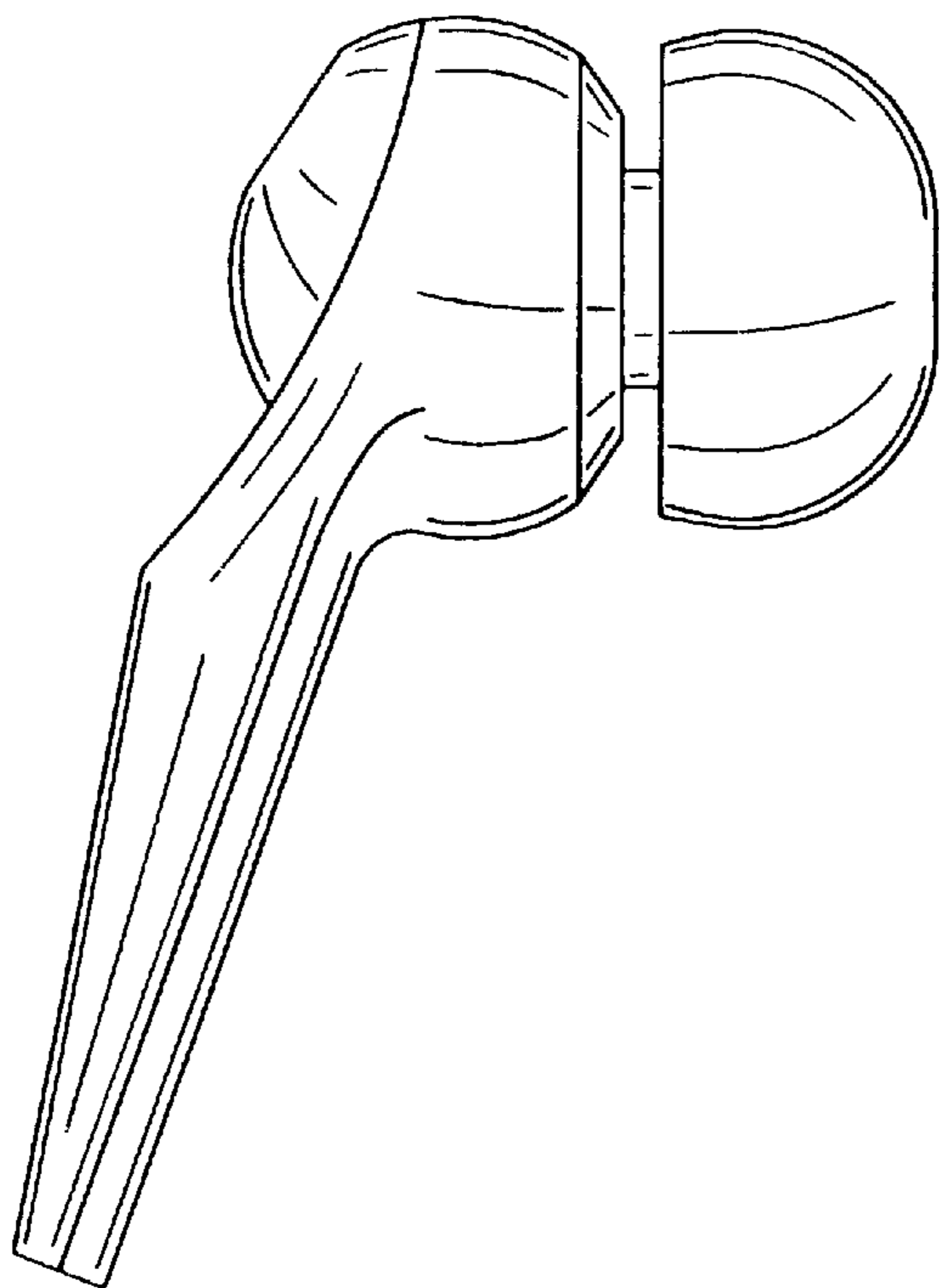

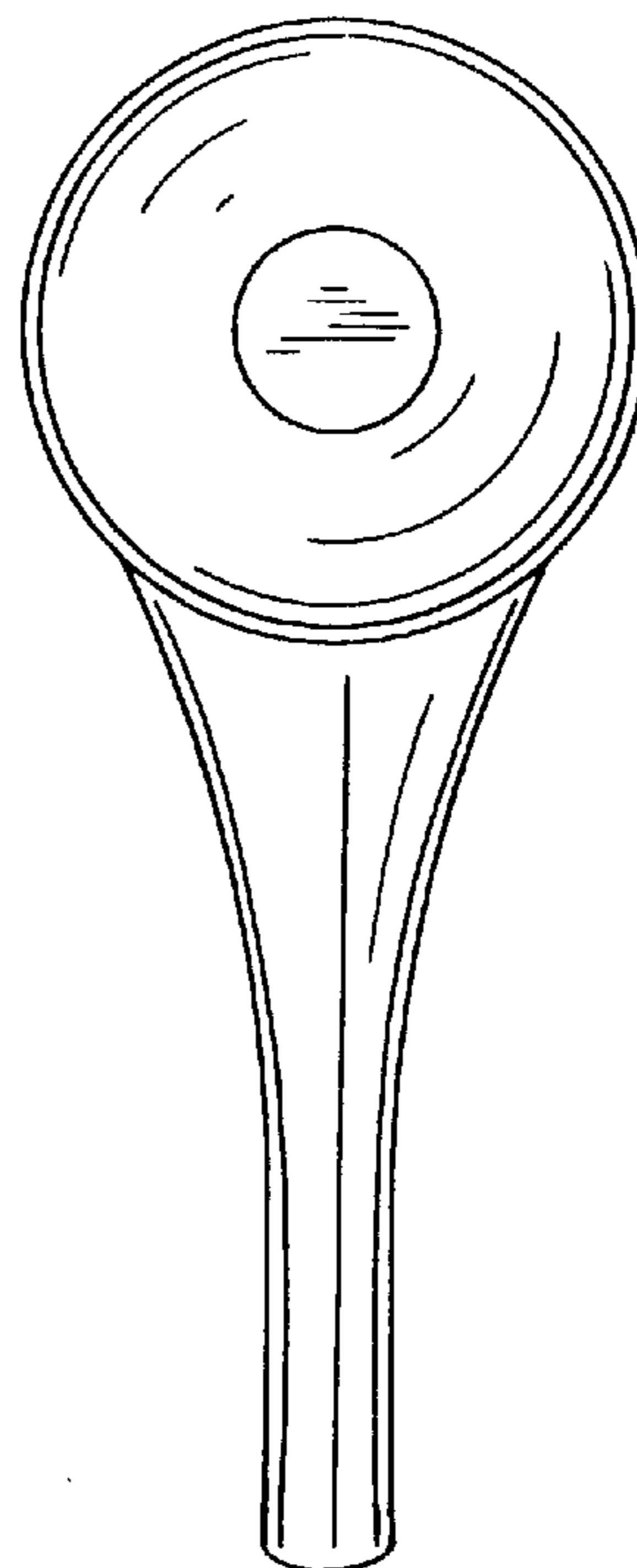

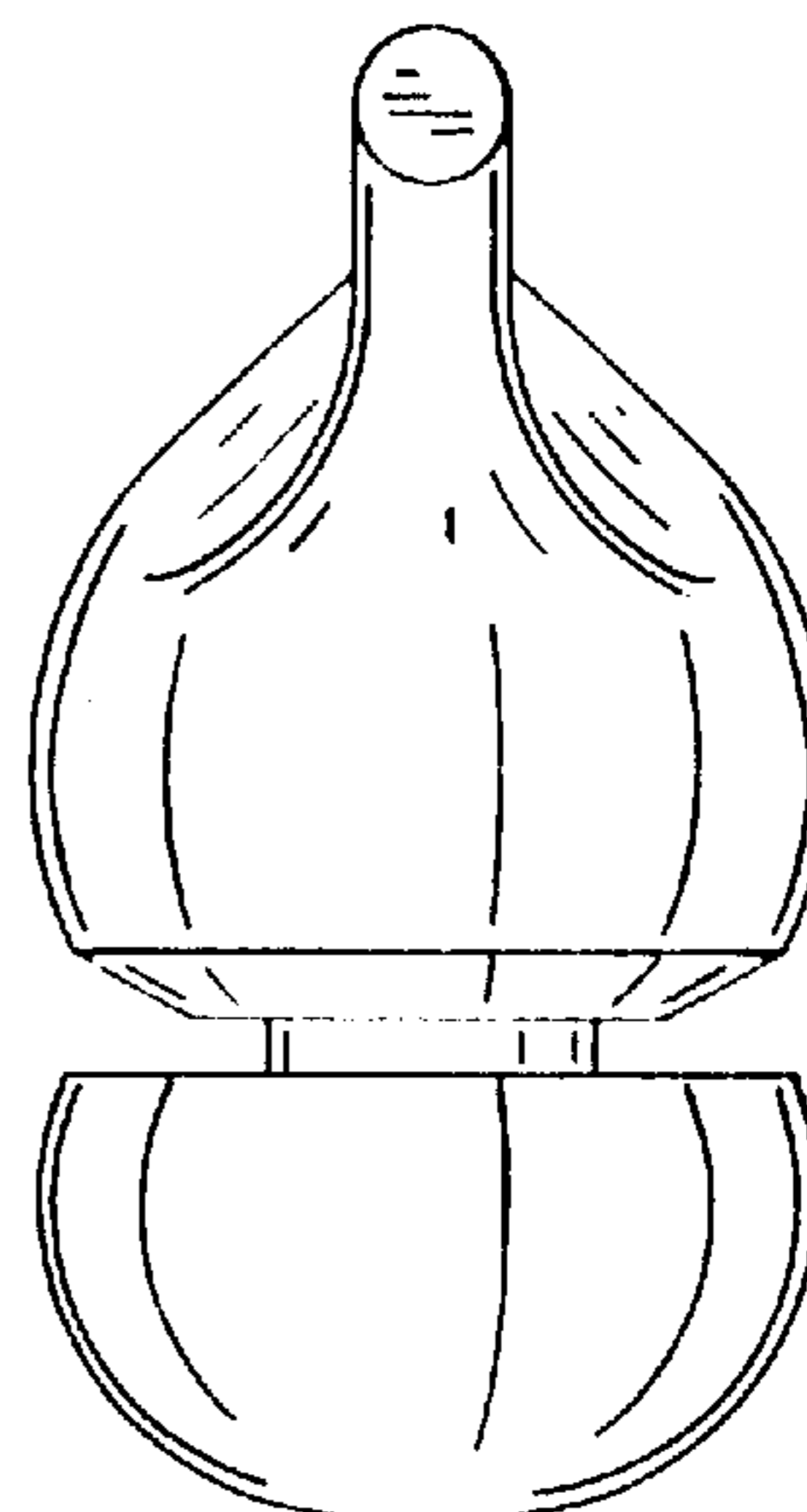

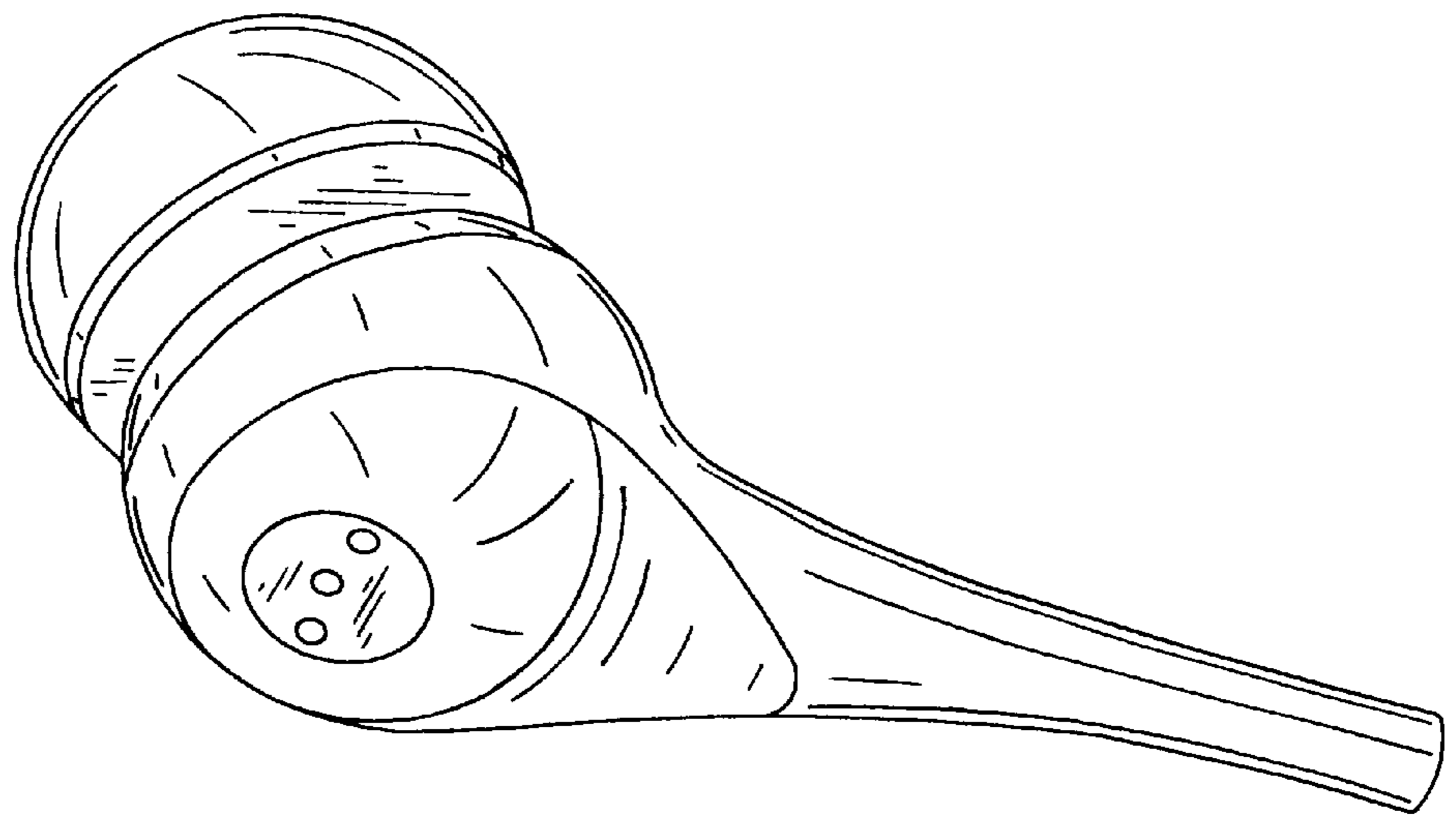

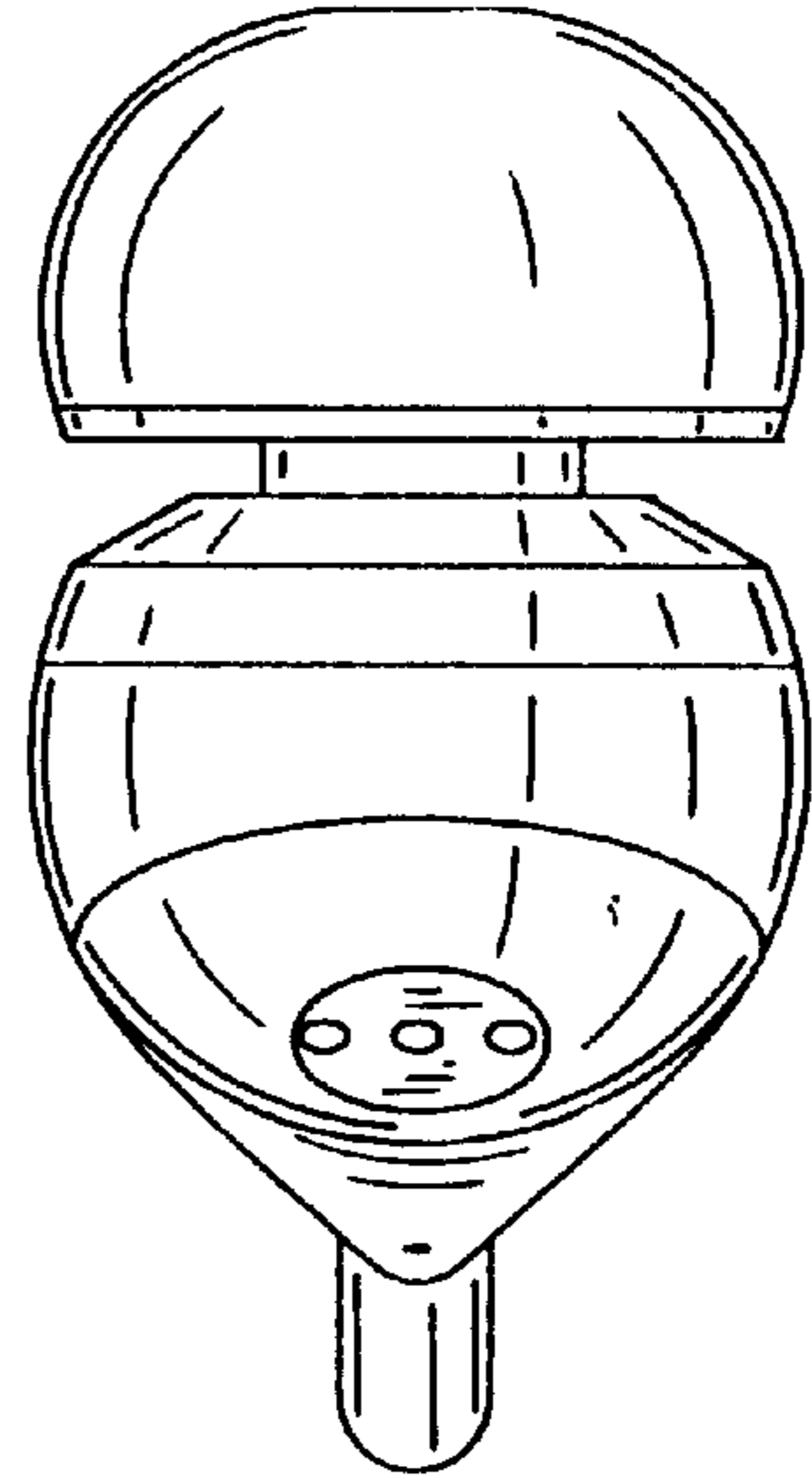

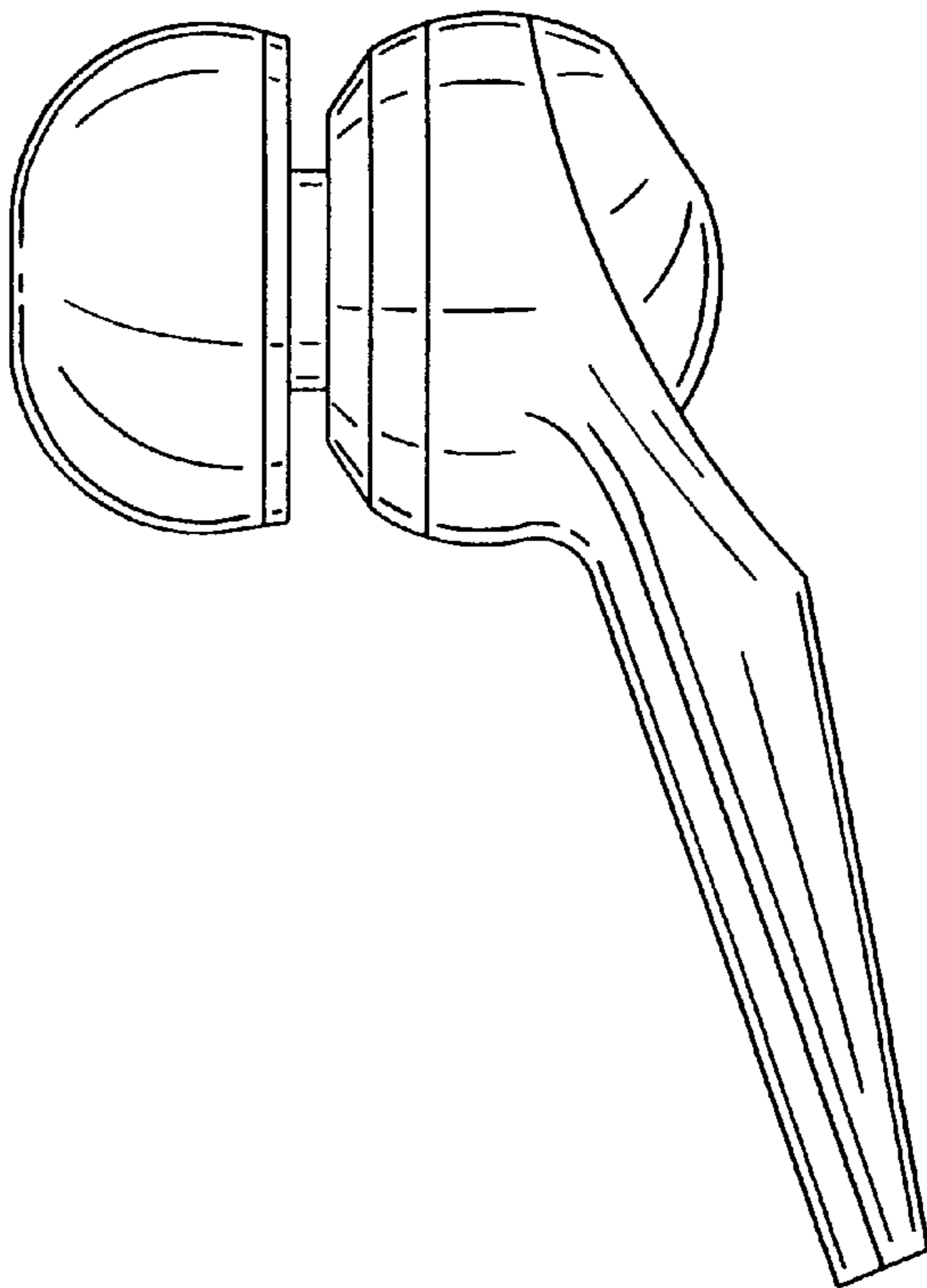

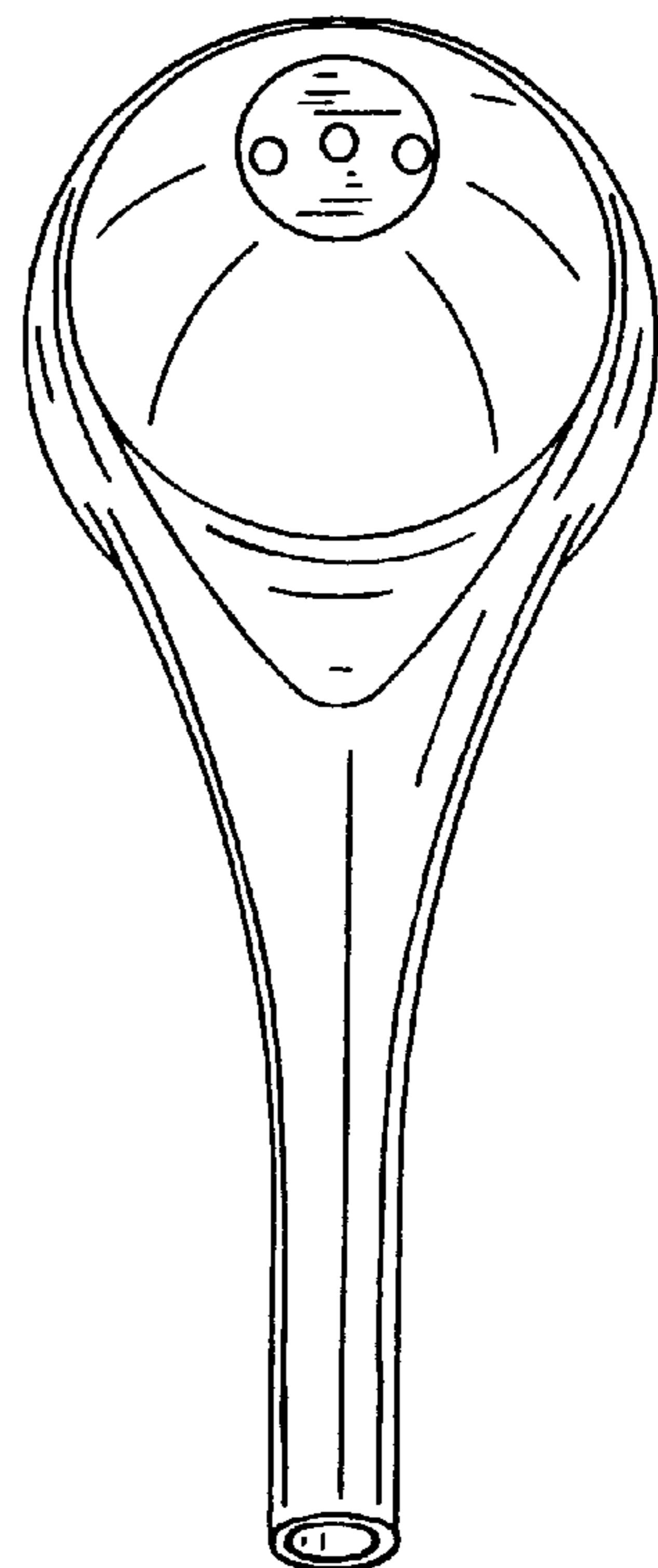

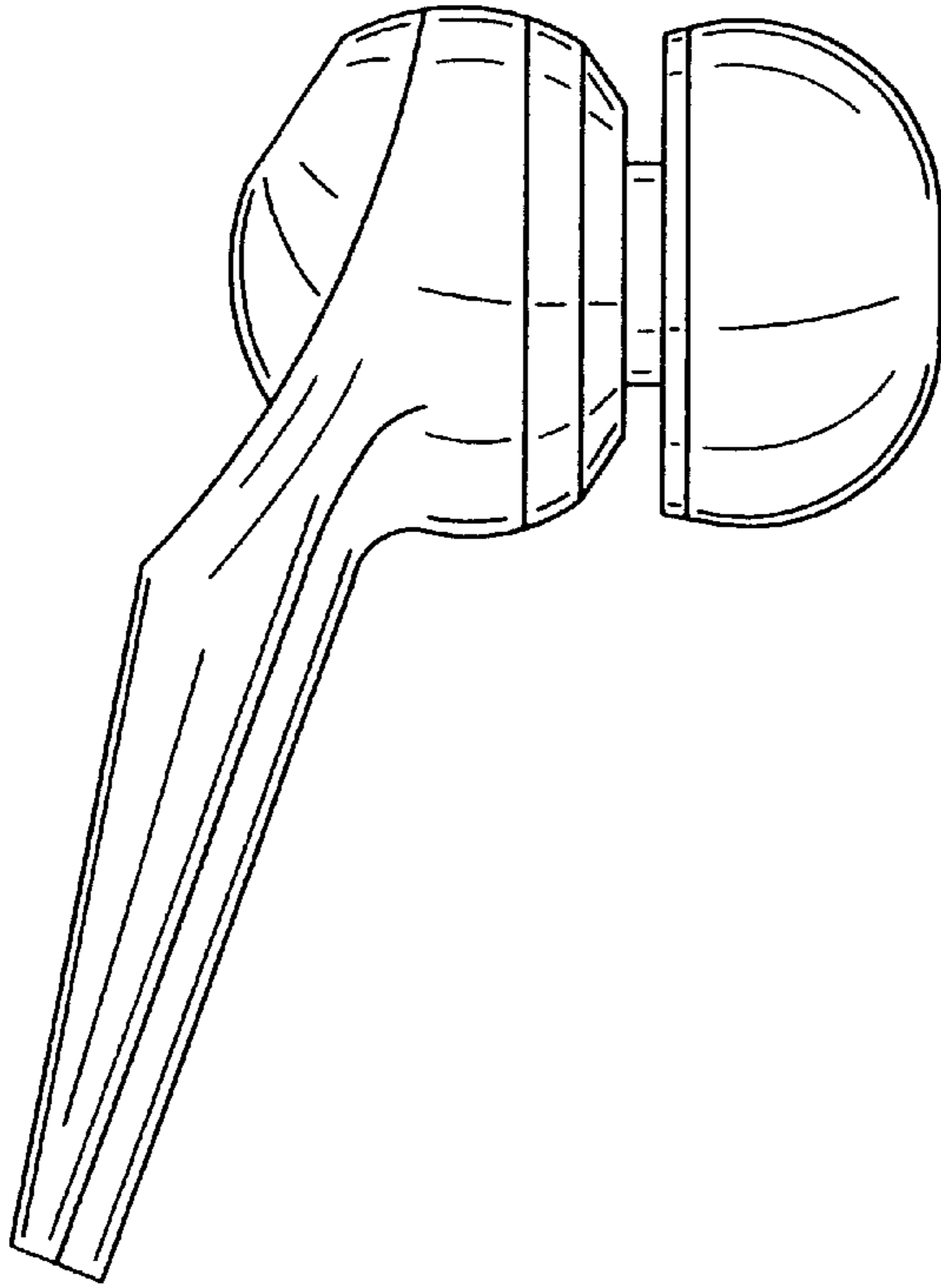

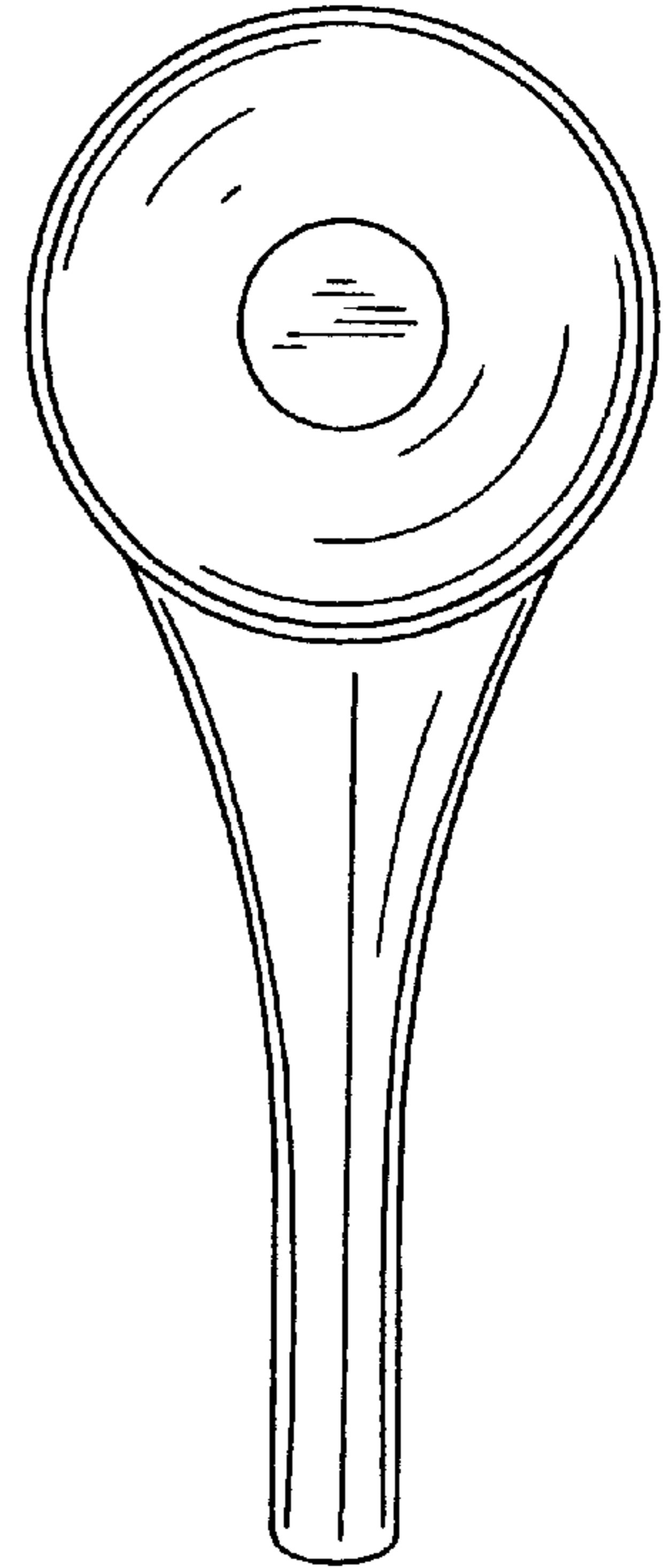
