### **DESCRIPTION**

FIG. 1 is a perspective view;

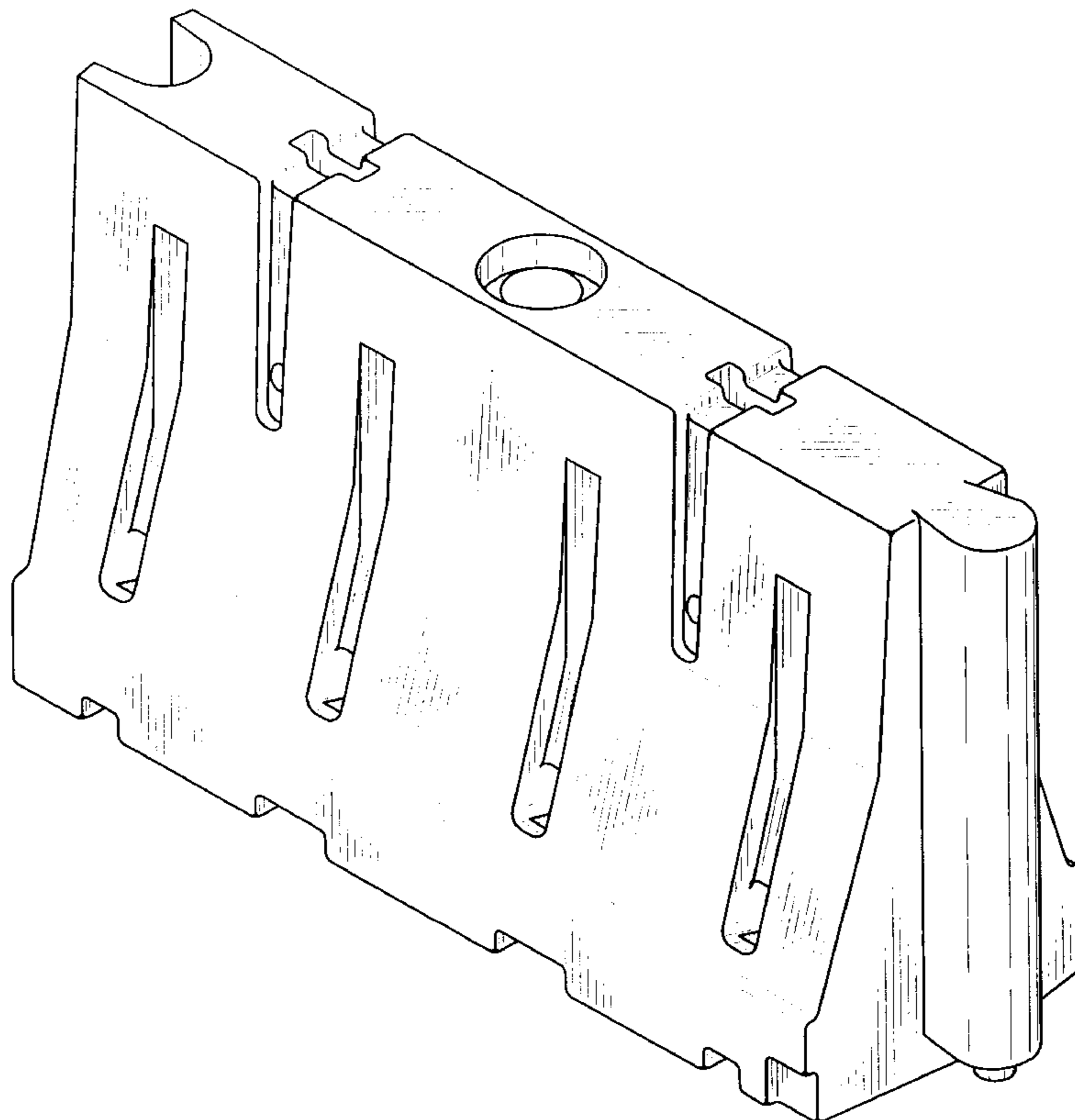

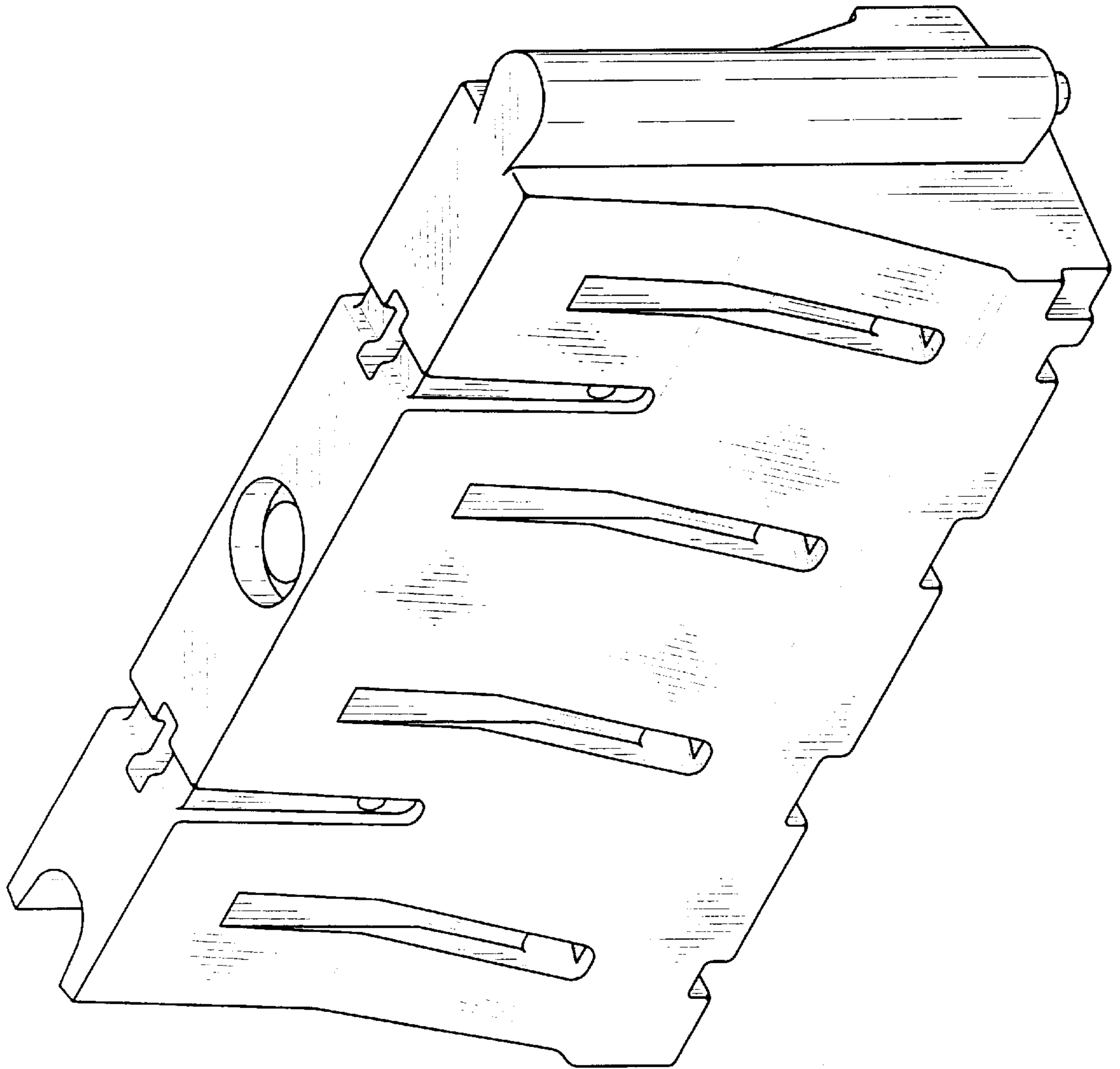

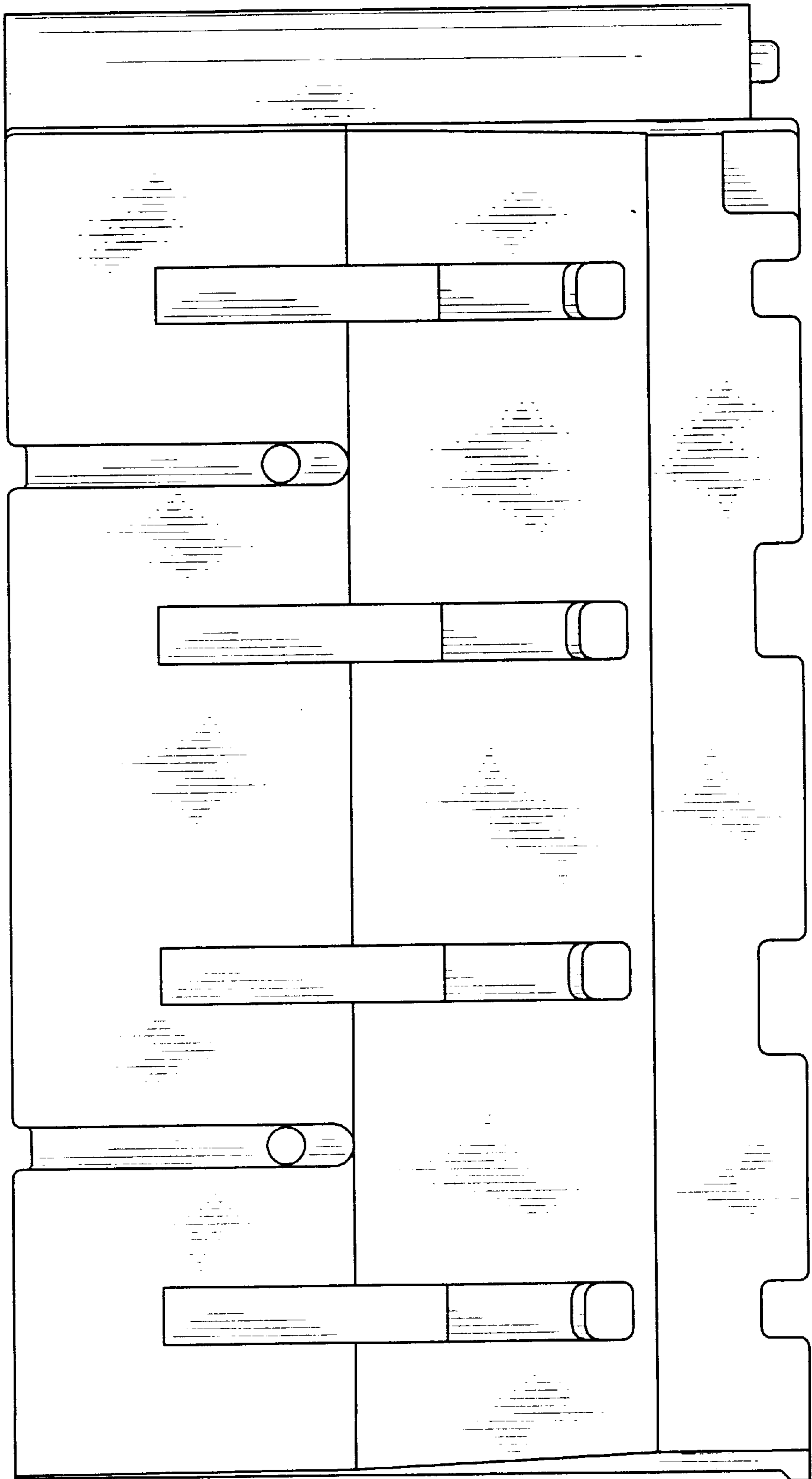

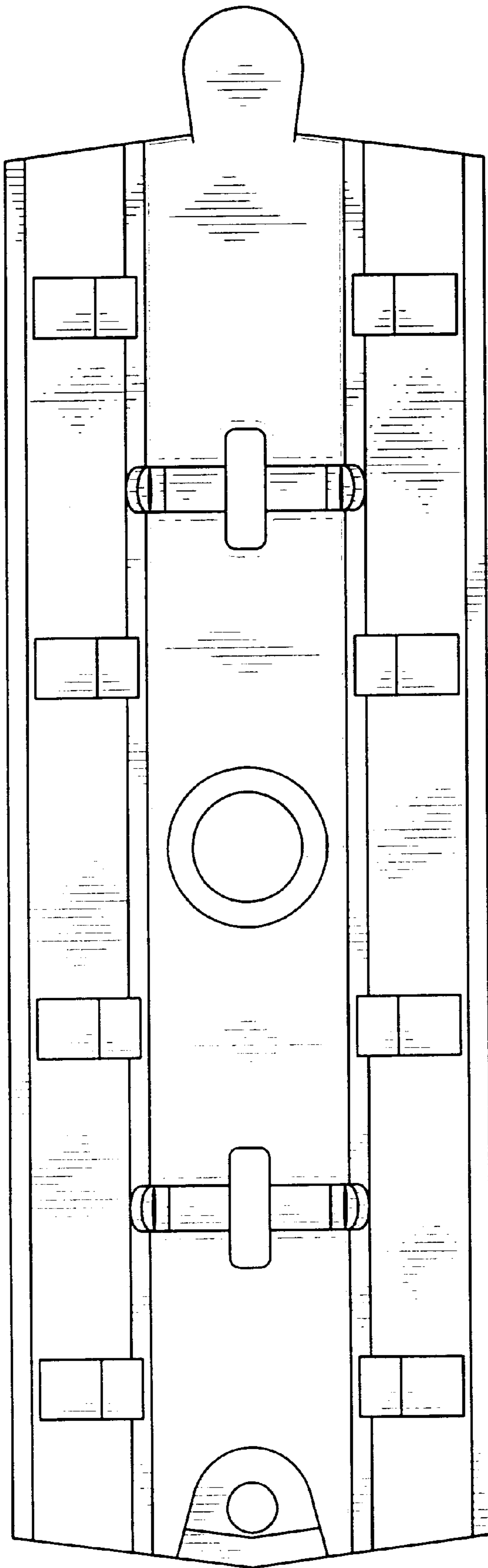

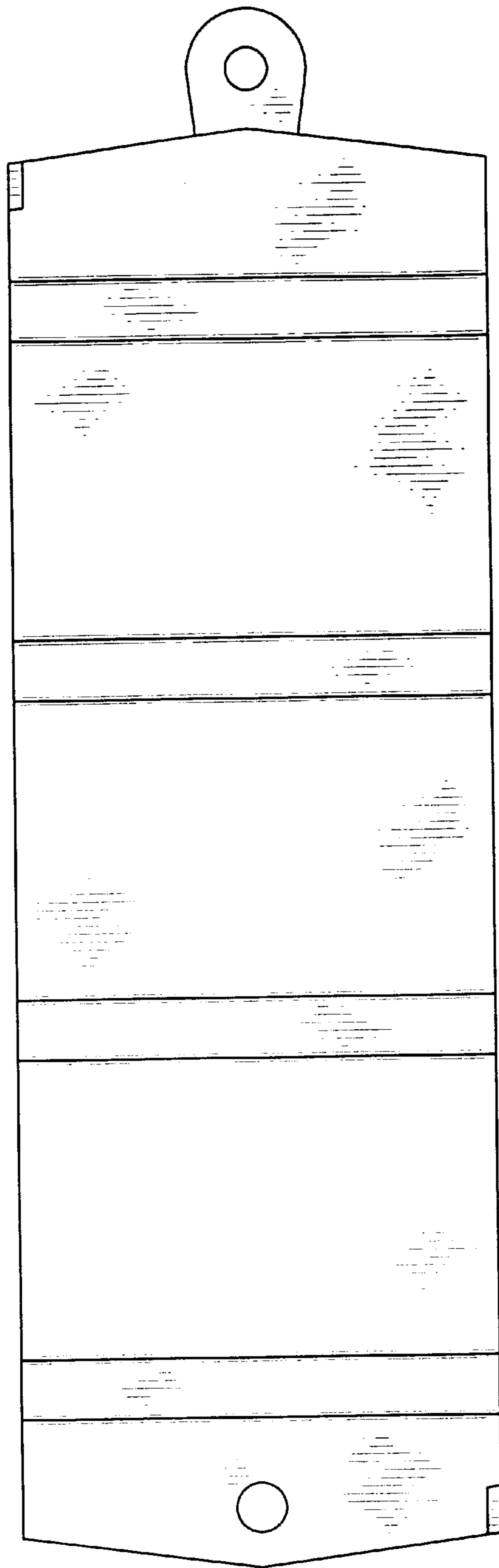

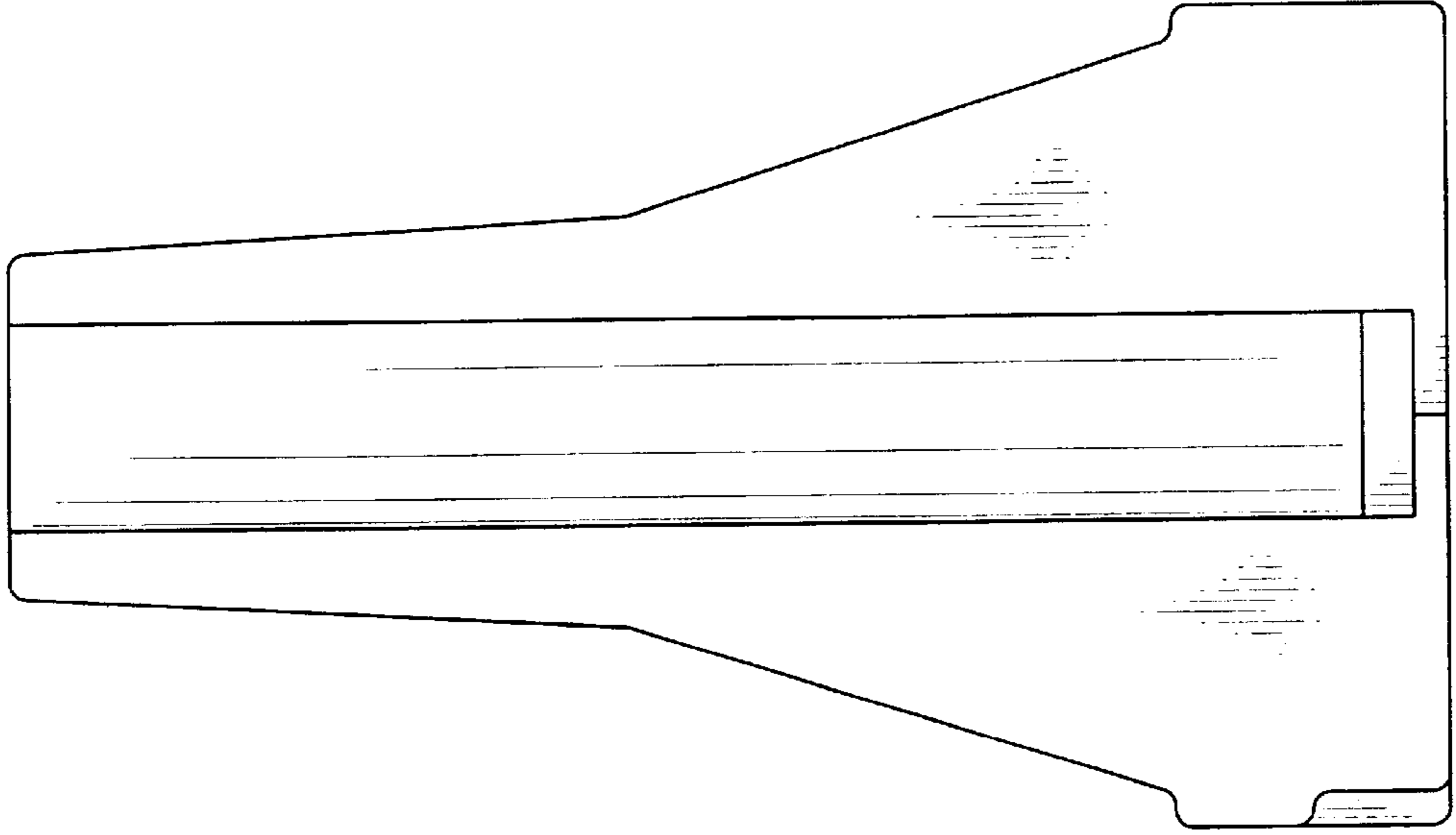
