[57] **CLAIM**

The ornamental design for a make up applicator, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of the applicator of this invention, the other side elevation view being the mirror image of FIG. 1;

FIG. 2 is a top plan view of the applicator of FIG. 1 and the bottom plan view is the mirror image of it;

FIG. 3 is a end elevation view from the pad or front end of the make up applicator of FIG. 1;

FIG. 4 is an end elevation view of from the handle or rear end of the applicator of FIG. 1;

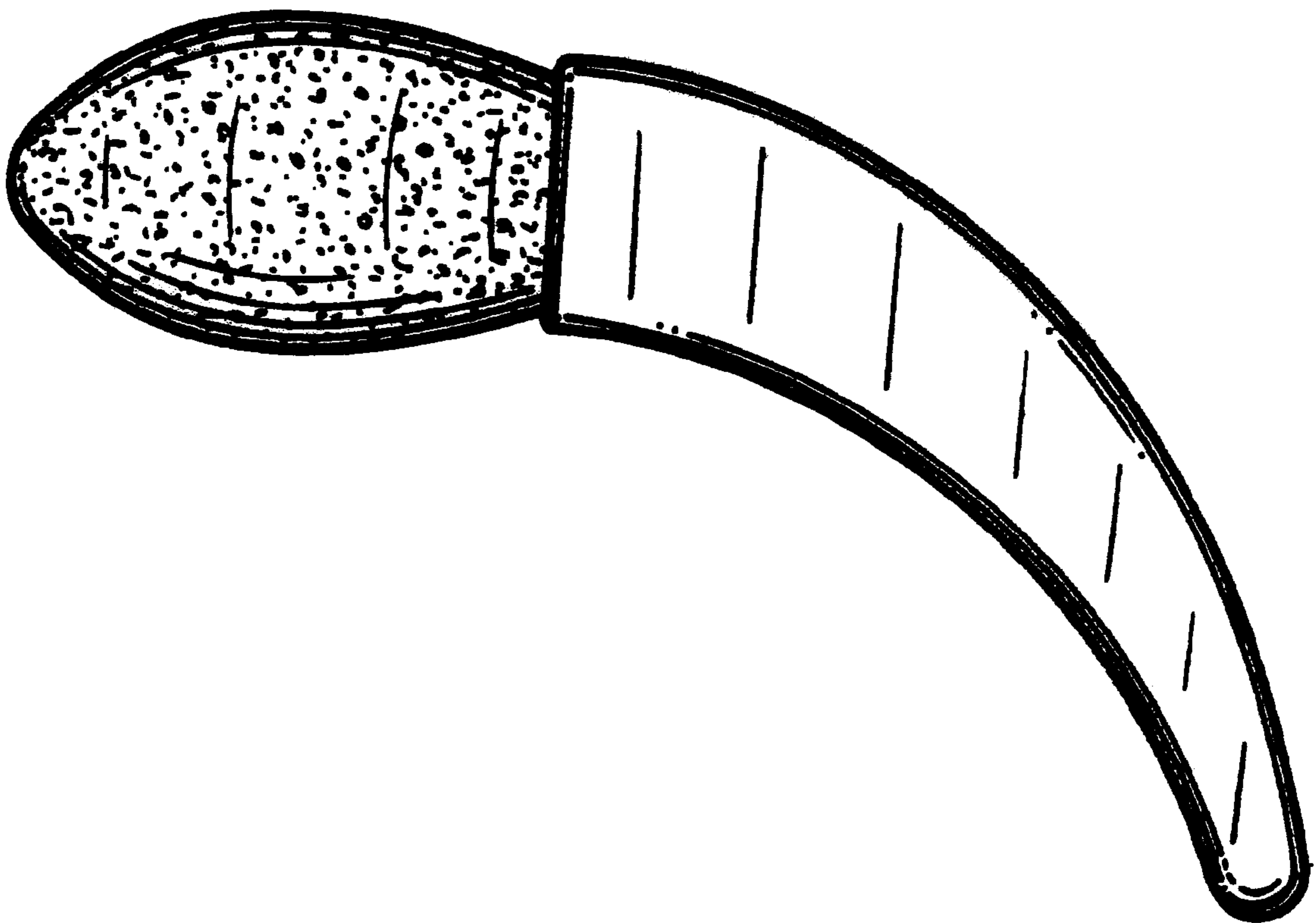
FIG. 5 is a side elevation view of a second embodiment of the applicator of this invention, the other side elevation view being the mirror image of FIG. 5;

FIG. 6 is a top plan view of the second embodiment of the applicator of FIG. 5 and the bottom plan view is the mirror image of it;

FIG. 7 is an end elevation view of the second embodiment from the pad end of the make up applicator of FIG. 5; and,

FIG. 8 is an end elevation view of the second embodiment from the handle end of the applicator of FIG. 5.

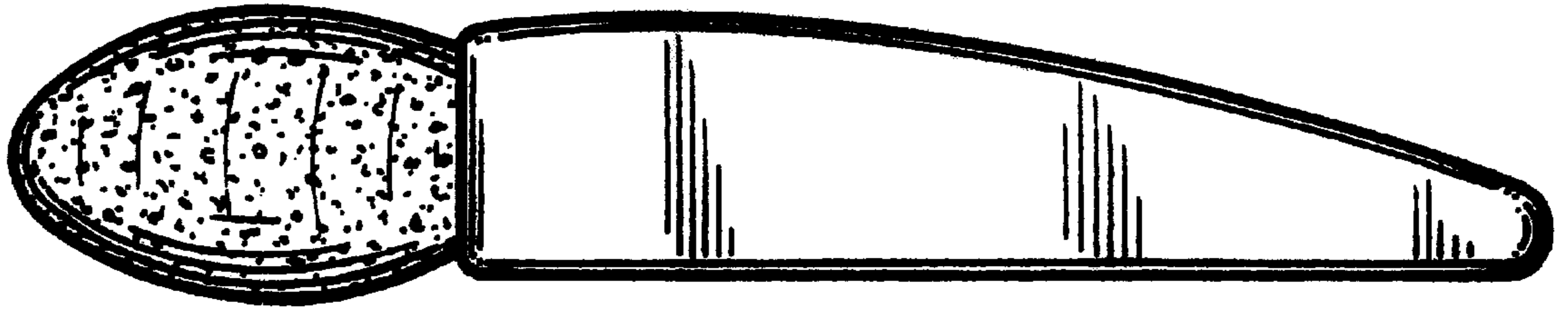

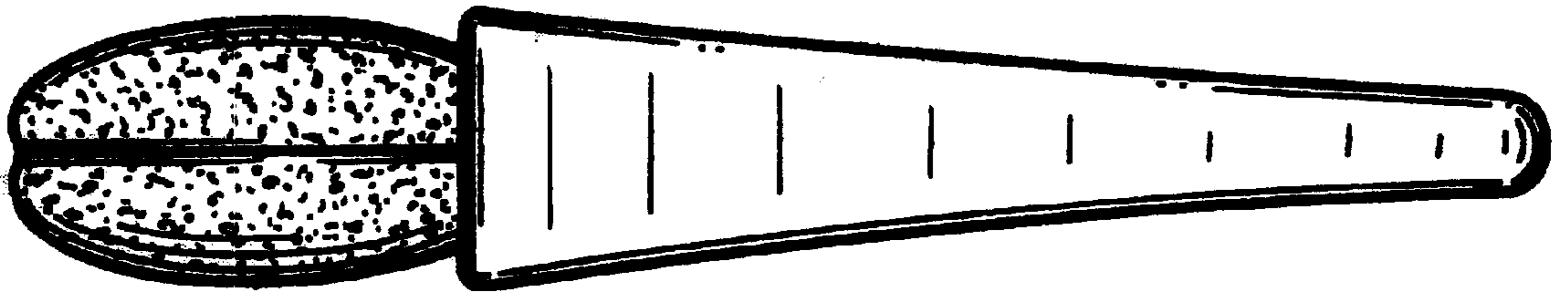

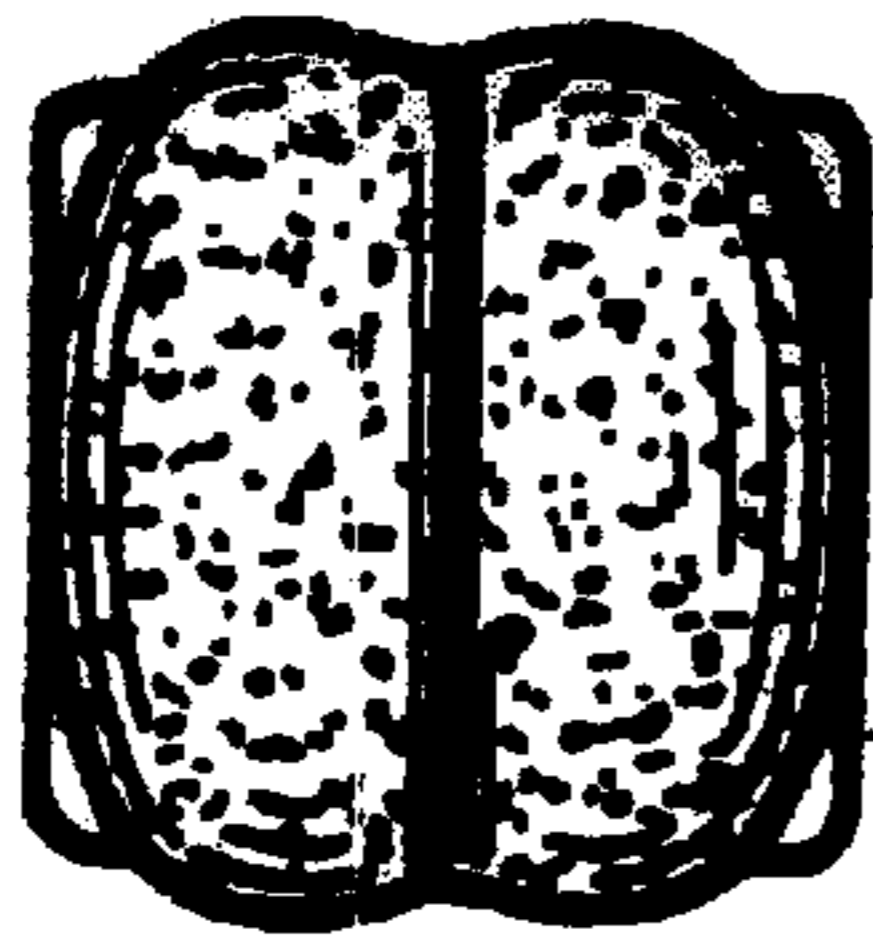

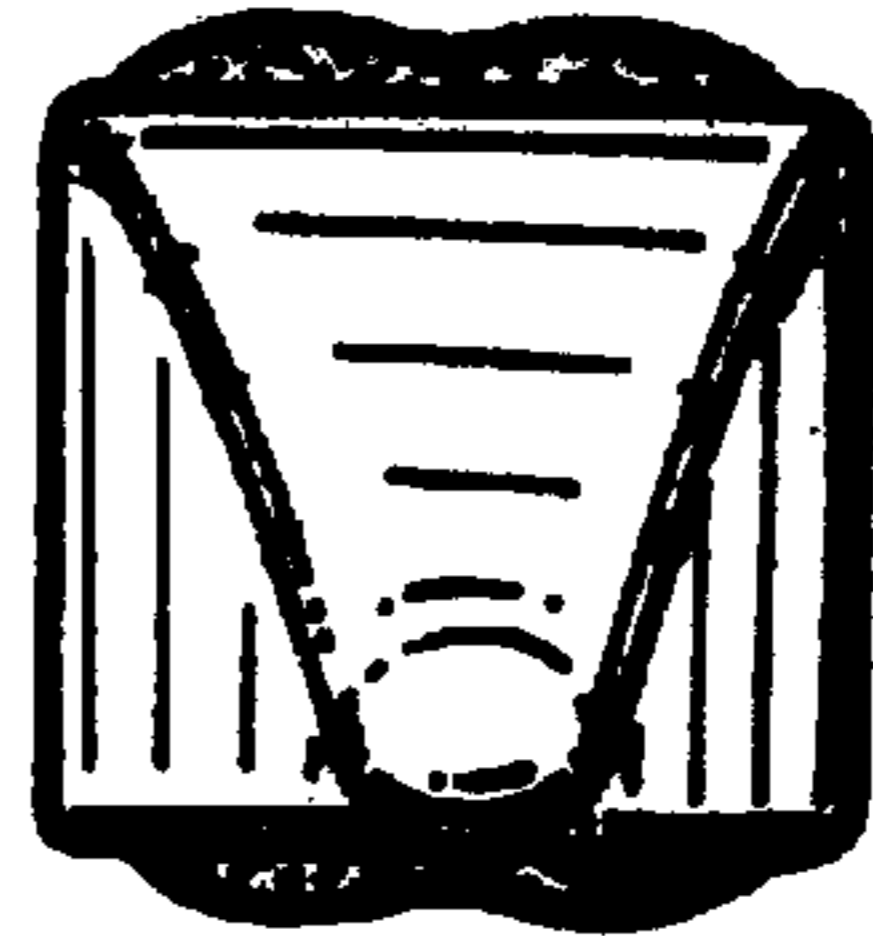

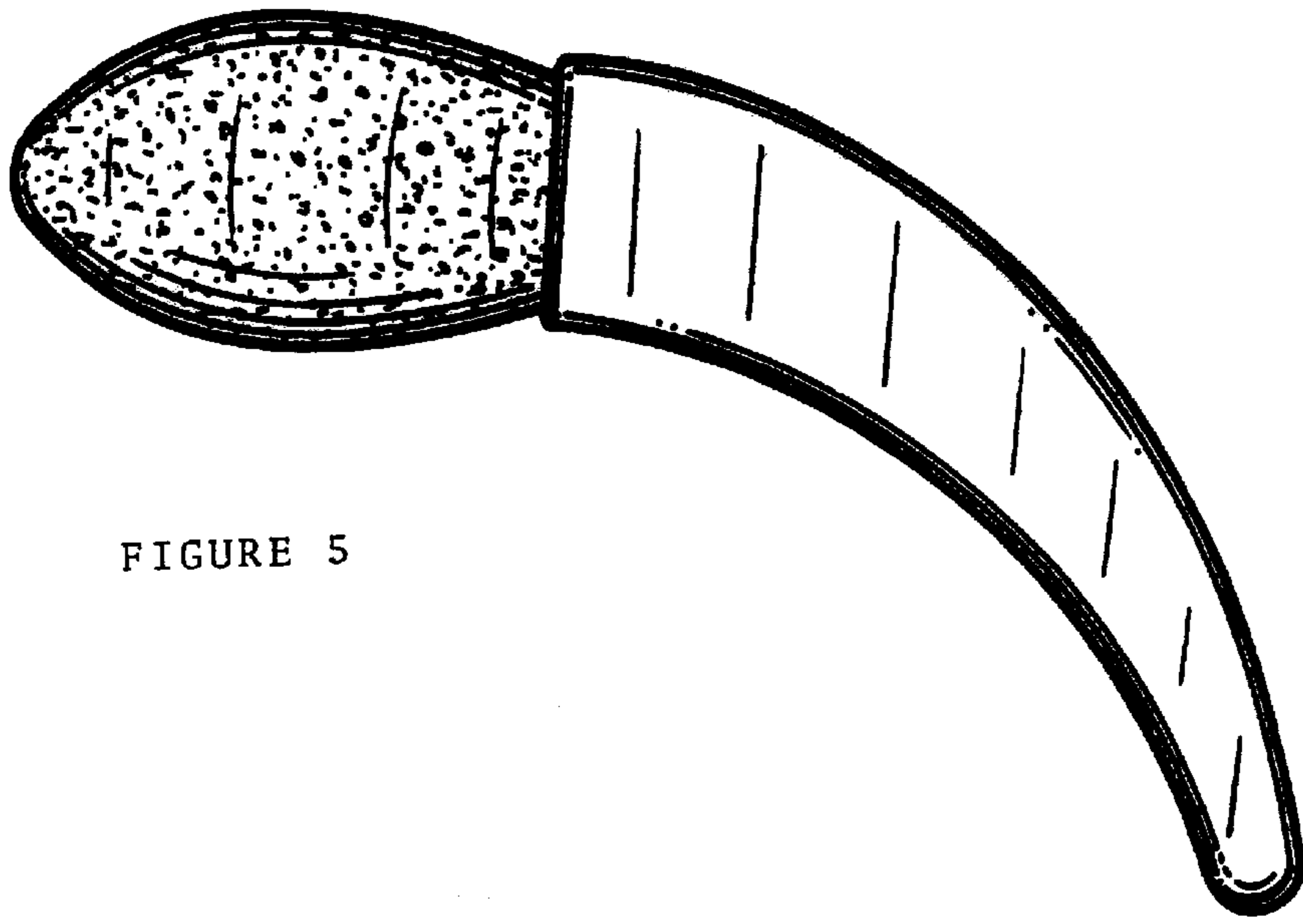

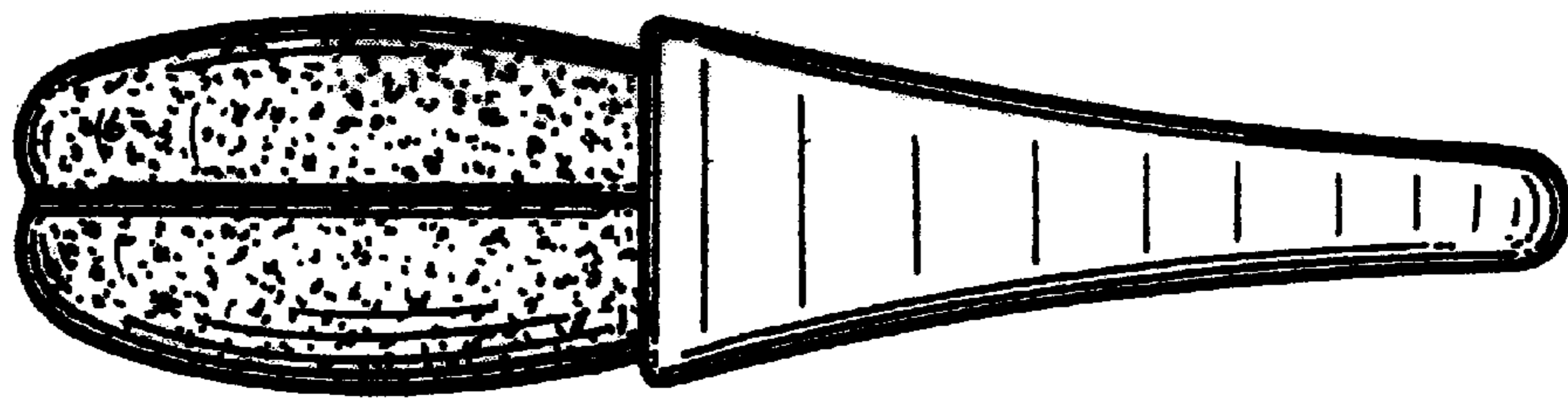

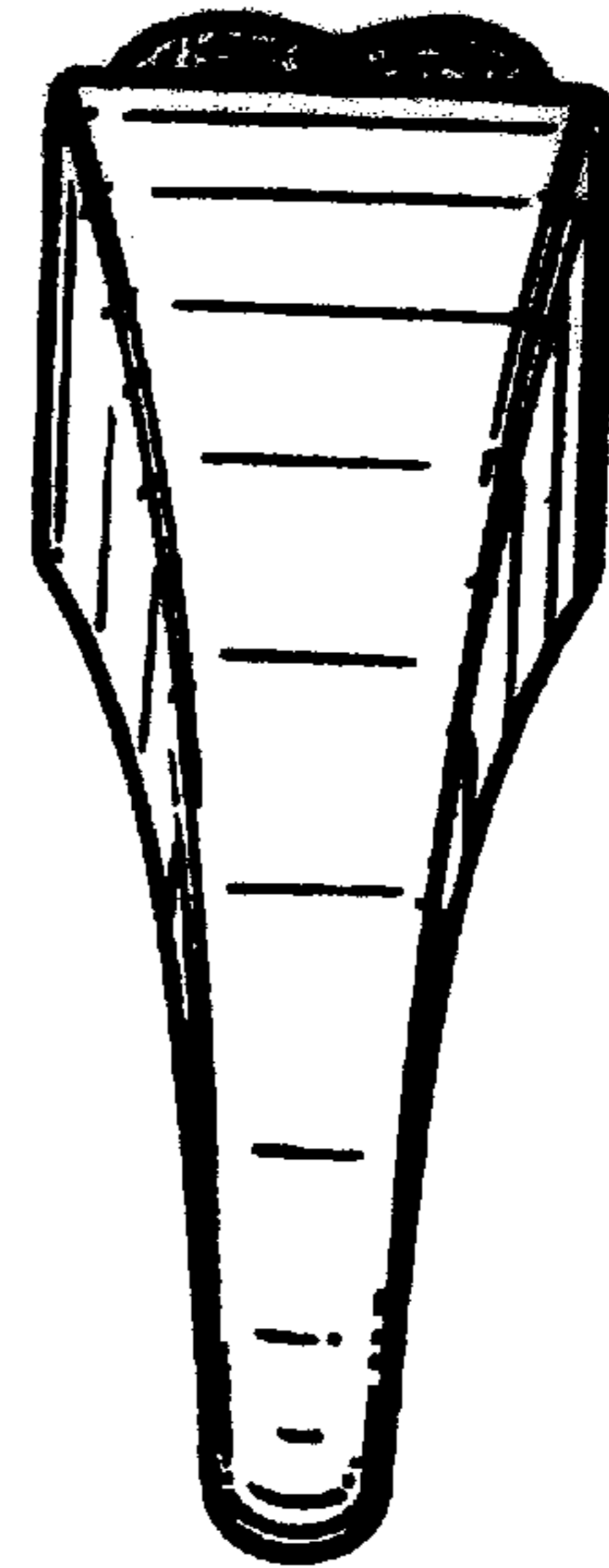
