**DESCRIPTION**

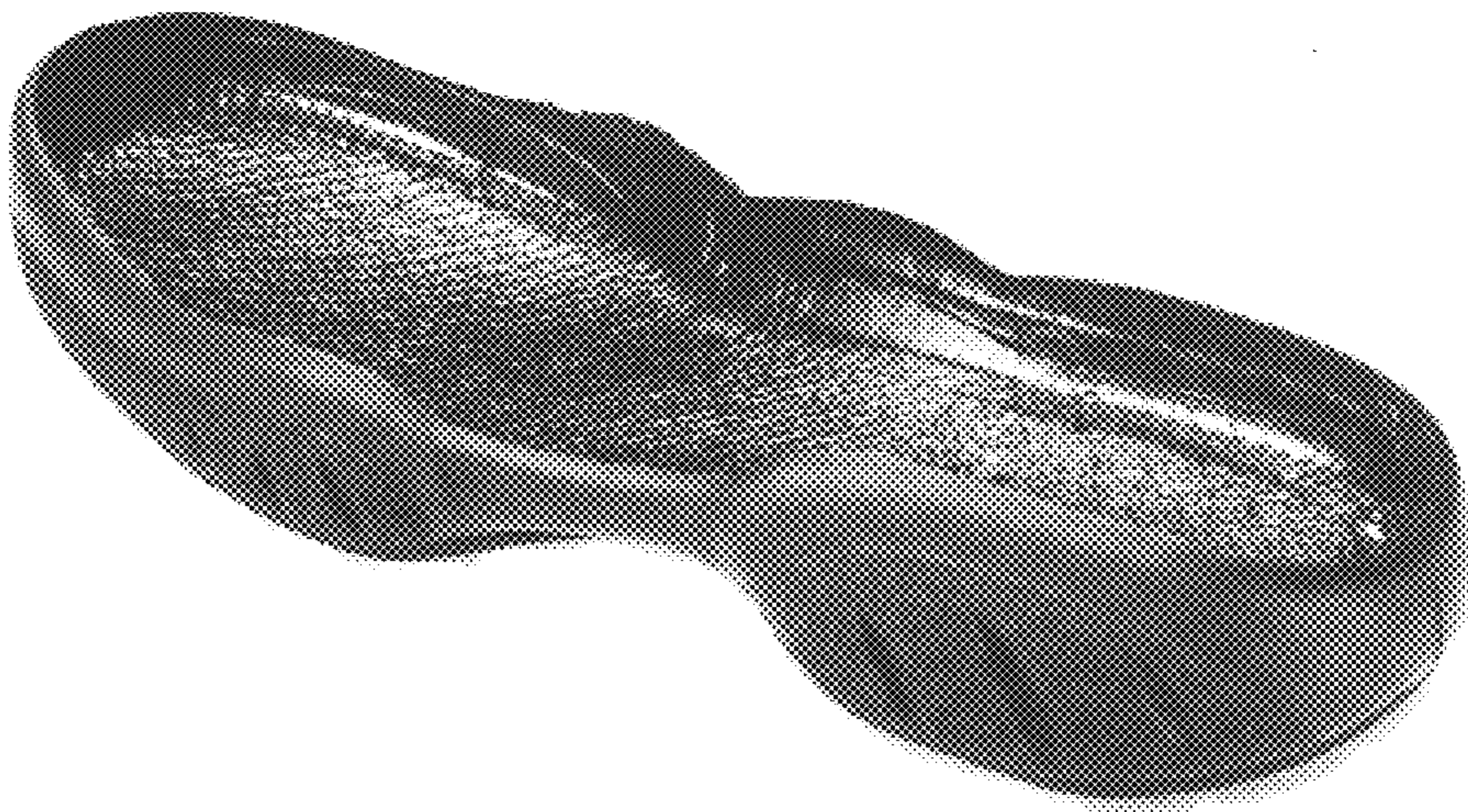
FIG. 1 is a top right perspective view of a shoe sole showing my new design;
