[57] **CLAIM**

The ornamental design for a watch and jewelry case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first and second embodiments of a watch and jewelry case;

FIG. 2 is a perspective view of the first embodiment thereof shown in an open position with an elliptically shaped insert; FIG. 3 is an exploded view of FIG. 2;

FIG. 4 is a perspective view of the second embodiment thereof shown in an open position with a round shaped insert;

FIG. 5 is an exploded view of FIG. 4;

FIG. 6 is a front elevation view of the first and second embodiments thereof;

FIG. 7 is a side elevation view of the first and second embodiments thereof;

FIG. 8 is a top plan view of the first and second embodiments thereof;

FIG. 9 is a bottom plan view of the first and second embodiments thereof;

FIG. 10 is a rear elevation view of the first and second embodiments thereof;

FIG. 11 is a top plan view of the elliptically shaped insert of the first embodiment thereof shown separately for clarity of illustration;

FIG. 12 is a bottom plan view of FIG. 11;

FIG. 13 is a rear elevation view of FIG. 11;

FIG. 14 is a front elevation view of FIG. 11;

FIG. 15 is a side elevation view of FIG. 11, the opposite side being a mirror image thereof;

FIG. 16 is a top plan view of the round shaped insert of the second embodiment thereof shown separately for clarity of illustration;

FIG. 17 is a bottom plan view of FIG. 16;

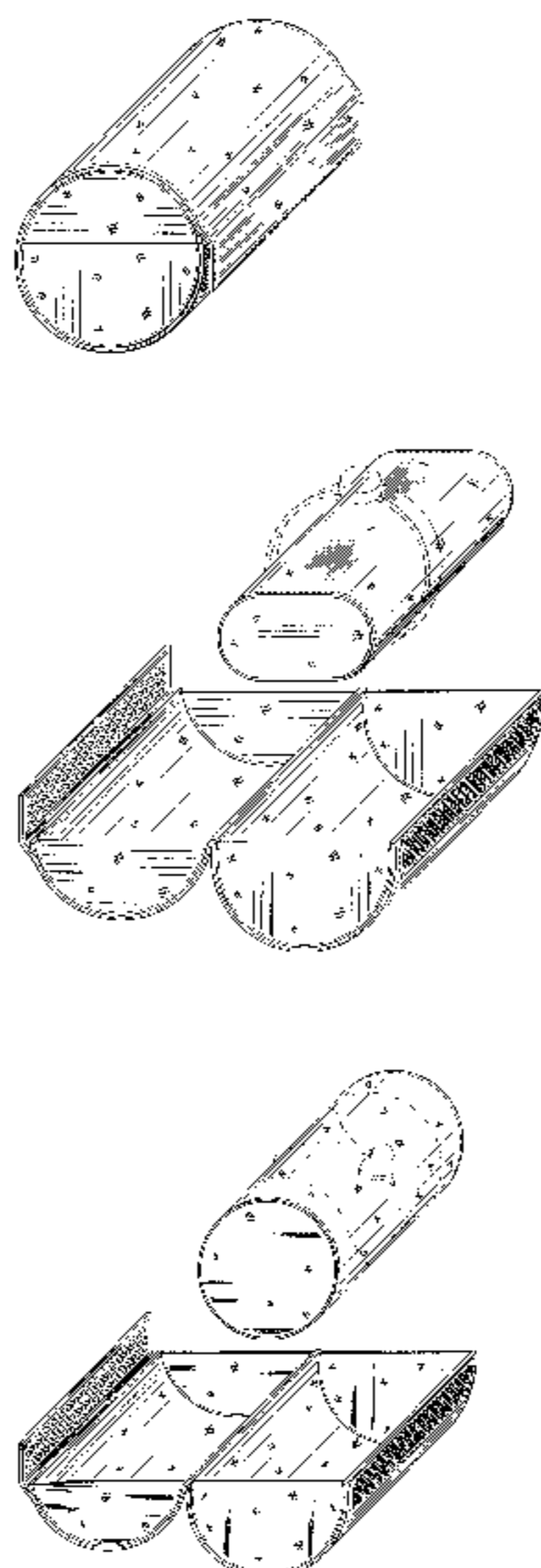
FIG. 18 is a front elevation view of FIG. 16, the rear view being a mirror image thereof; and,

FIG. 19 is a side elevation view of FIG. 16, the opposite side being a mirror image thereof.

The broken line showing of a watch and necklace in FIGS. 2-5 is for illustrative purposes only and forms no part of the claimed design. The broken lines on the watch and jewelry case are understood to represent stitching.

The fragmentary criss-cross pattern shown on the surface of the watch and jewelry case is understood to represent fabric and is repeated uniformly throughout the areas shown.

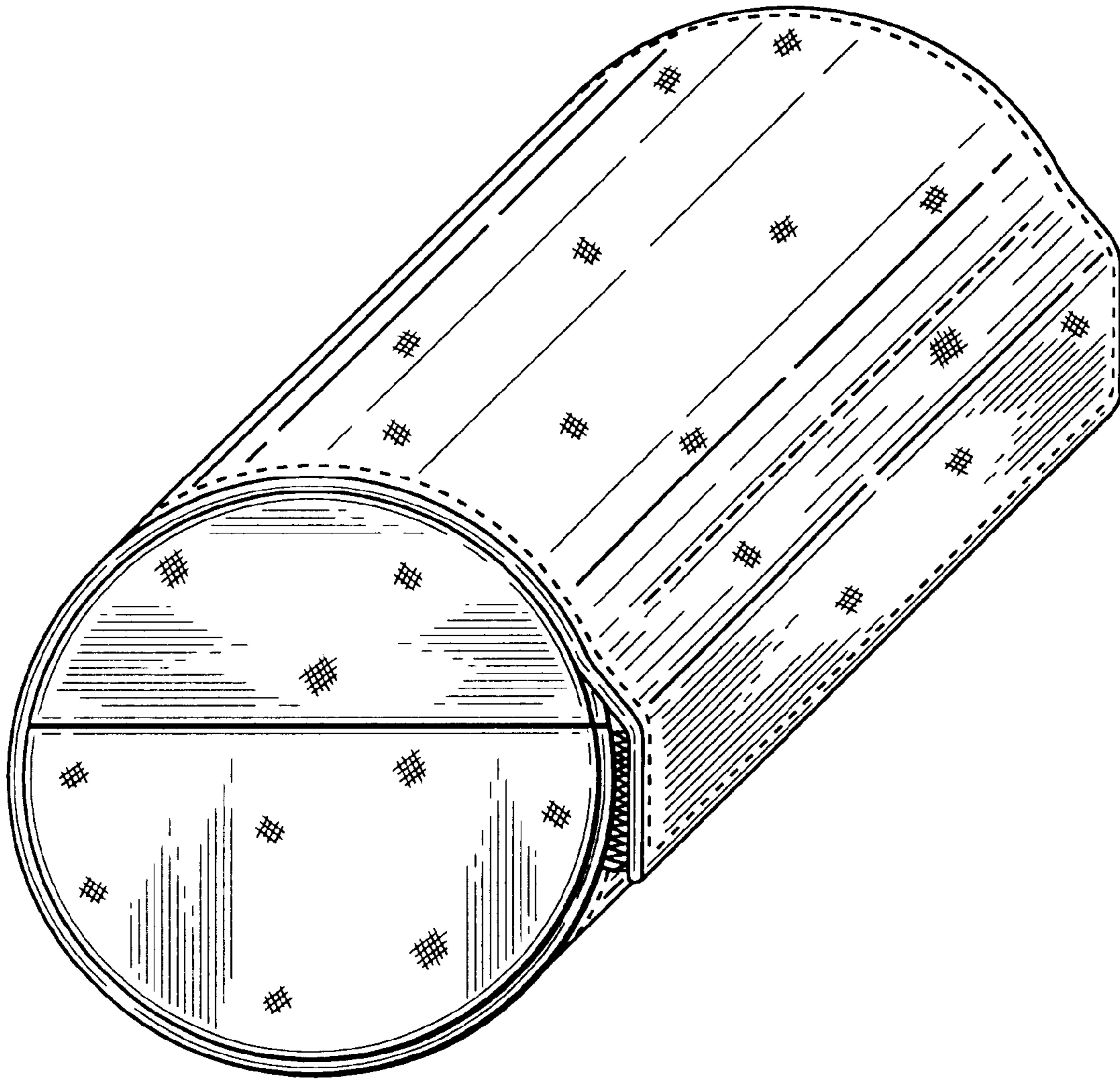

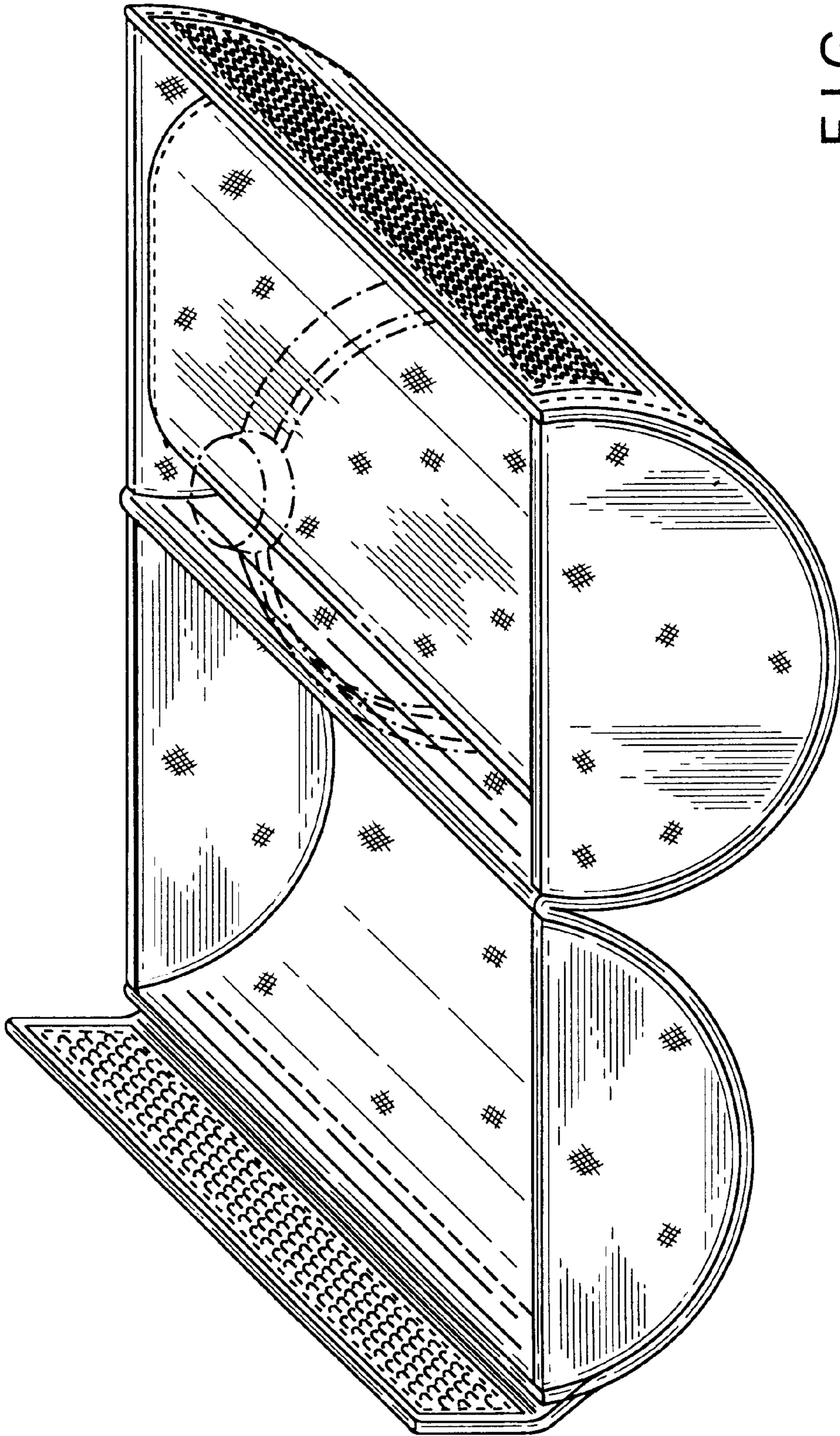
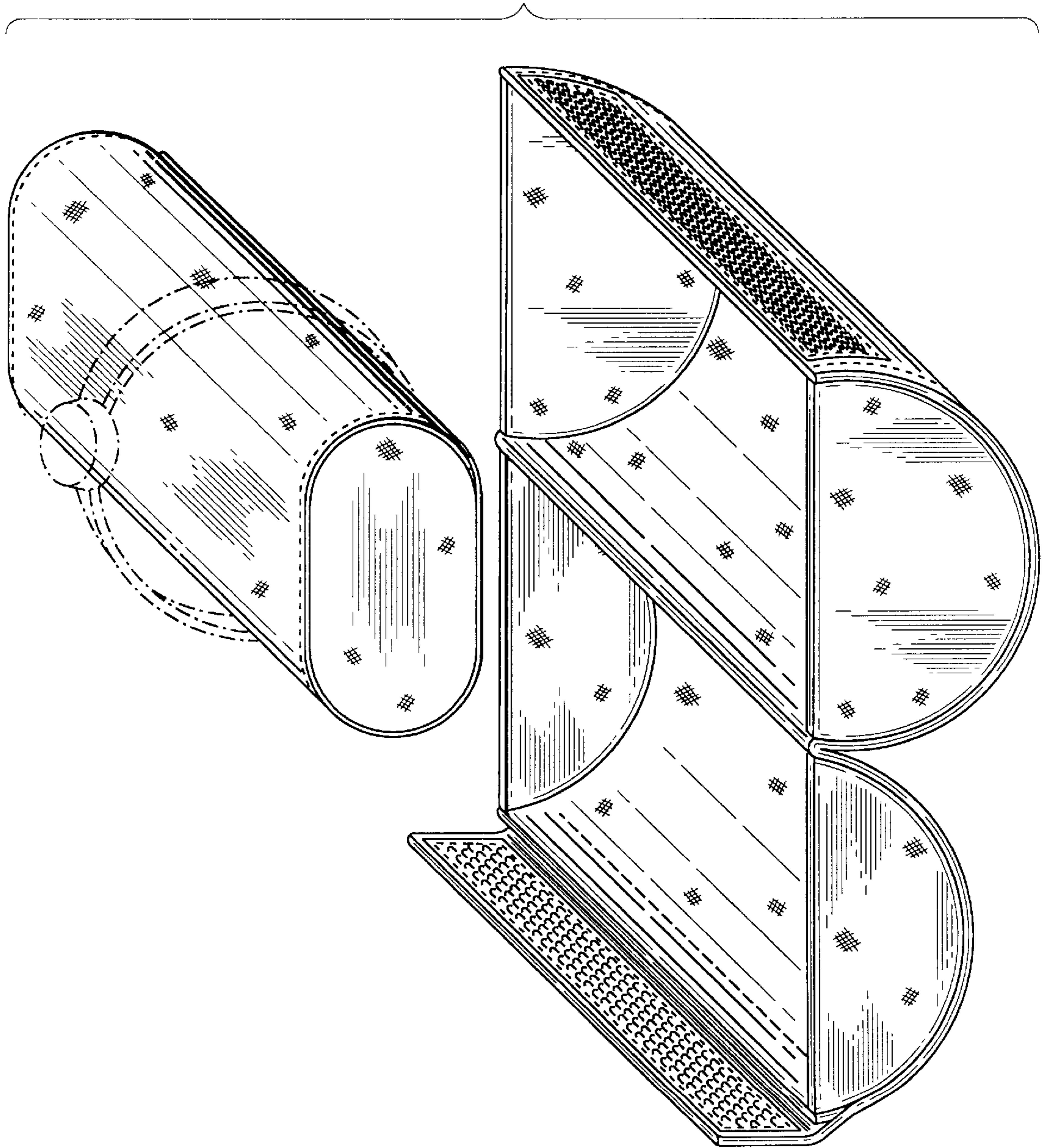

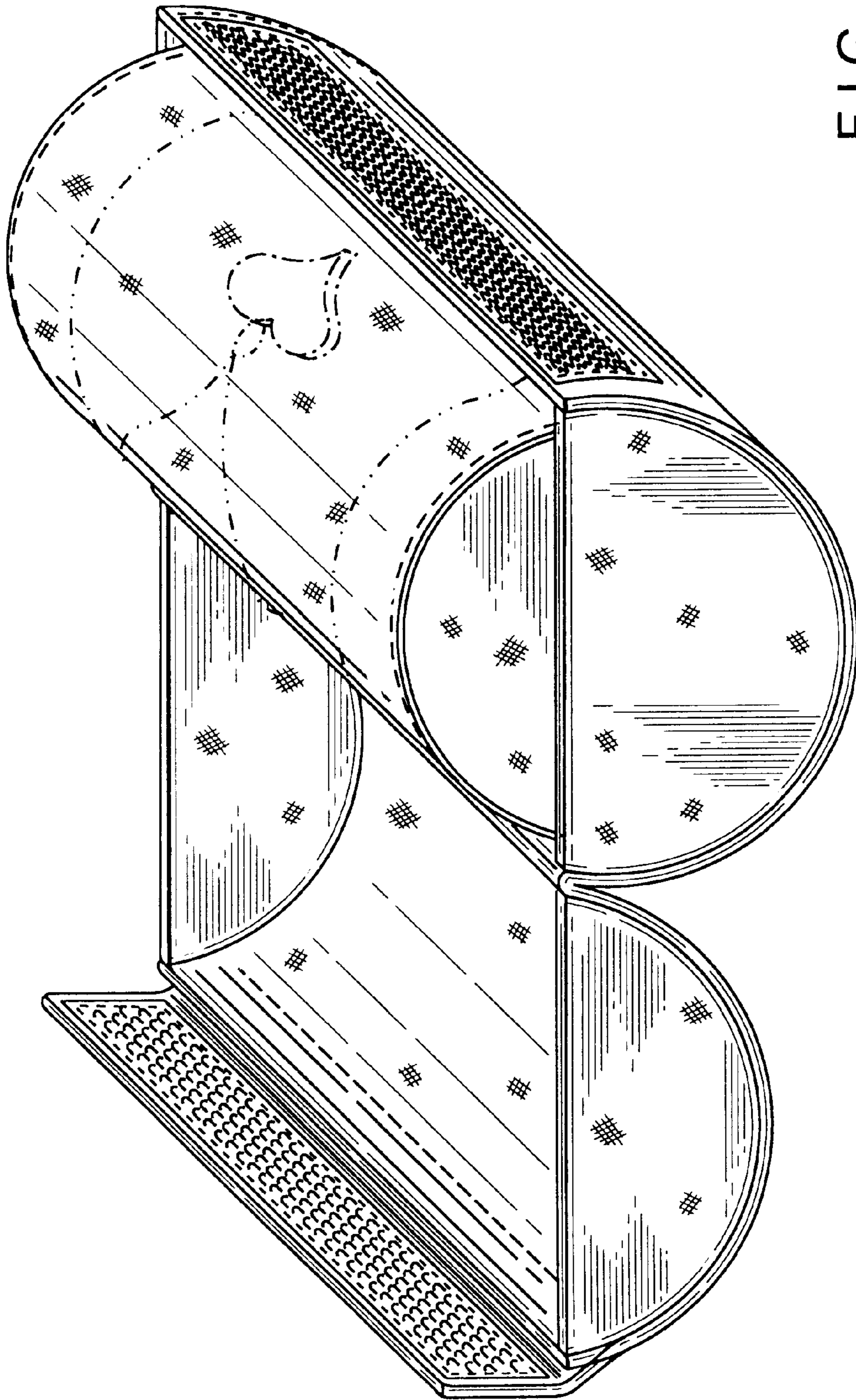
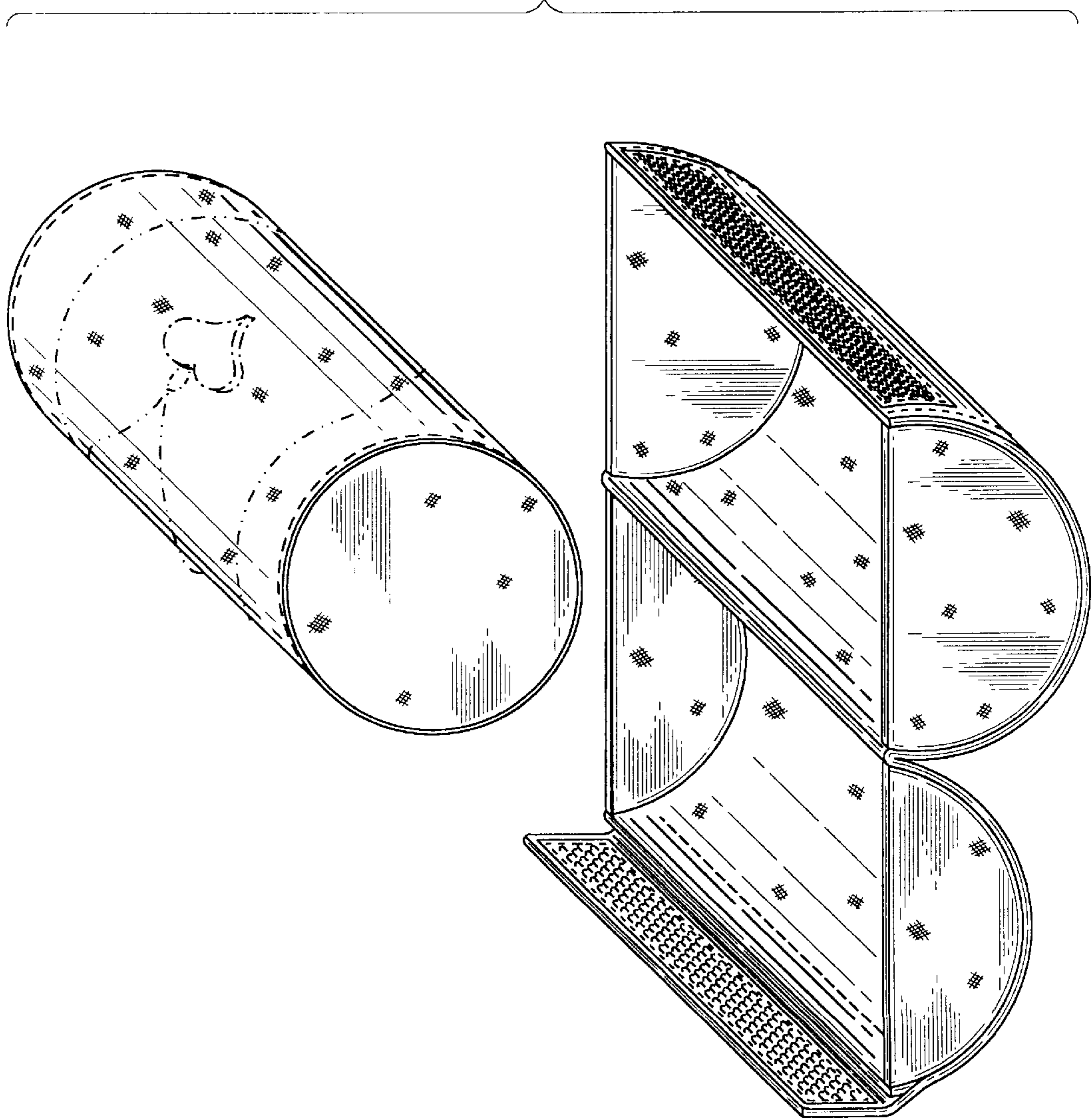

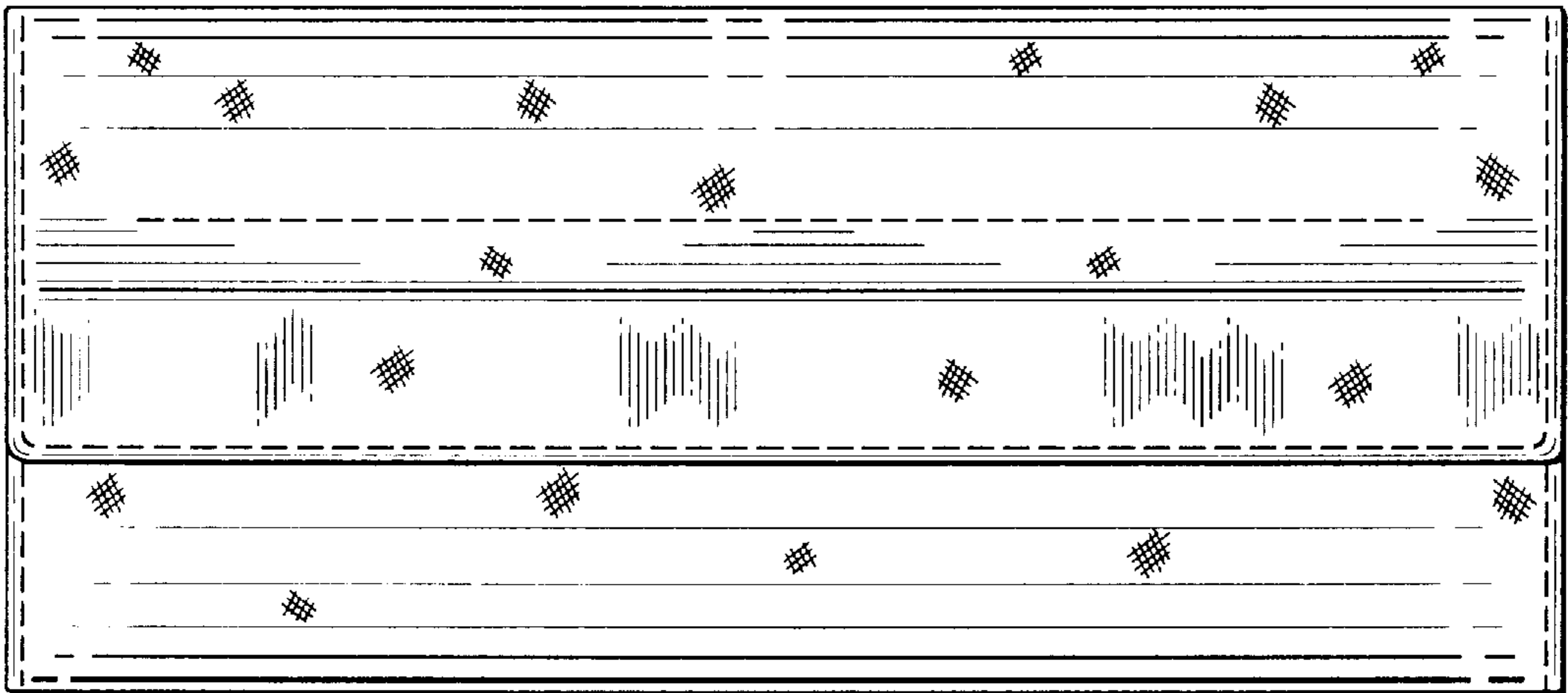

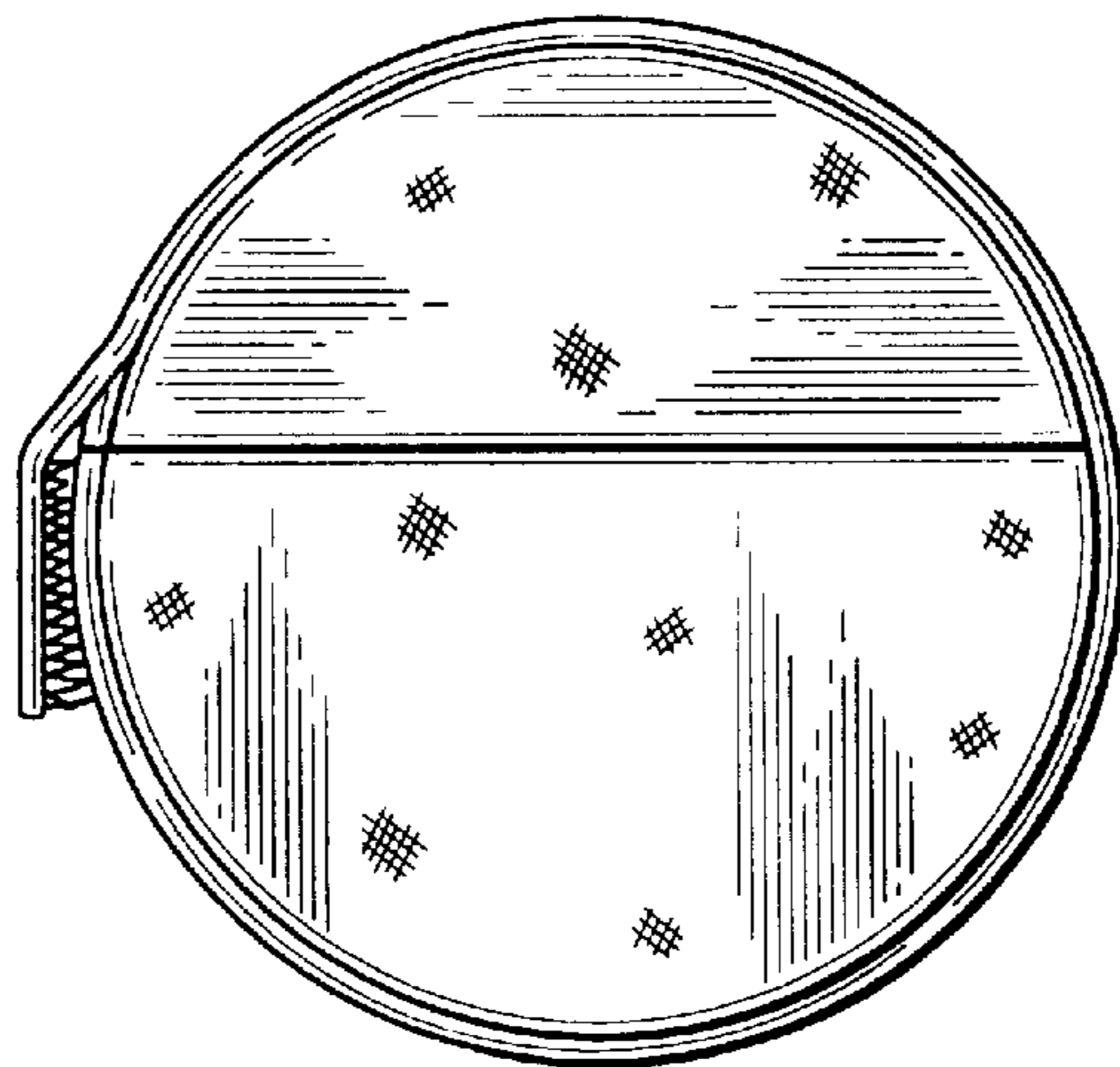

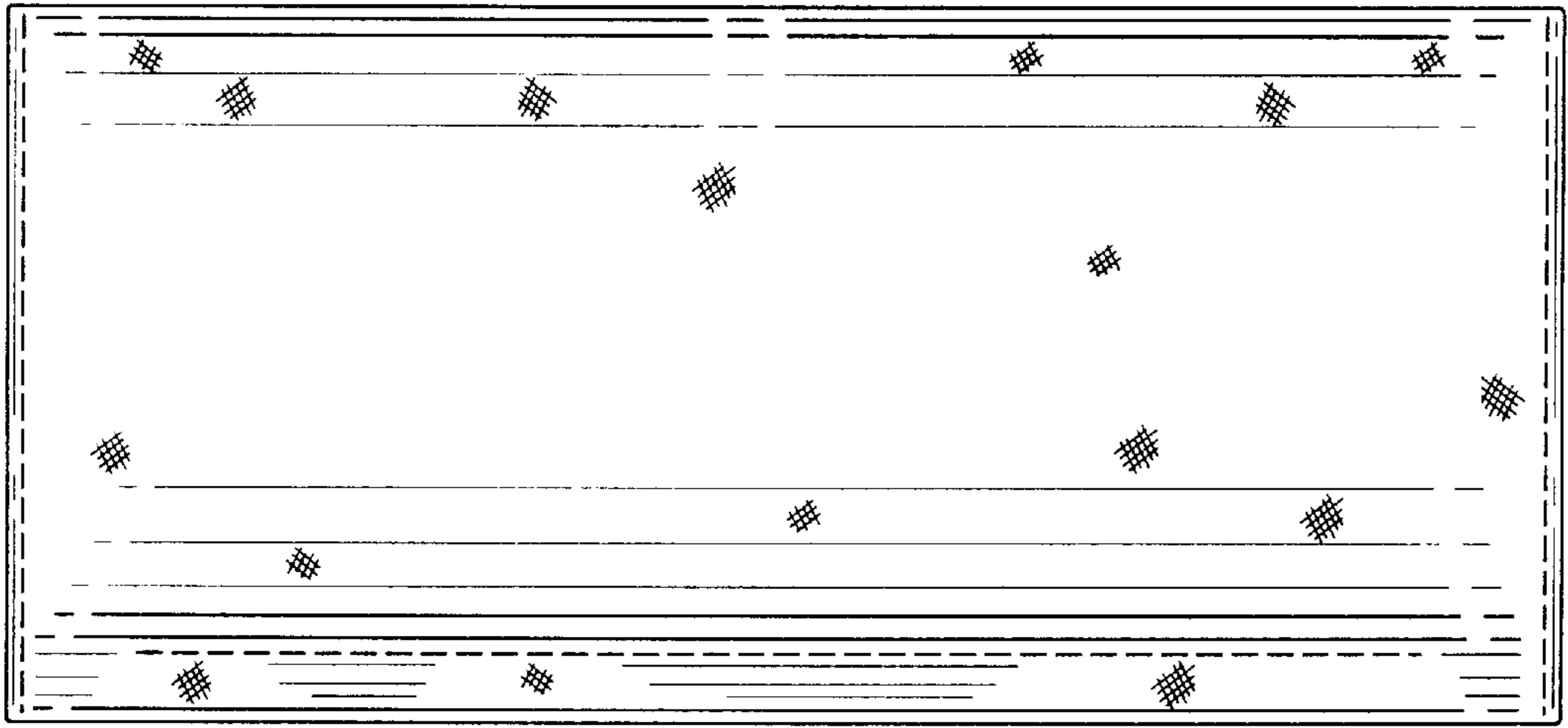

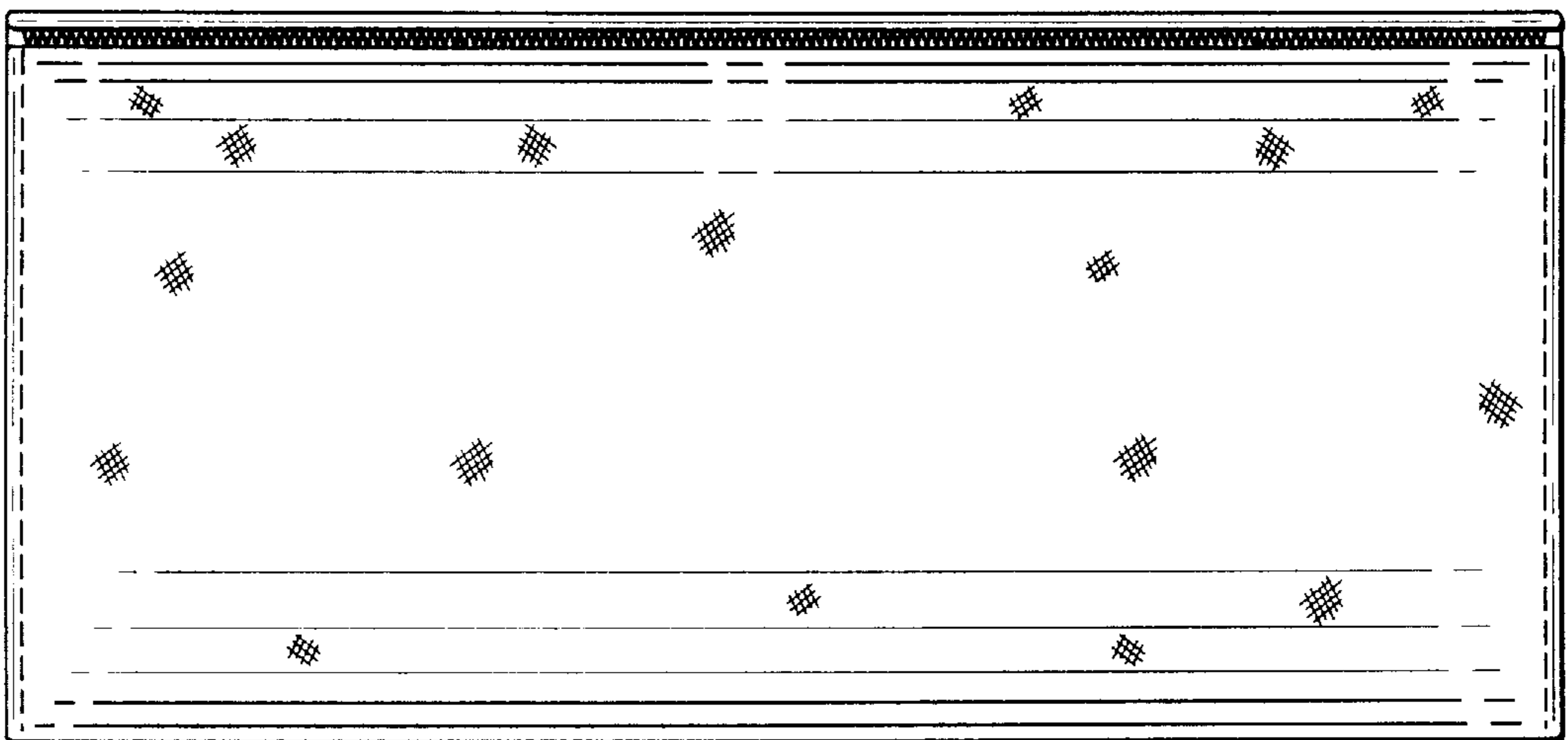

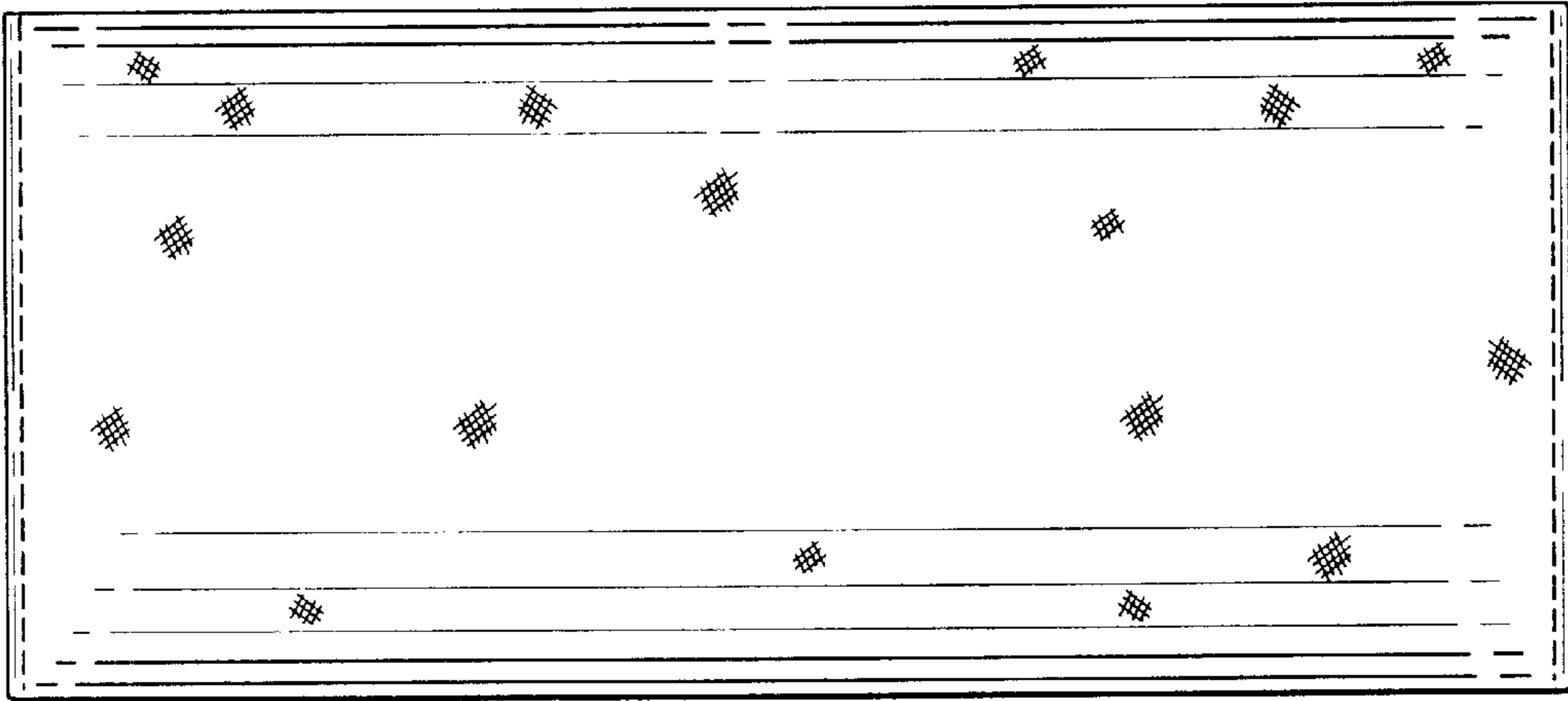

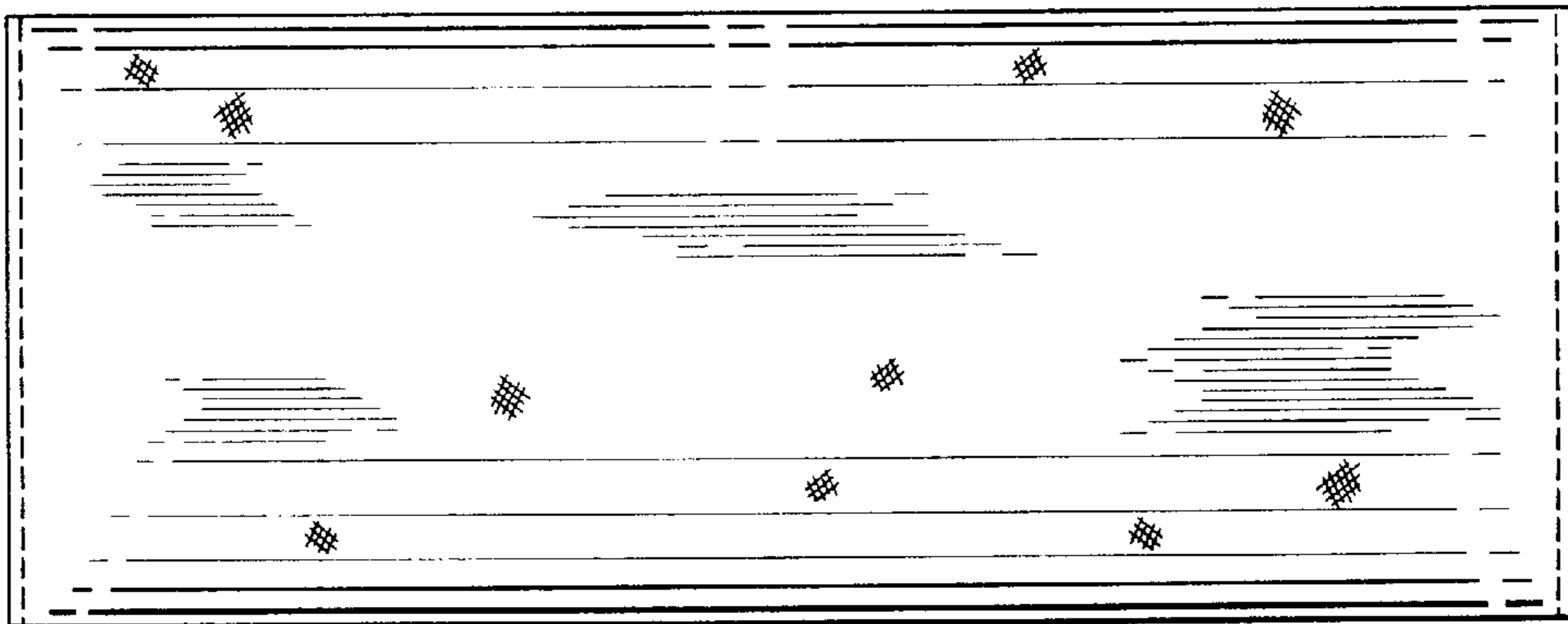

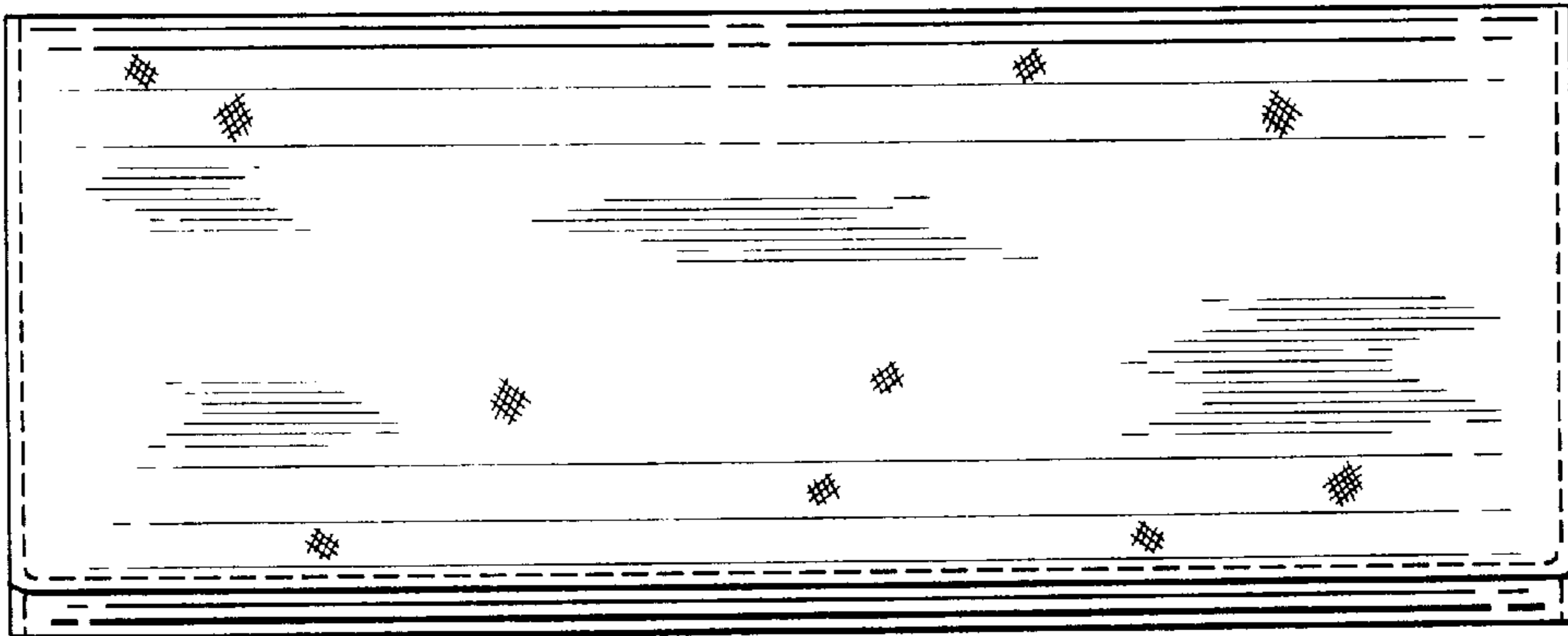

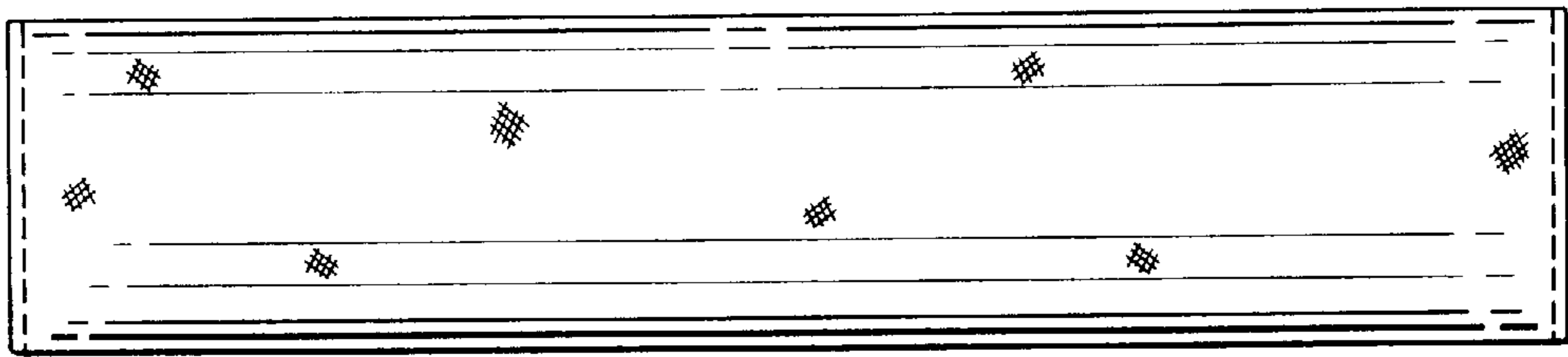

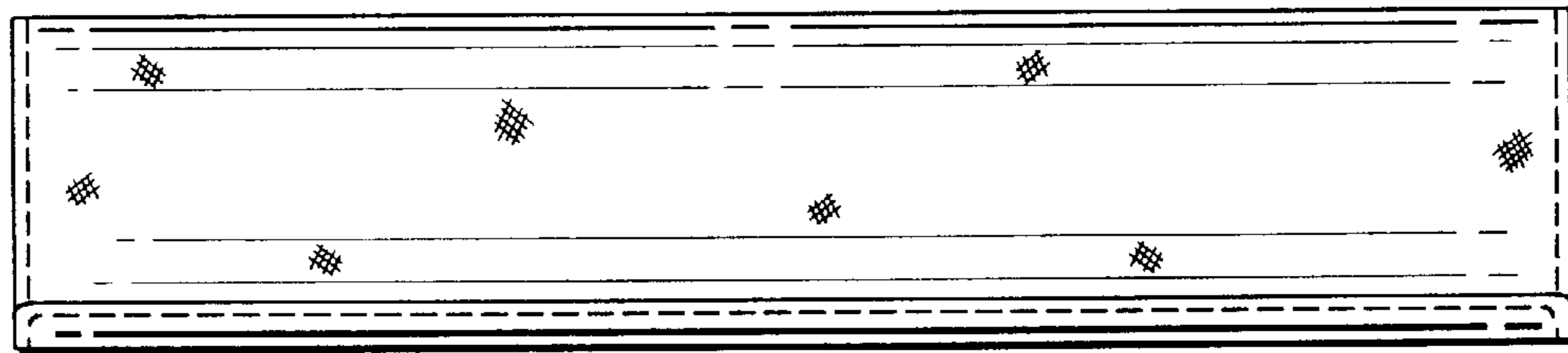

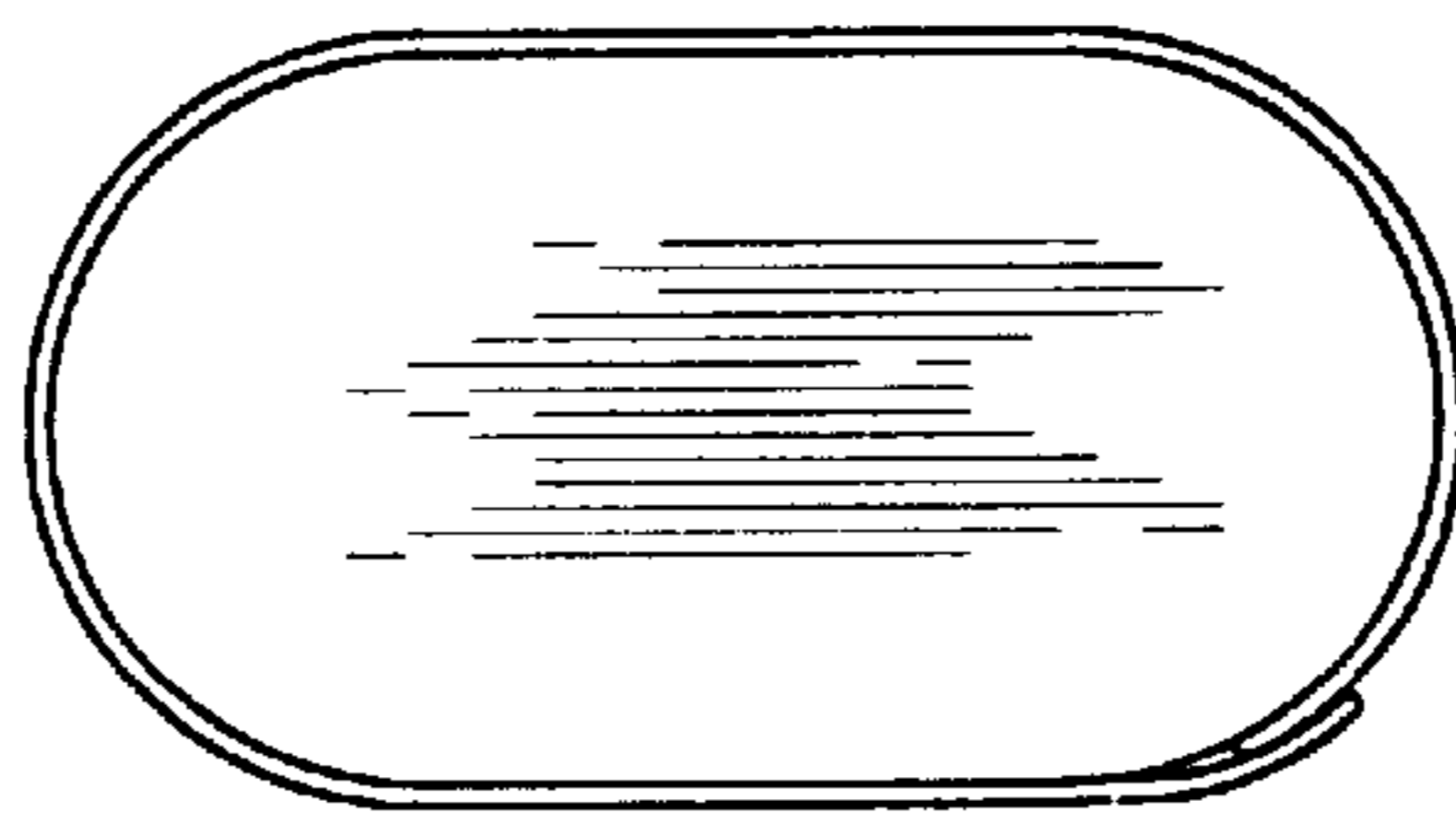

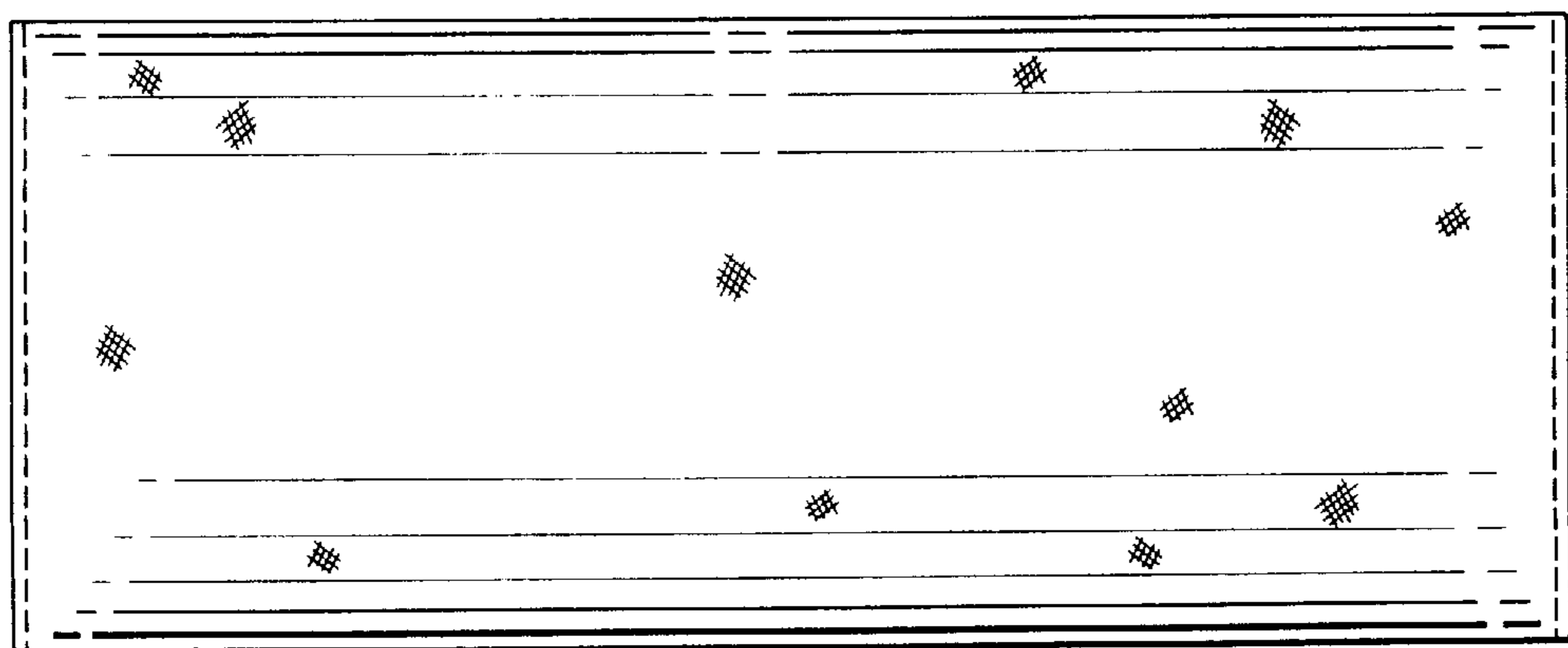

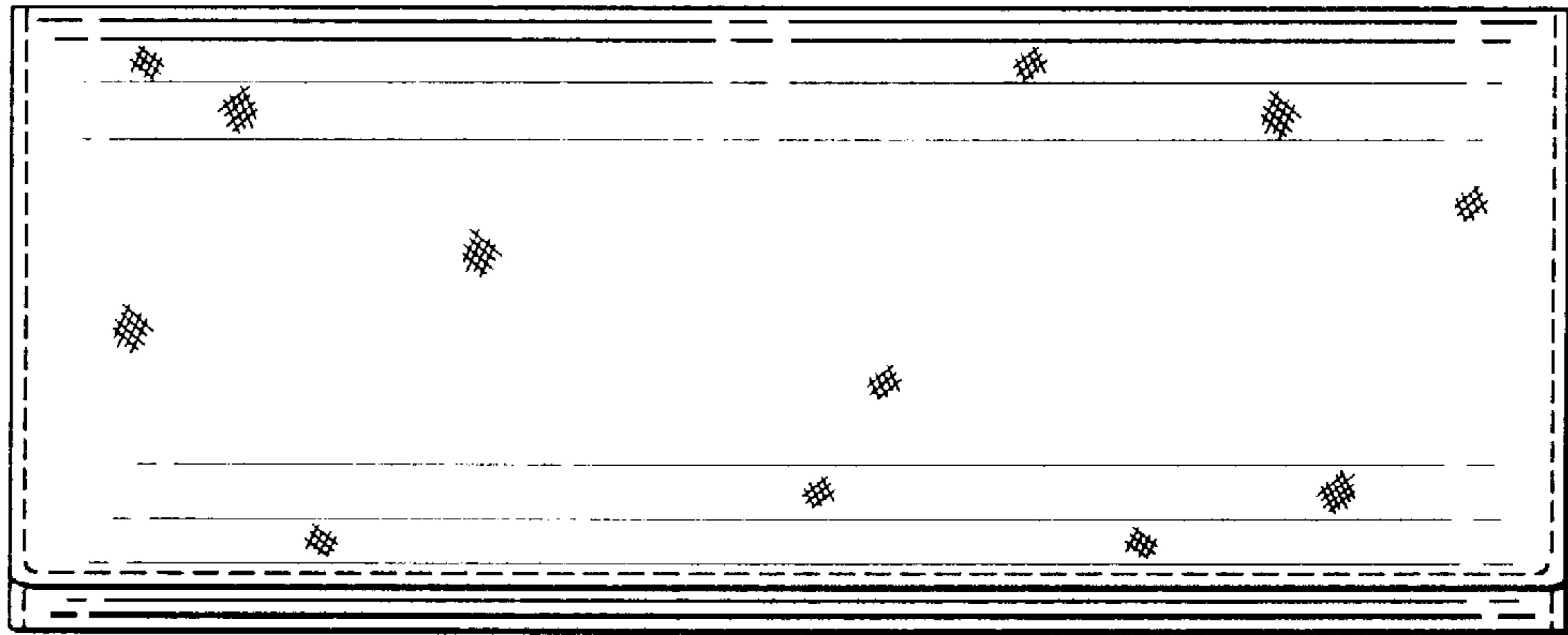

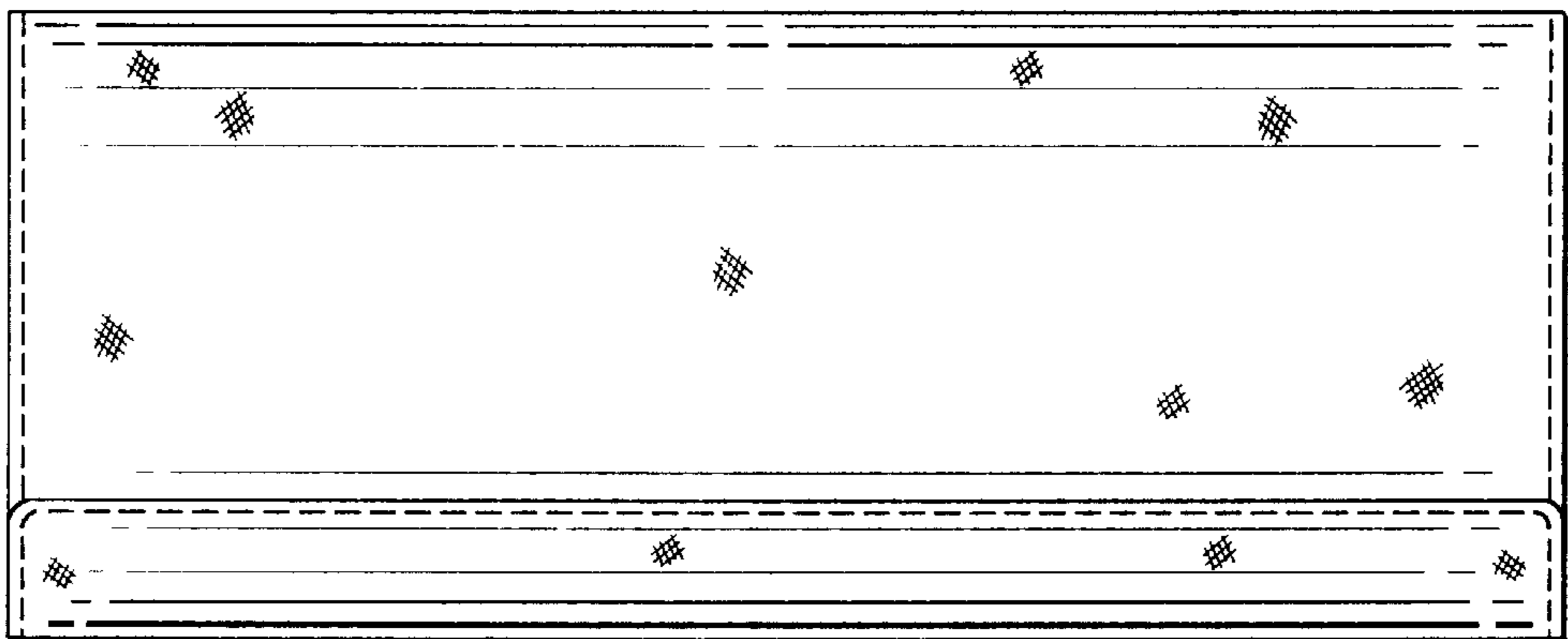

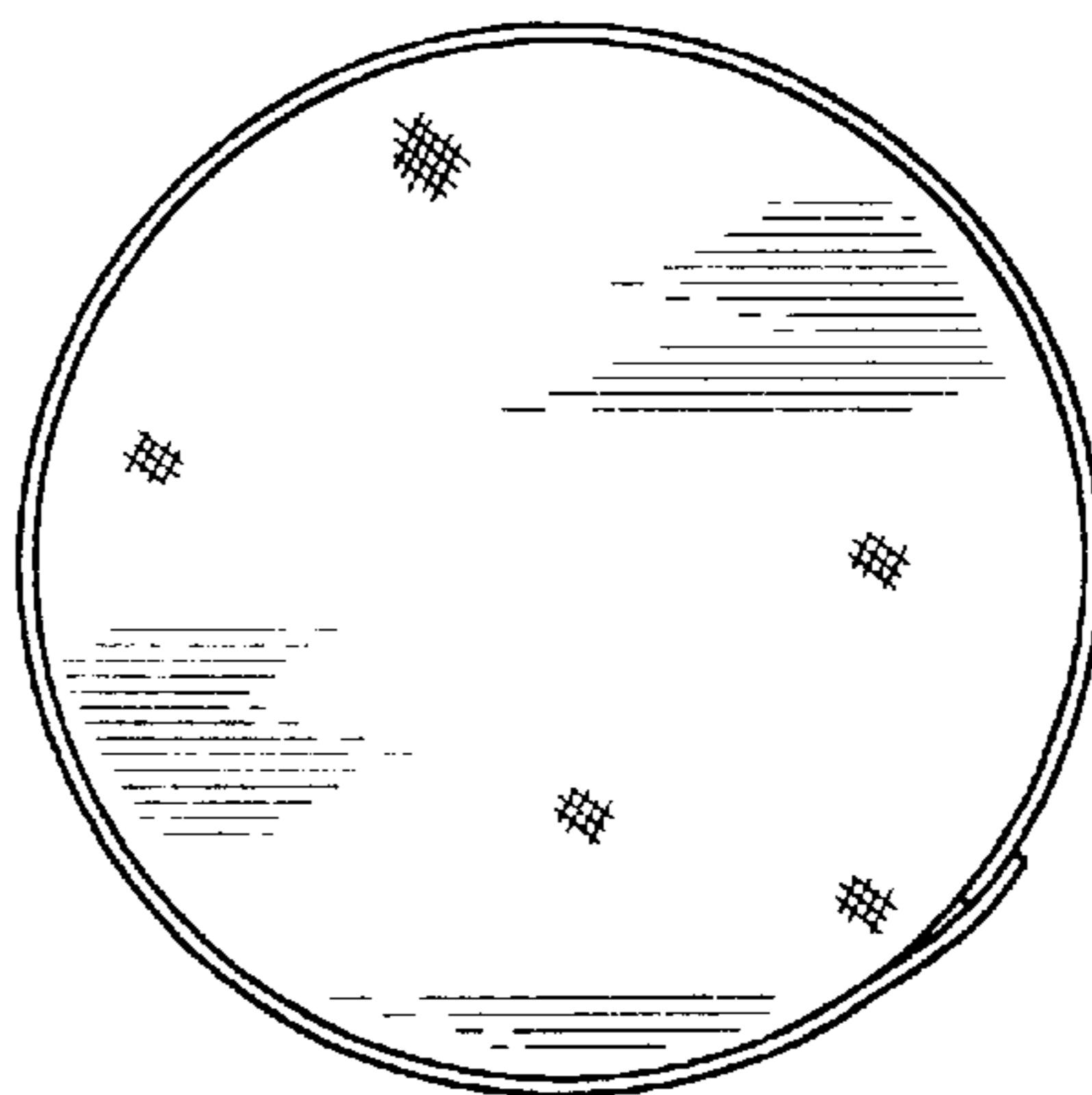
