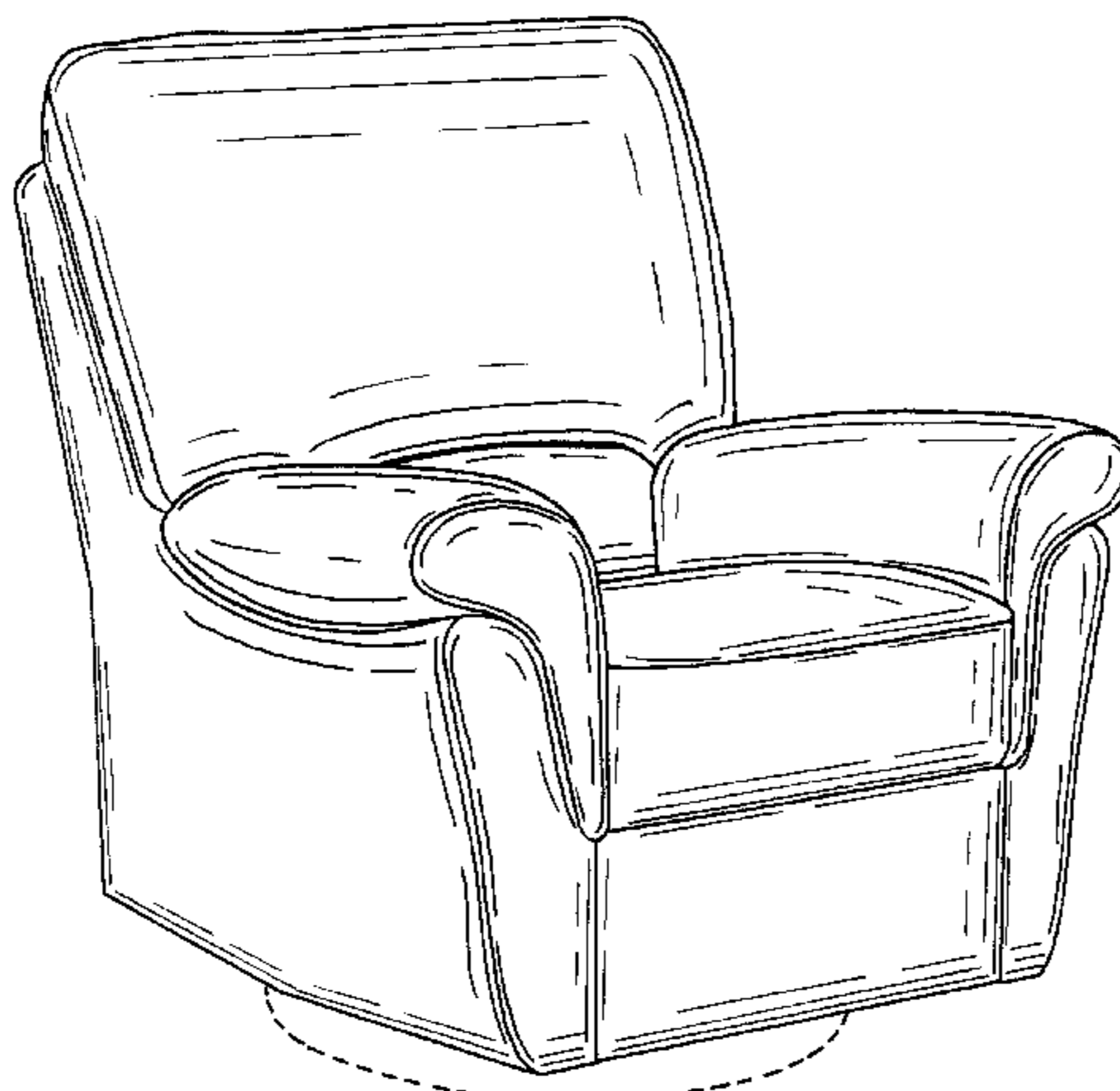
### [57] **CLAIM**

### **DESCRIPTION**

FIG. 1 is a front perspective view our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view, the left side being a mirror image thereof; and, FIG. 5 is a rear perspective view thereof. 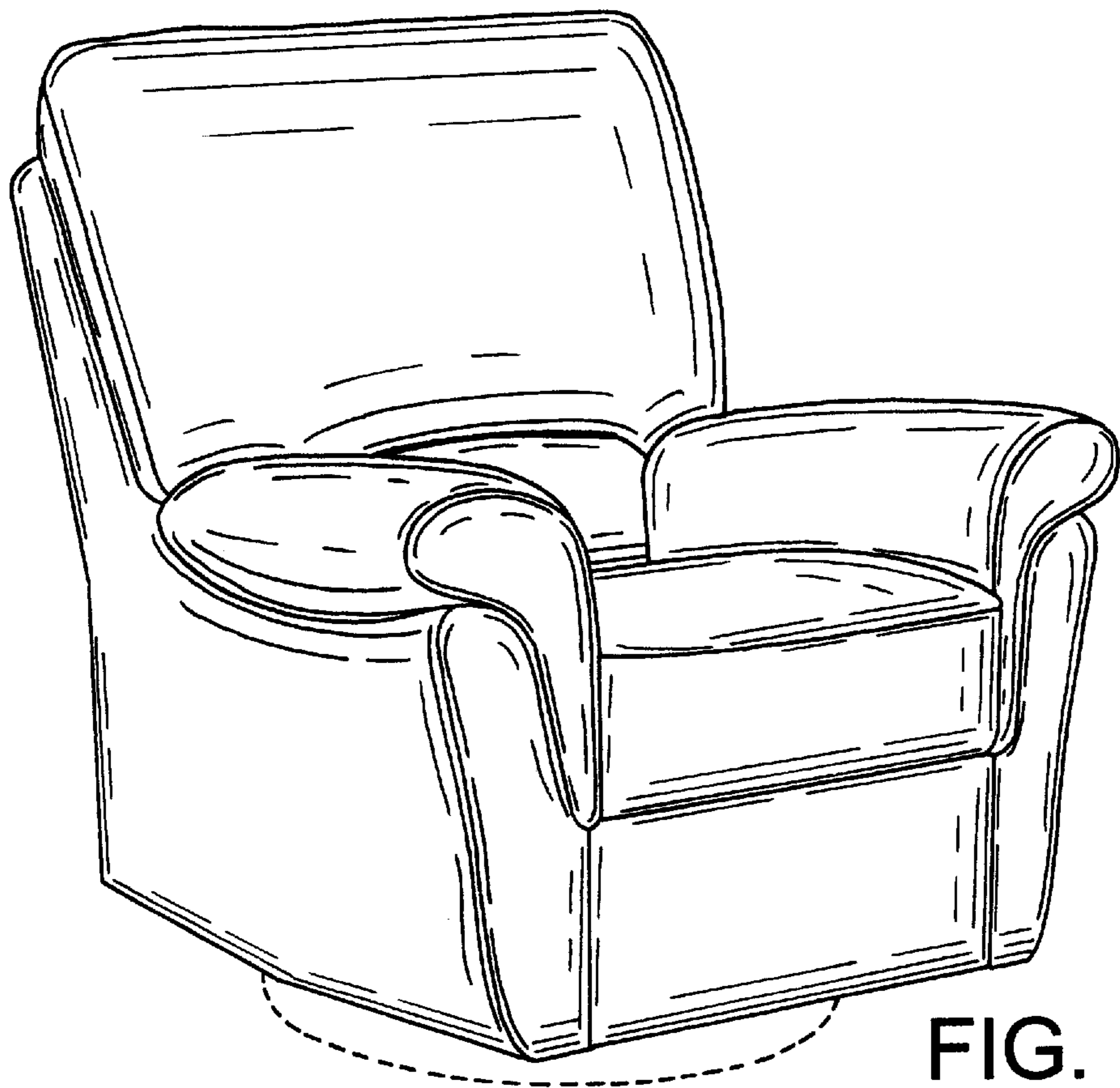

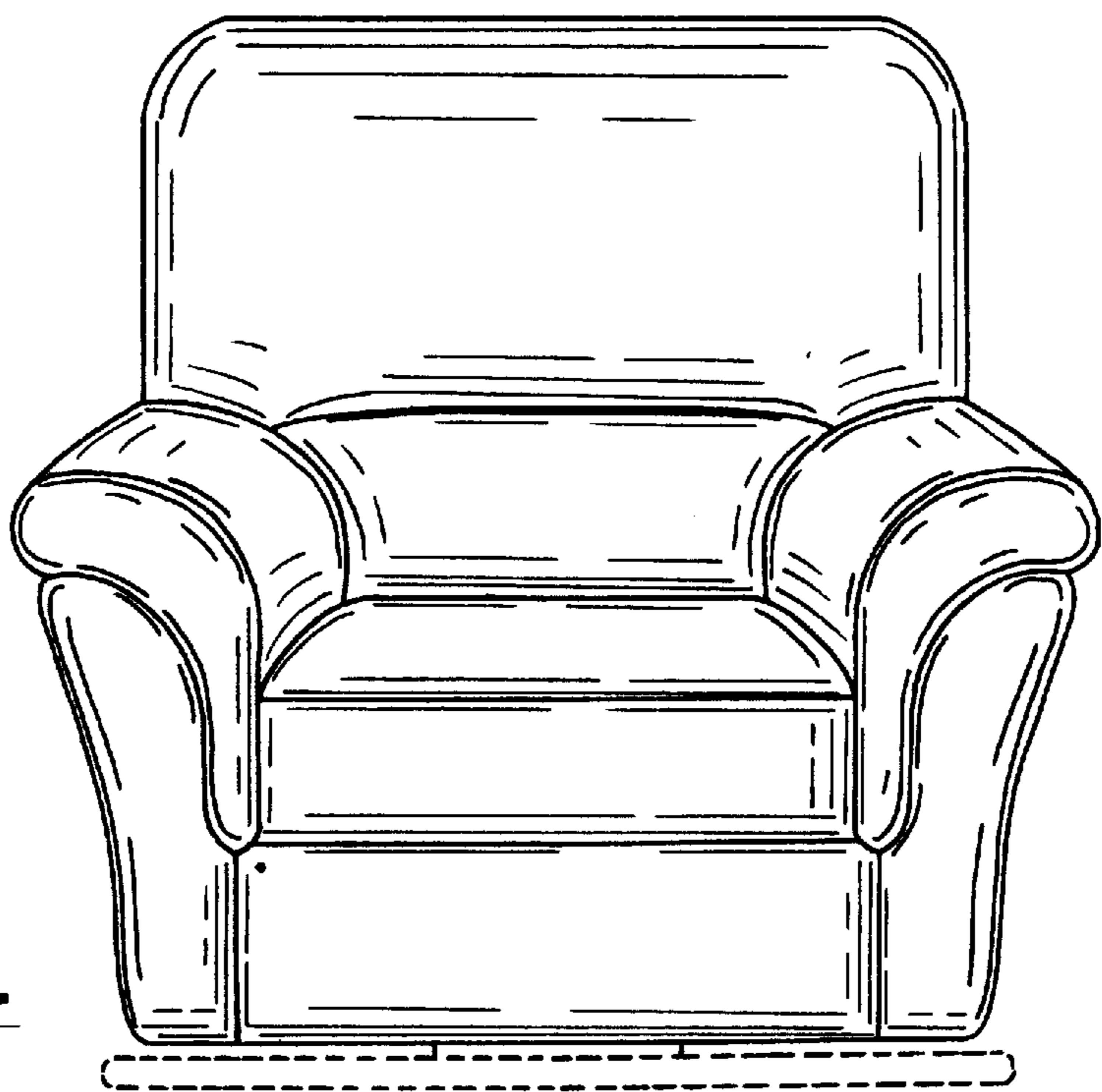

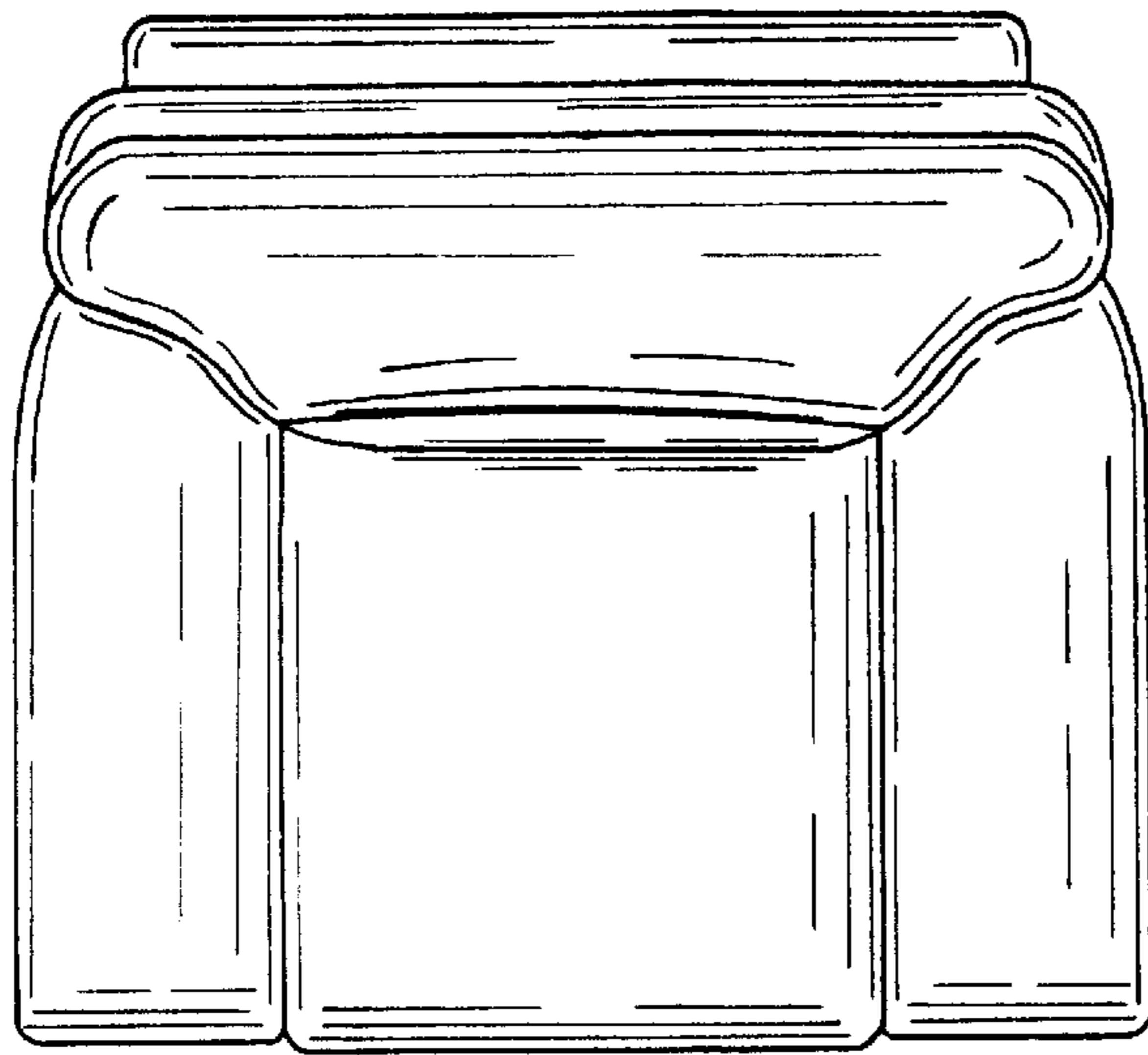

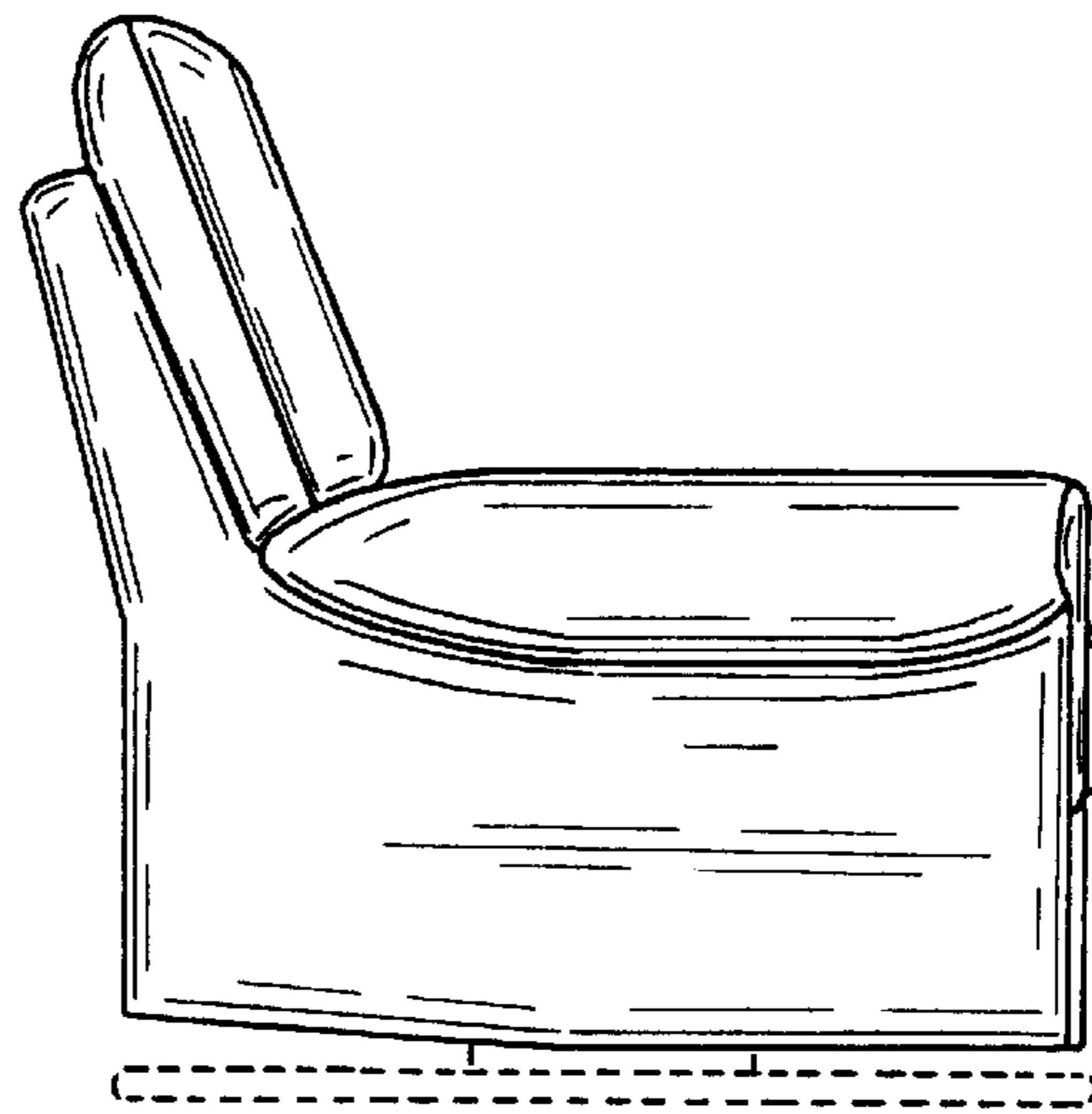

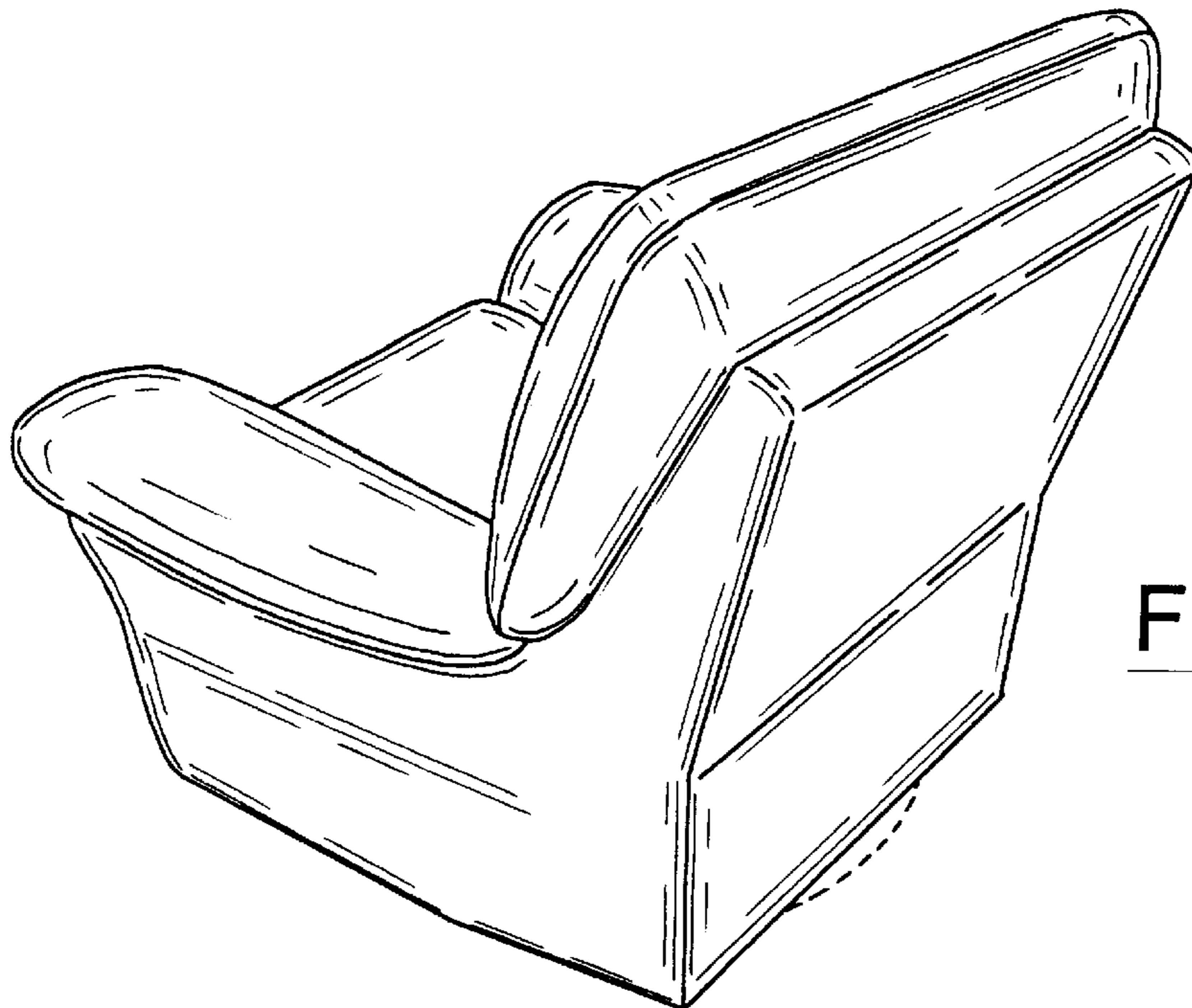
