[57] CLAIM

The ornamental design for a children's play space, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the children's play space embodying our design showing the domed top in its closed position, and showing the supporting structure and base in dashed lines for environmental purposes only and forming no part of the claimed design;

FIG. 2 is an elevated left side view of the children's play space embodying our design showing the domed top in its closed position, the elevated right side view being a mirror image thereof;

FIG. 3 is an elevated front view of the children's play space embodying our design showing the domed top in its closed position, the elevated rear view being a mirror image thereof;

FIG. 4 is a top view of the children's play space embodying our design showing the domed top in its closed position;

FIG. 5 is an elevated left side view of the children's play space embodying our design showing the domed top in its partially open position, the elevated right side view being a mirror image thereof; and,

FIG. 6 is an elevated left side view of the children's play space embodying our design showing the domed top in its fully open position, the elevated right side view being a mirror image thereof.

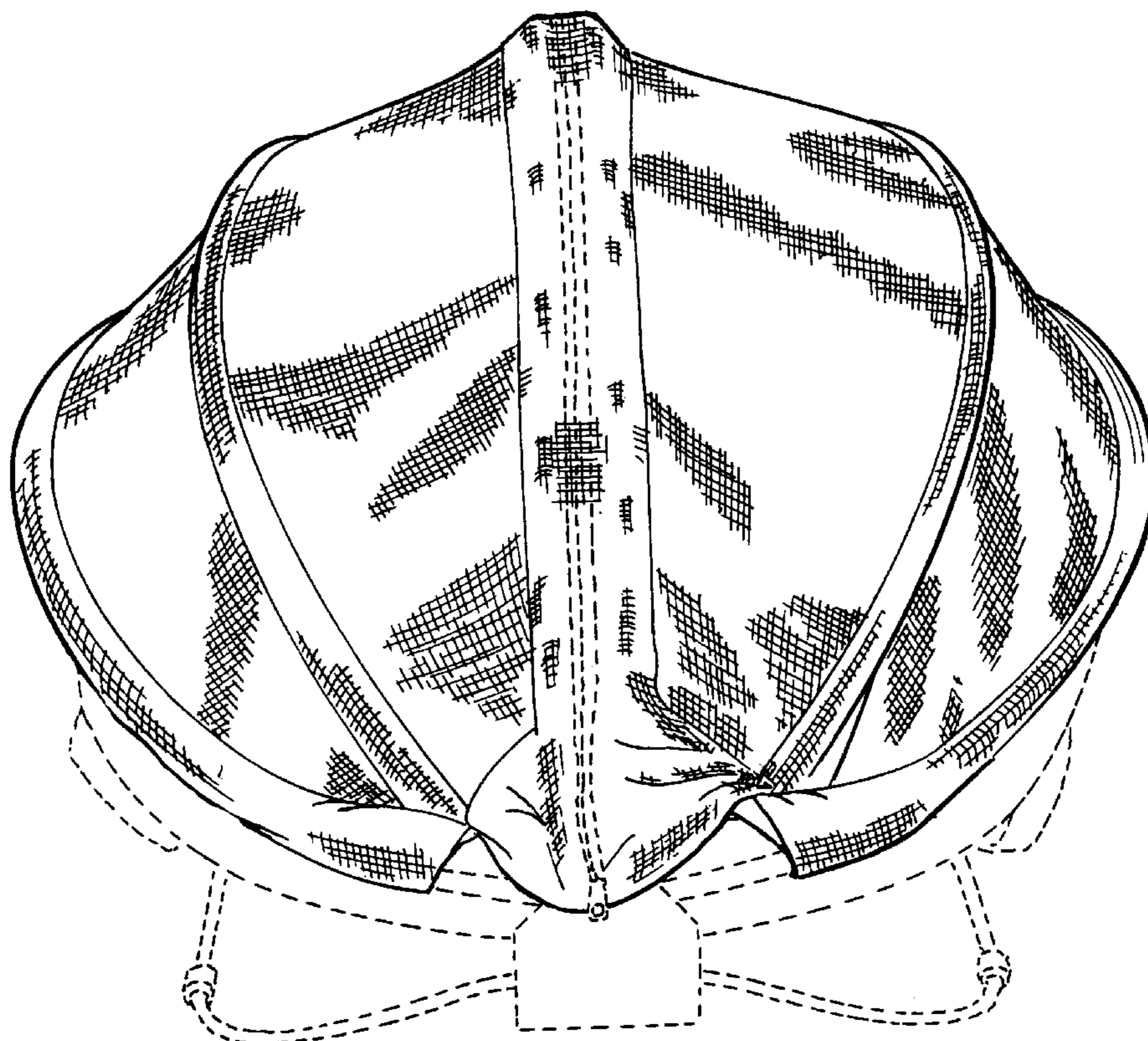

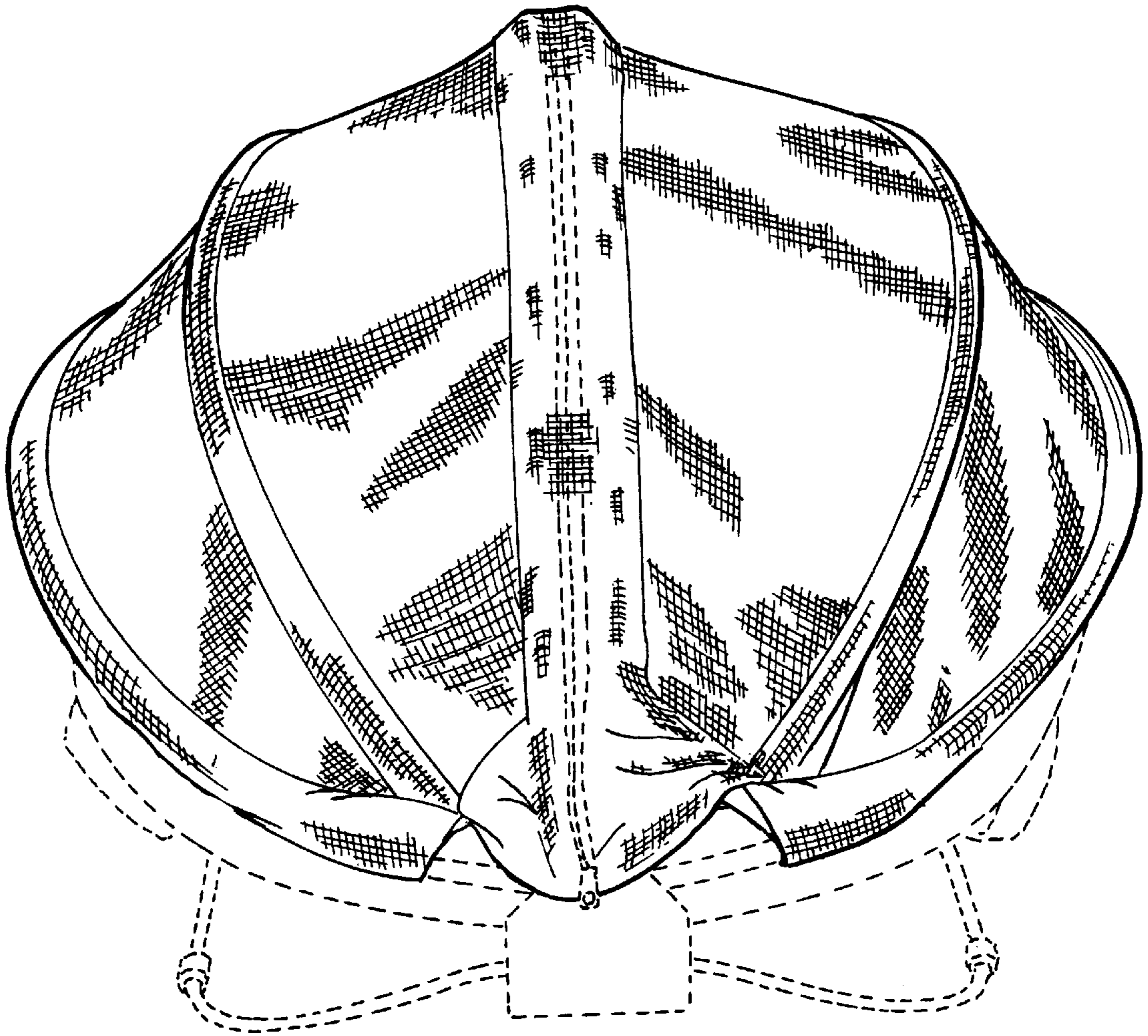

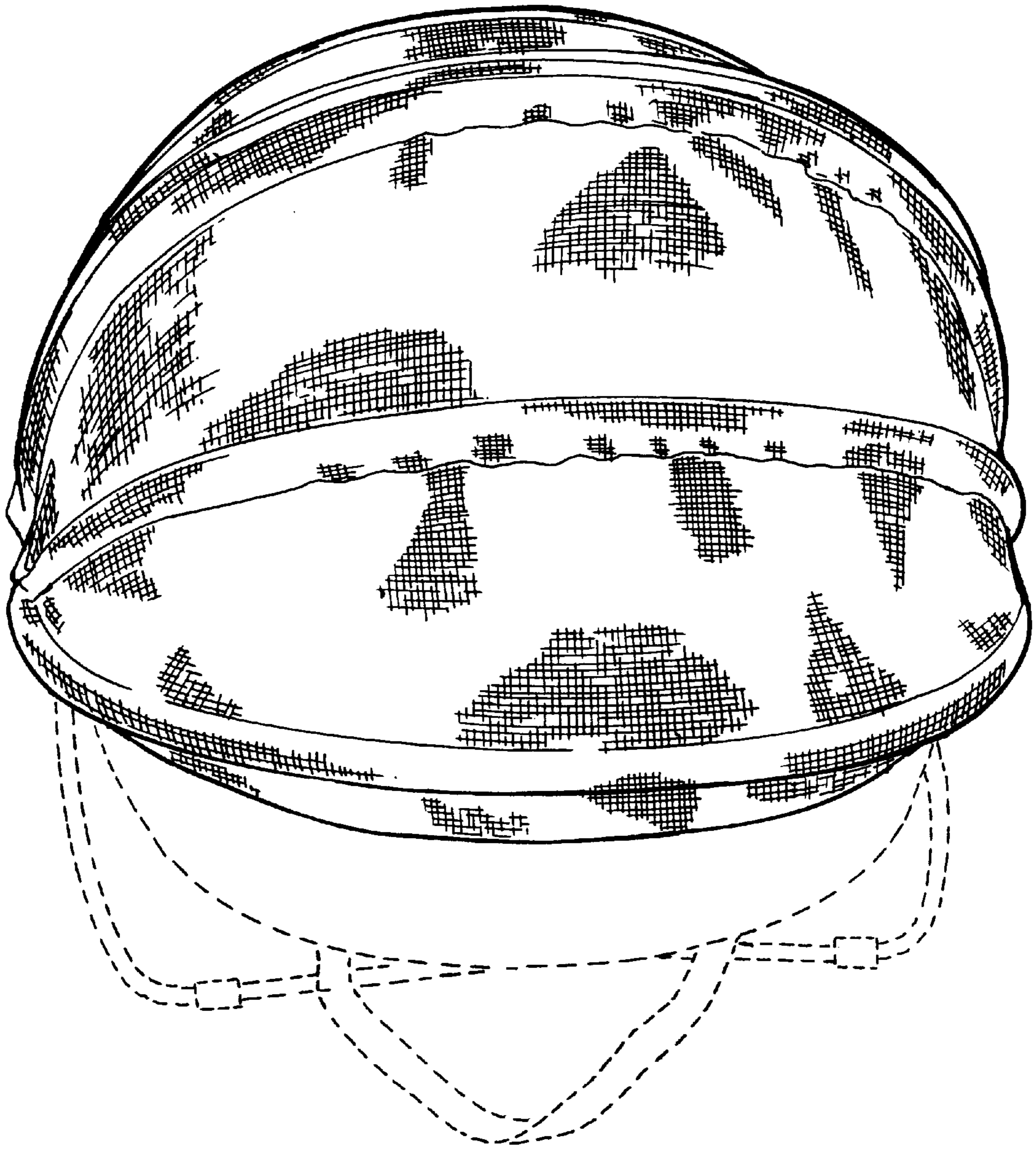

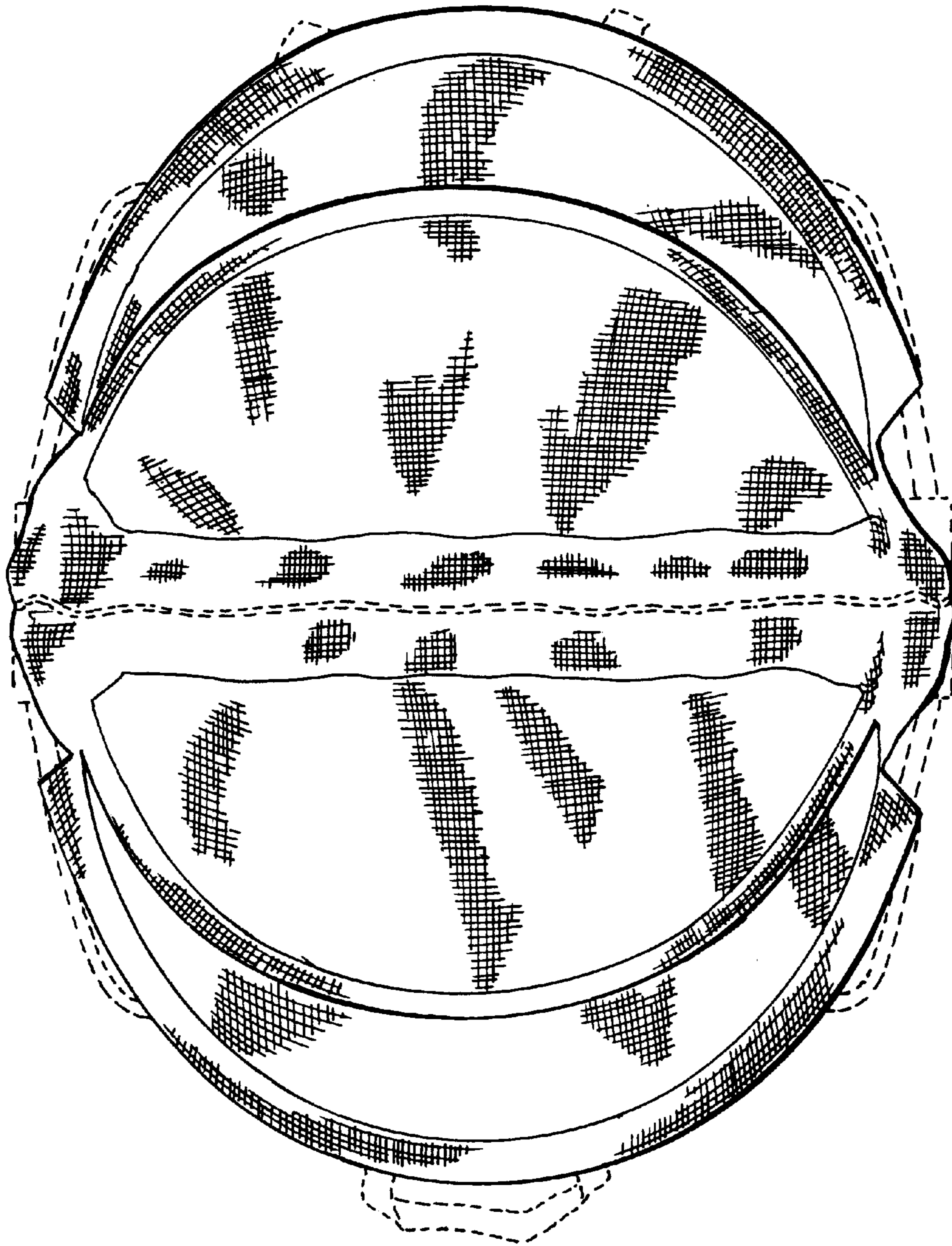

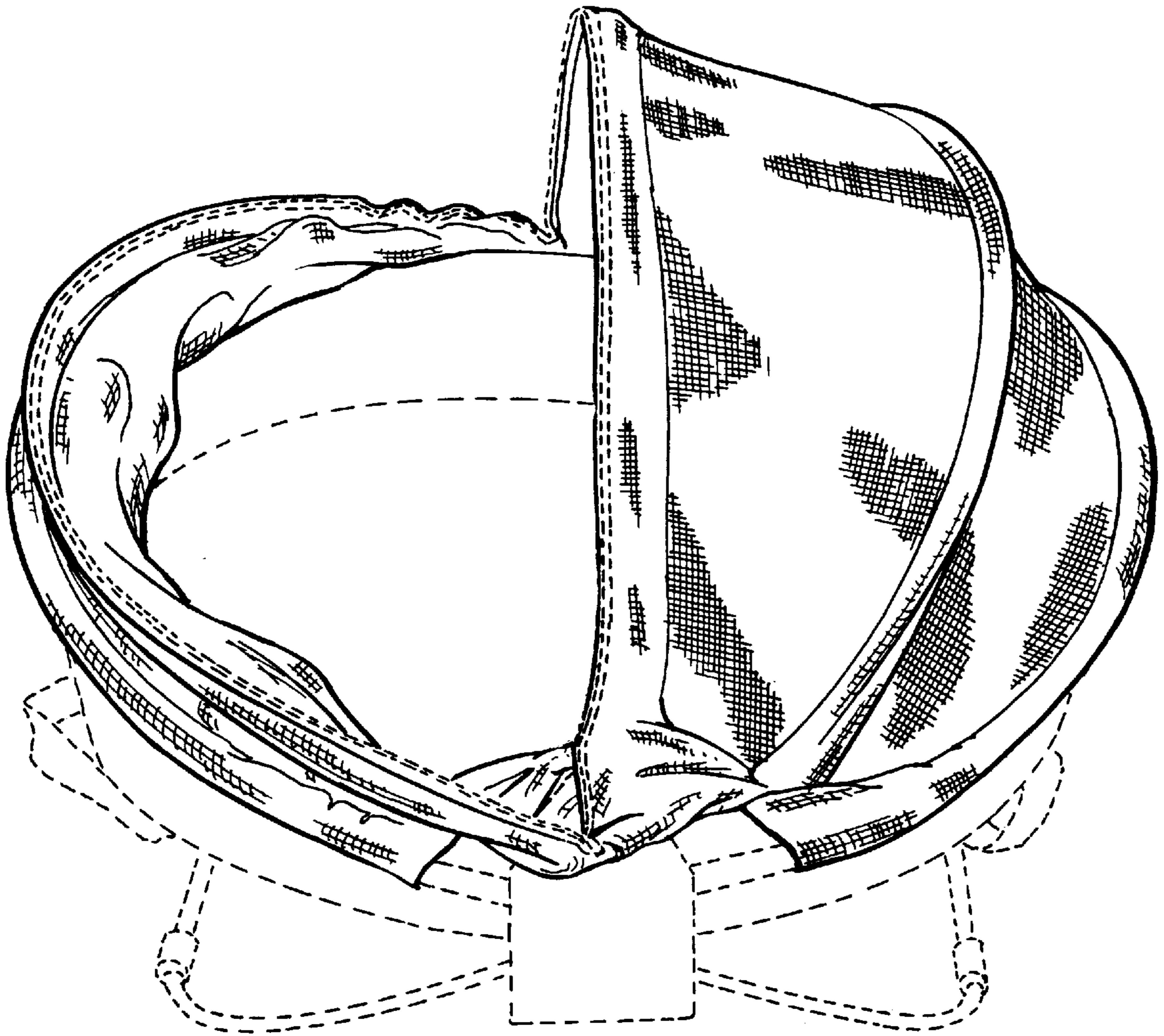

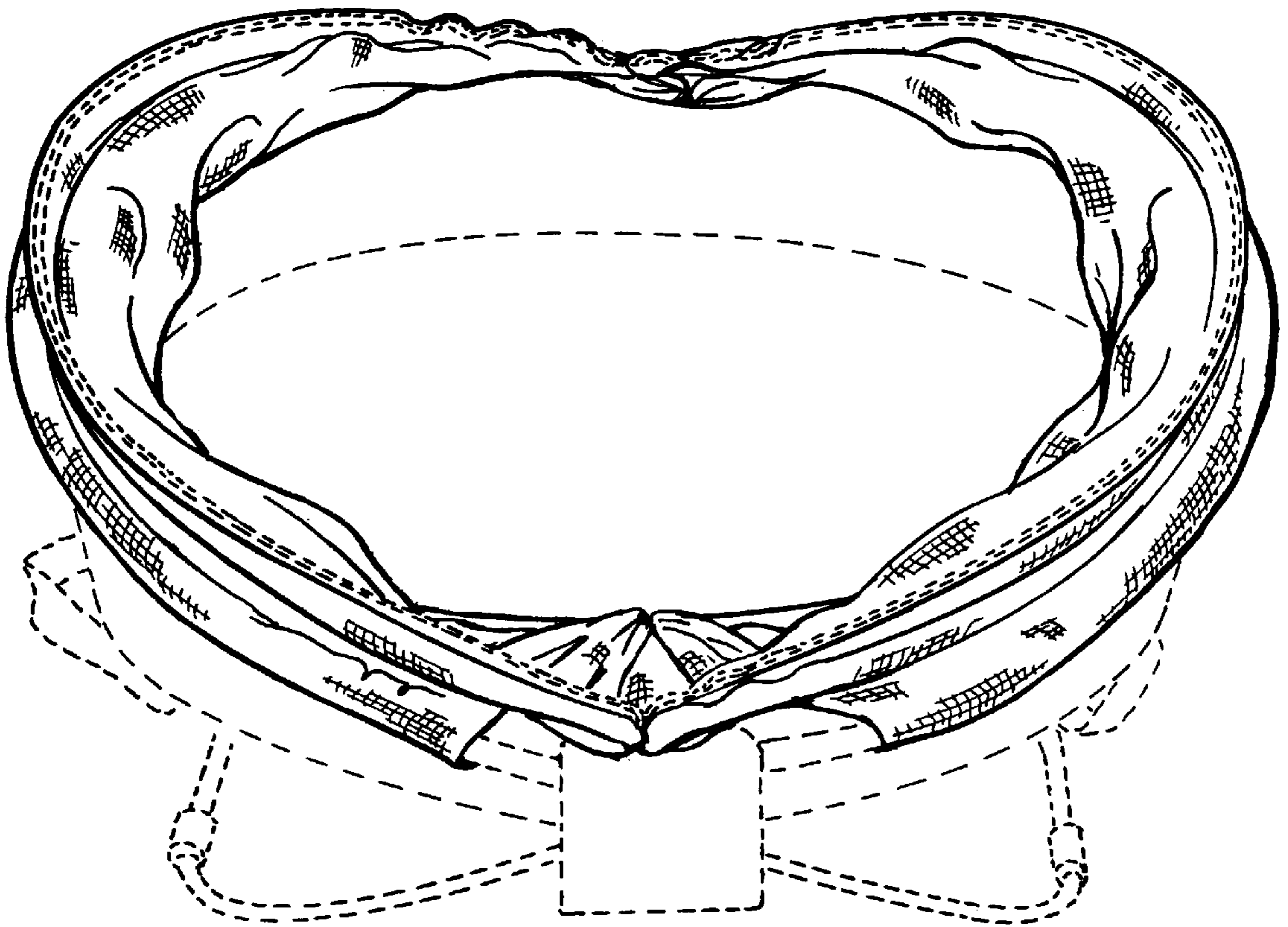
