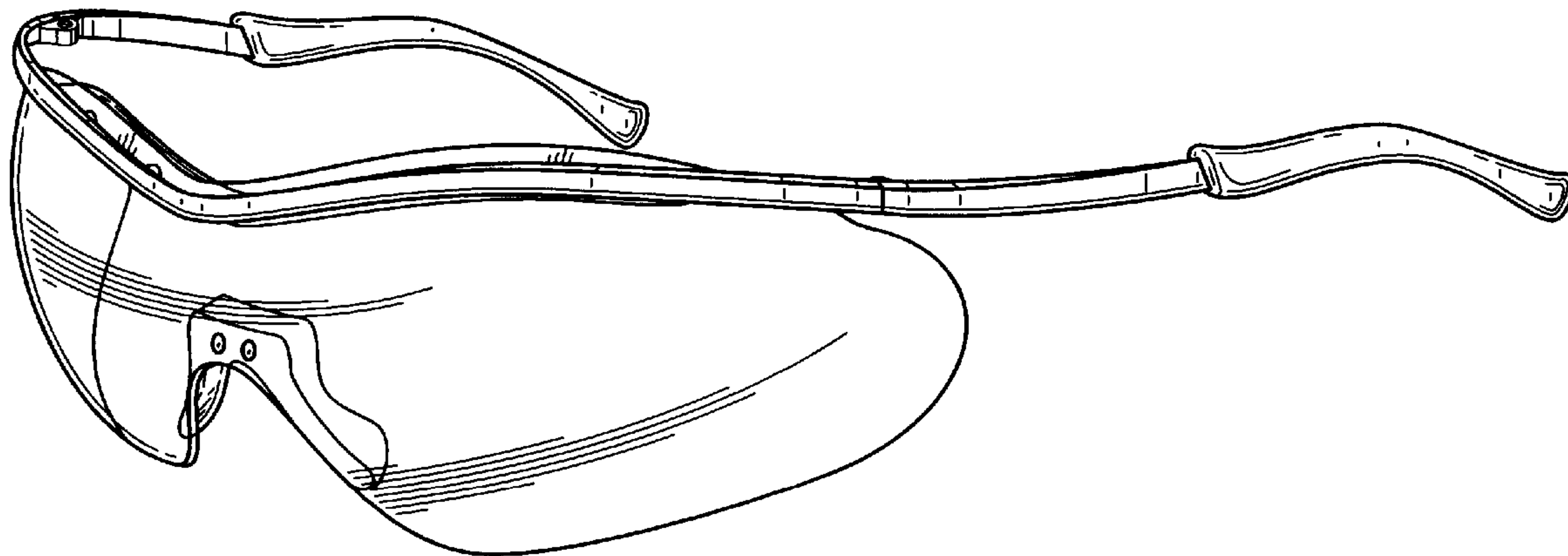
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of eyewear showing my new design;

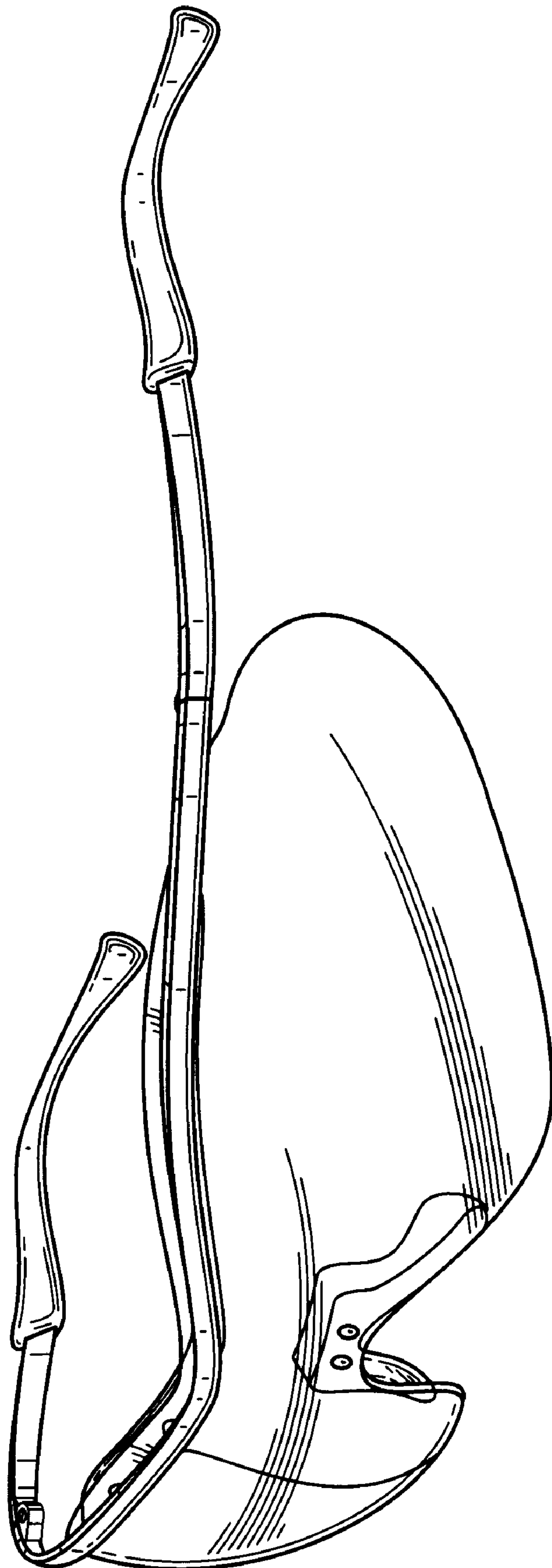

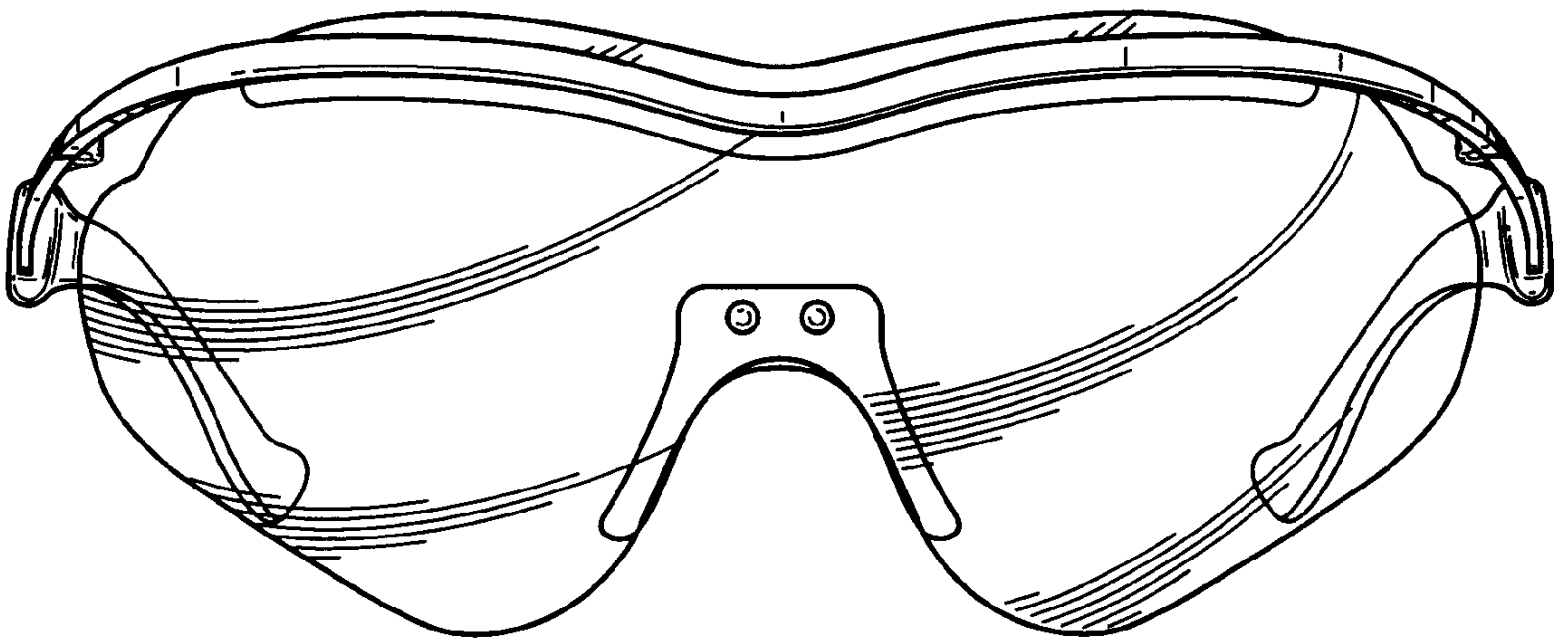

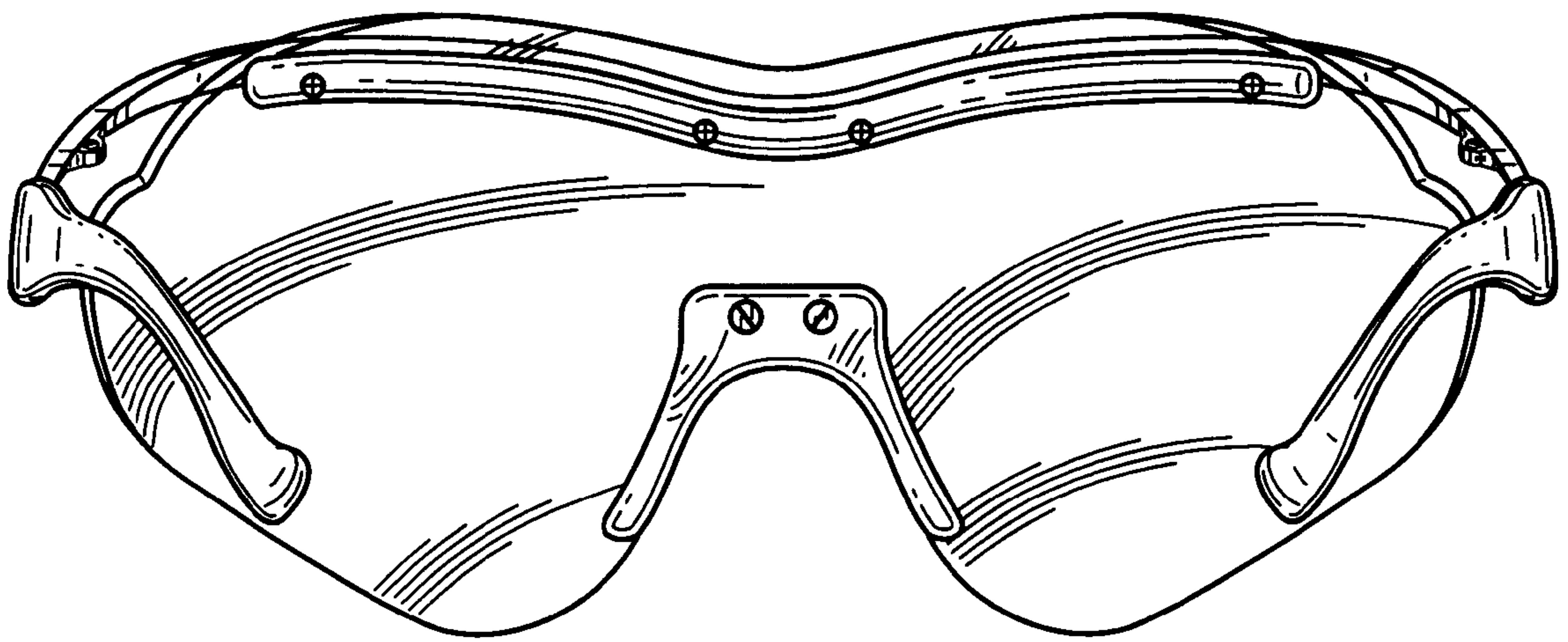

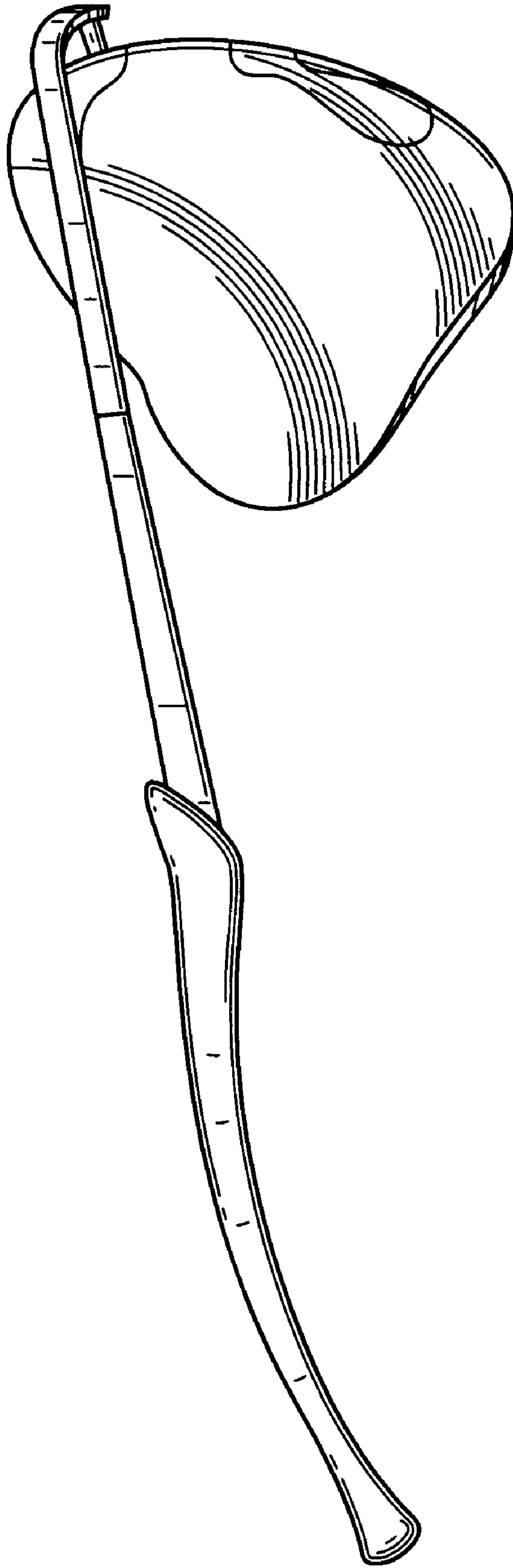

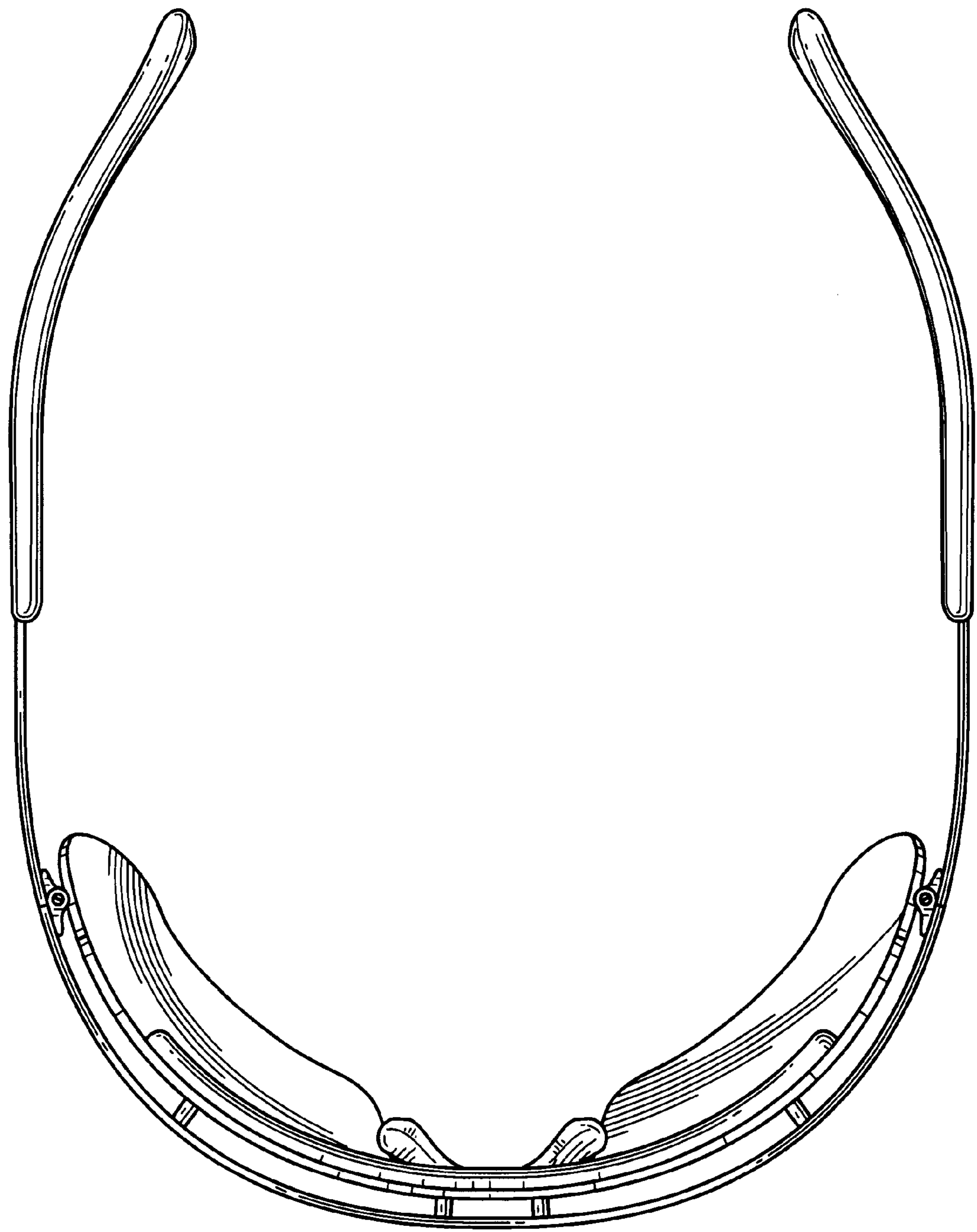

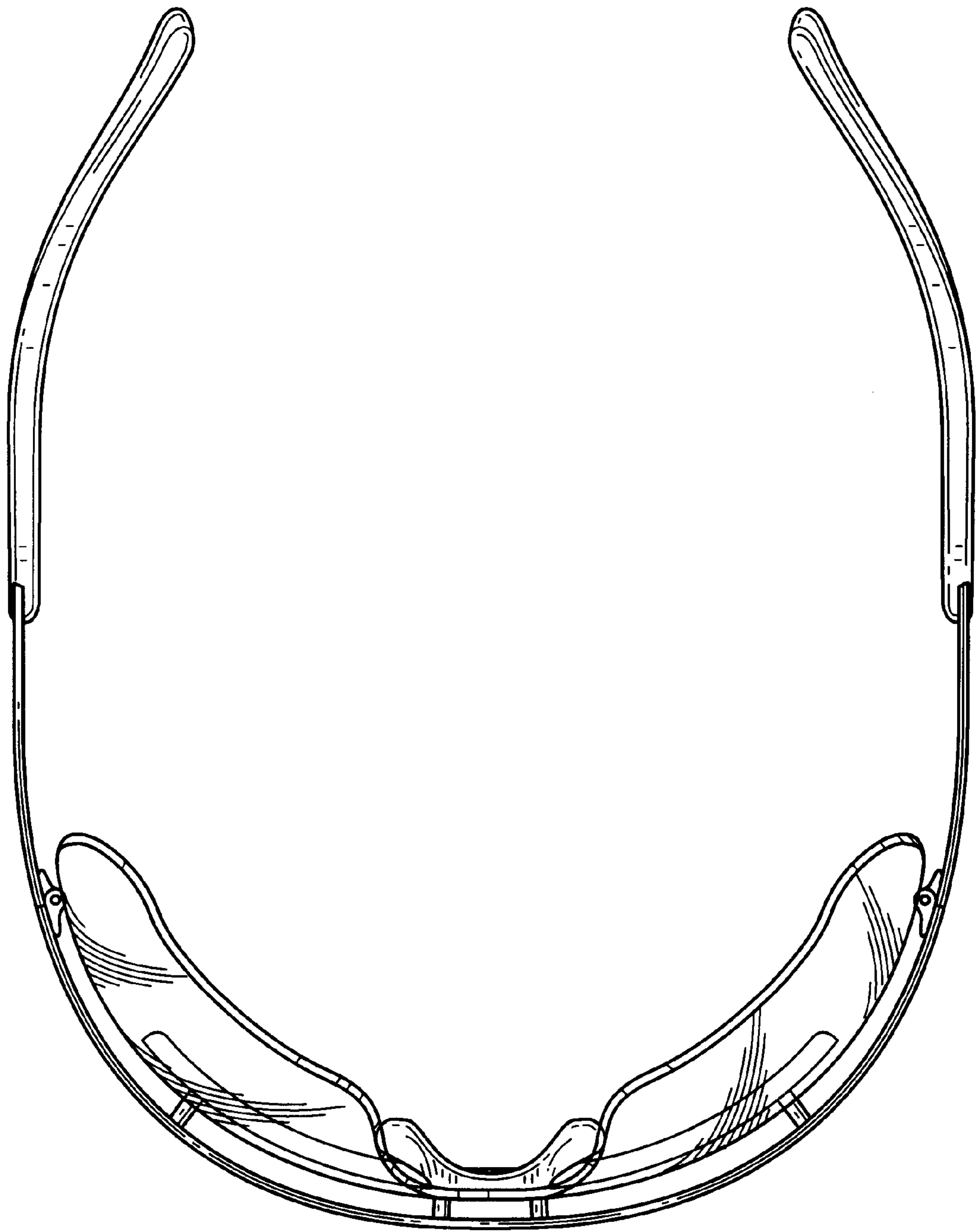
