The ornamental design for a collection assembly with a specimen label, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the collection assembly with a specimen label.

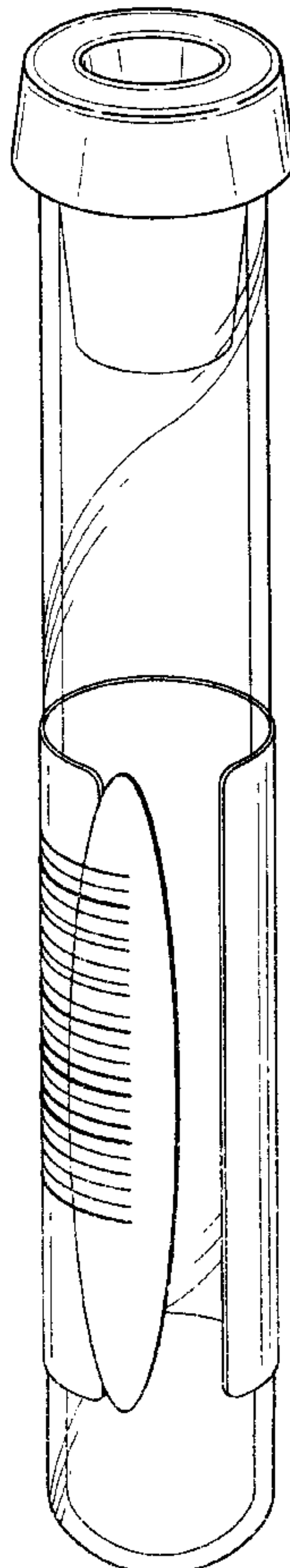

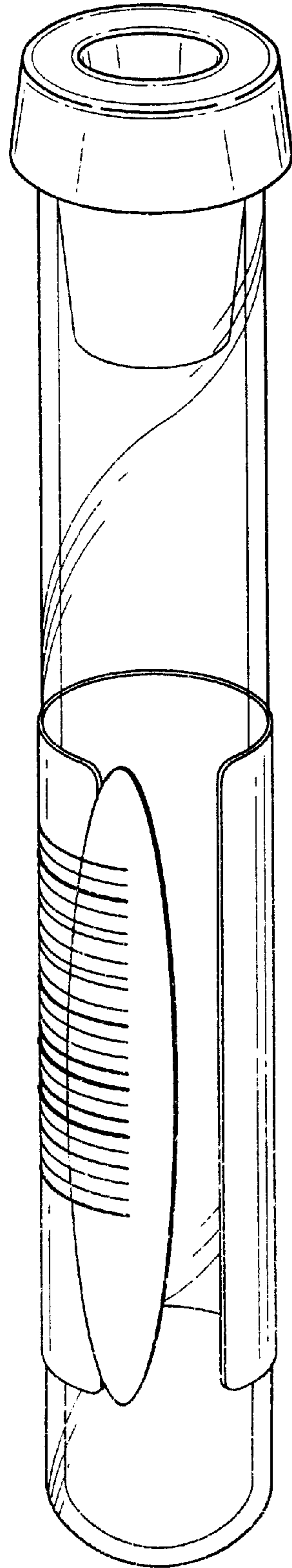

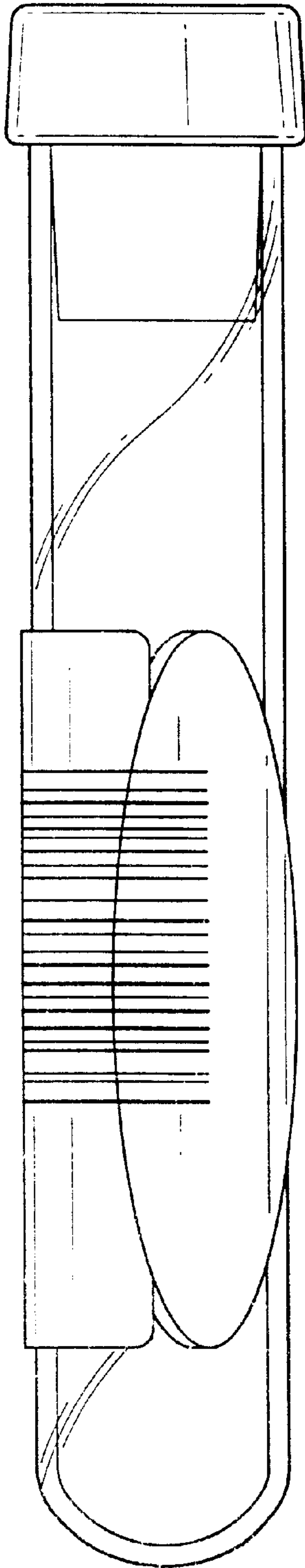

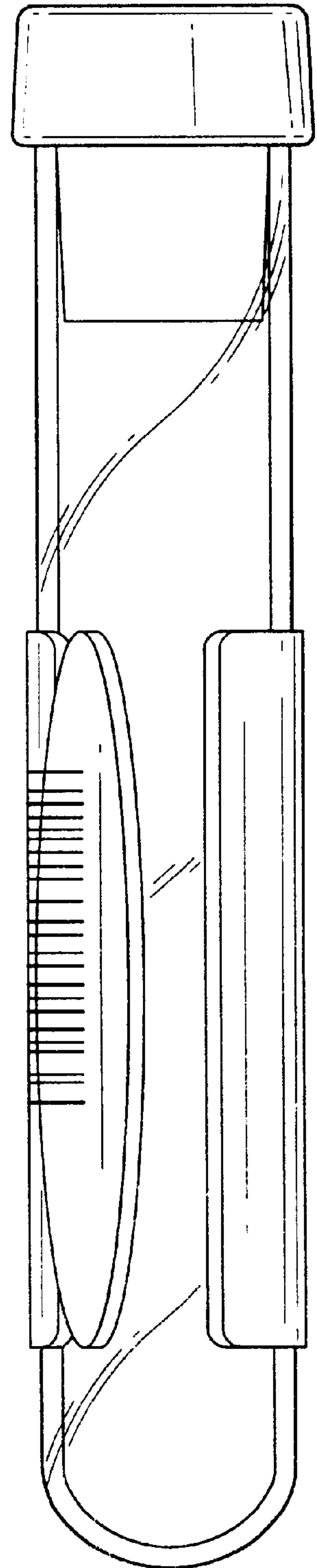

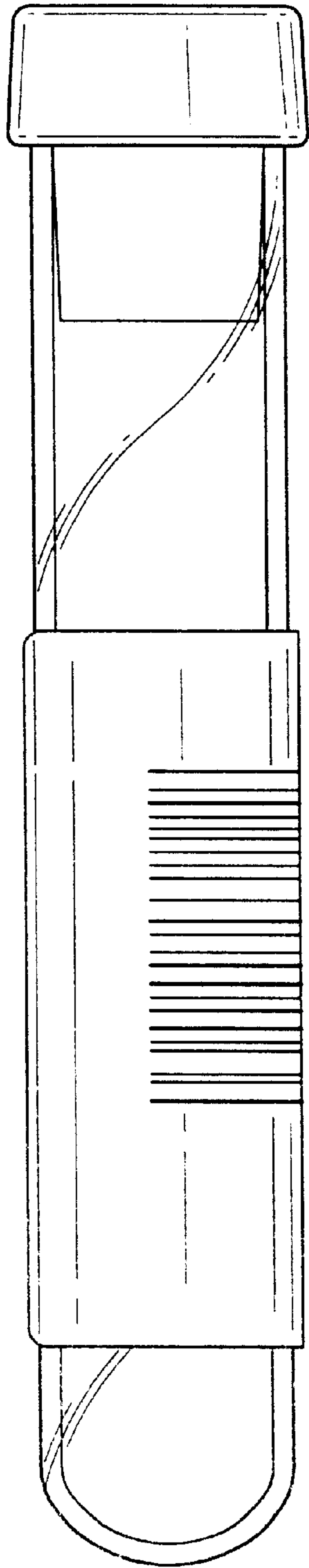

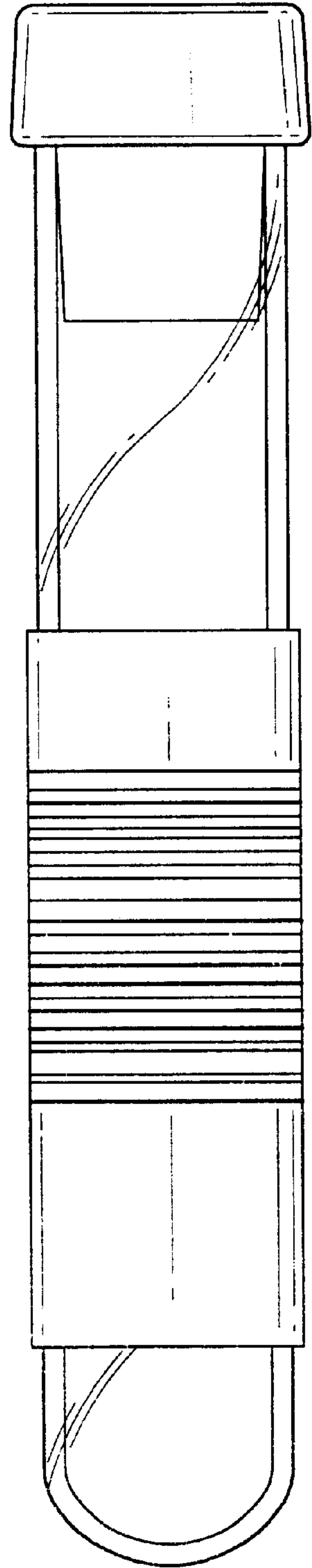

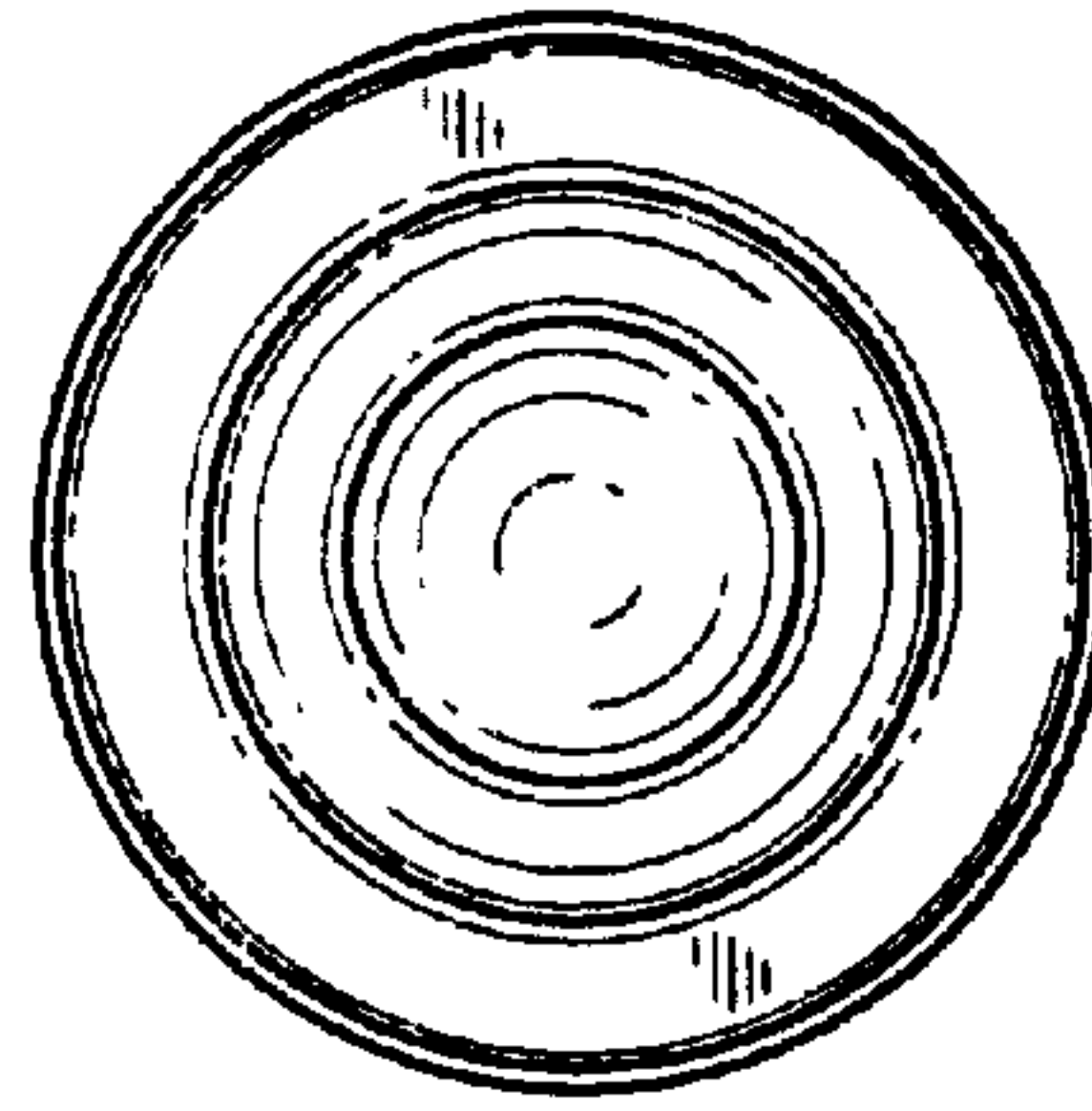
