[57] CLAIM

The ornamental design for a carrying case for a compact disc player and accessory items, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a carrying case for a compact disc player and accessory items showing my new design;

FIG. 2 is a rear elevation view of the invention illustrated in FIG. 1;

FIG. 3 is a right elevation view of the invention illustrated in FIG. 1;


FIG. 4 is a left elevation view of the invention illustrated in FIG. 1;












