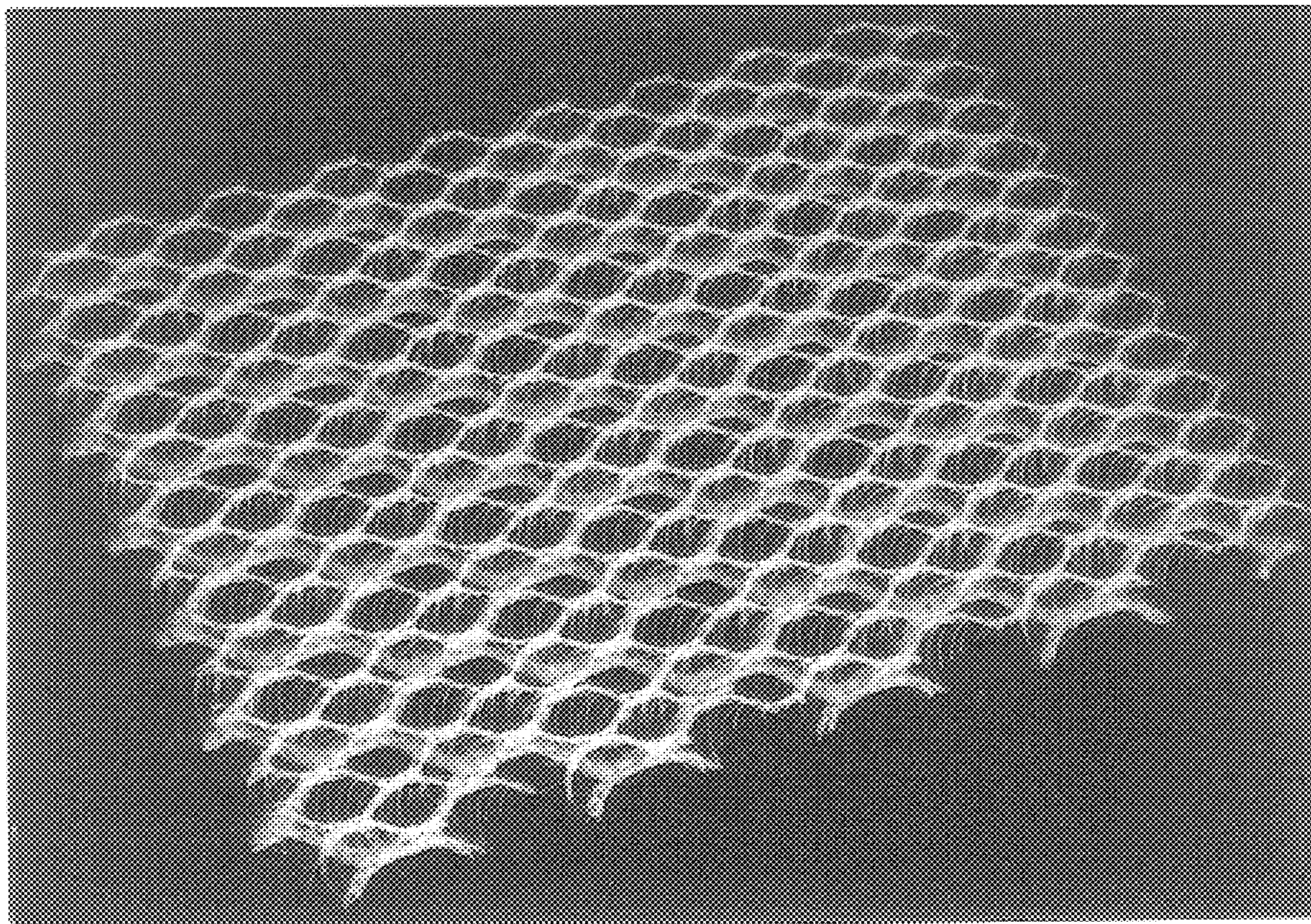
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a plan view of a three-dimensional net fabric;  
FIG. 2 is a bottom view thereof;

FIG. 5 is a front view thereof;

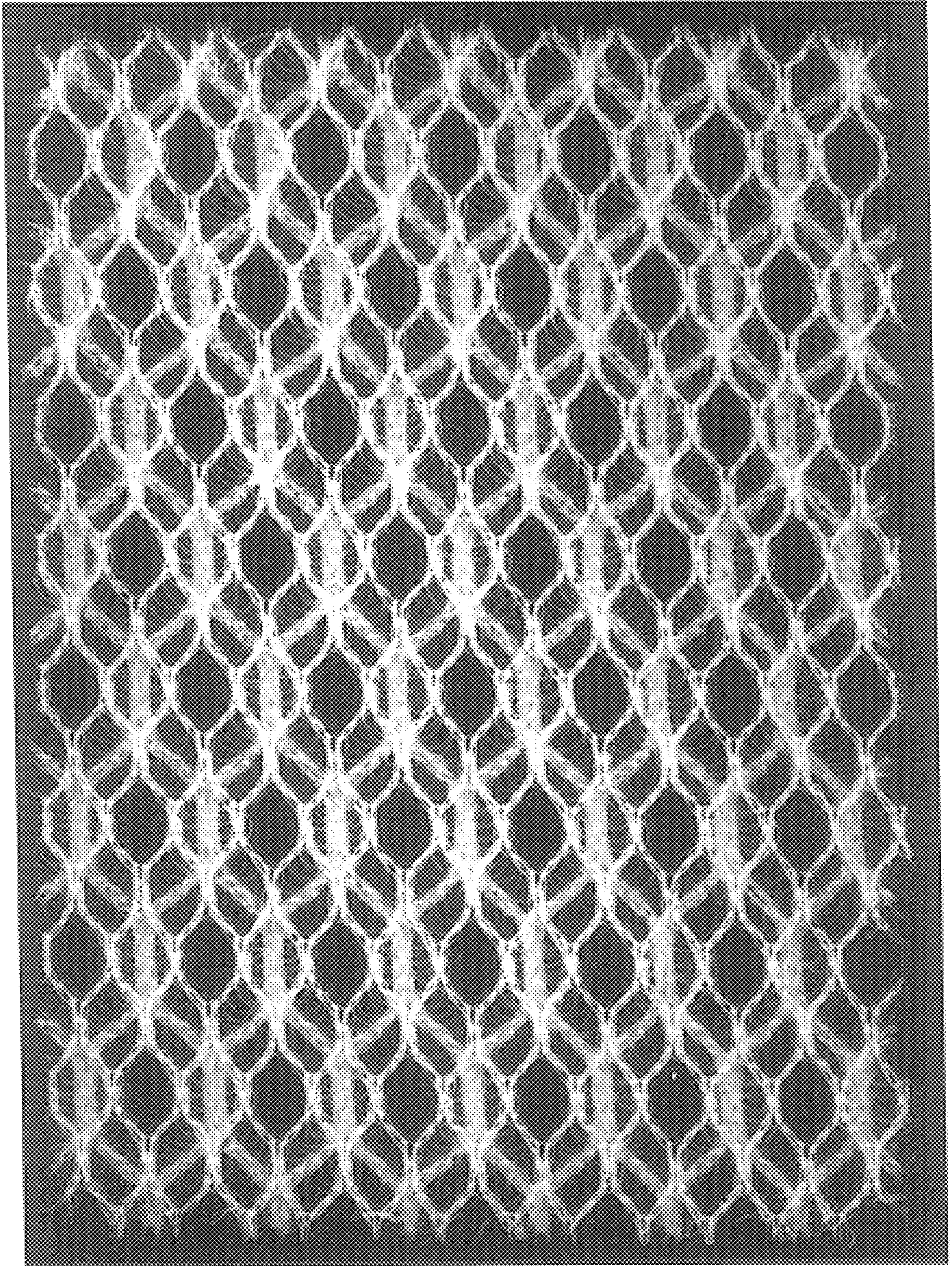

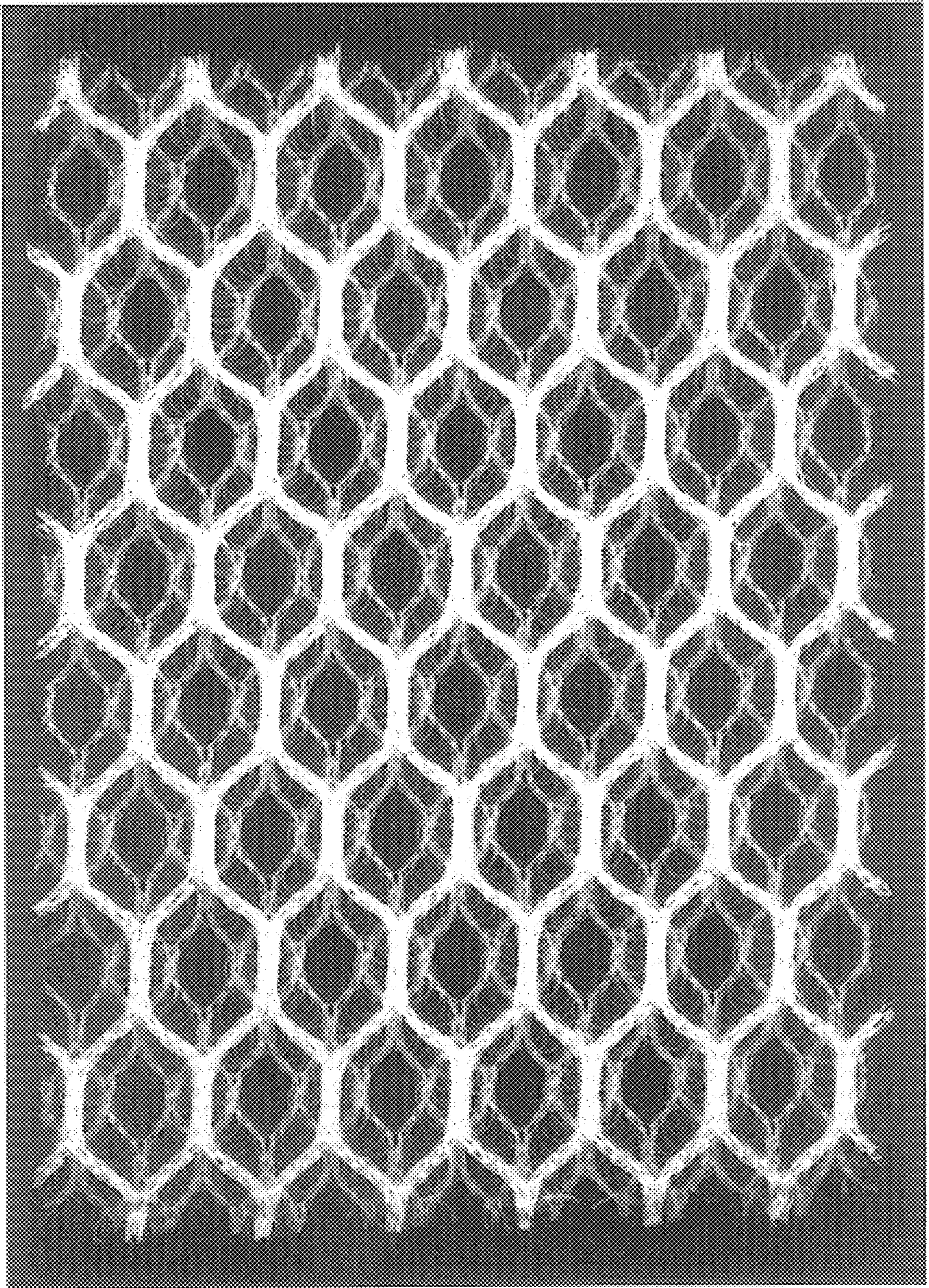

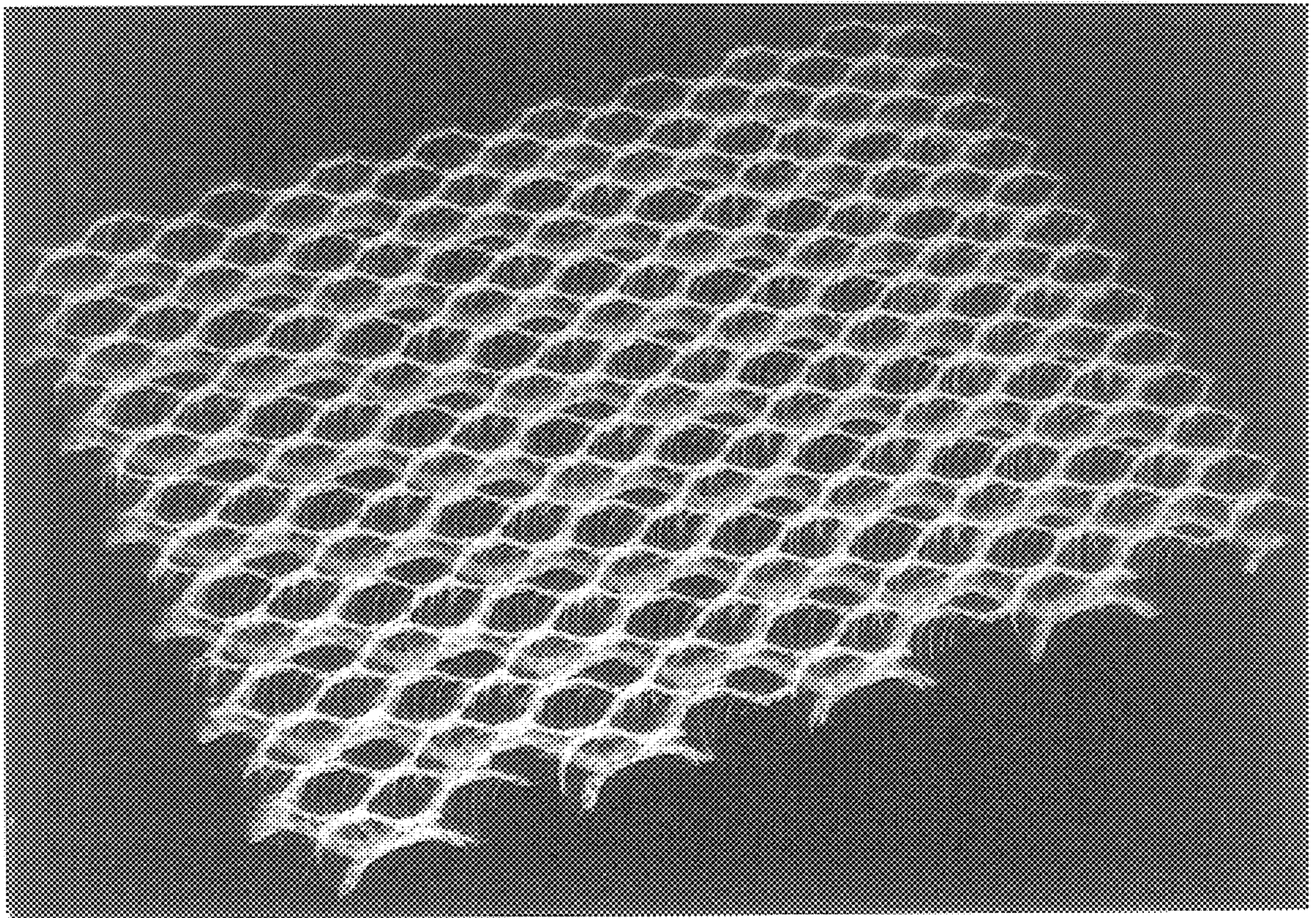

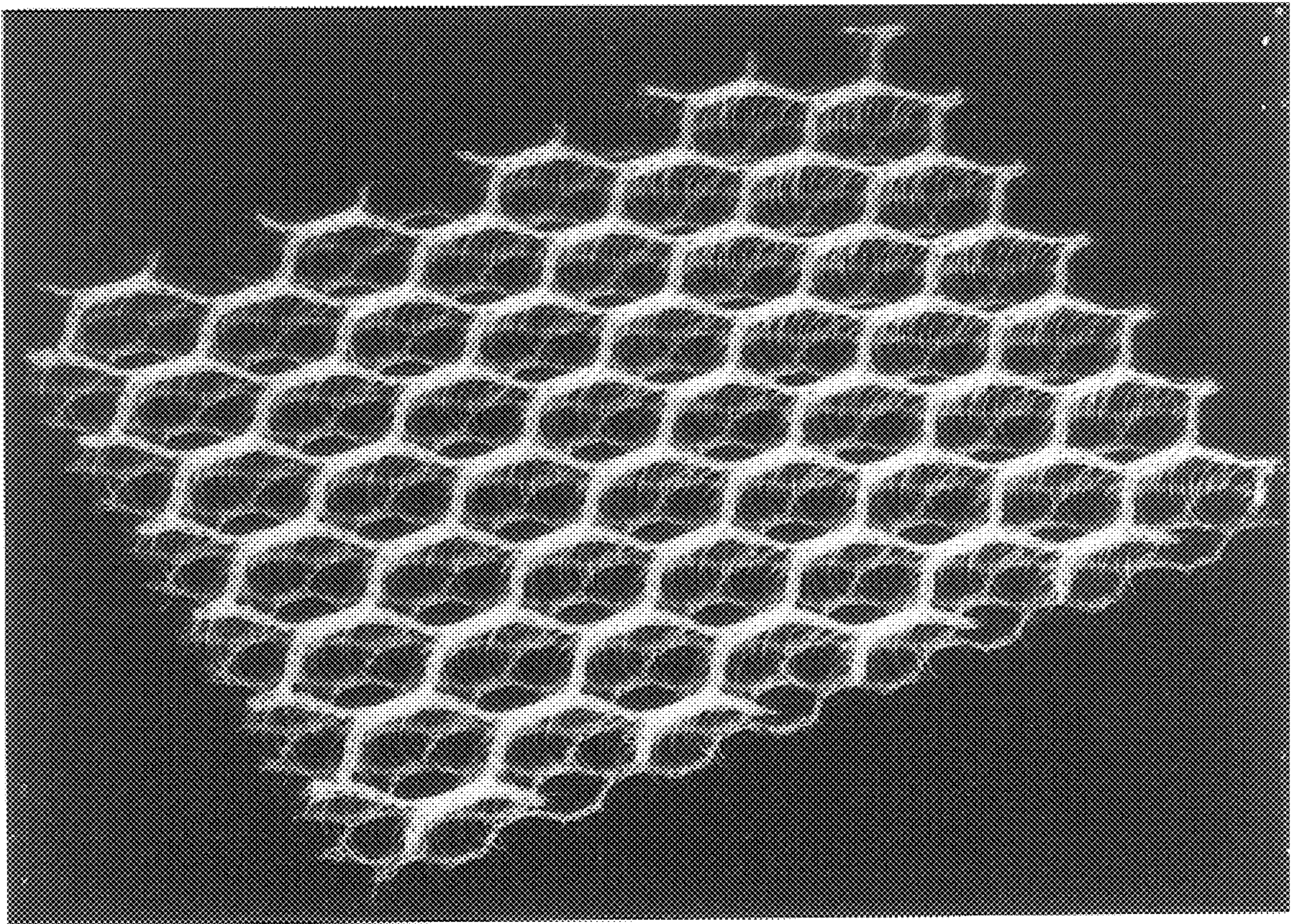

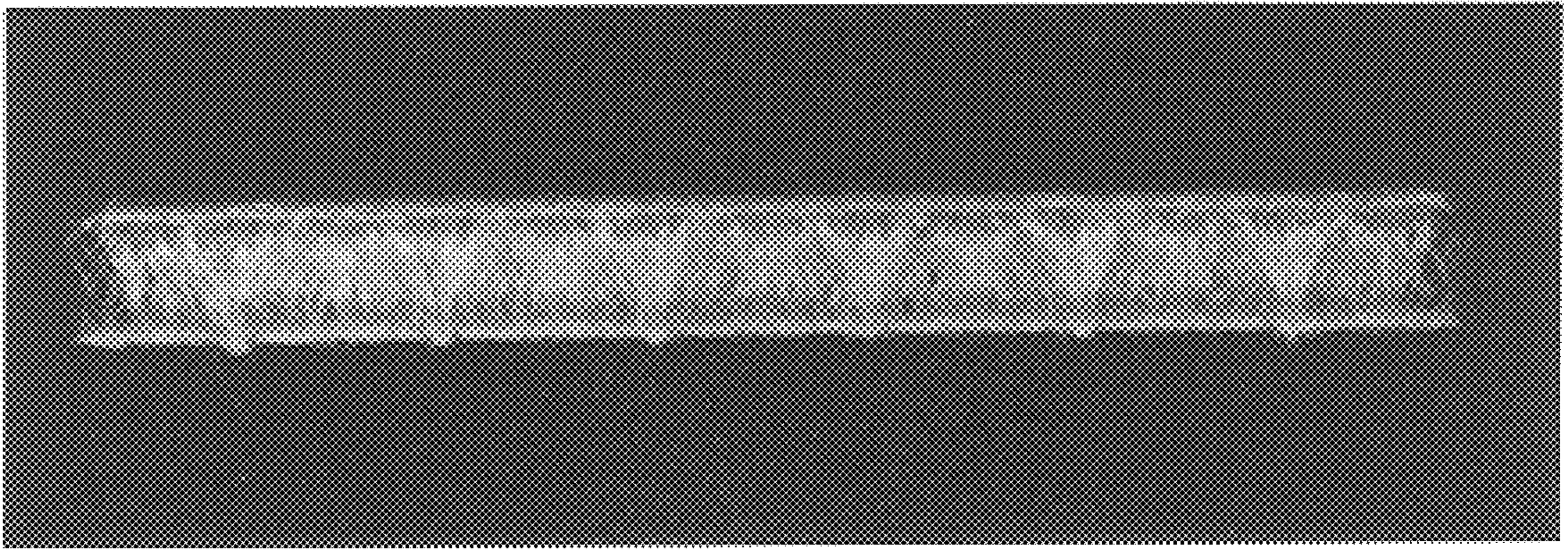

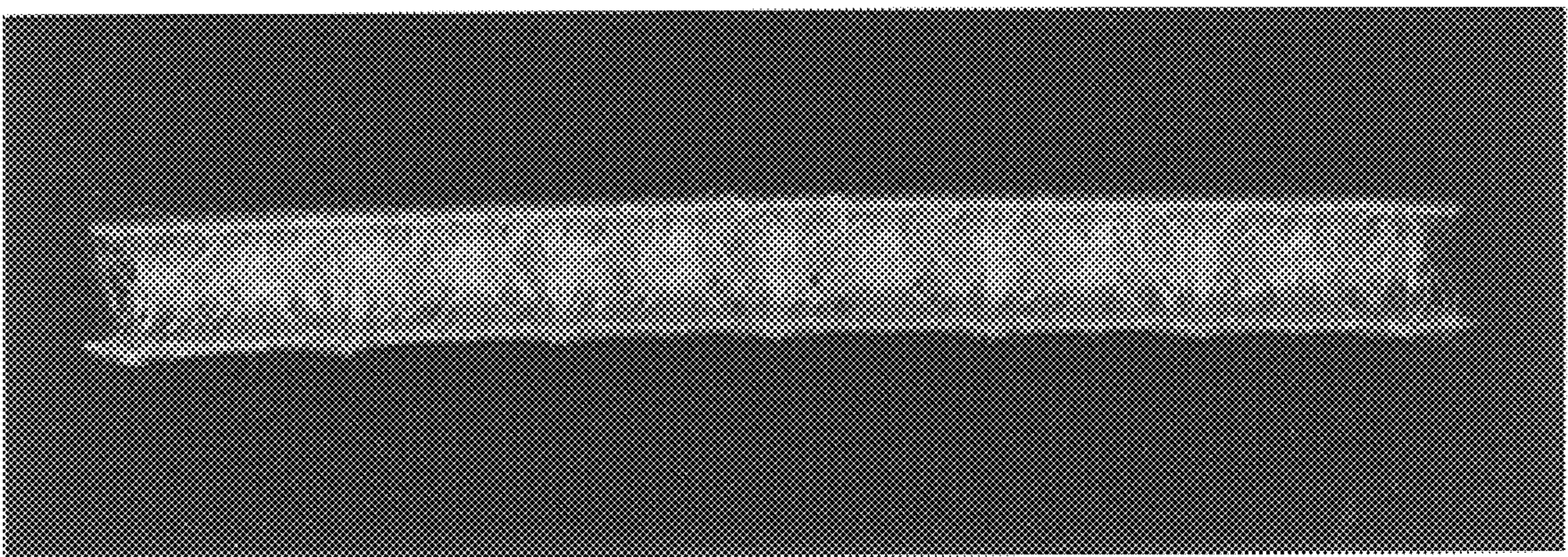

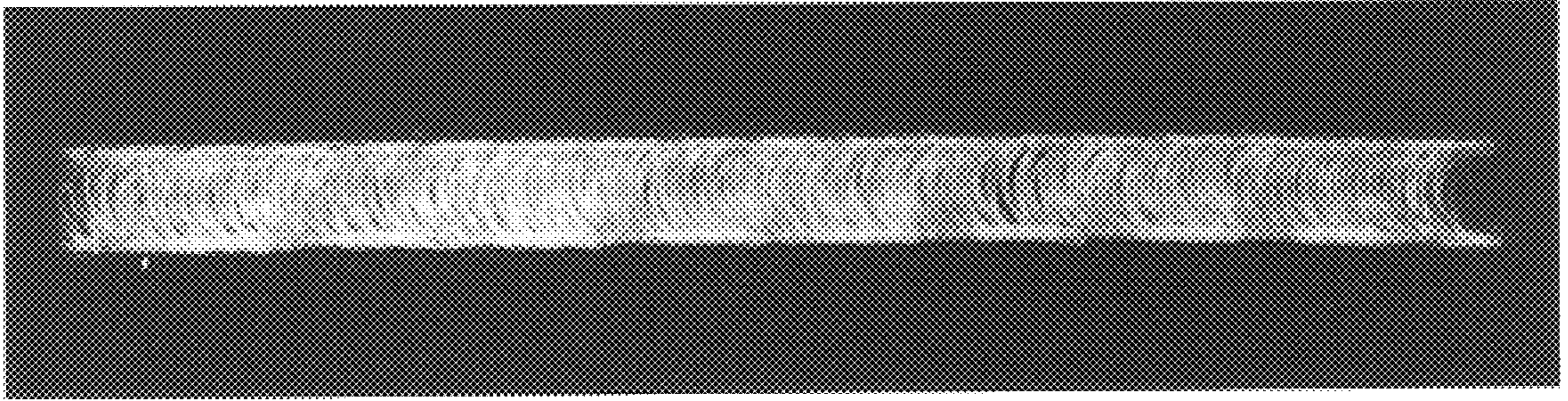

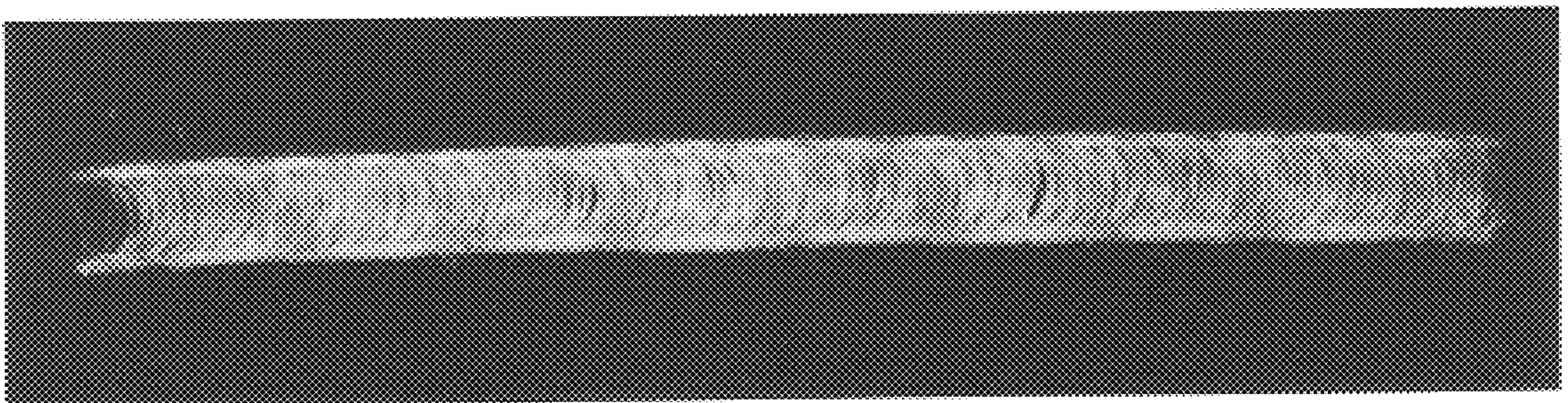
