FIG. 11 is a top plan view of a seat in the form of a loveseat.

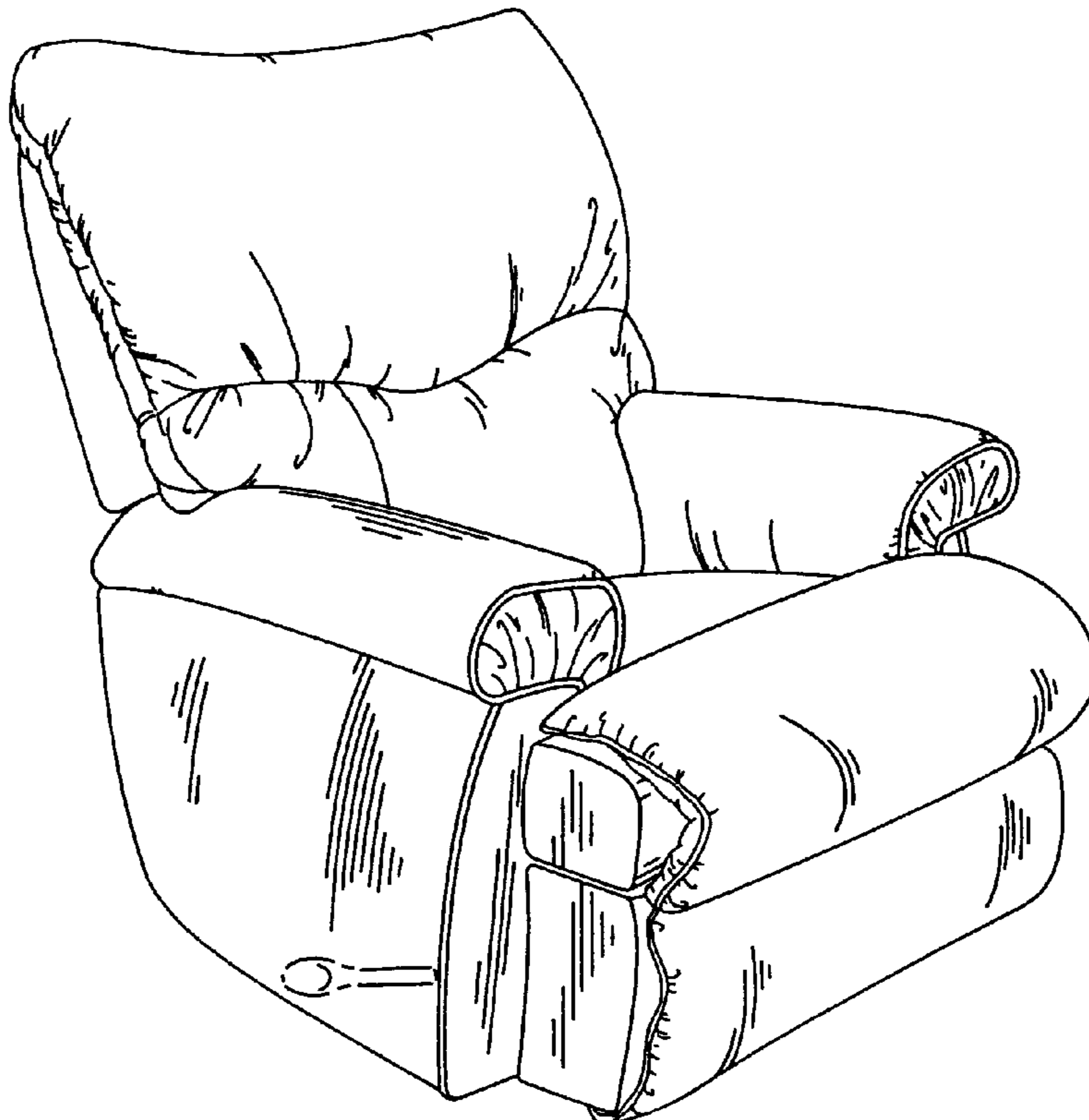
The side views of FIGS. 6 and 9 are like that shown in FIG. 5.

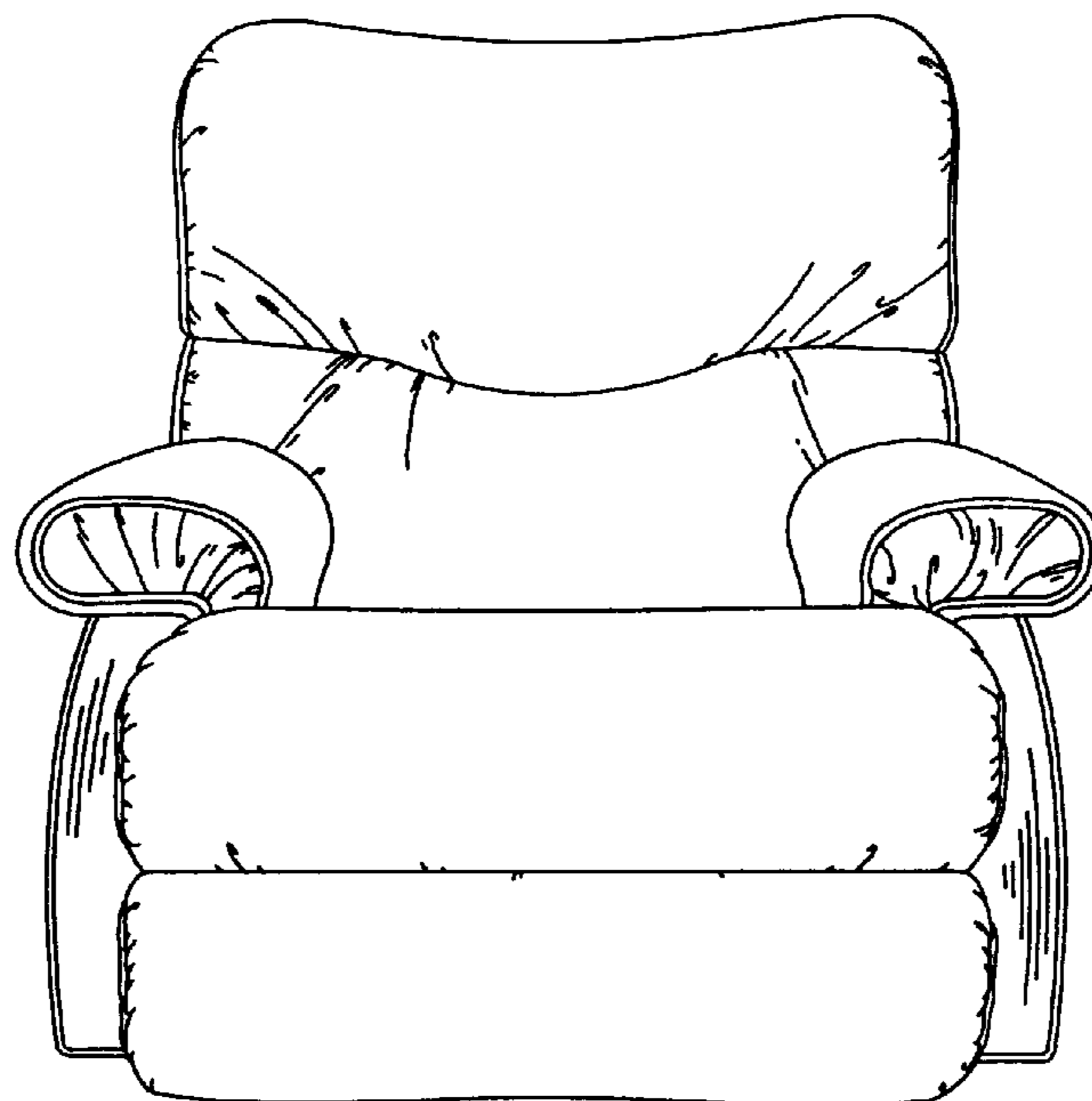
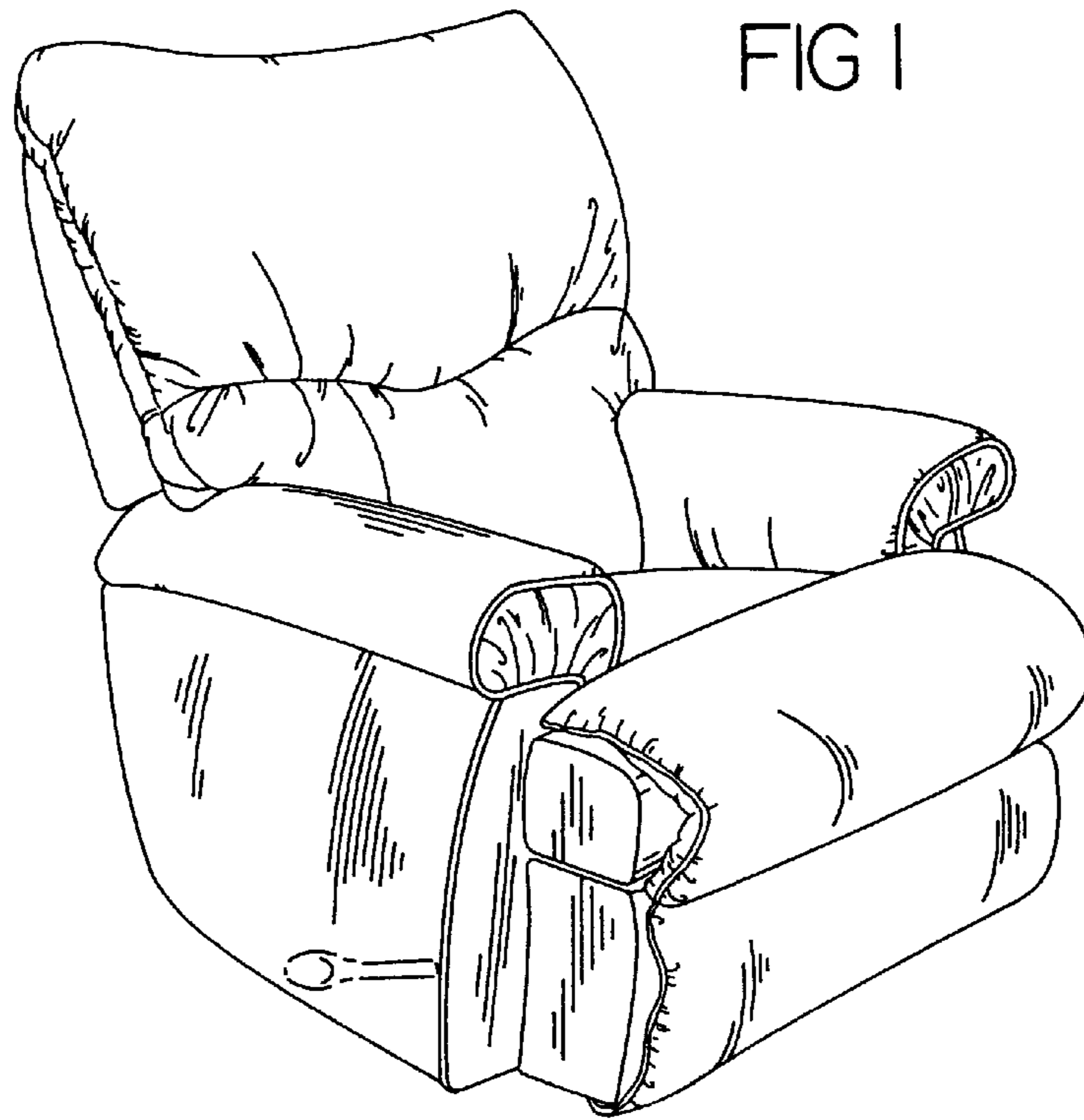

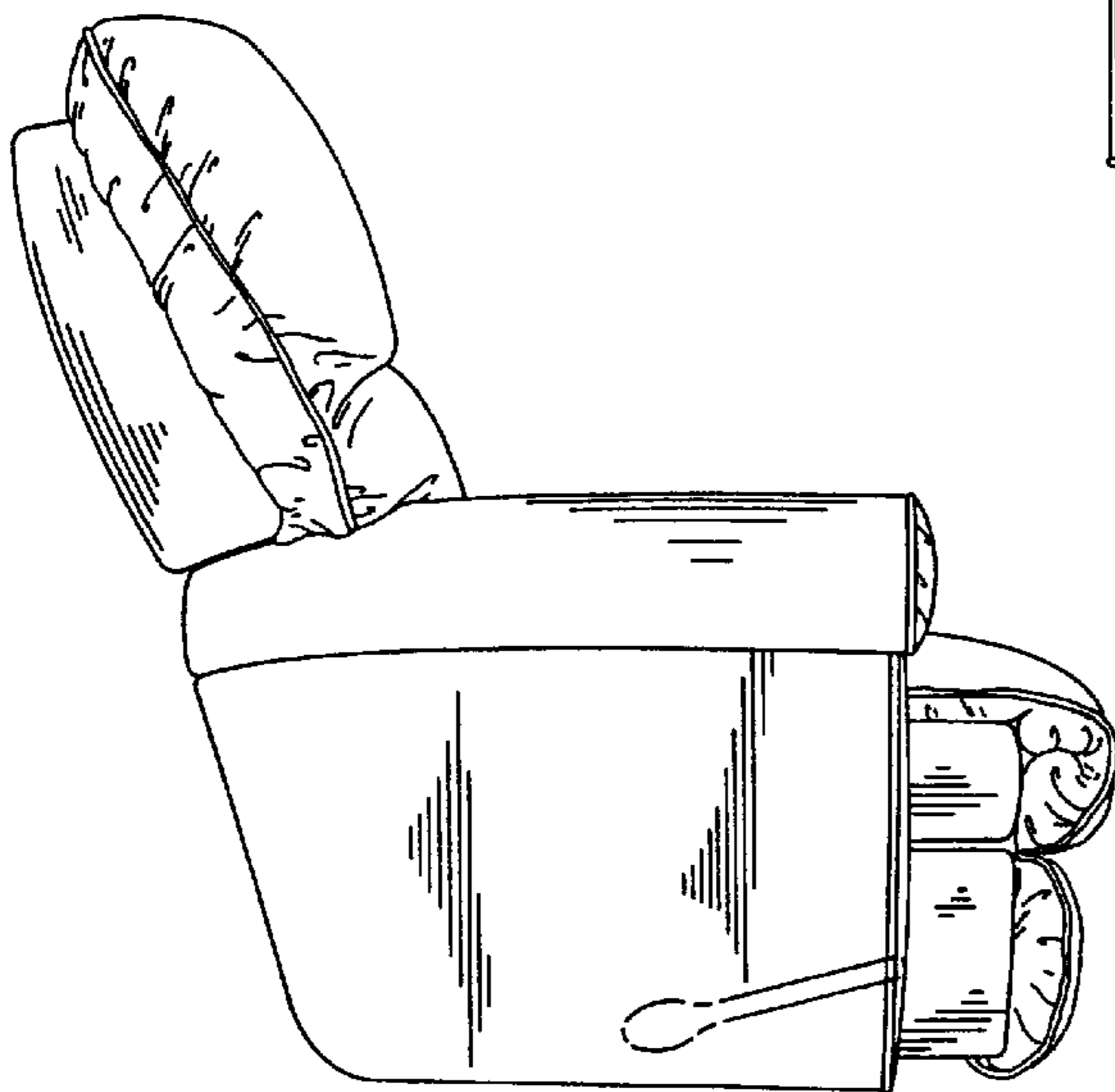
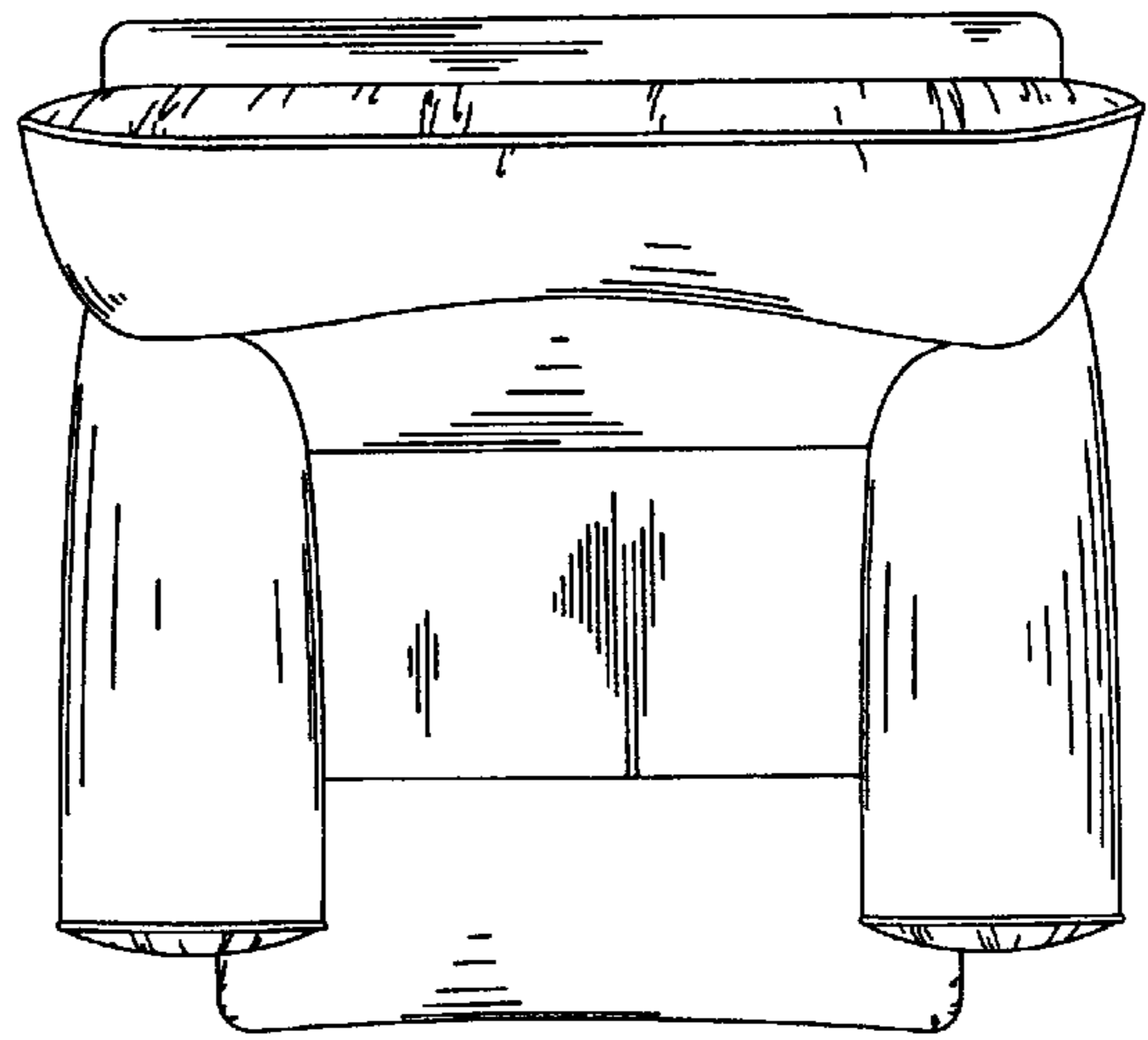

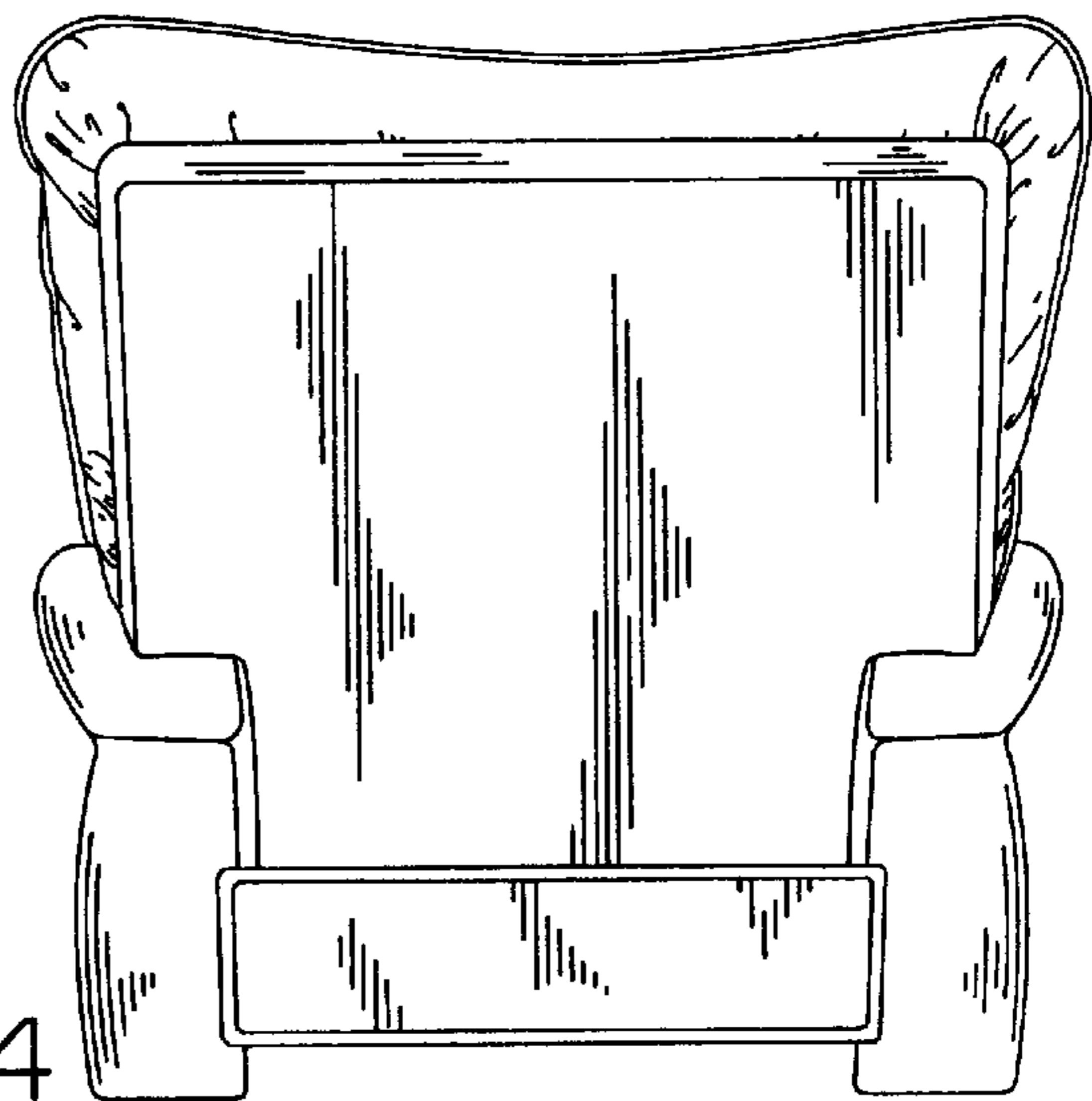

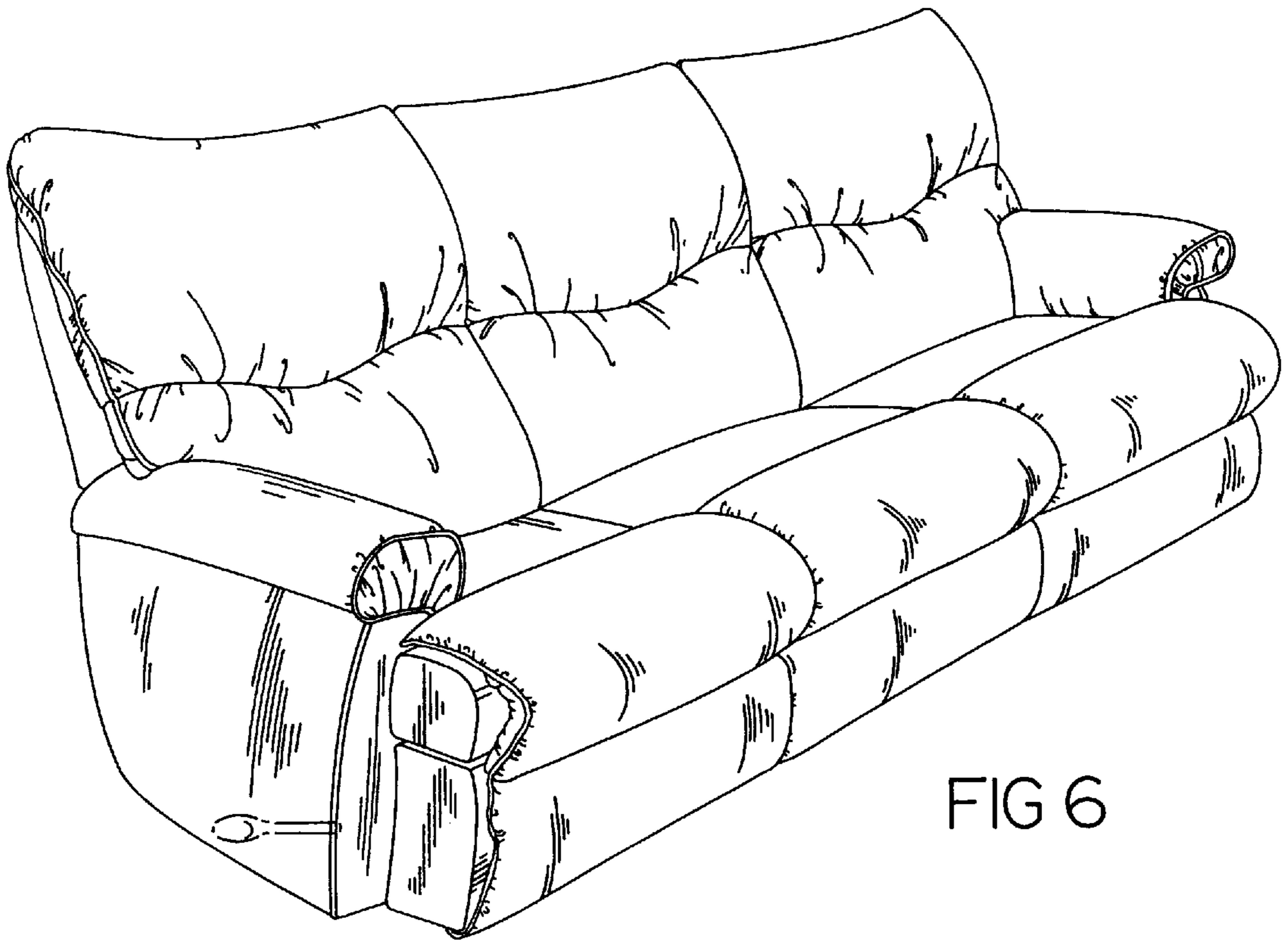
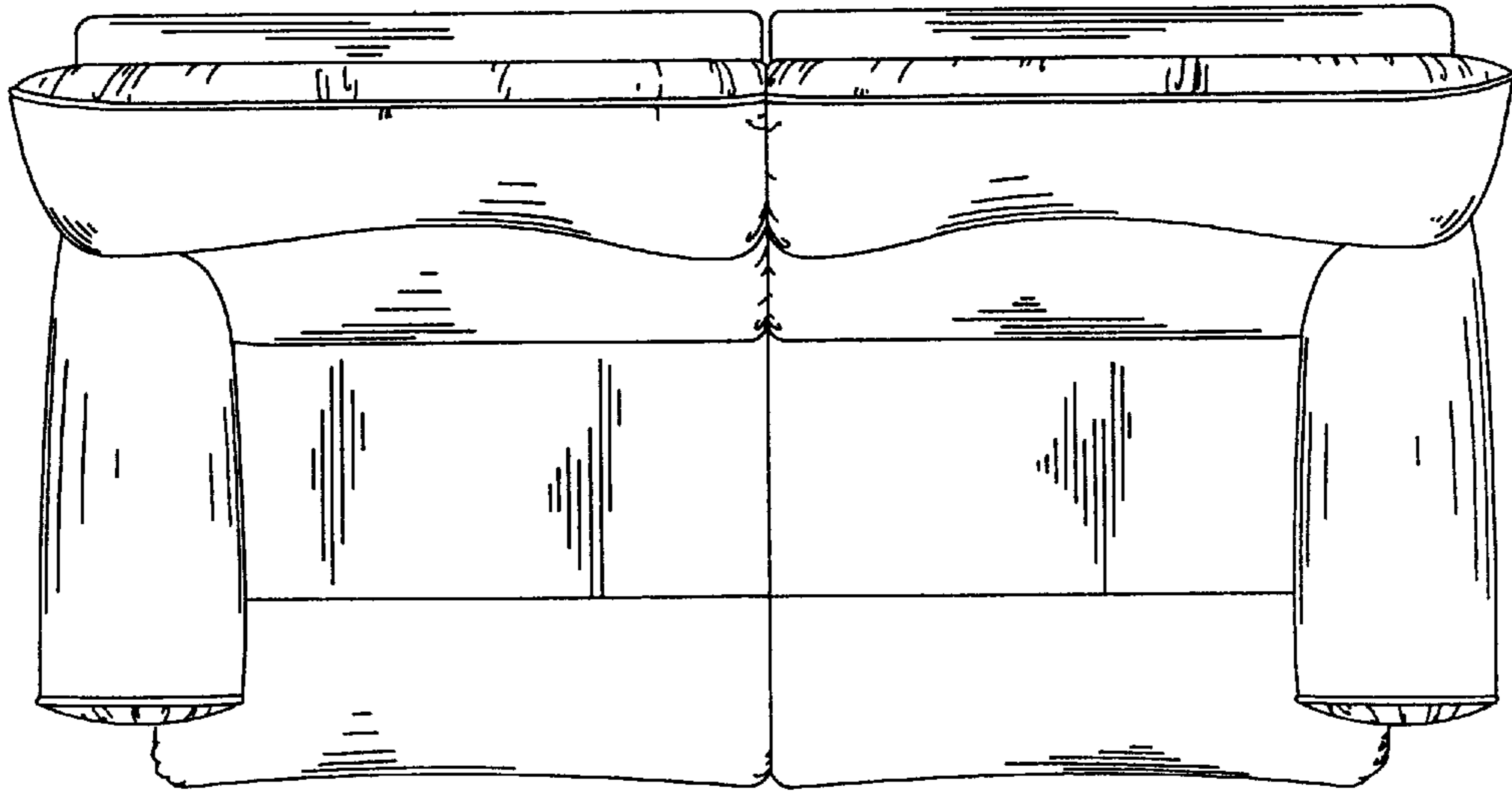

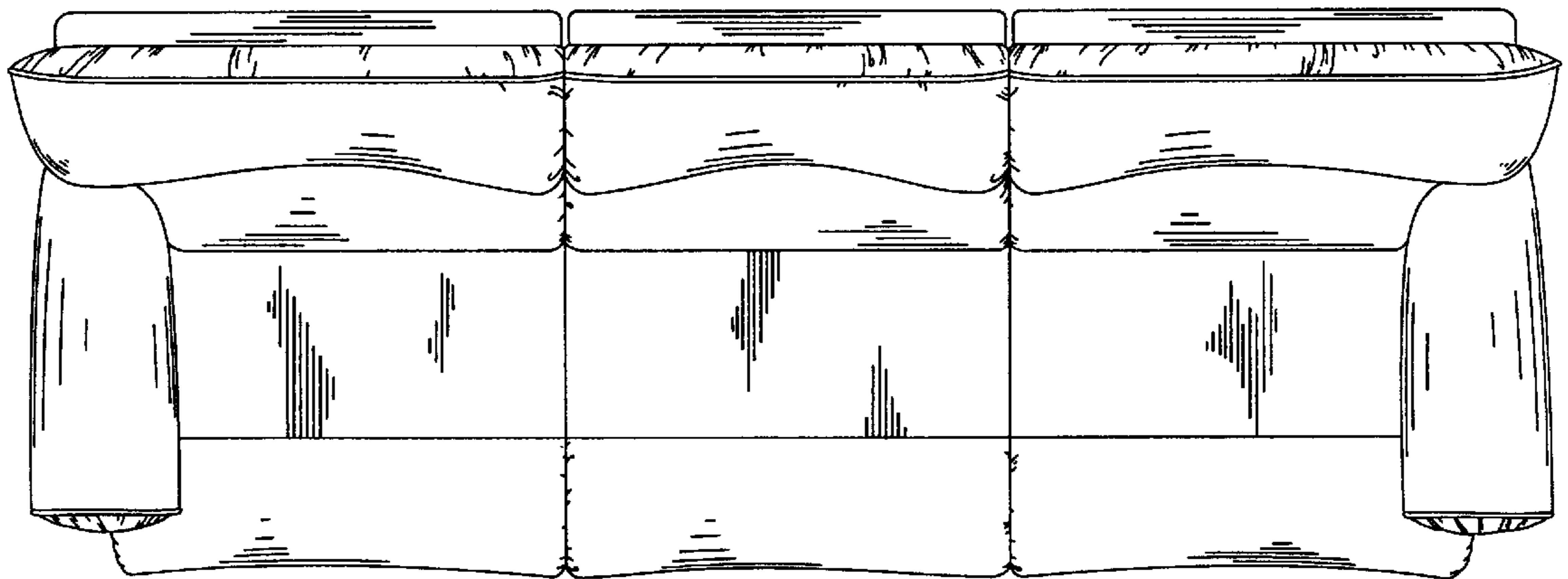
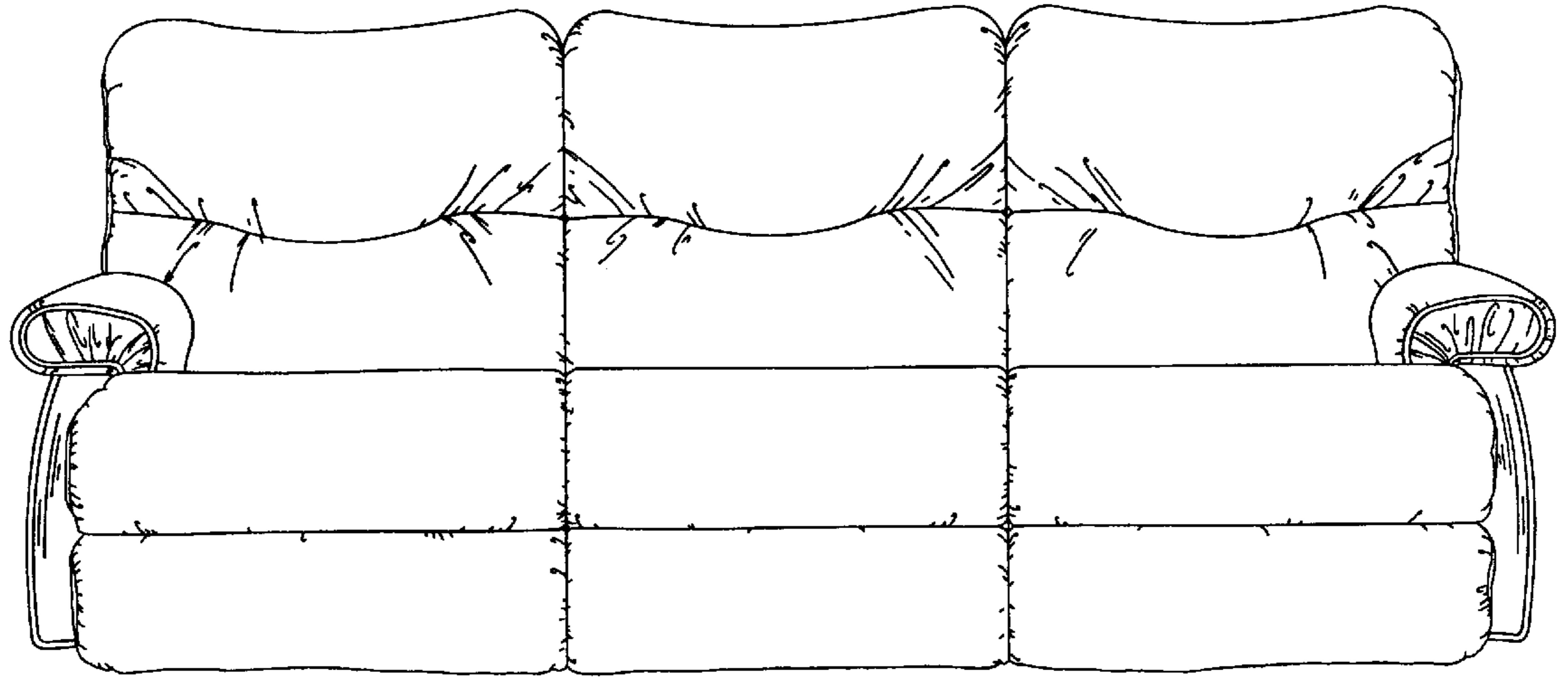

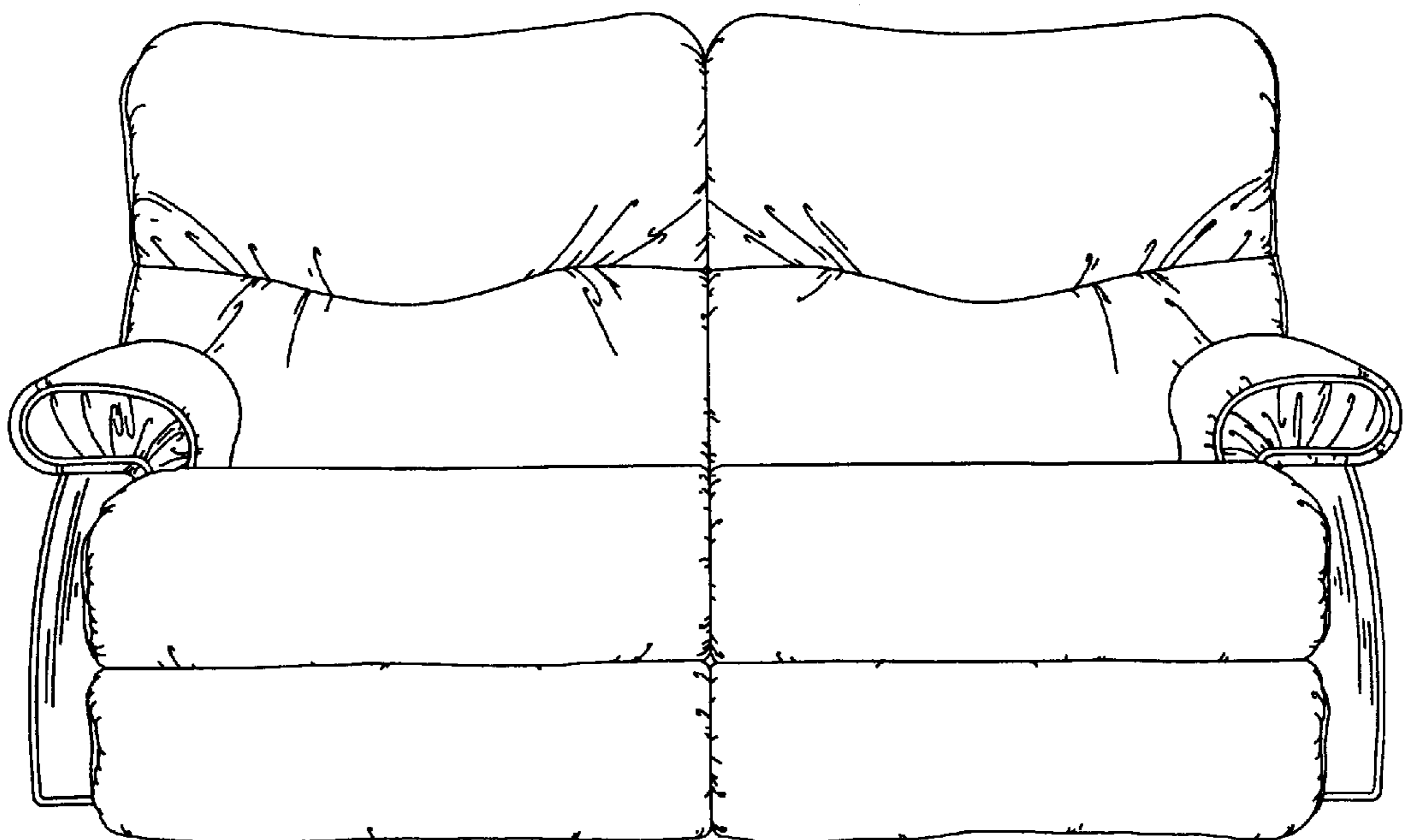
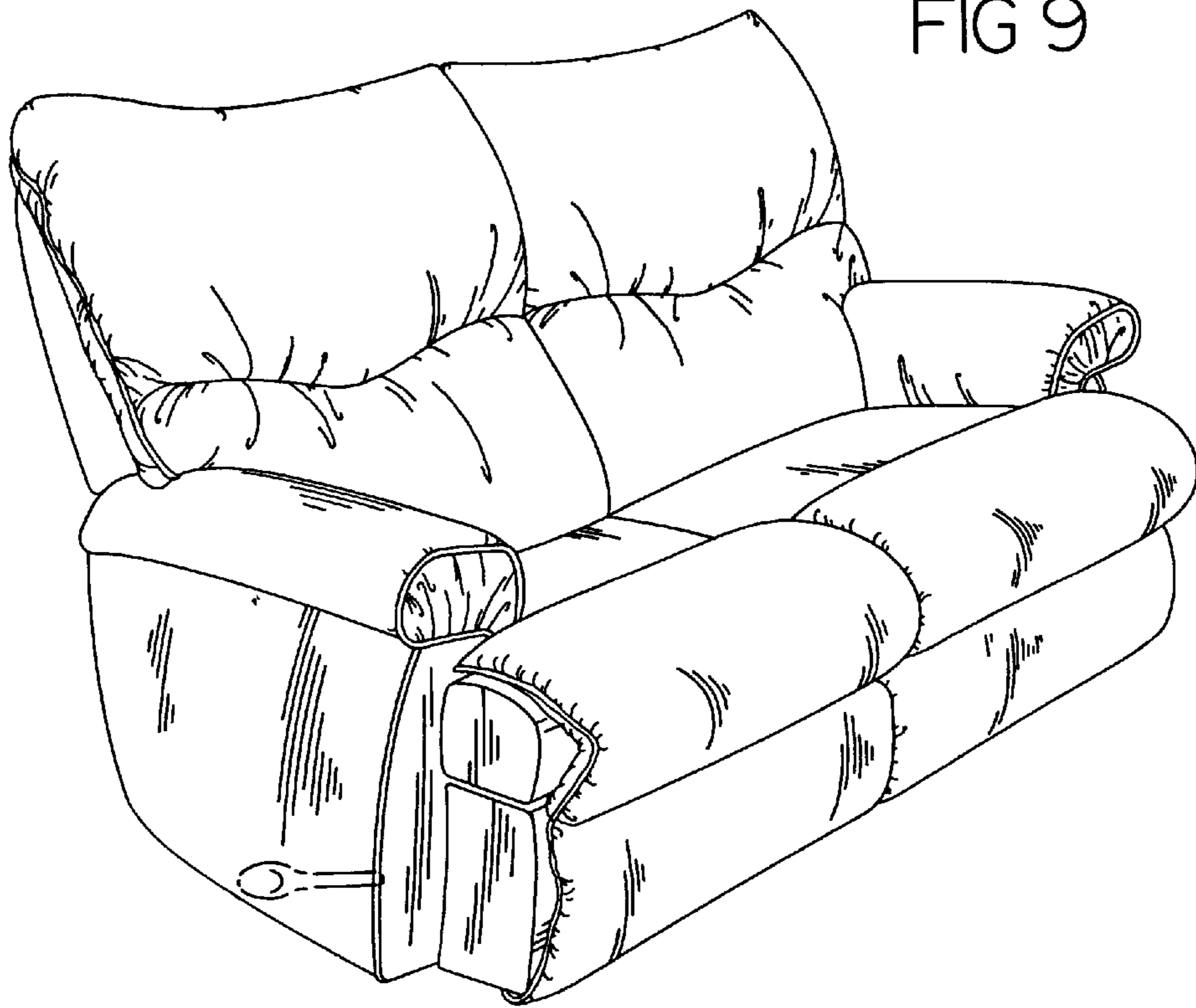
