DESCRIPTION

FIG. 1 is a top plan view of the support ring for cooking utensil;

FIG. 2 is a bottom plan view thereof;

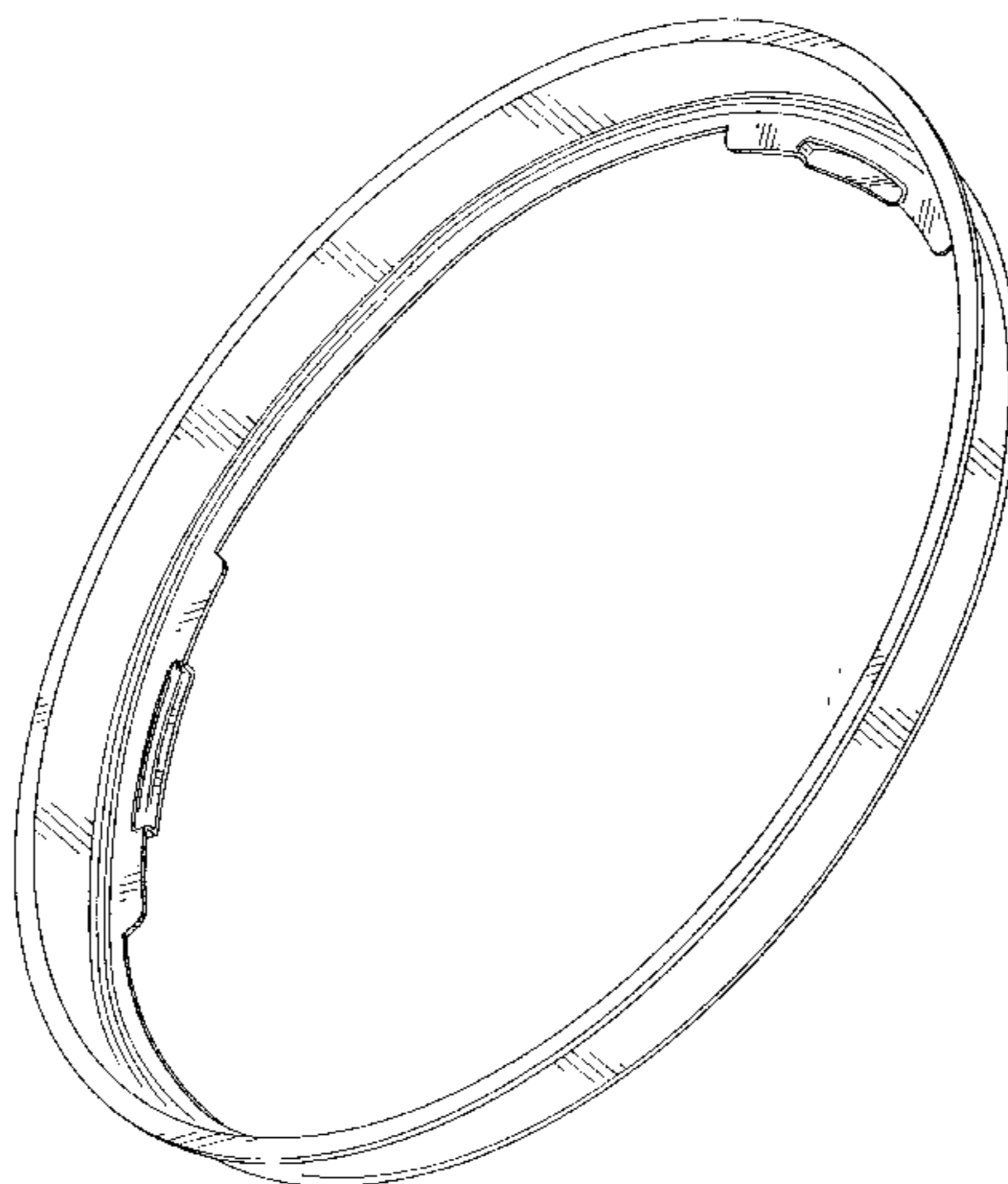
FIG. 3 is a right side elevational view thereof, the front, rear and left side elevational views being identical thereto;

FIG. 4 is a bottom perspective view thereof;

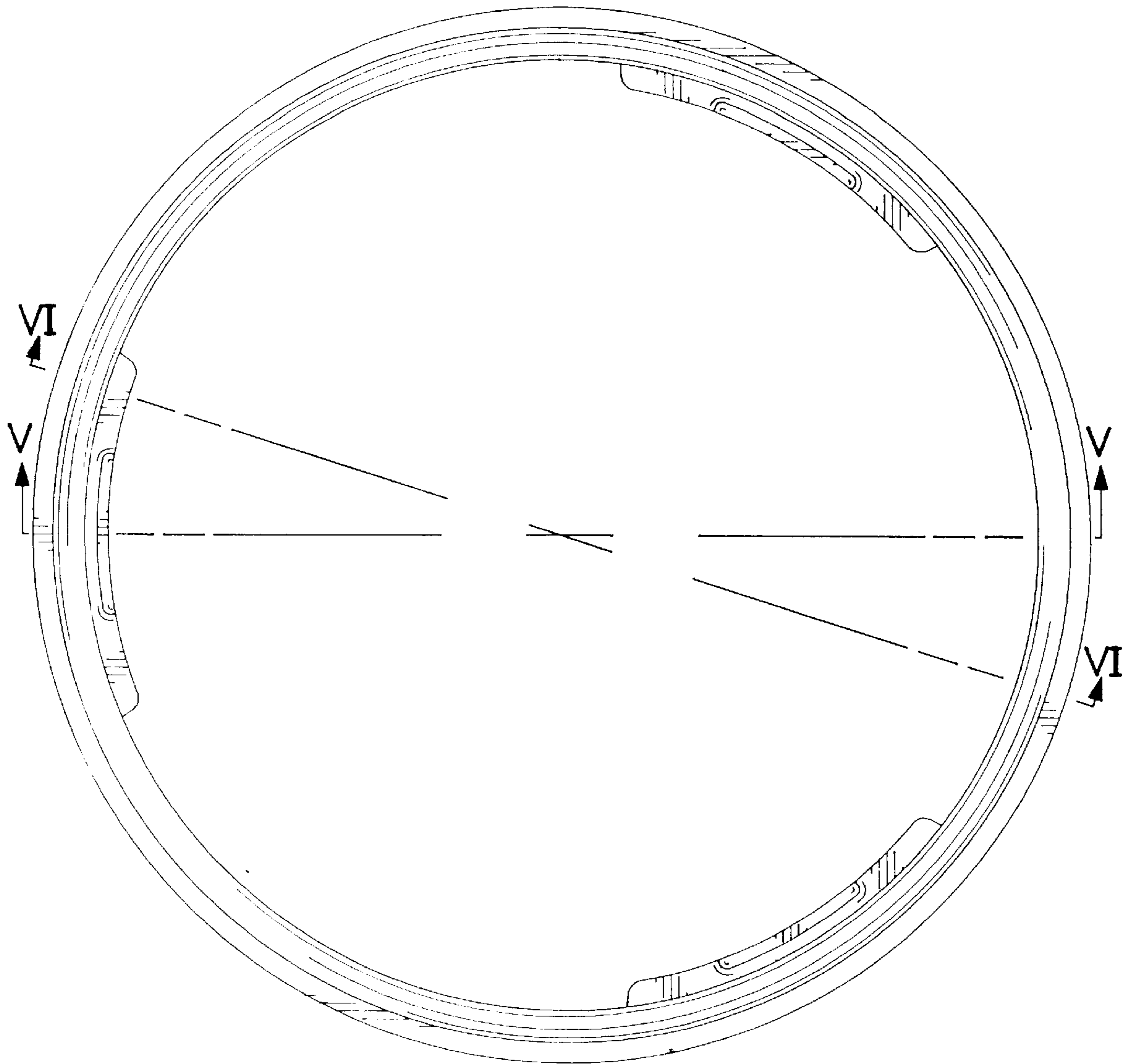

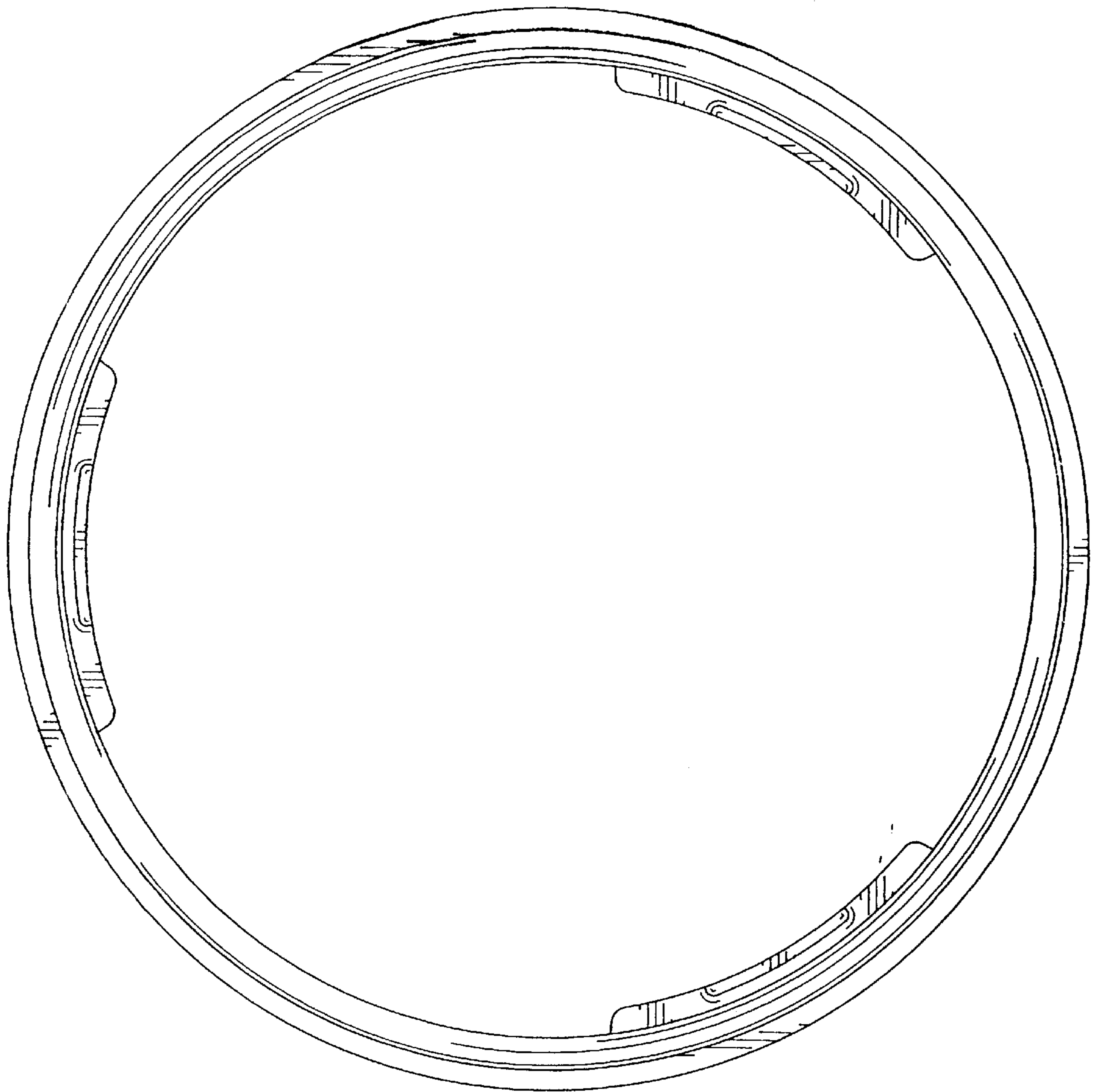

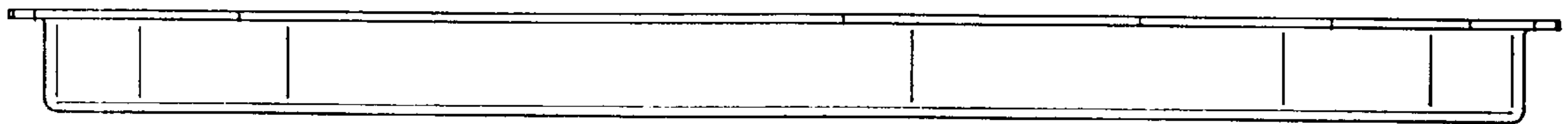

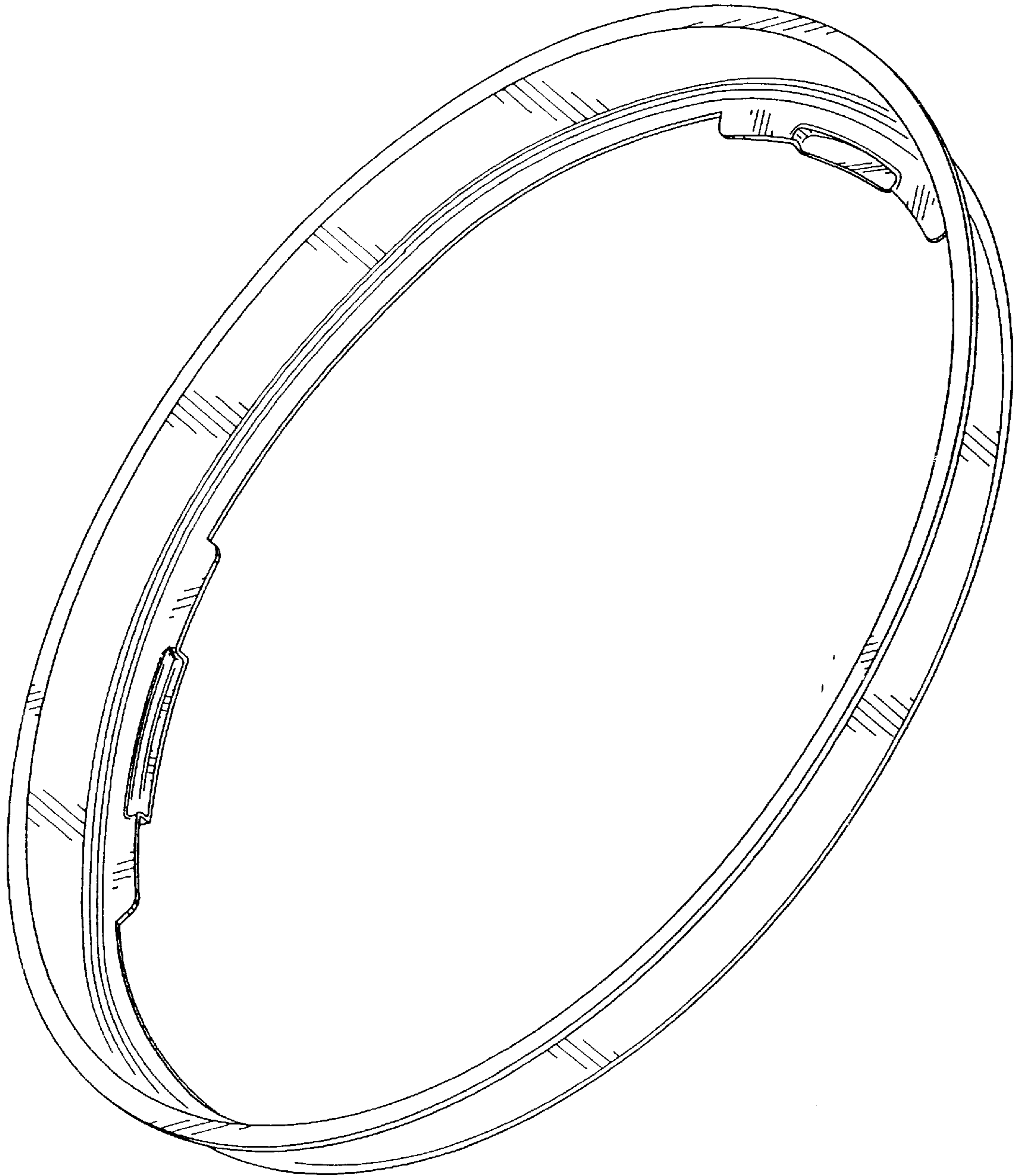

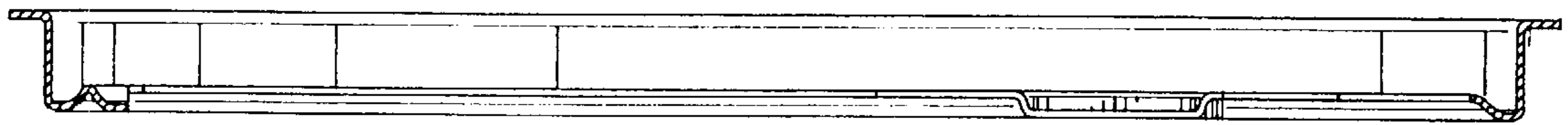

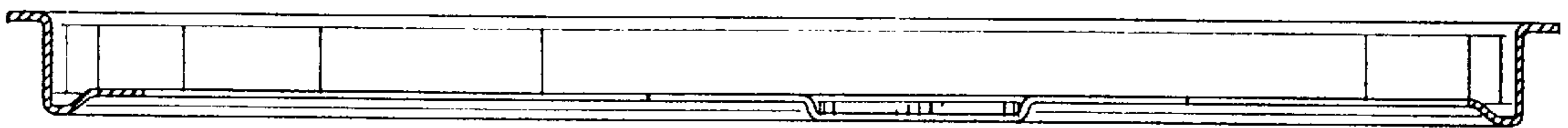
