[57] **CLAIM**

The ornamental design for a boat cleat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a boat cleat, taken from an interior side thereof, showing my new design;
FIG. 2 is a perspective view, taken from an exterior side thereof;
FIG. 3 is a top plan view shown on an enlarged scale;
FIG. 4 is a bottom plan view shown on an enlarged scale;
FIG. 5 is a side elevational view shown on an enlarged scale, taken from the interior side thereof;
FIG. 6 is side elevational view shown on an enlarged scale; taken from the exterior side thereof; and,
FIG. 7 is an end elevational view shown on an enlarged scale thereof.

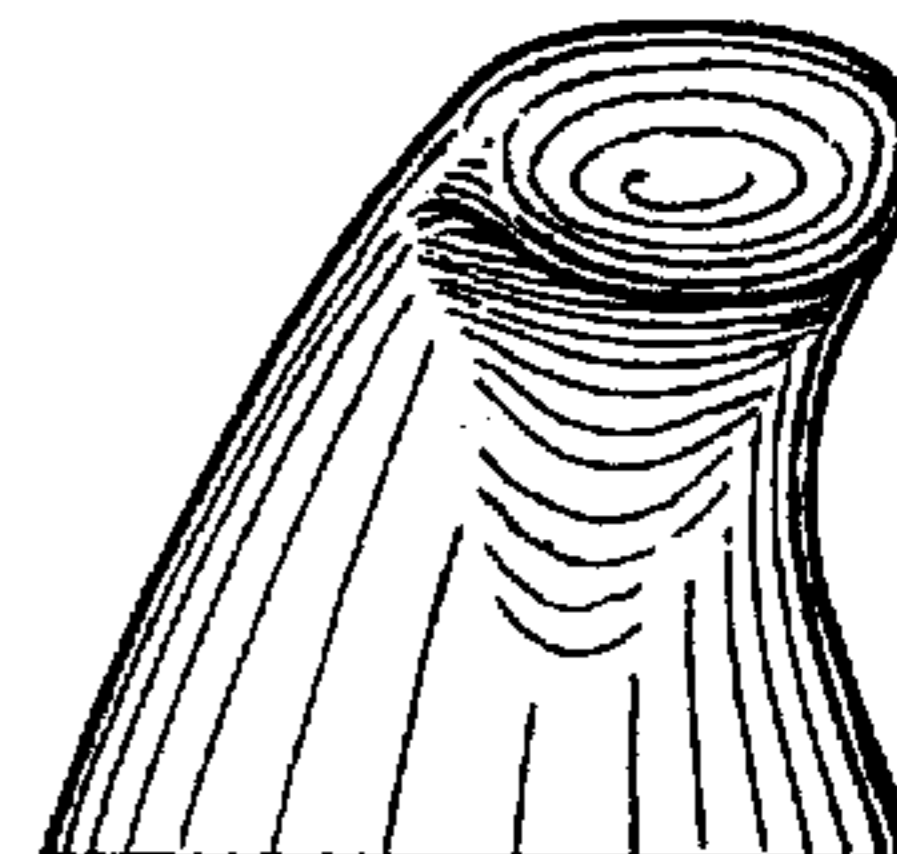
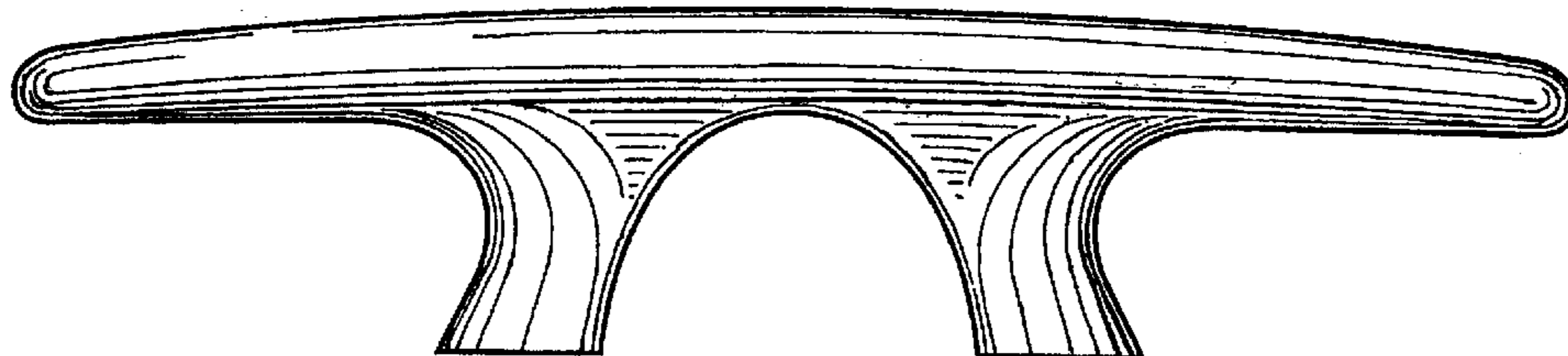

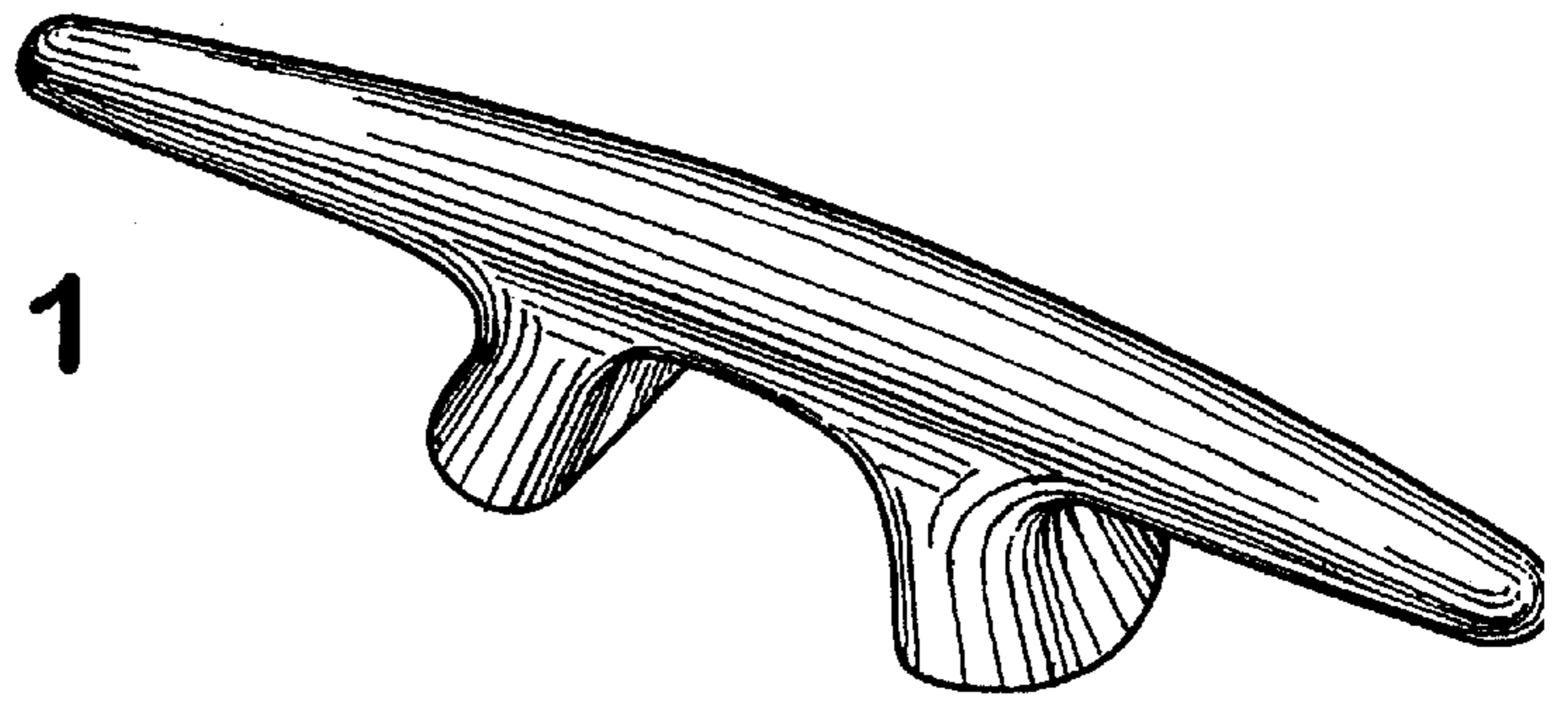

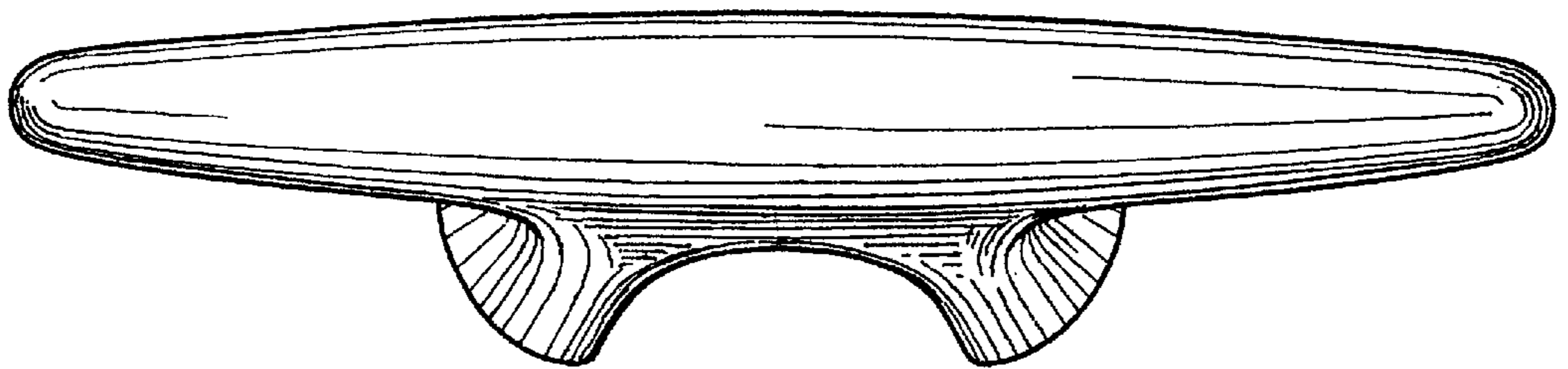
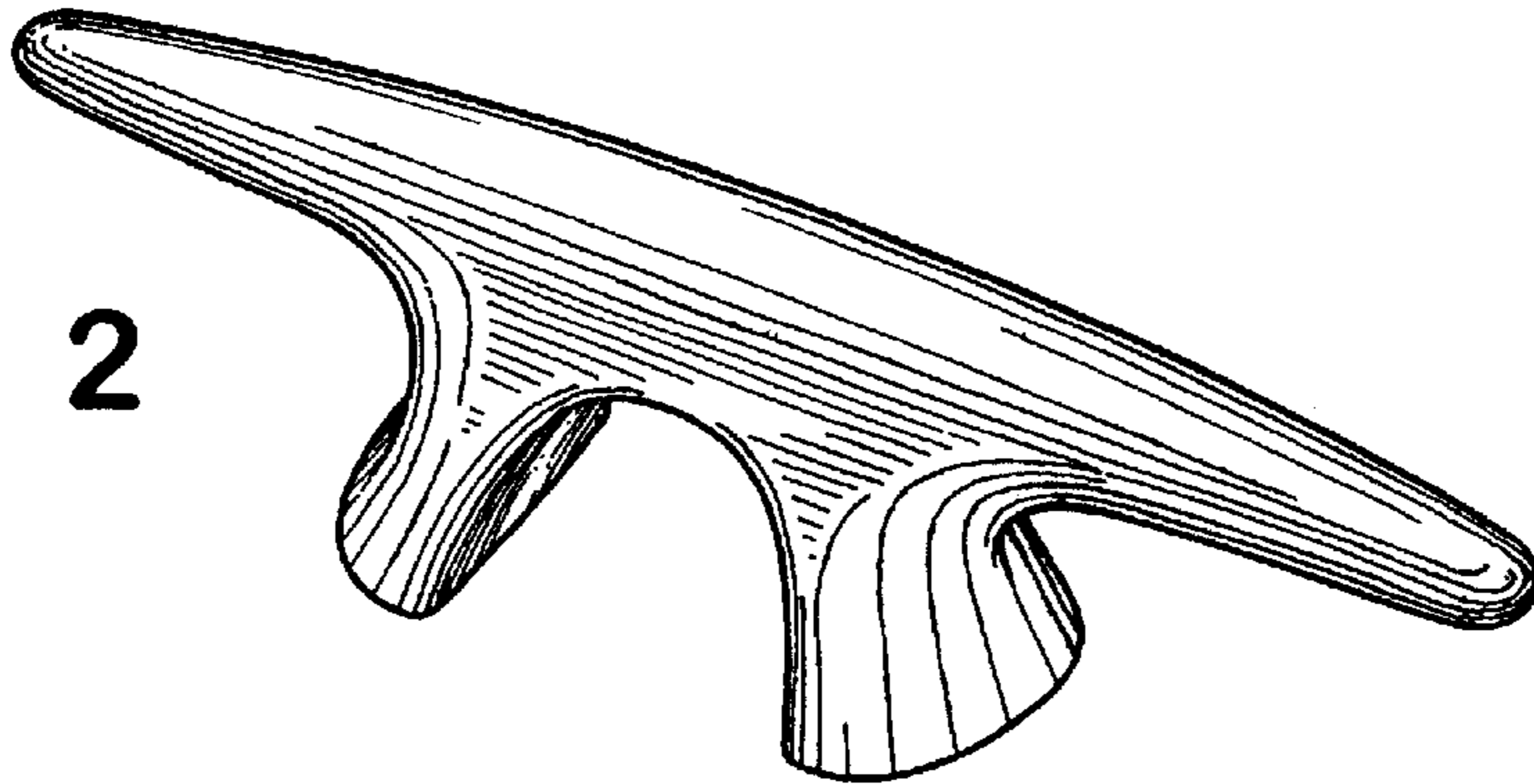

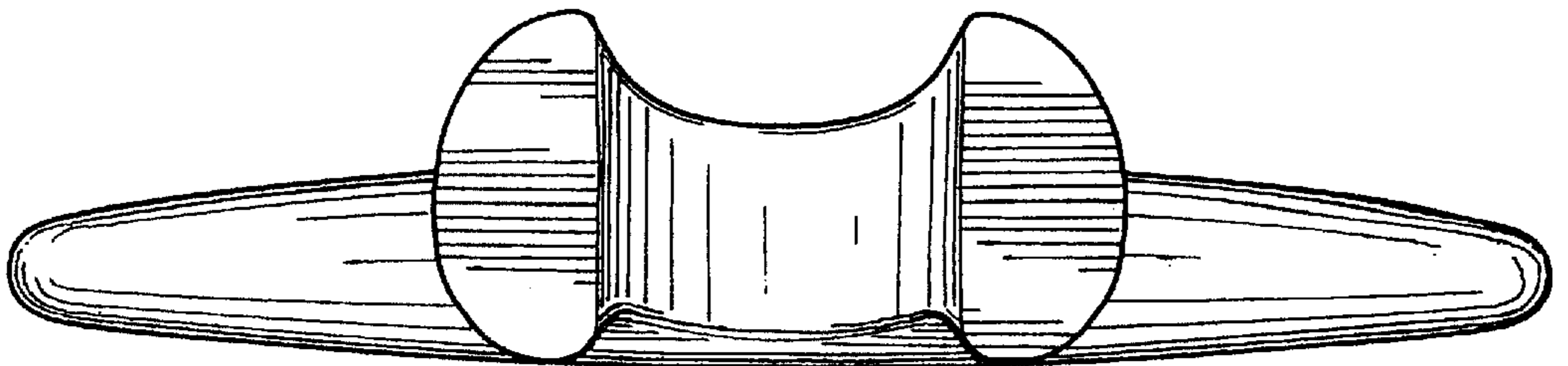

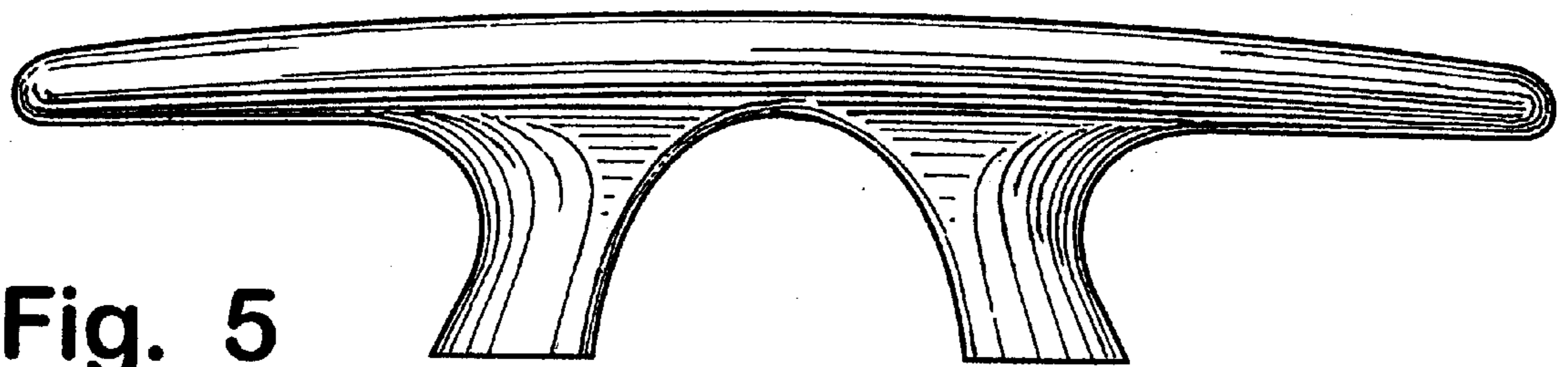

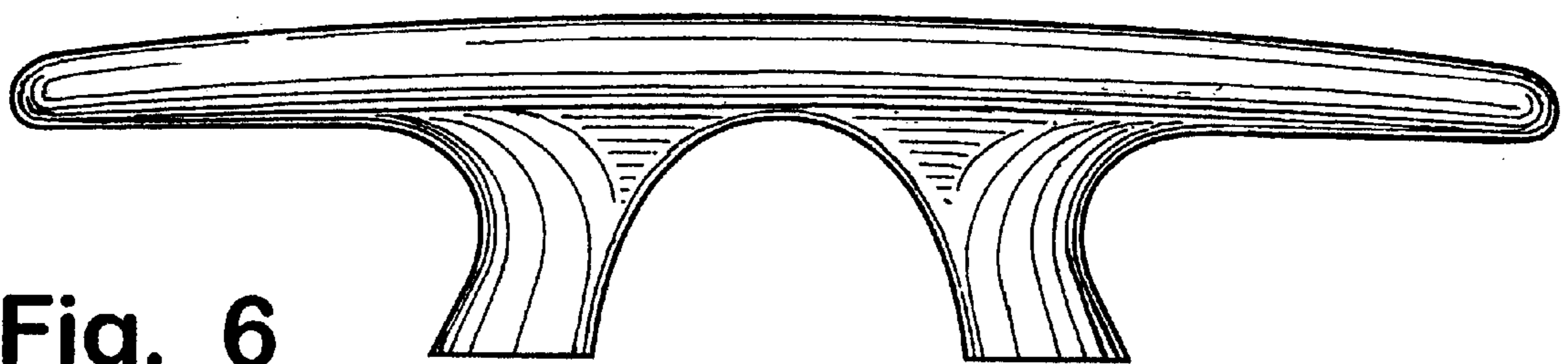

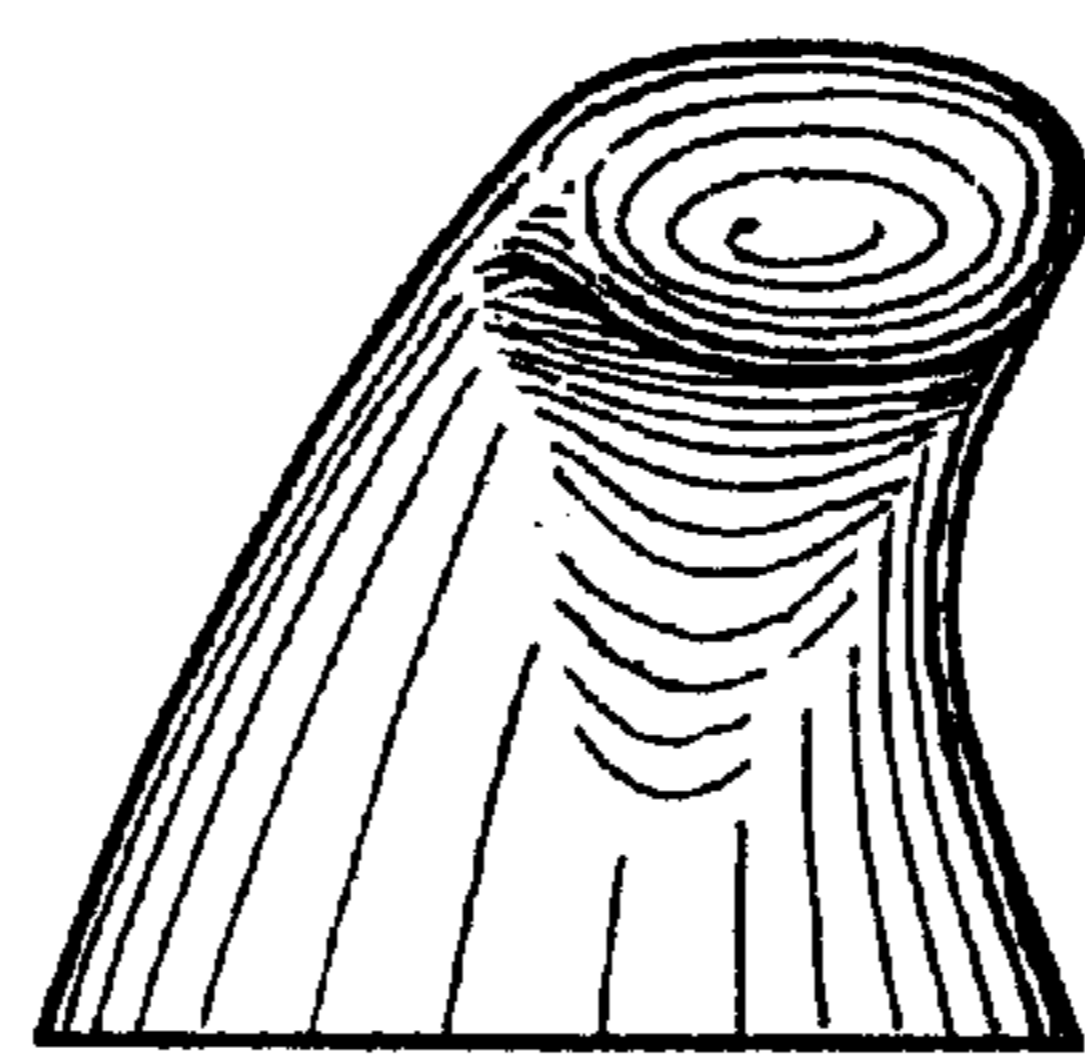
