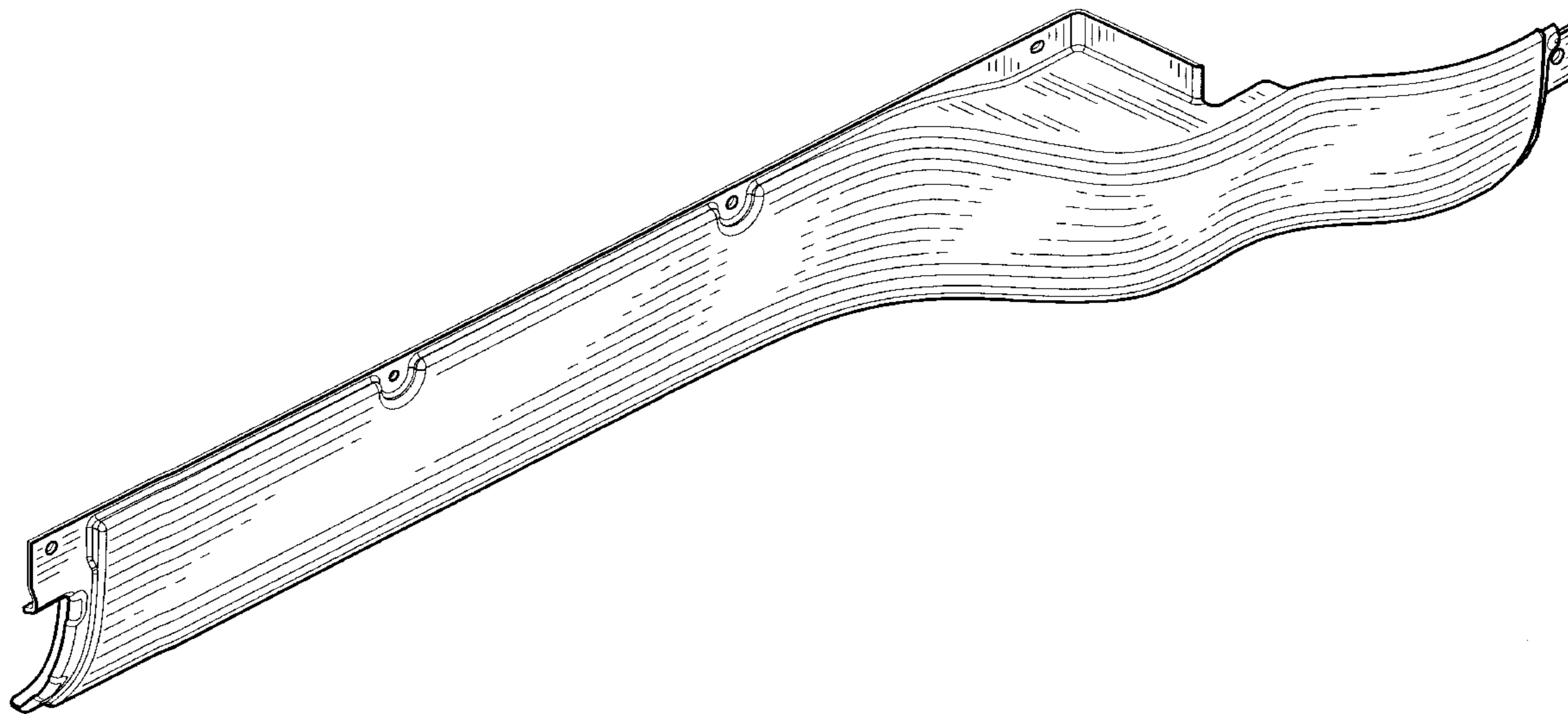
[57] **CLAIM**

The ornamental design for a rocker panel for a truck, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of our rocker panel for a truck; FIG. 2 is a left side view thereof; FIG. 3 is a front view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a back view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is a reduced perspective view of our invention. The broken line showing of a truck, in FIG. 8, depicts environment and is not part of the claimed design. The design envisioned contains a second portion whose image is mirror symmetrical to the one shown. The embodiment shown is for the left side of the vehicle.

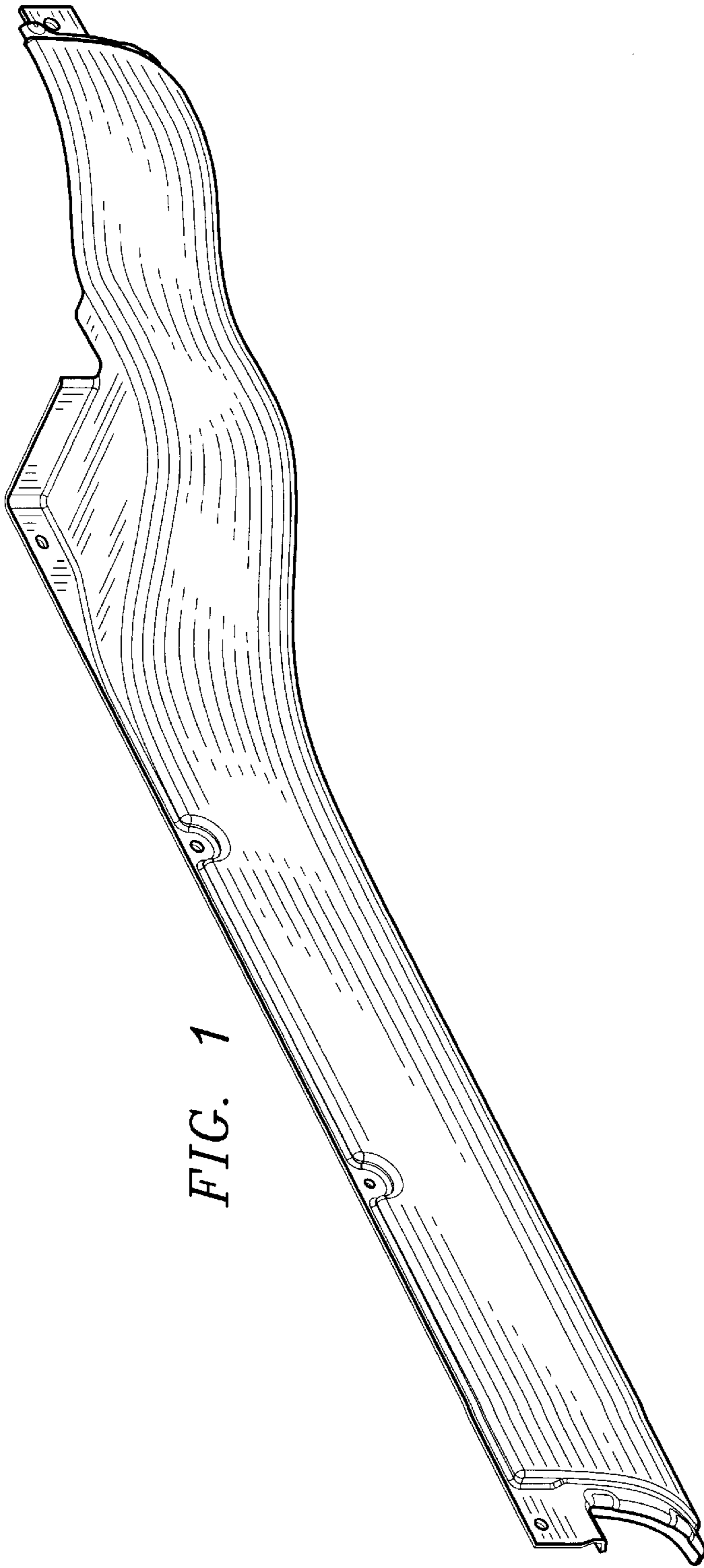

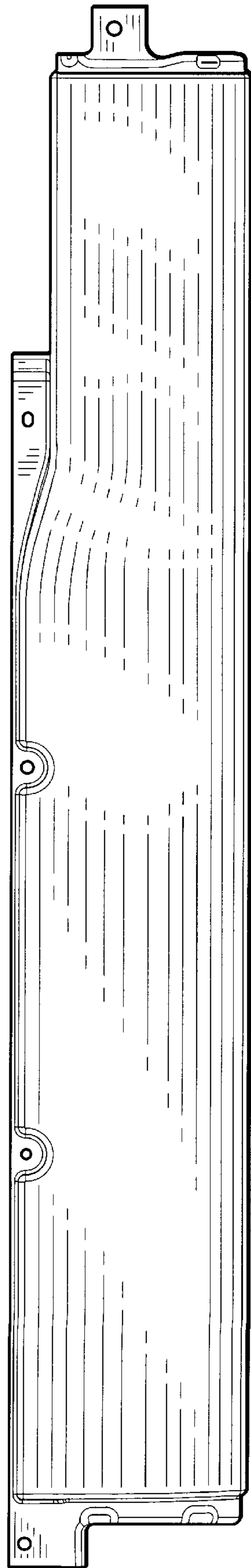

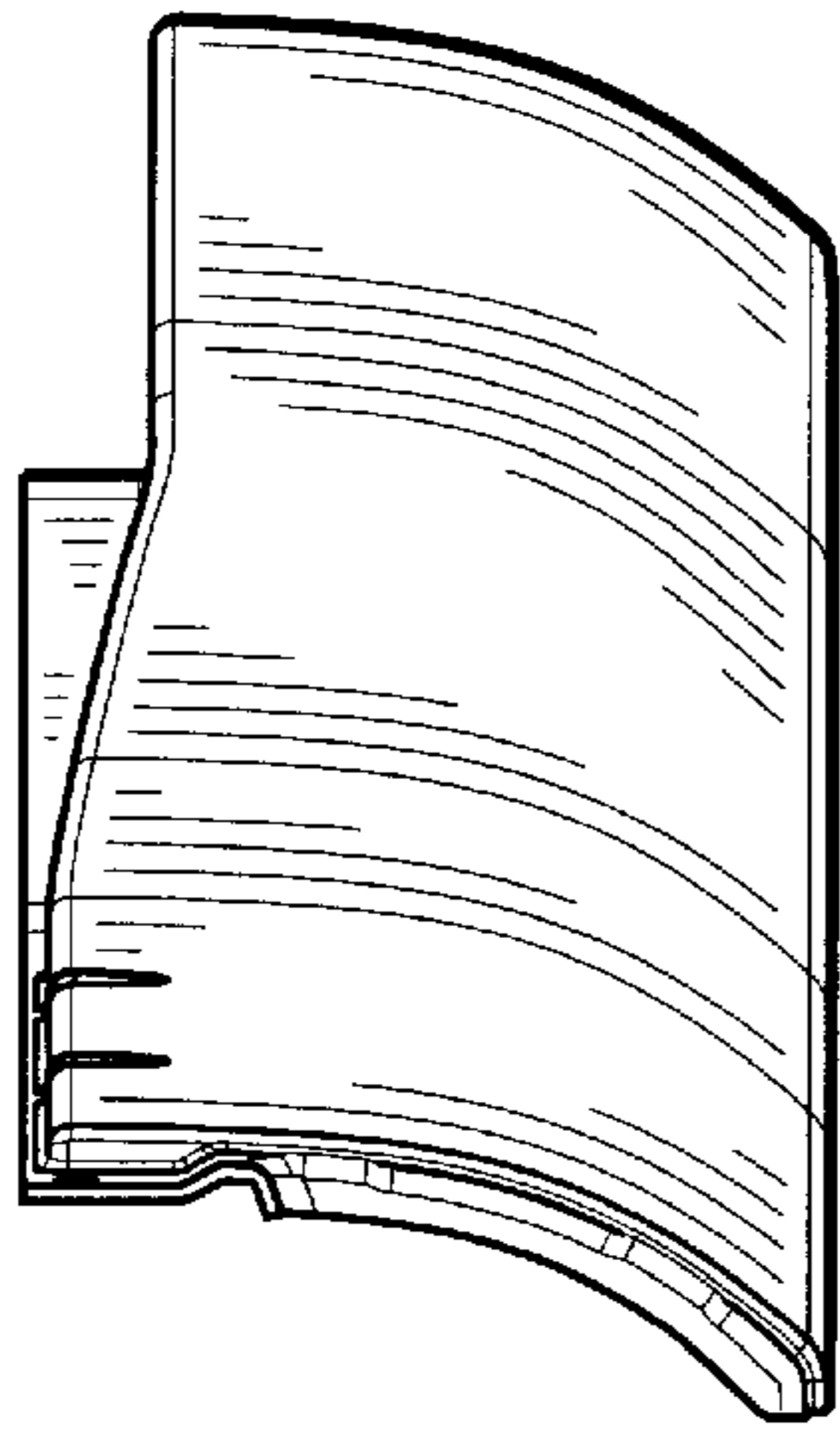

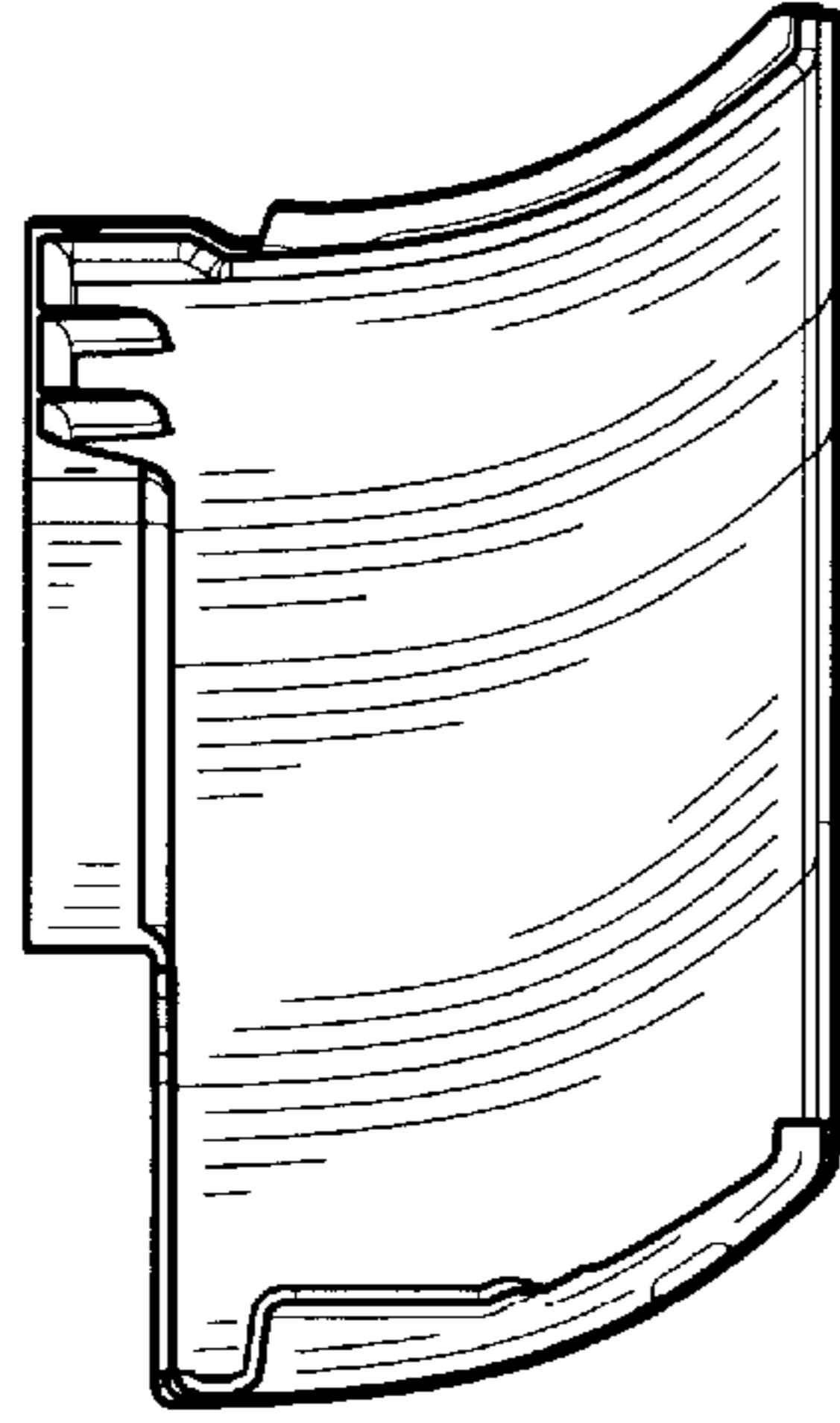

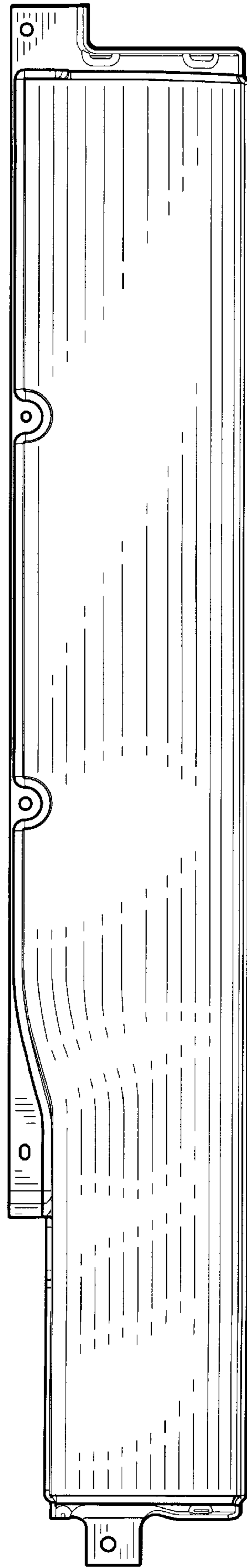

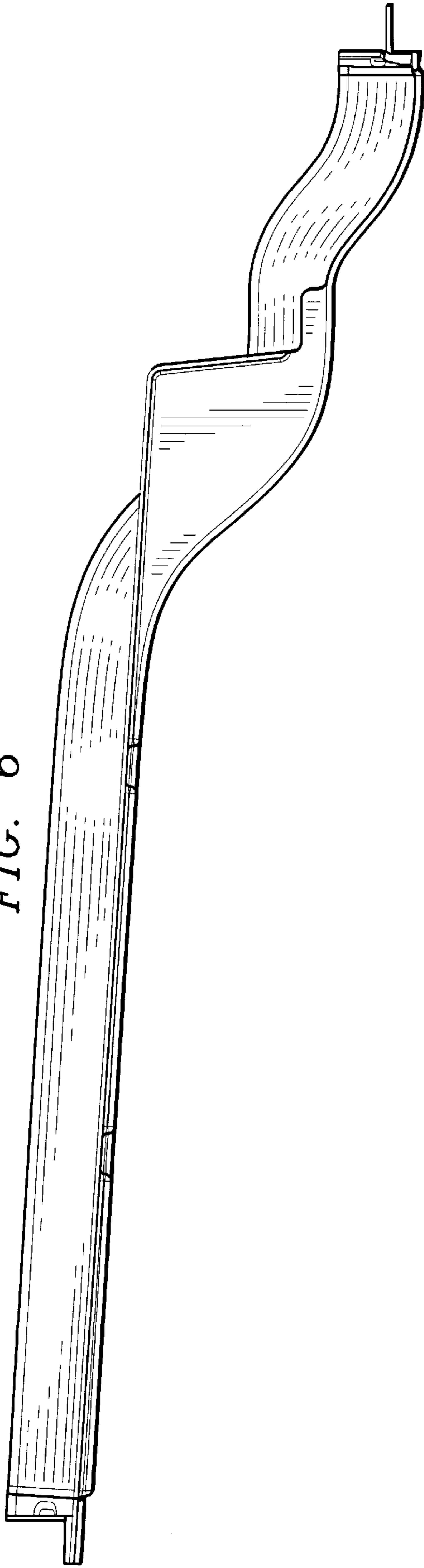
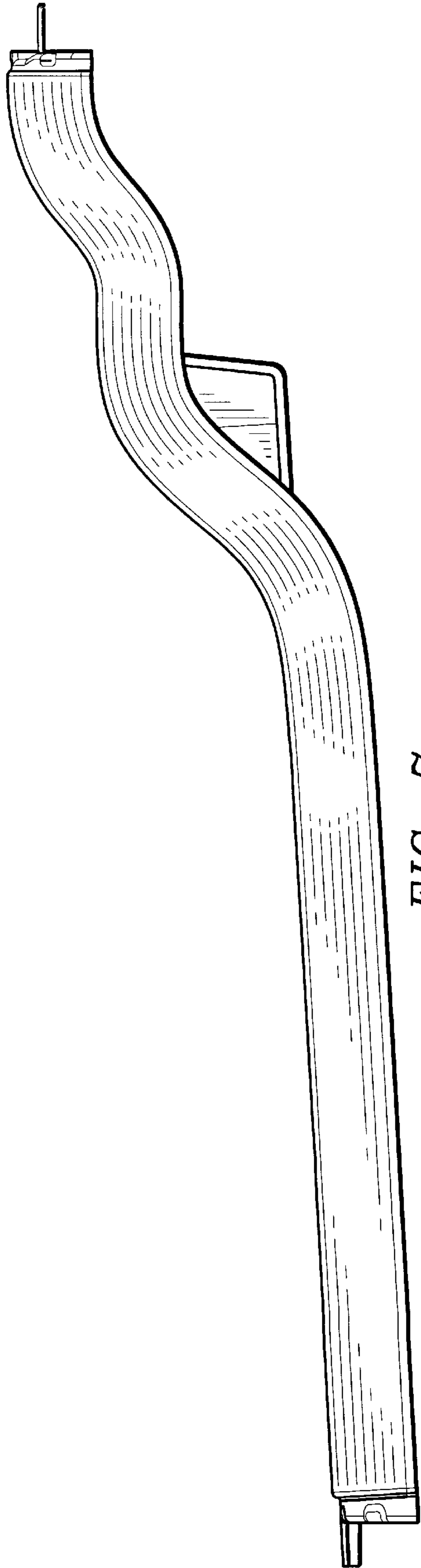

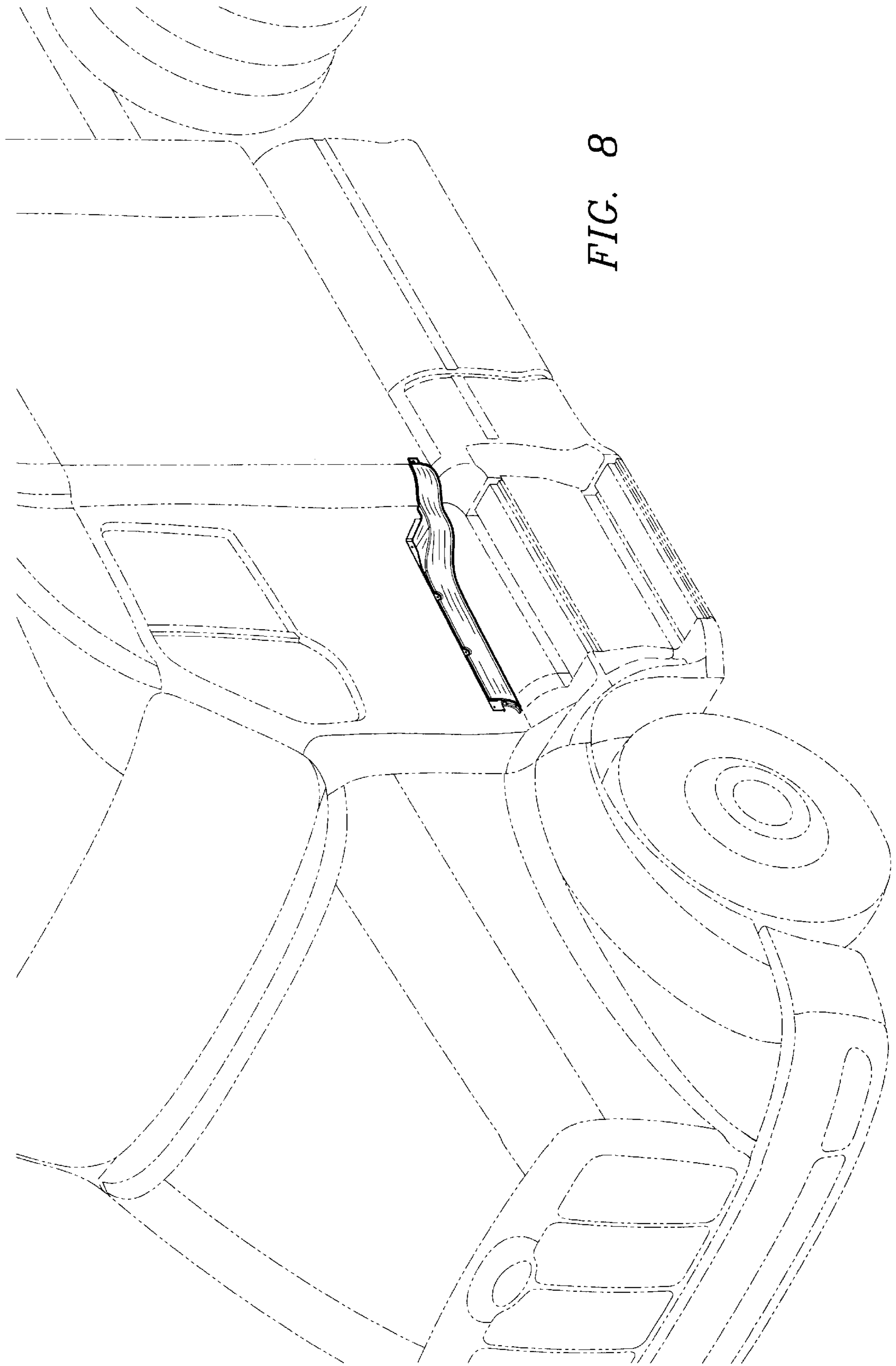
