[57] CLAIM

The ornamental design for a speakerphone accessory, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and left side perspective view showing our new design for a speakerphone accessory.

FIG. 2 is a rear, top, and right side perspective view showing the speakerphone accessory of FIG. 1.

FIG. 3 is a top elevation view thereof.

FIG. 4 is a front plan view thereof.

FIG. 5 is a right side elevated view thereof.

FIG. 6 is a rear plan view thereof.

FIG. 7 is a left side elevated view thereof.

FIG. 8 is a bottom elevation view thereof.

FIG. 9 is a front, top, and left side perspective view showing an alternate embodiment of our new design for a speakerphone accessory.

FIG. 10 is a rear, top, and right side perspective view showing the speakerphone accessory of FIG. 9.

FIG. 11 is a top elevation view thereof.

FIG. 12 is a front plan view thereof.

FIG. 13 is a right side elevated view thereof.

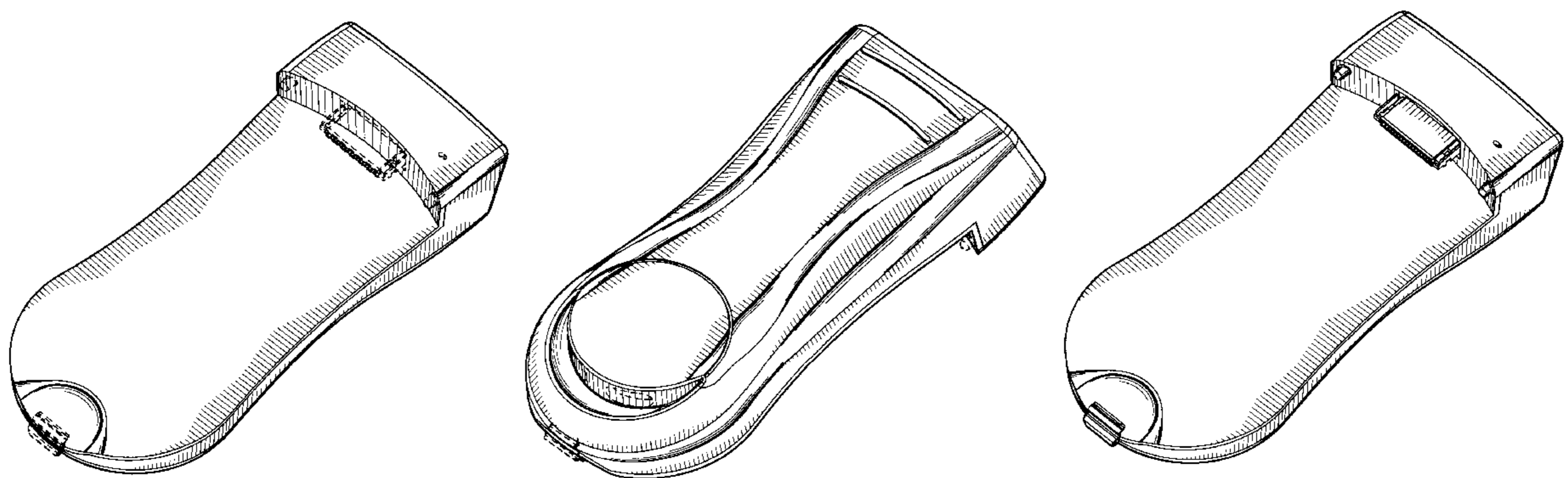
FIG. 14 is a rear plan view thereof.

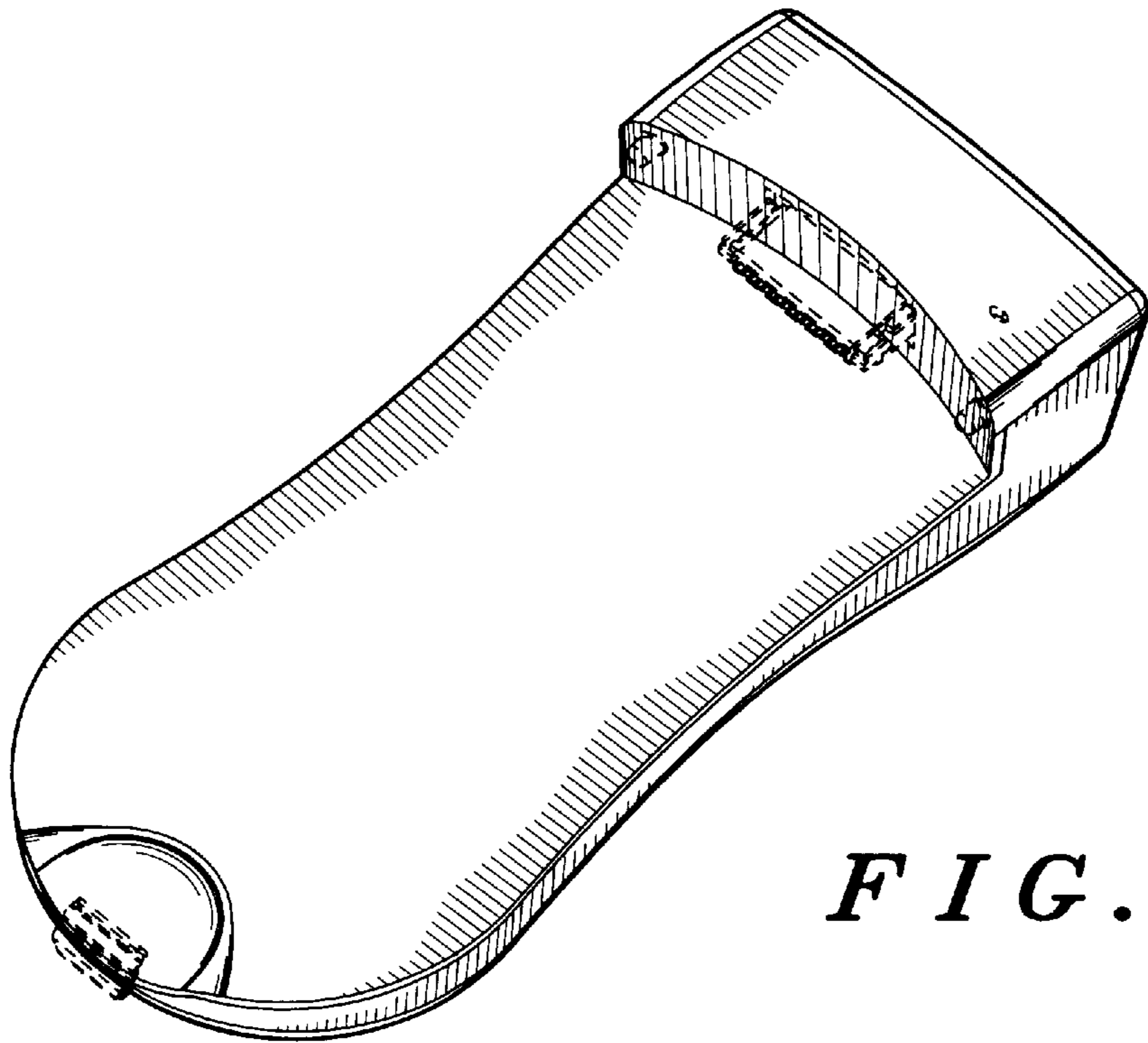

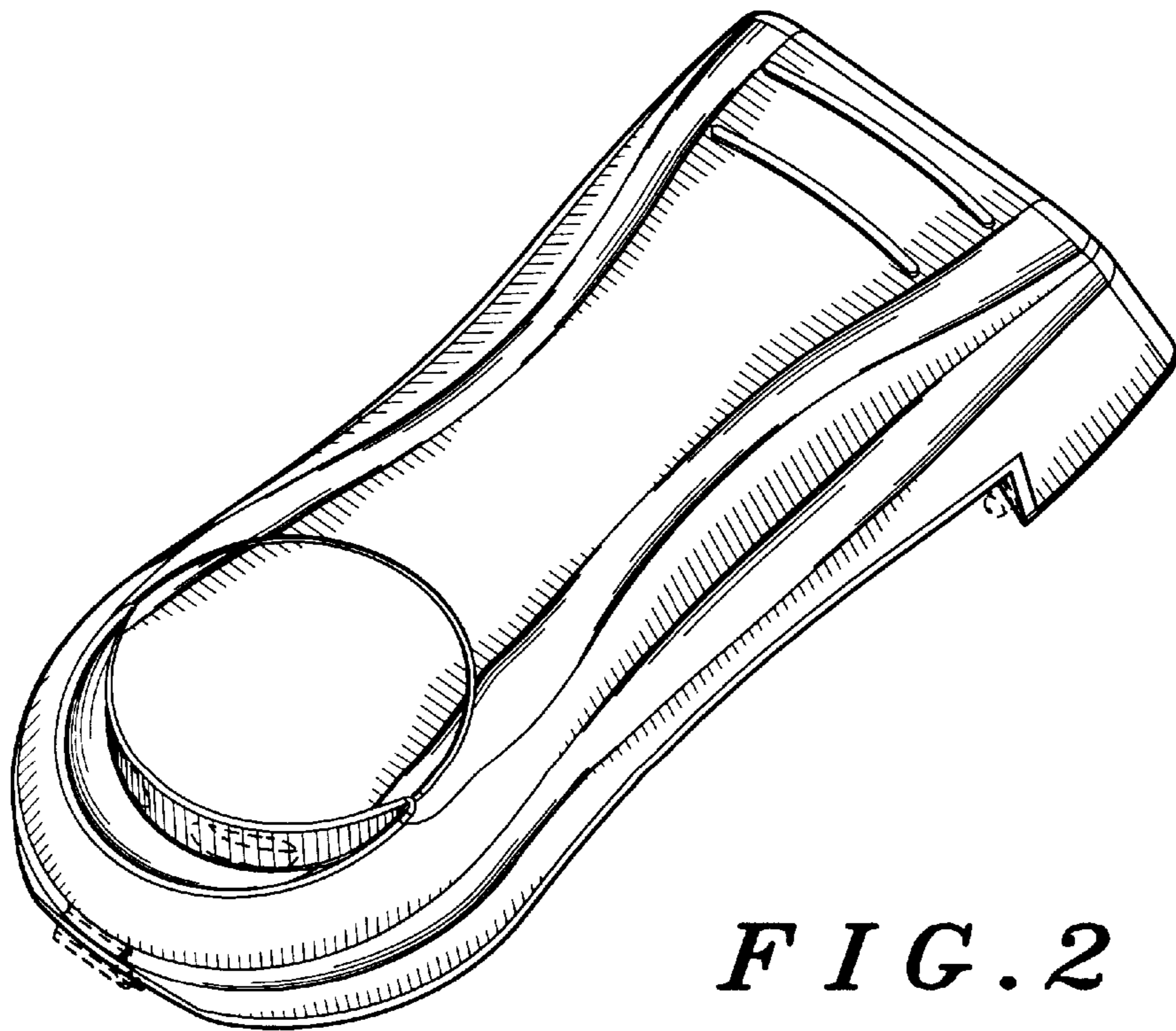

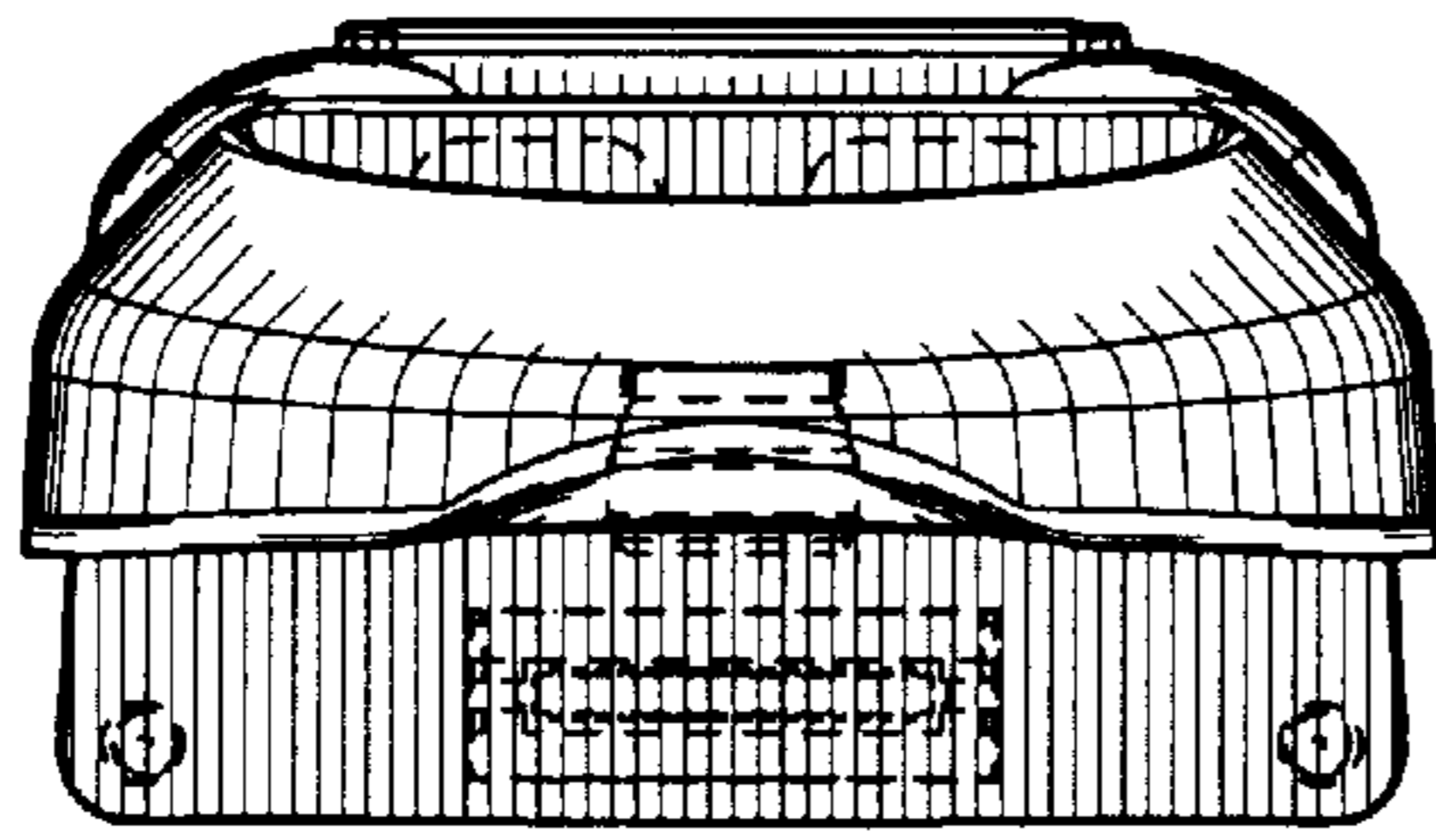

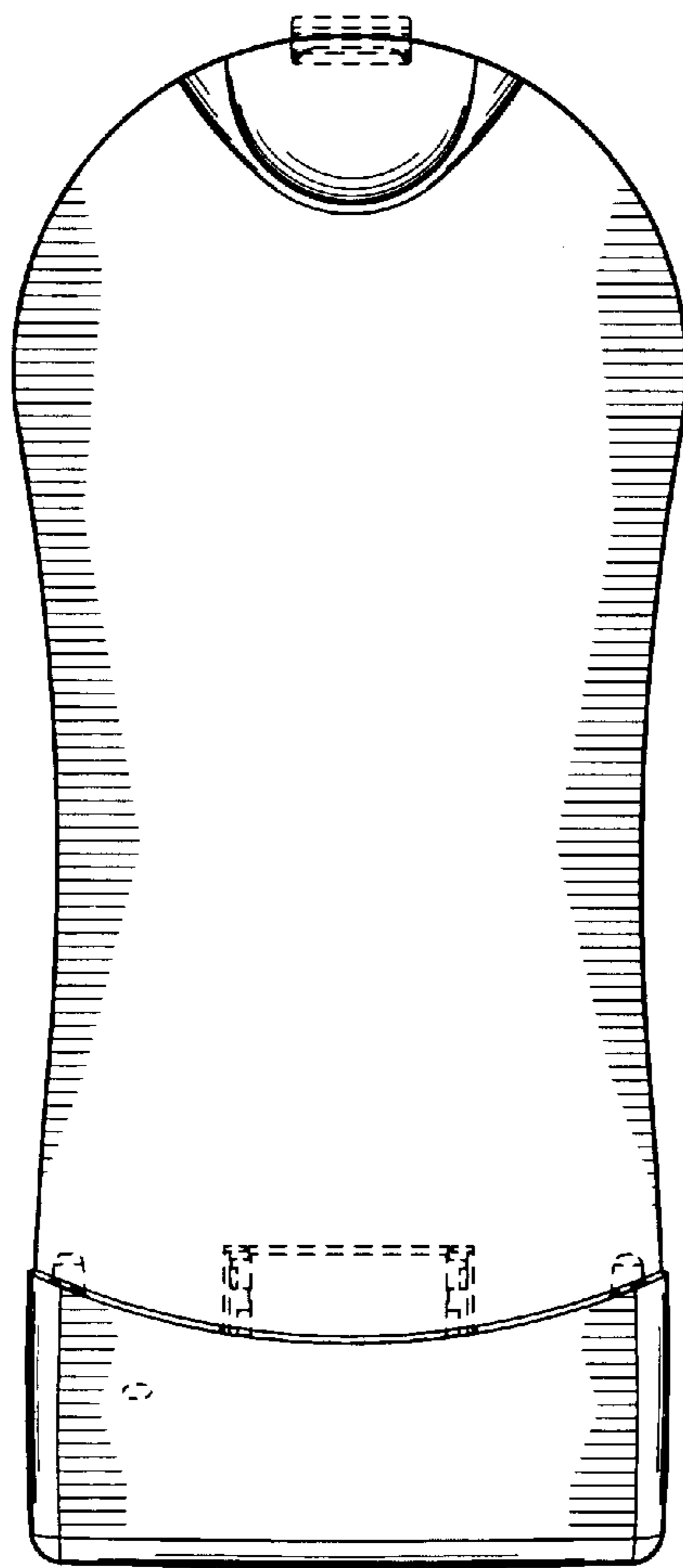

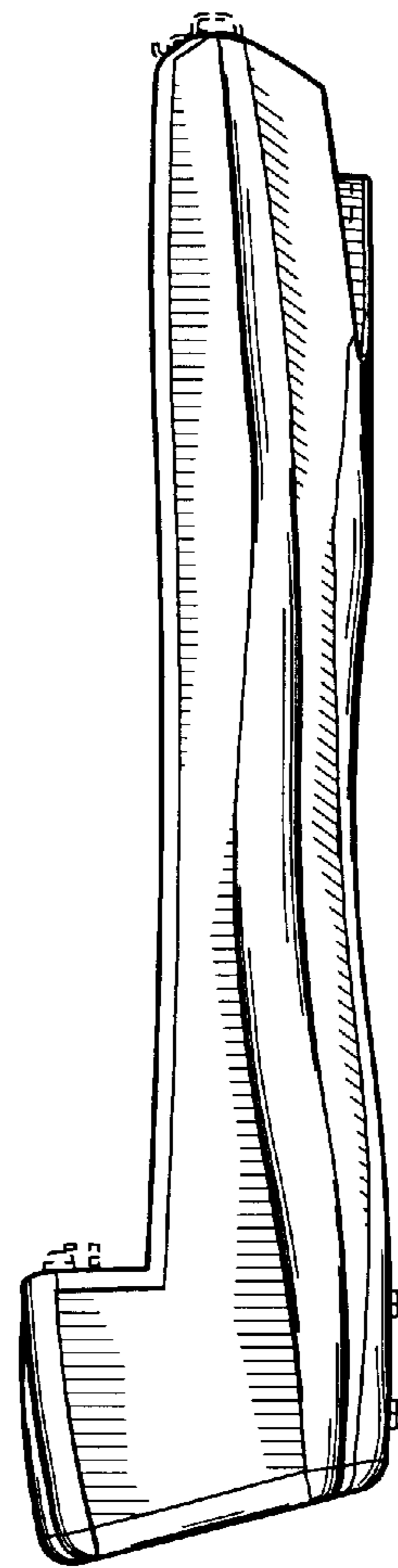

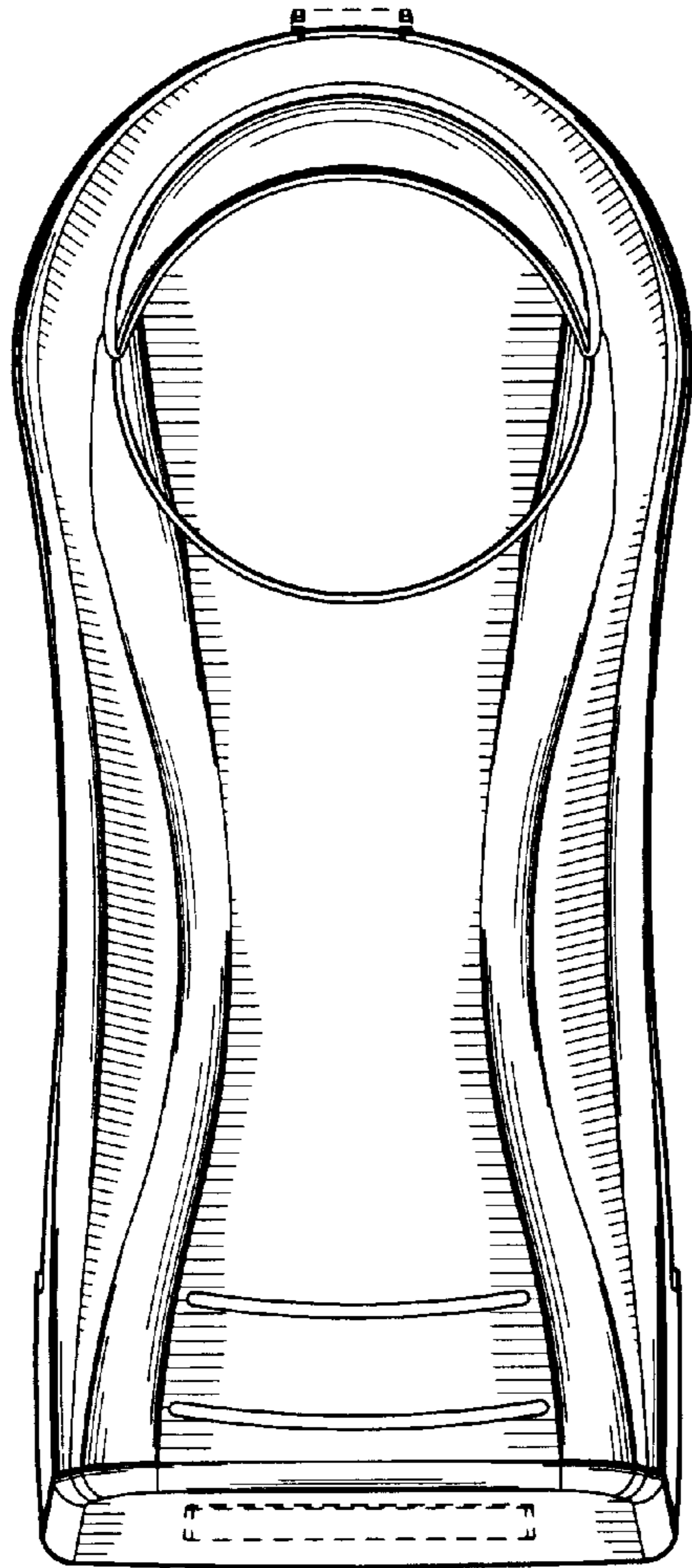

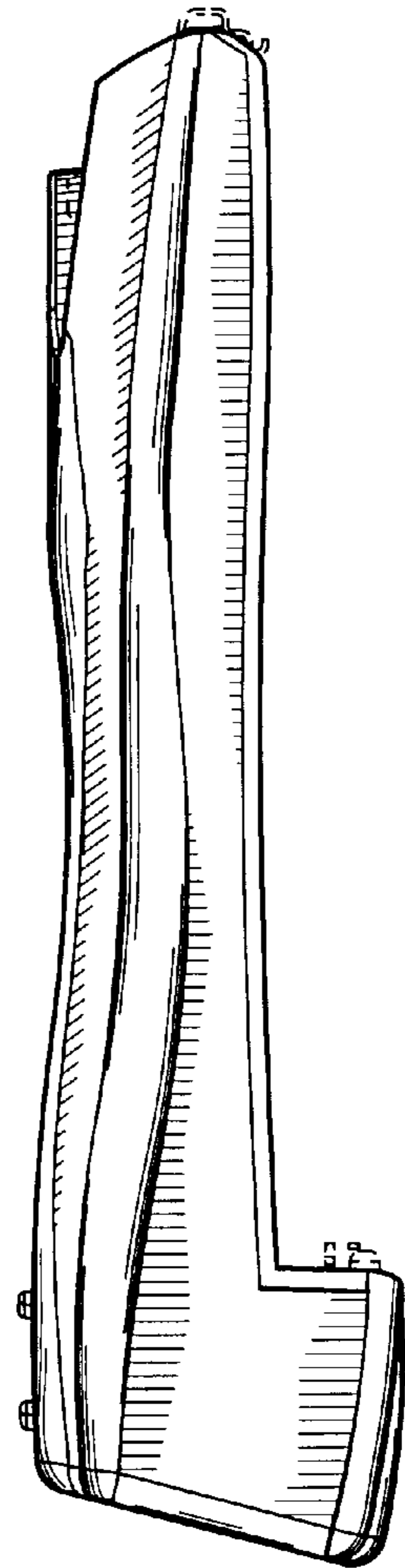

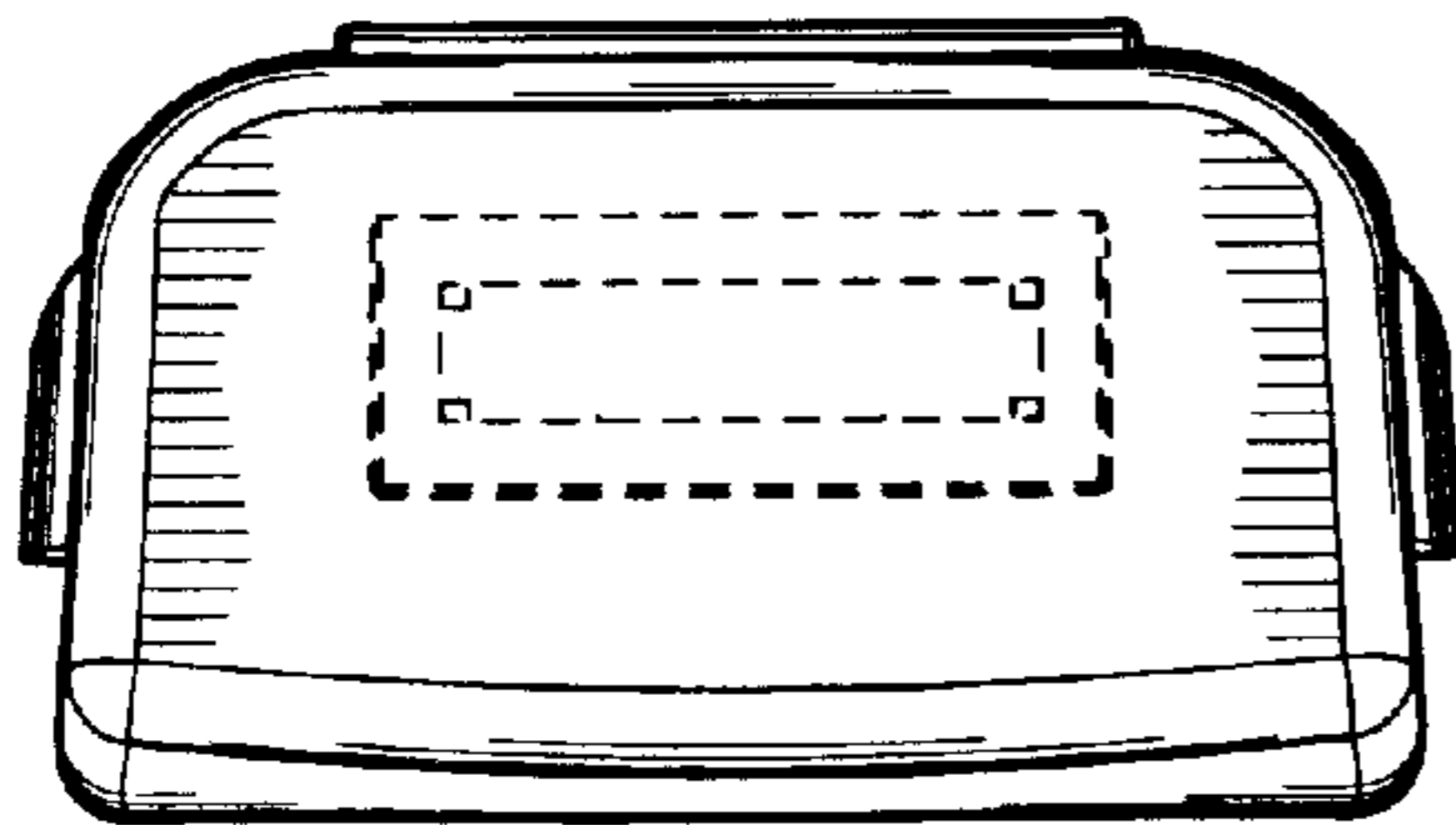

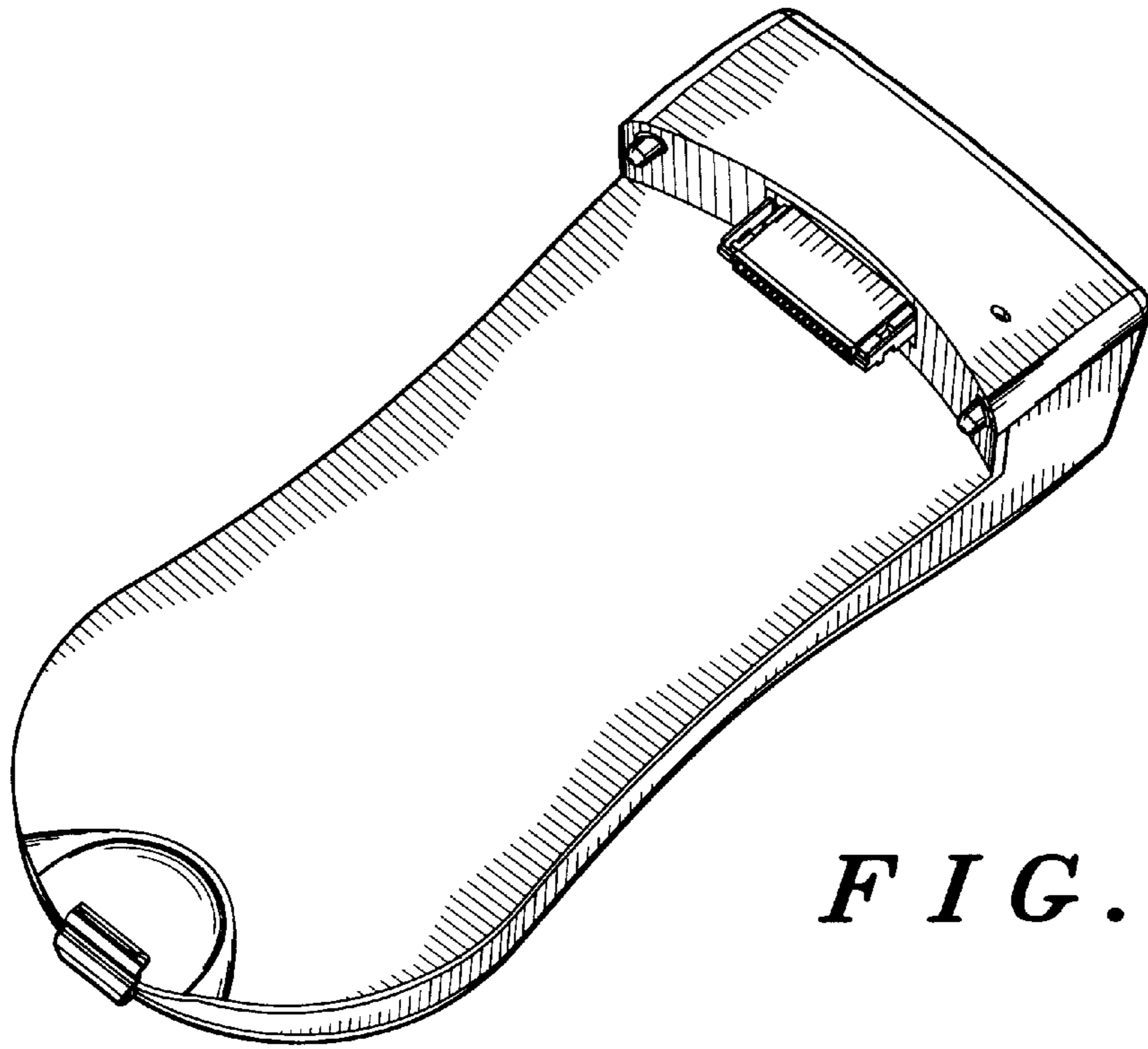

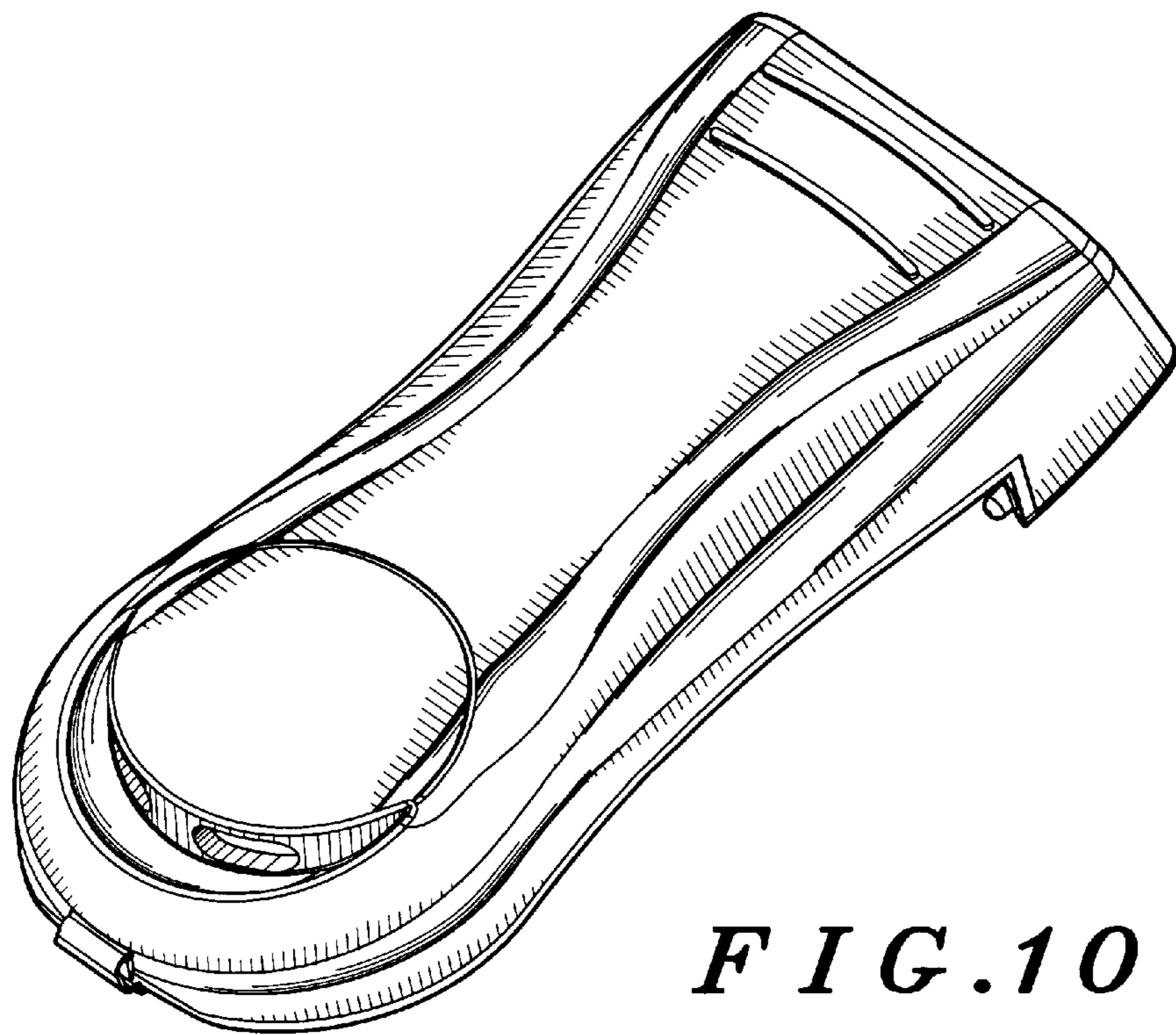

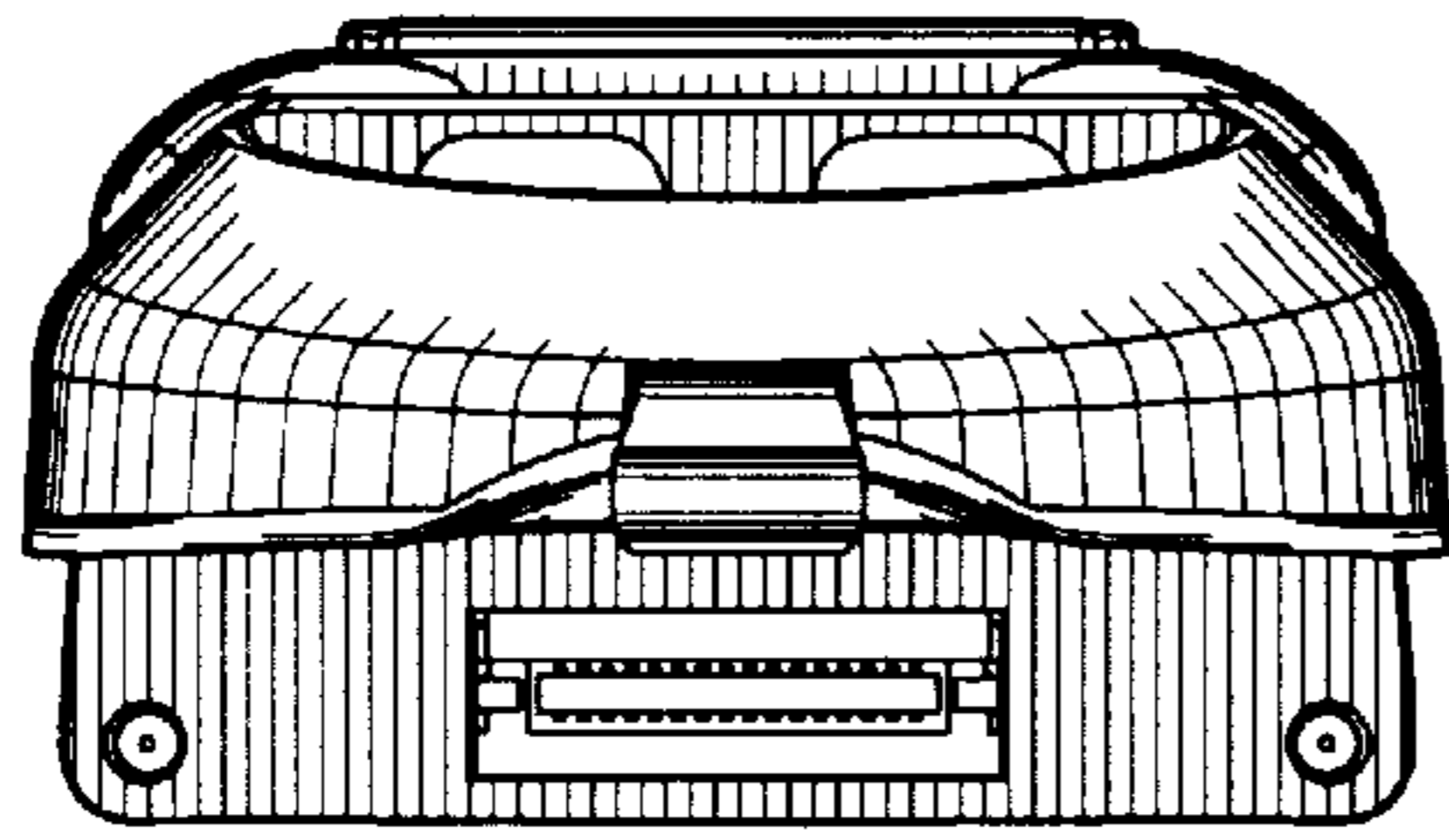

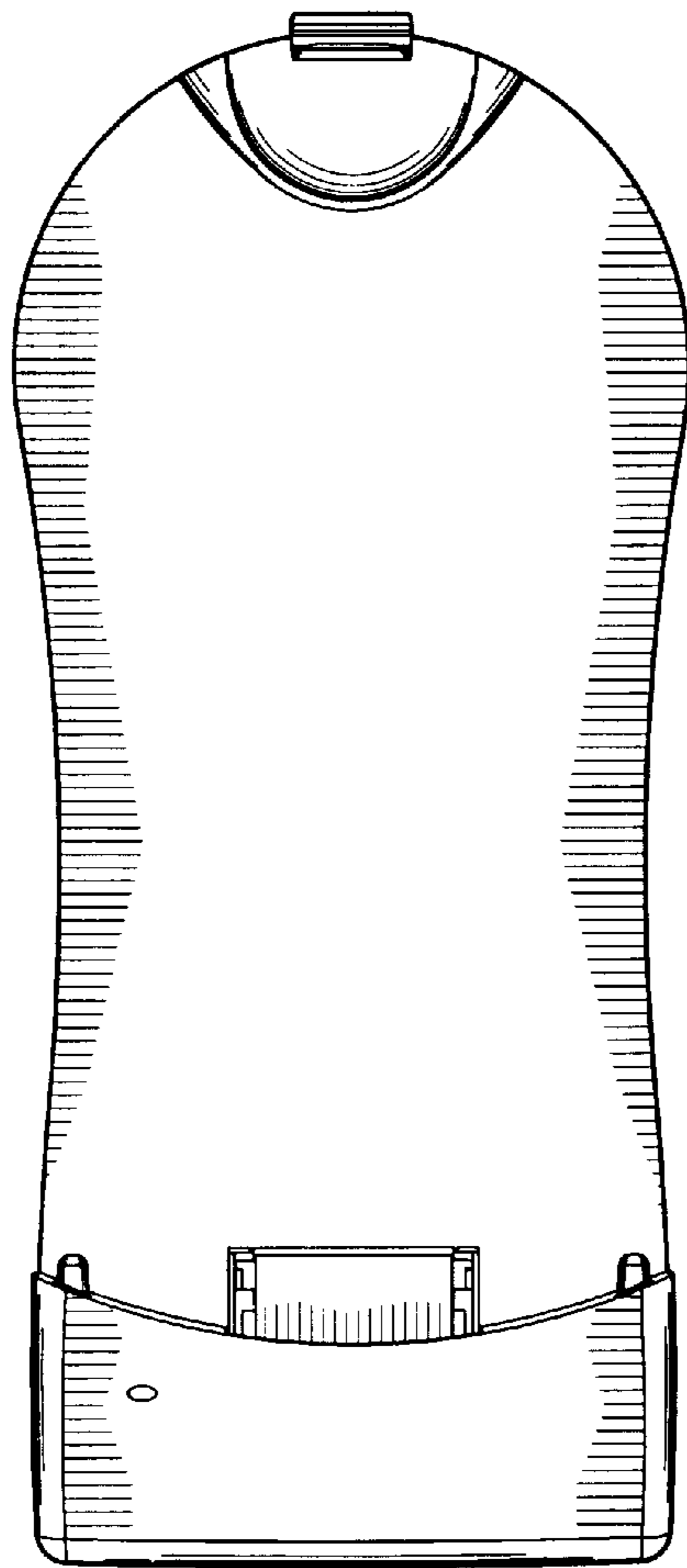

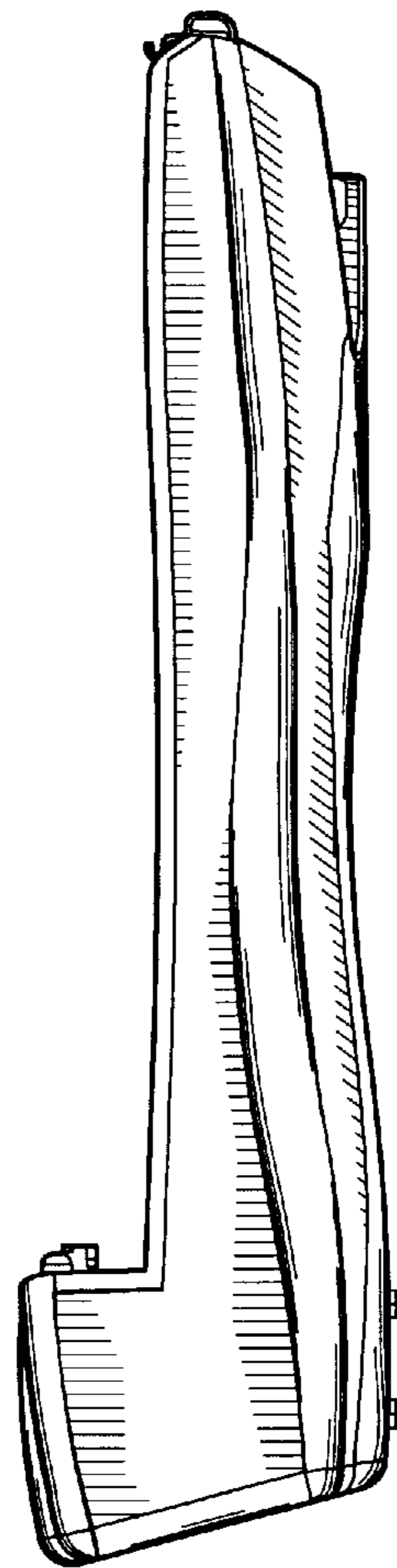

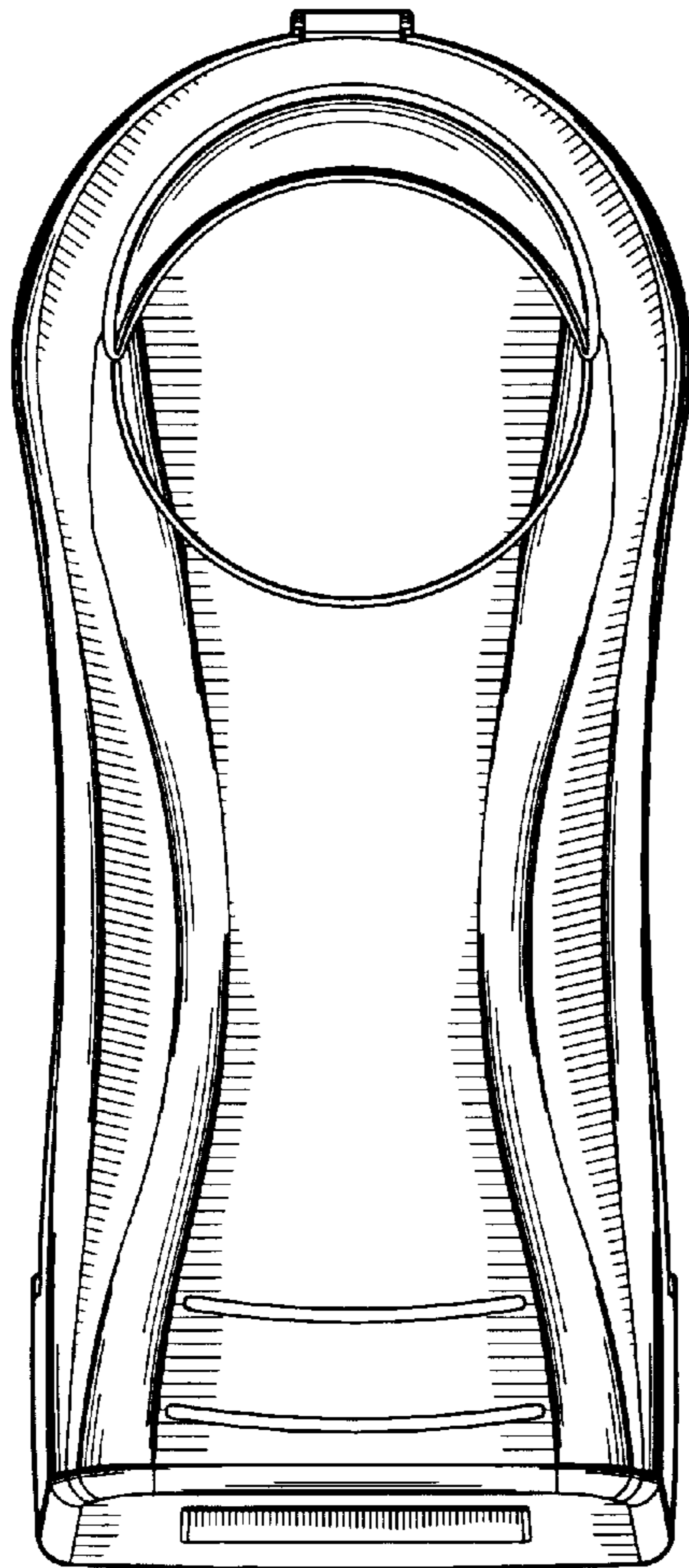

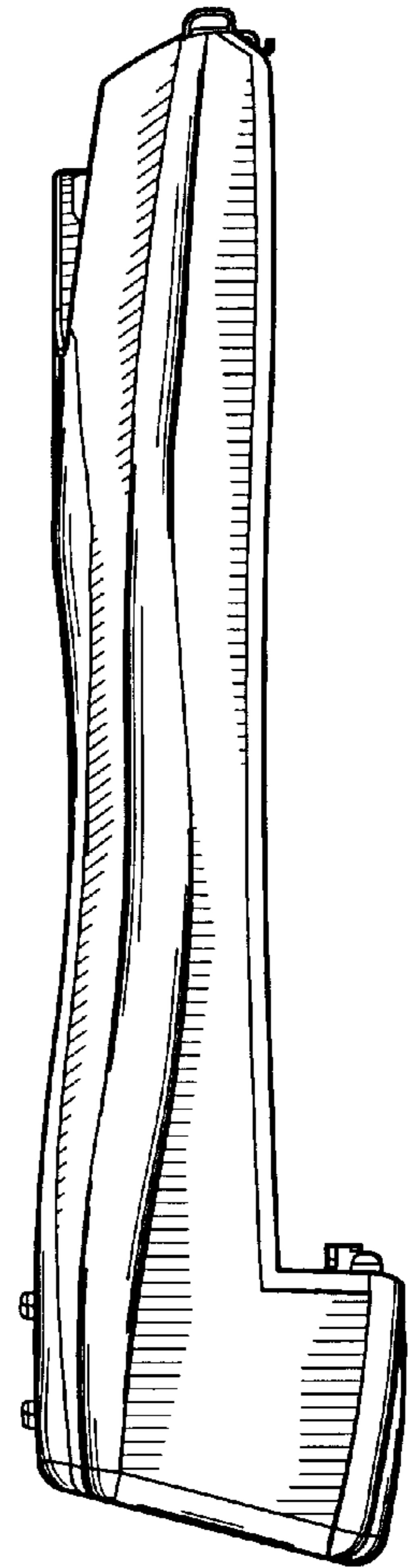

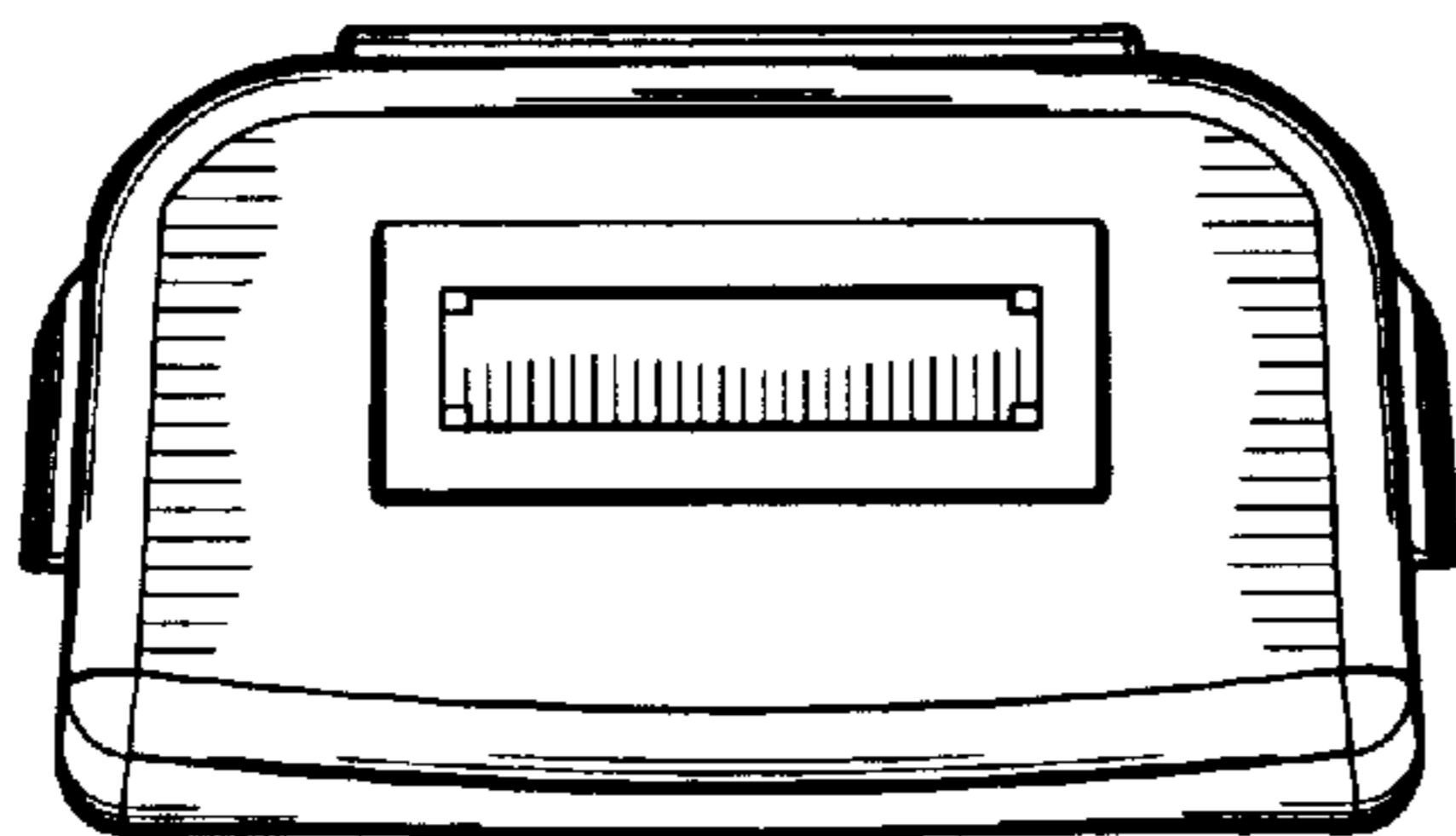
