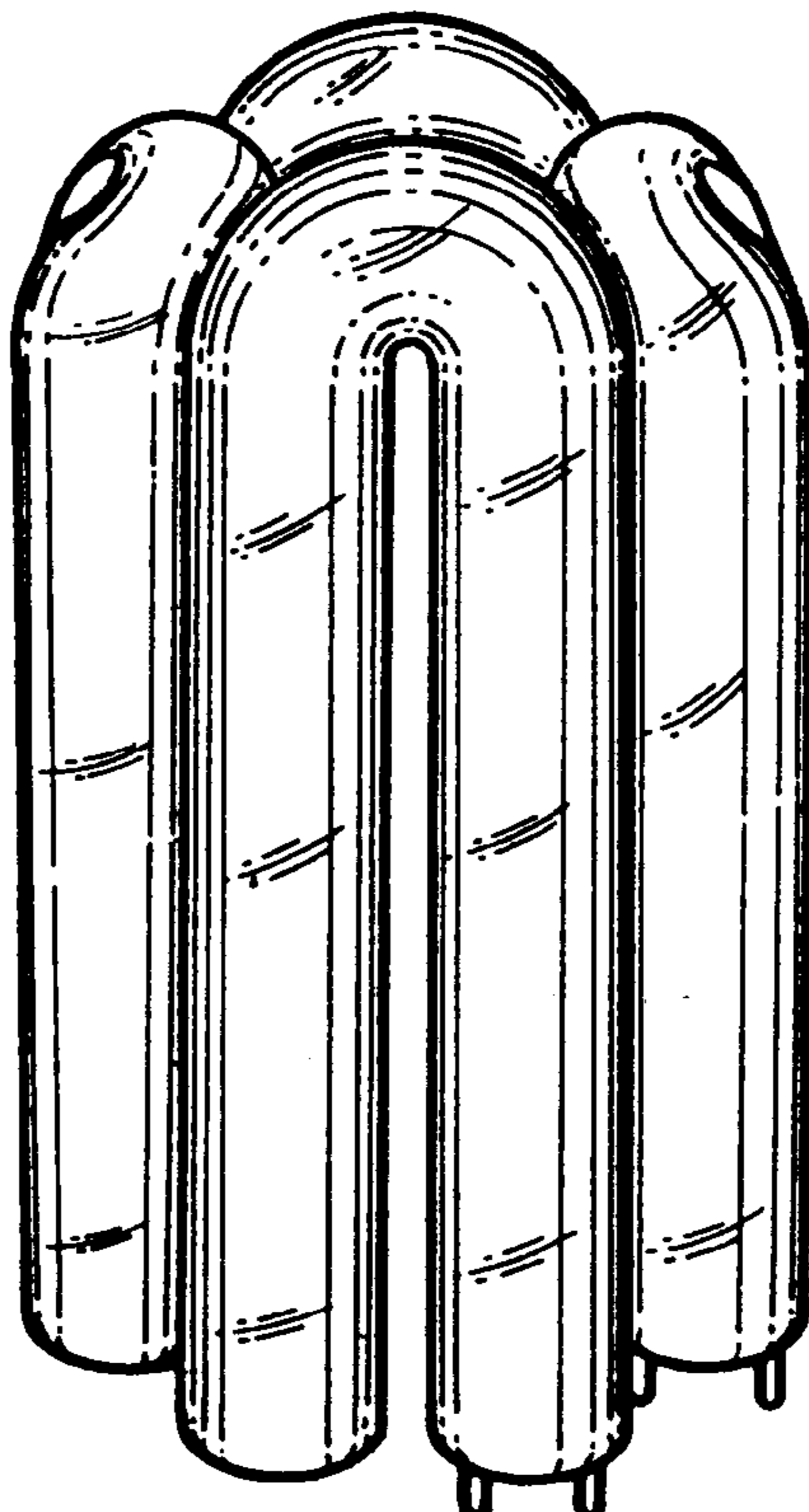
[57] **CLAIM**

The ornamental design for compact fluorescent tube, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a compact fluorescent tube; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a rear elevational view thereof; FIG. 8 is a section view along lines 8—8 in FIG. 2; FIG. 9 is a section view along lines 9—9 in FIG. 4; and, FIG. 10 is a perspective view thereof, with the broken line showing for illustrative purposes only and forming no part of the claimed design.

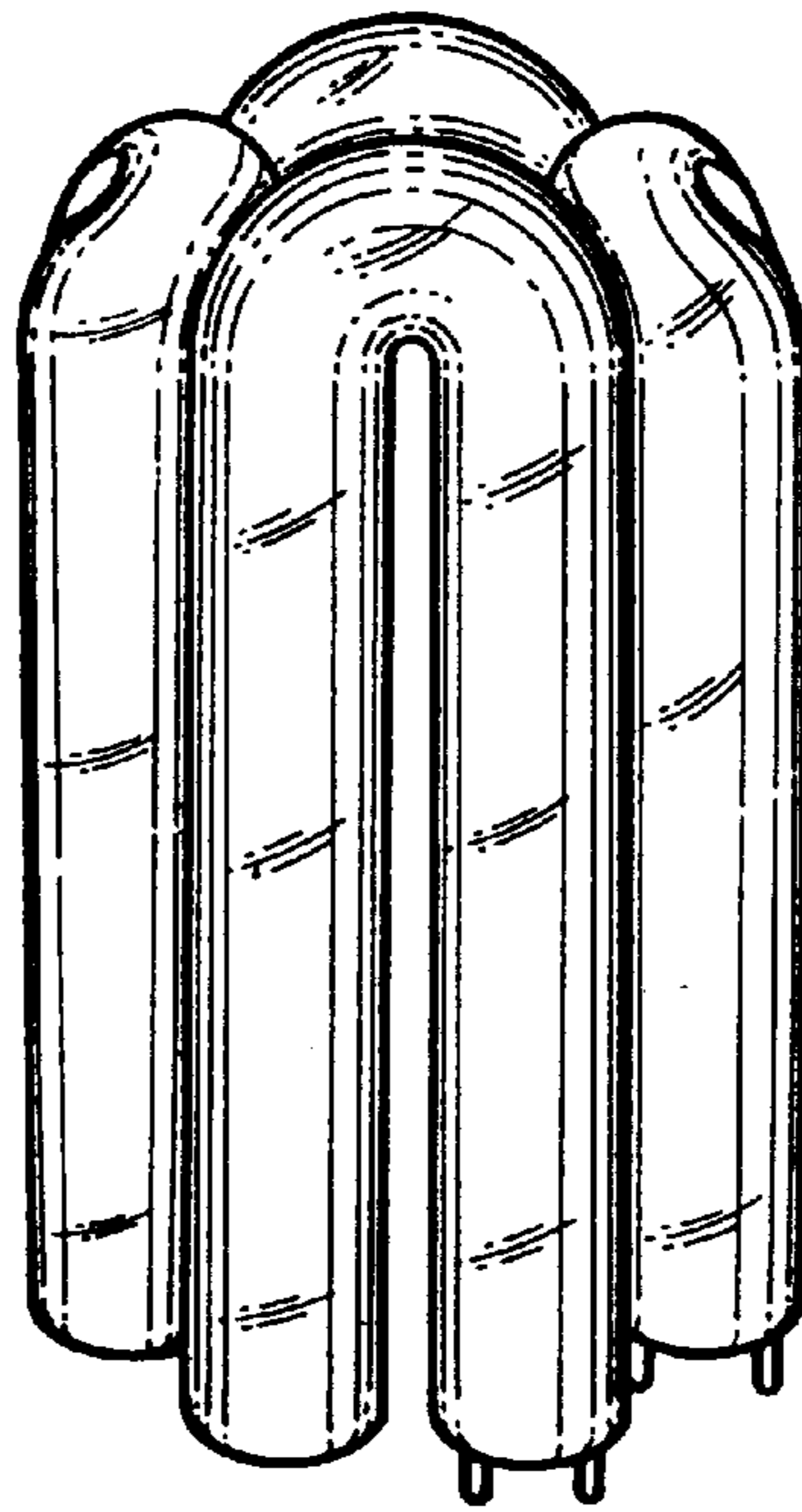

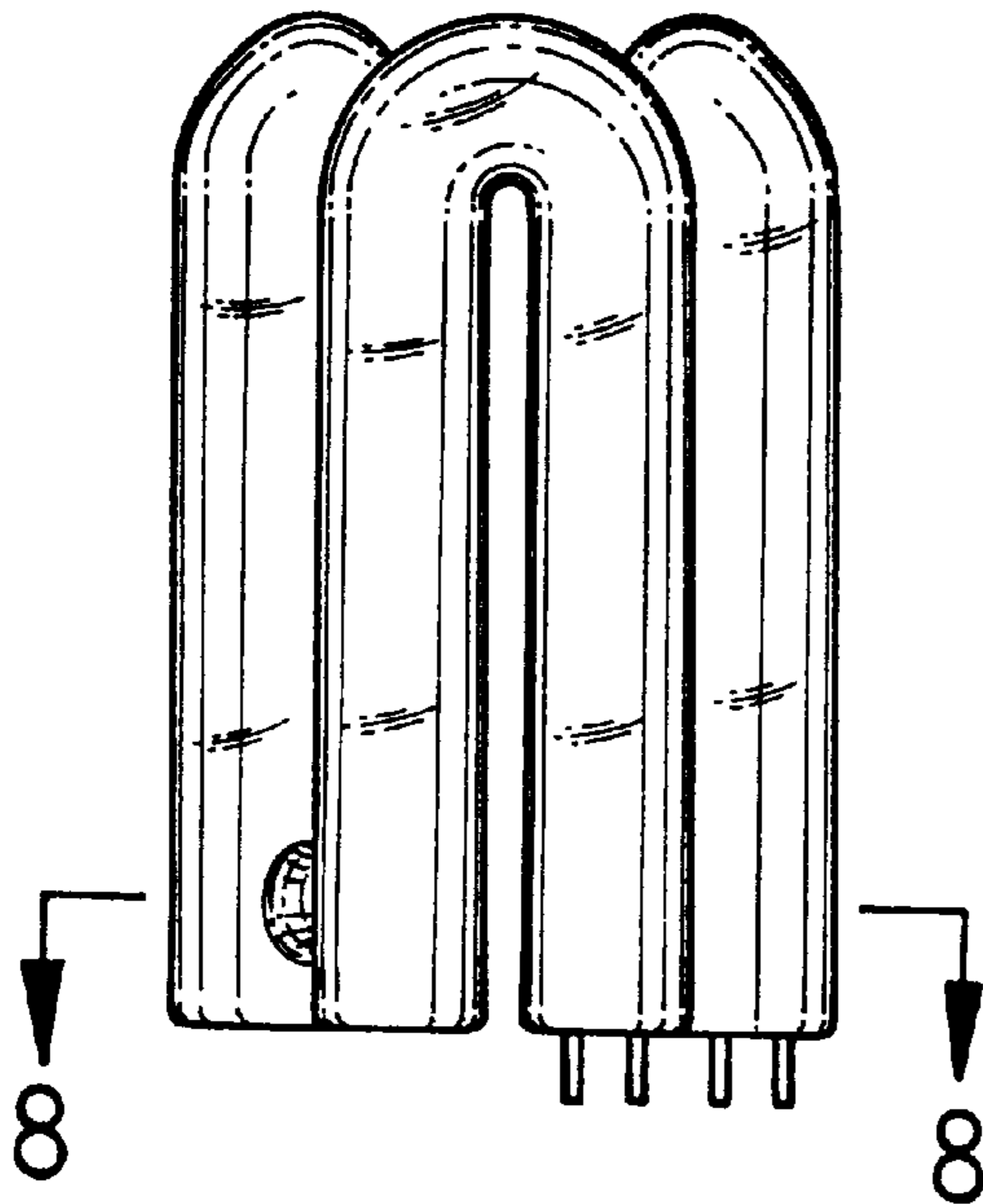

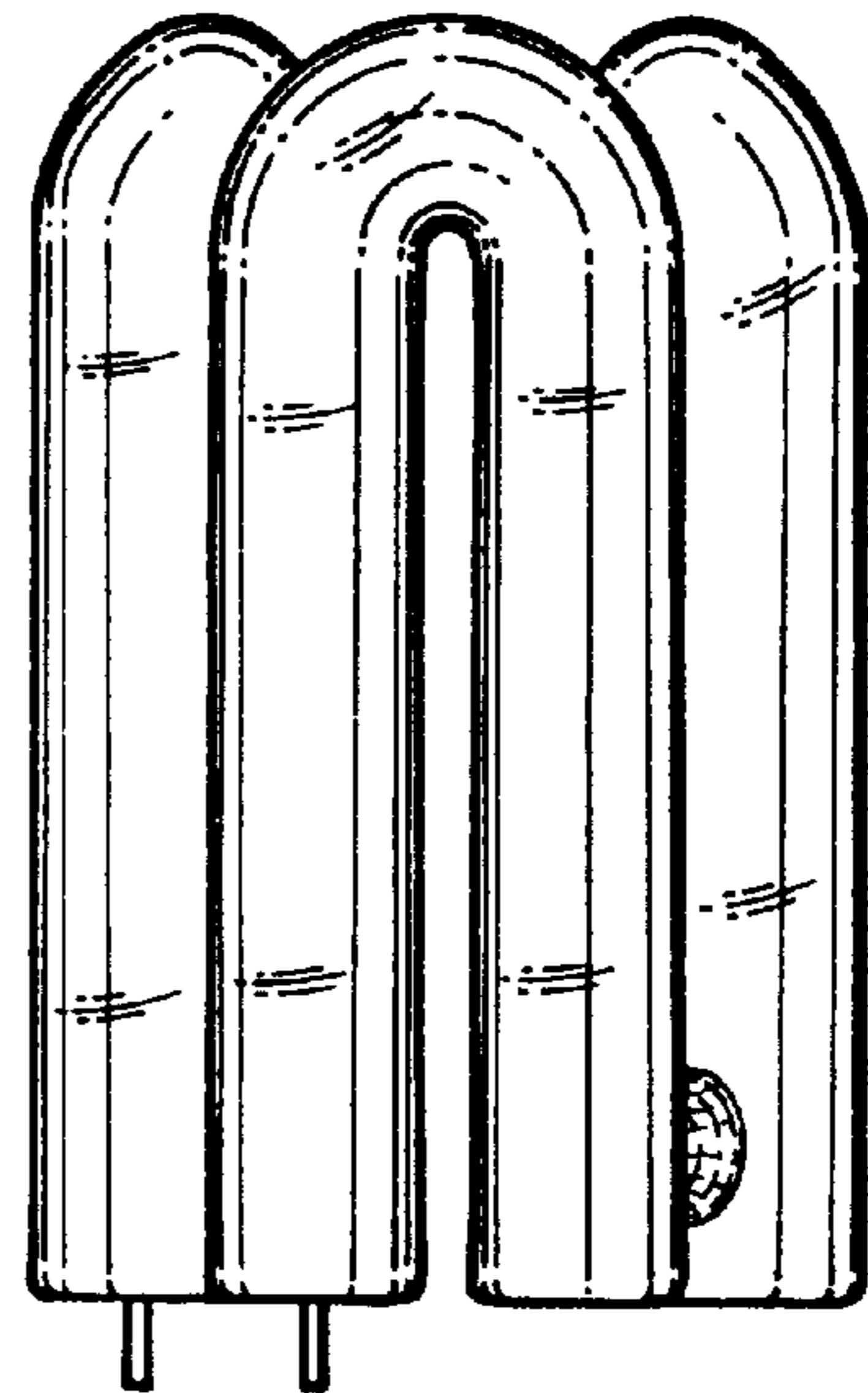

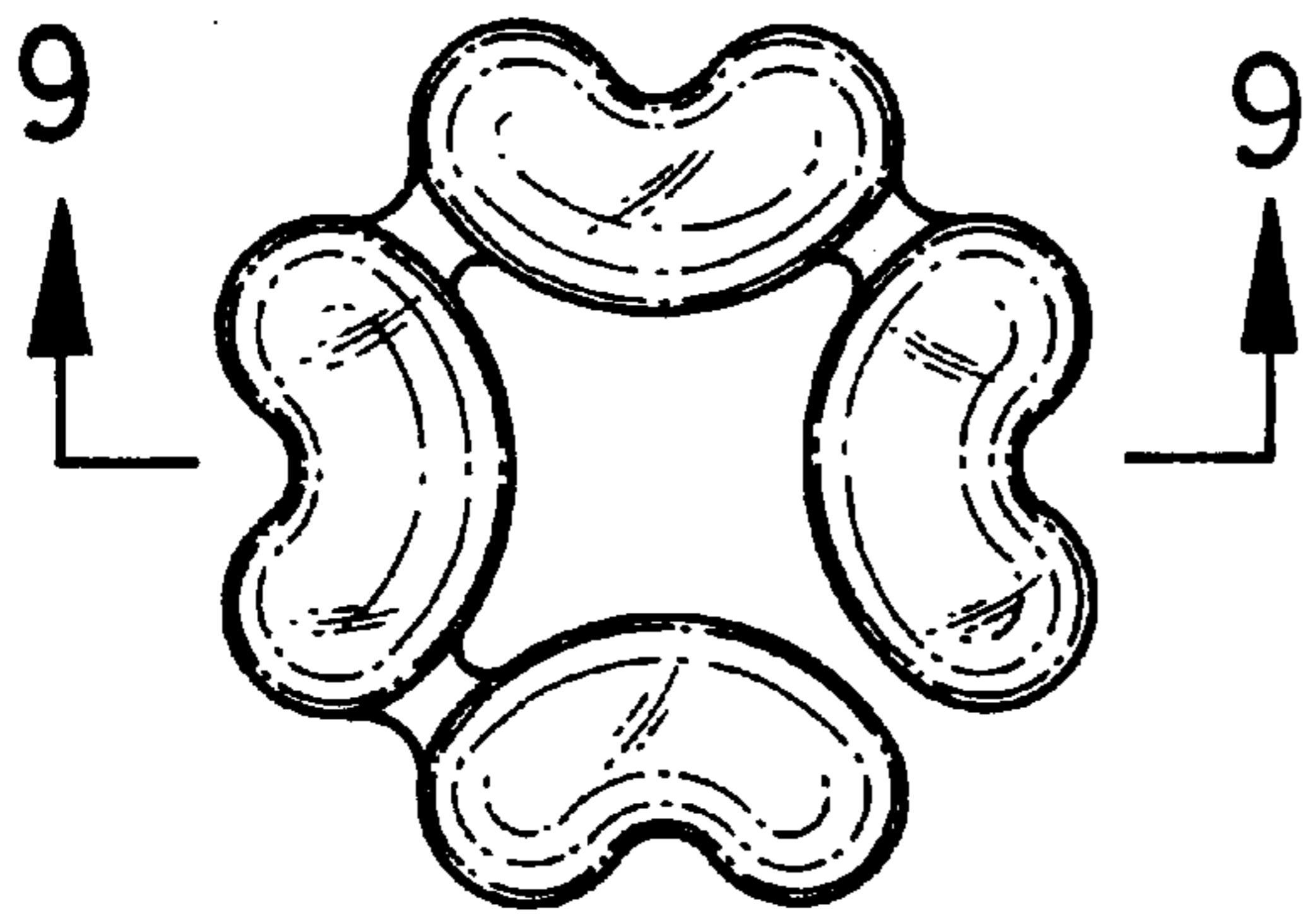

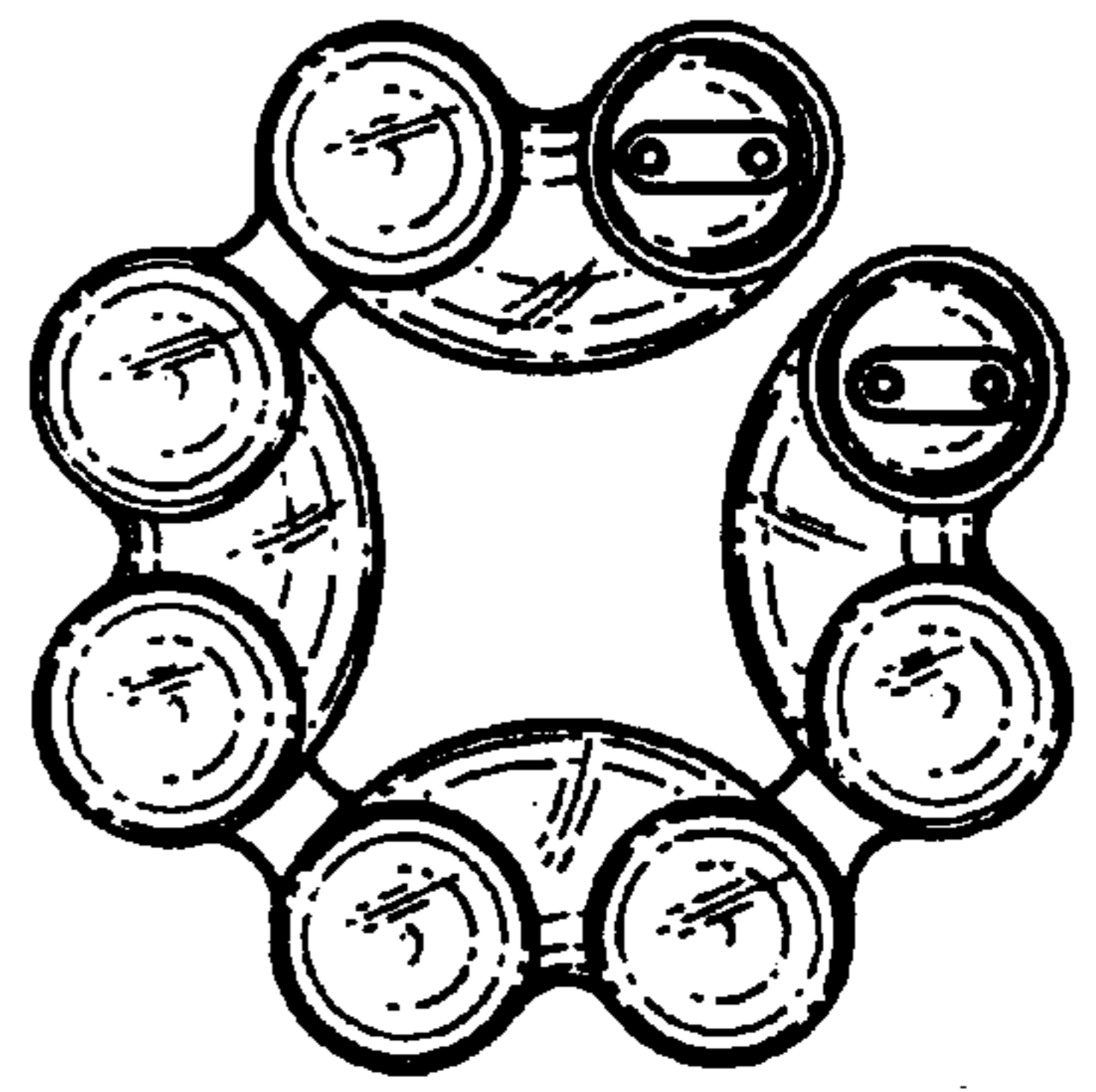

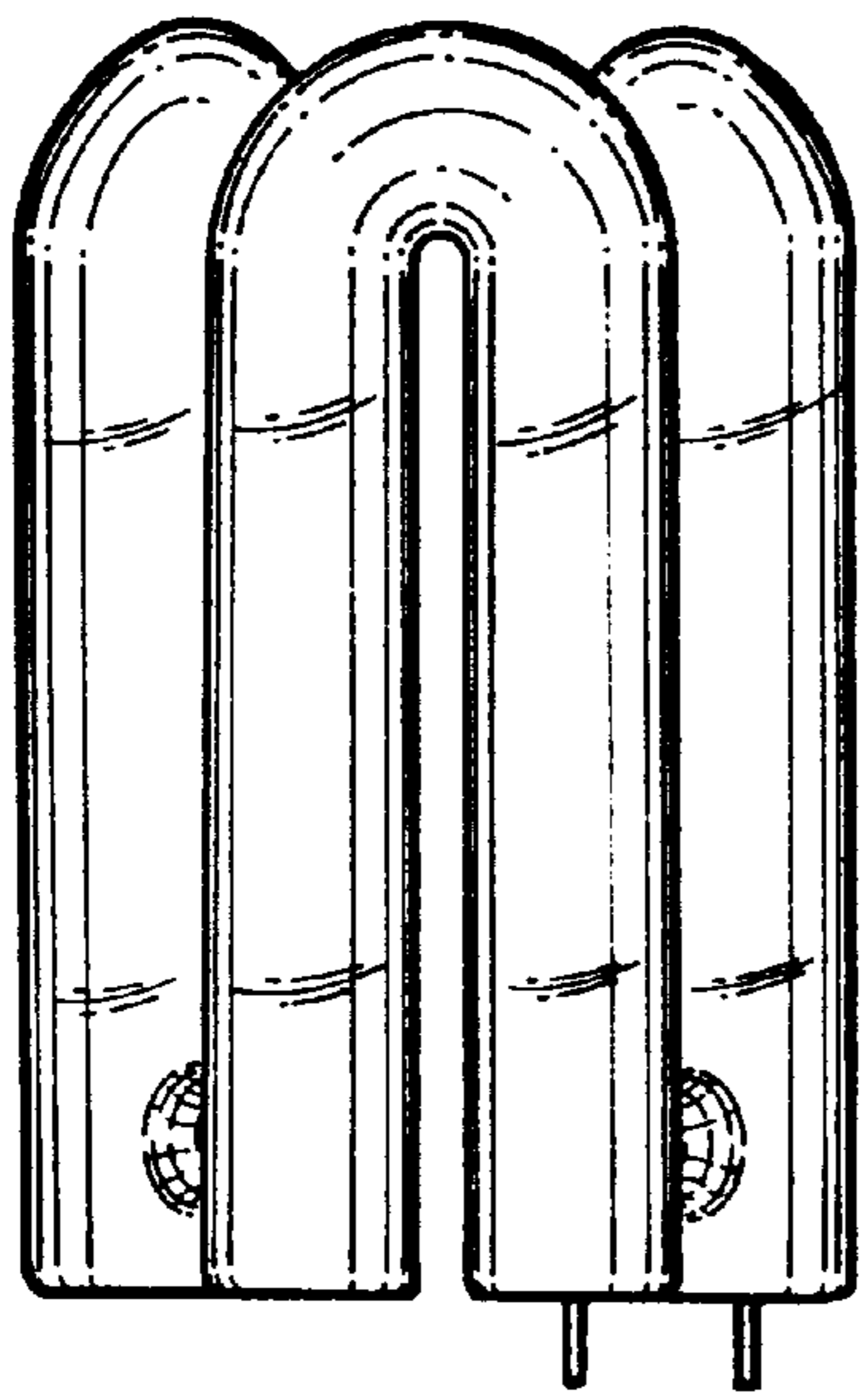

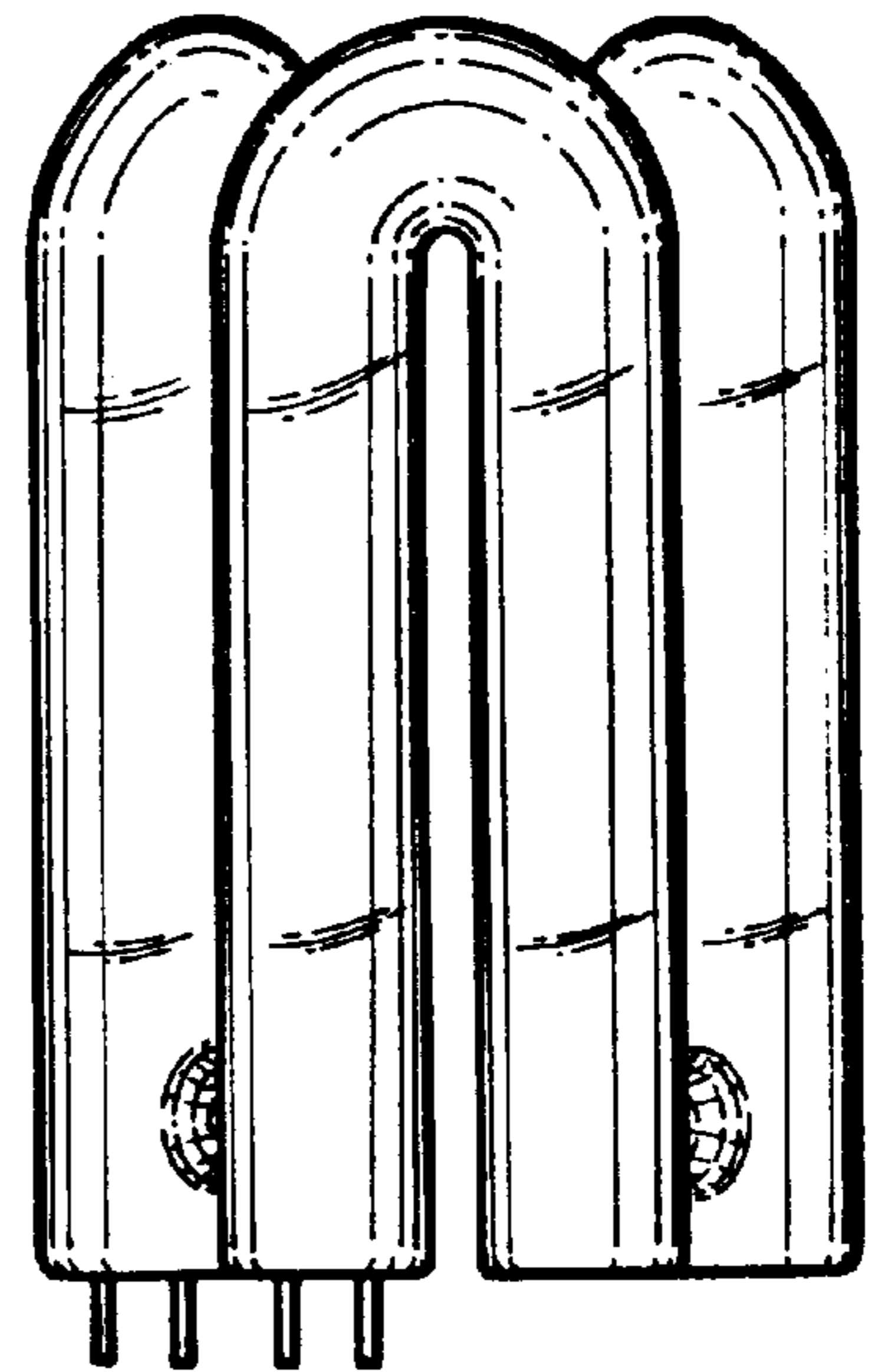

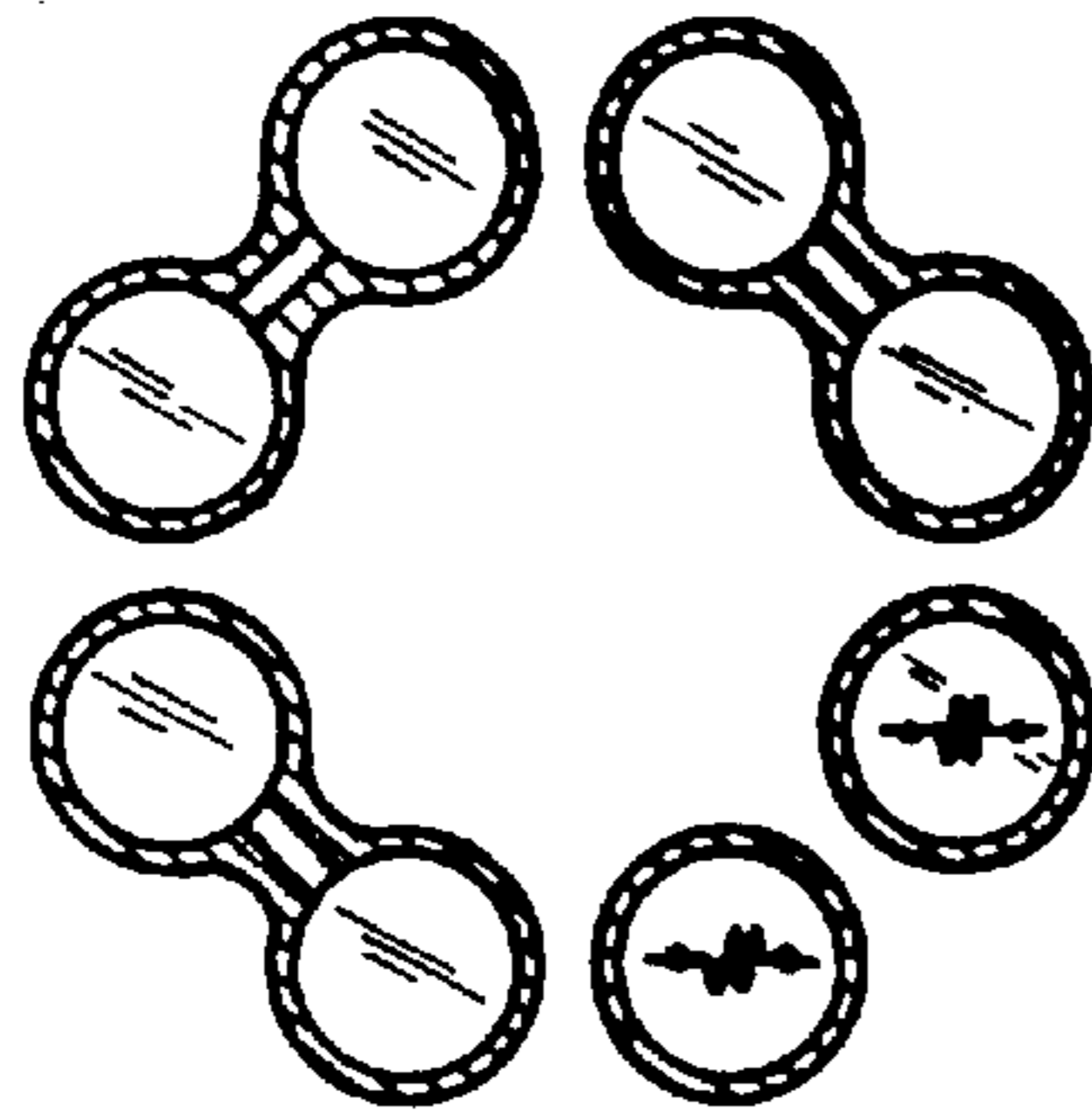

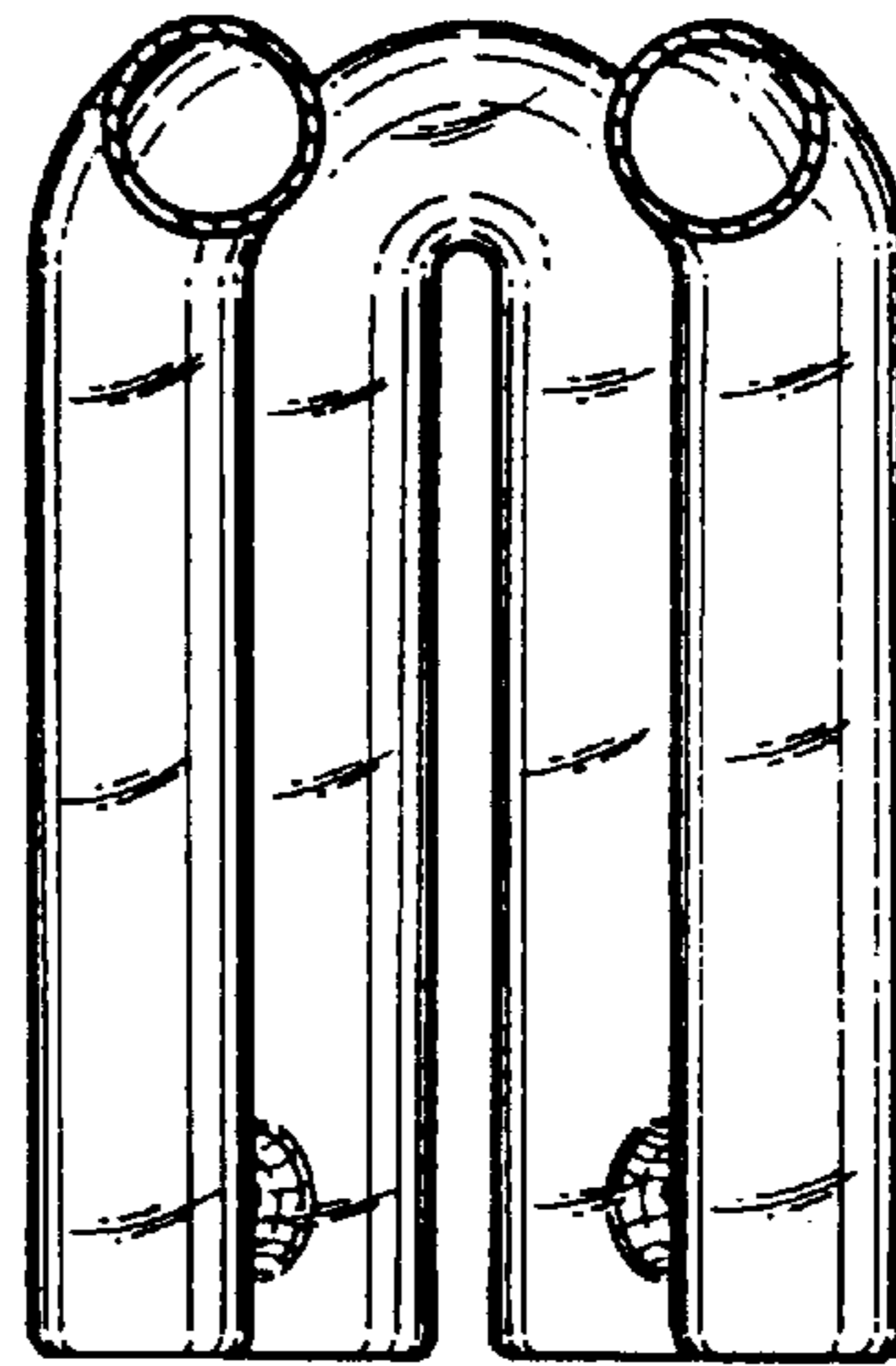

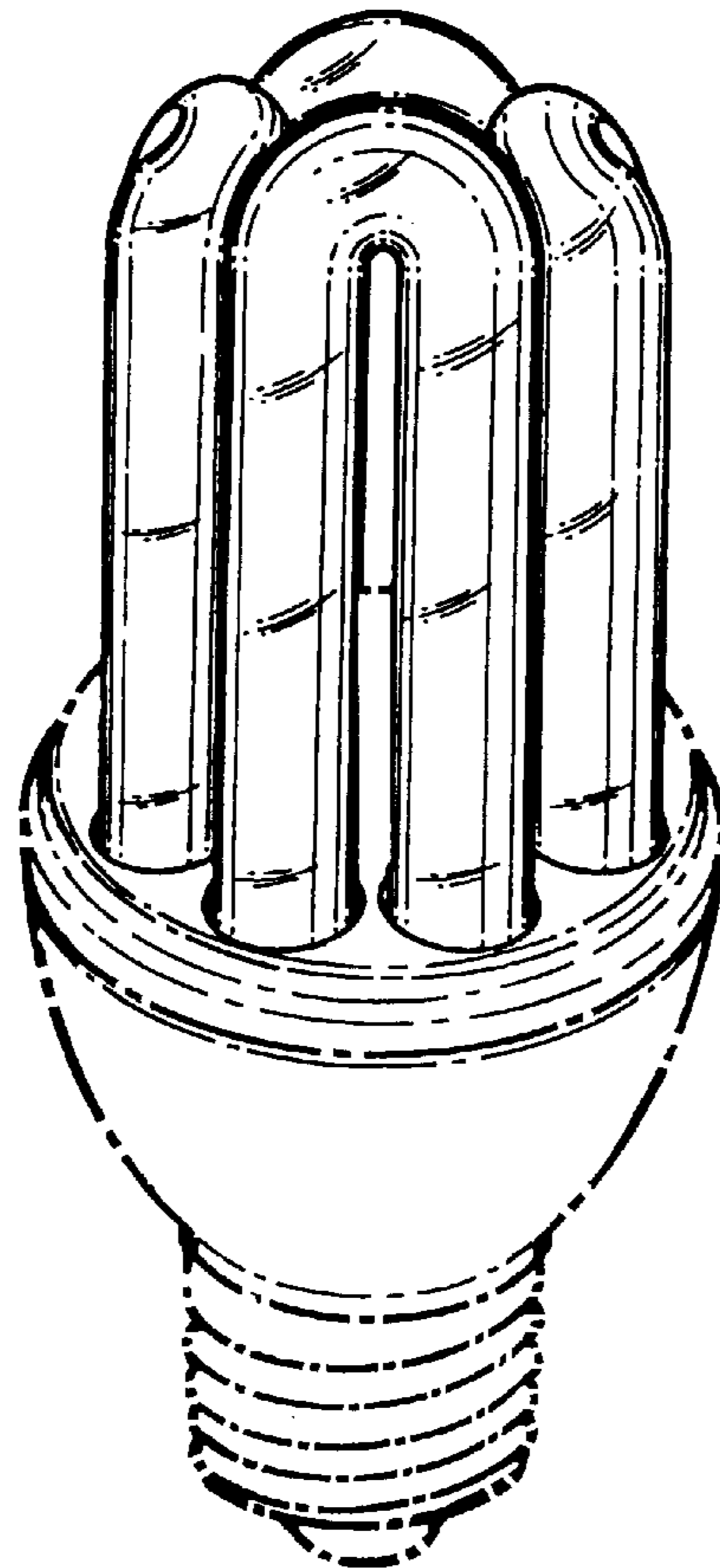
