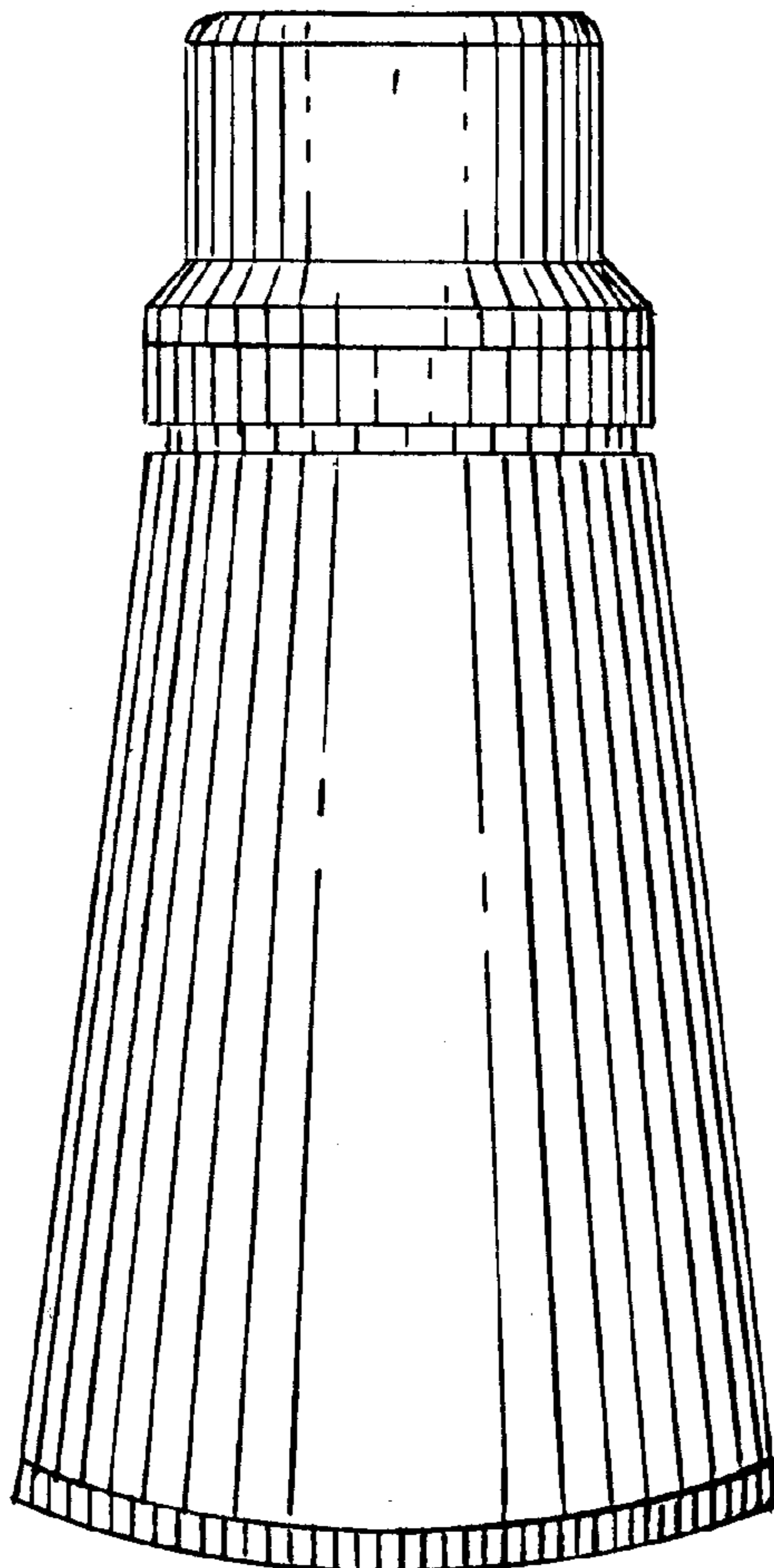
FIG. 1 is a left side elevational view of an applicator showing our new design;

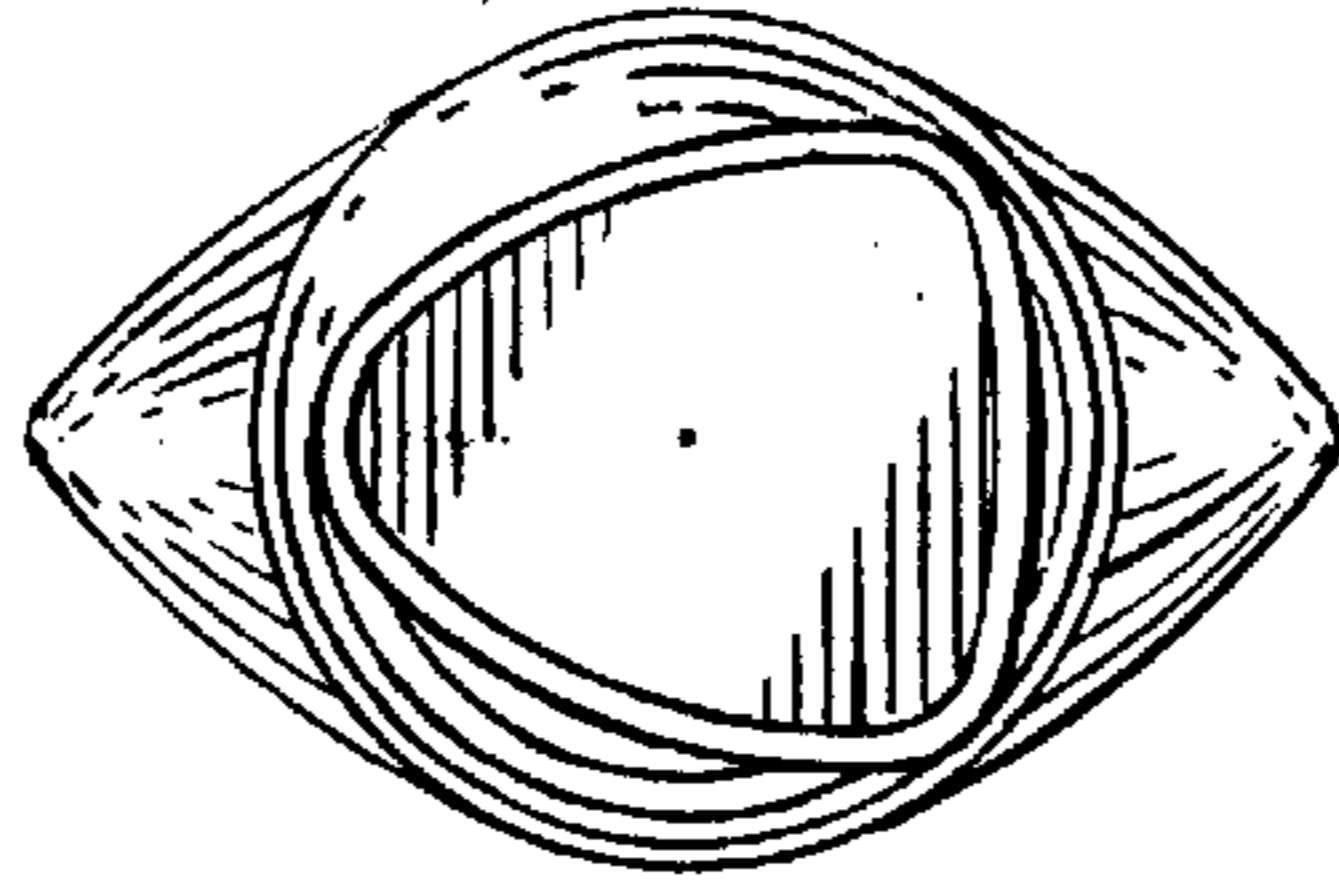

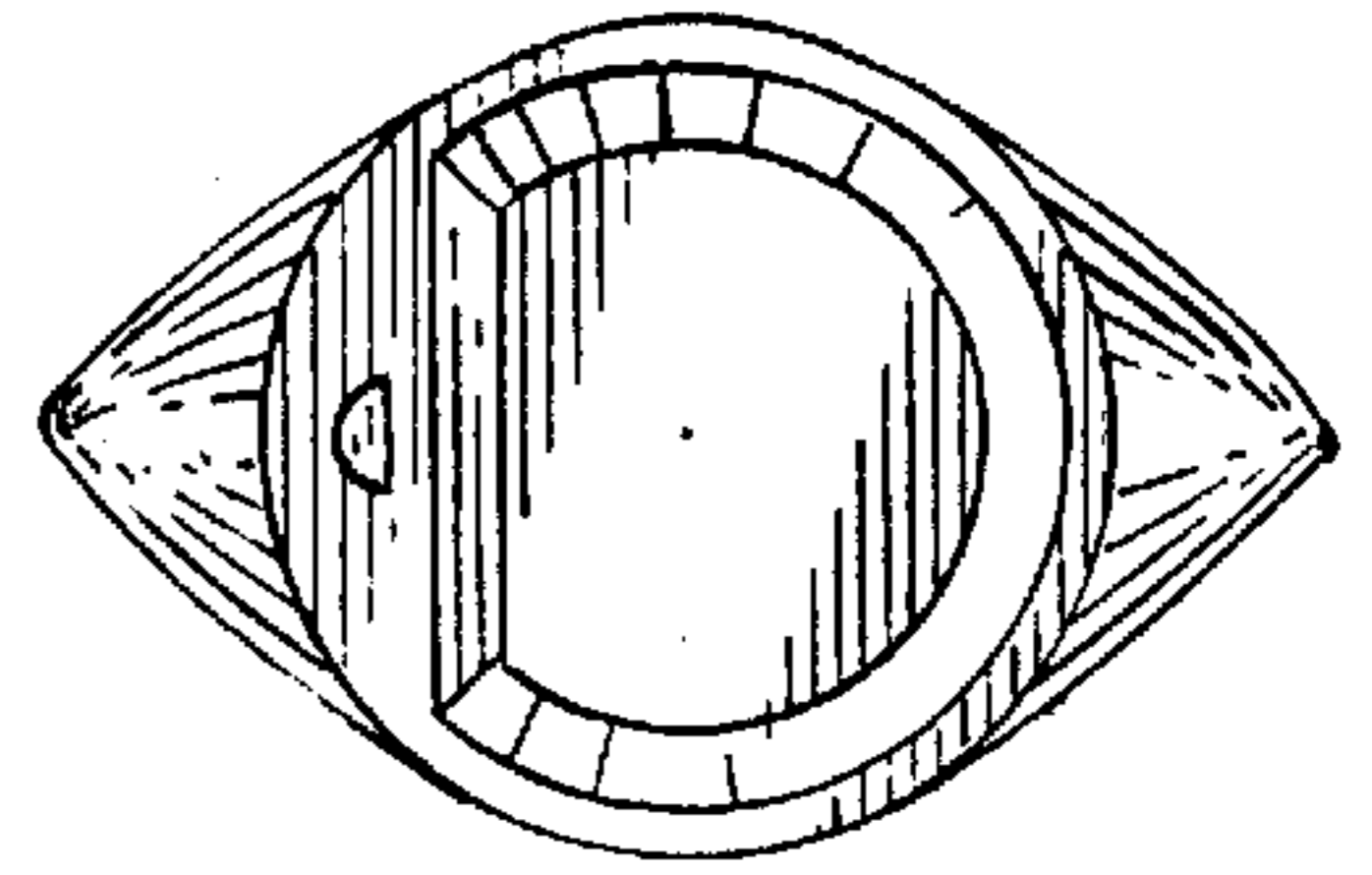

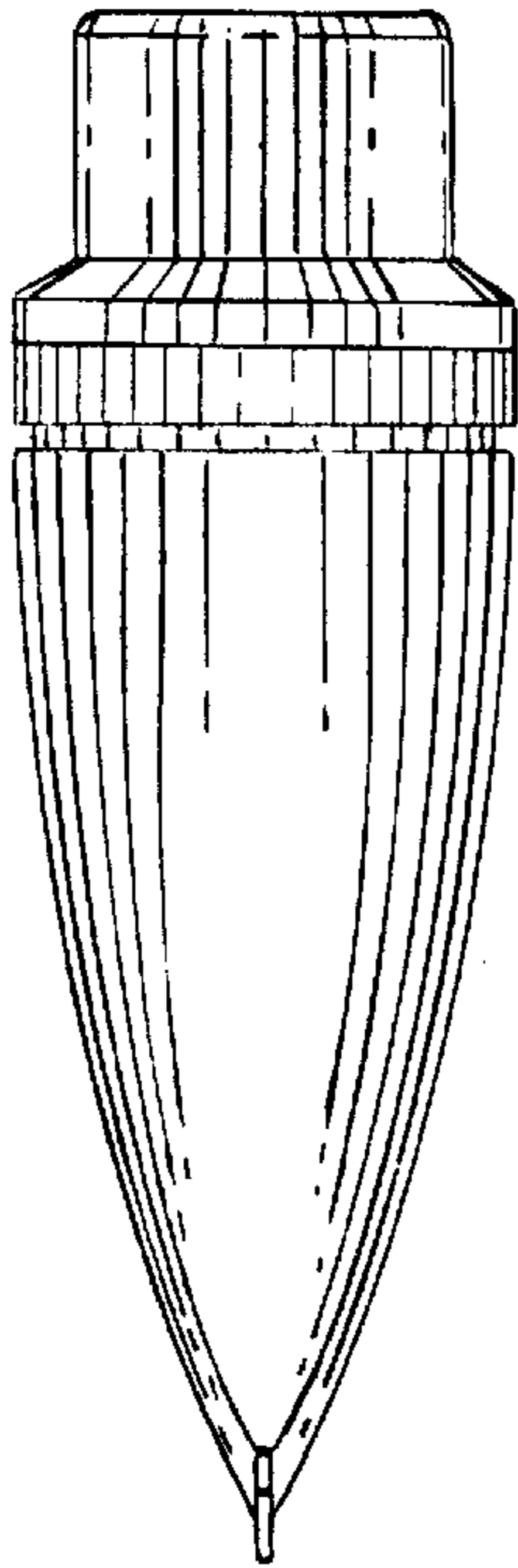

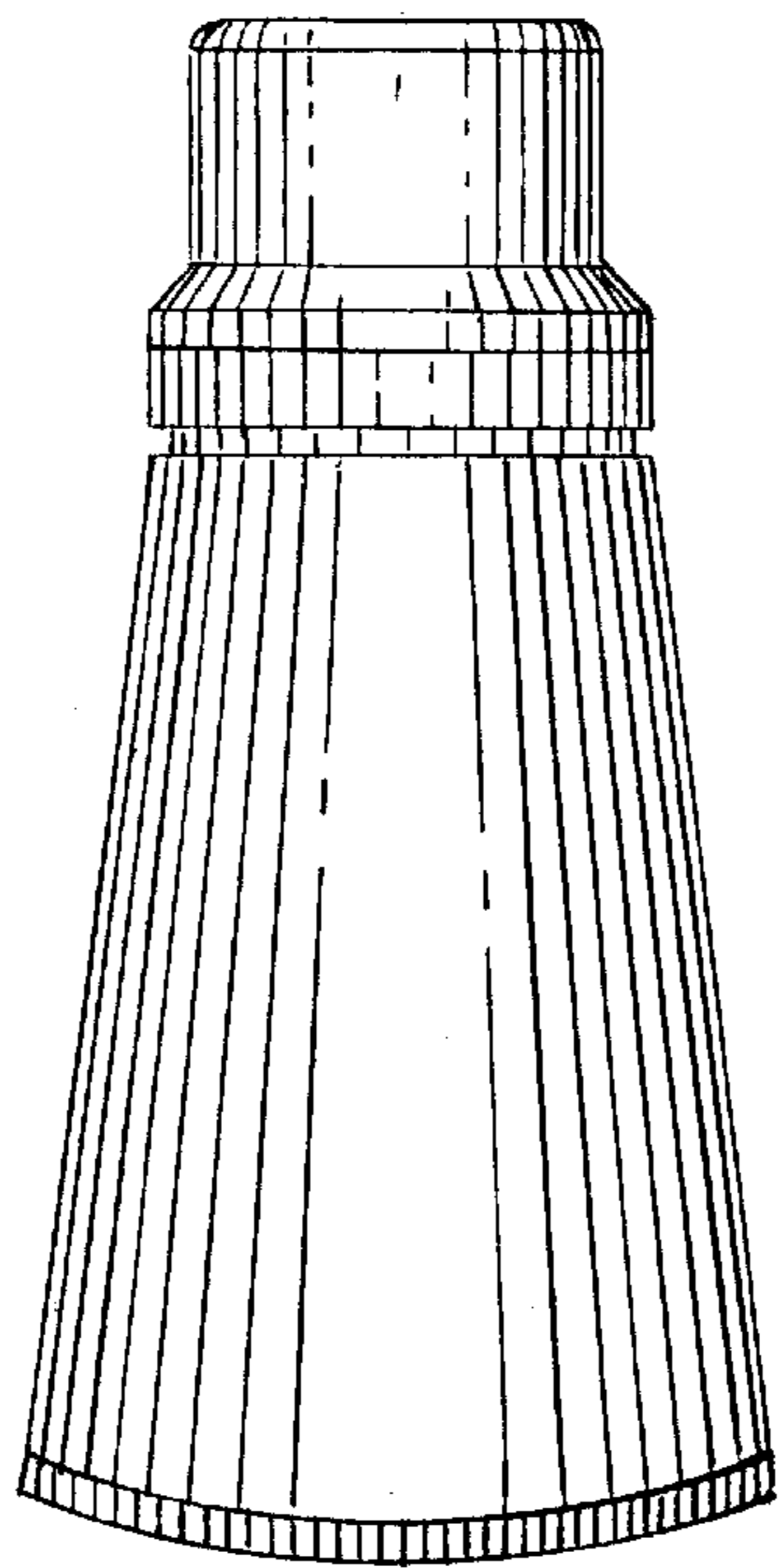

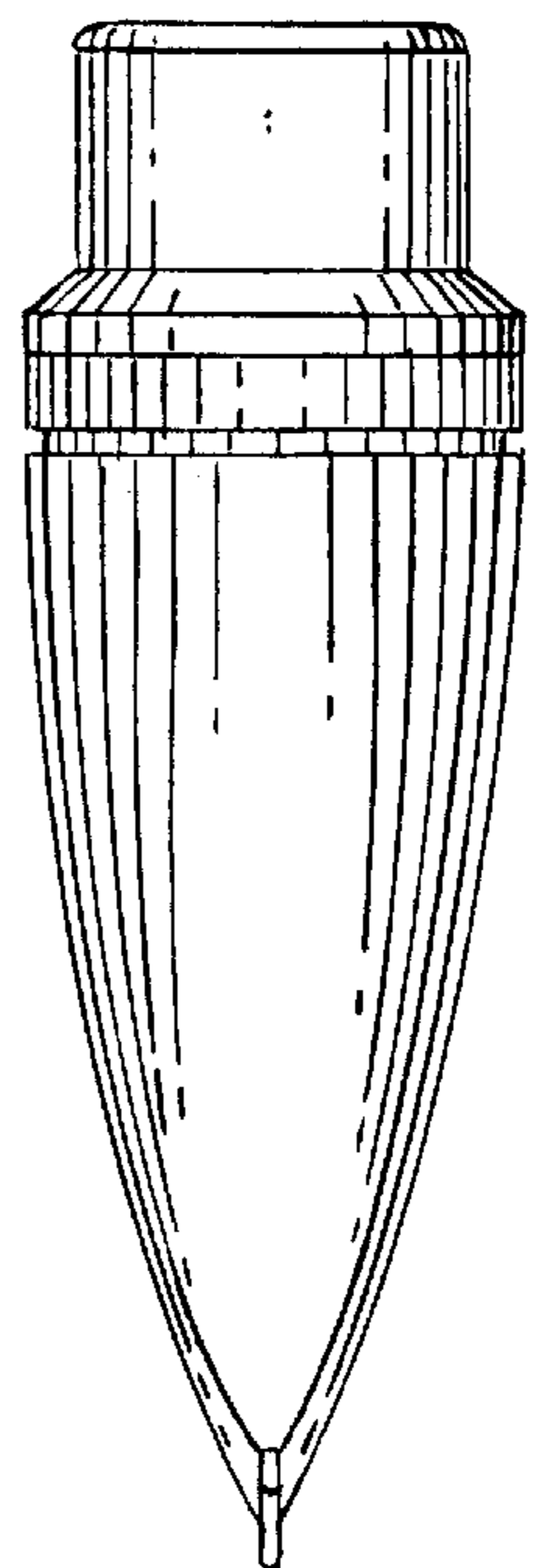

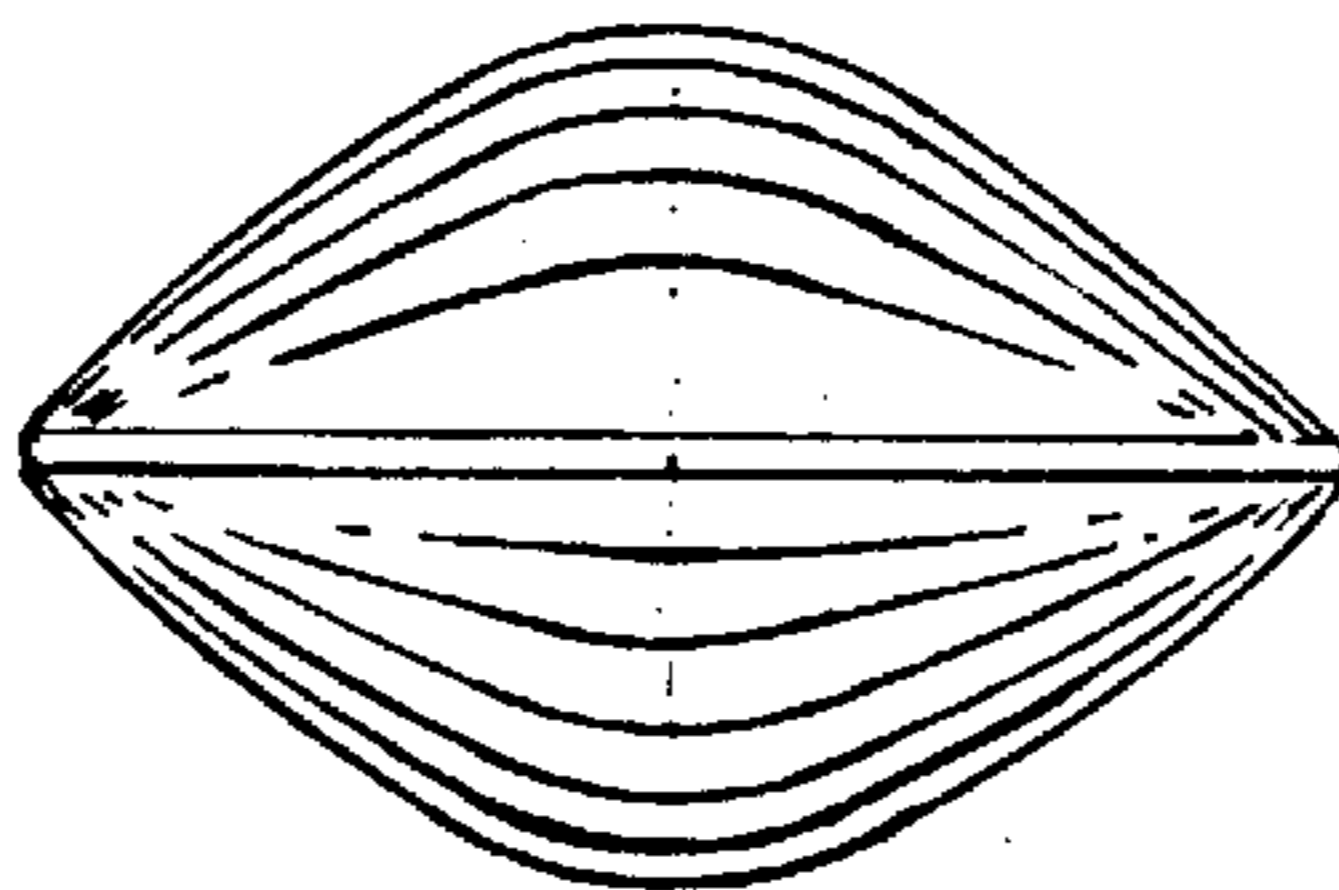

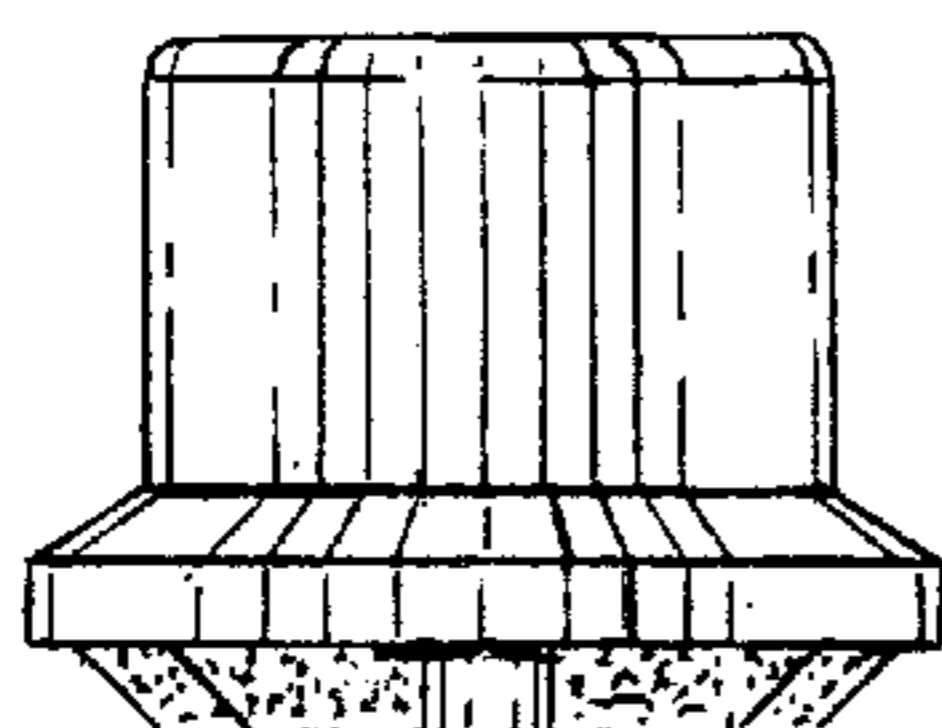

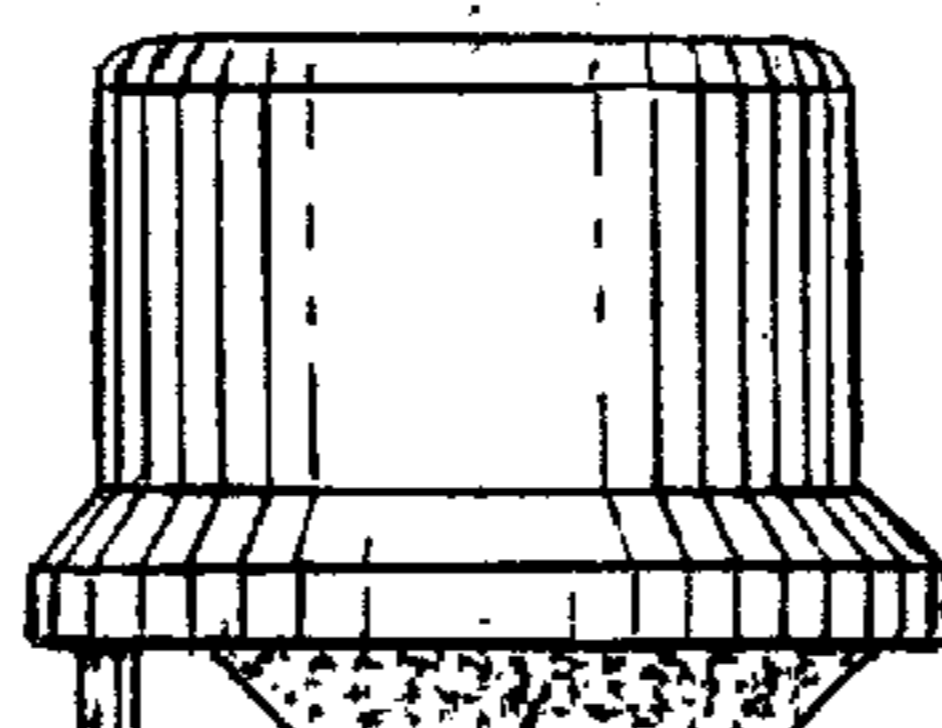

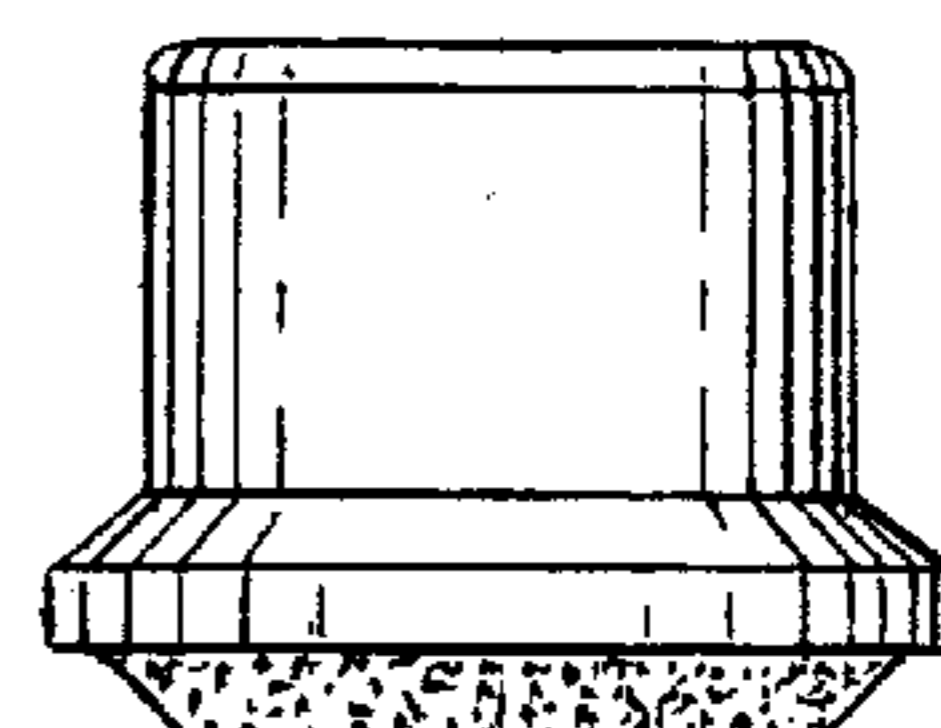
